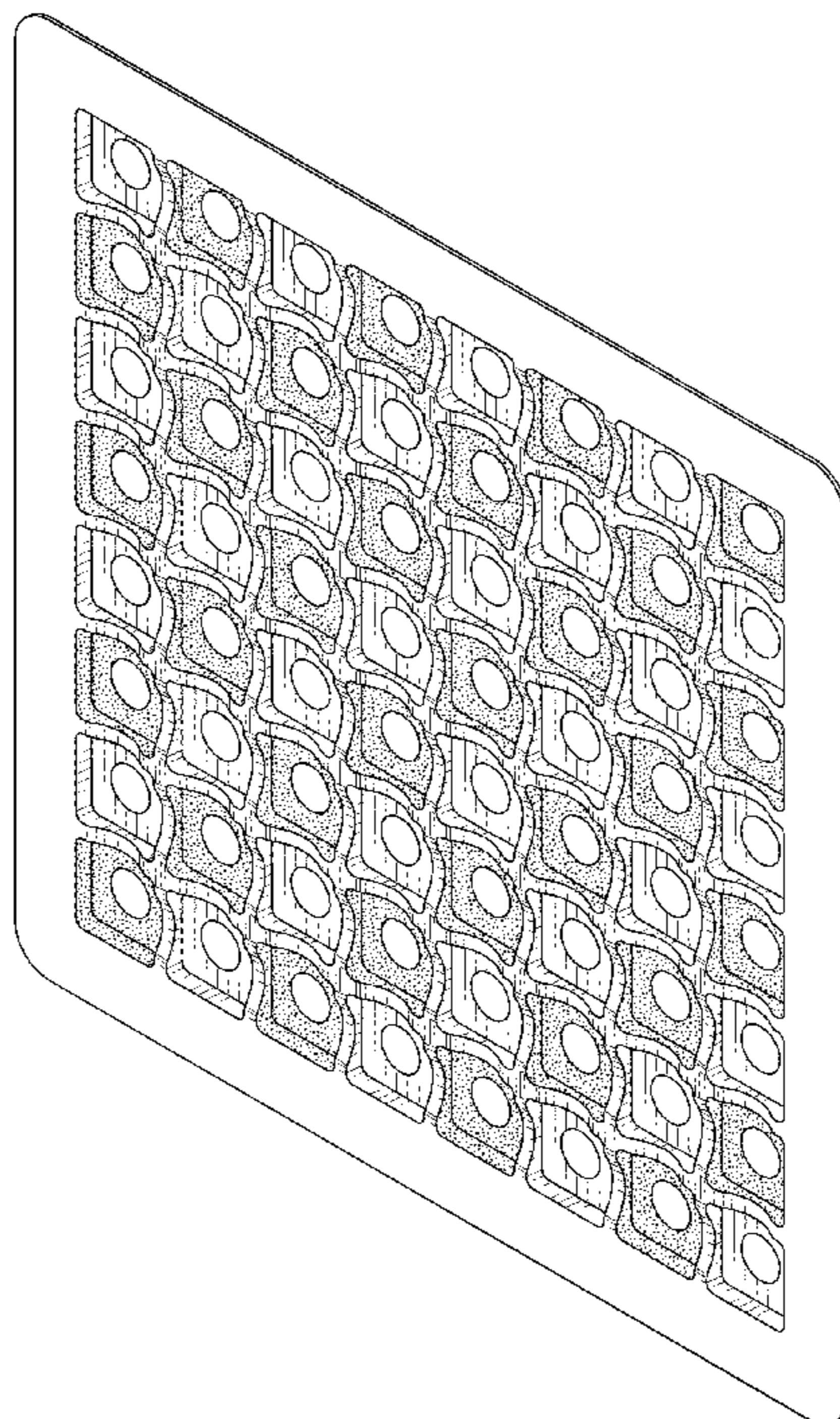
(57) **CLAIM**

The ornamental design for a chess board and candy serving tray, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a chess board and candy serving tray showing my new design;
 FIG. 2 is a bottom perspective view thereof;
 FIG. 3 is a front elevated view thereof;
 FIG. 4 is a rear elevated view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a right elevated view thereof;
 FIG. 8 is a left elevated view thereof;
 FIG. 9 is a magnified view thereof taken about circle 9 in FIG. 2; and,
 FIG. 10 is a vertical cross-sectional view thereof taken along line 10-10 in FIG. 6.
 The broken lines showing a tray body in FIGS. 4, 5, 6, 7, 8, and 10 are included for the purpose of showing environmental structure and form no part of the claimed design.

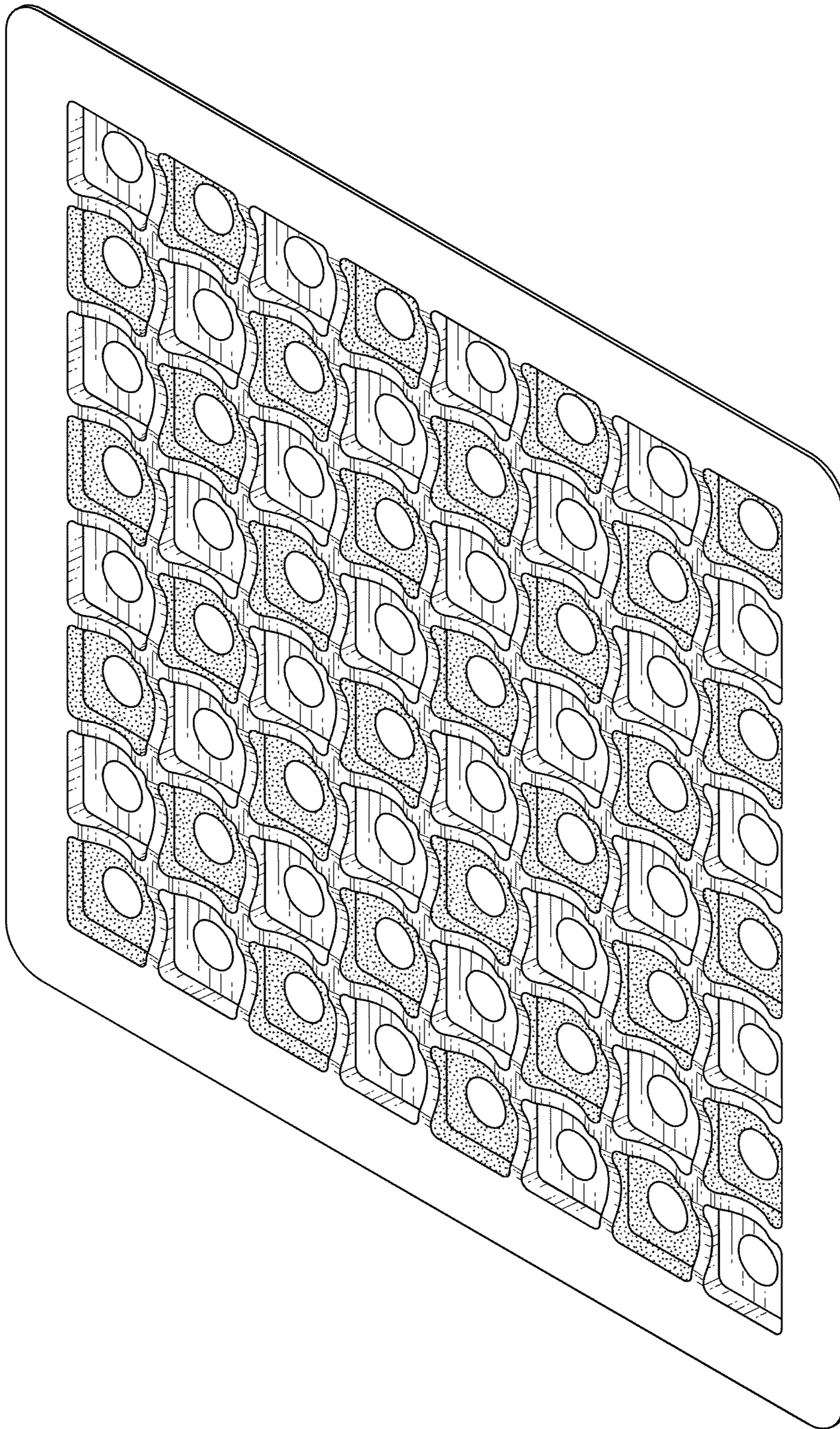

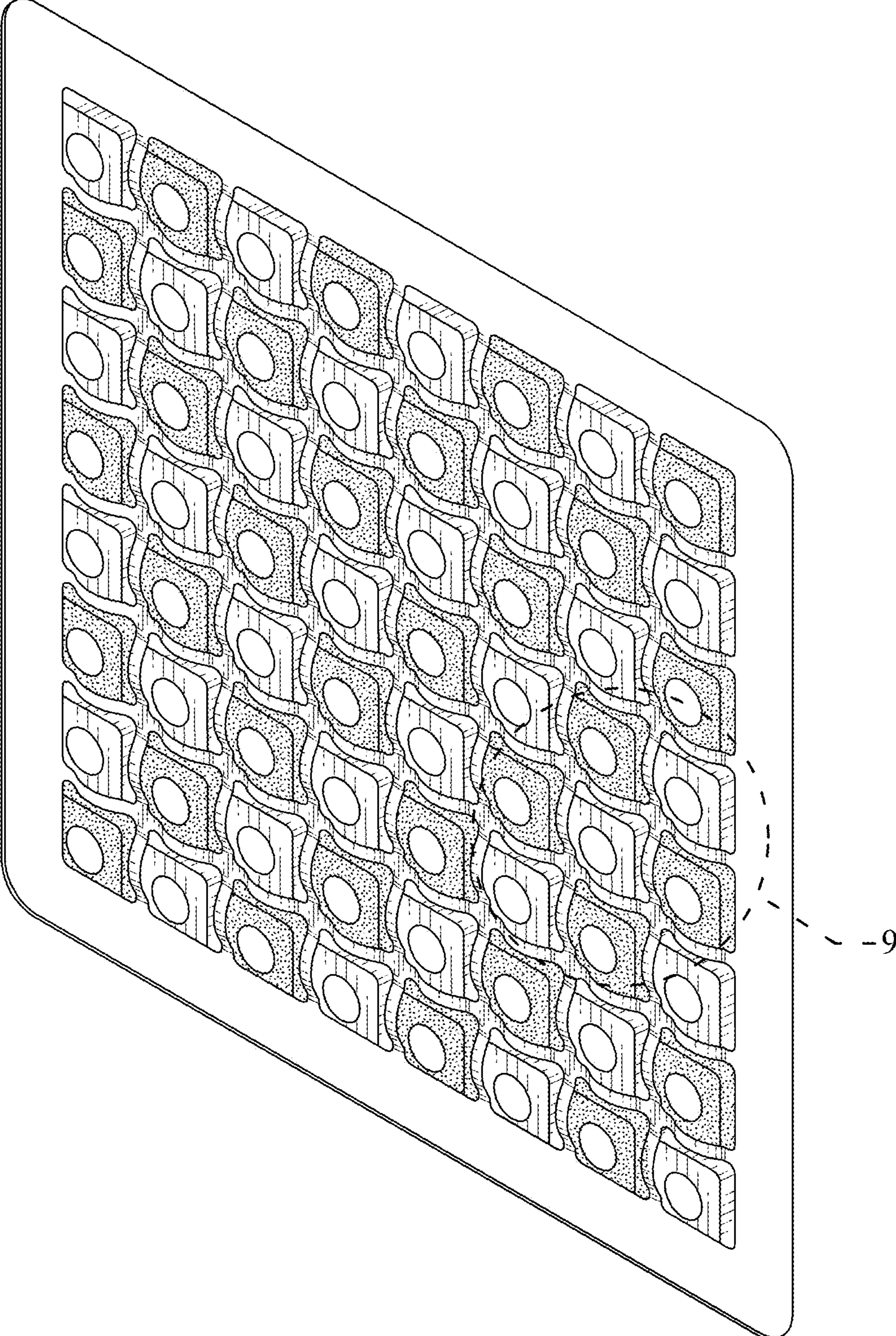

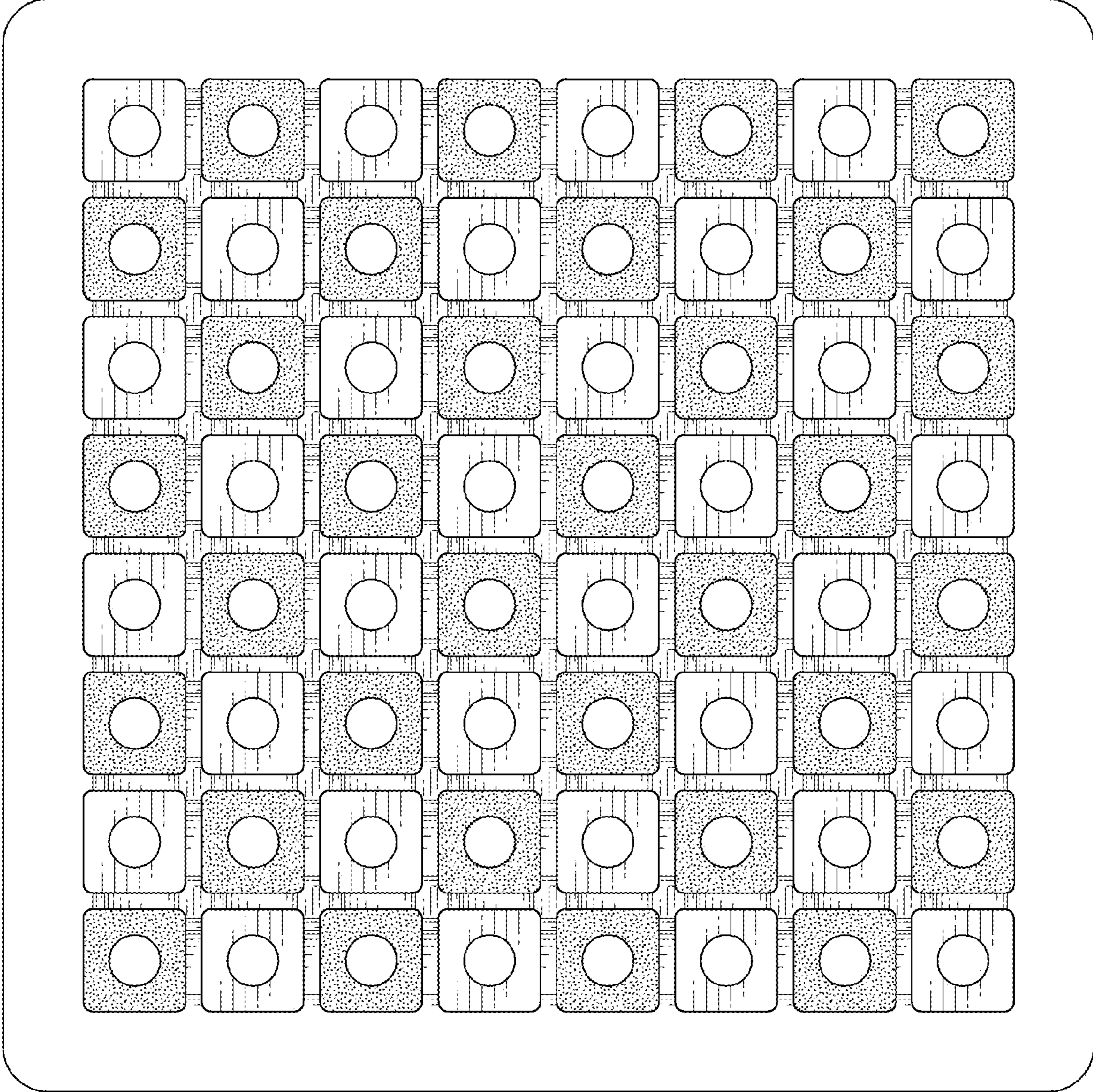

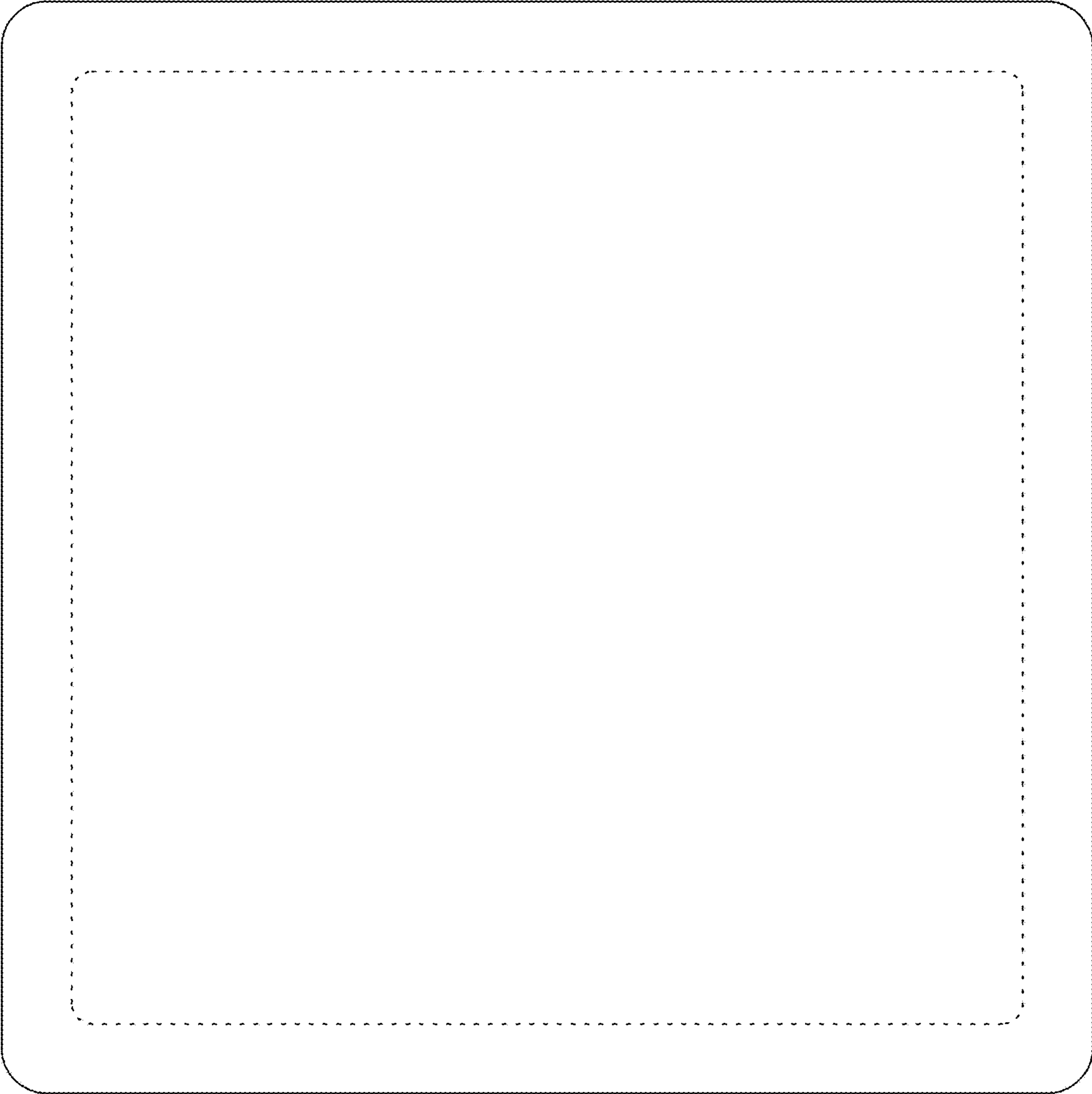

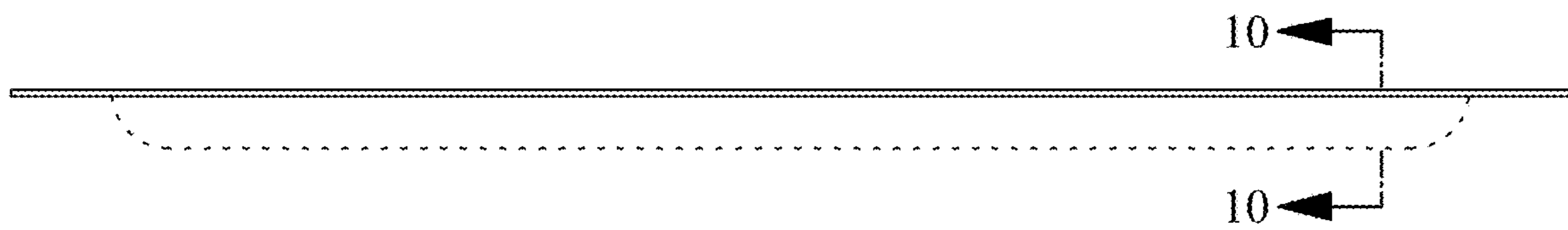

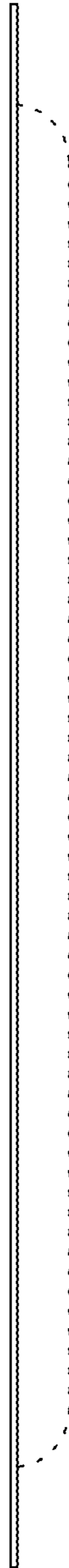

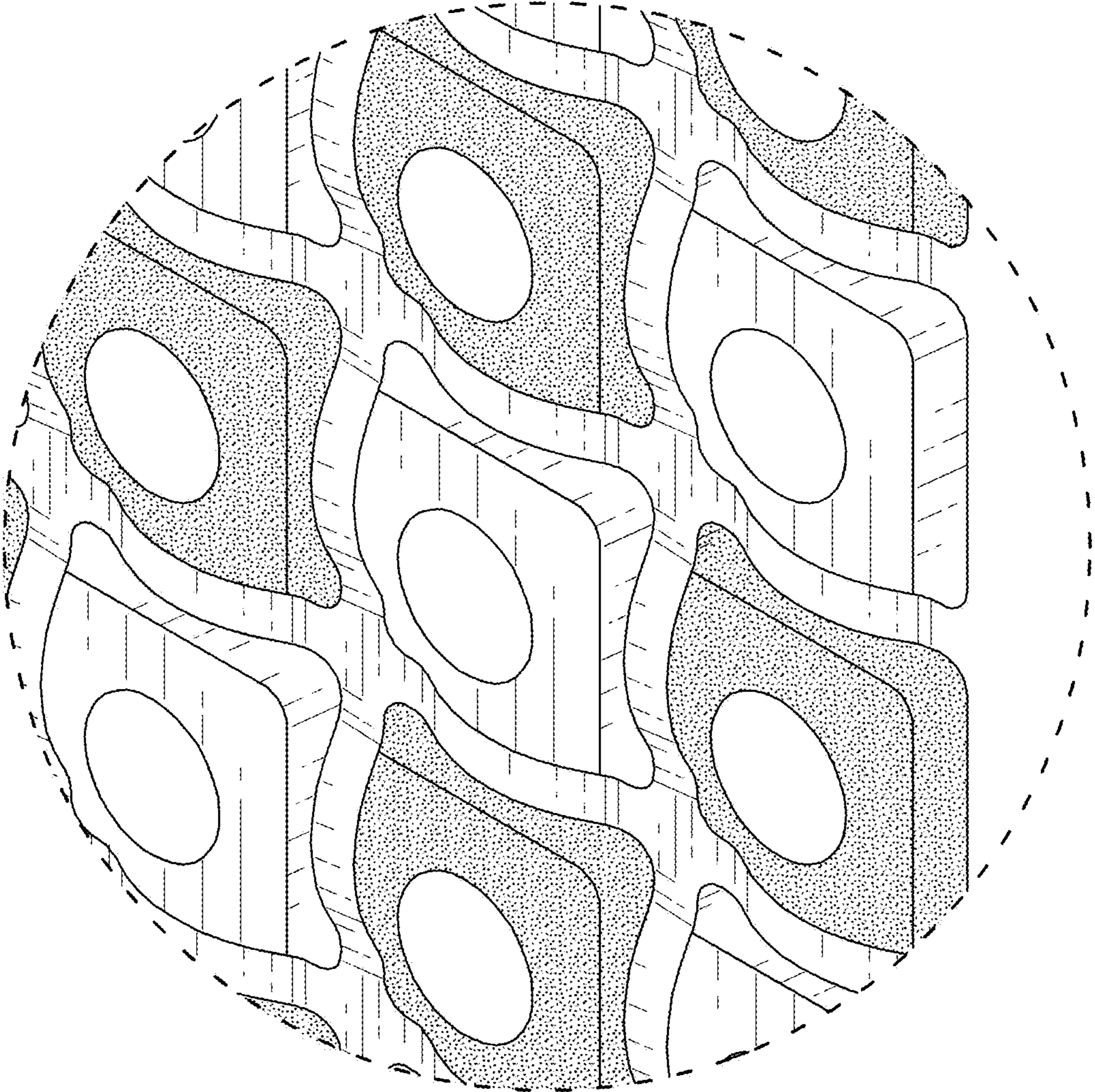
