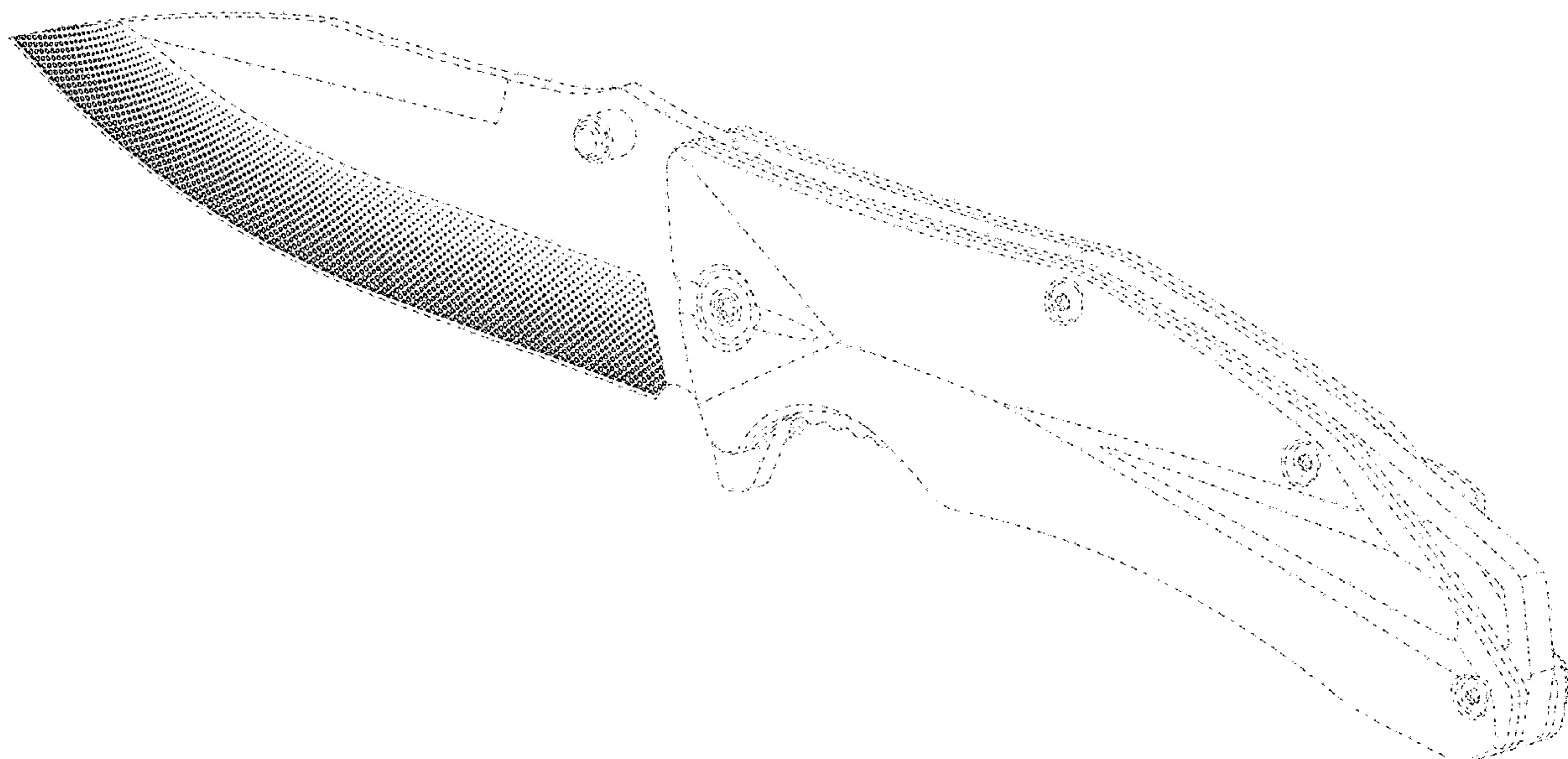
(57) **CLAIM**

The ornamental design of a knife blade, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of the knife blade;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left elevational view thereof;
FIG. 5 is a right elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a closer view of an area identified in FIG. 2
showing embossments thereof;
FIG. 9 is a closer view of an area identified in FIG. 8;
FIG. 10 is a perspective view of the knife blade, shown in
use with a knife grip; and,
FIG. 11 is front elevational view of the knife blade in use
with the knife grip.
The portions of the knife blade shown in broken lines form
no part of the claimed design. The broken line showing of a
knife grip in FIGS. 10 and 11 illustrates environment; the
broken lines form no part of the claimed design.

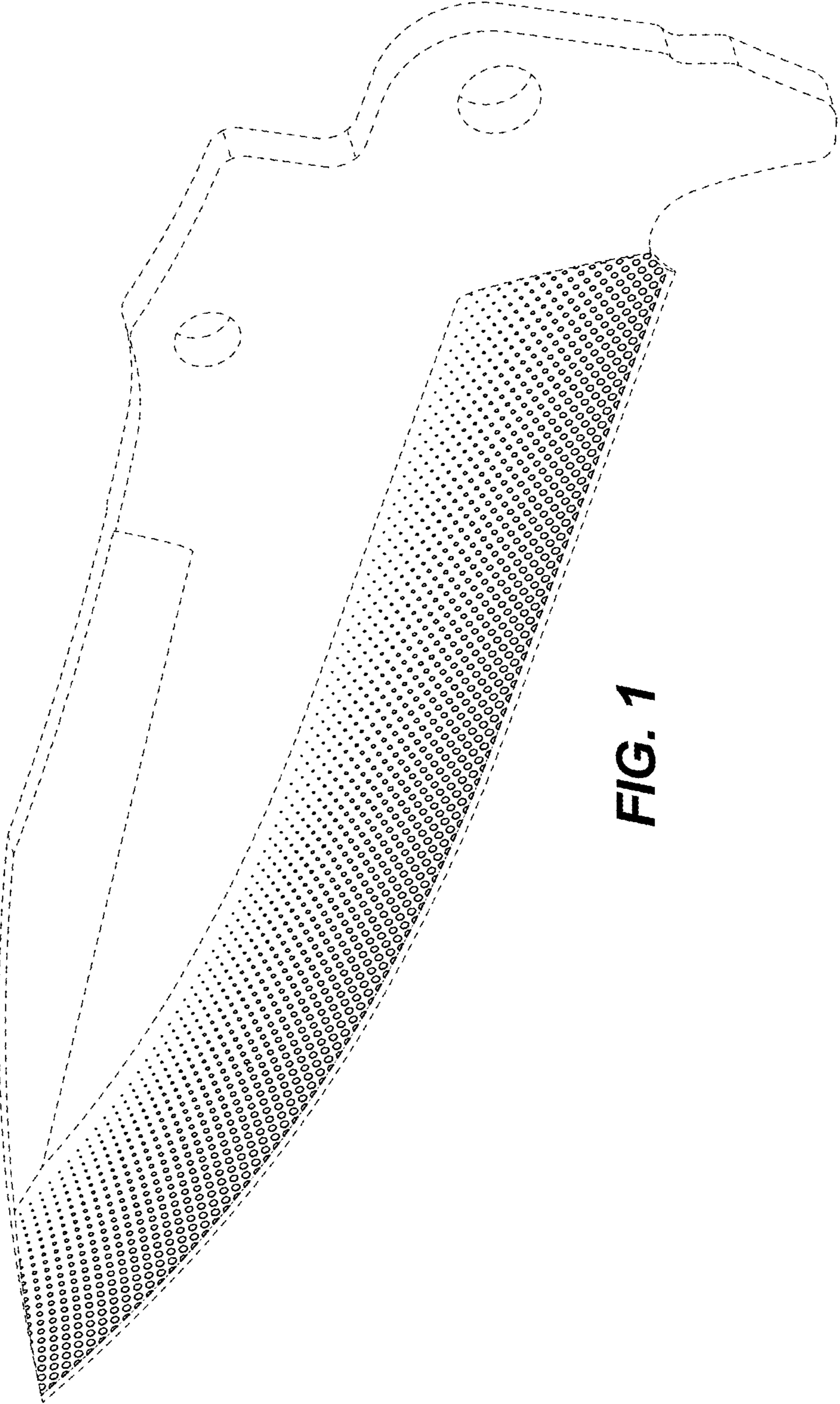

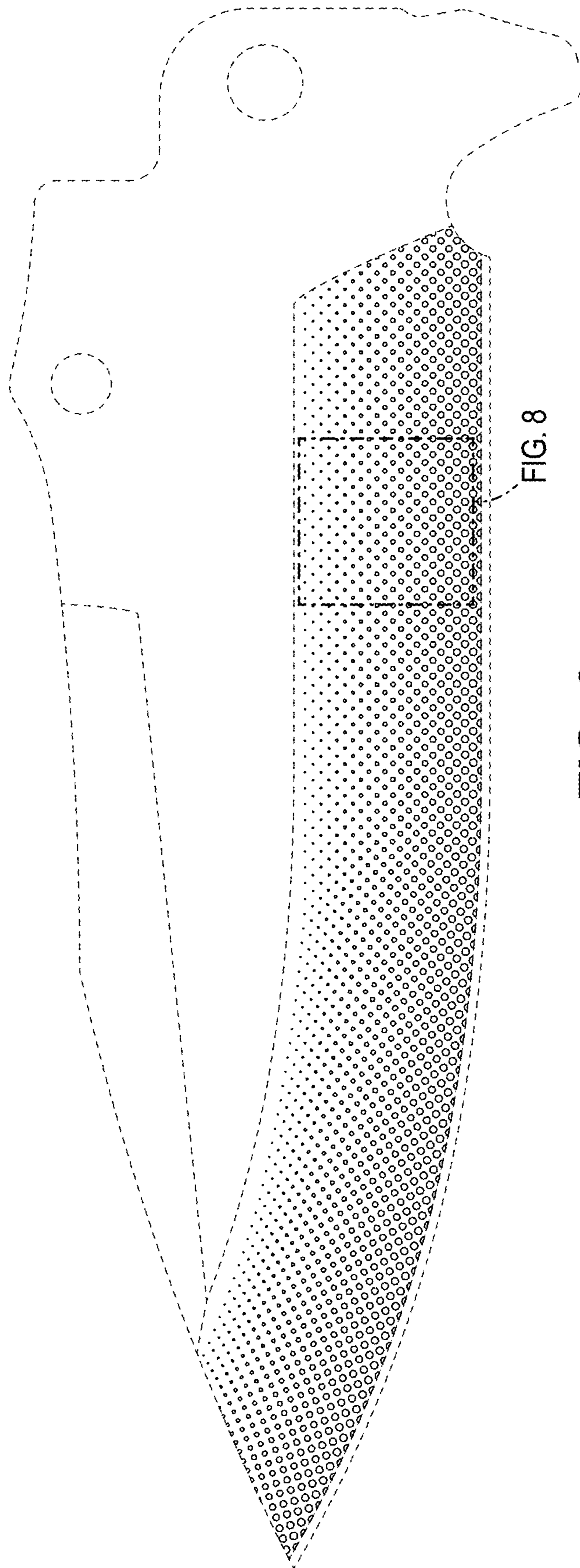

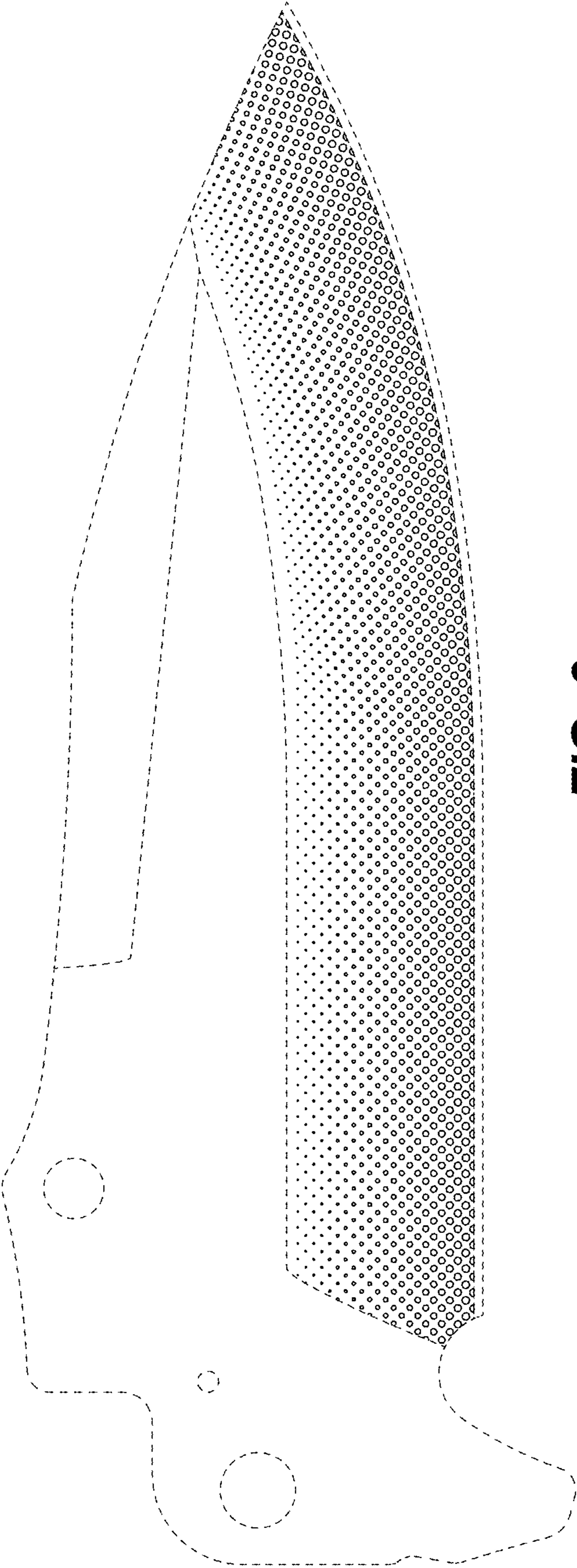

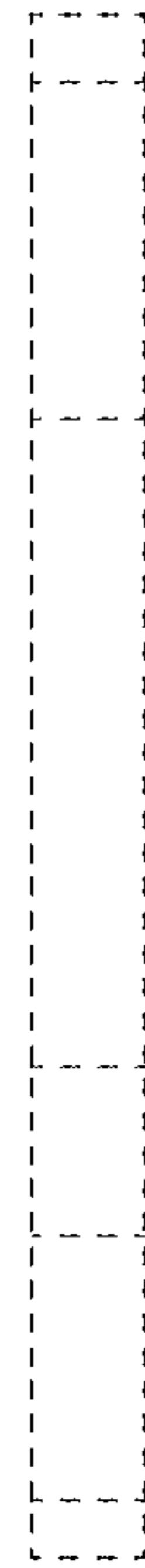

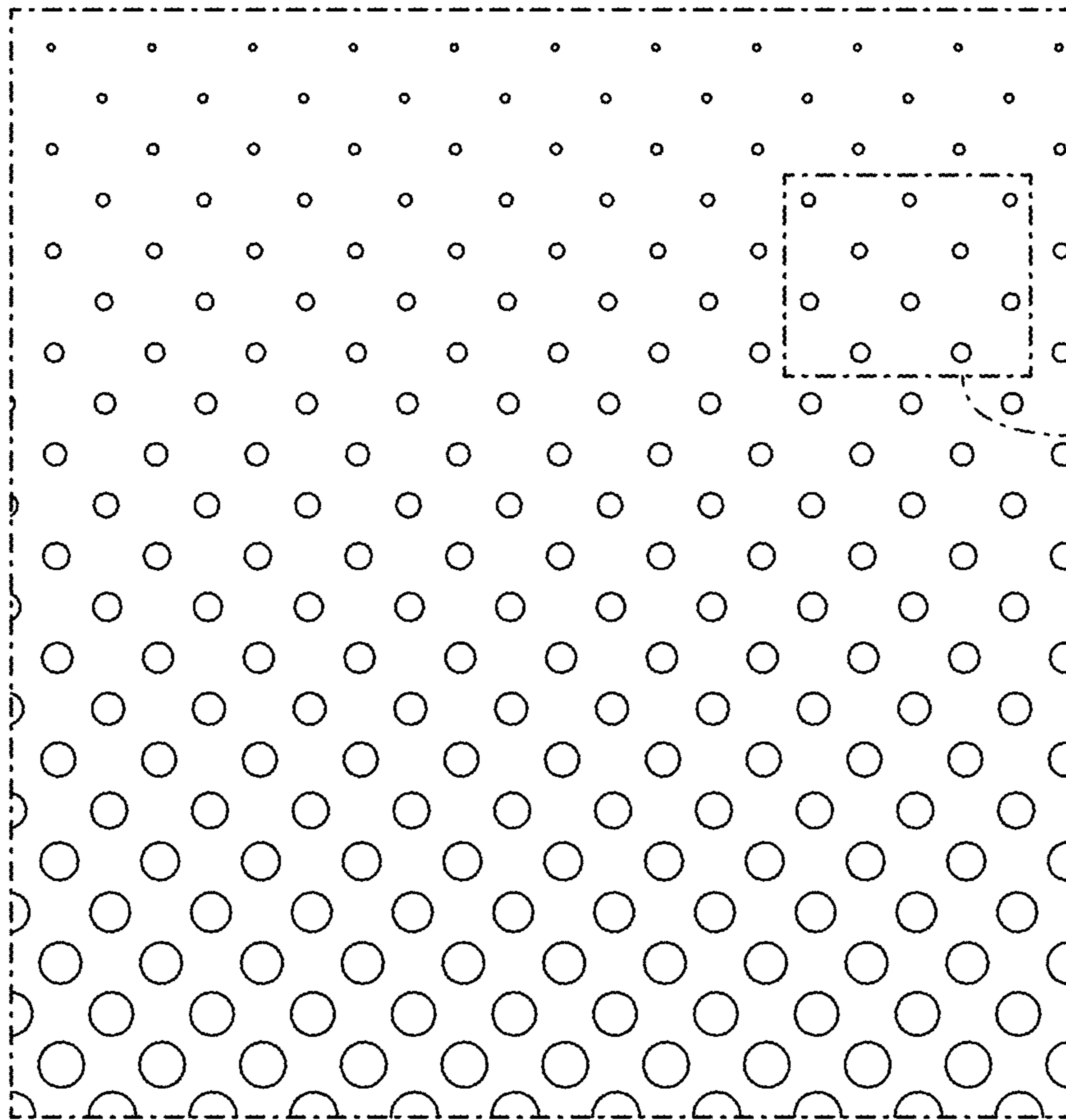

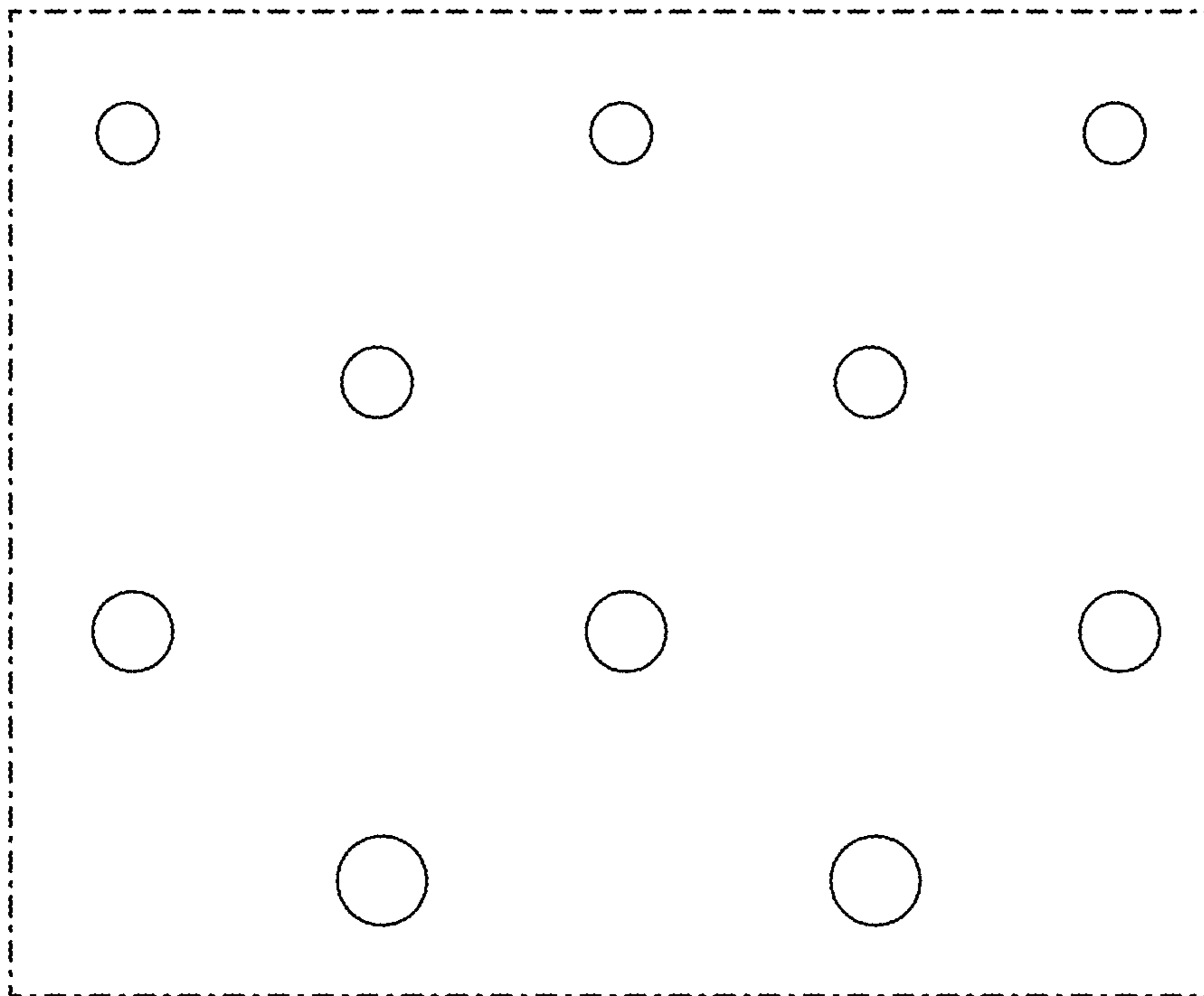

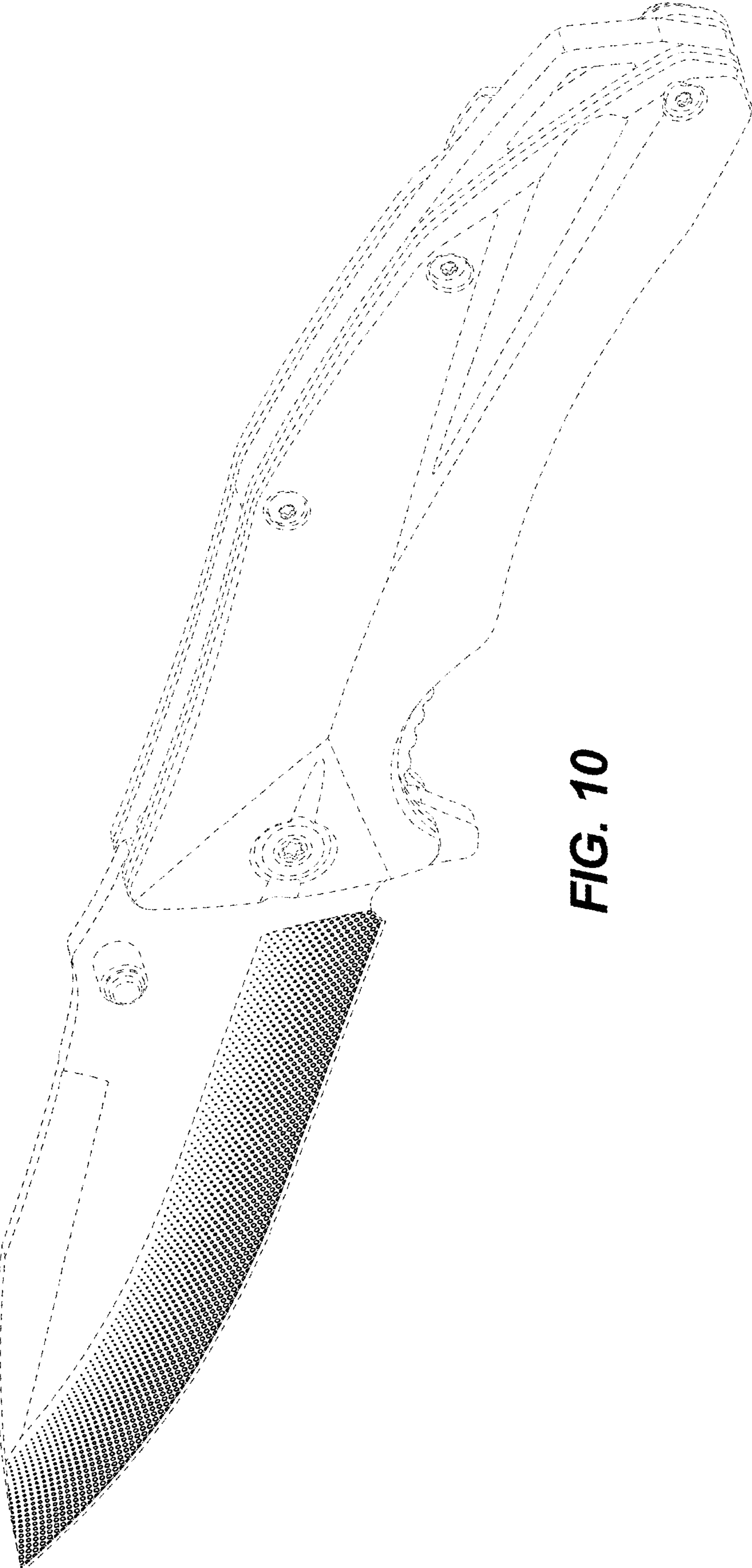

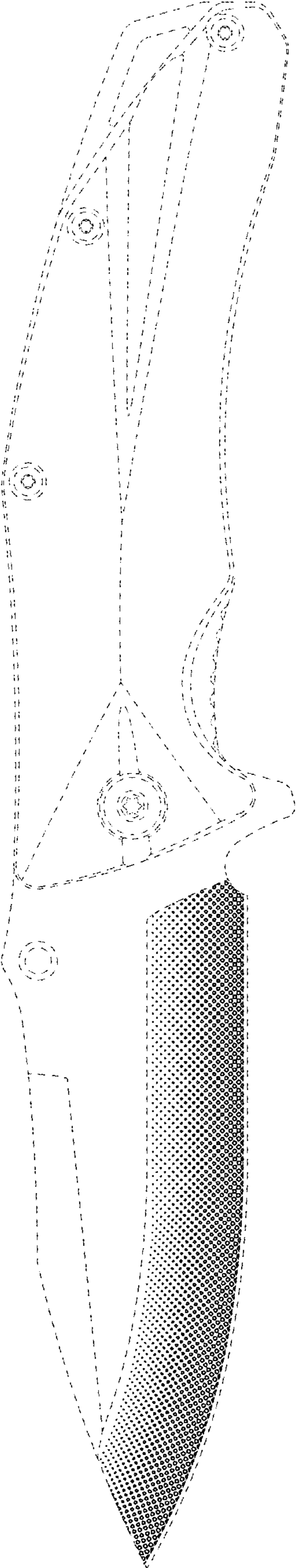
