FIG. 2 is a bottom plan view of the article of FIG. 1.

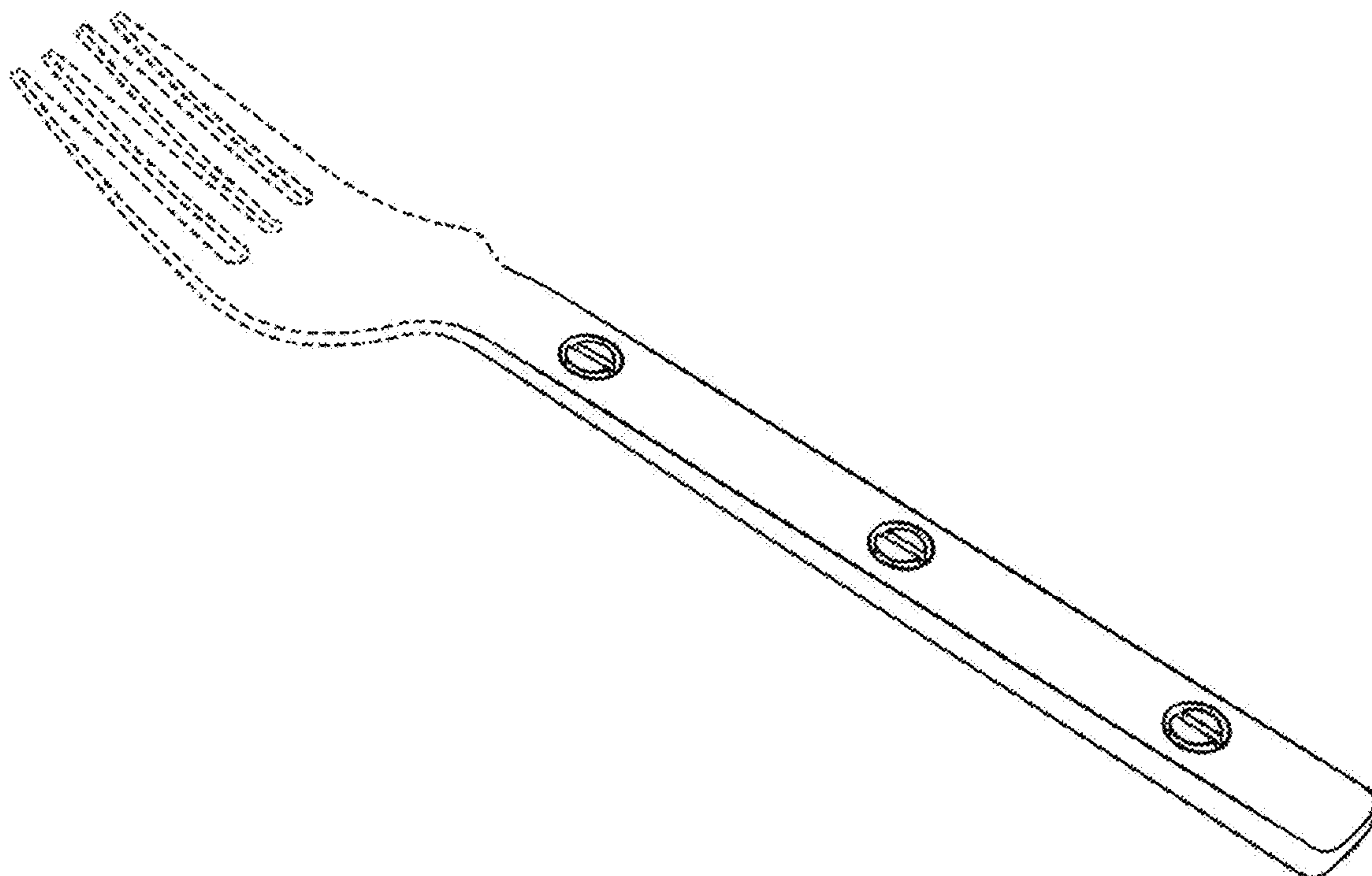

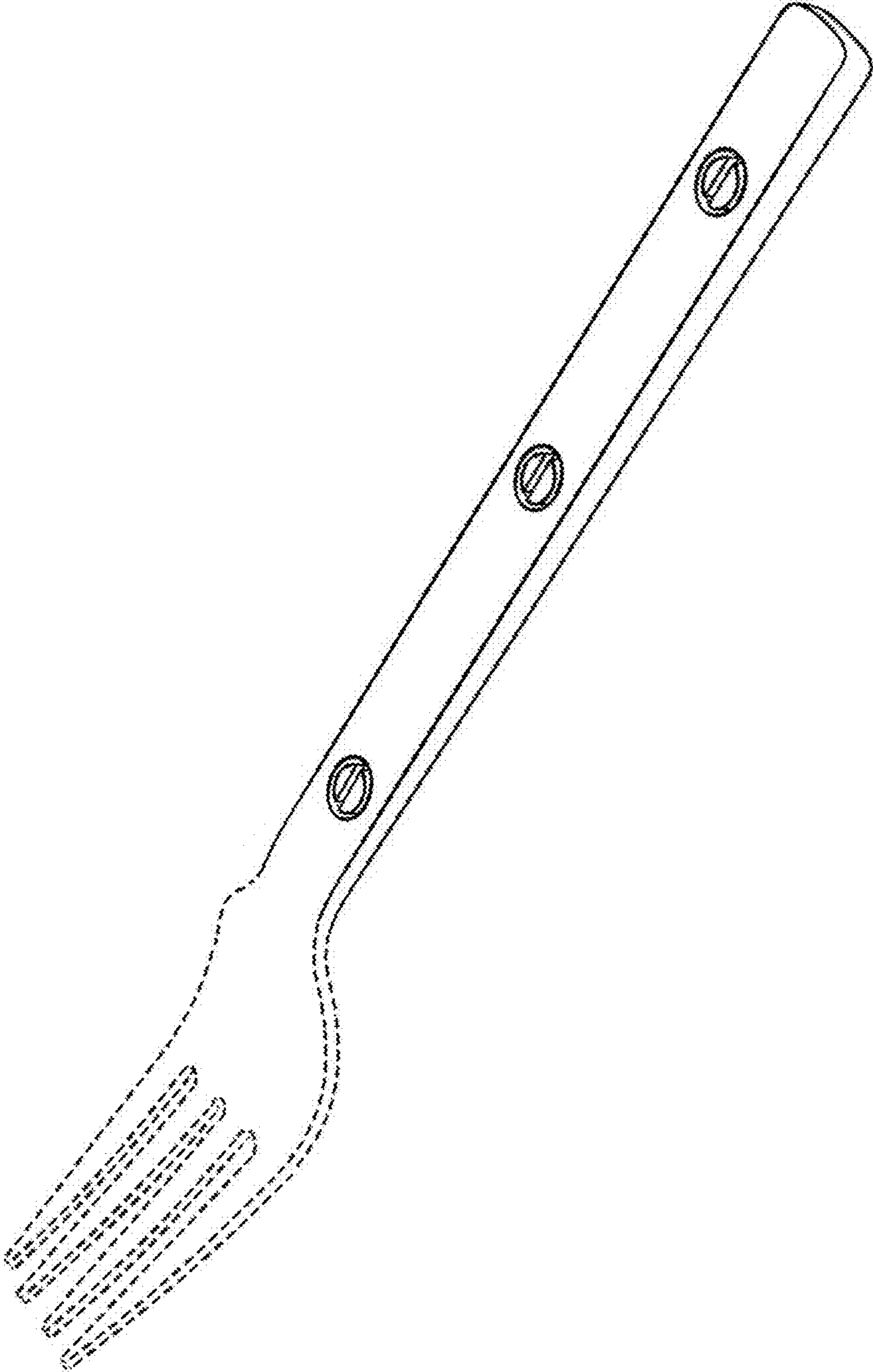

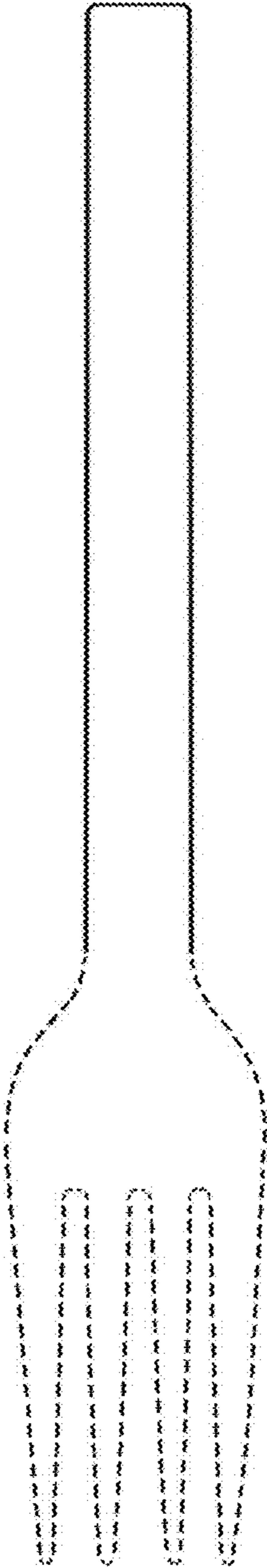
