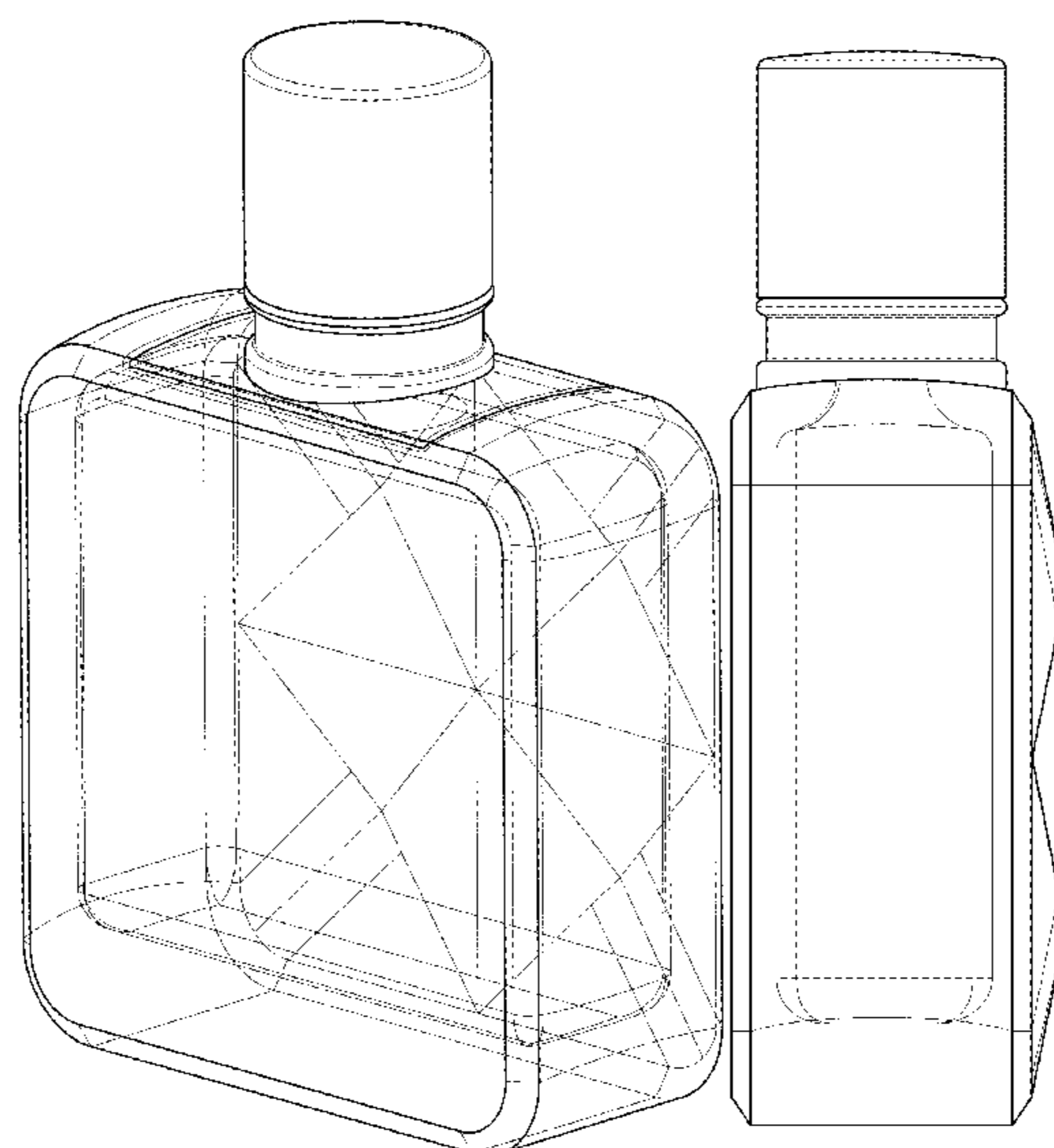
(57) **CLAIM**

The ornamental design for a perfume bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top-front-right perspective view of a perfume bottle, showing the design;
FIG. 2 is a front view of the perfume bottle of FIG. 1;
FIG. 3 is a rear view of the perfume bottle of FIG. 1;
FIG. 4 is a right view of the perfume bottle of FIG. 1;
FIG. 5 is a left view of the perfume bottle of FIG. 1;
FIG. 6 is a top view of the perfume bottle of FIG. 1; and,
FIG. 7 is a bottom view of the perfume bottle of FIG. 1.
The broken lines in the drawings showing the perfume bottle illustrate the portions of the perfume bottle that form no part of the claimed design.

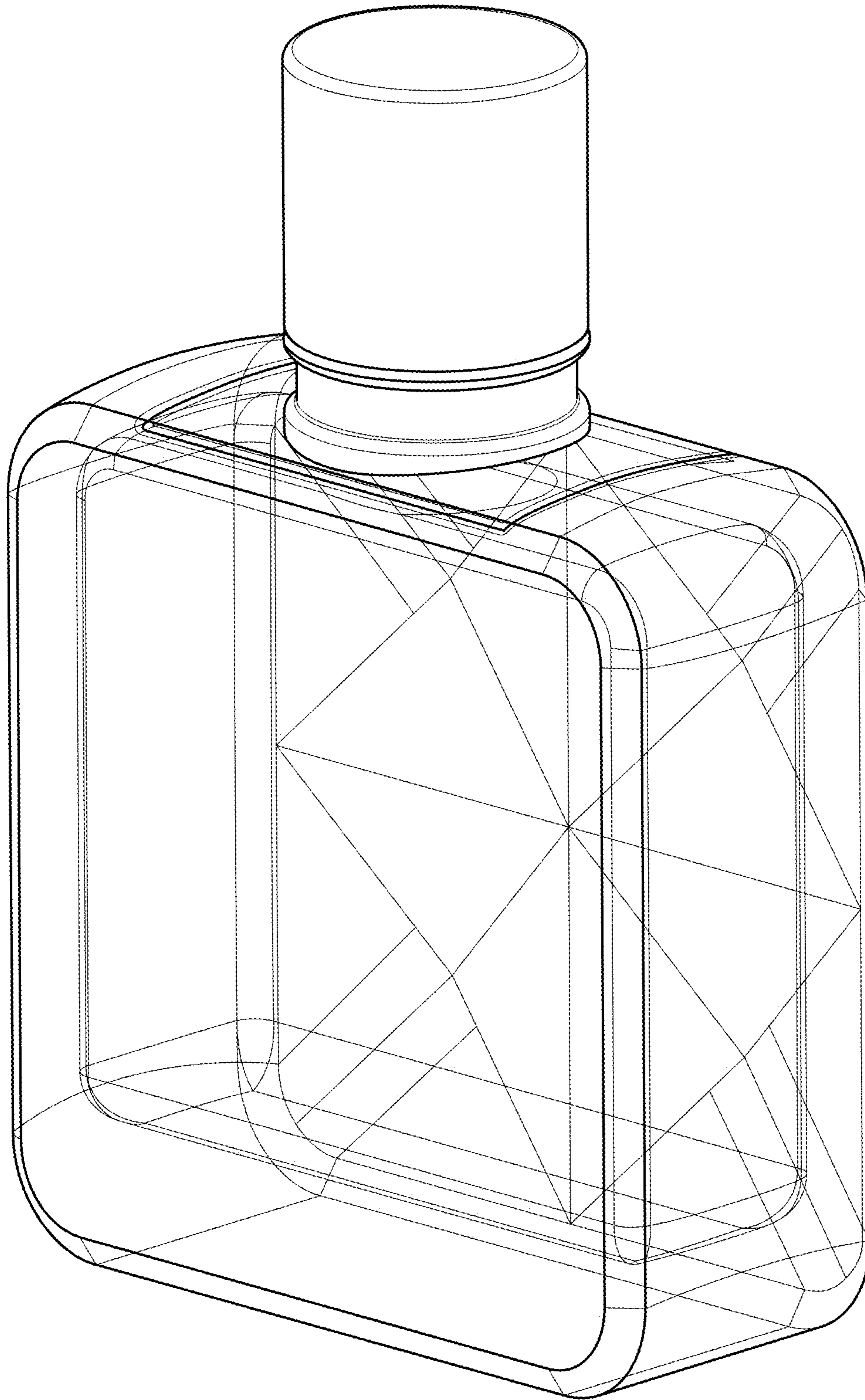

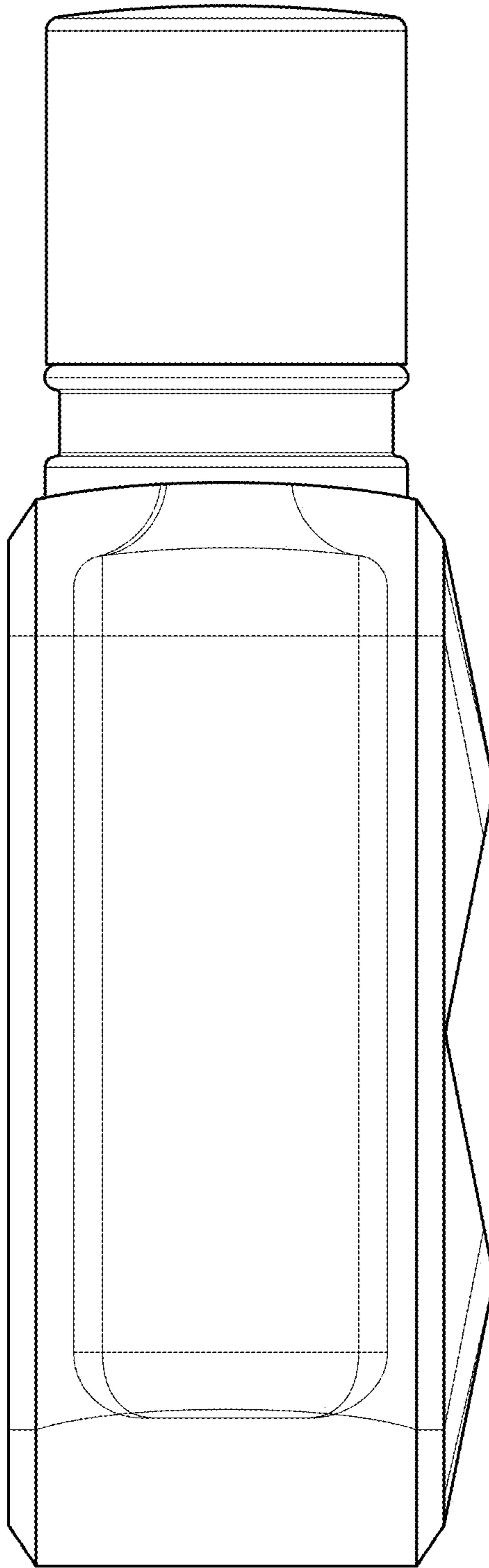

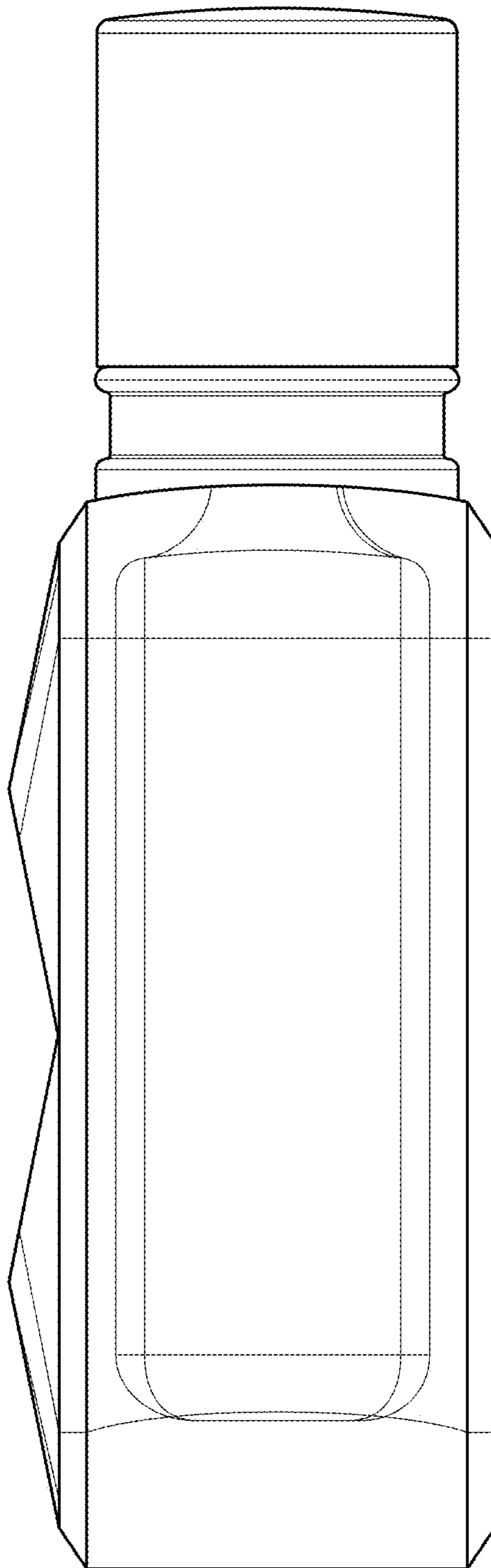

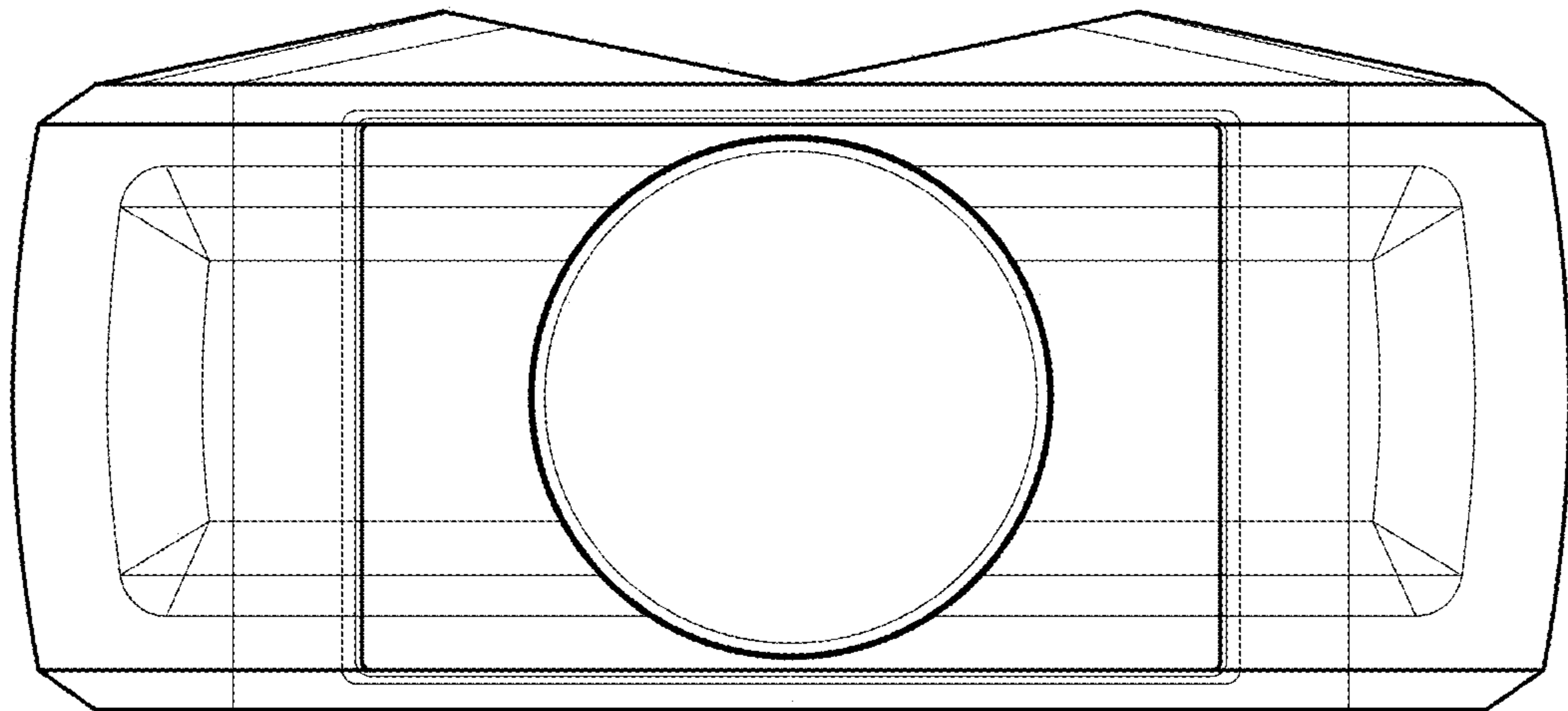

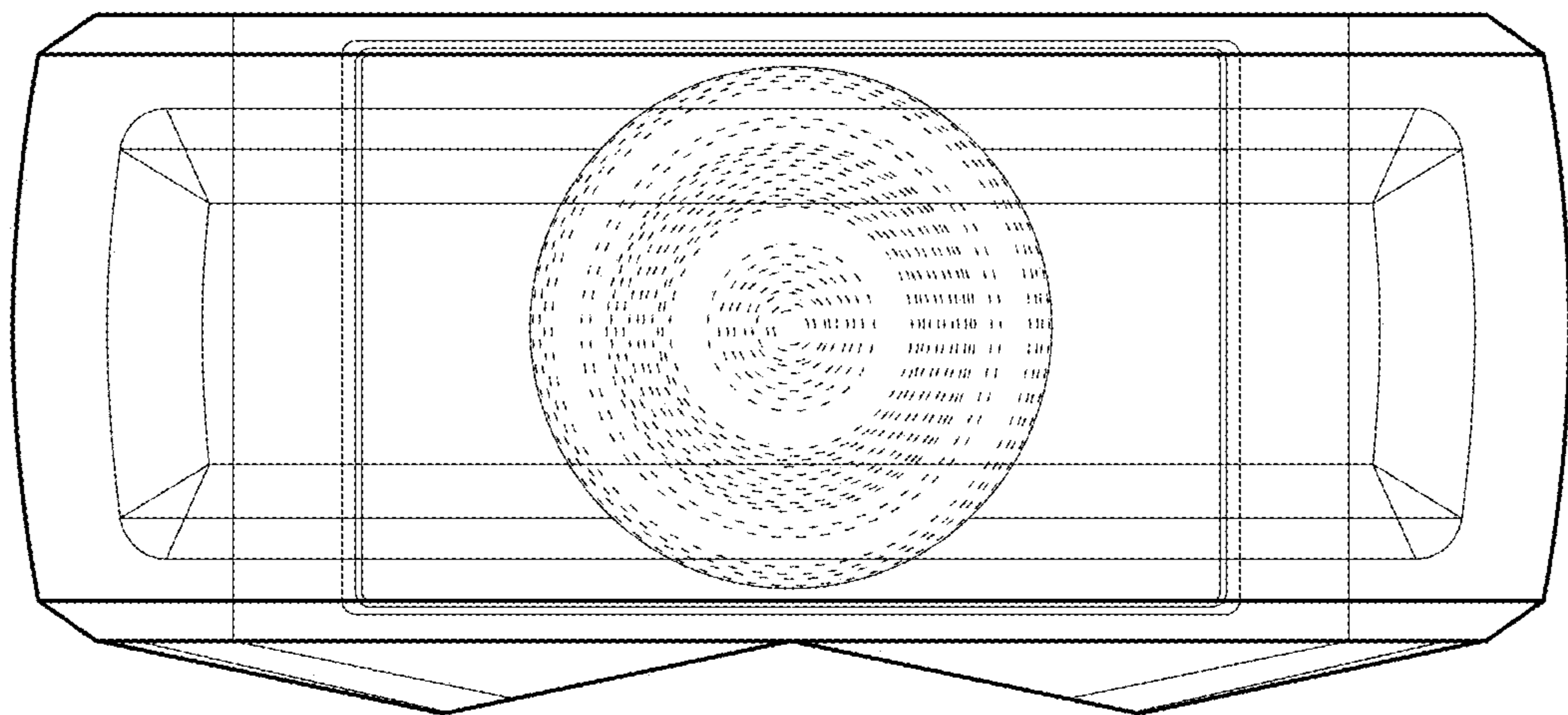
