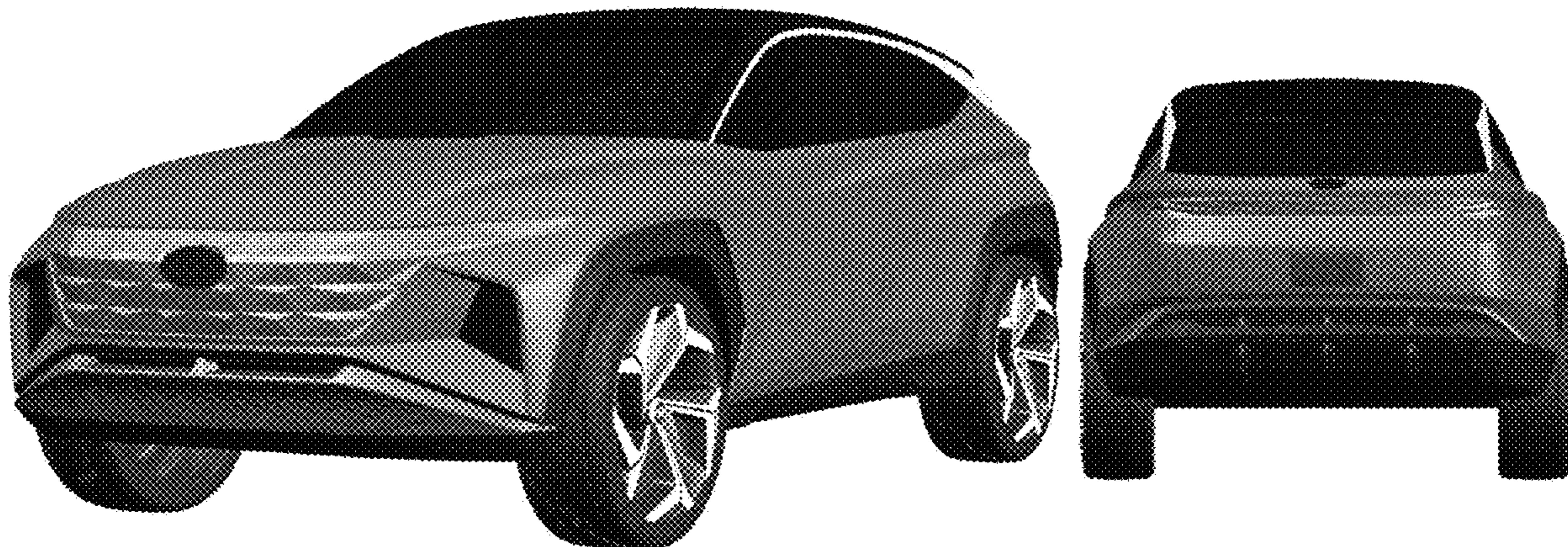
Reproduction **1.1** is a perspective view of a motor car

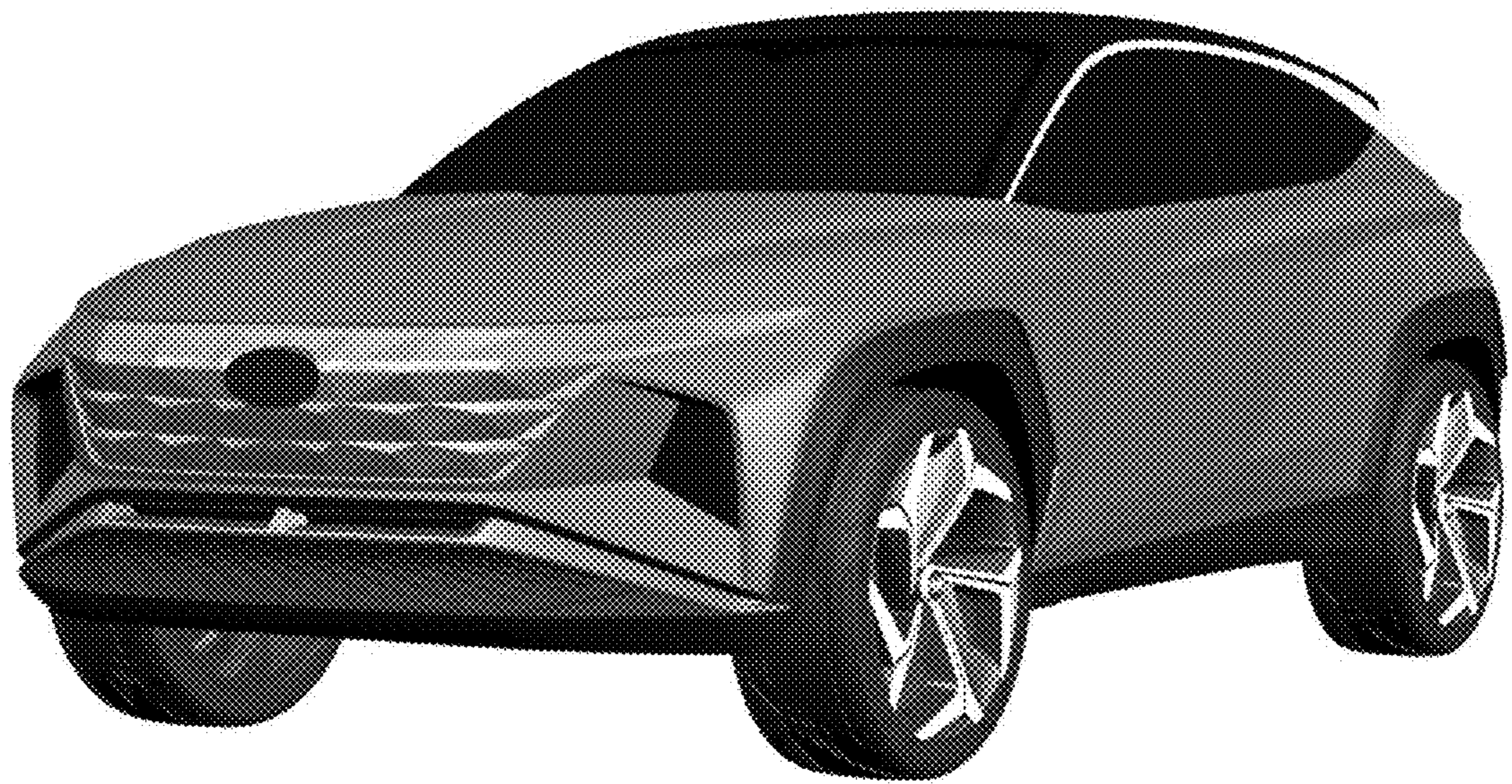

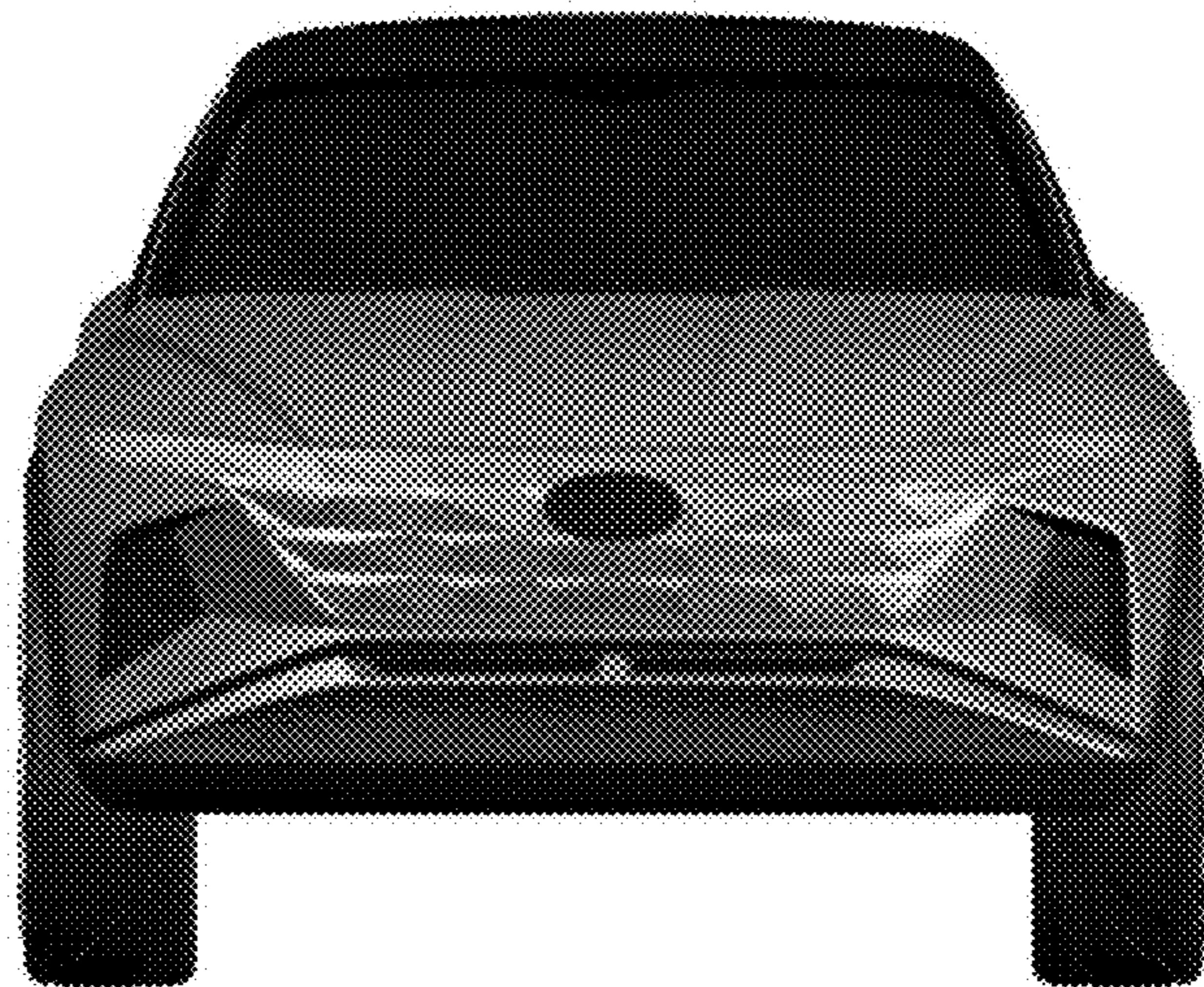

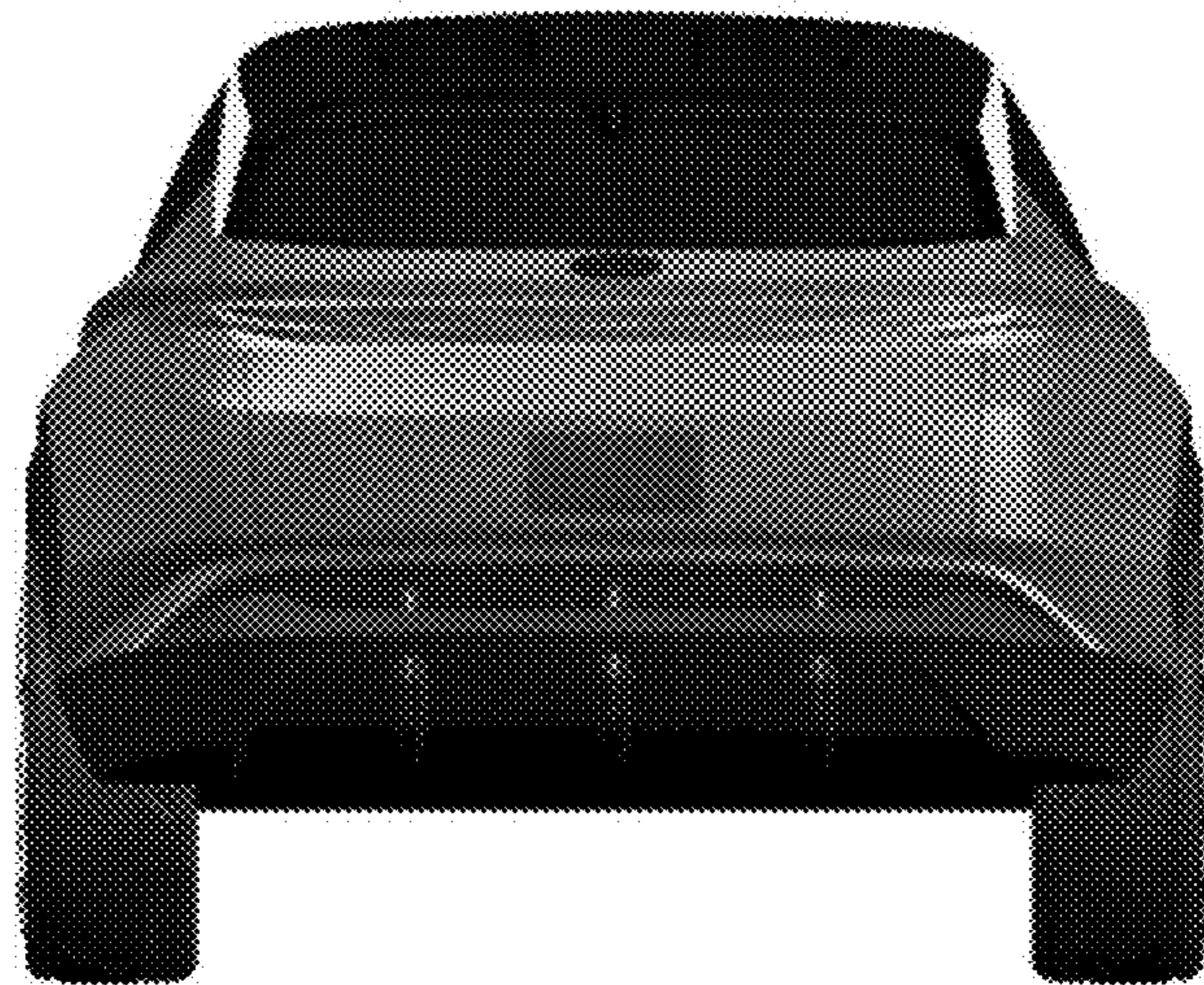

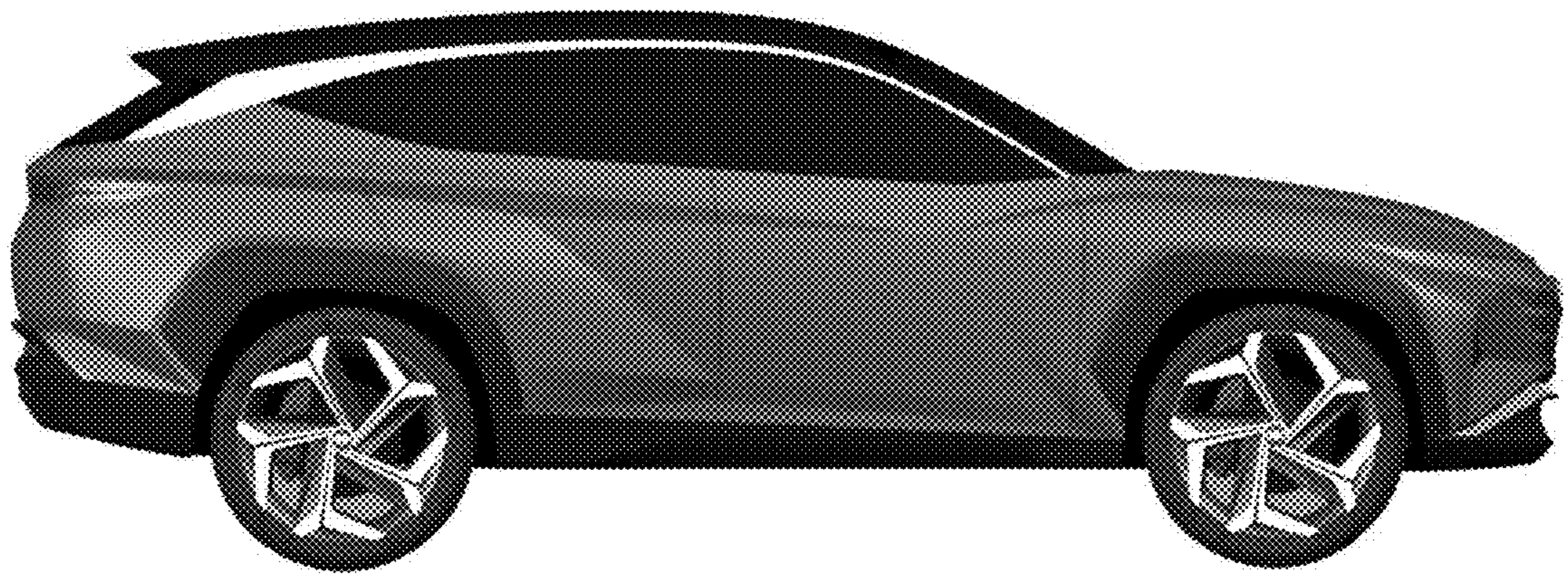

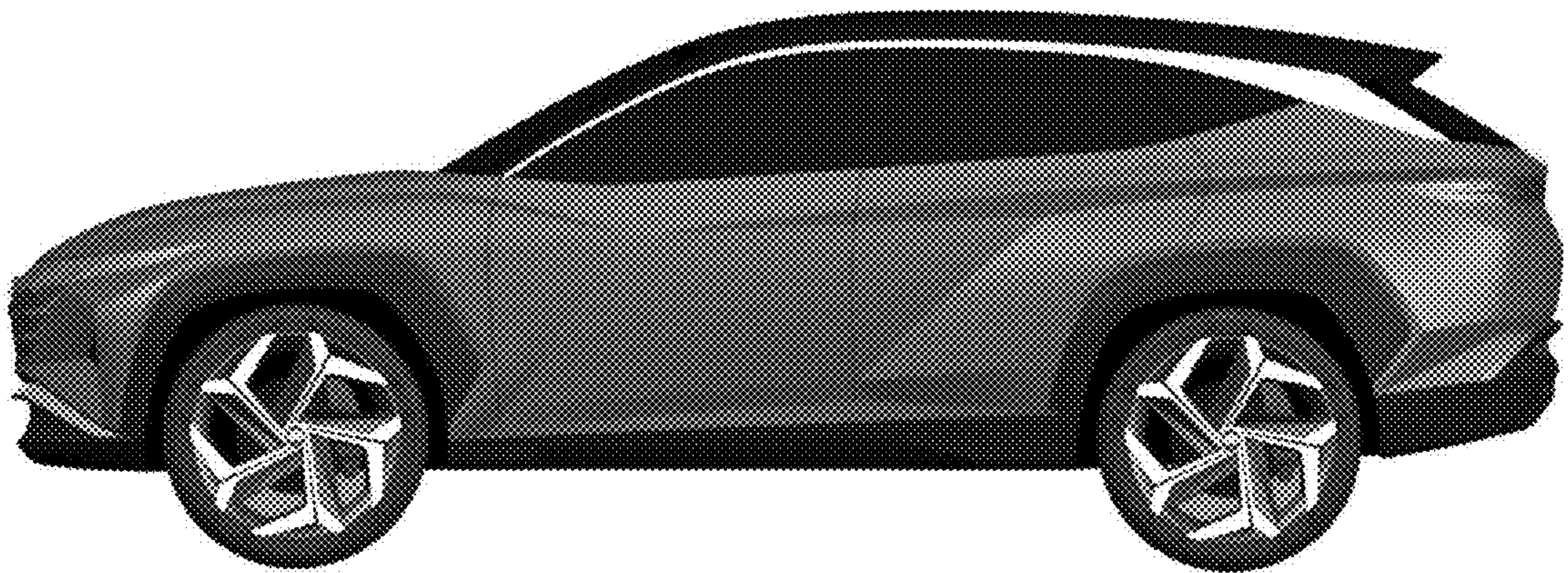
