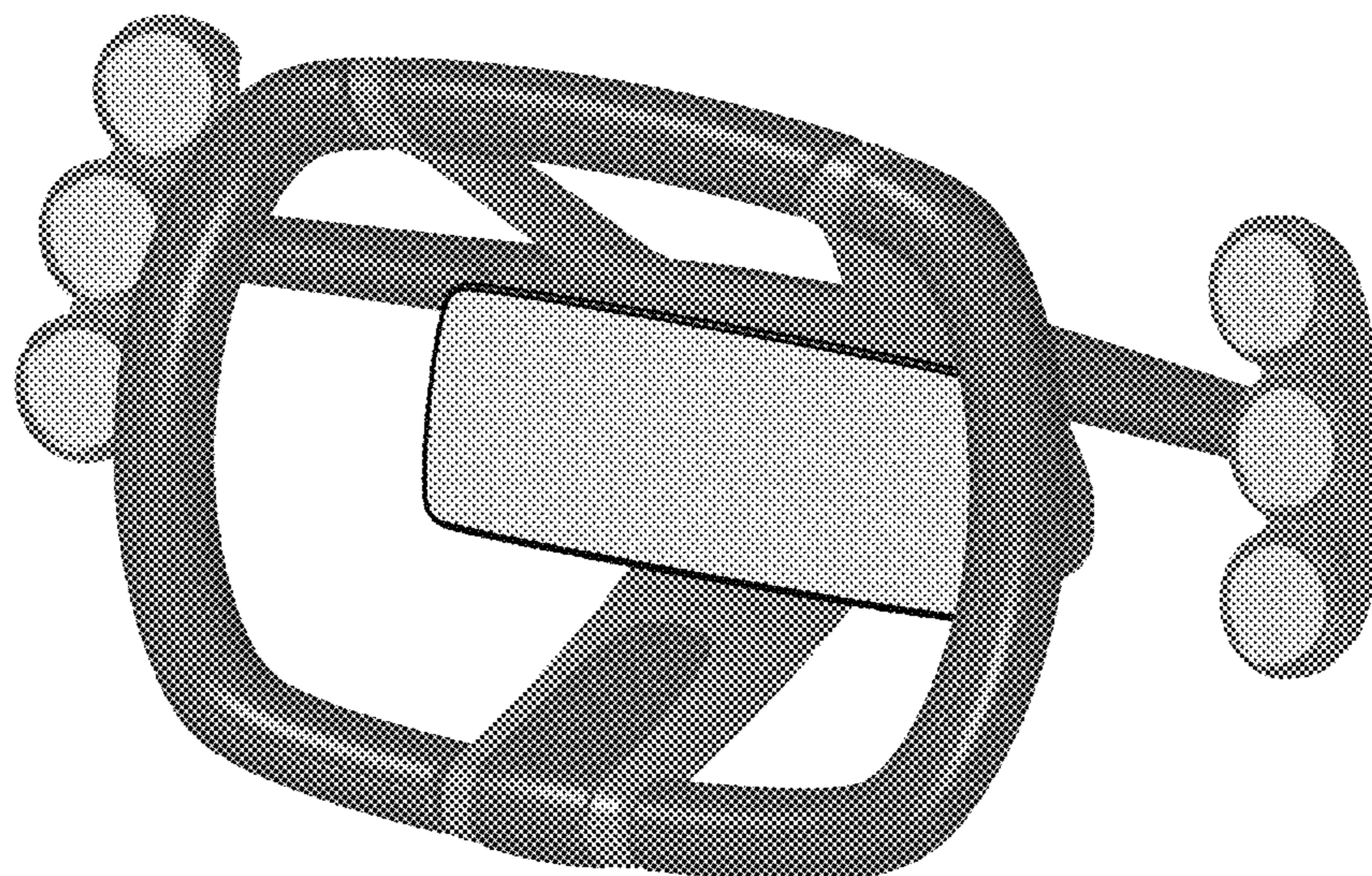
(57) **CLAIM**

DESCRIPTION

1. Steering wheel with display screens for an automobile
1.1 is a perspective view of a steering wheel with display screen for an automobile embodying our new design;

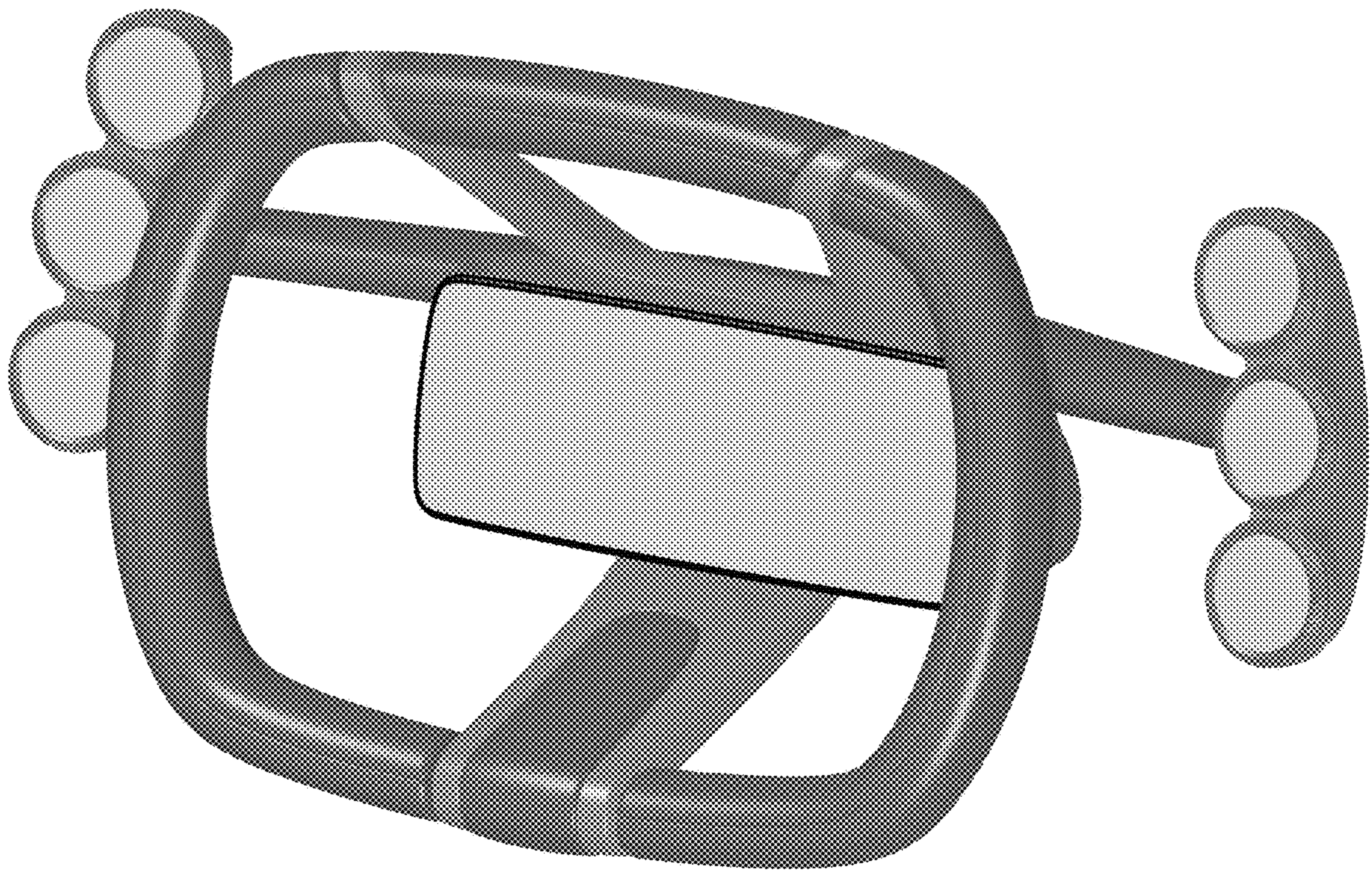

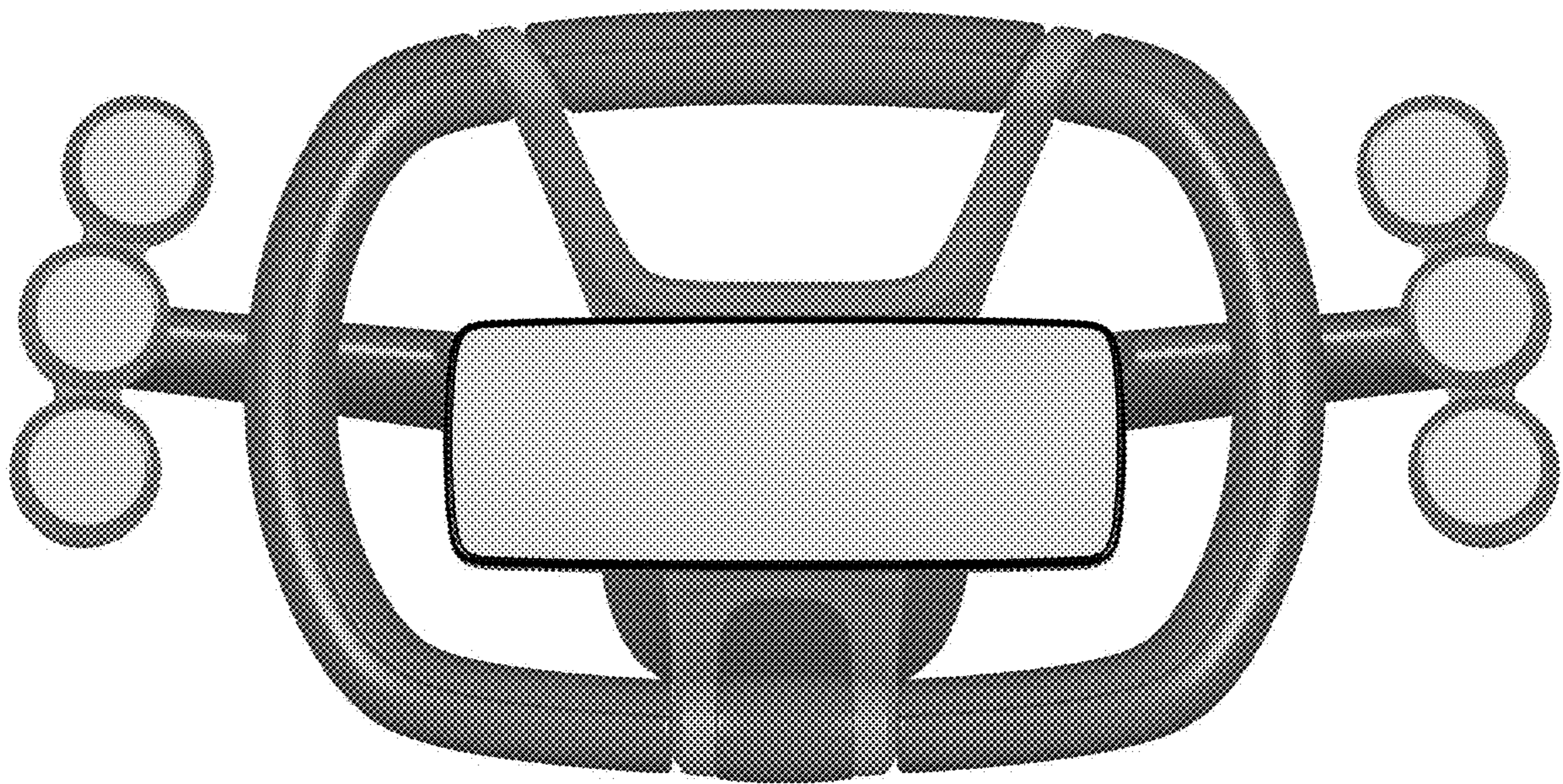

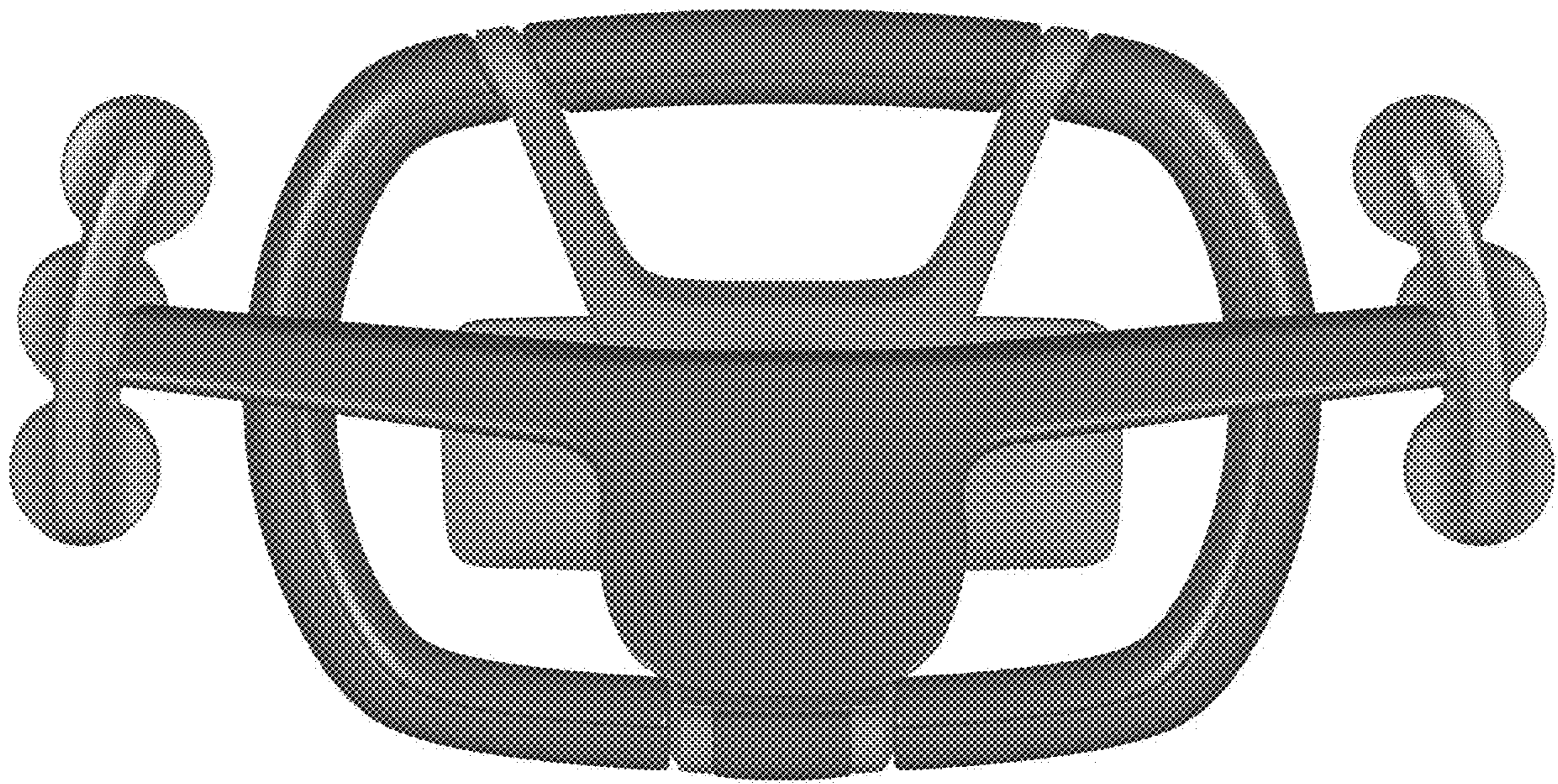

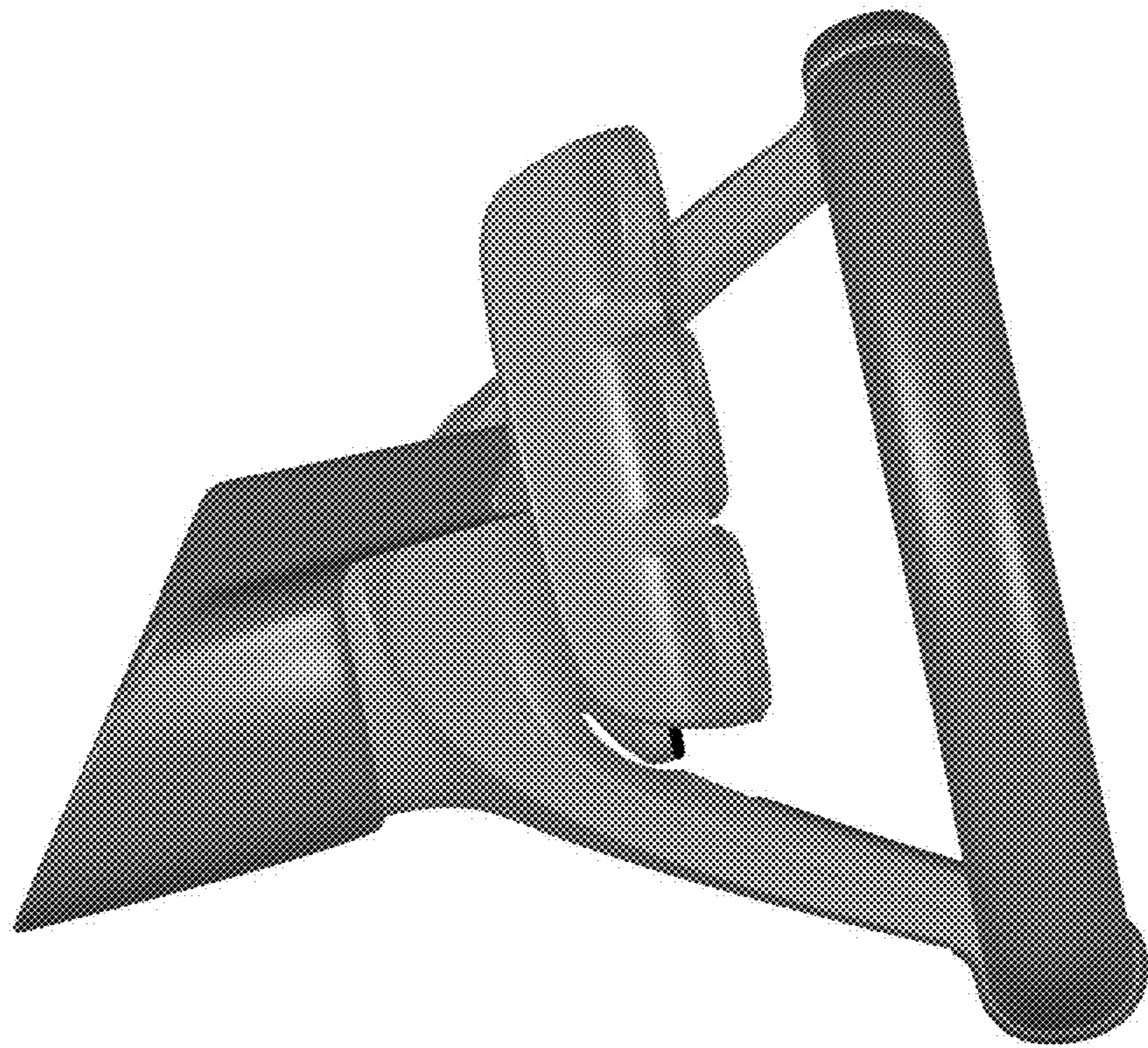

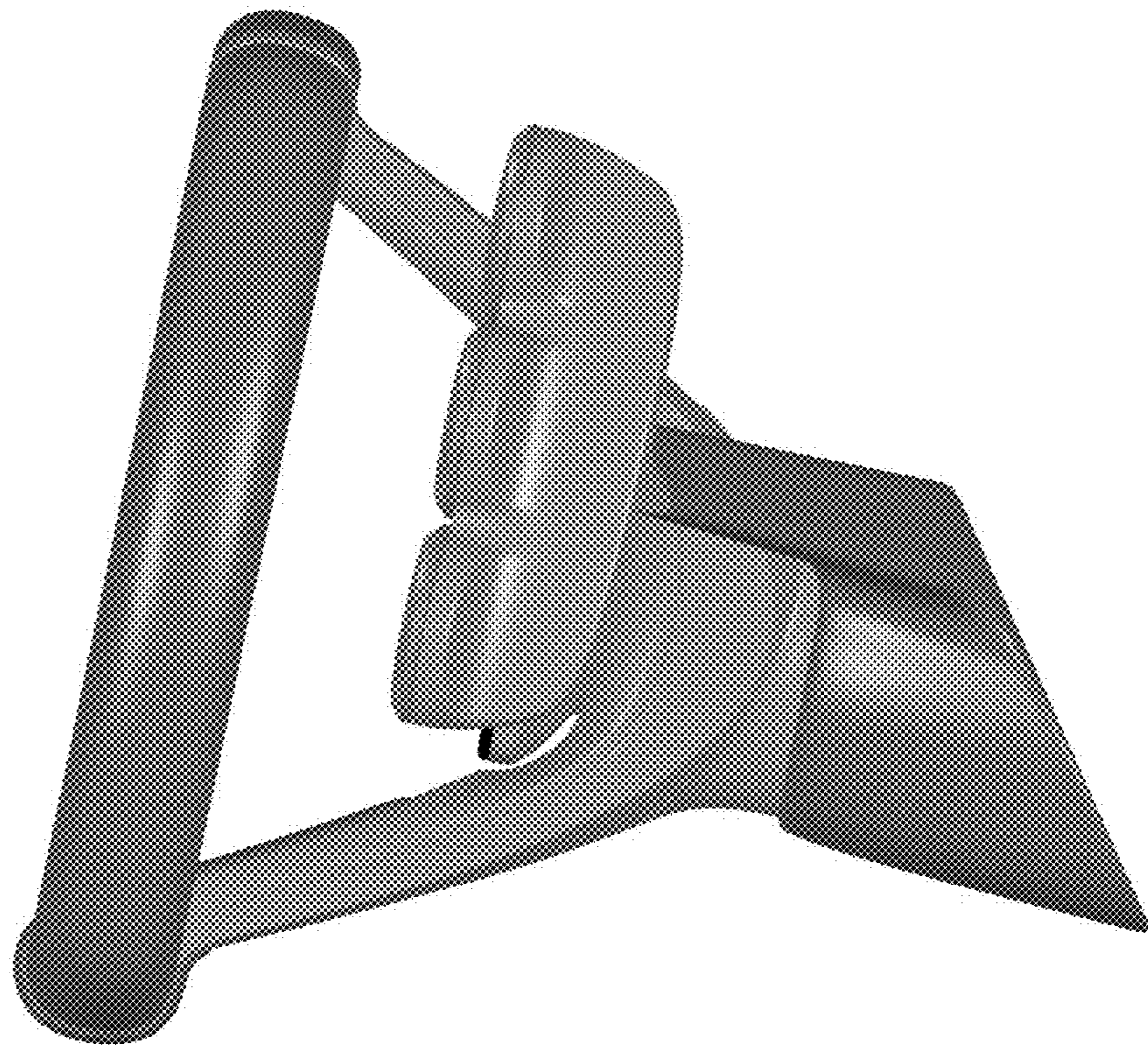

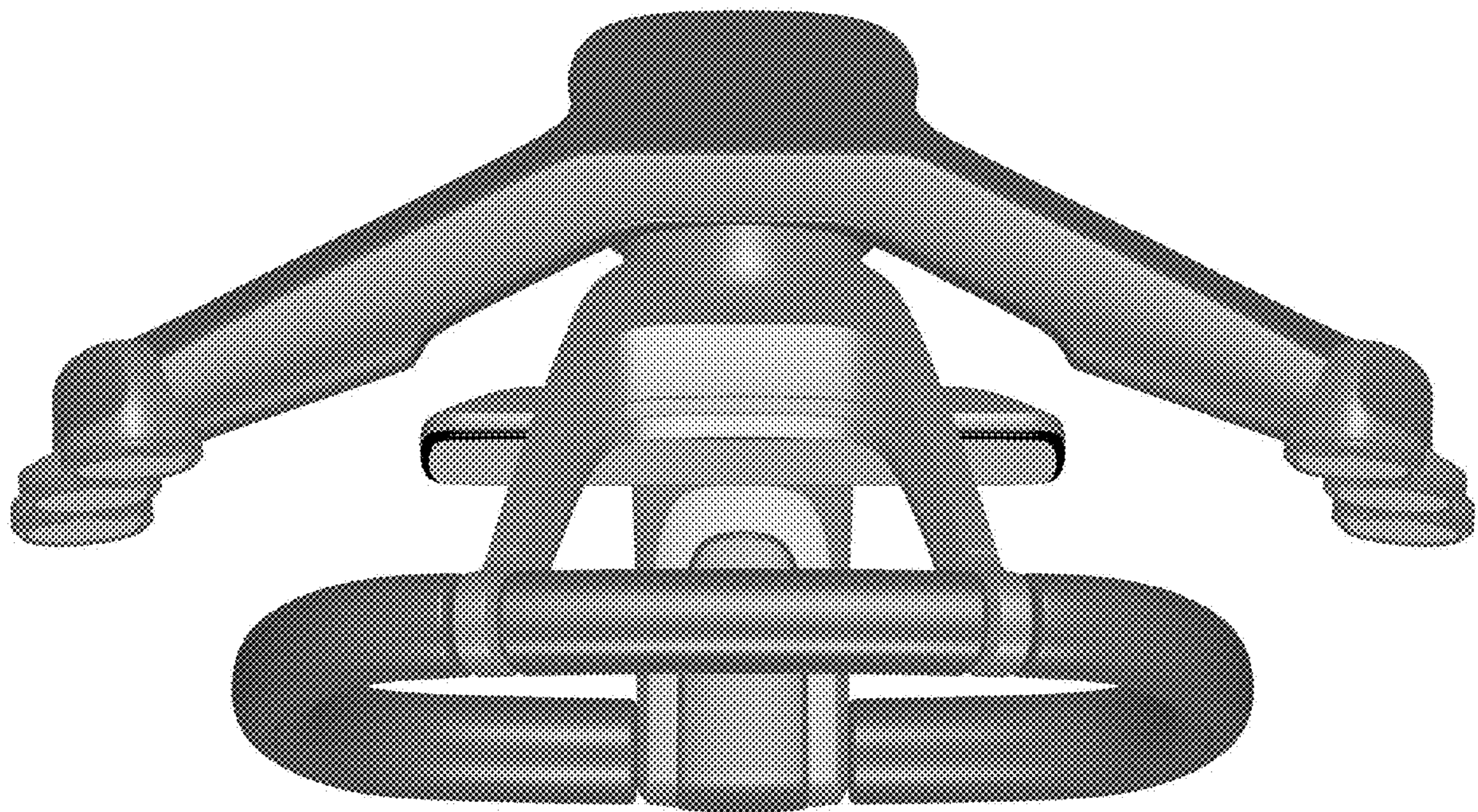
