(57) **CLAIM**

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIGS. 1 through 8 relate to the first embodiment of our new tire design. FIGS. 9 through 16 relate to the second embodiment of our new tire design.

FIG. 1 is a perspective view of the first embodiment of the tire;

FIG. 2 is a front view of the tire;

FIG. 3 is a right view of the tire;

FIG. 4 is a left view of the tire;

FIG. 5 is an enlarged view of the tire with section lines related to views 6, 7, 8;

FIG. 6 is a first transversal section view of the tire taken along line 6-6;

FIG. 7 is a second transversal section view of the tire taken along line 7-7;

FIG. 8 is a third transversal section view of the tire taken along line 8-8;

FIG. 9 is a perspective view of the second embodiment of the tire;

FIG. 10 is a front view of the tire;

FIG. 11 is a right view of the tire;

FIG. 12 is a left view of the tire;

FIG. 13 is an enlarged view of the tire with section lines related to views 14, 15, 16;

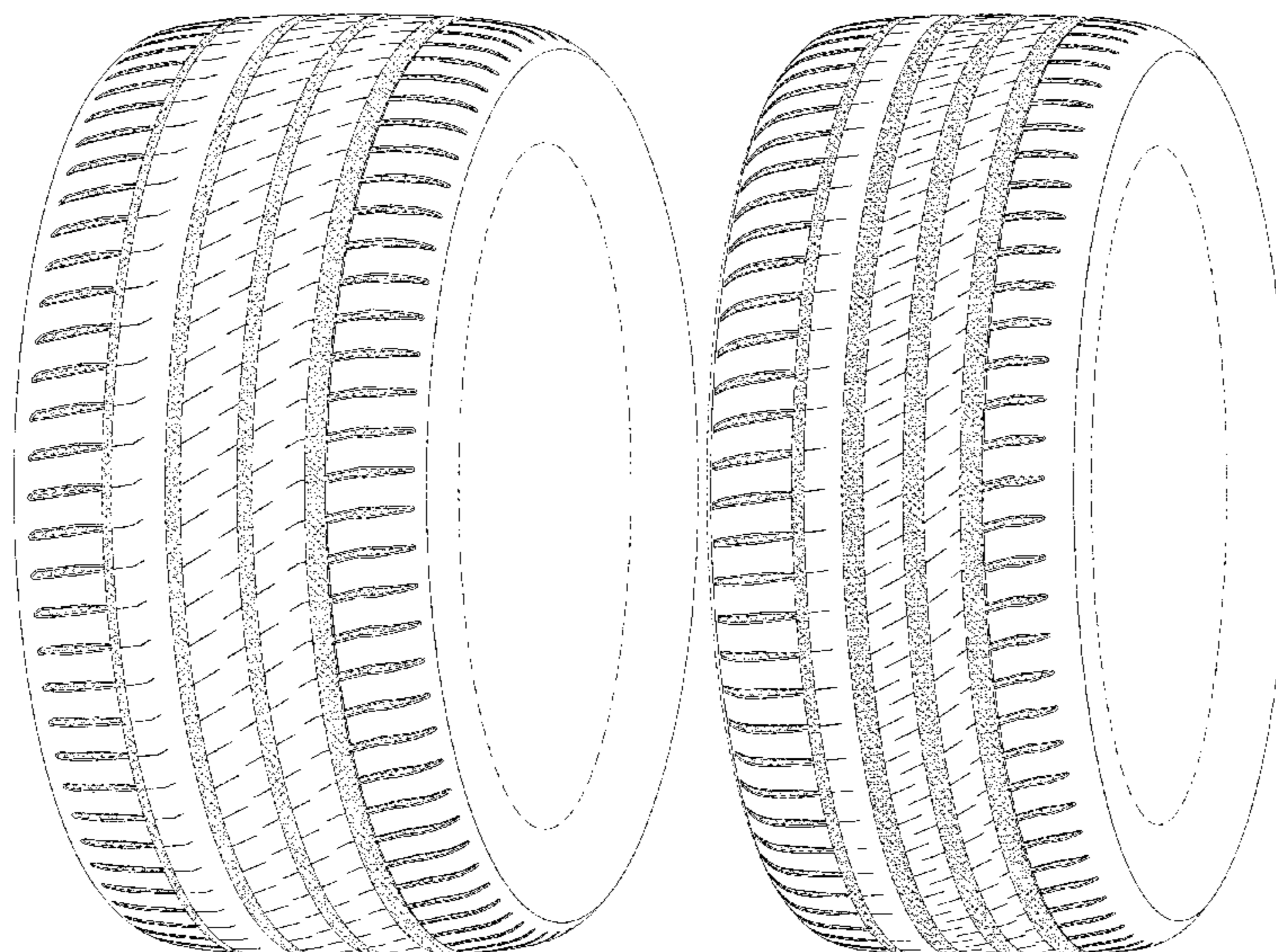
FIG. 14 is a first transversal section view of the tire taken along line 14-14;

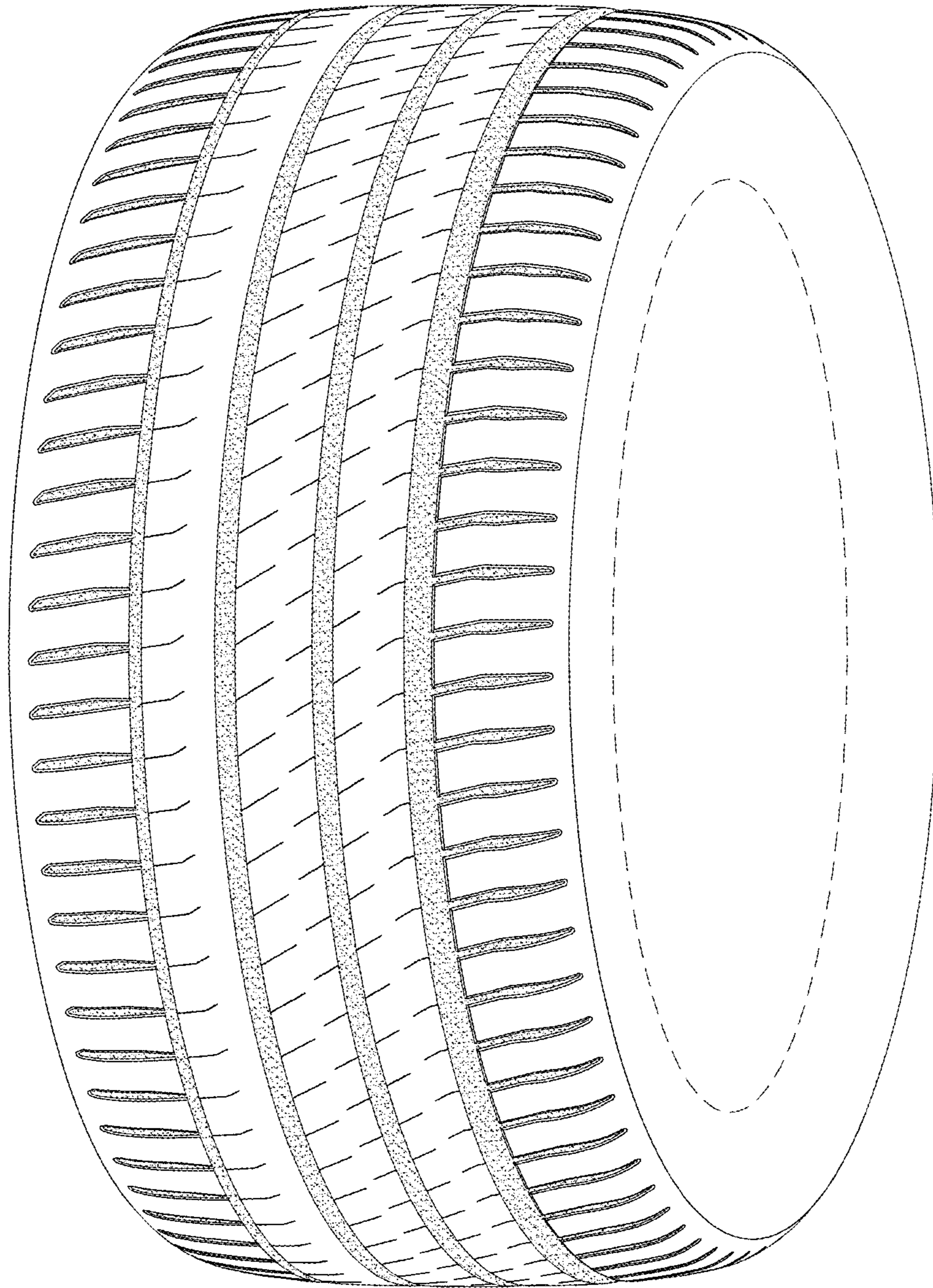

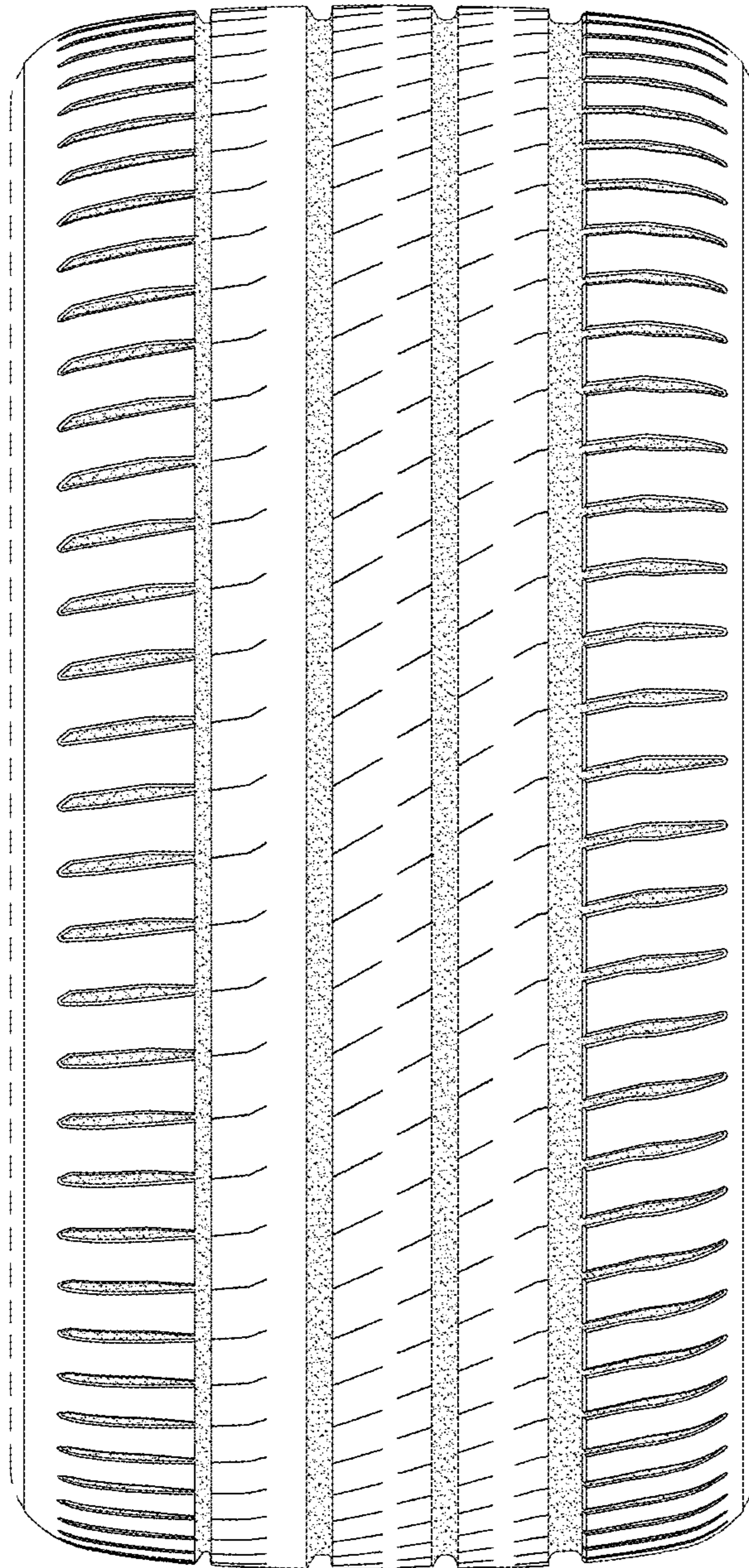

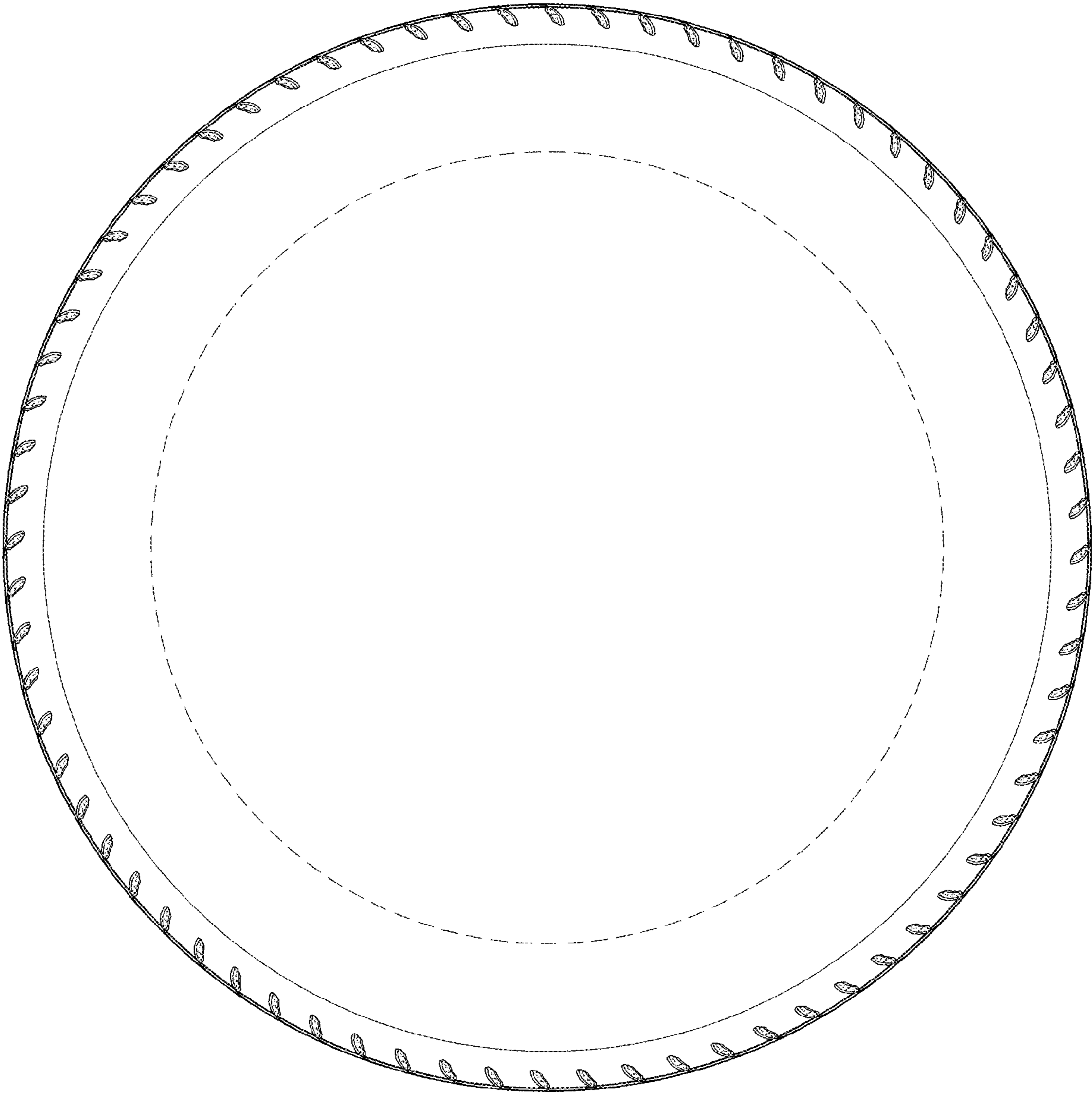

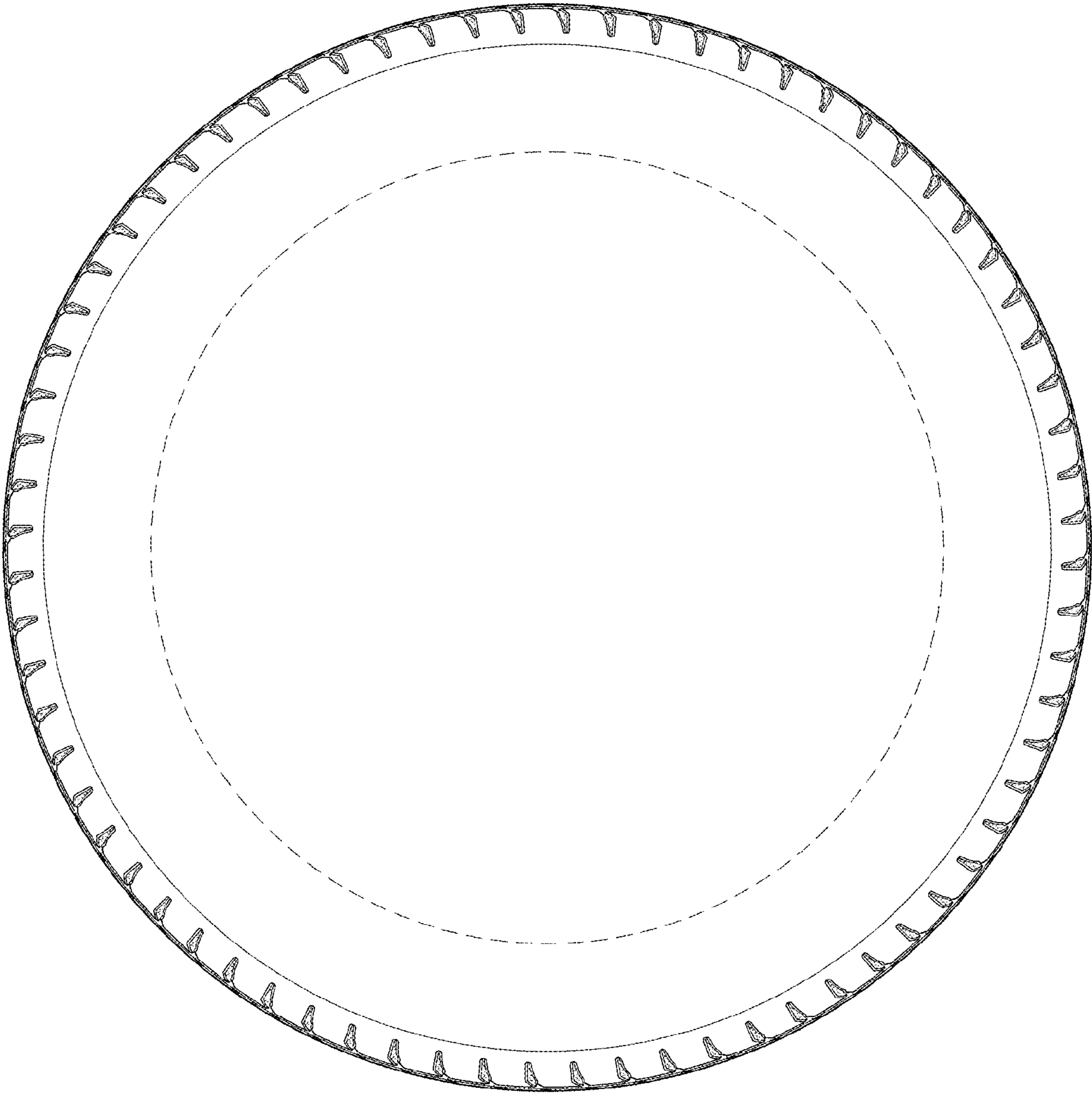

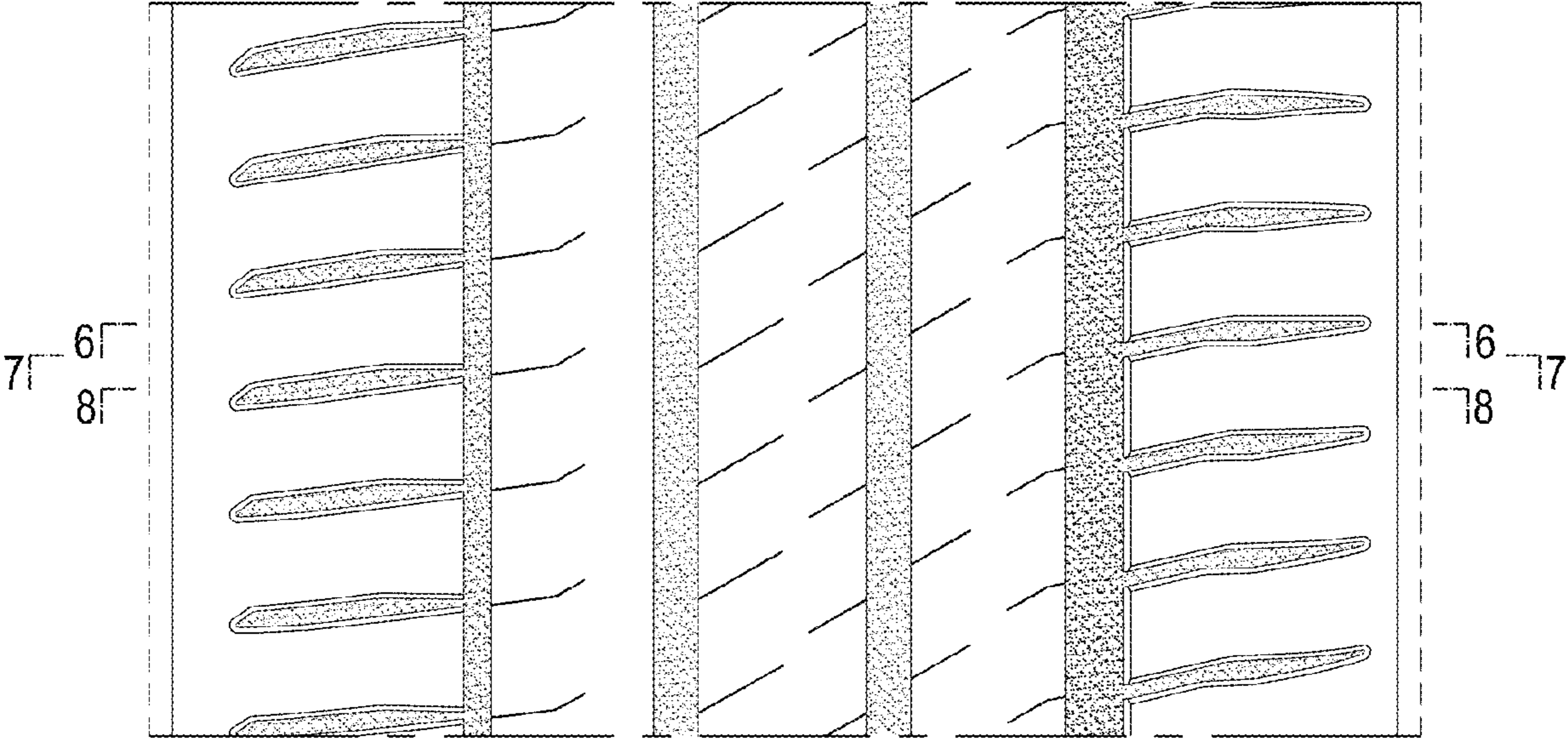

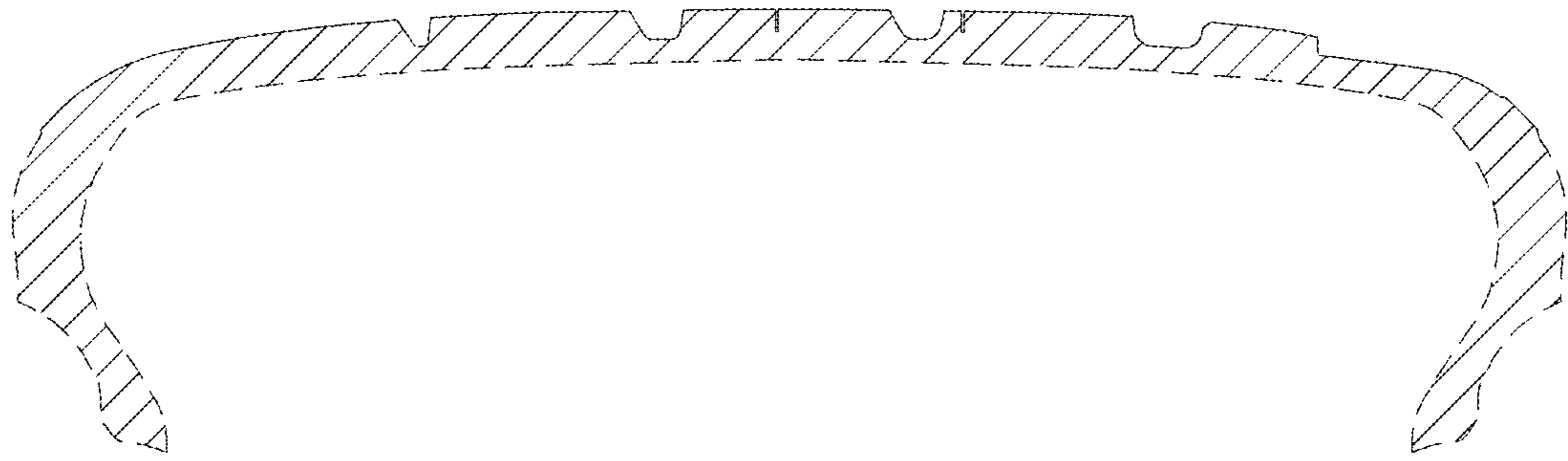

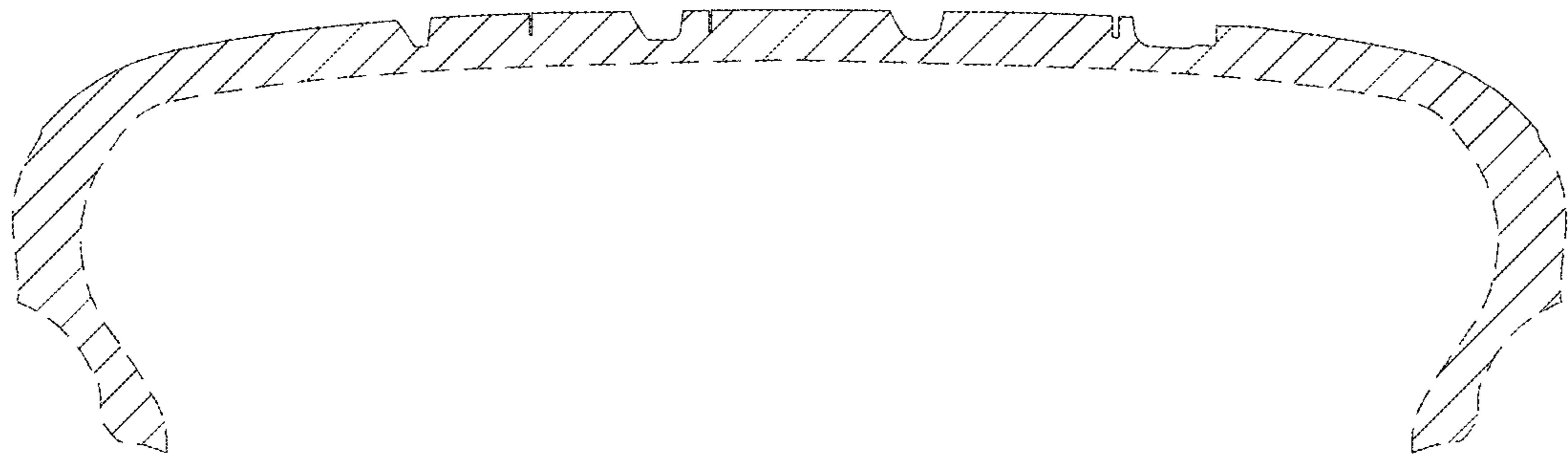

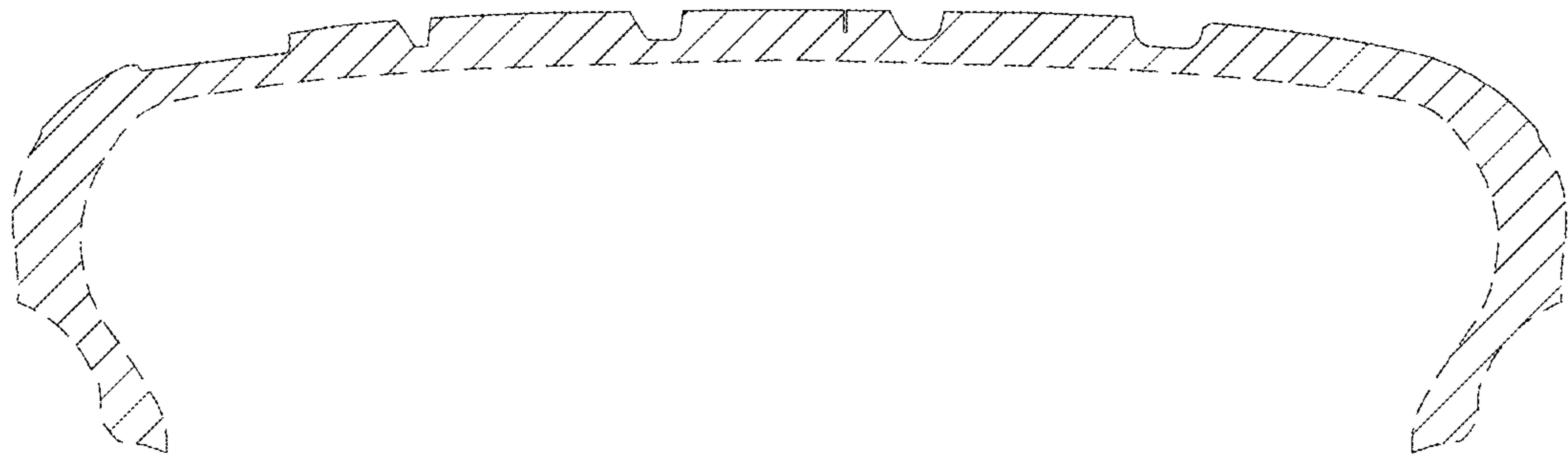

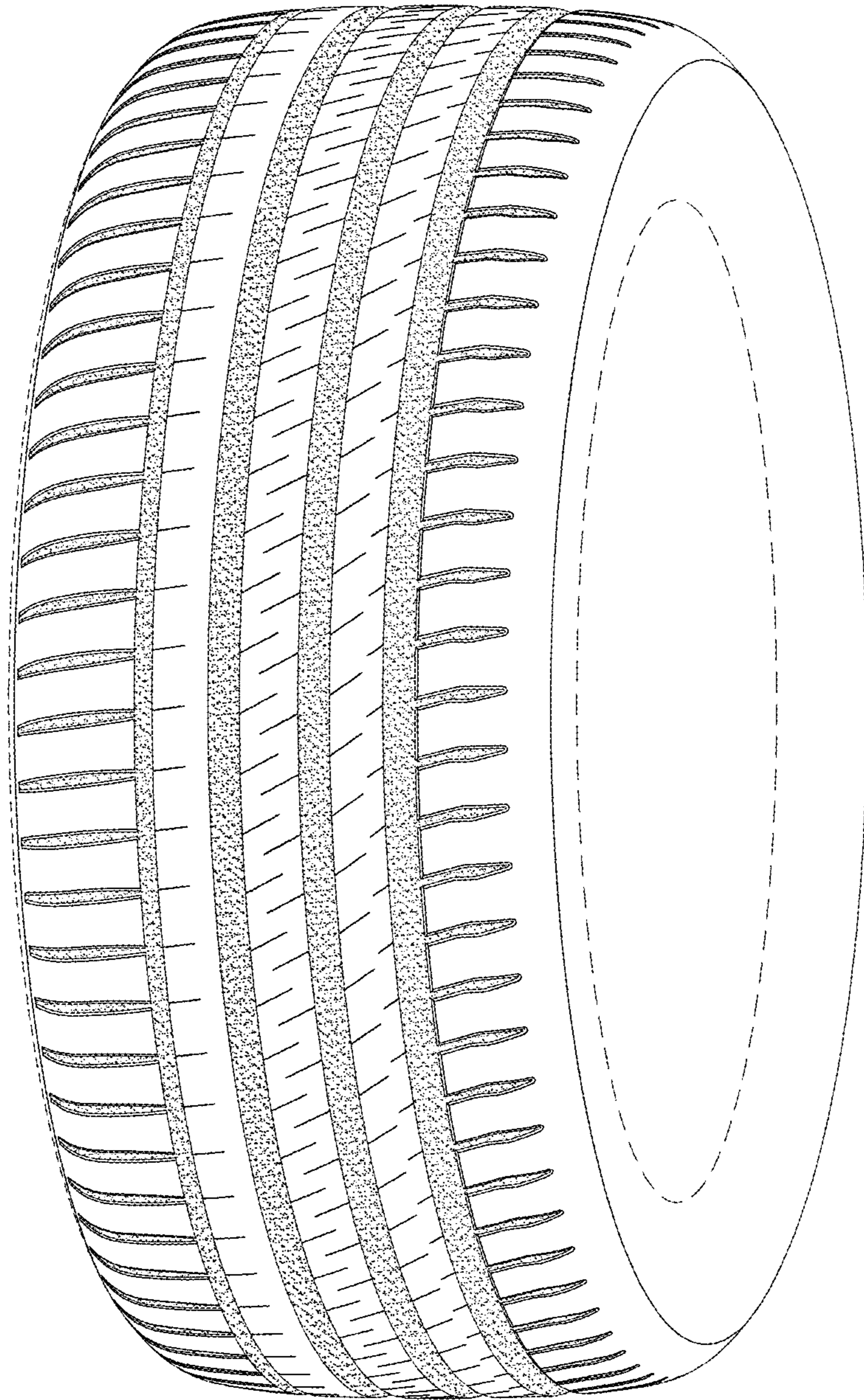

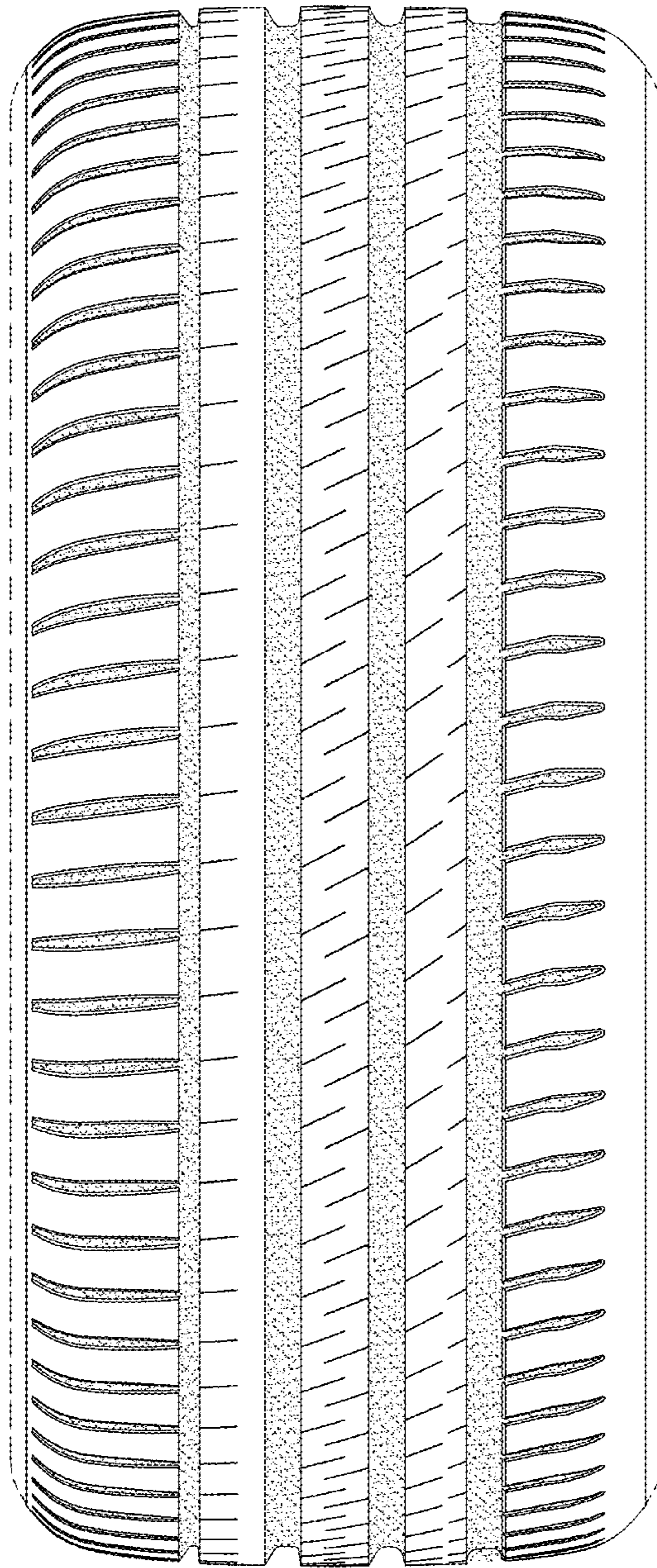

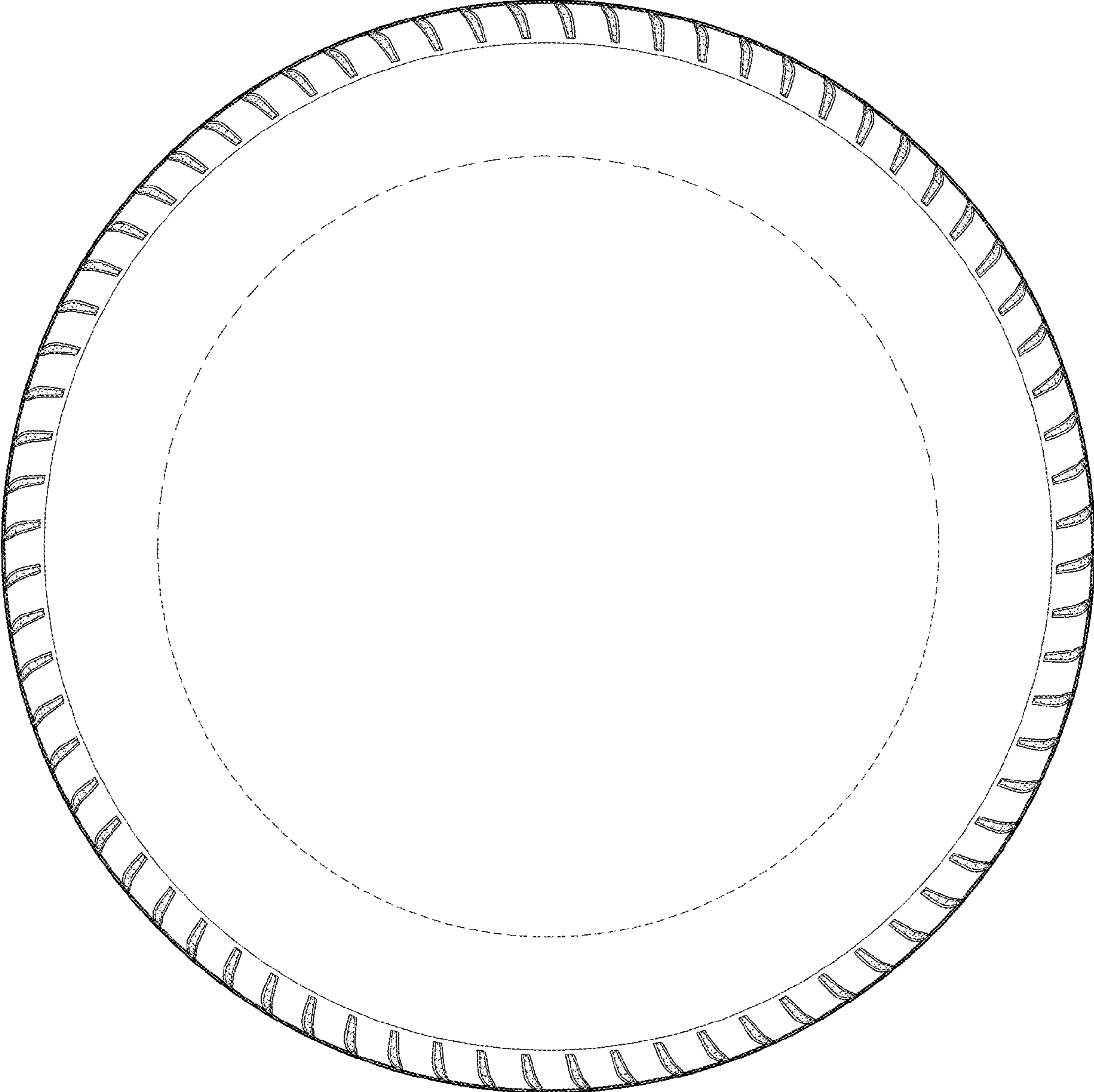

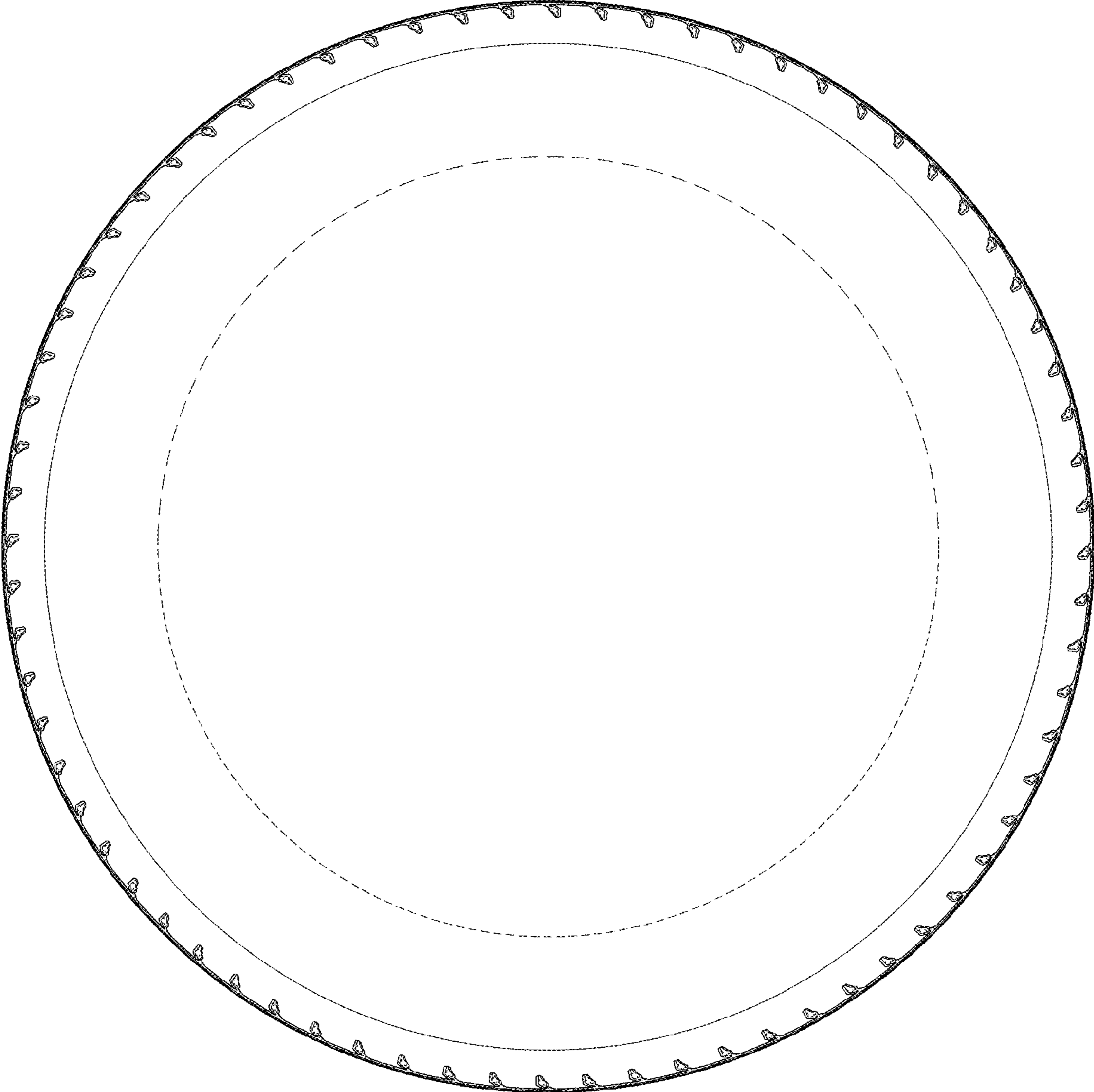

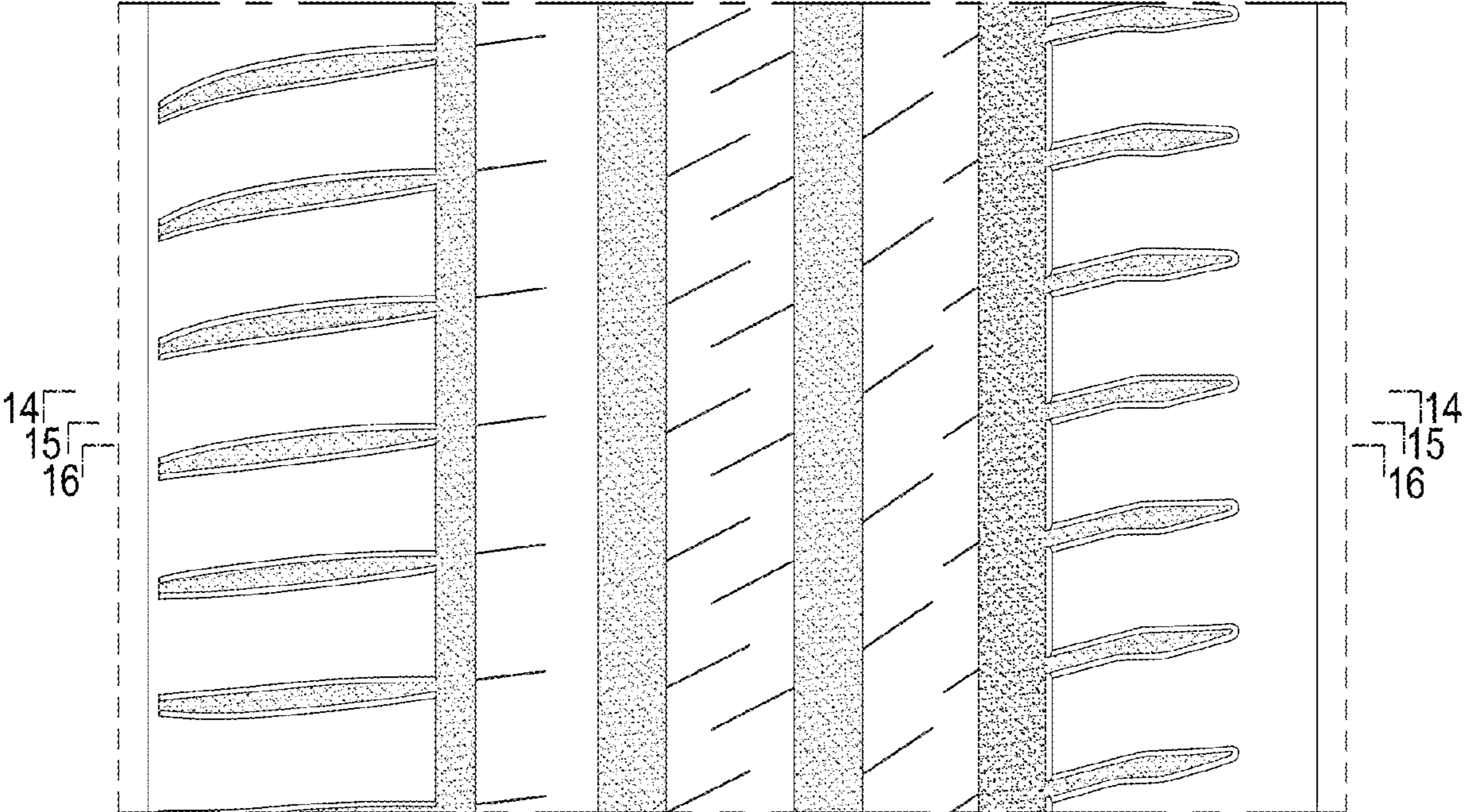

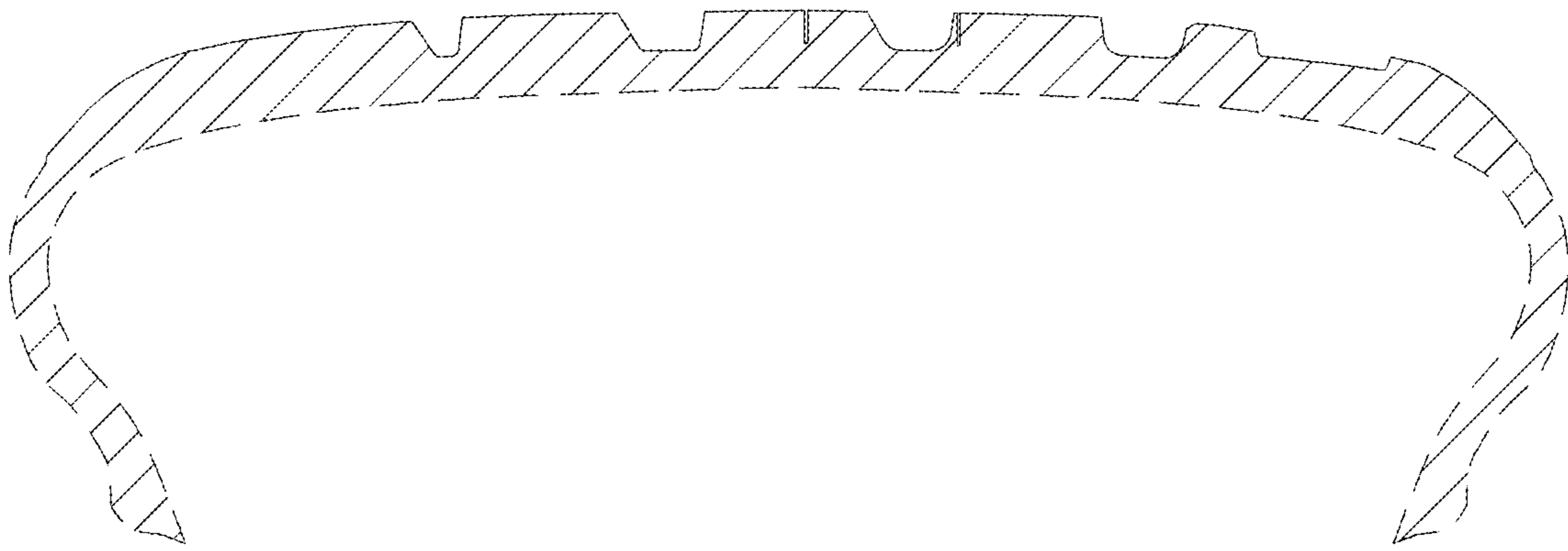

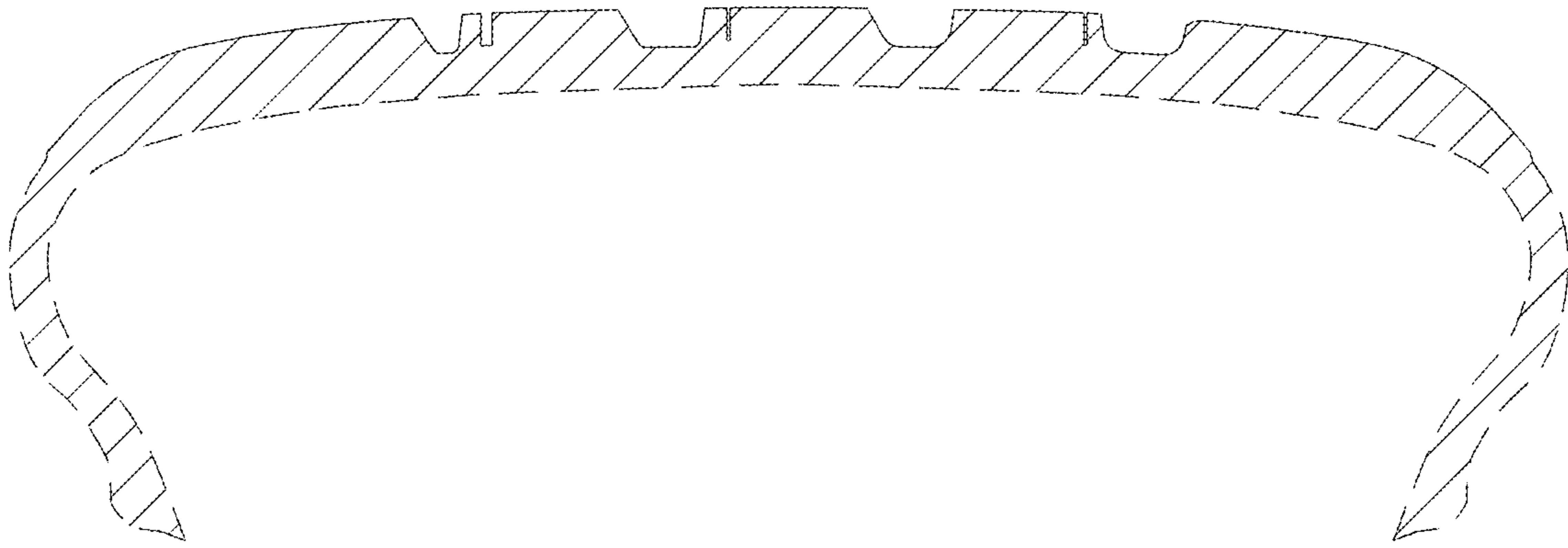

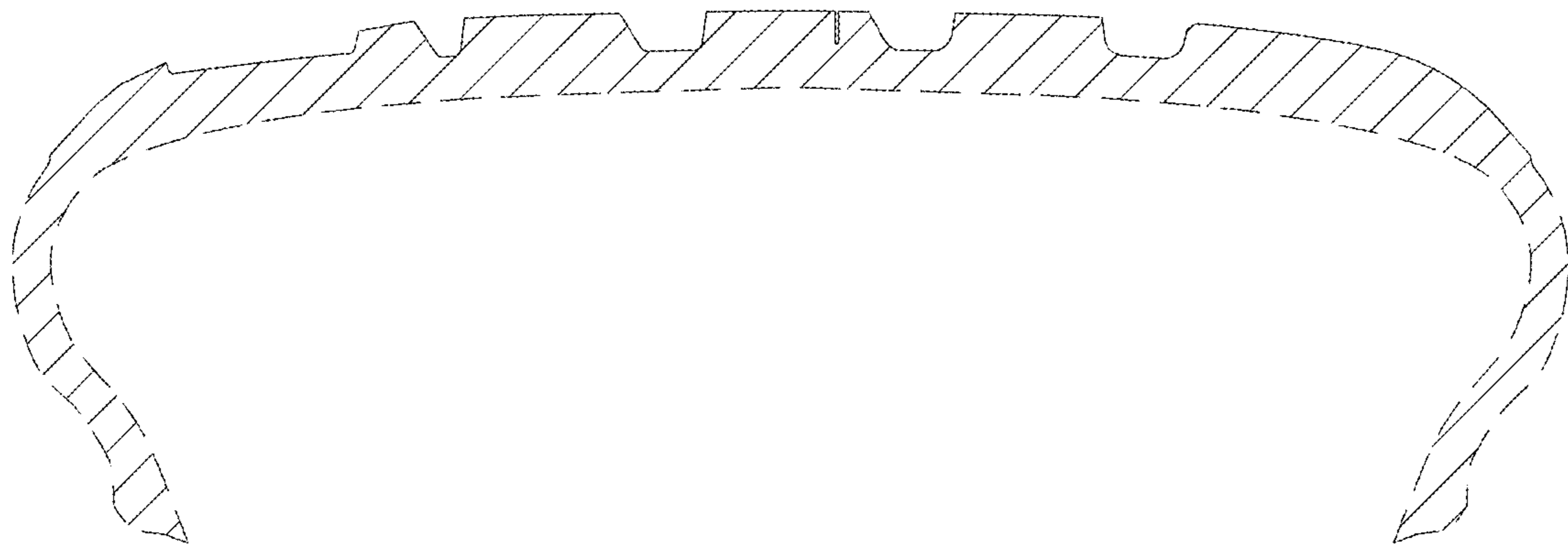
