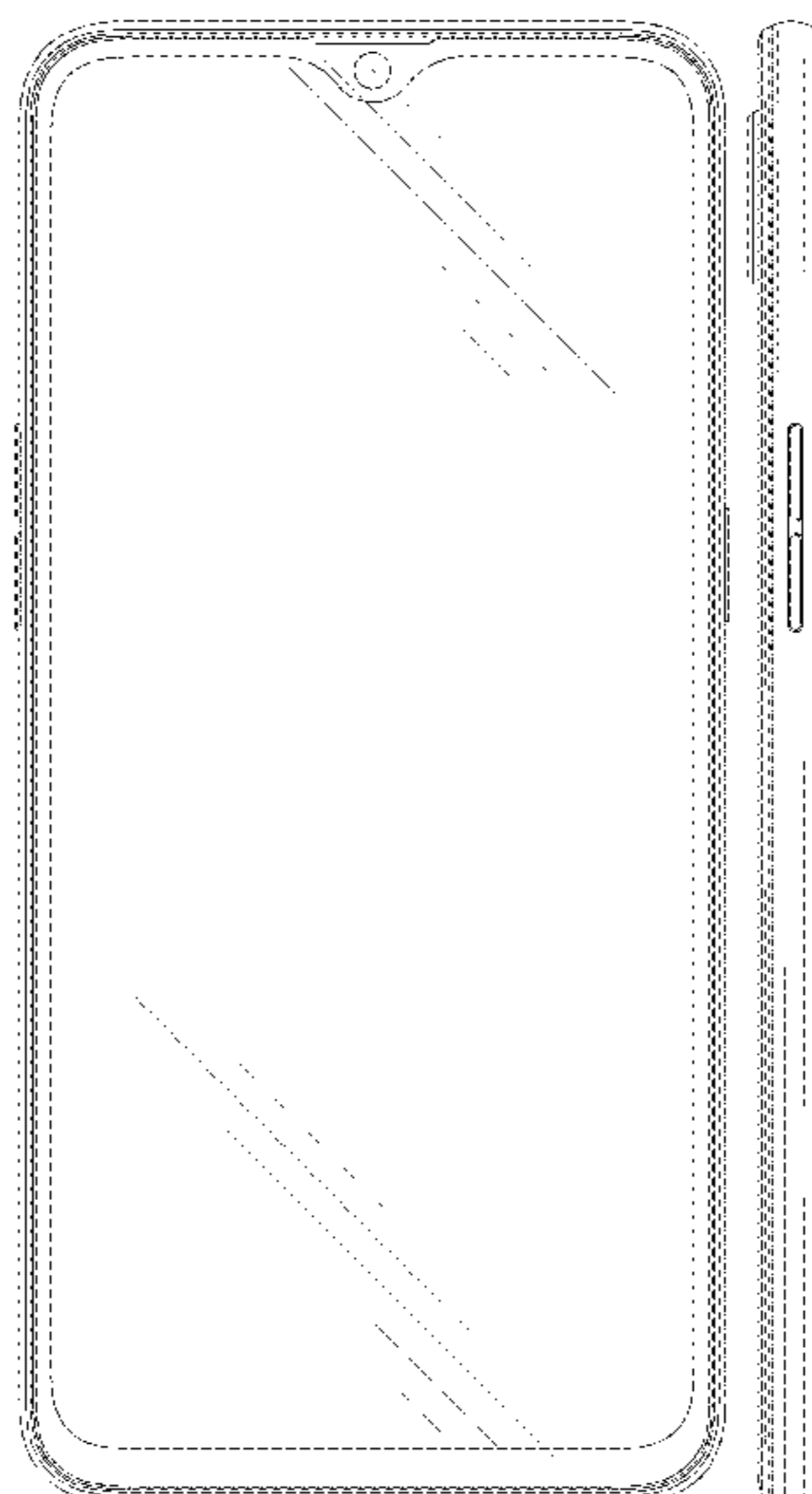
(57) **CLAIM**

The ornamental design for a mobile phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a mobile phone showing our new design;

FIG. 5 is a top view thereof;

The shade lines in the figures show contour and not surface ornamentation.

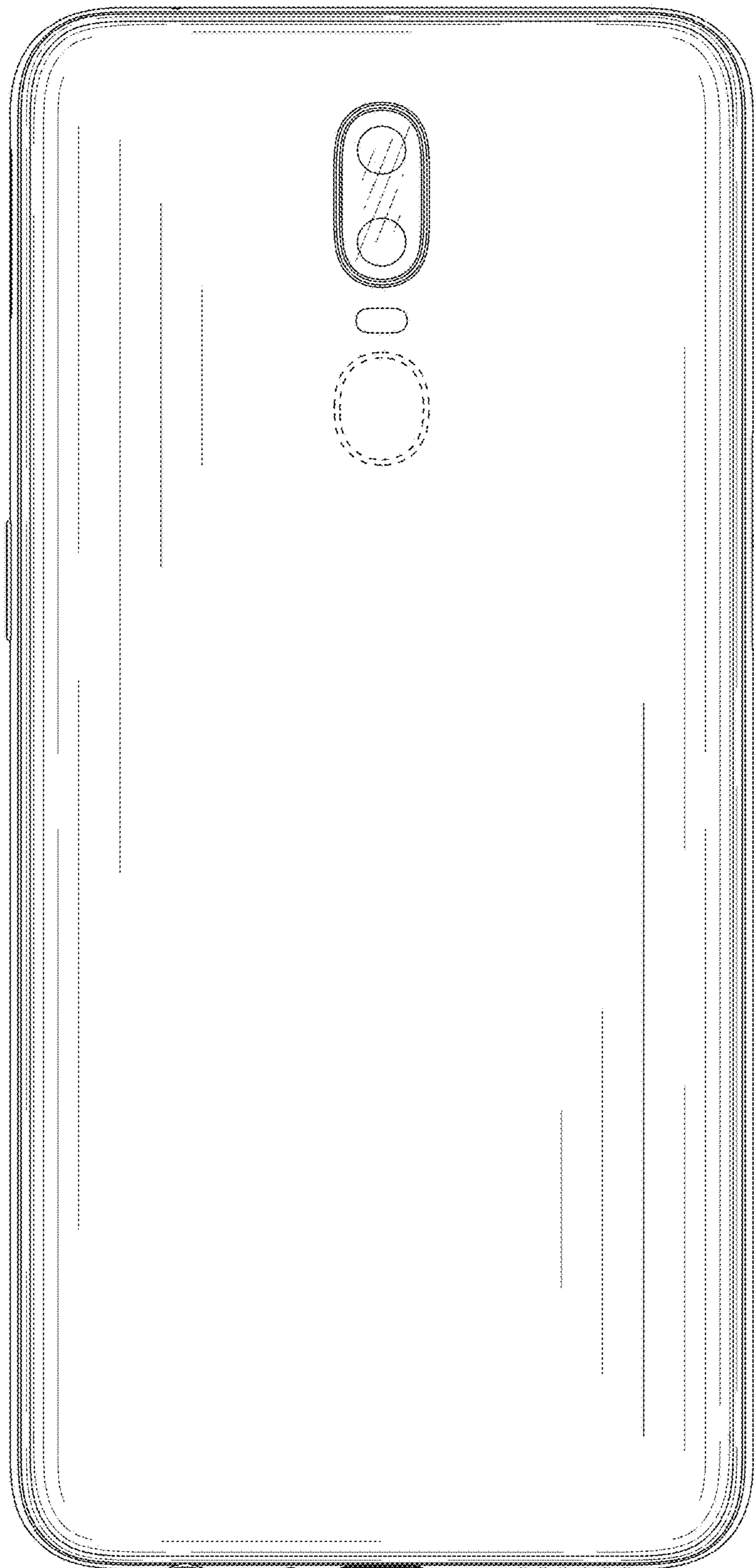
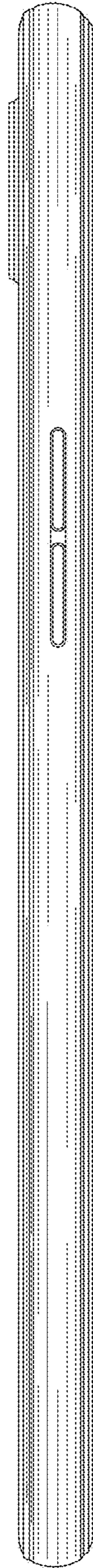
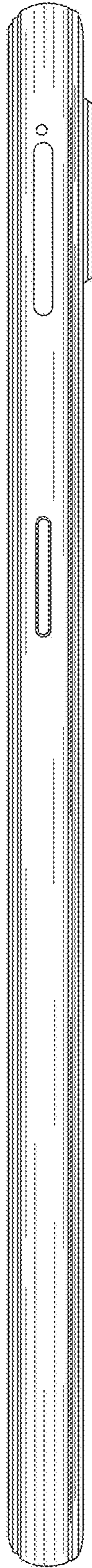


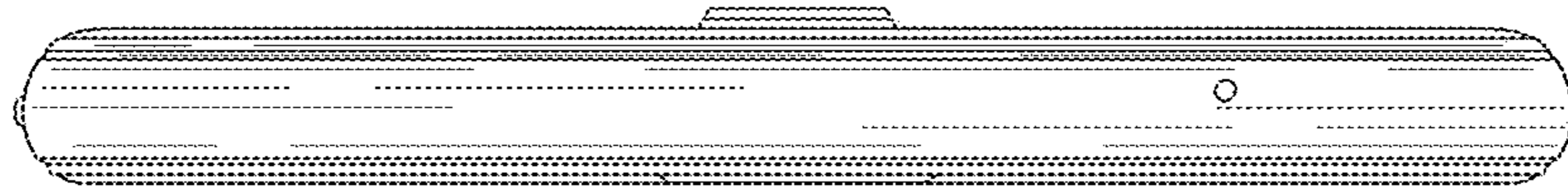

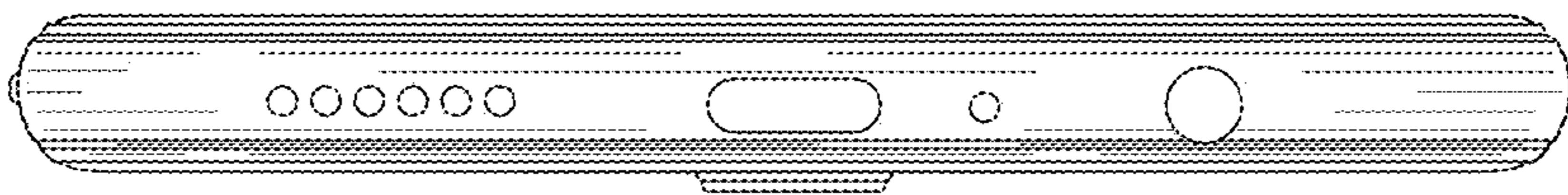

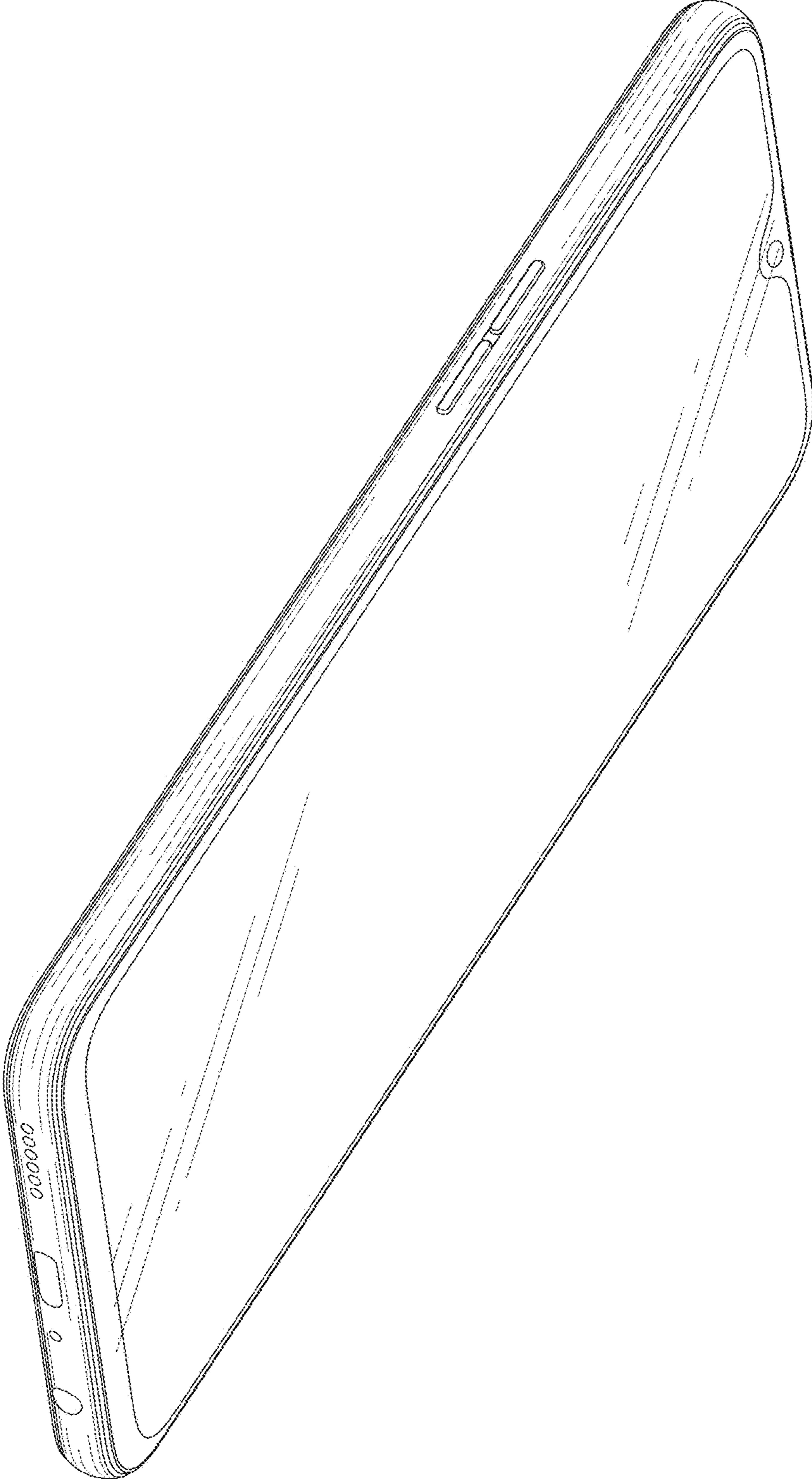
