(57) **CLAIM**

We claim the ornamental design for a mobile phone with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image in a sequence showing a mobile phone with animated graphical user interface according to a first embodiment;

FIG. 2 is a front view of a second image thereof, shown separate from the broken lines mobile phone for clarity of illustration;

FIG. 3 is a front view of a third image thereof, shown separate from the broken lines mobile phone for clarity of illustration;

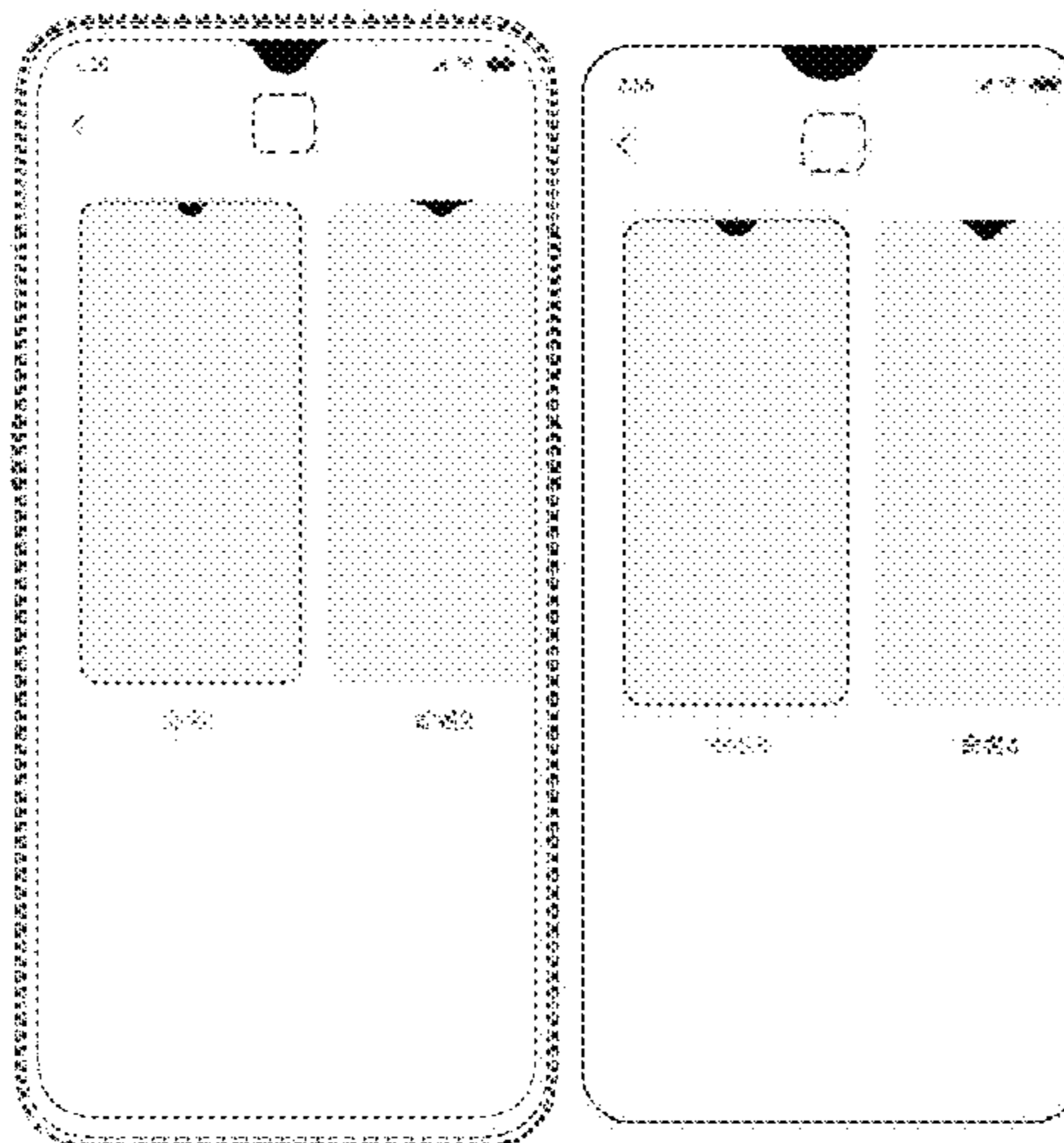
FIG. 4 is a front view of a first image in a sequence showing a mobile phone with animated graphical user interface according to a second embodiment;

FIG. 5 is a front view of a second image thereof, shown separate from the broken lines mobile phone for clarity of illustration; and,

FIG. 6 is a front view of a third image thereof, shown separate from the broken lines mobile phone for clarity of illustration.

The outermost broken lines showing the mobile phone, as well as the broken lines showing portions of the animated graphical user interface, form no part of the claimed design. The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-3 and FIGS. 4-6 respectively. The process or period in which one image transitions to another image forms no part of the claimed design.

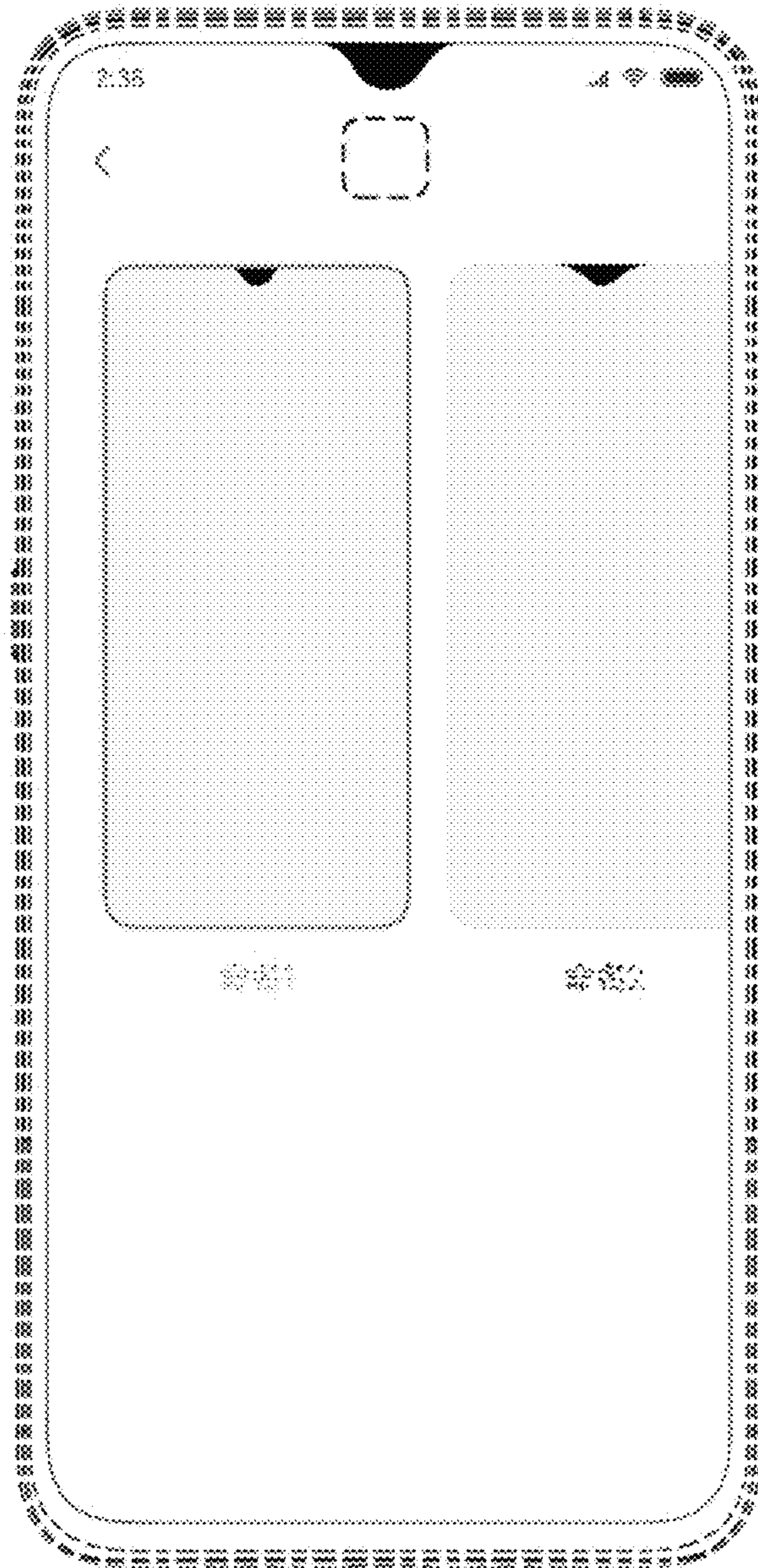

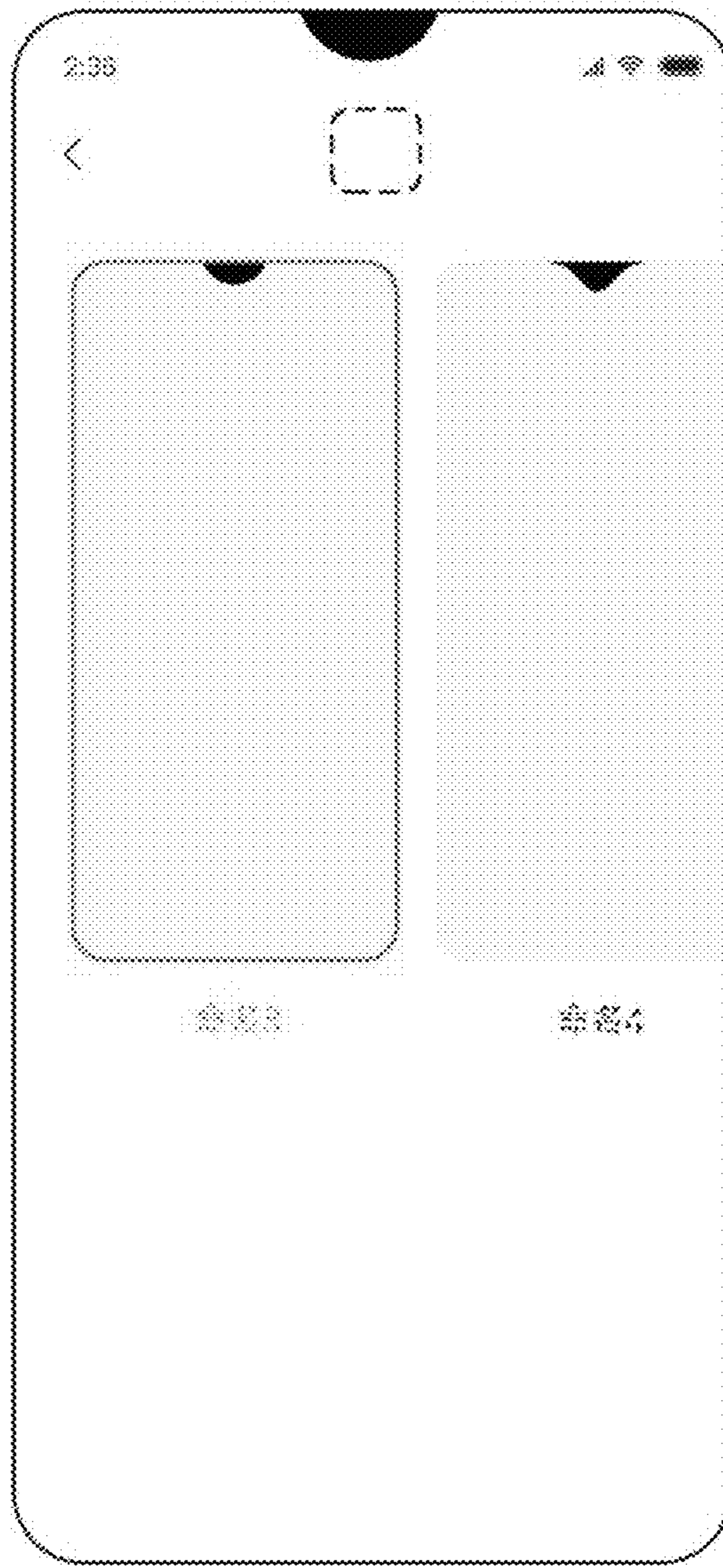

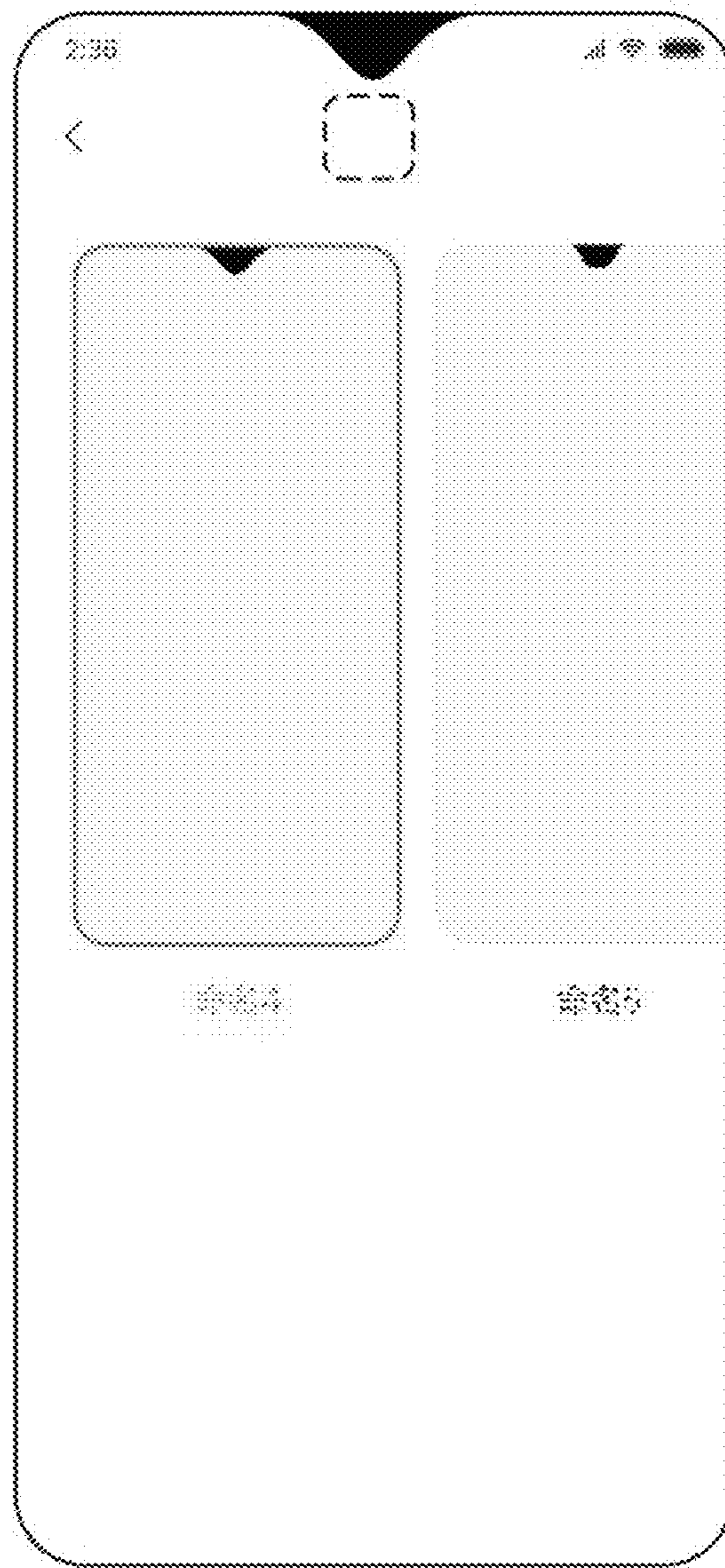

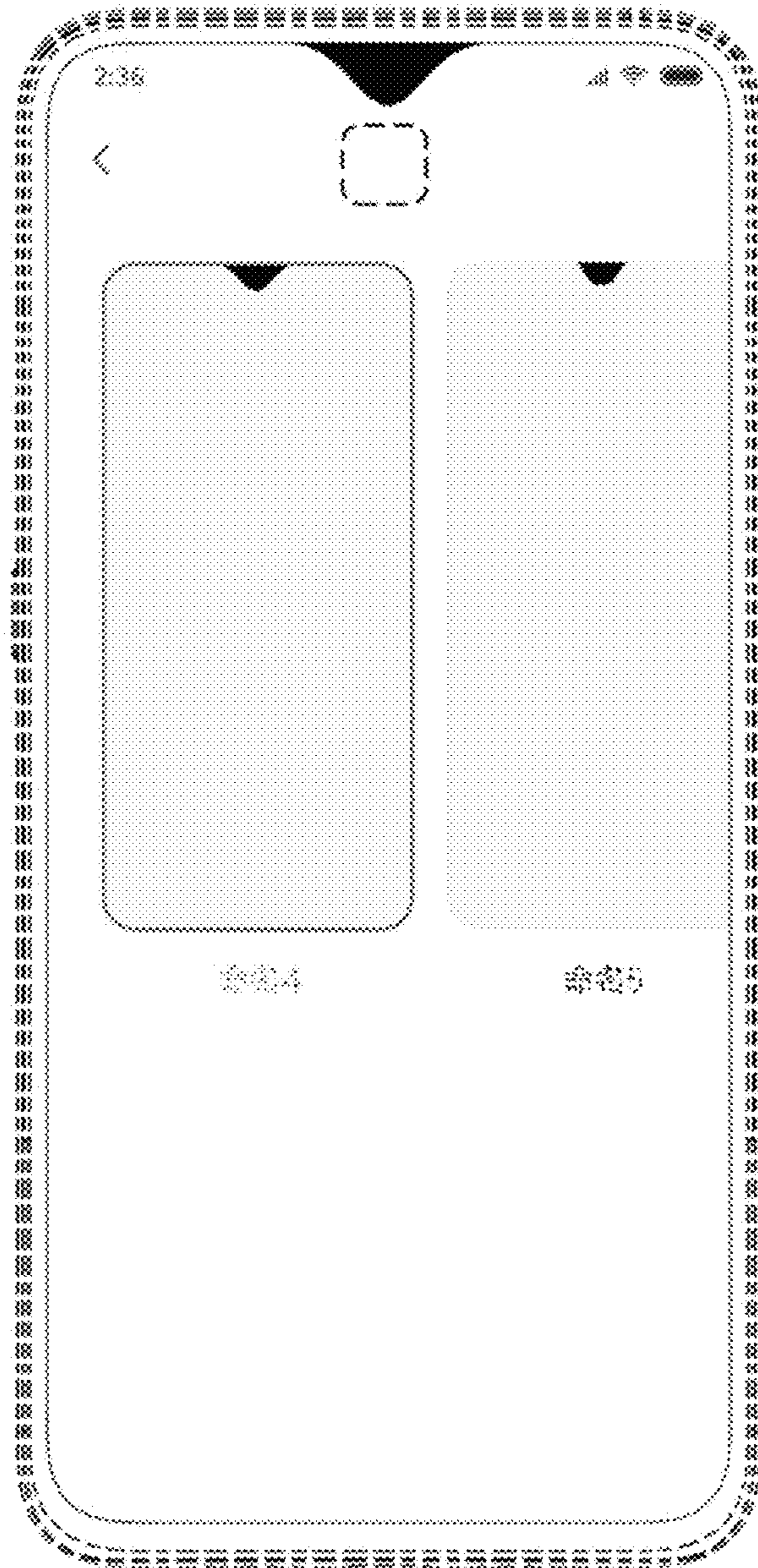

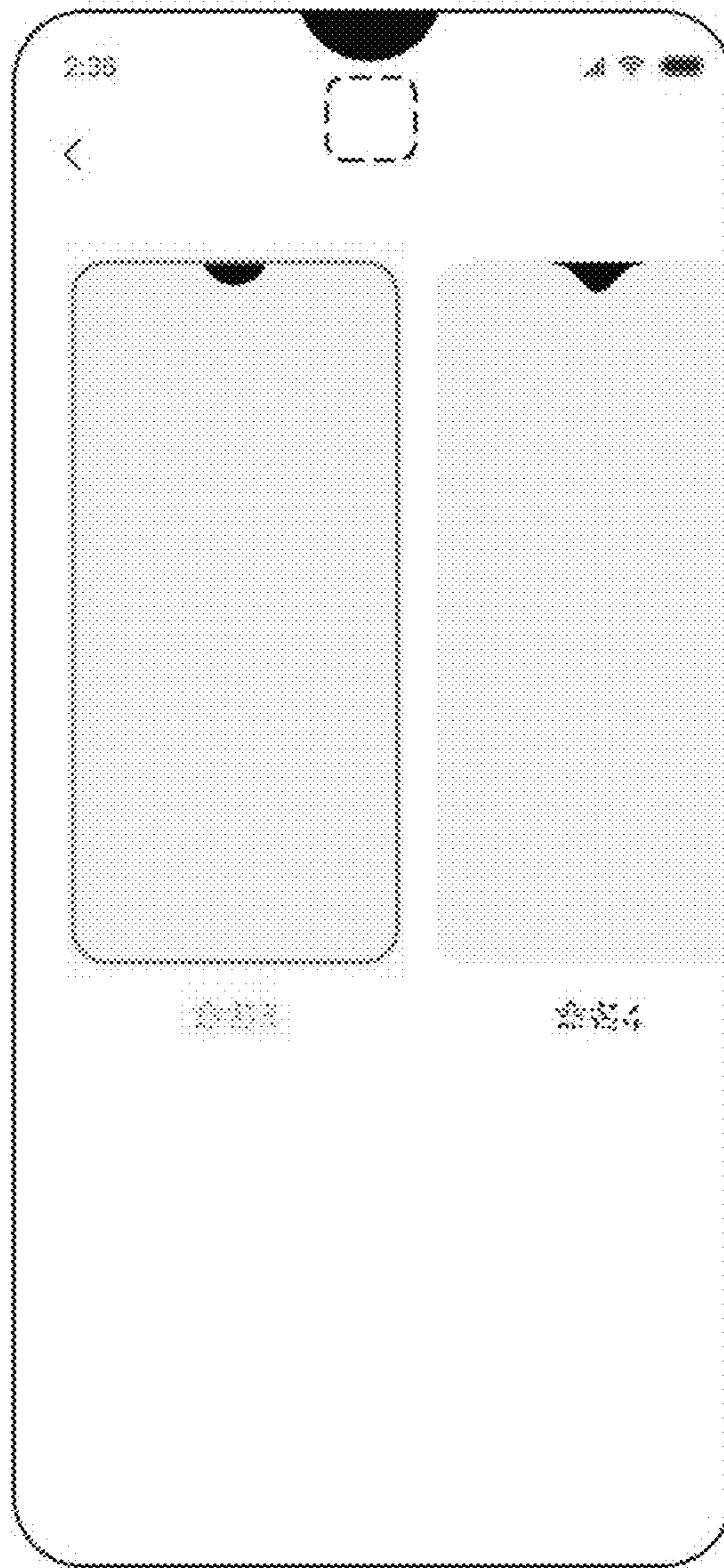

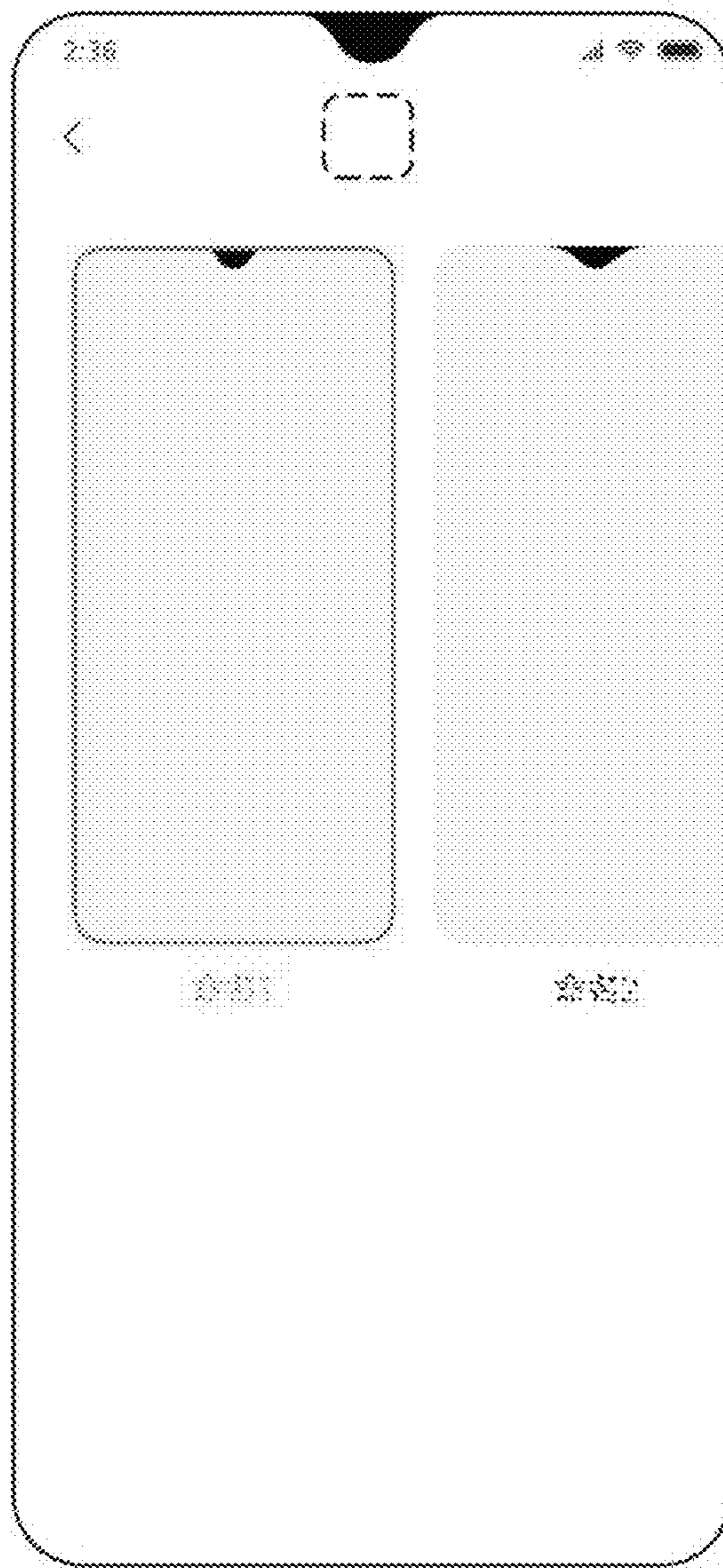
