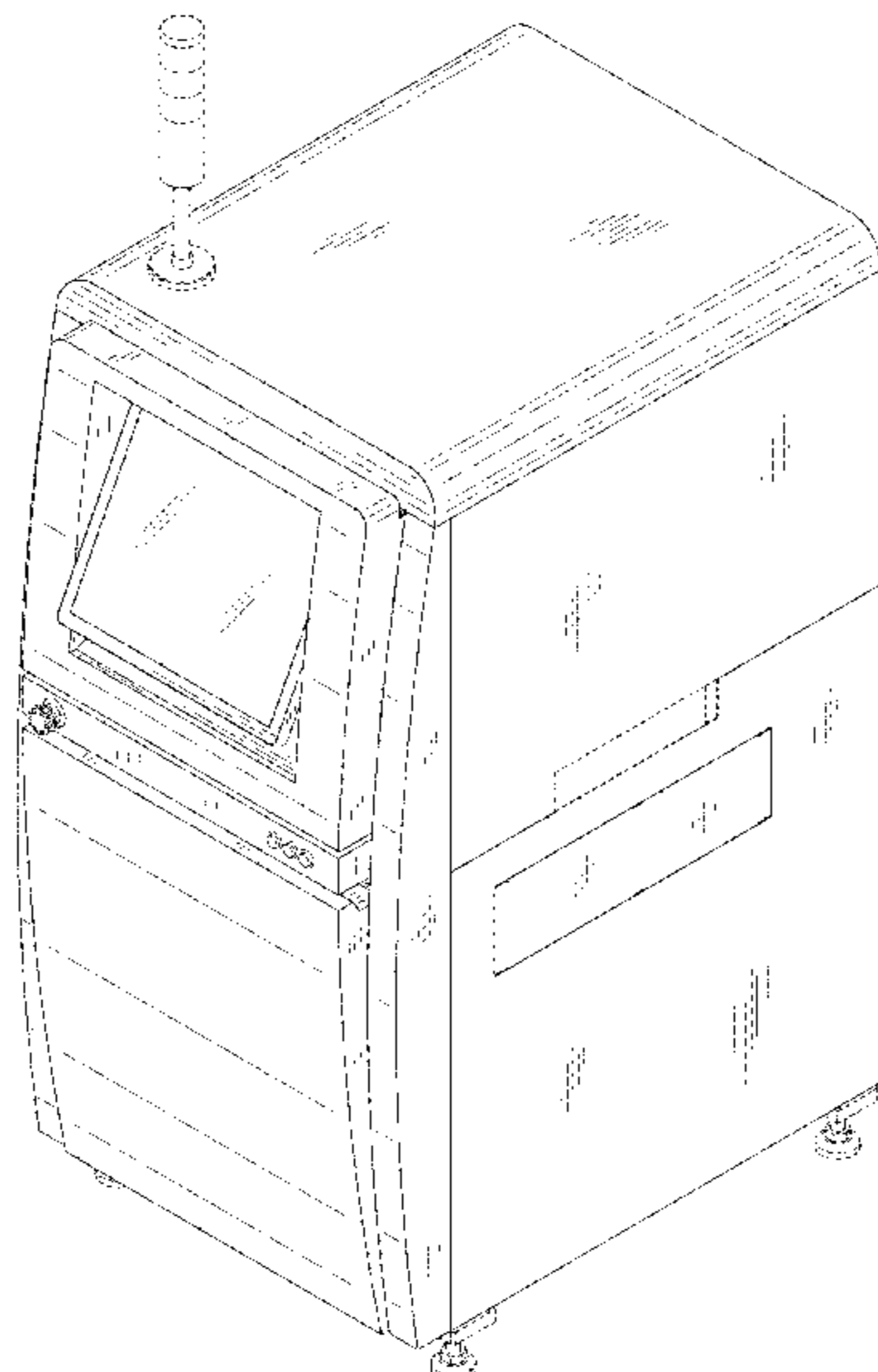
(57) **CLAIM**

The ornamental design for a printed circuit board inspection machine, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a first embodiment of a printed circuit board inspection machine showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a left side view thereof;
FIG. 7 is another perspective view of the design, shown in a position of use with a monitor being tilted forward;
FIG. 8 is a front, top and right side perspective view of a second embodiment of a printed circuit board inspection machine showing our new design;
FIG. 9 is a front view thereof;
FIG. 10 is a top plan view thereof;
FIG. 11 is a bottom plan view thereof;
FIG. 12 is a right side view thereof;
FIG. 13 is a left side view thereof; and,
FIG. 14 is another perspective view of the design, shown in a position of use with a monitor being tilted forward.
The broken lines illustrate portions of the printed circuit board inspection machine that form no part of the claimed design.

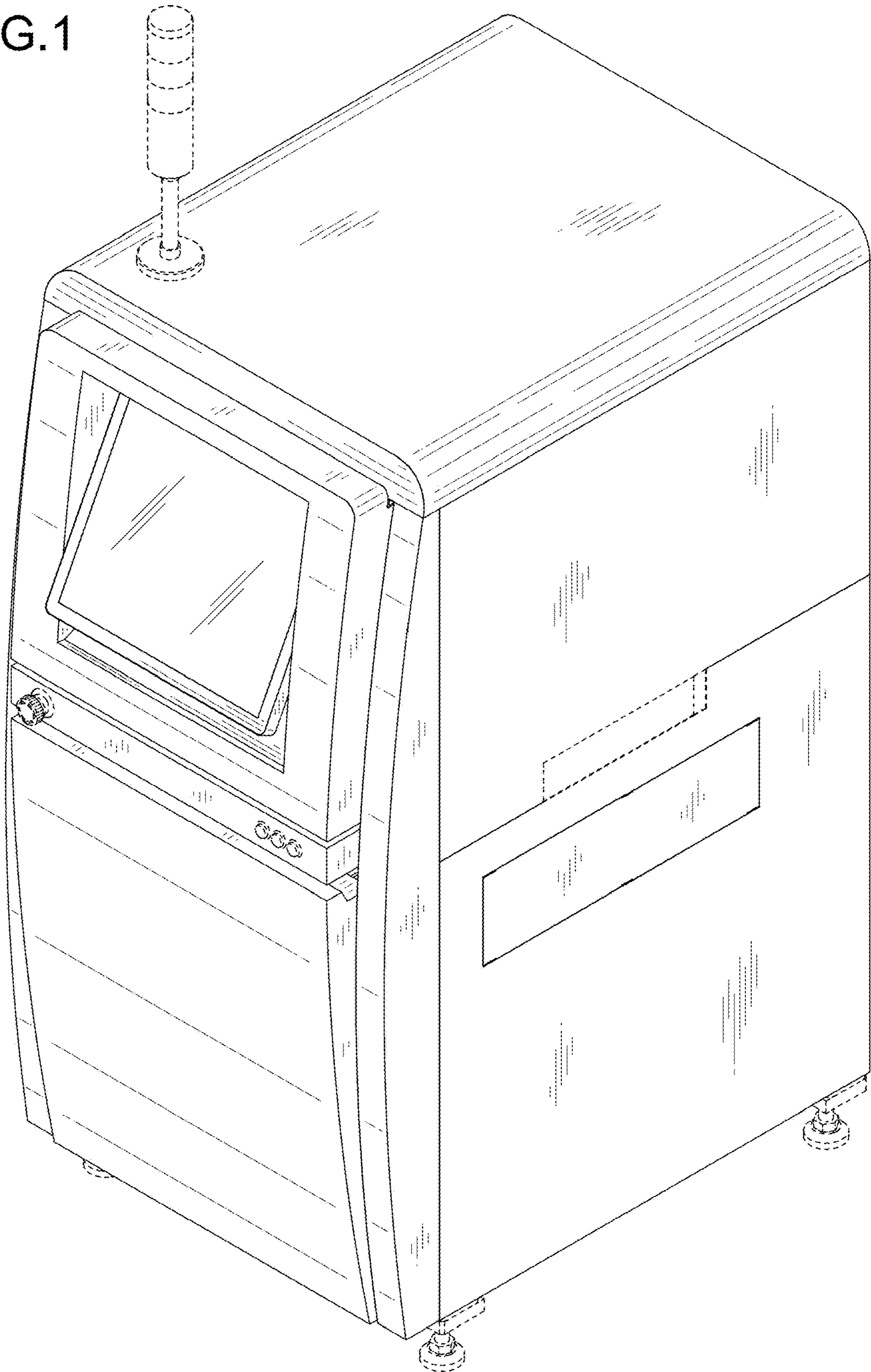

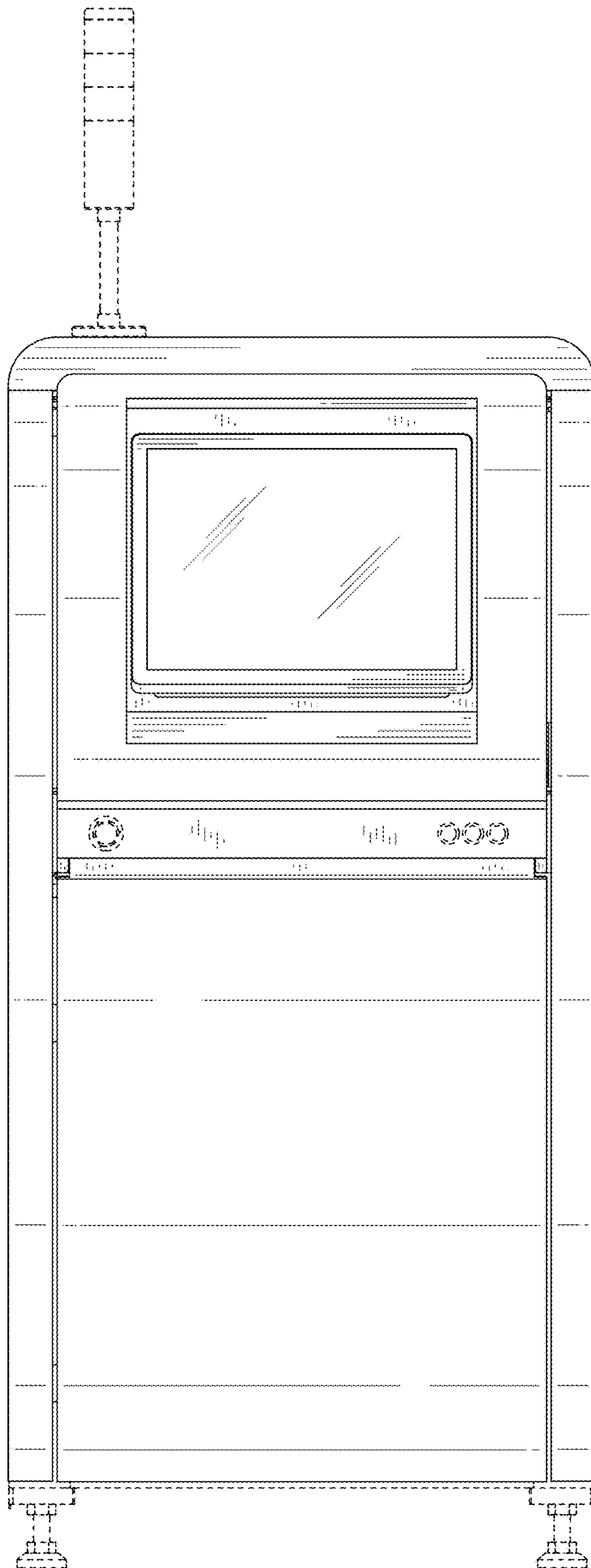

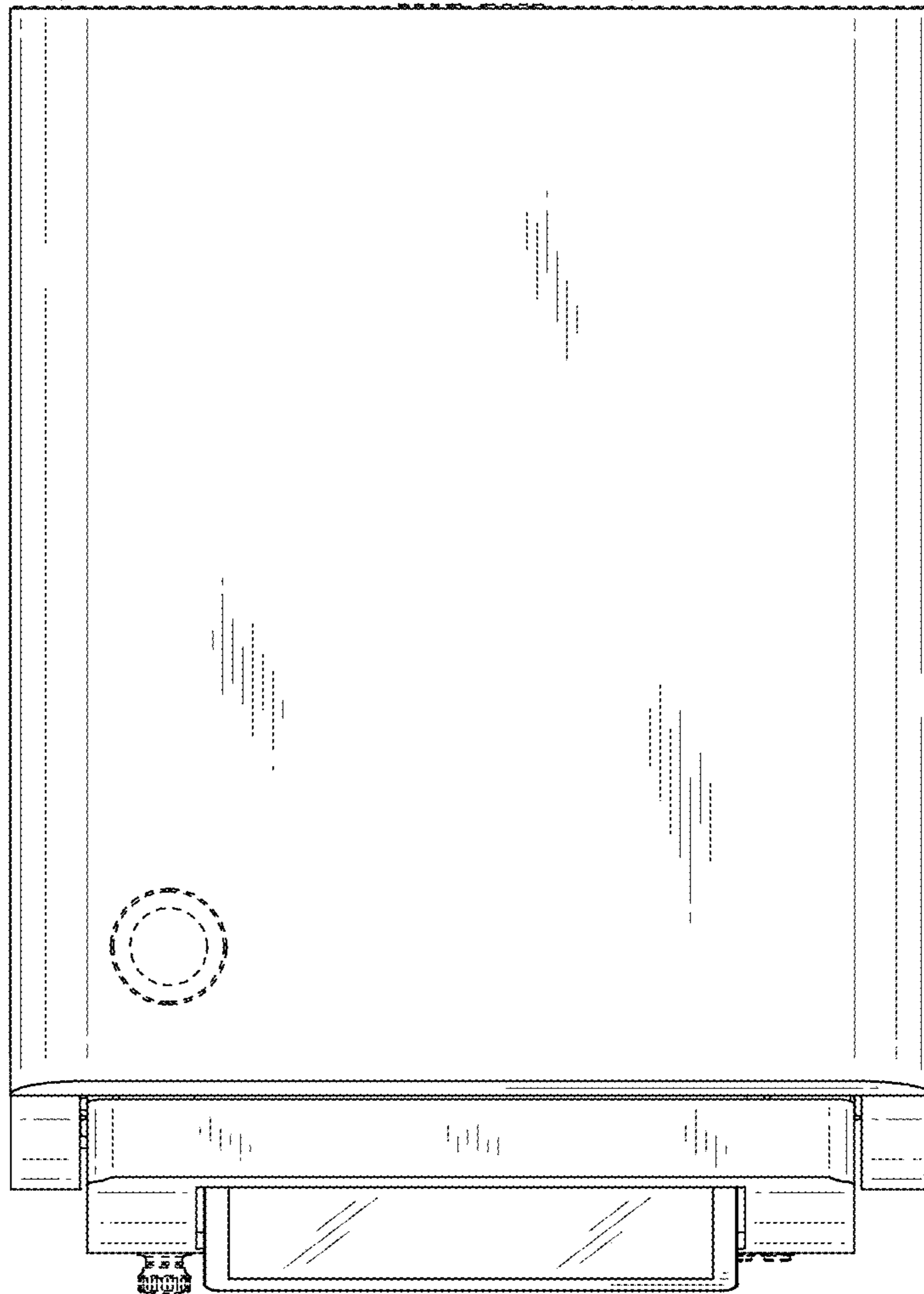

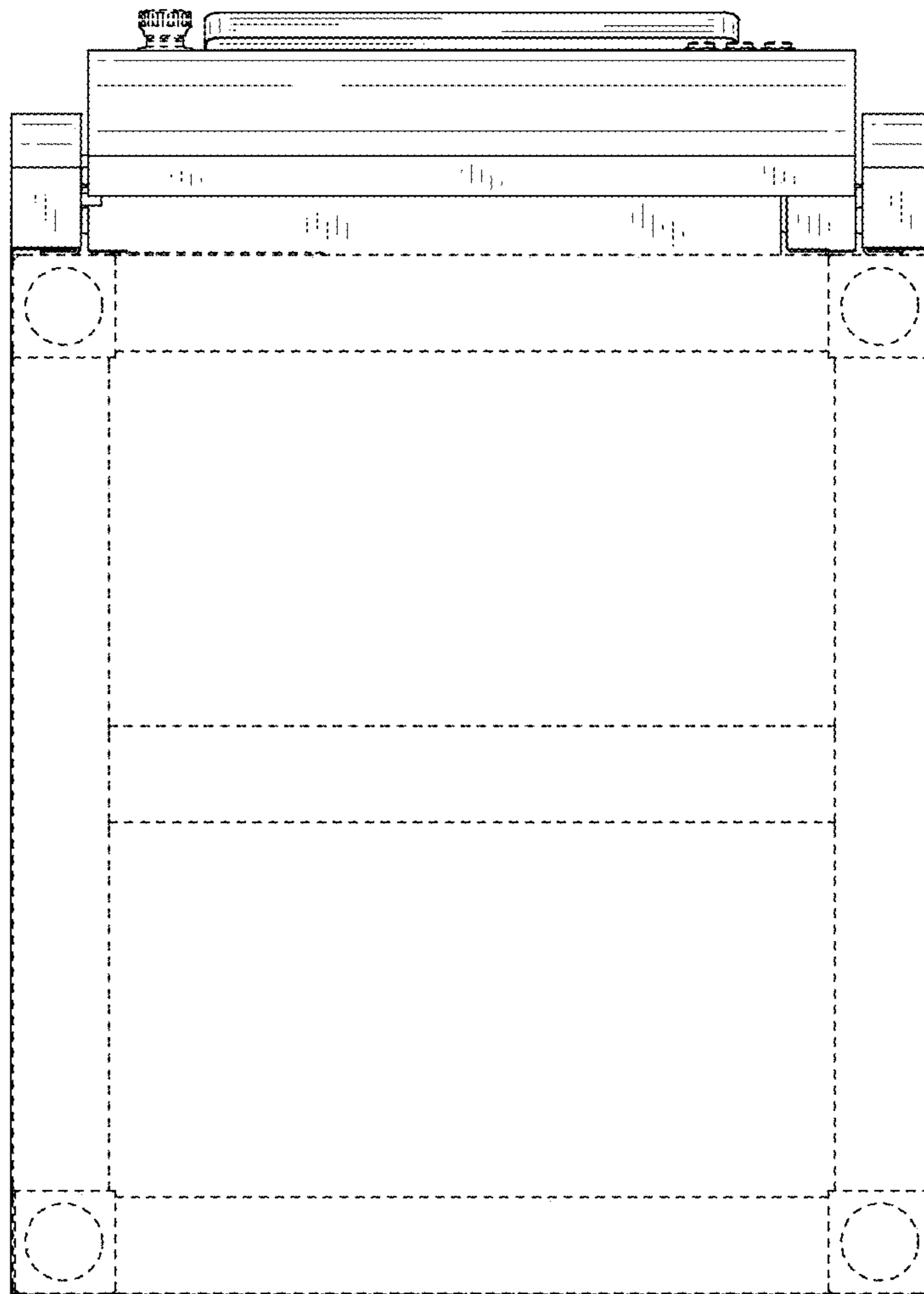

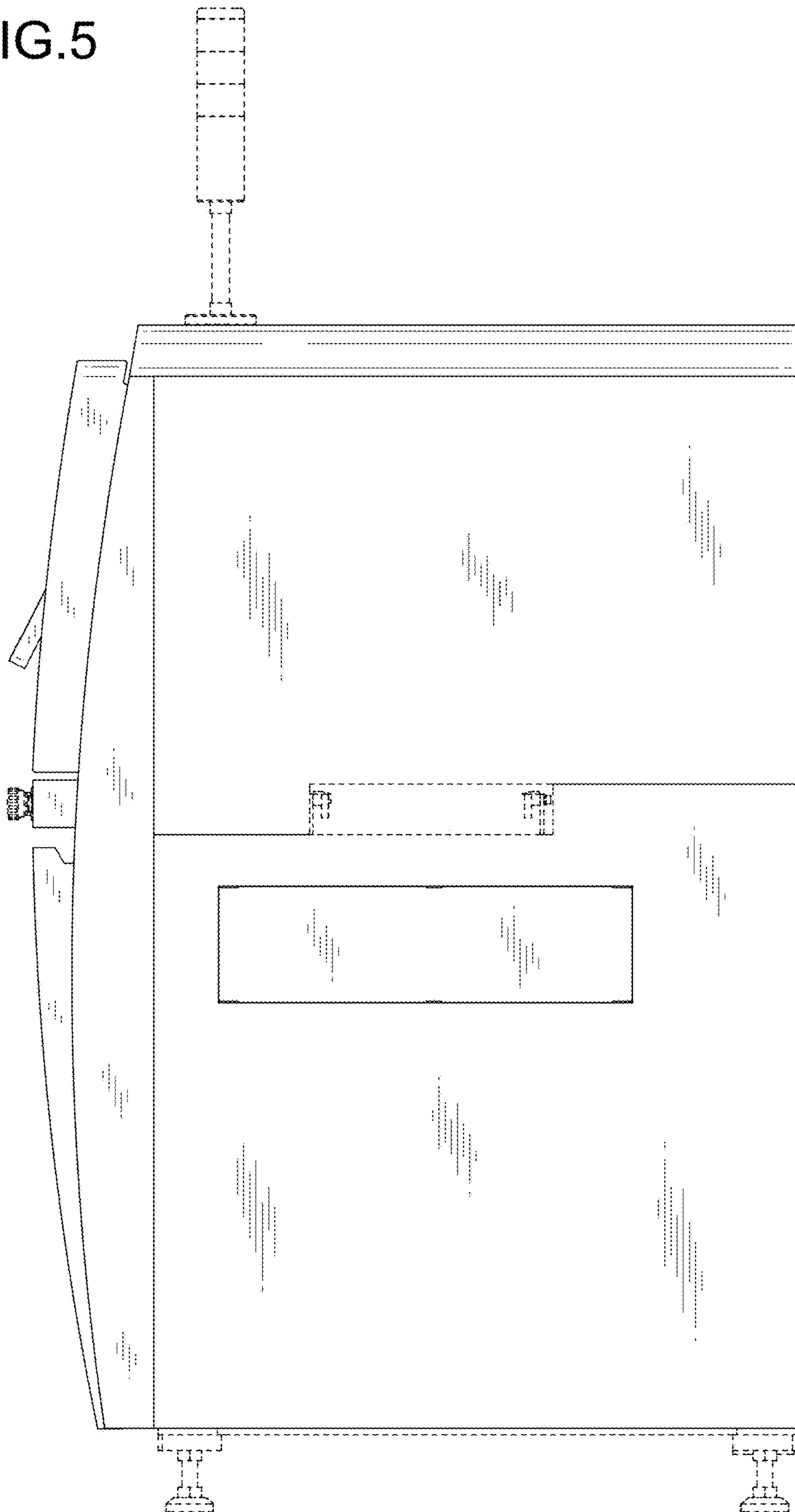

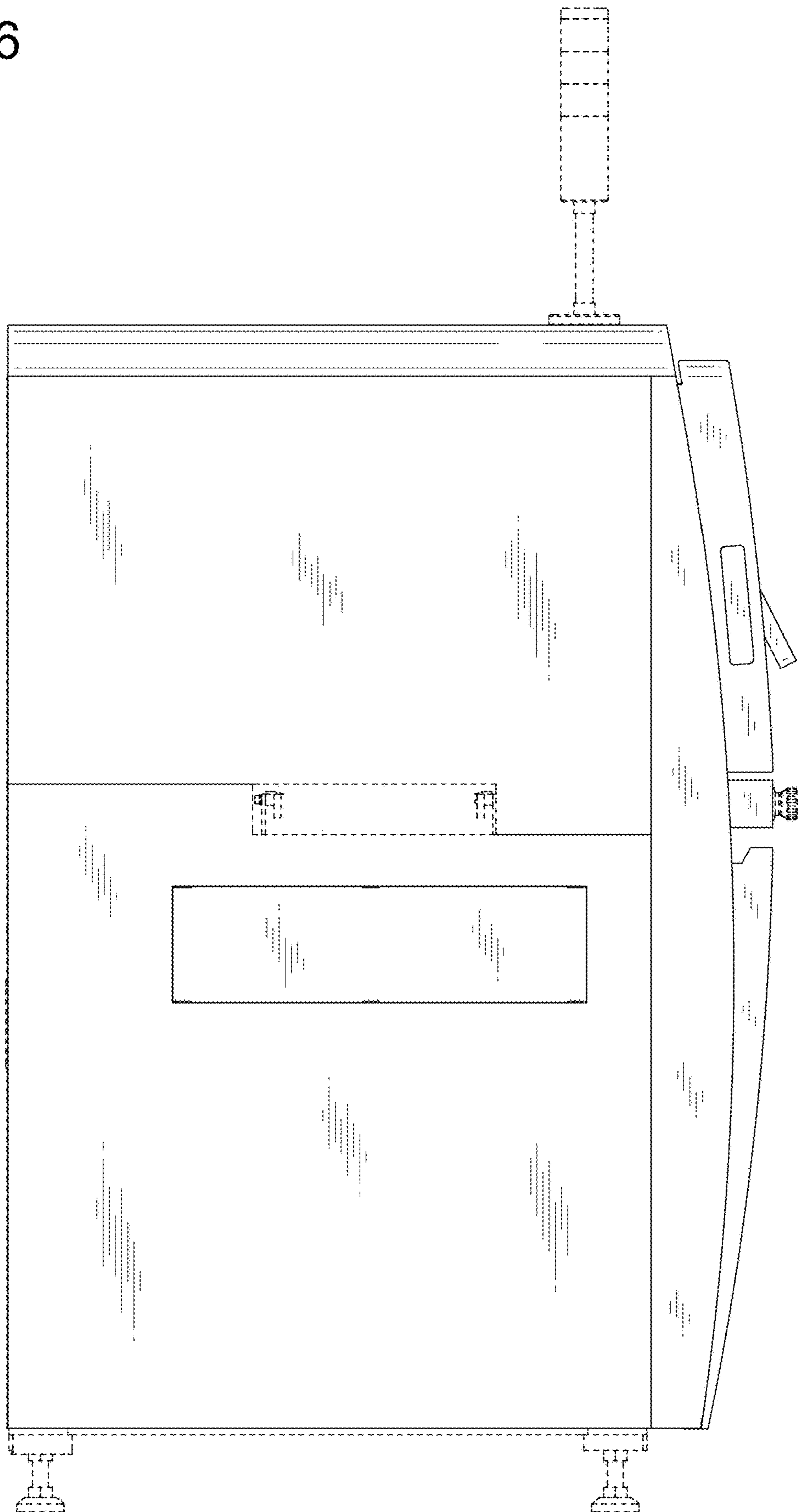

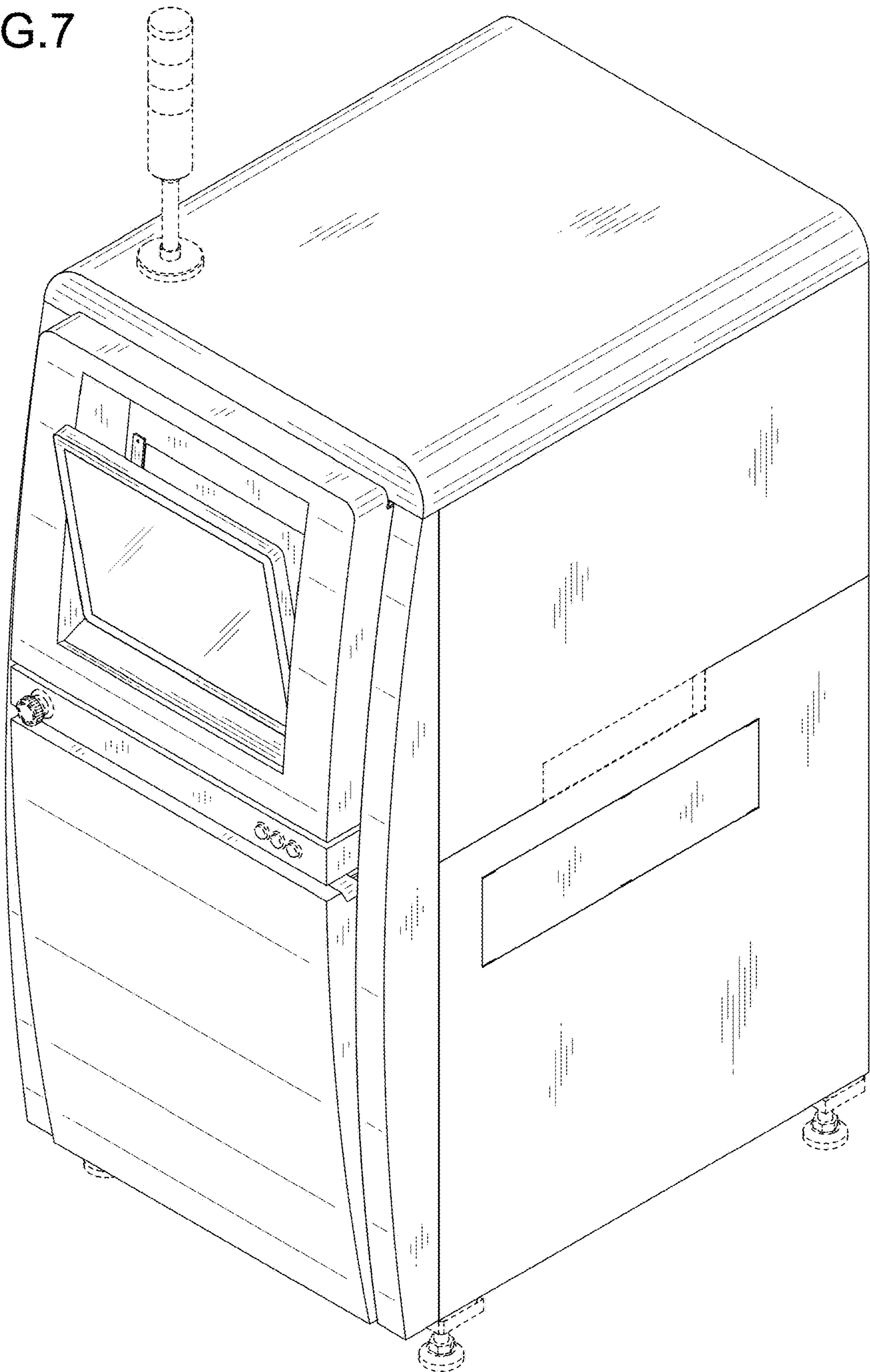

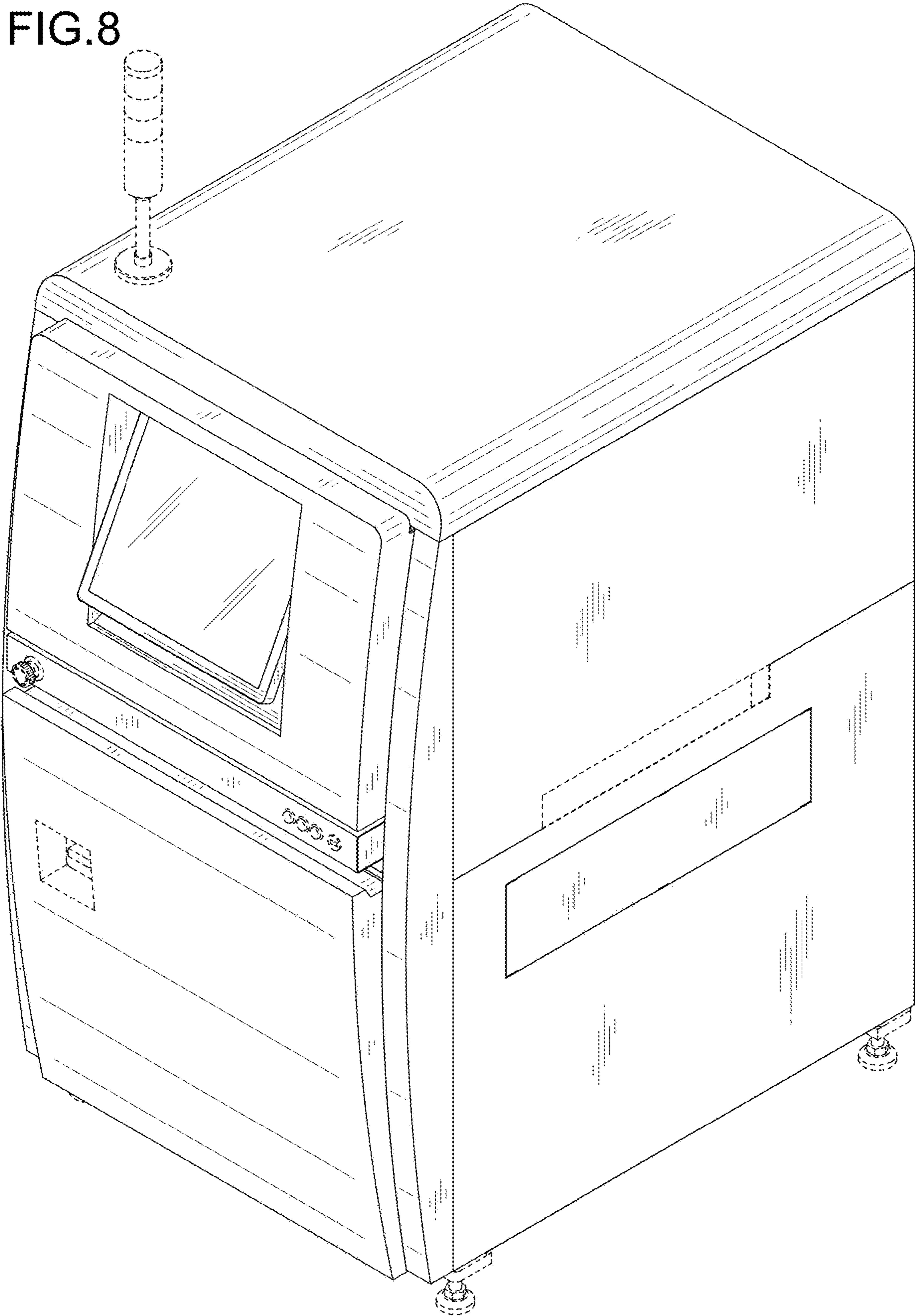

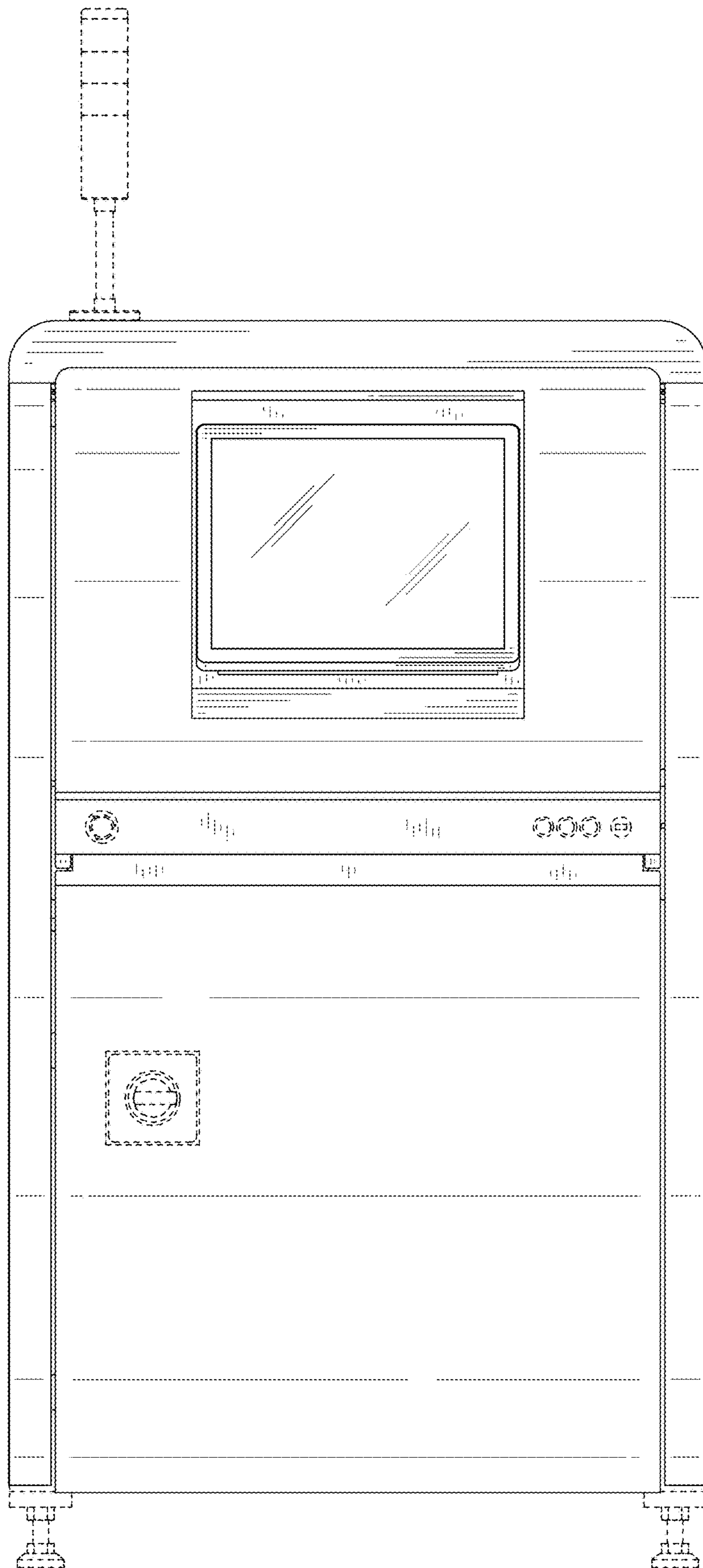

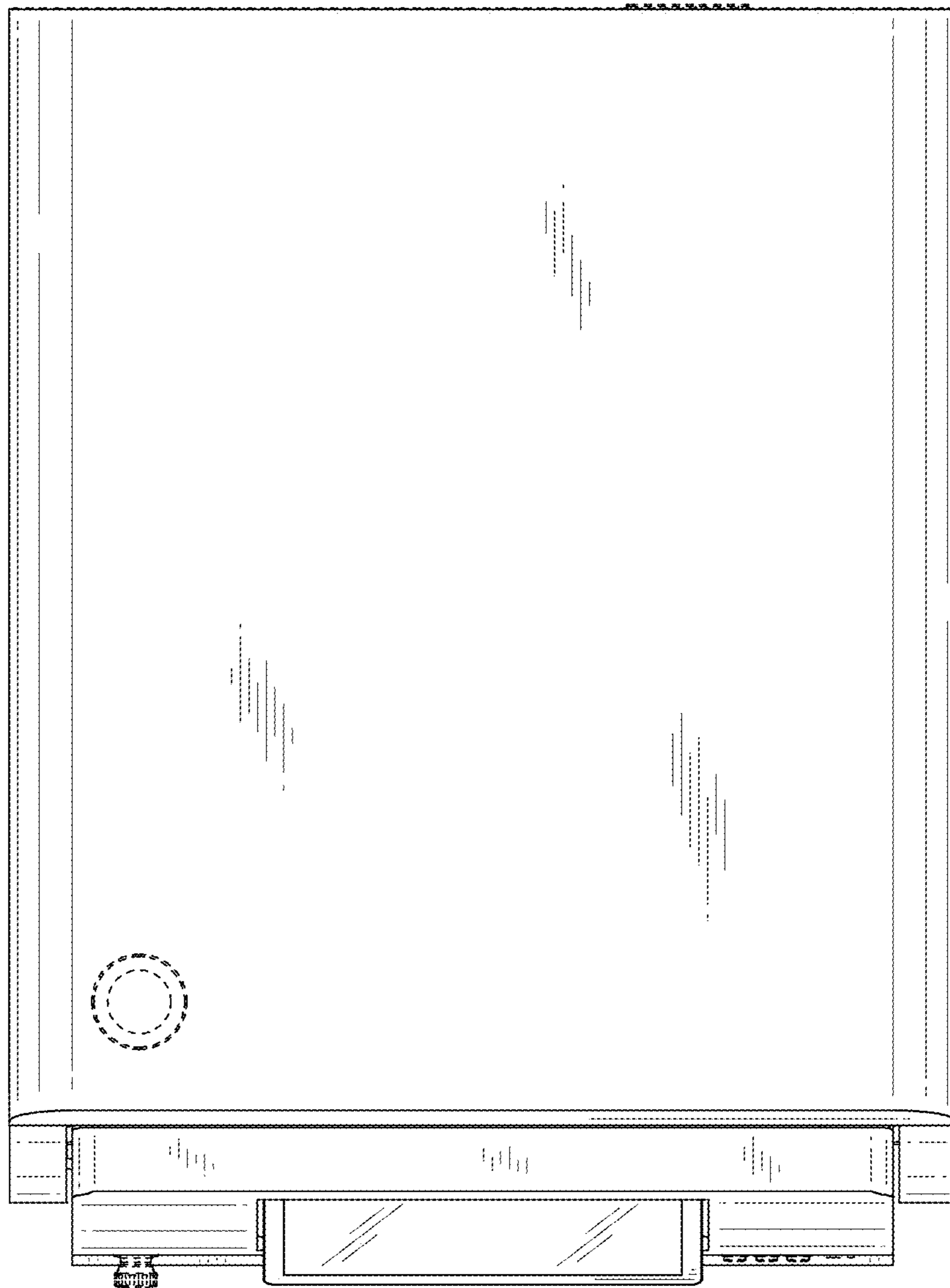

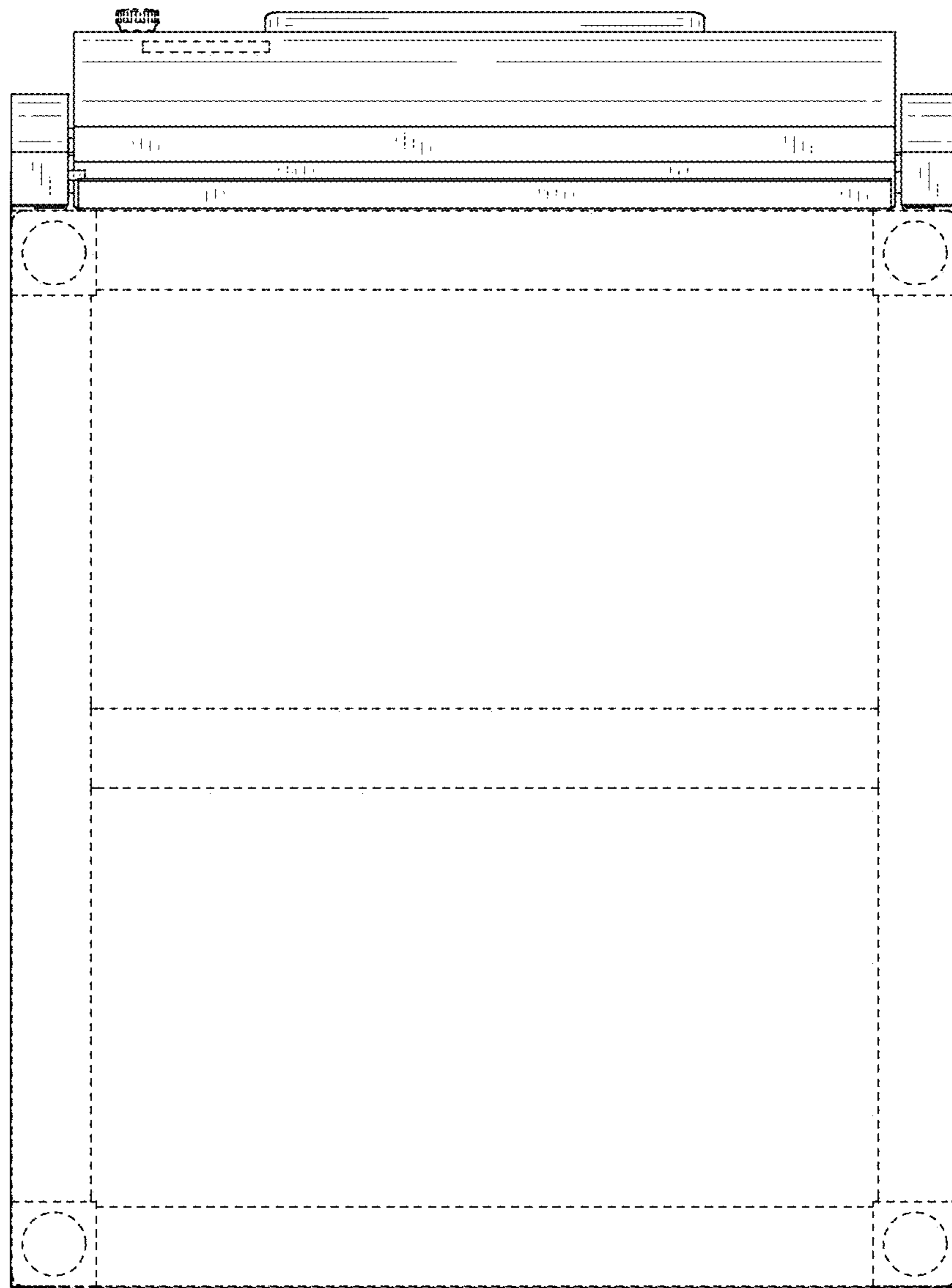

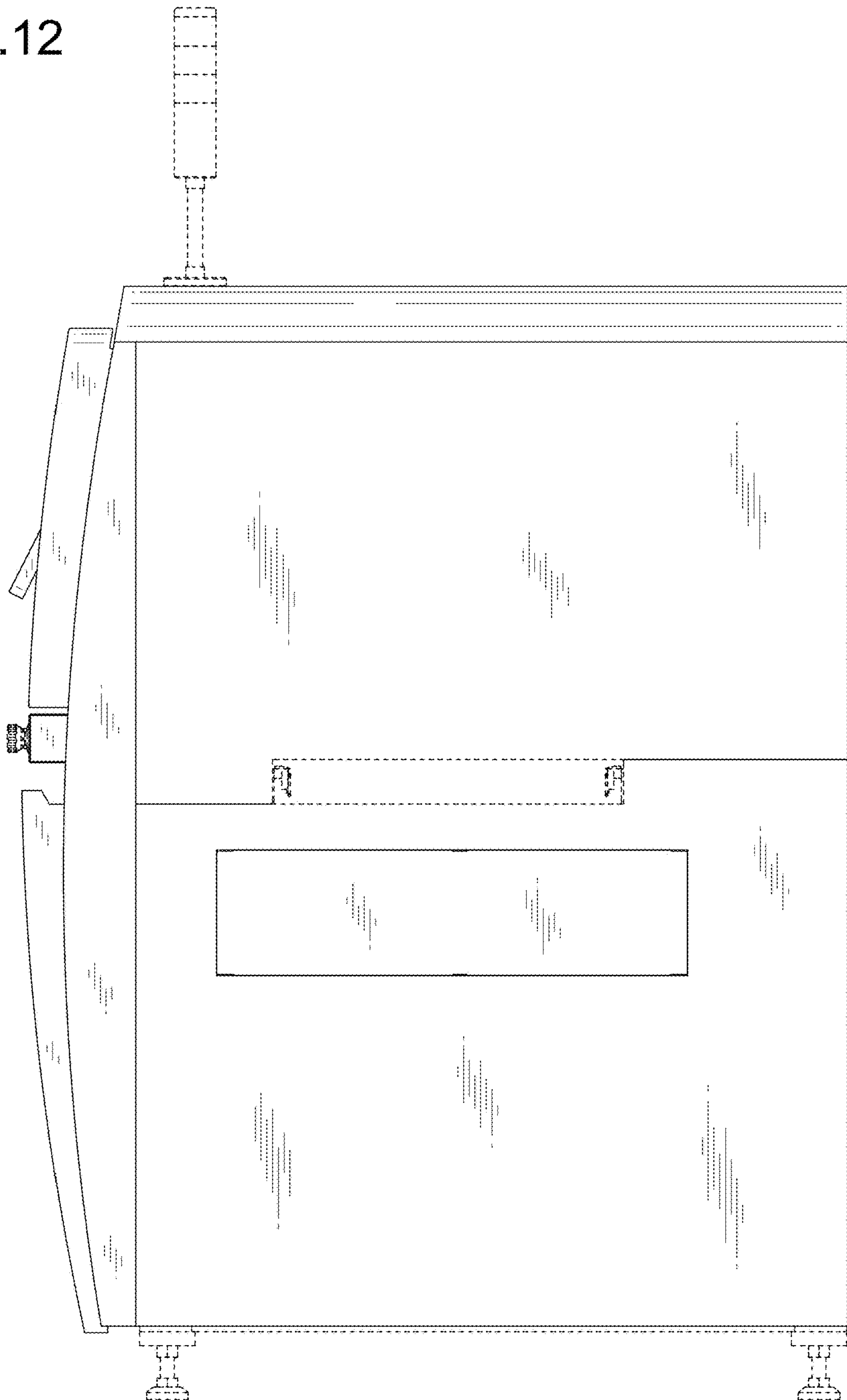

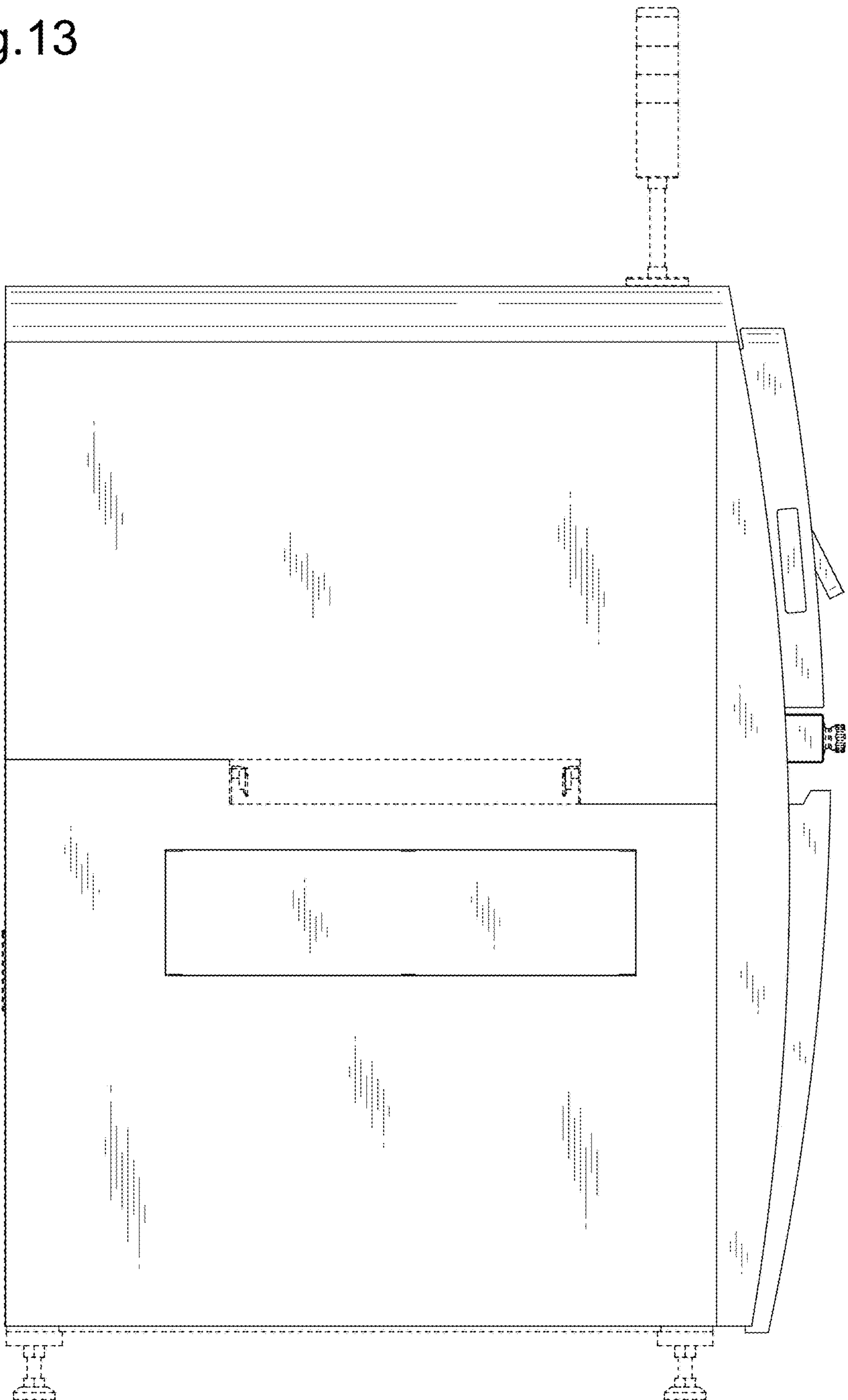
