DESCRIPTION

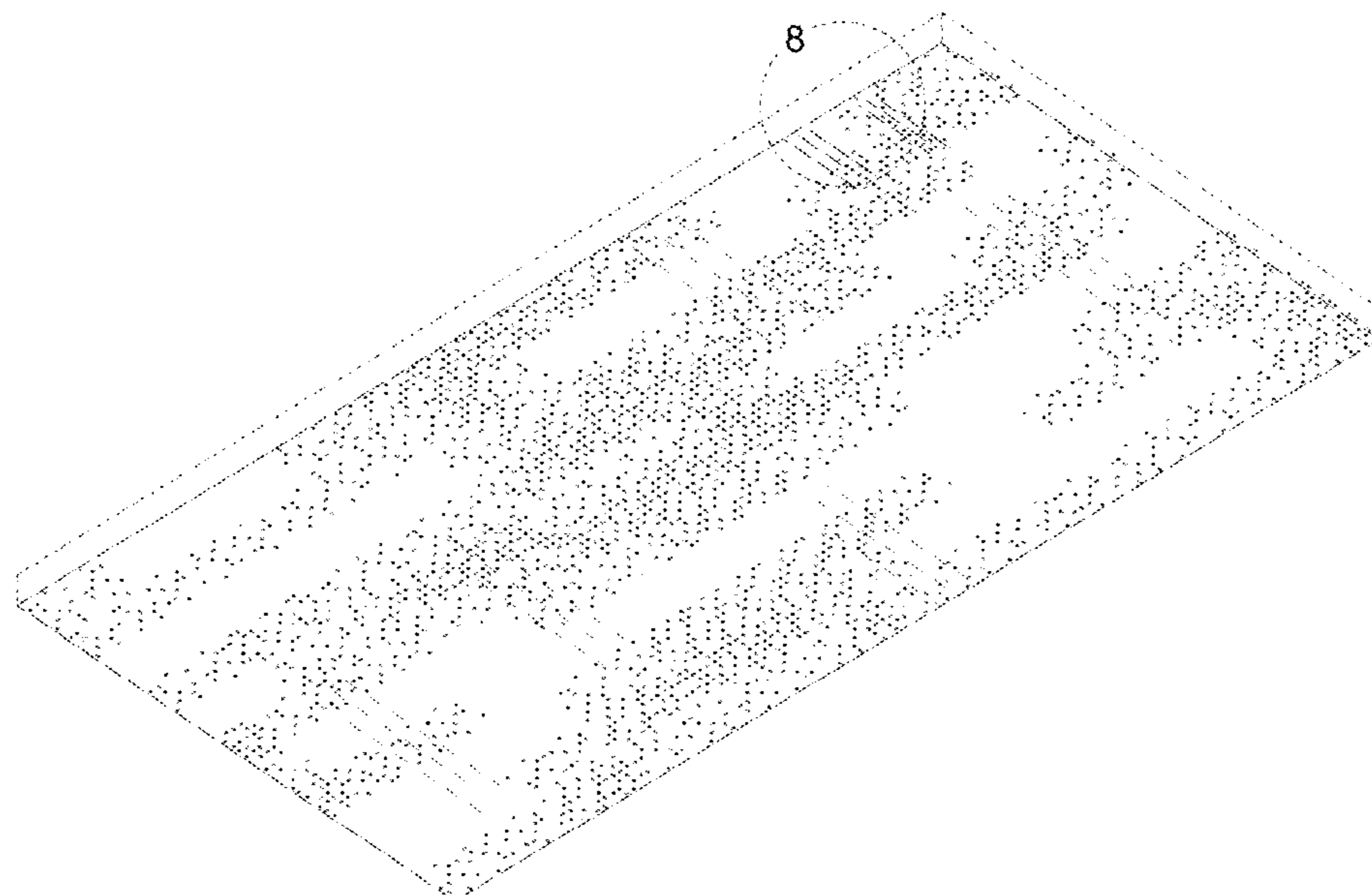
FIG. 1 is a bottom, front, left perspective view of an architectural fixture, showing our new design;

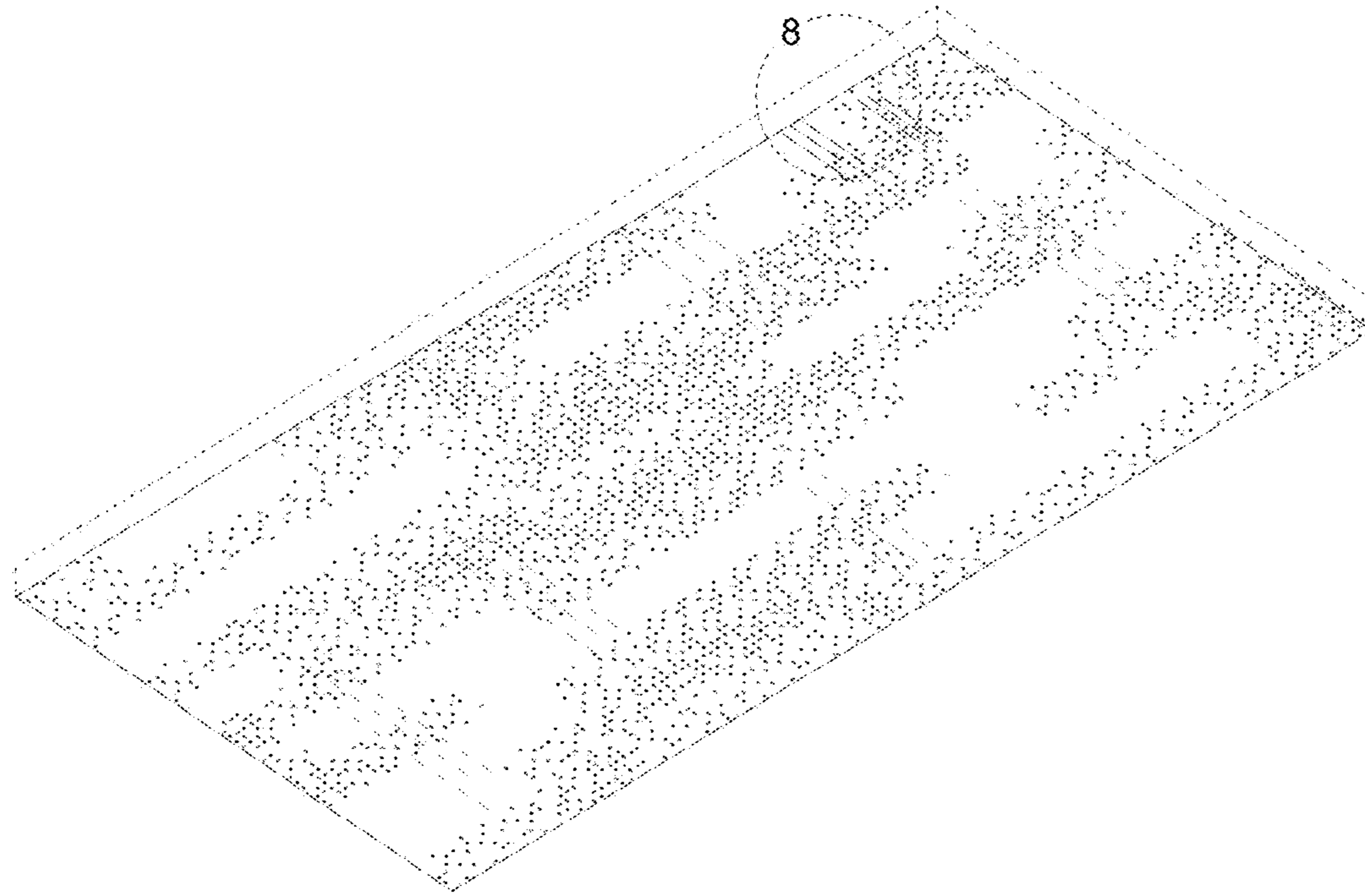

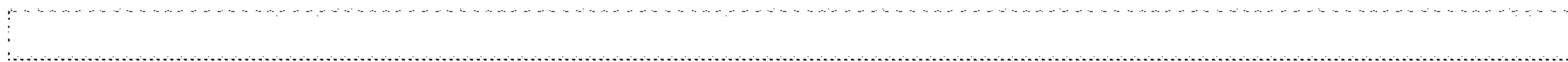

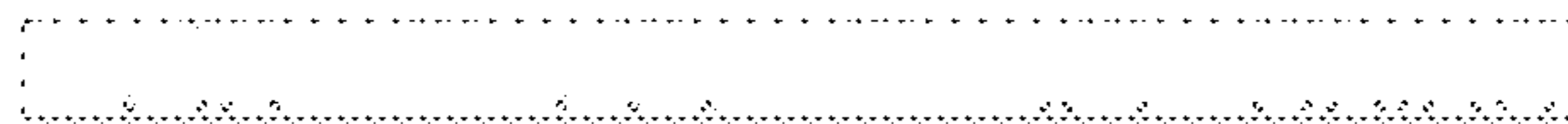

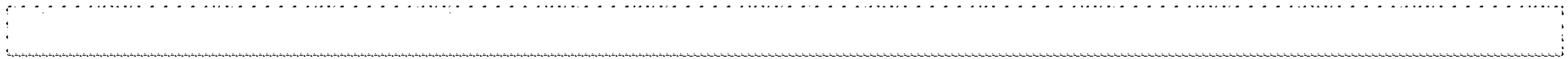

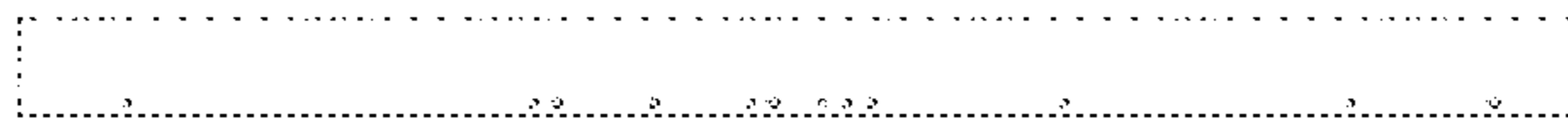

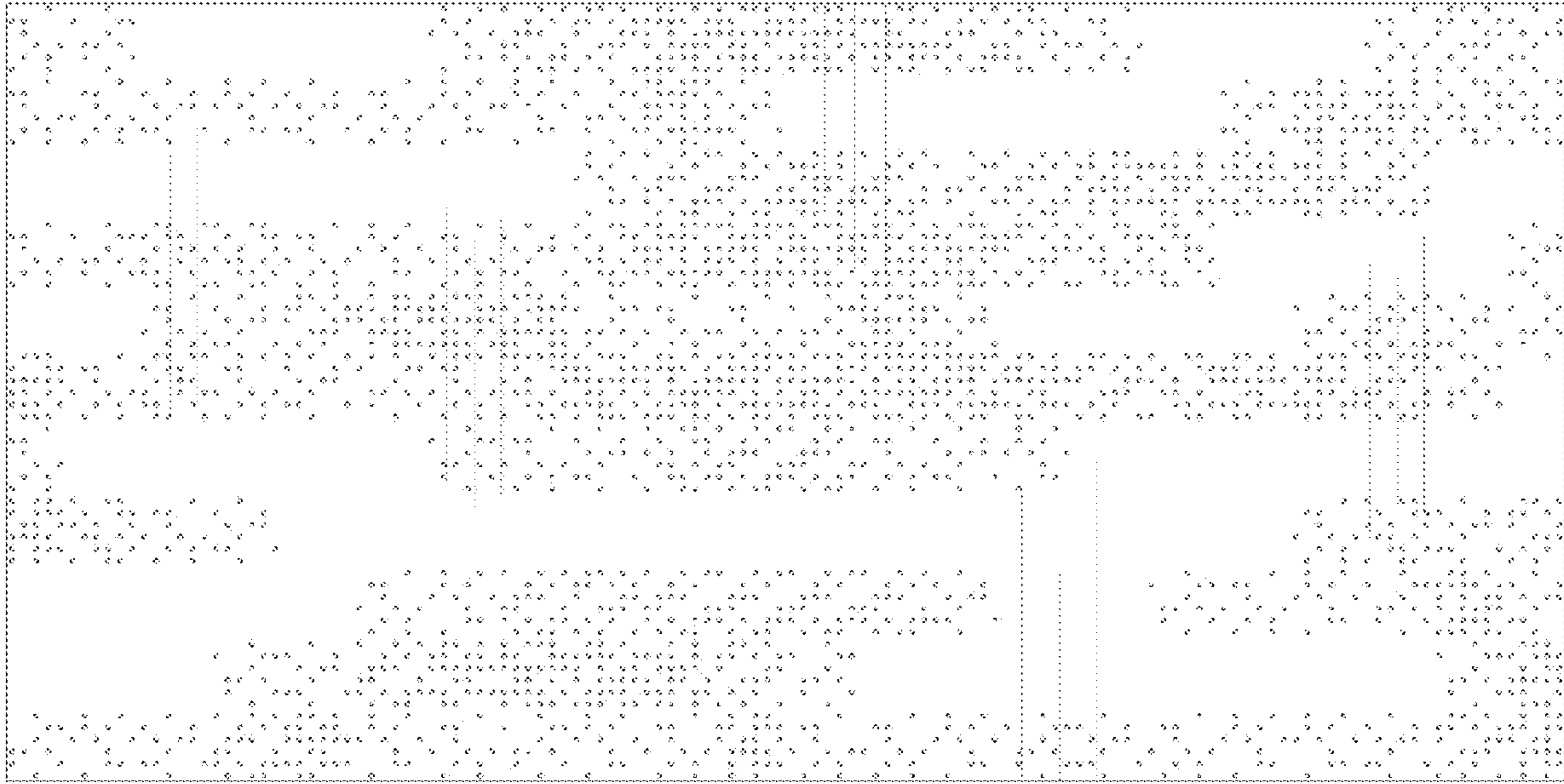

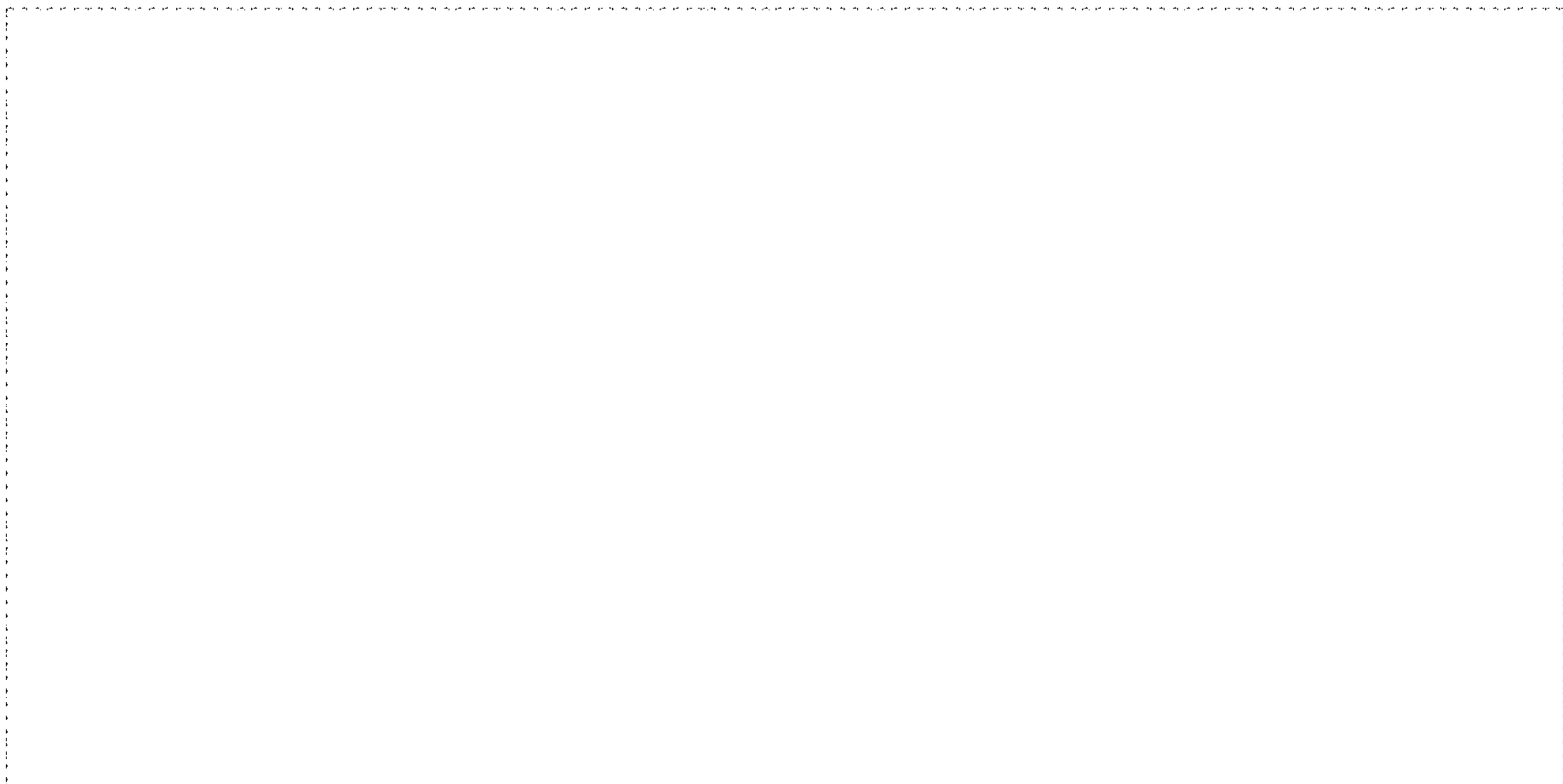

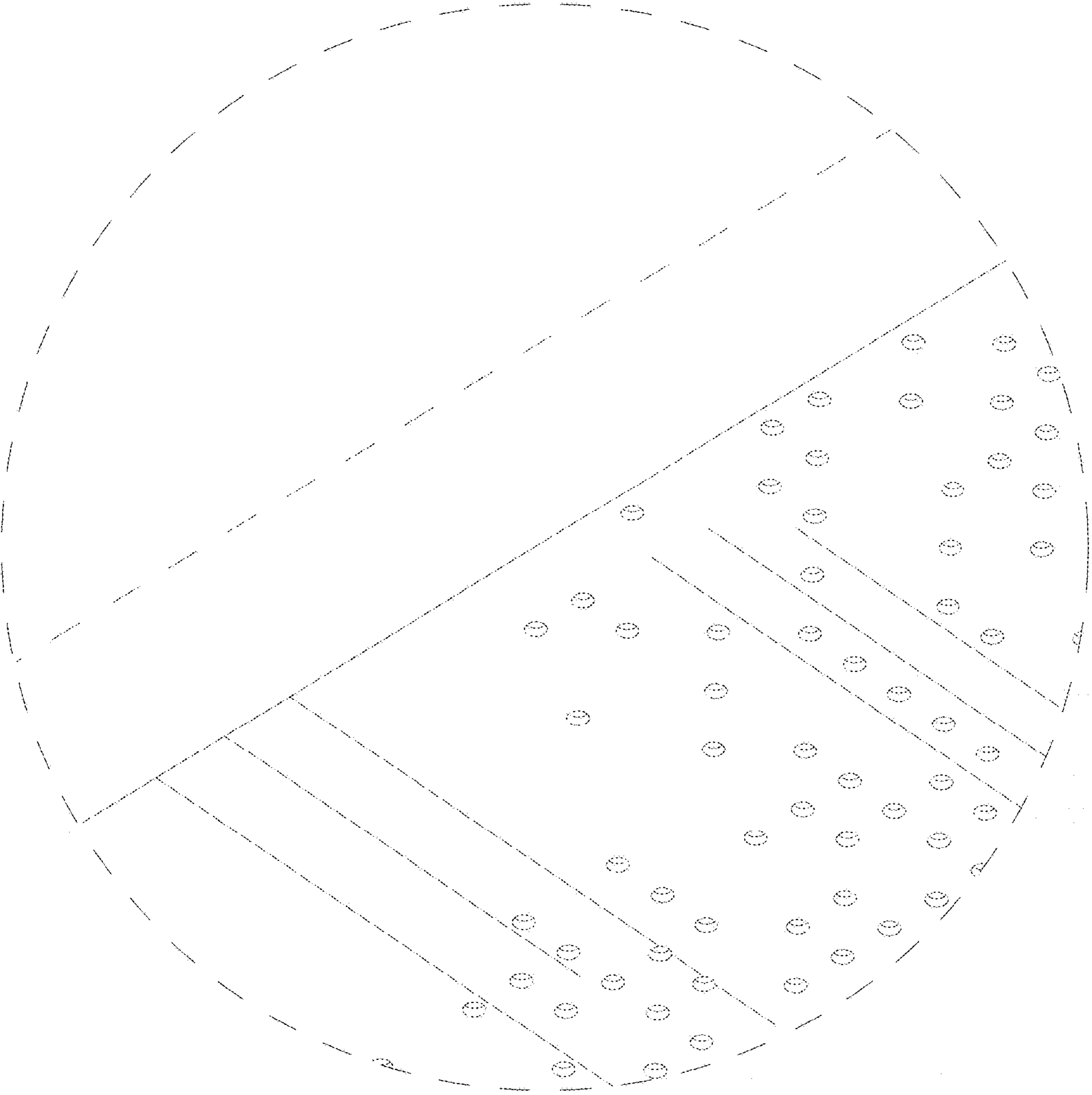
