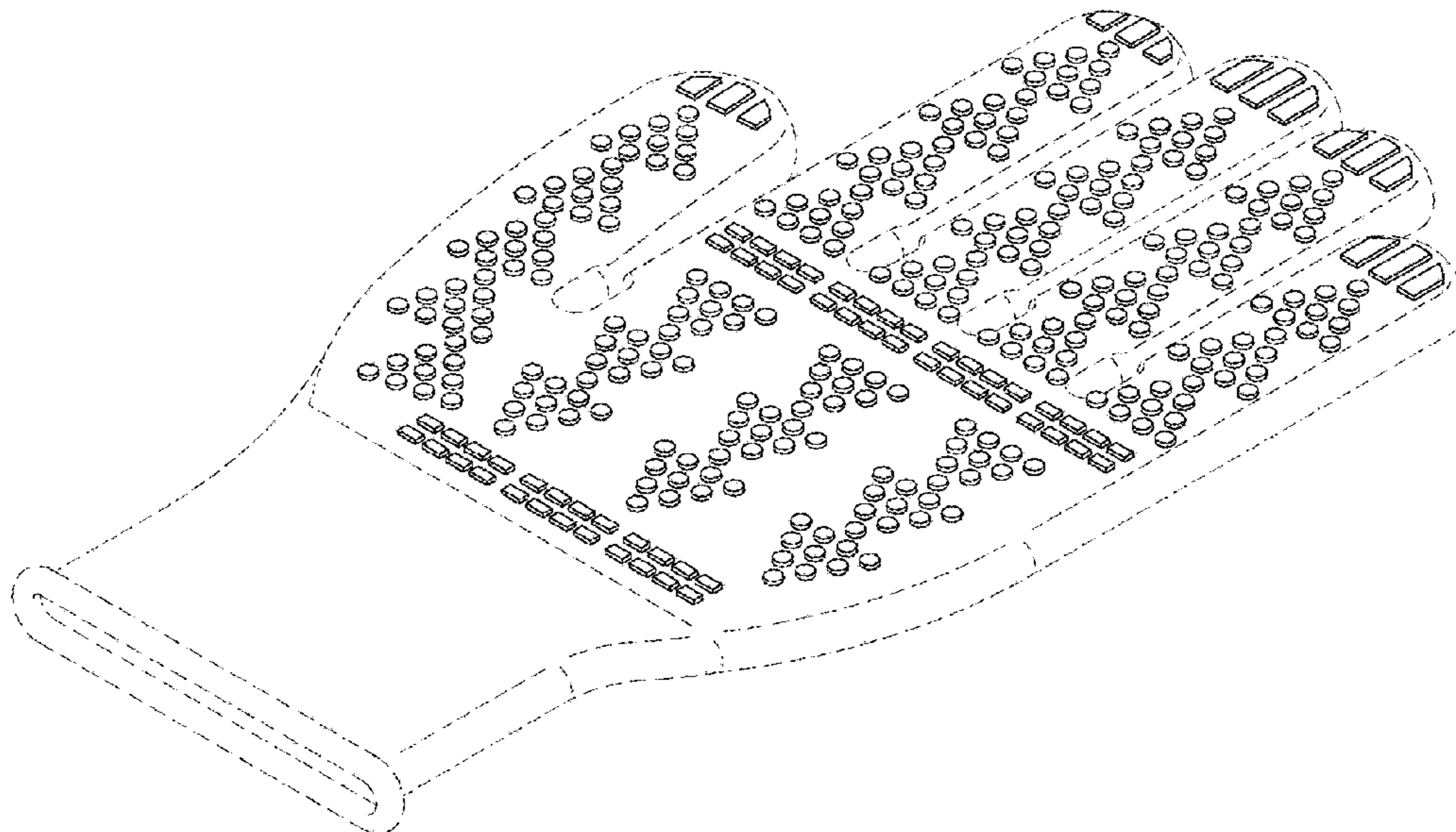
(57) **CLAIM**

The ornamental design for a work glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the work glove in accordance with the present invention;  
FIG. 2 is a plan view of the work glove of FIG. 1;  
FIG. 3 is a side view of the work glove of FIG. 2;  
FIG. 4 is an opposite side view of the work glove of FIG. 2;  
FIG. 5 is an end view of the work glove of FIG. 2; and,

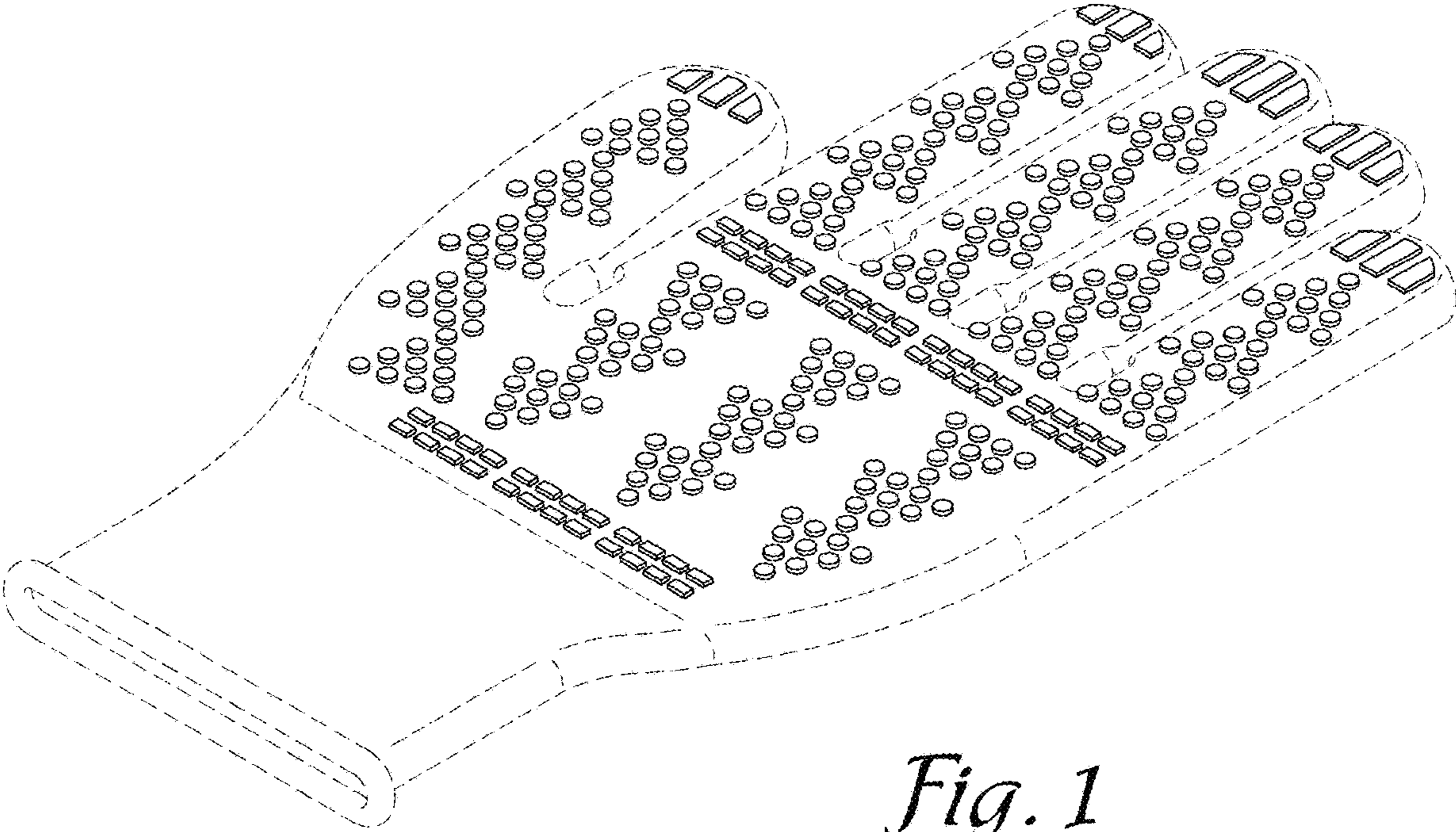

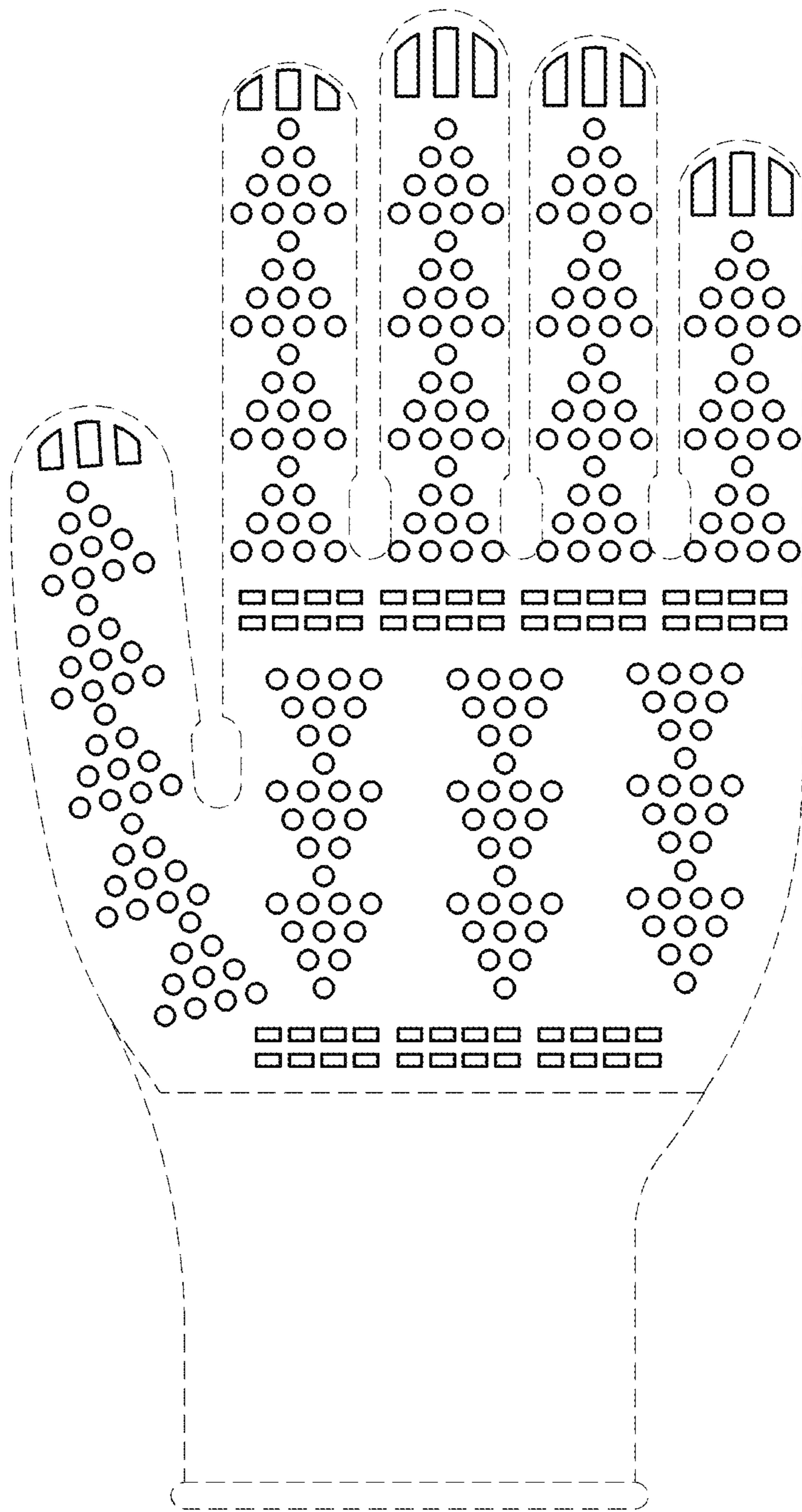

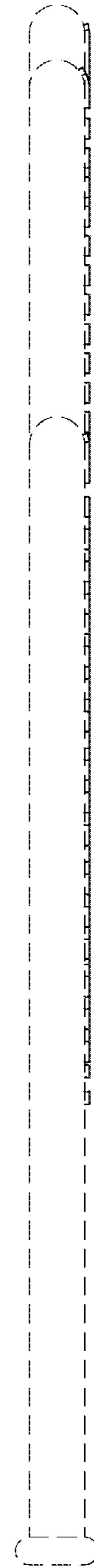

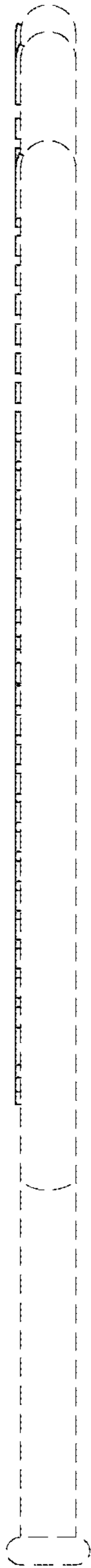

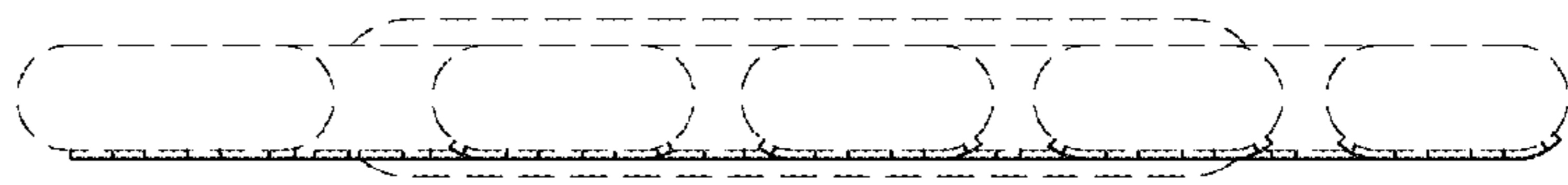

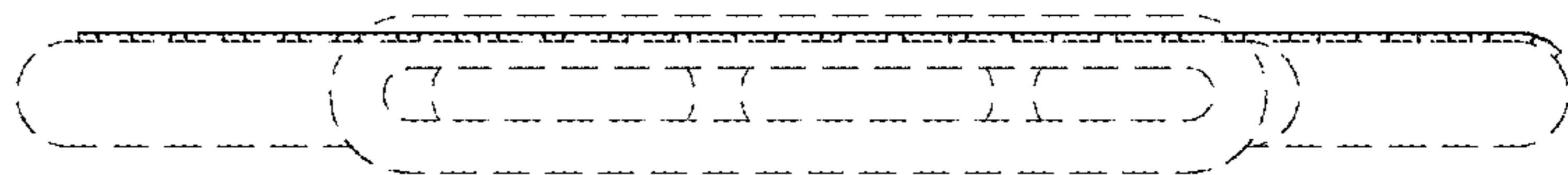
