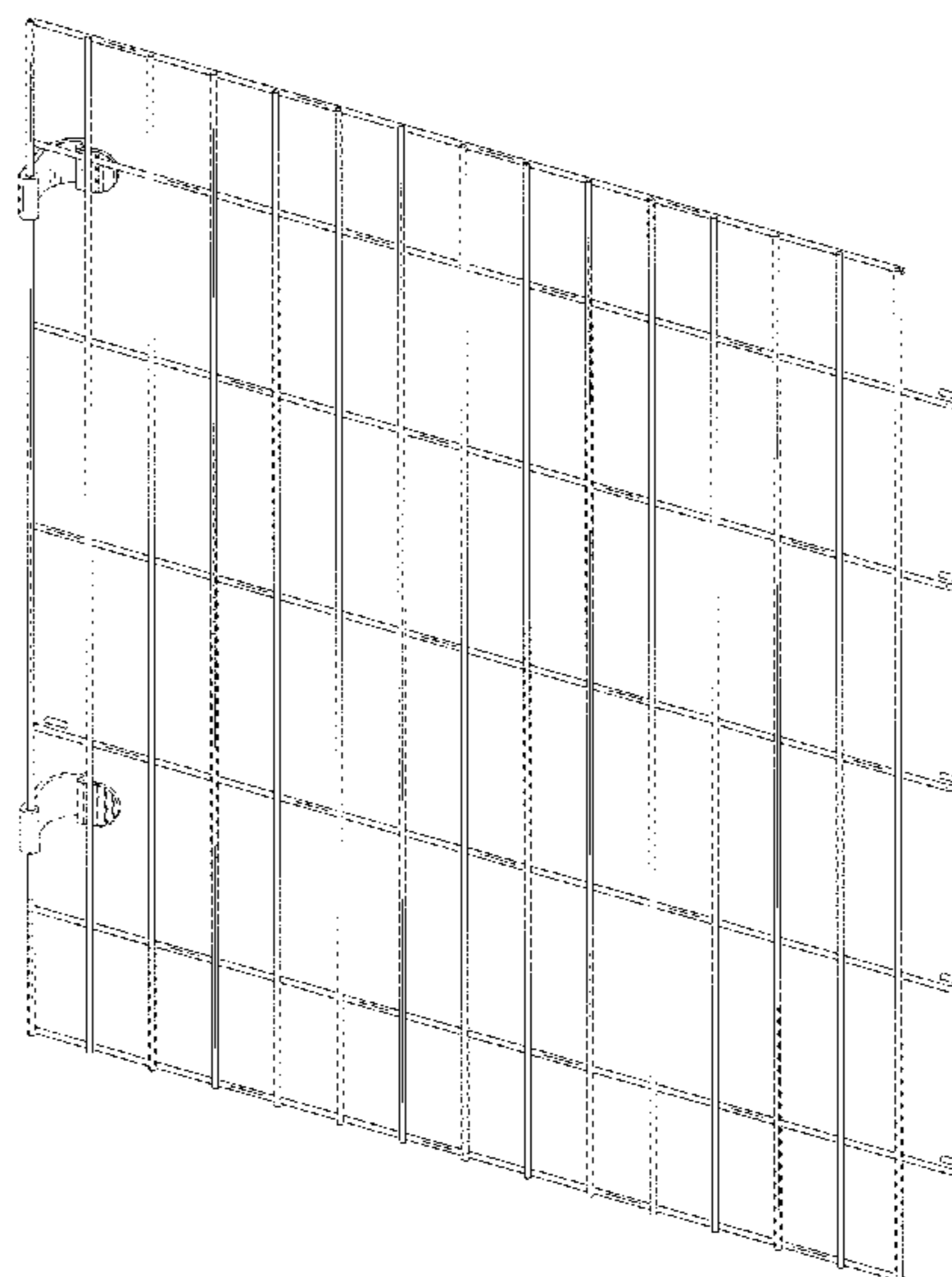
(57) **CLAIM**

The ornamental design for a divider panel for an animal enclosure, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a divider panel for an animal enclosure according to the present design;

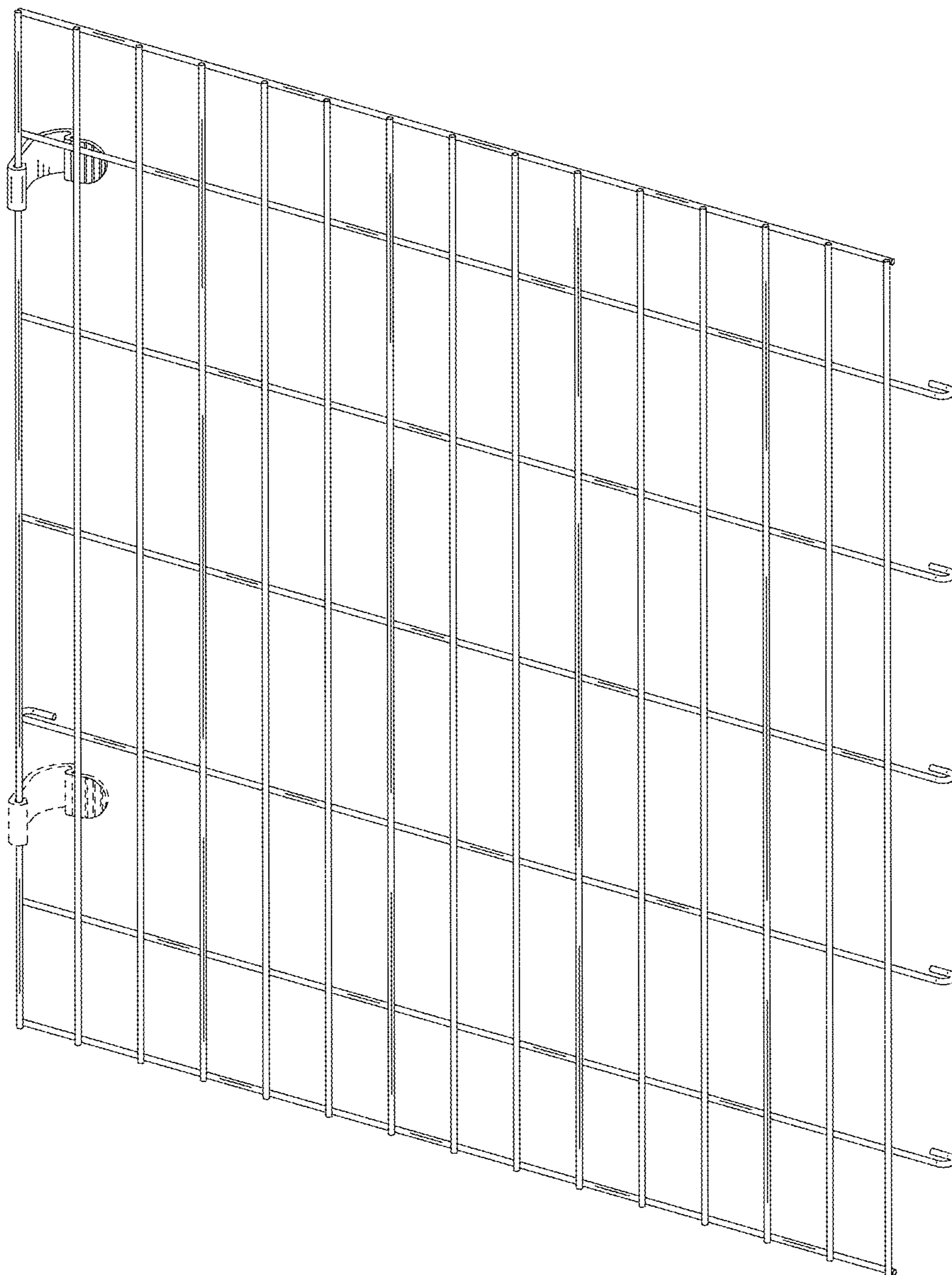

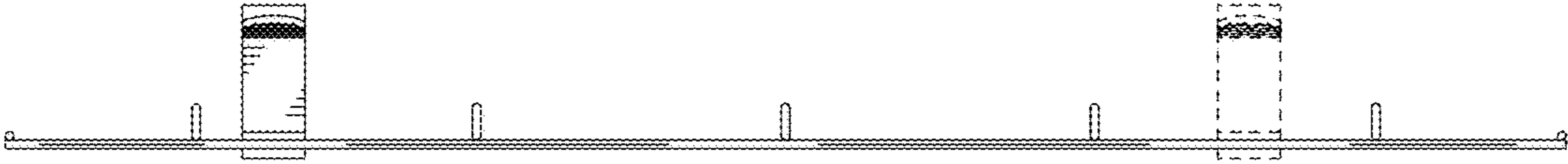

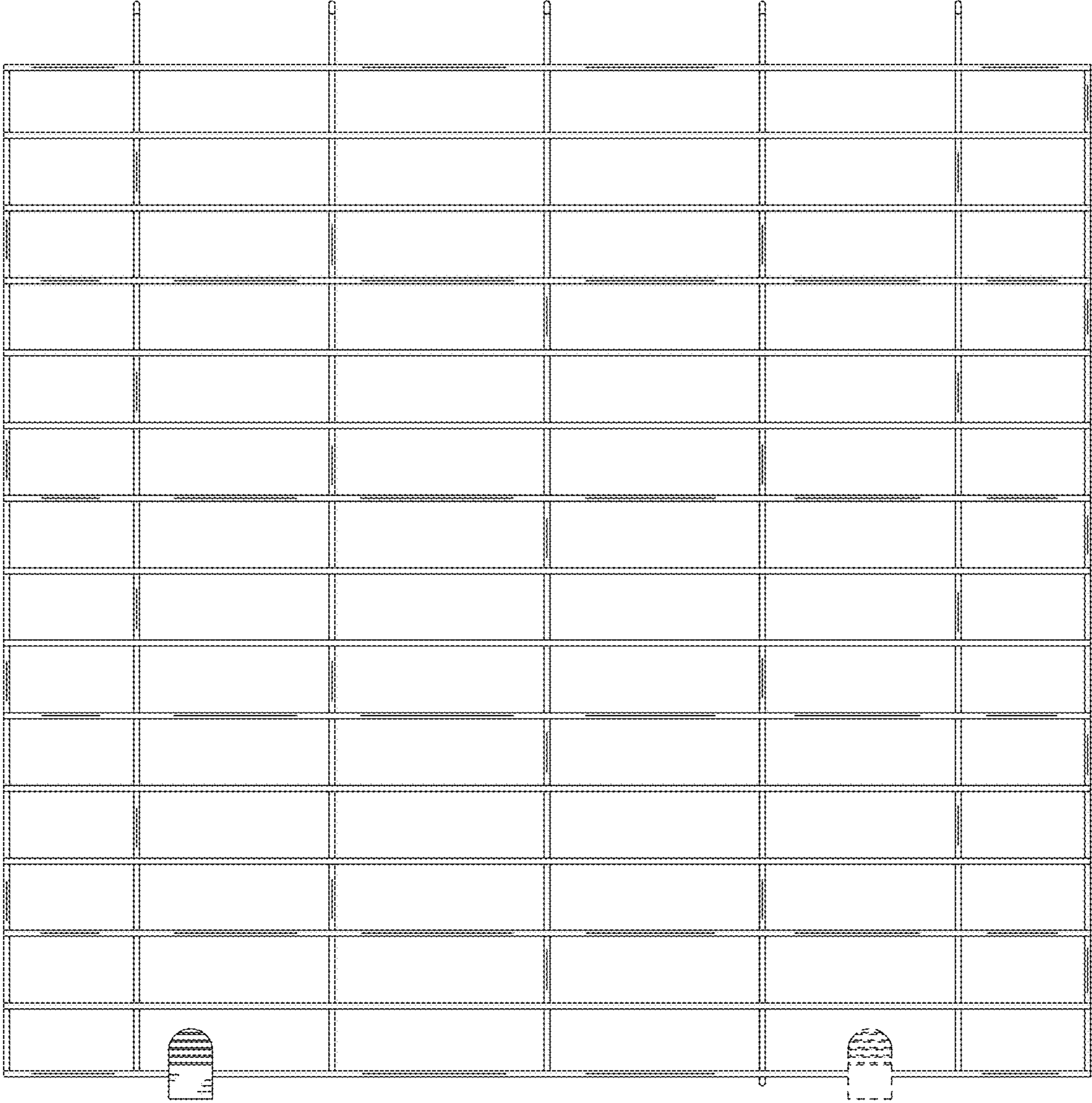

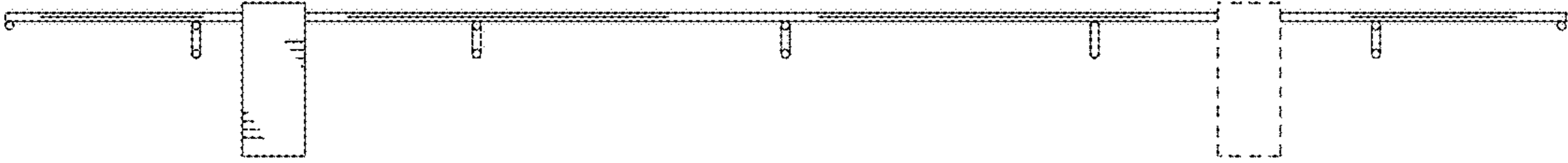

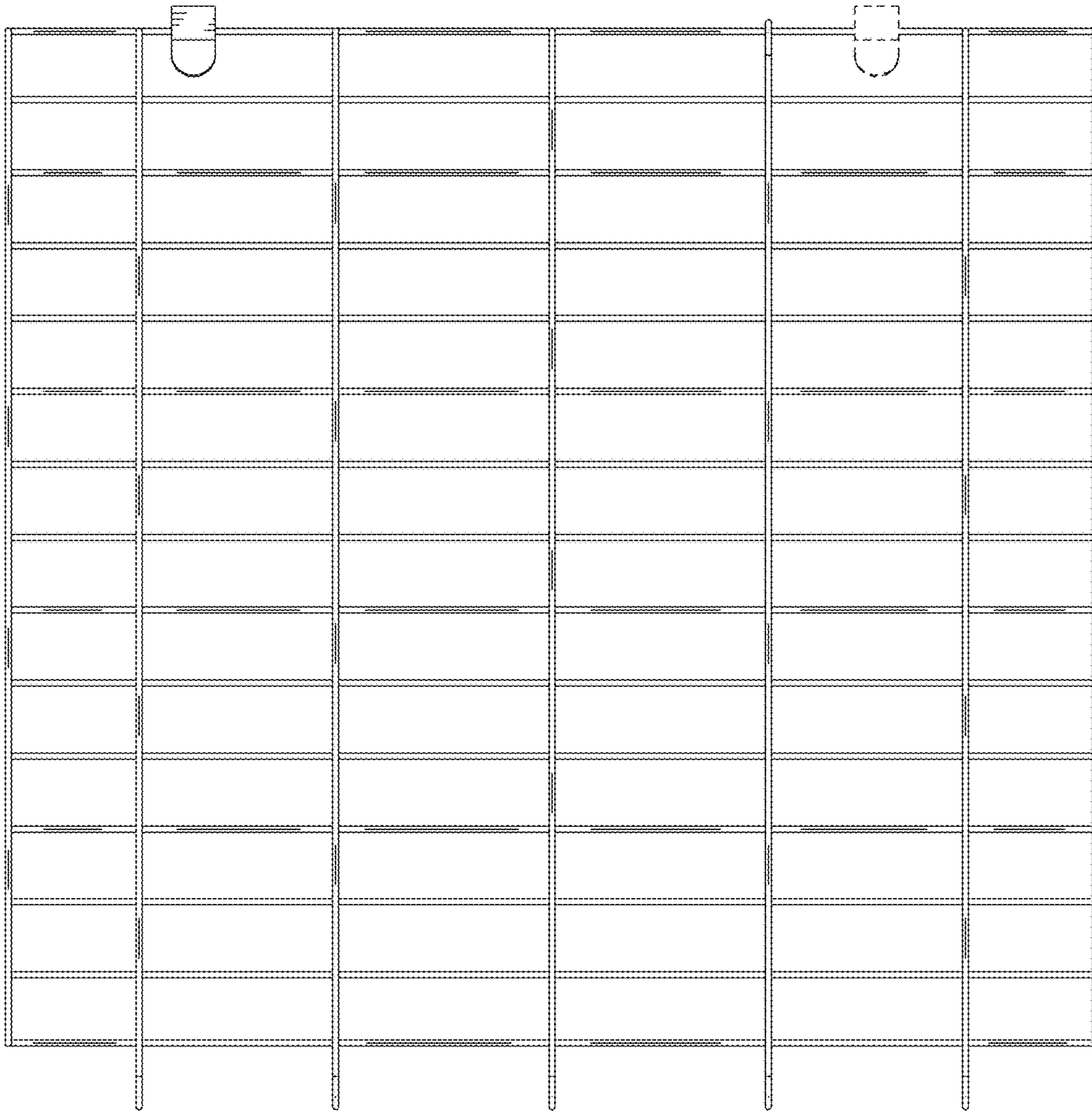

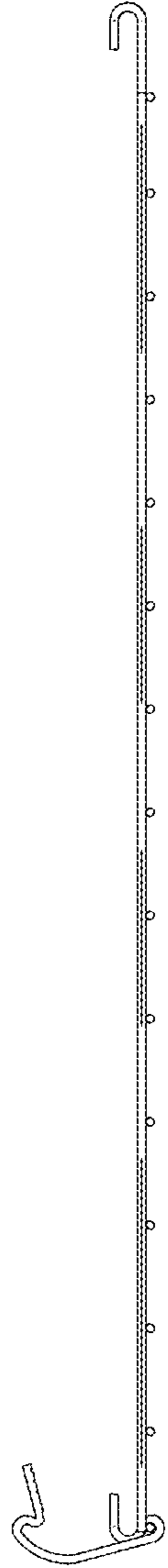

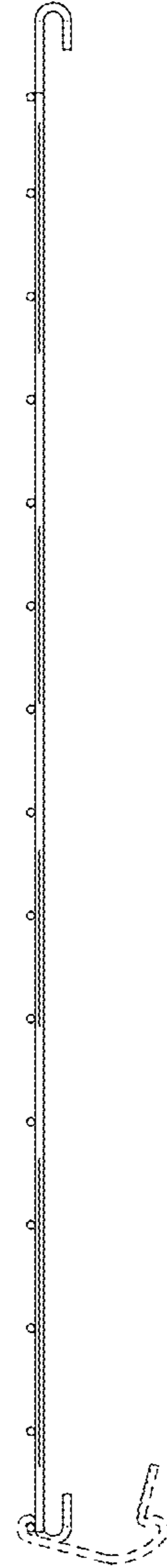
