(57) **CLAIM**

The ornamental design for a convoluted bottom wall of a slow feeding device, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric perspective view of a convoluted bottom wall of a slow feeding device in accordance with our design;

FIG. 2 is a top, plan view thereof;

FIG. 3 is a bottom, plan view thereof;

FIG. 4 is a front elevation view thereof;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a right side elevation view thereof;

FIG. 7 is a left side elevation view thereof;

FIG. 8 is a cross-section taken along line 8-8 of FIG. 2;

FIG. 9 is a cross-section taken along line 9-9 of FIG. 2;

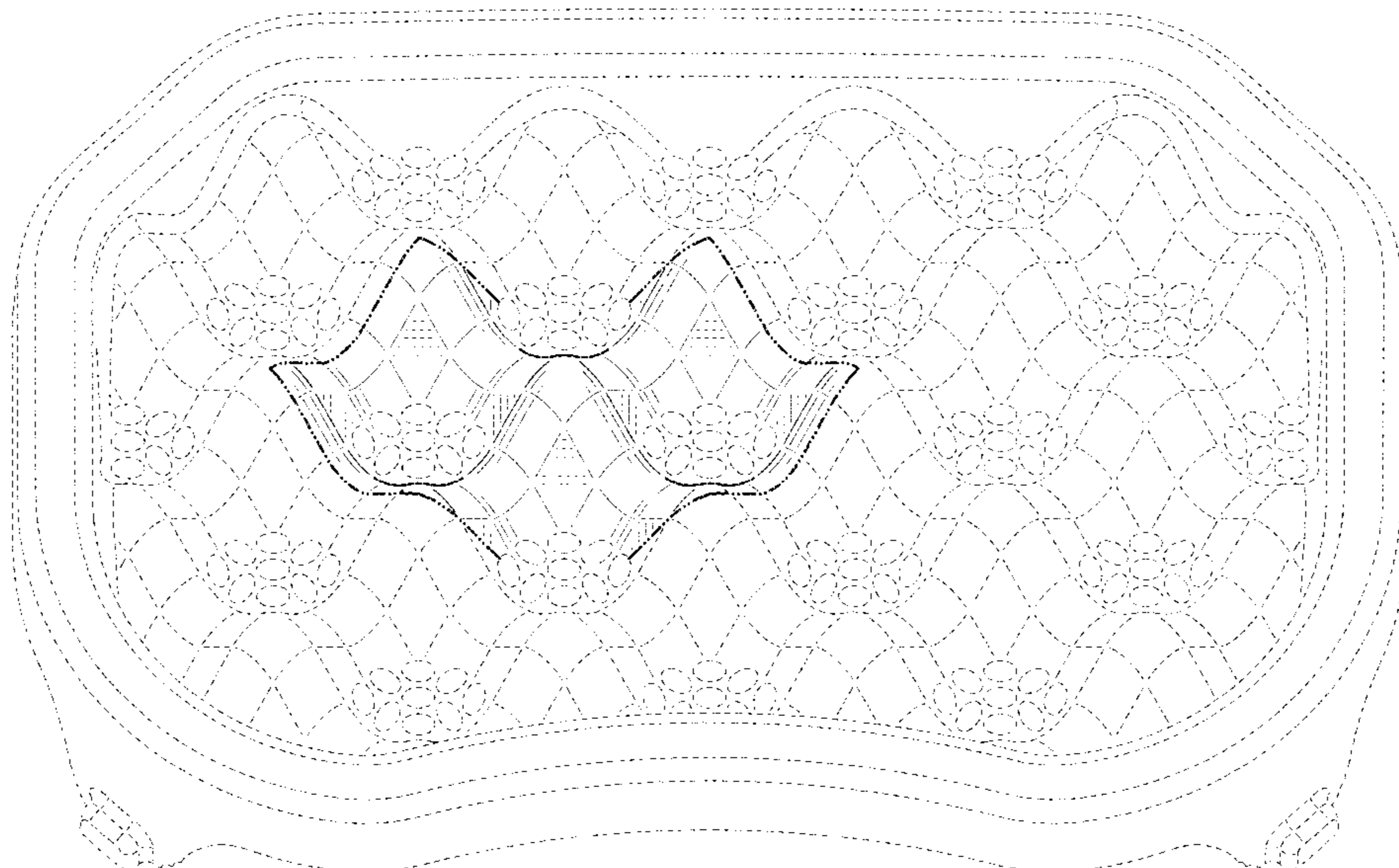
FIG. 10 is a top perspective view of the convoluted bottom wall of a slow feeding device; and,

FIG. 11 is a top perspective view of the convoluted bottom wall of a slow feeding device in use.

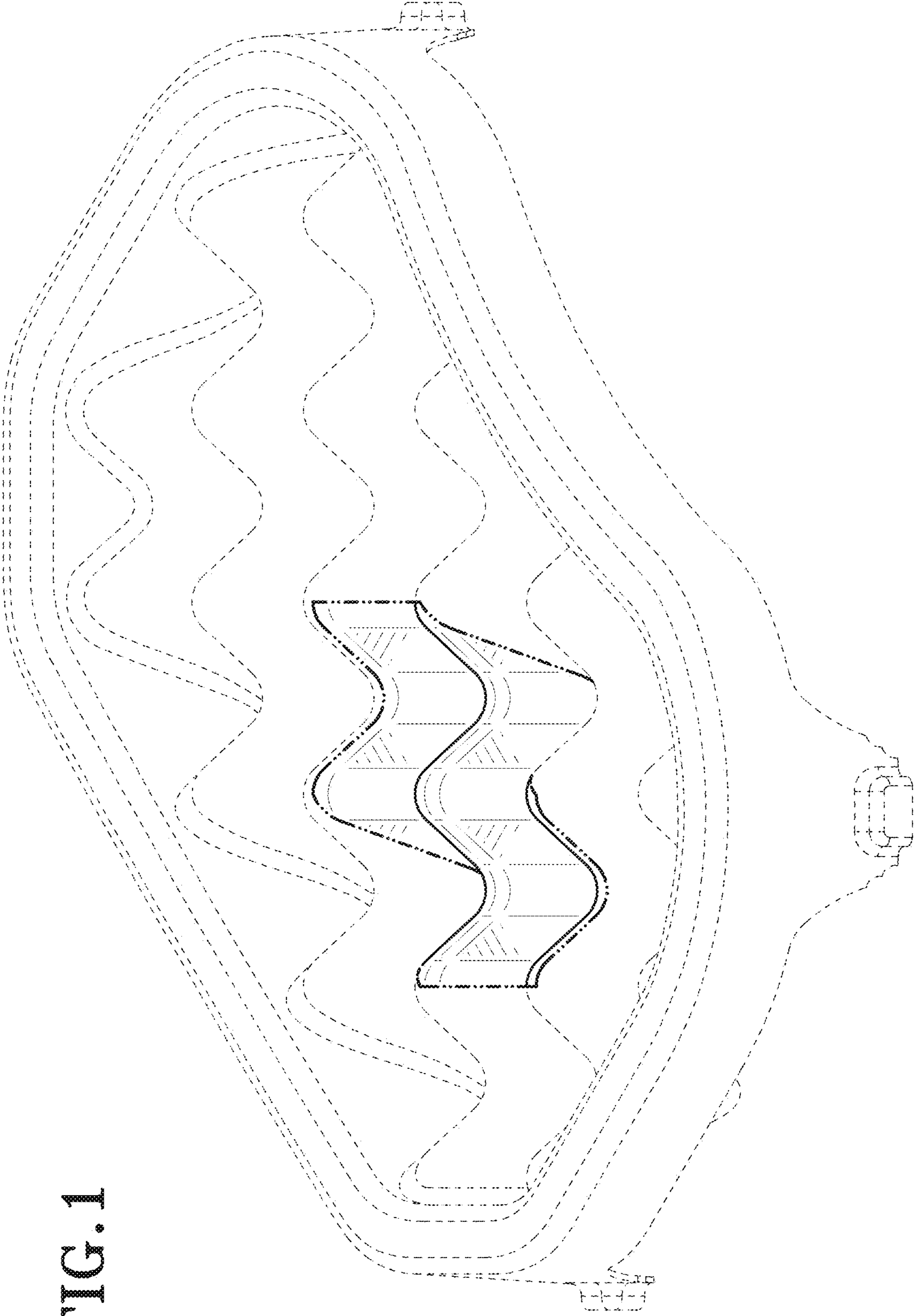
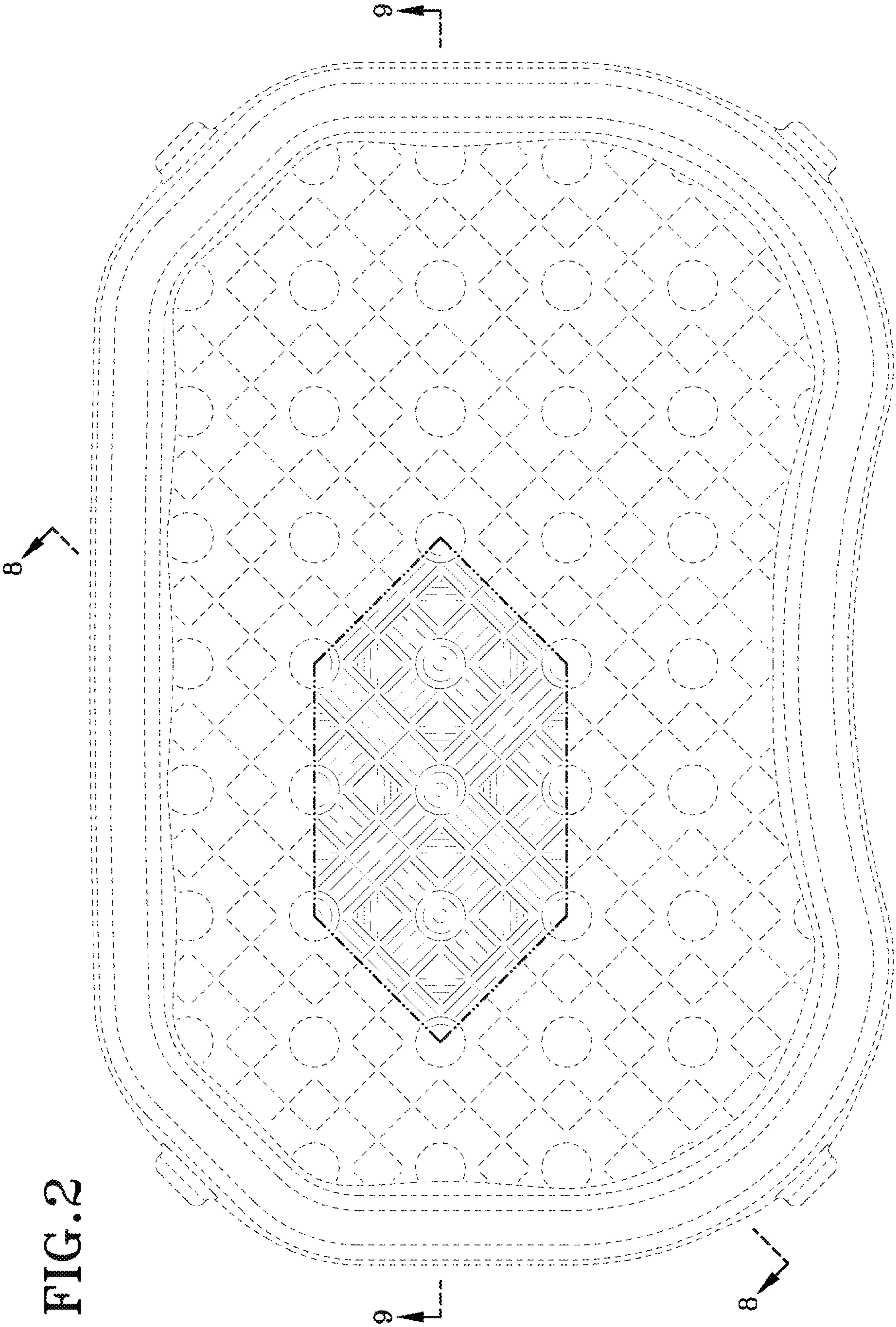

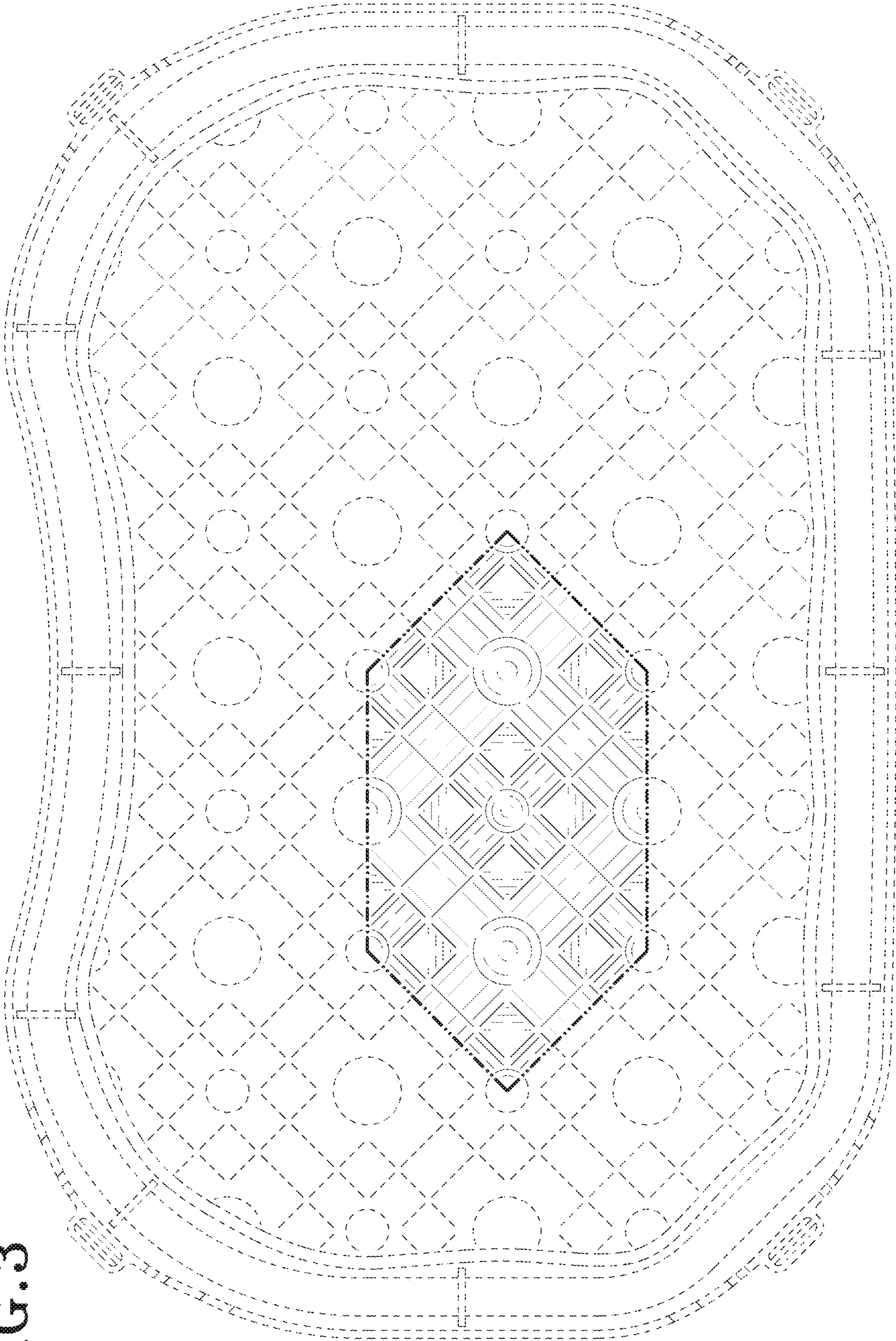

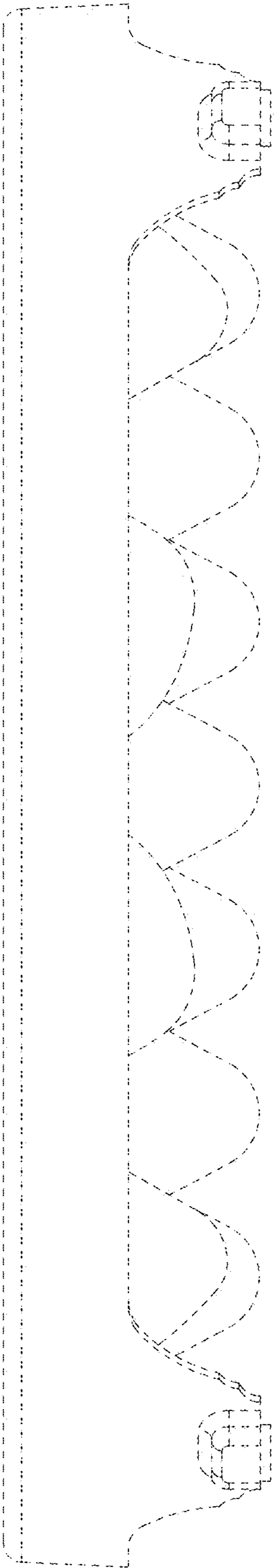

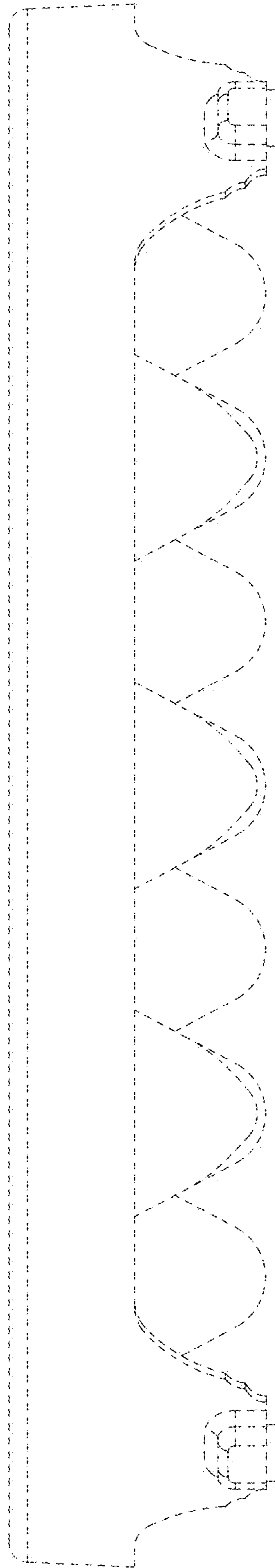

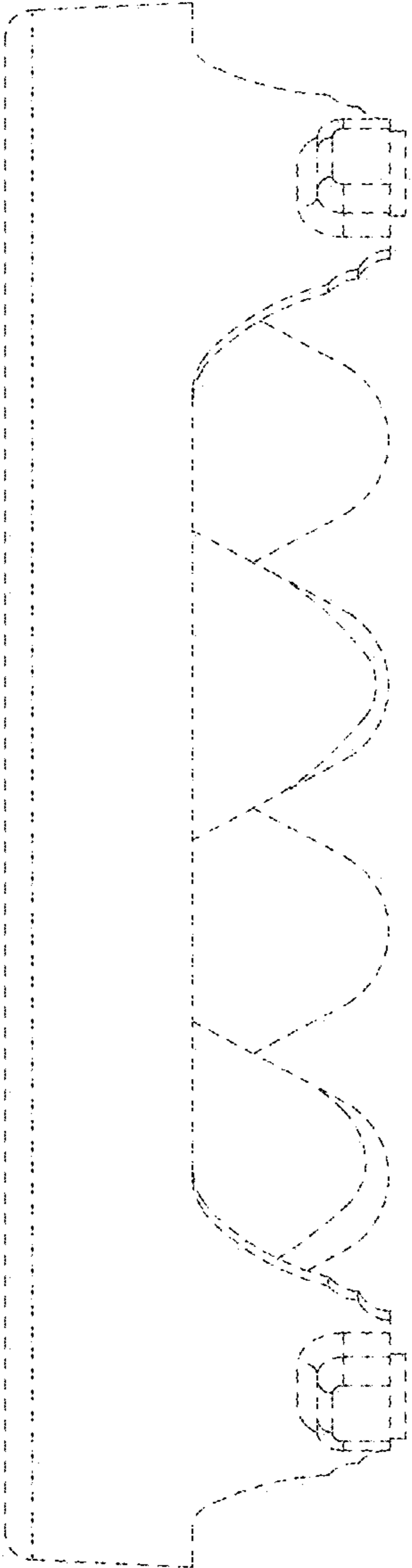

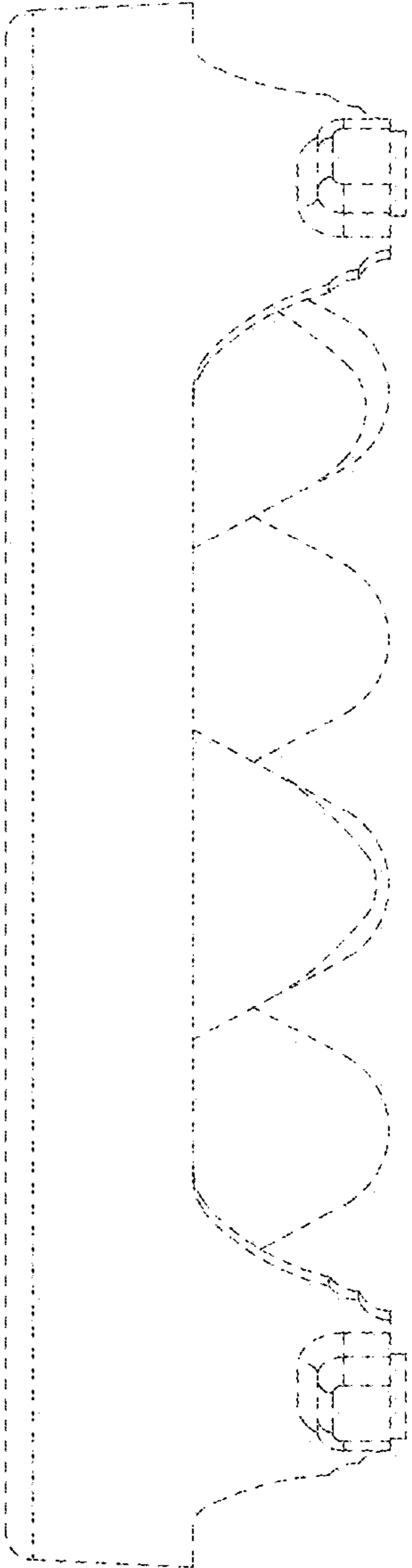

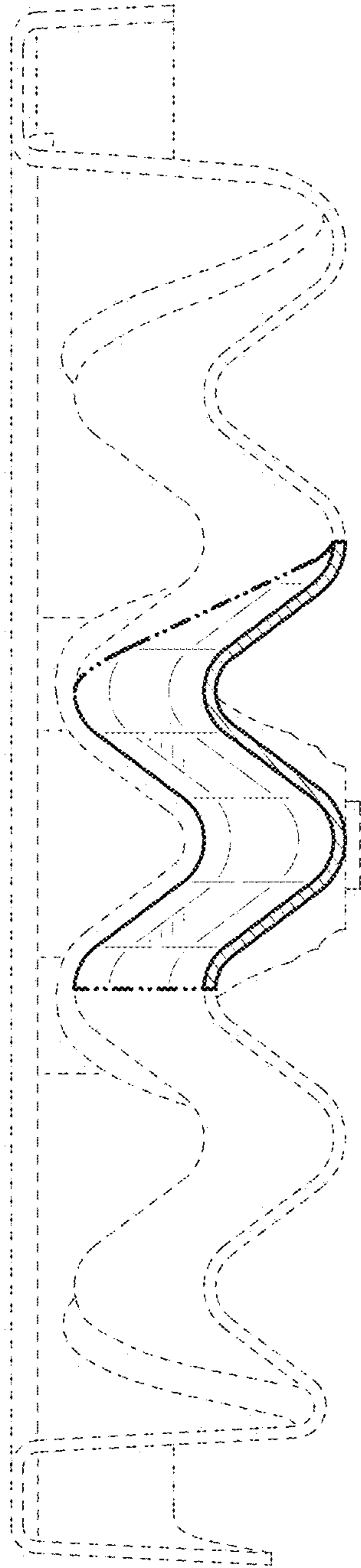

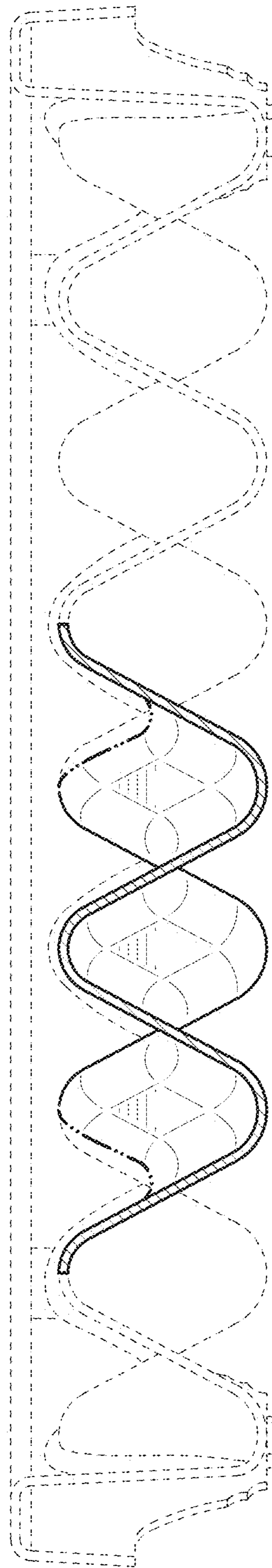

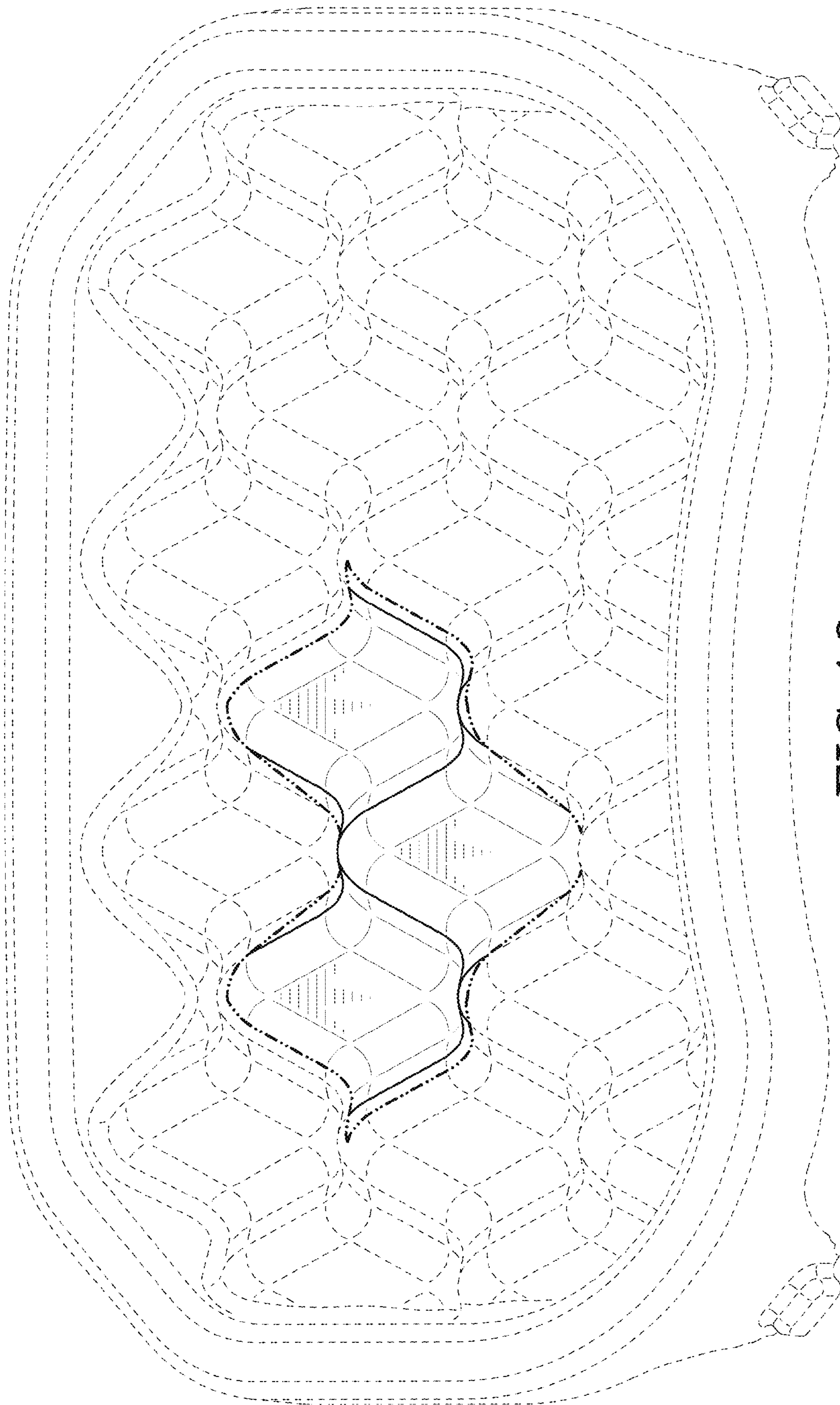

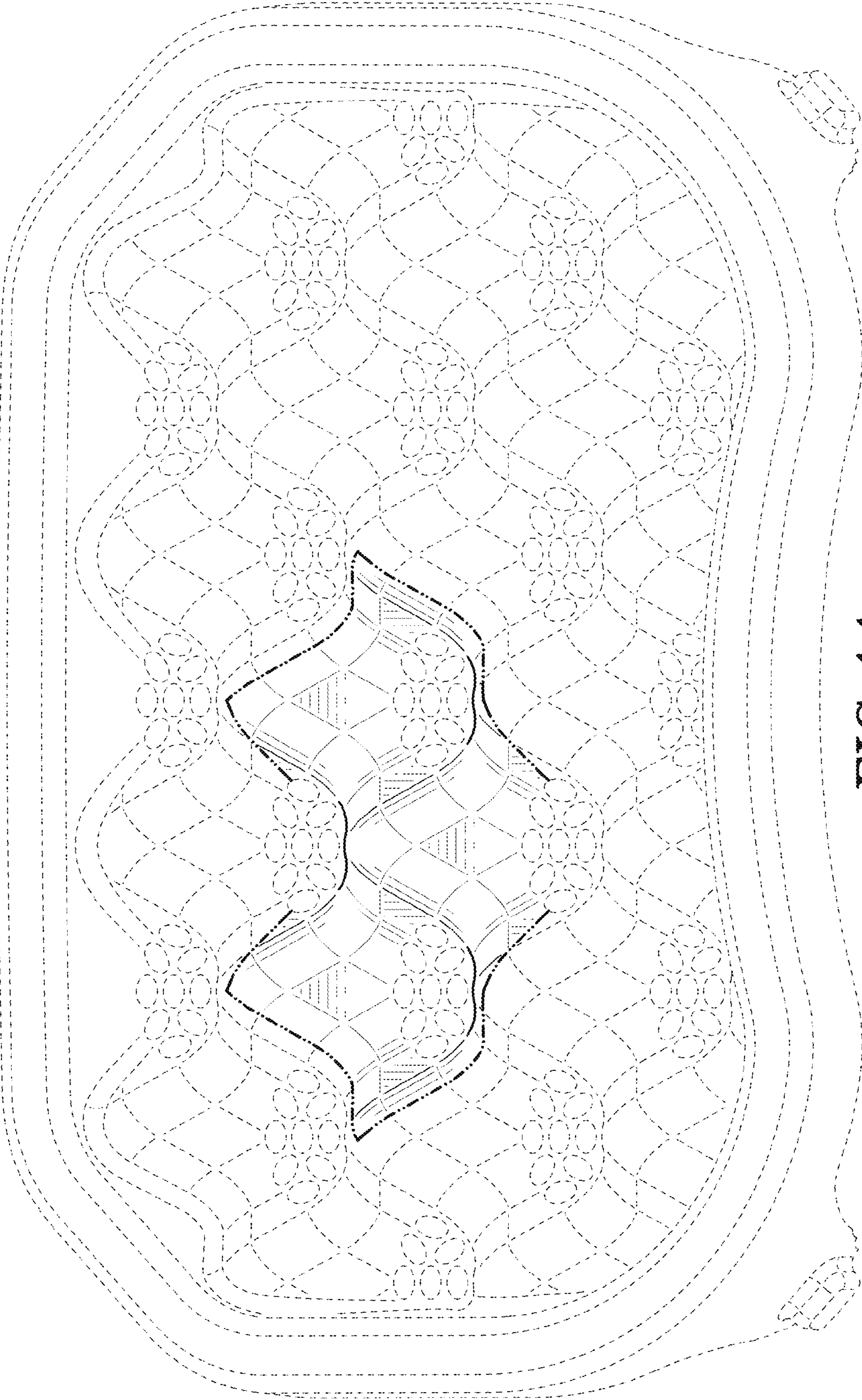
