FIG. 7 is a bottom plan view thereof; and,

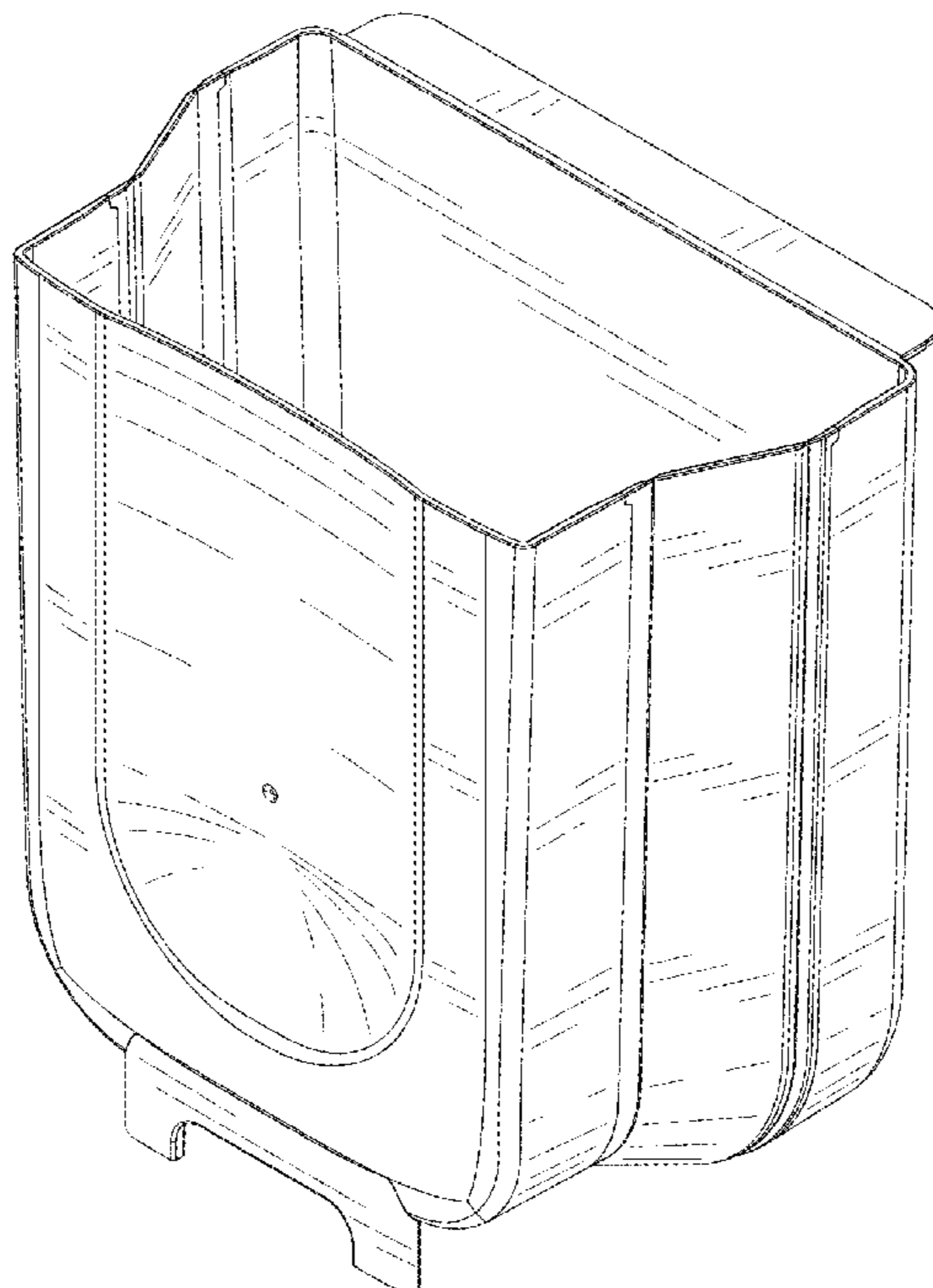
FIG. 8 is a perspective view thereof in a folded state.

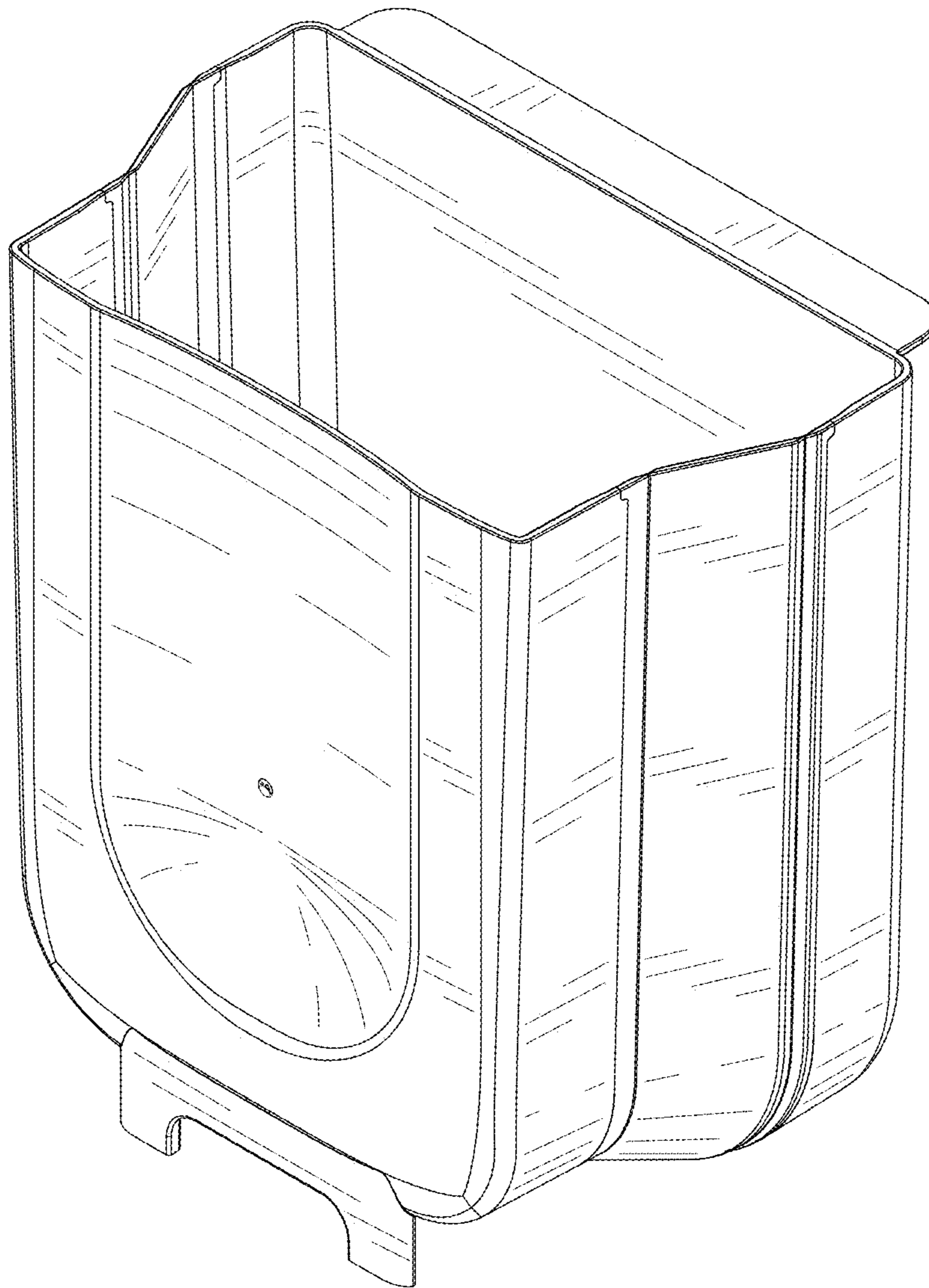

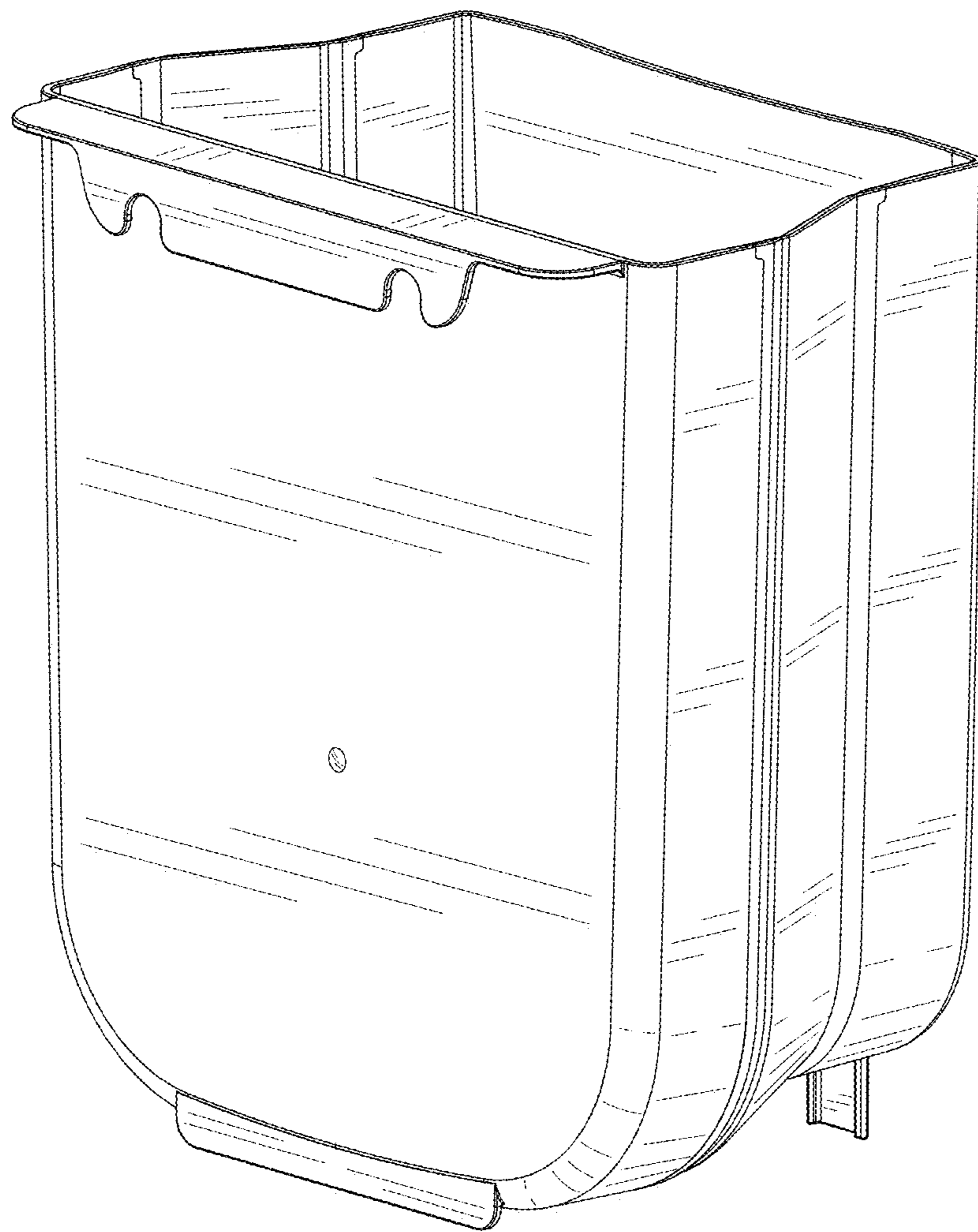

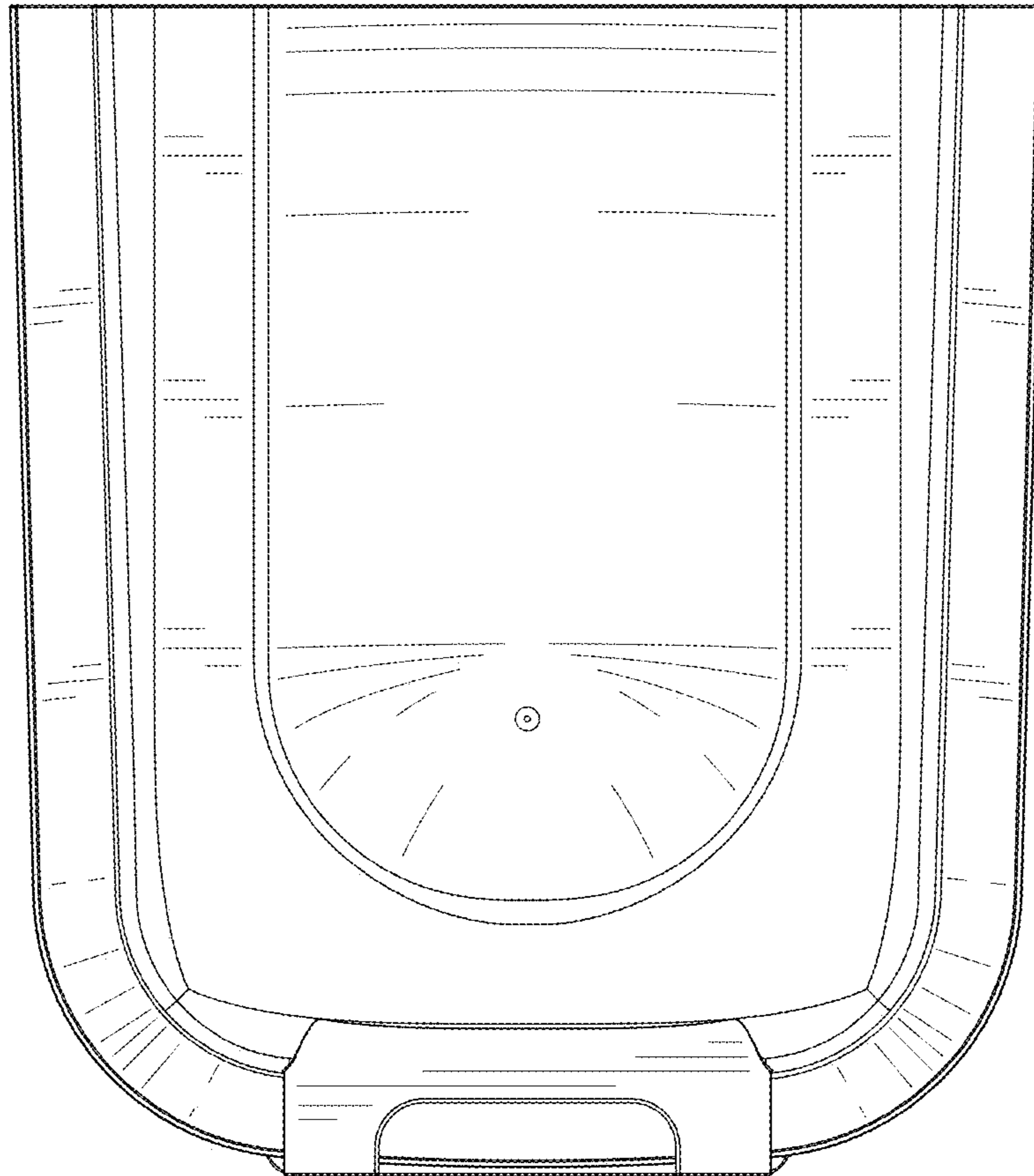

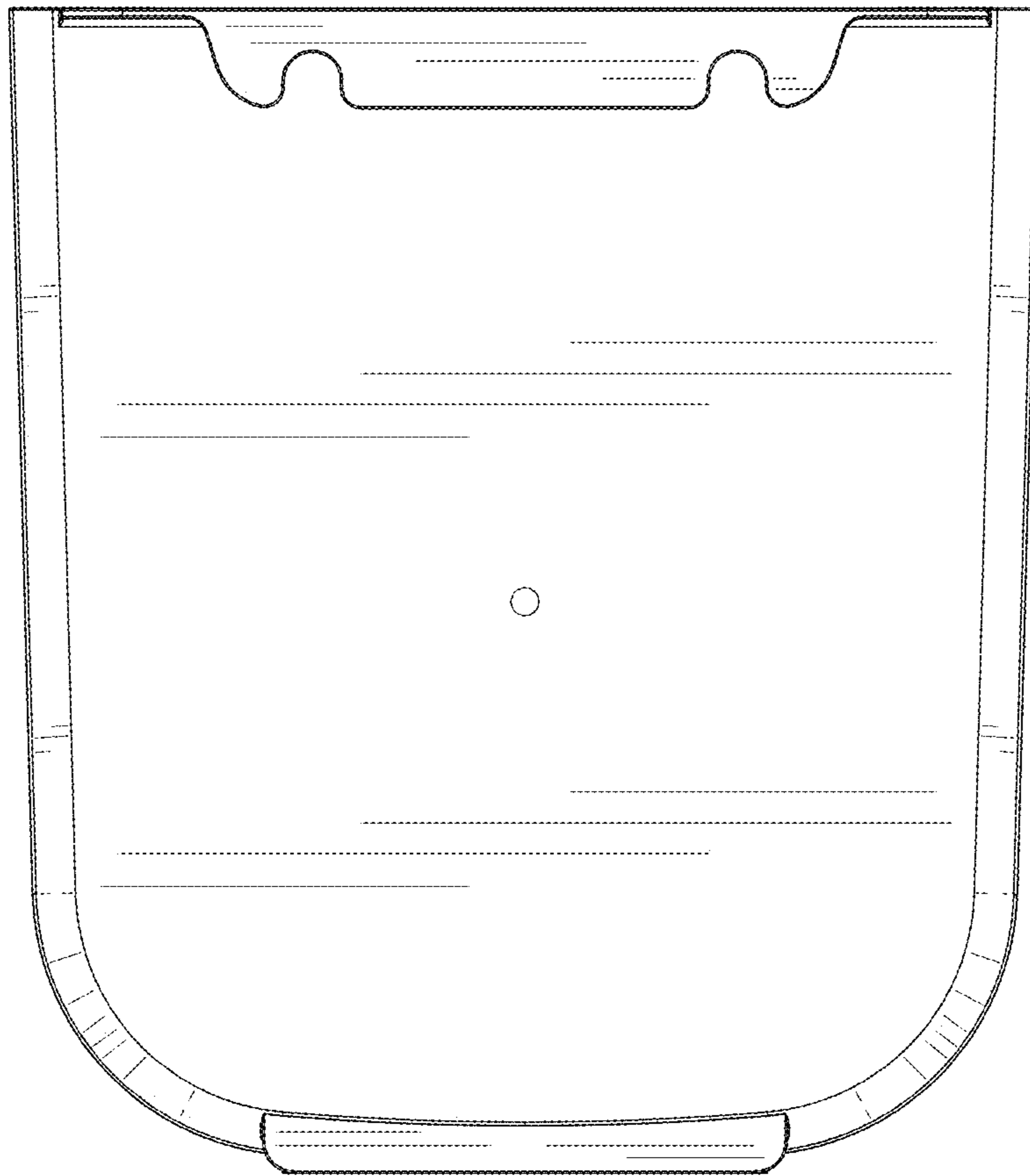

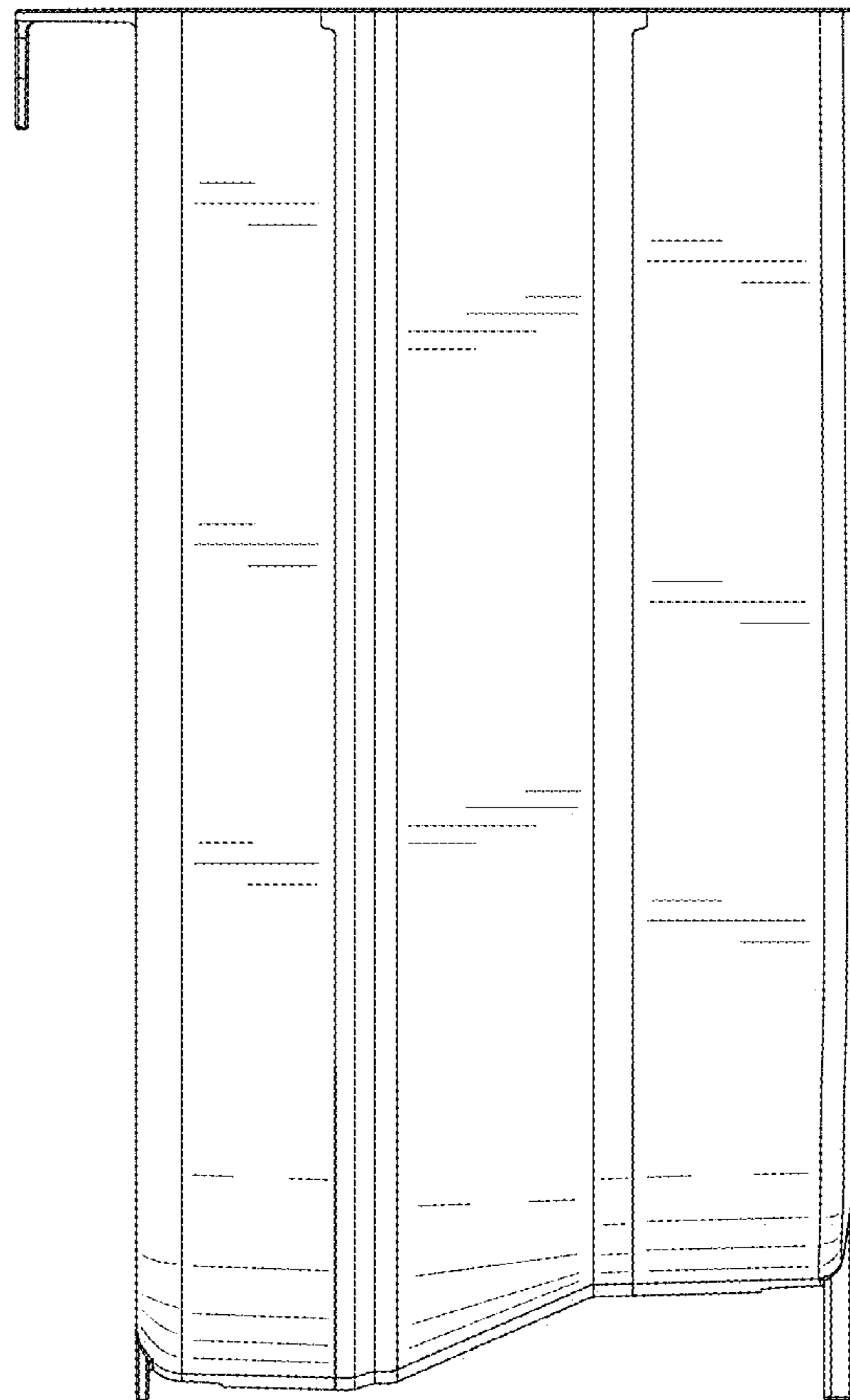

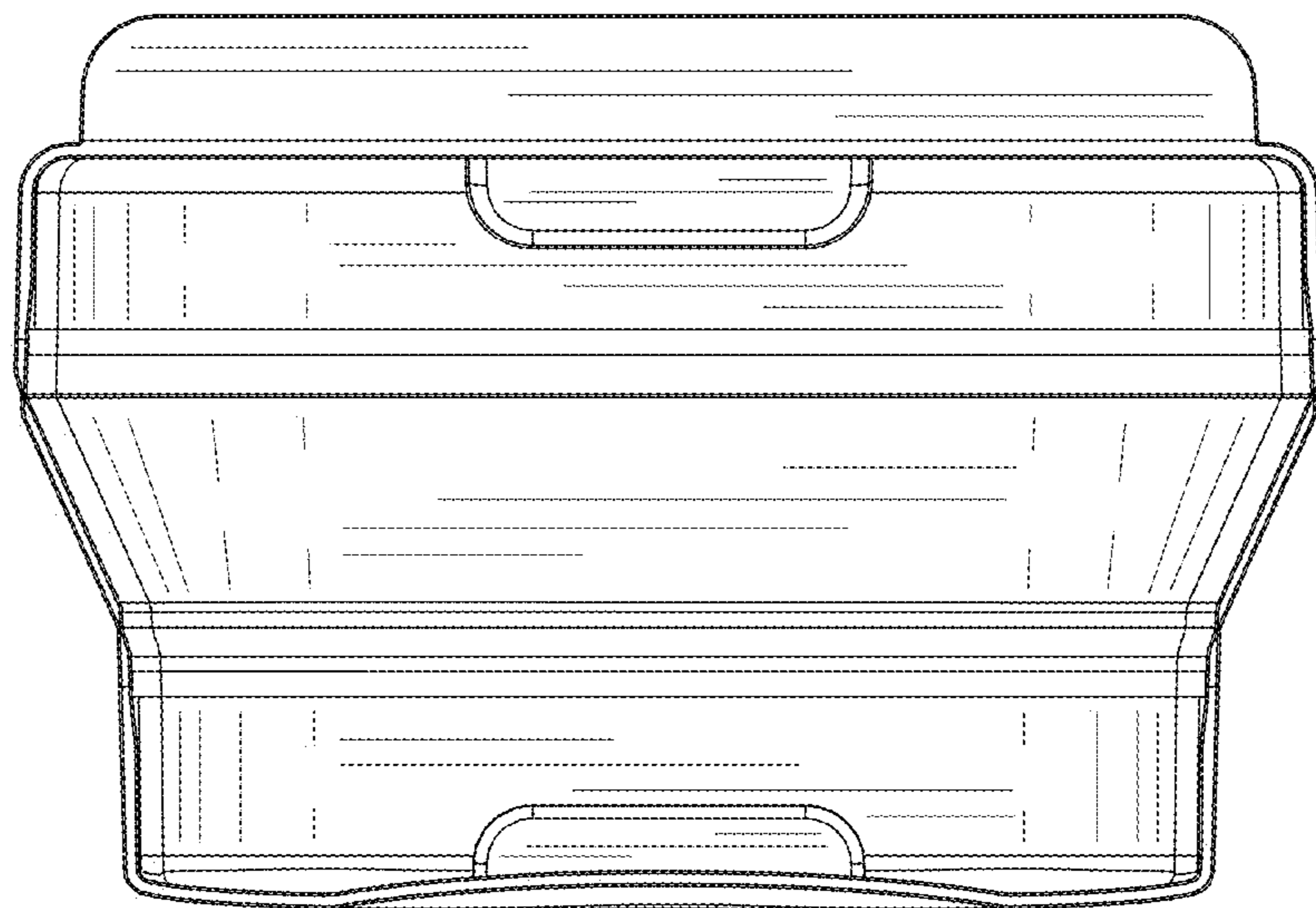

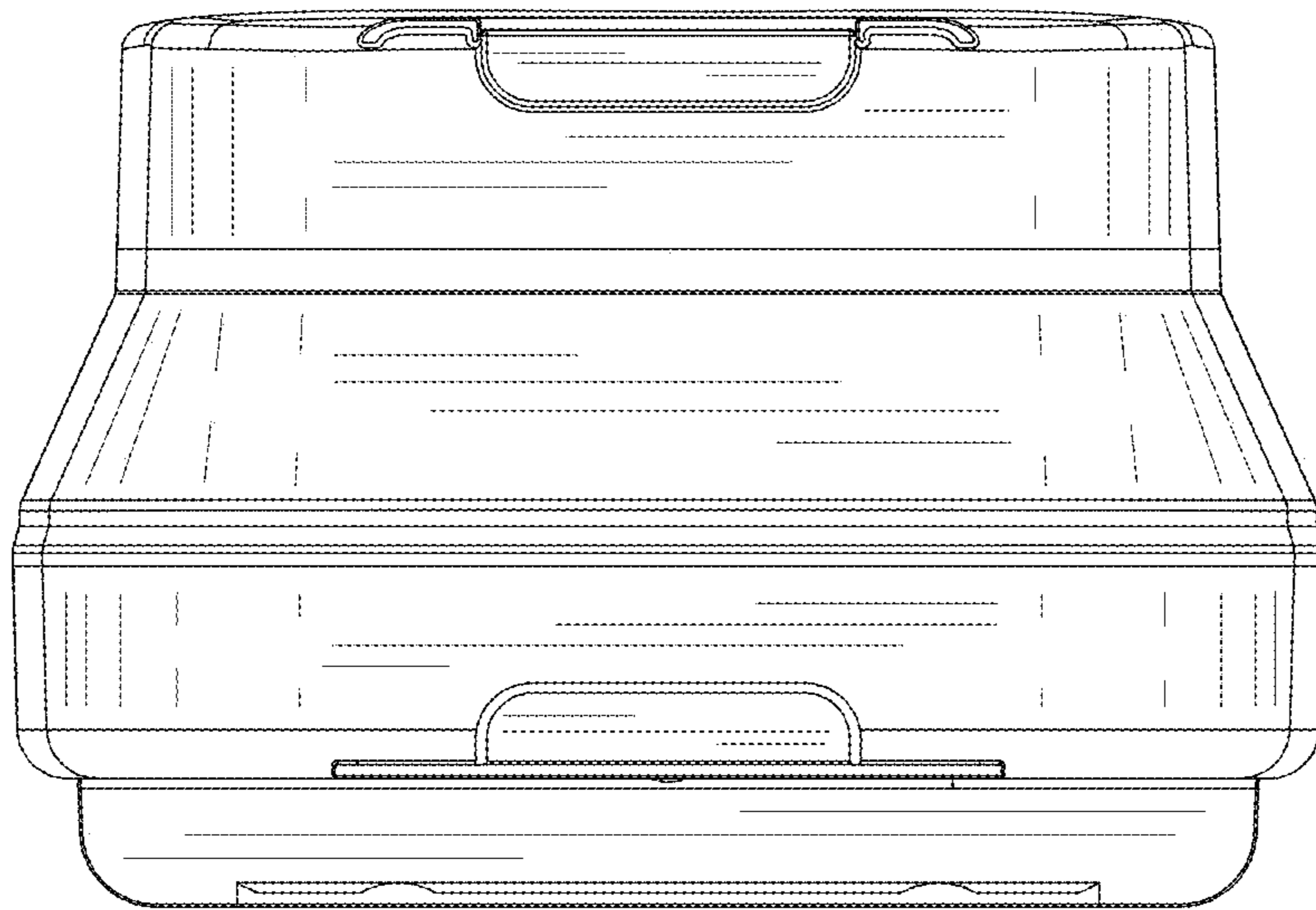

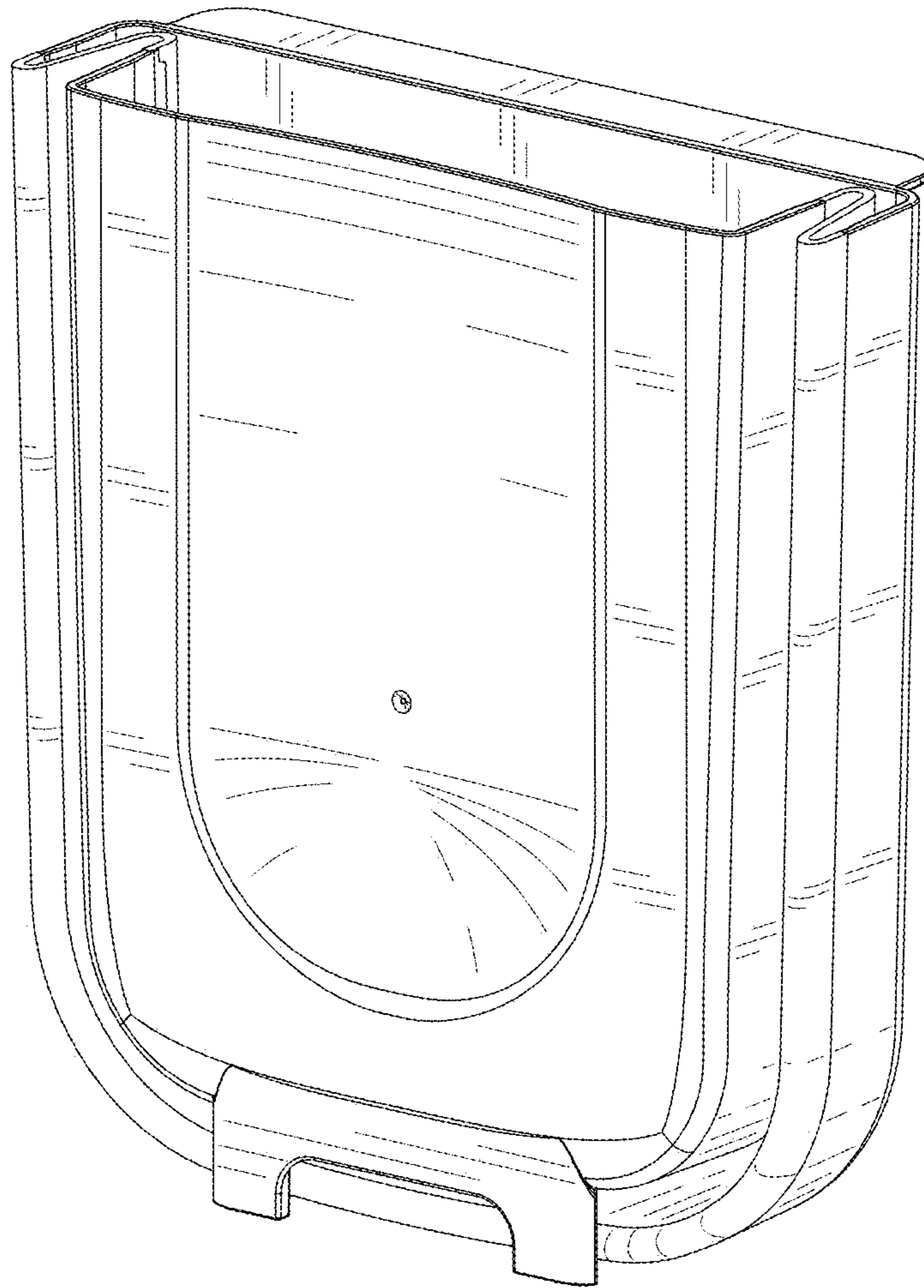
