(57) **CLAIM**


The ornamental design for a curved leveler with base pad, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, front, left side perspective view of a curved leveler with base pad showing our new design; FIG. 2 is a top, rear, right side perspective view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a left side elevational view thereof, the right side elevational view being a mirror image thereof; FIG. 6 is a front elevational view thereof; and, FIG. 7 is a rear elevational view thereof.

The broken lines illustrate portions of the curved leveler with base pad that form no part of the claimed design.














