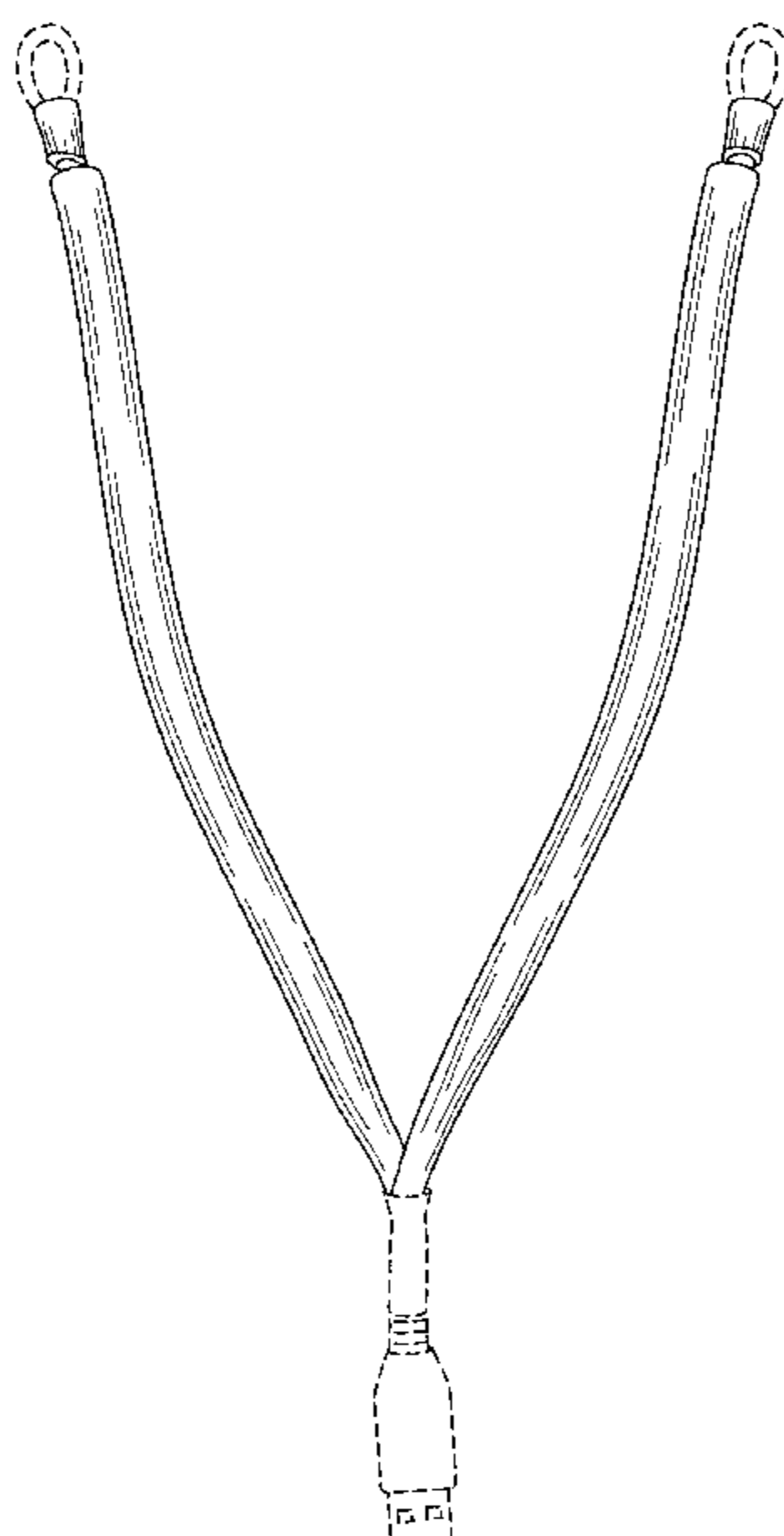
(57) **CLAIM**

I claim the ornamental design for a neckwear with electric warmer, as shown and described herein.

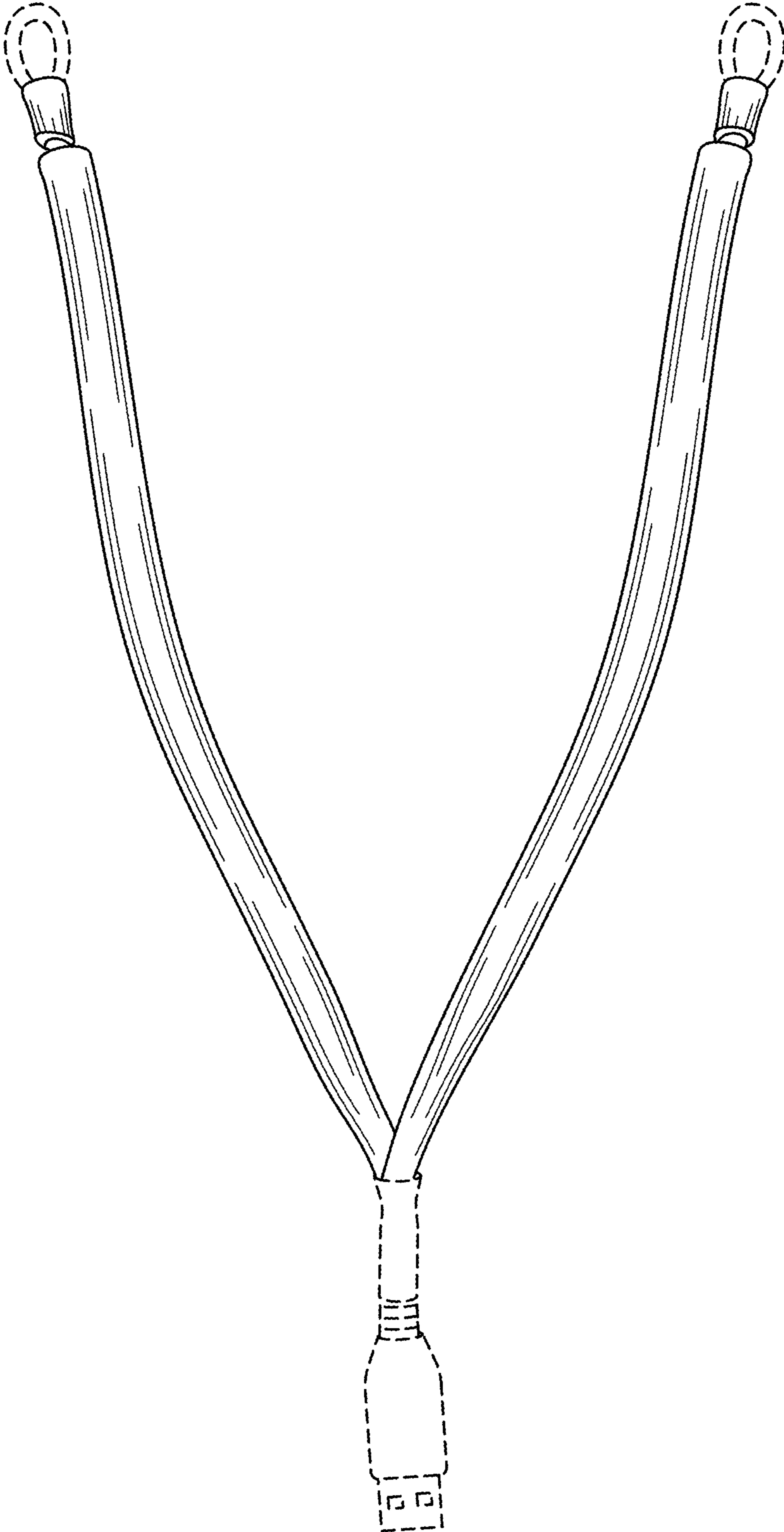

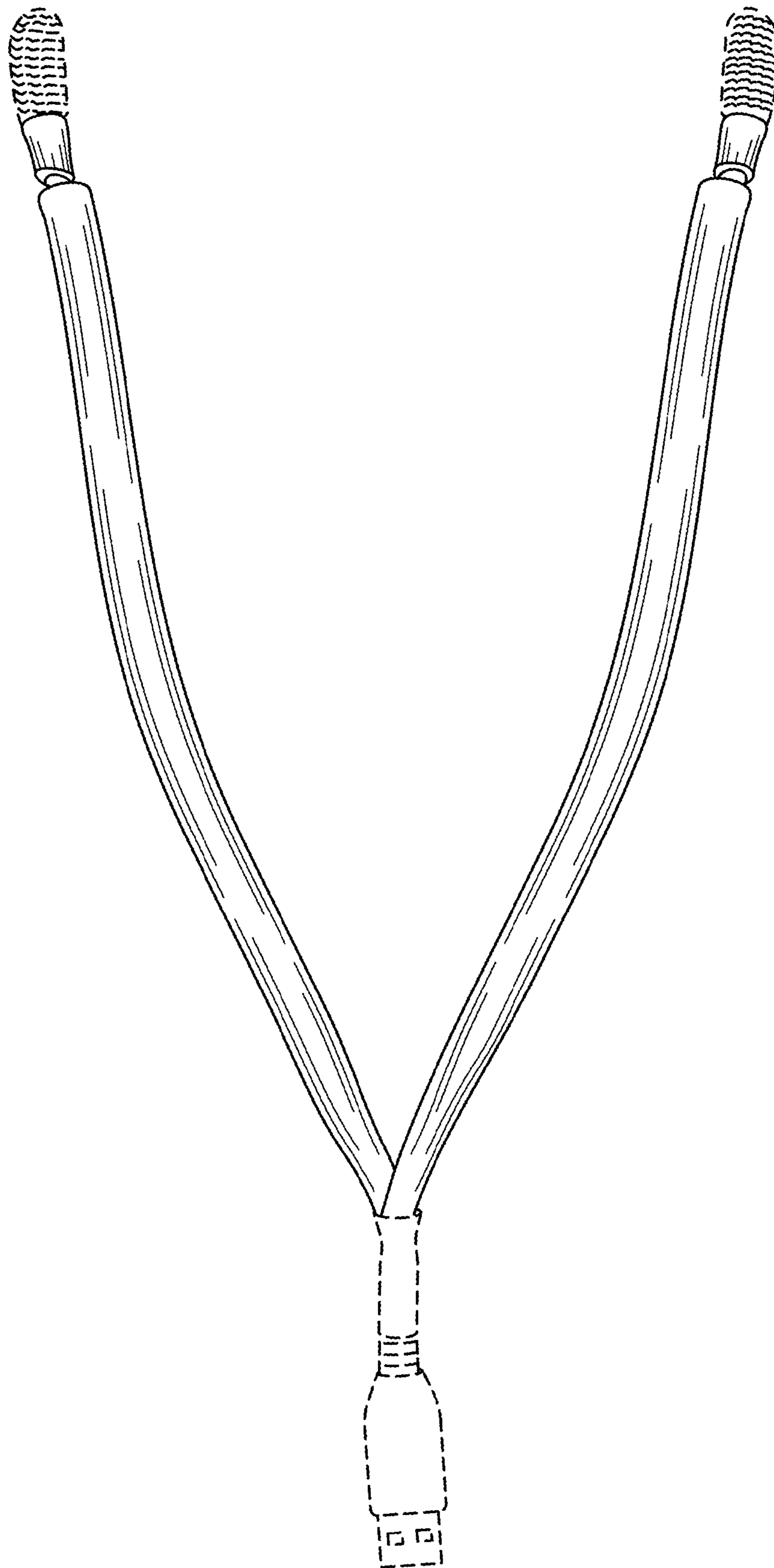
