FIG. 1 is a front perspective view of the present design, shown in a position of use with a user; FIG. 2 is a front view of the present design; FIG. 3 is a right side view of the present design, a corresponding left side view being a mirror image thereof; FIG. 4 is a rear view of the present design; FIG. 5 is a bottom view of the present design; and, FIG. 6 is a top view of the present design. 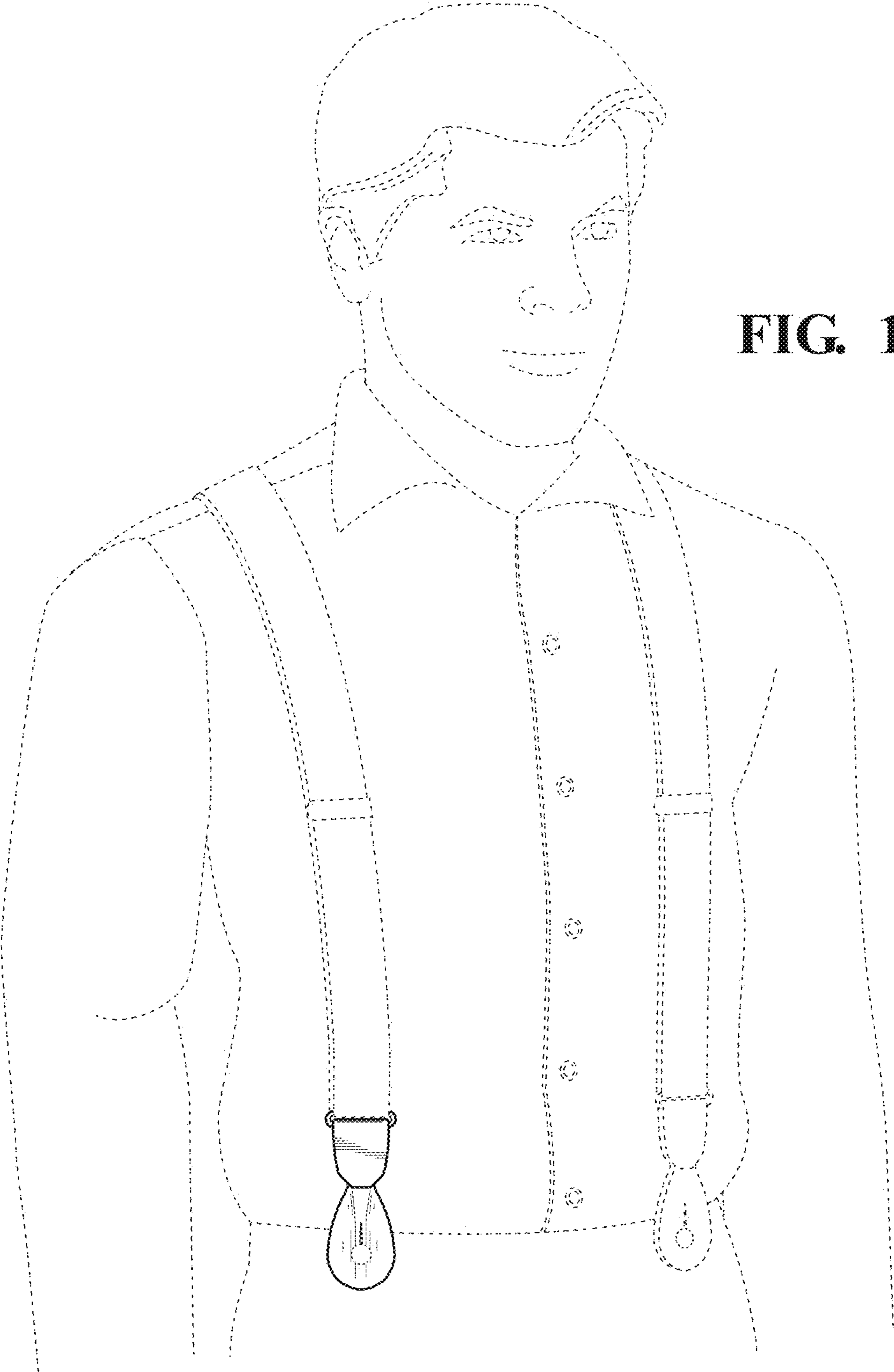

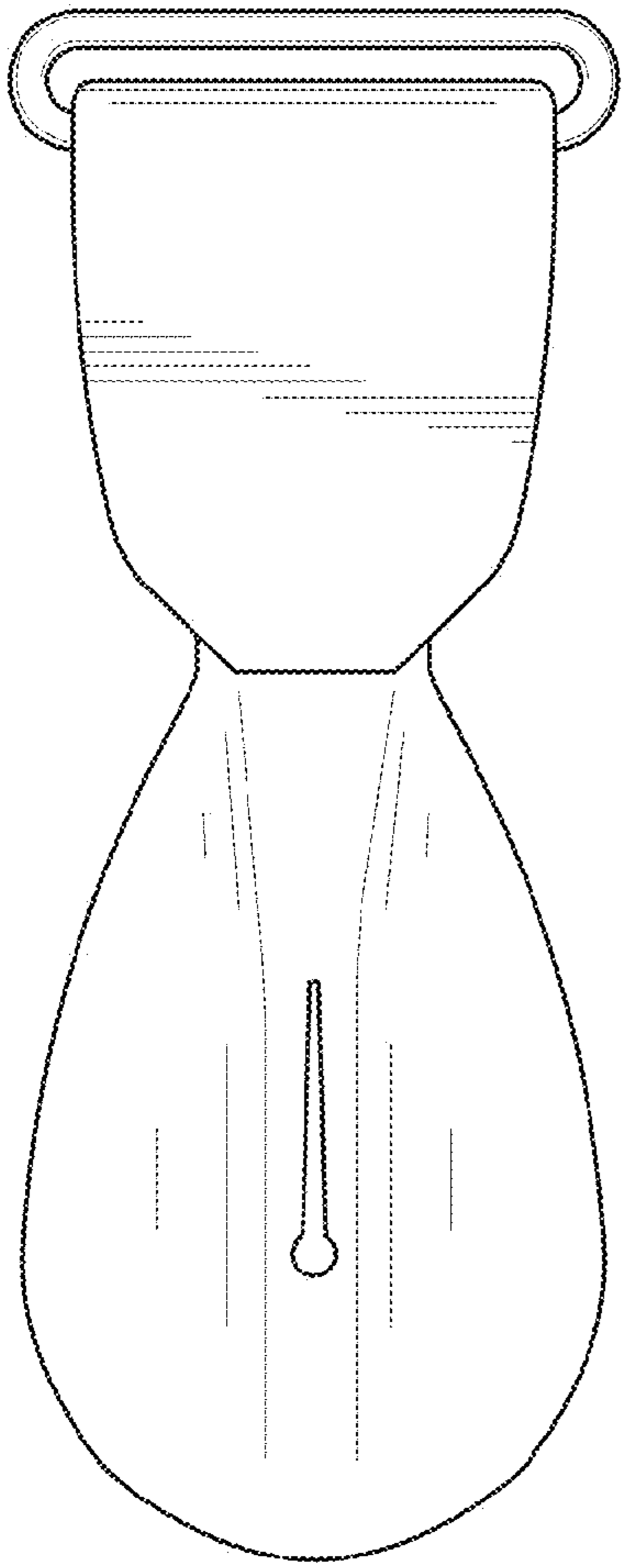

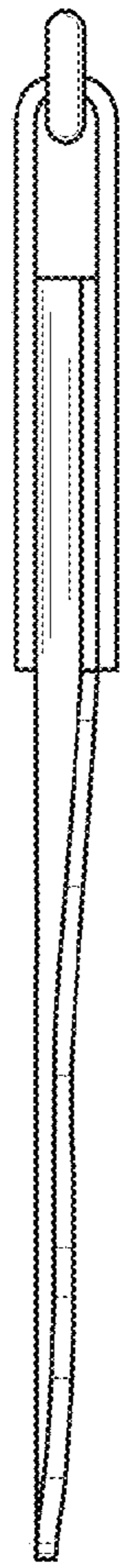

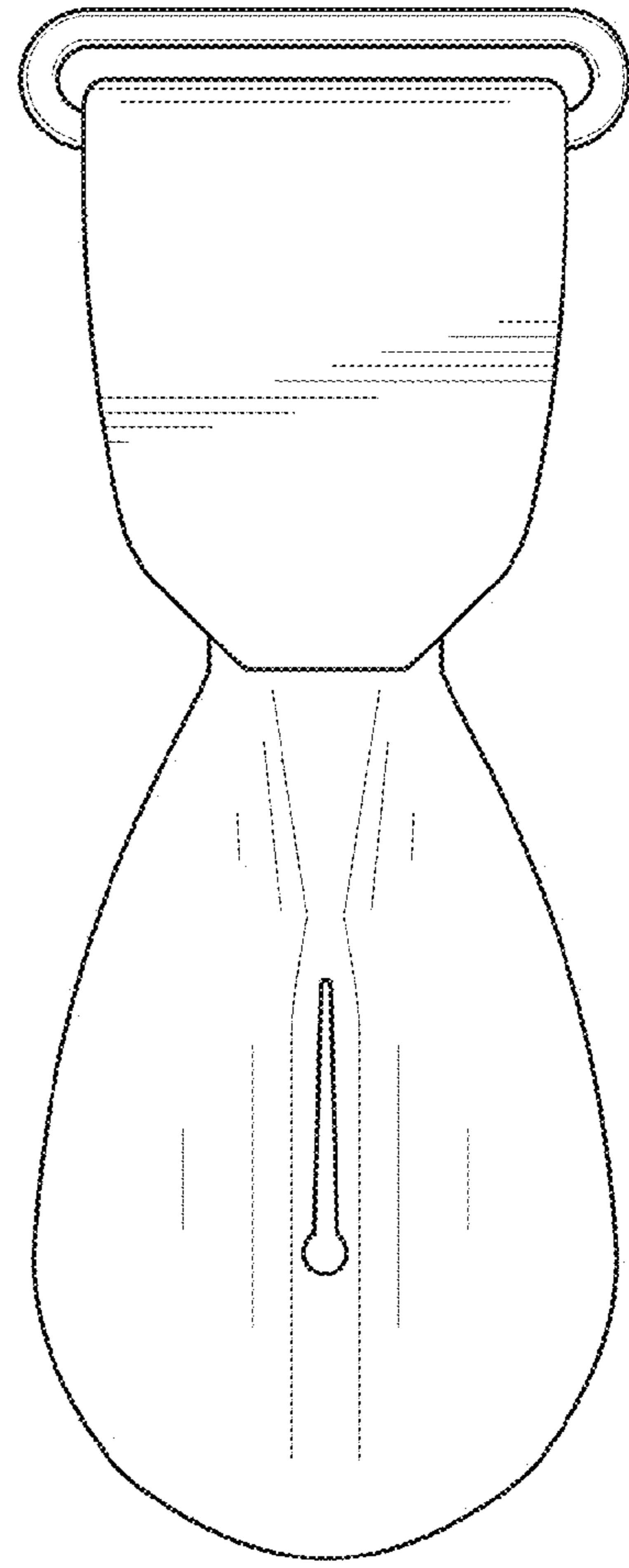

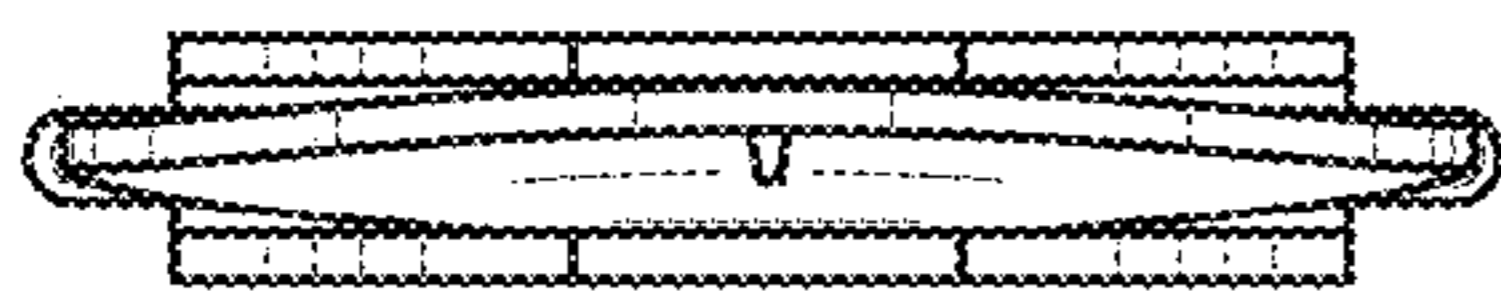
