DESCRIPTION

FIG. 17 is a front view thereof;

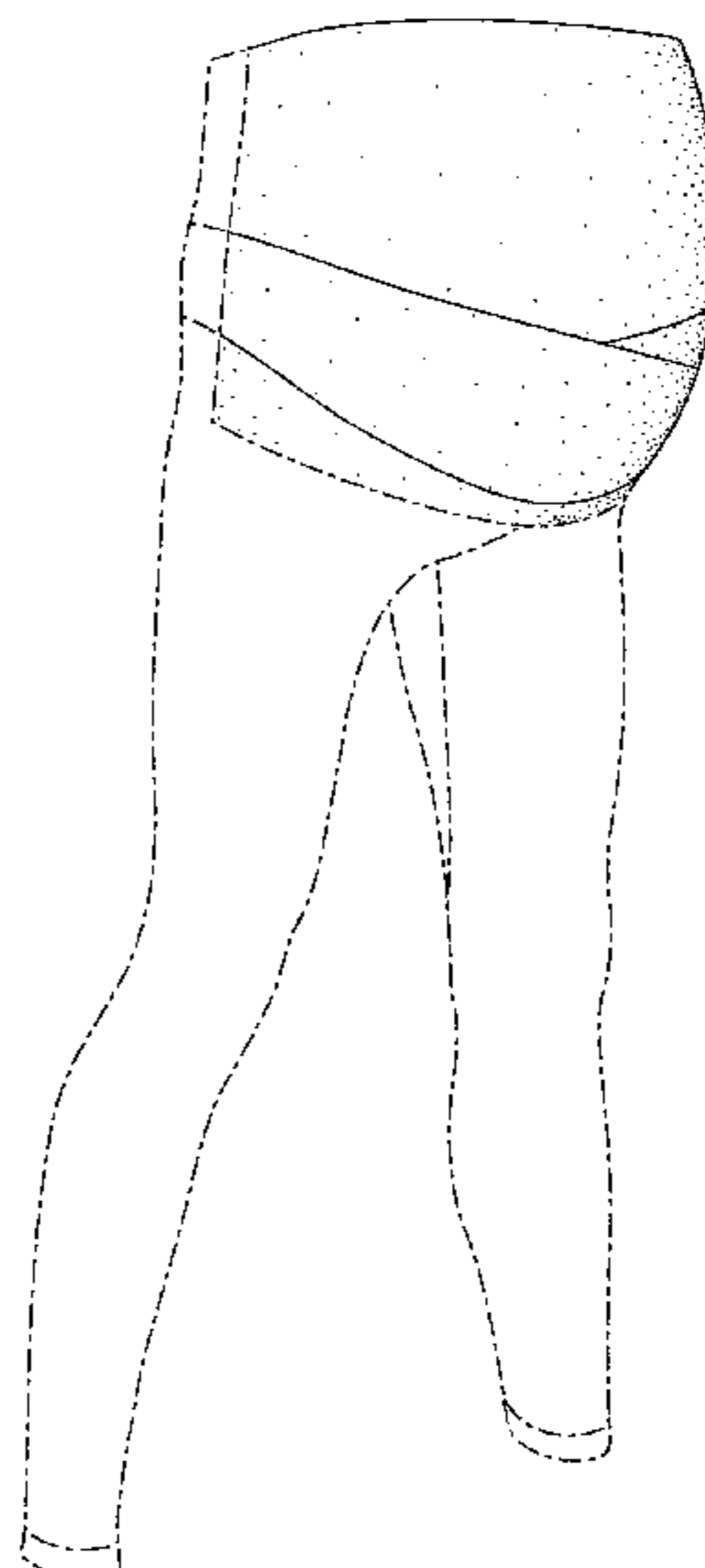
FIG. 18 is a left side view thereof;

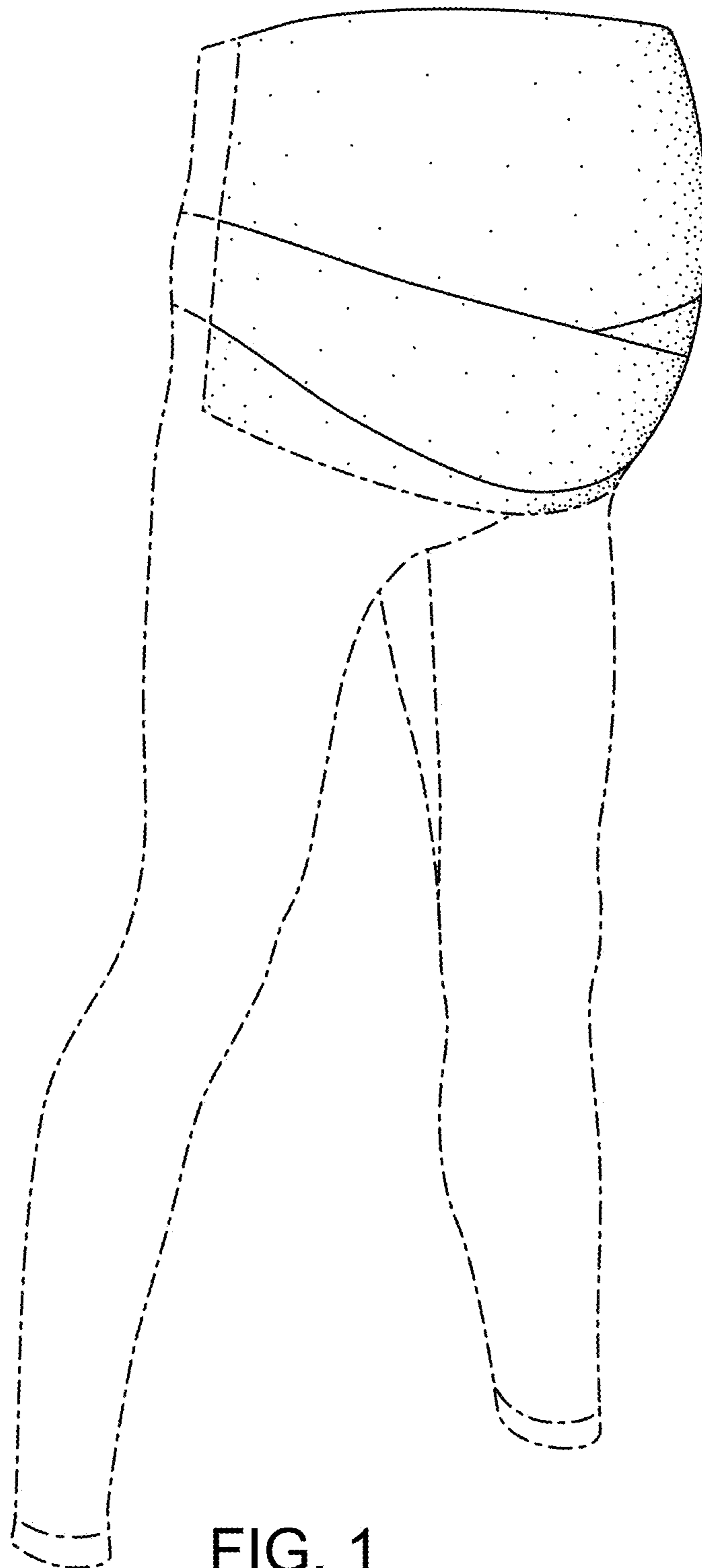

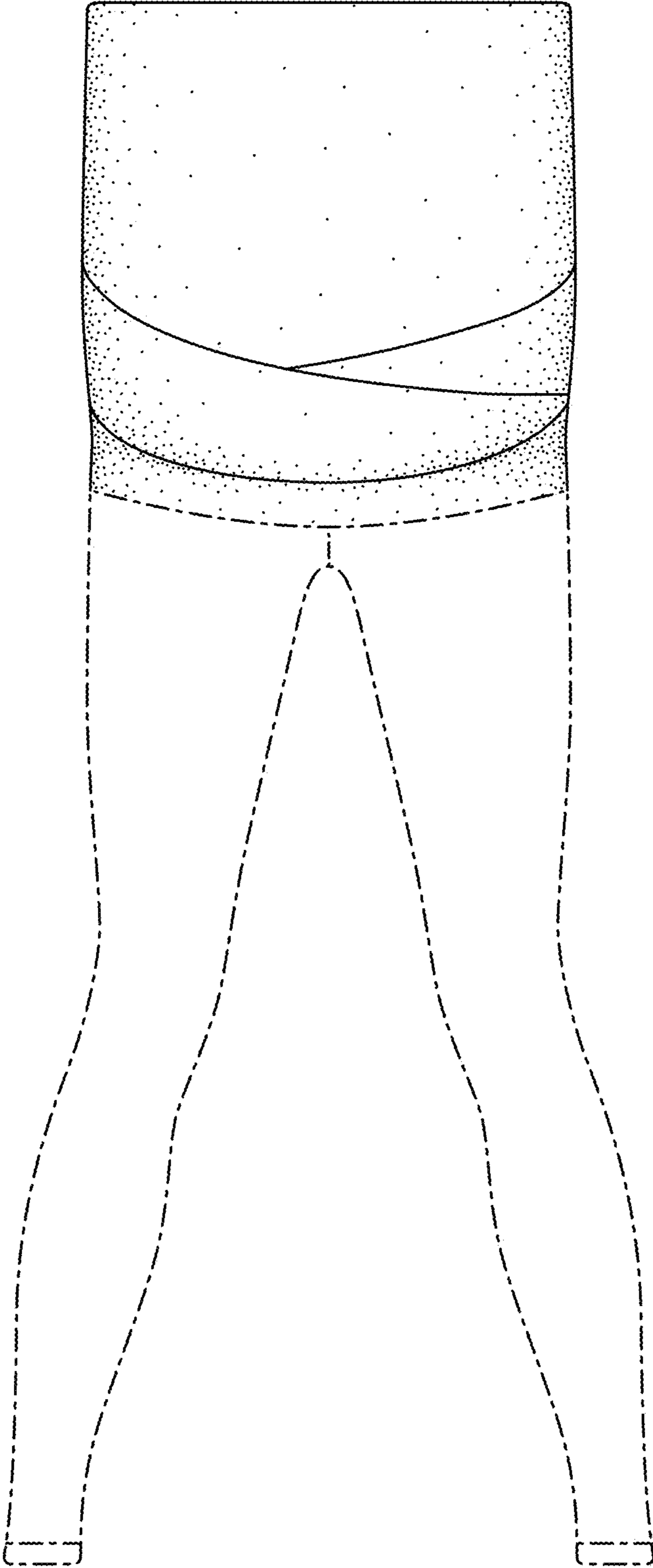

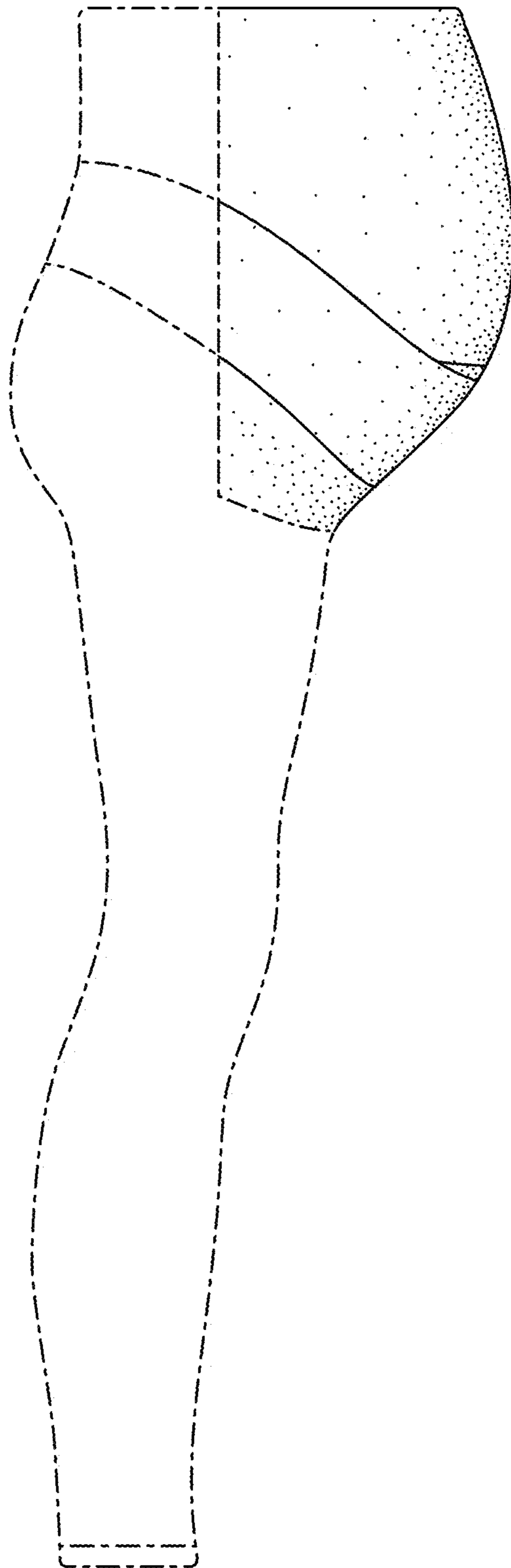

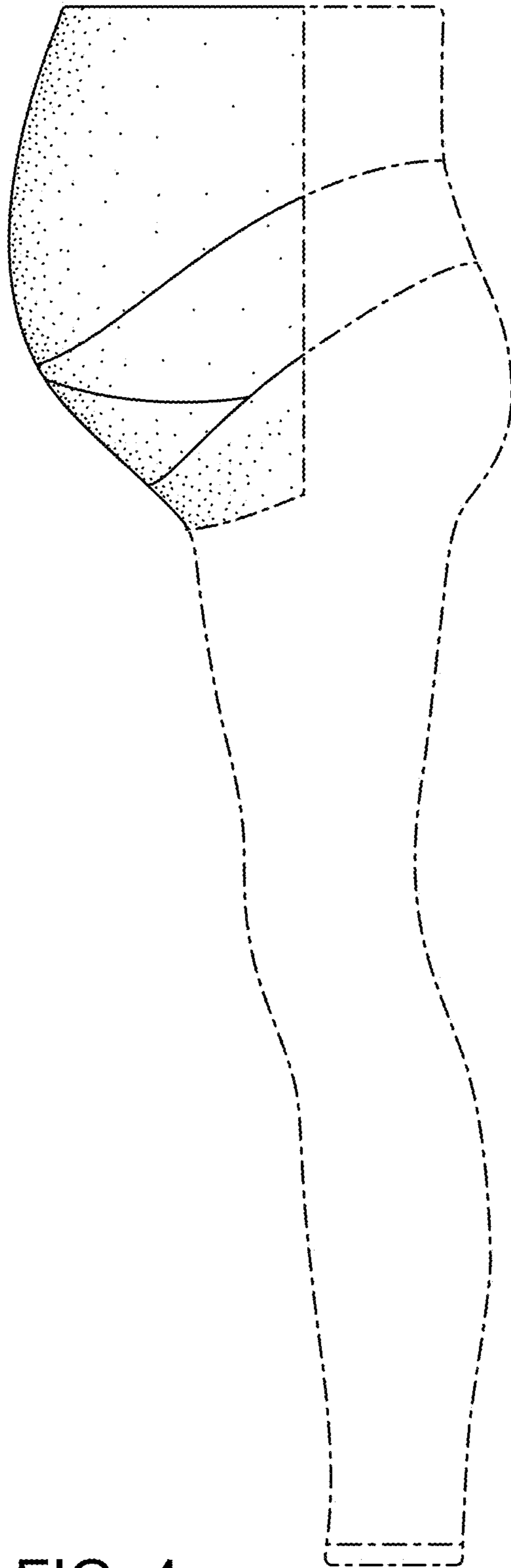

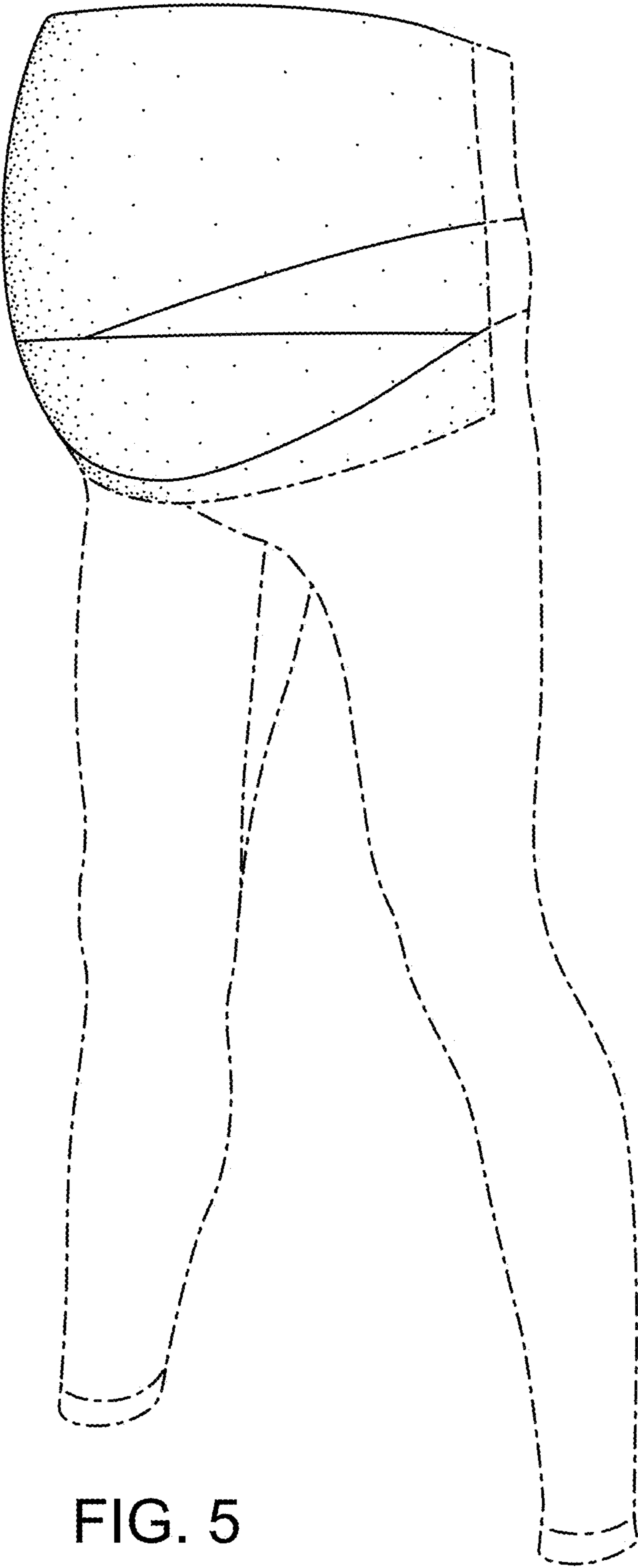
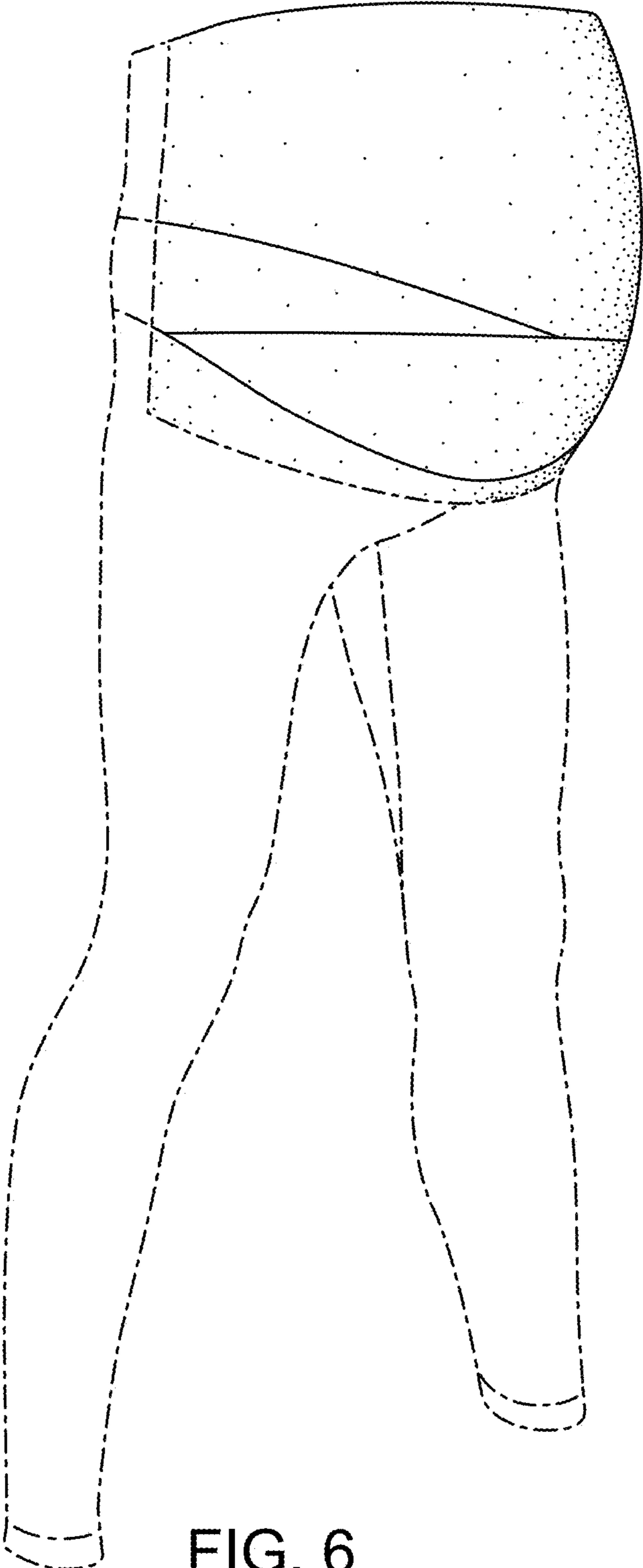

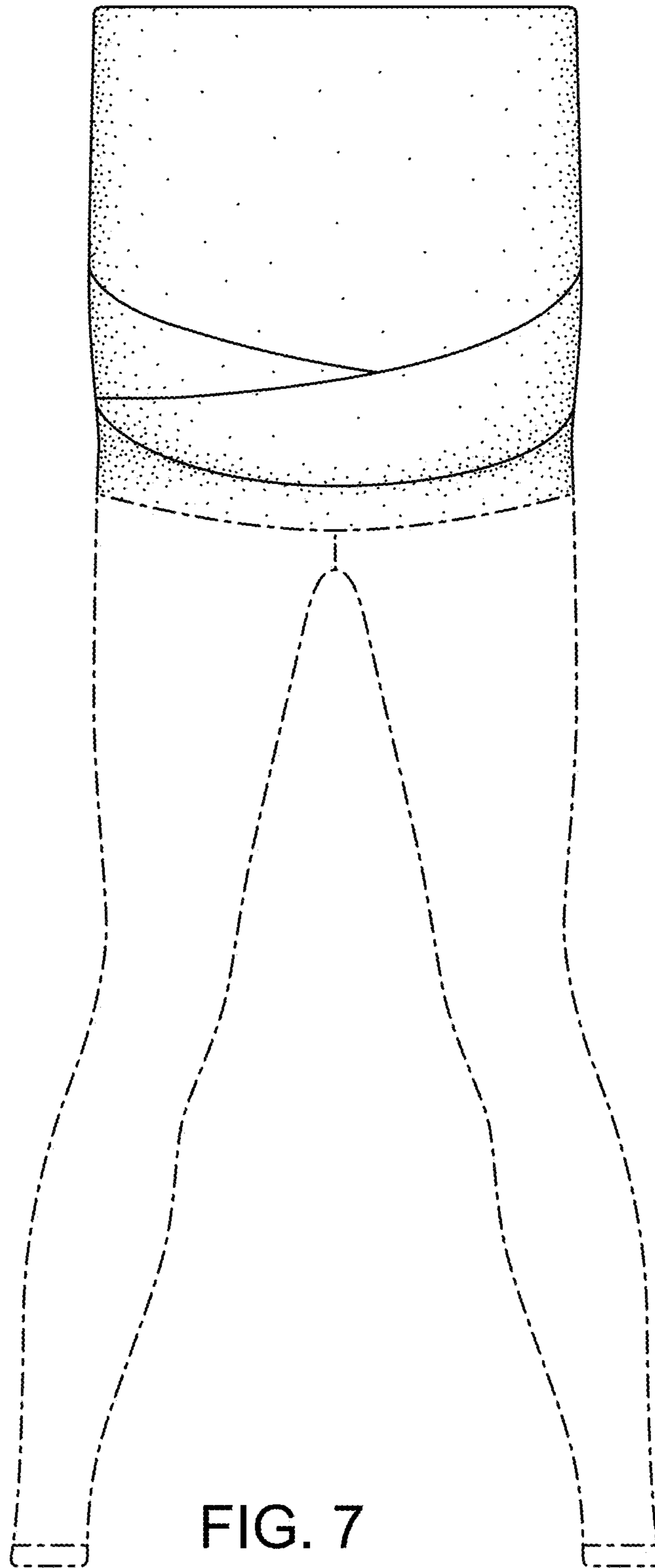

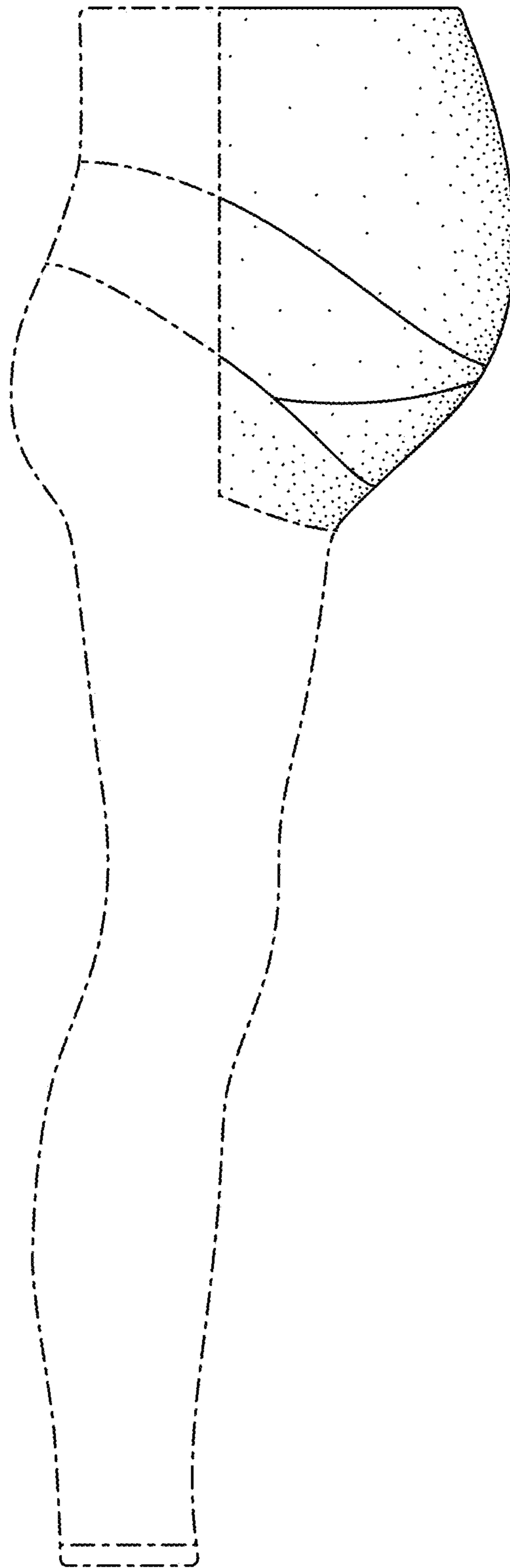

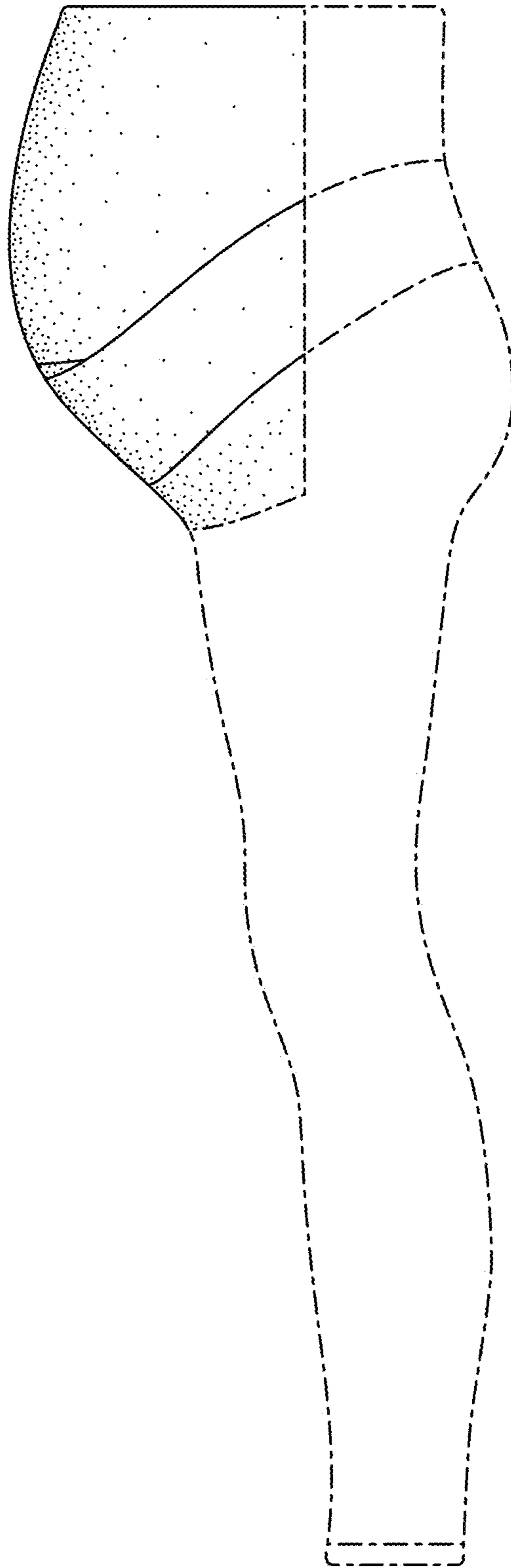

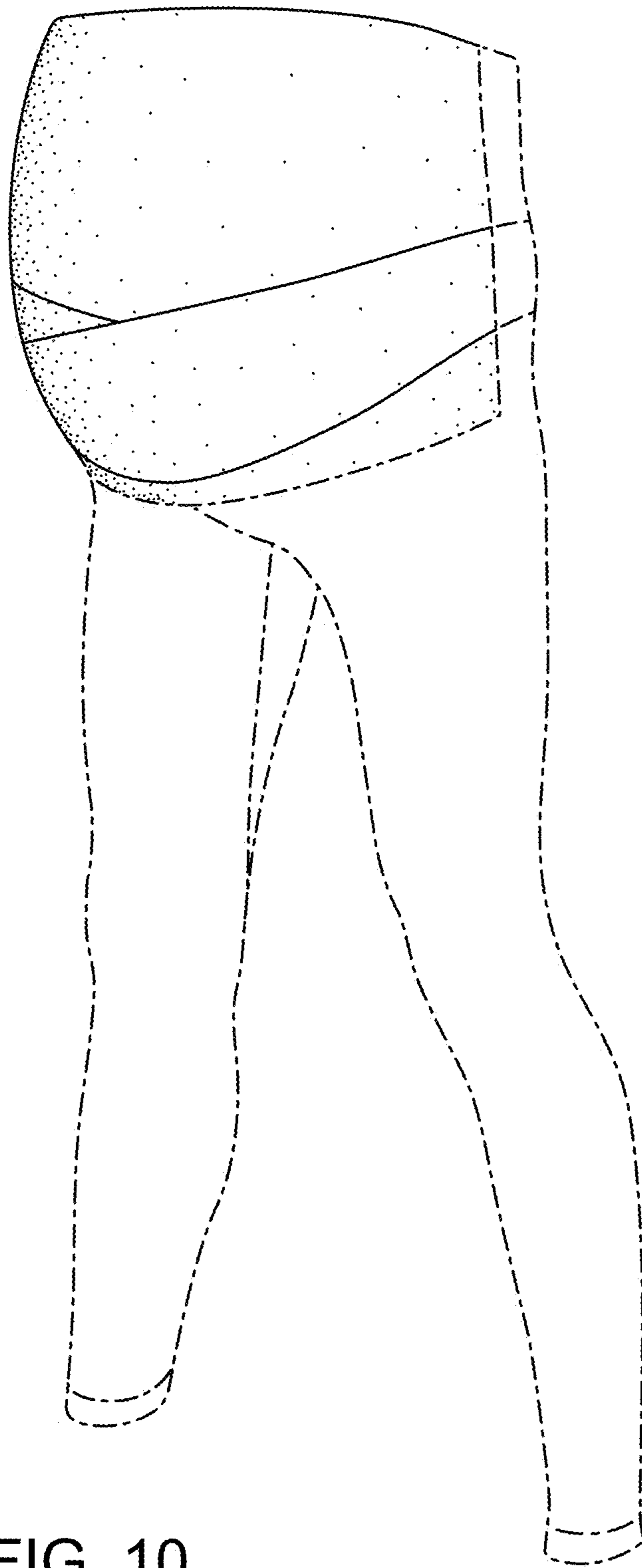

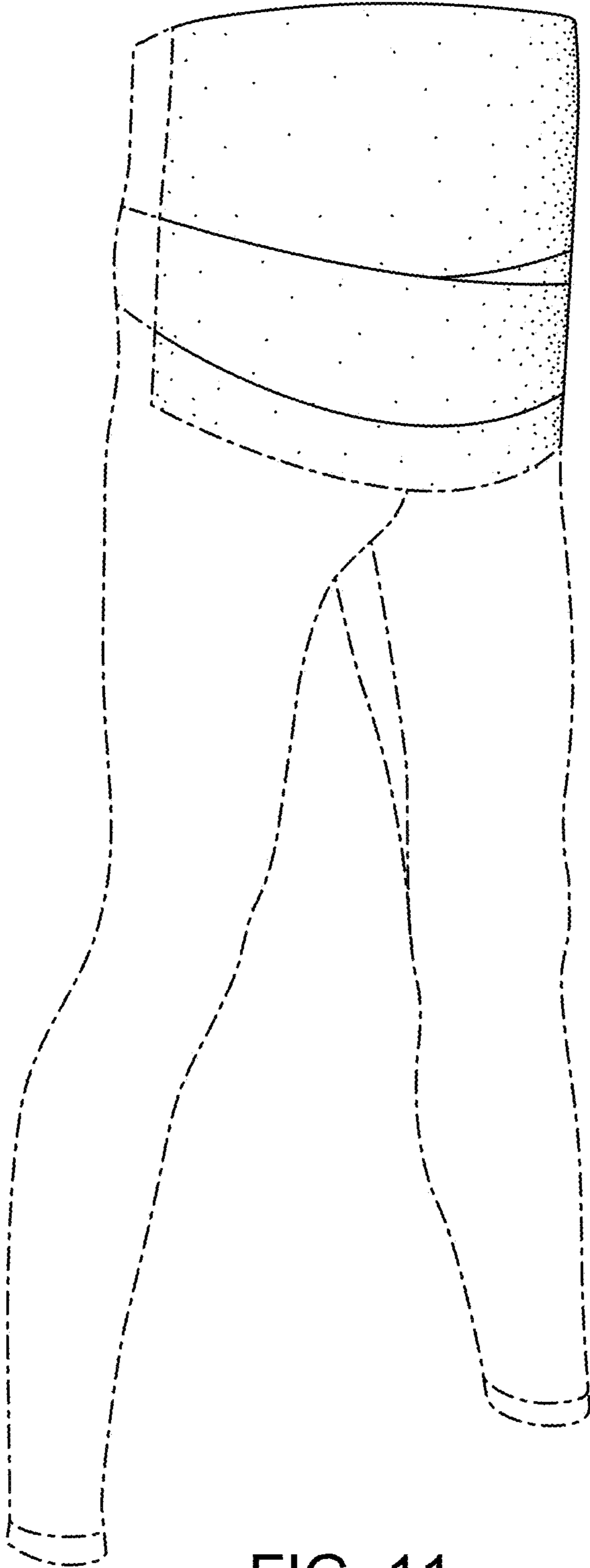

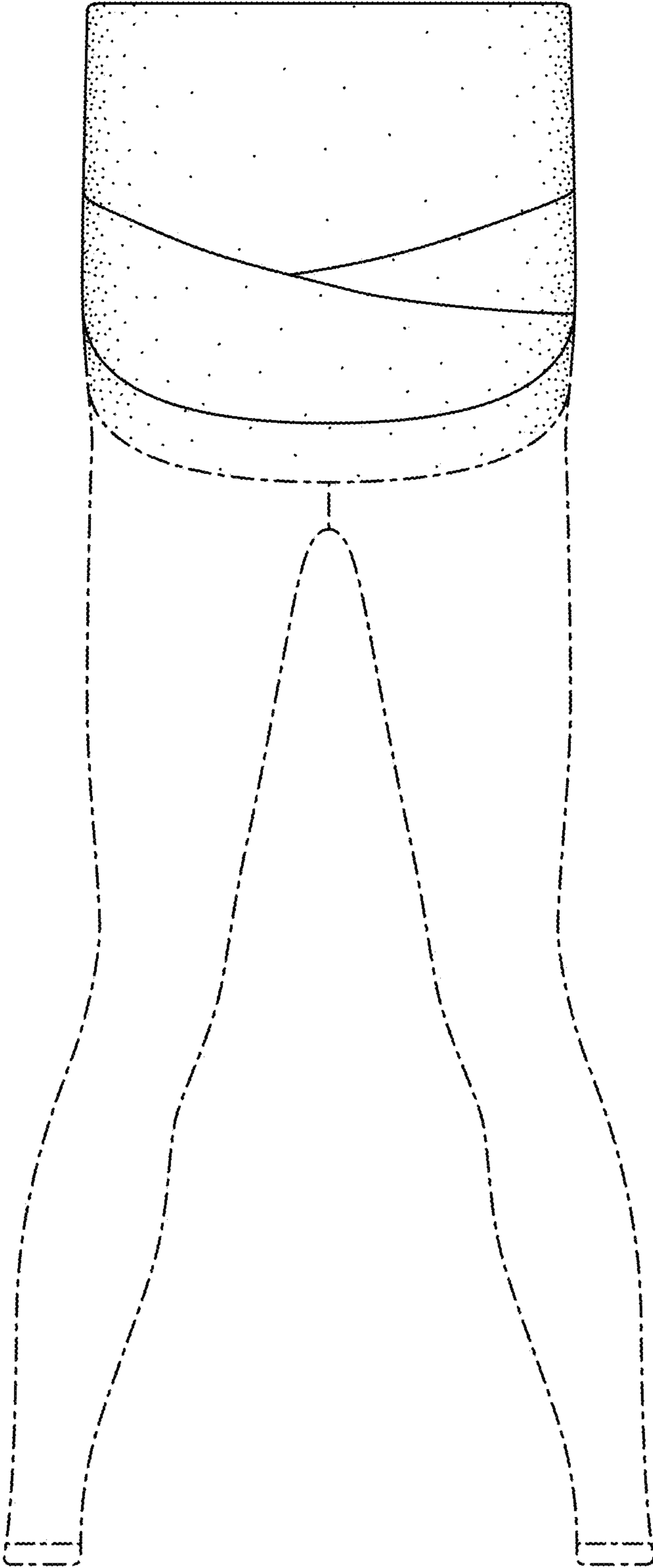

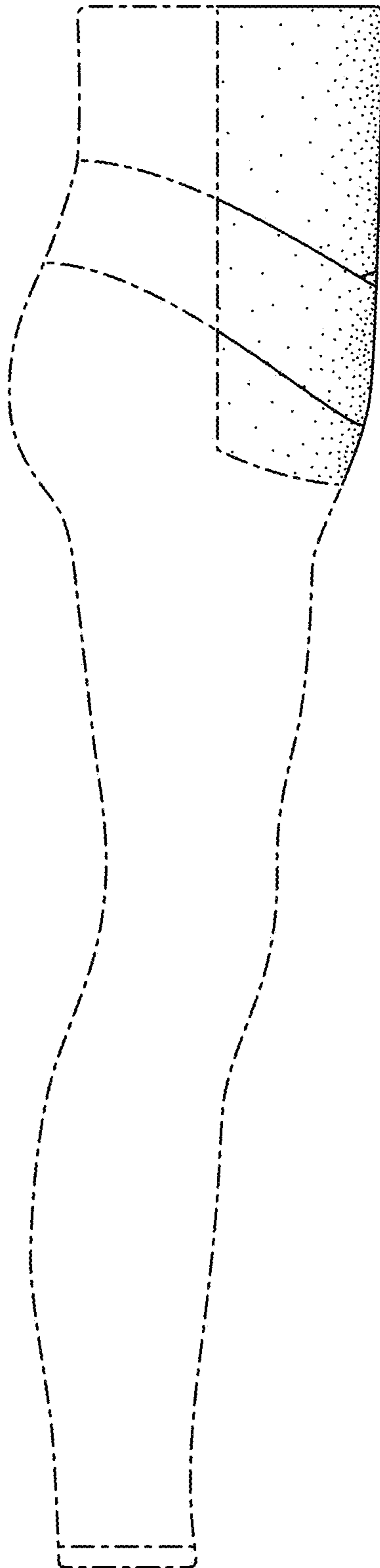

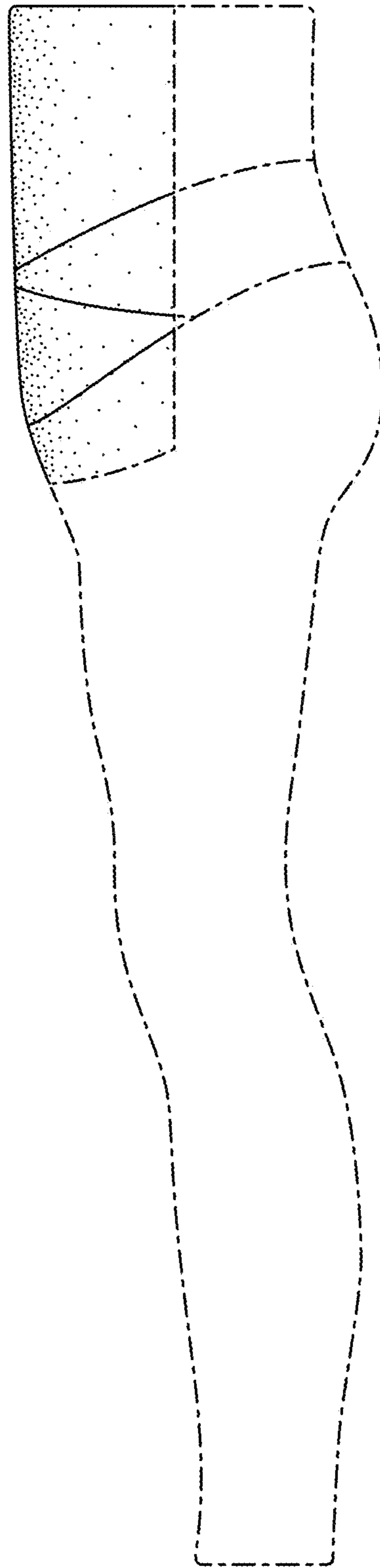

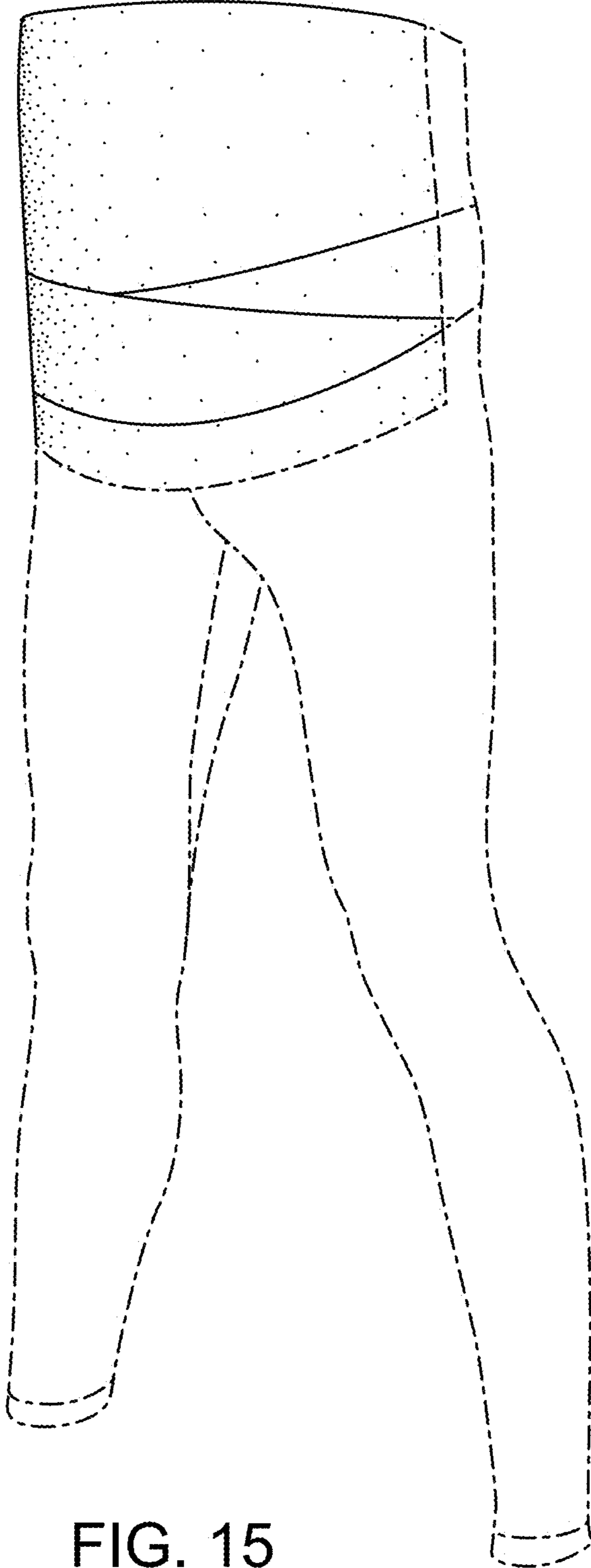

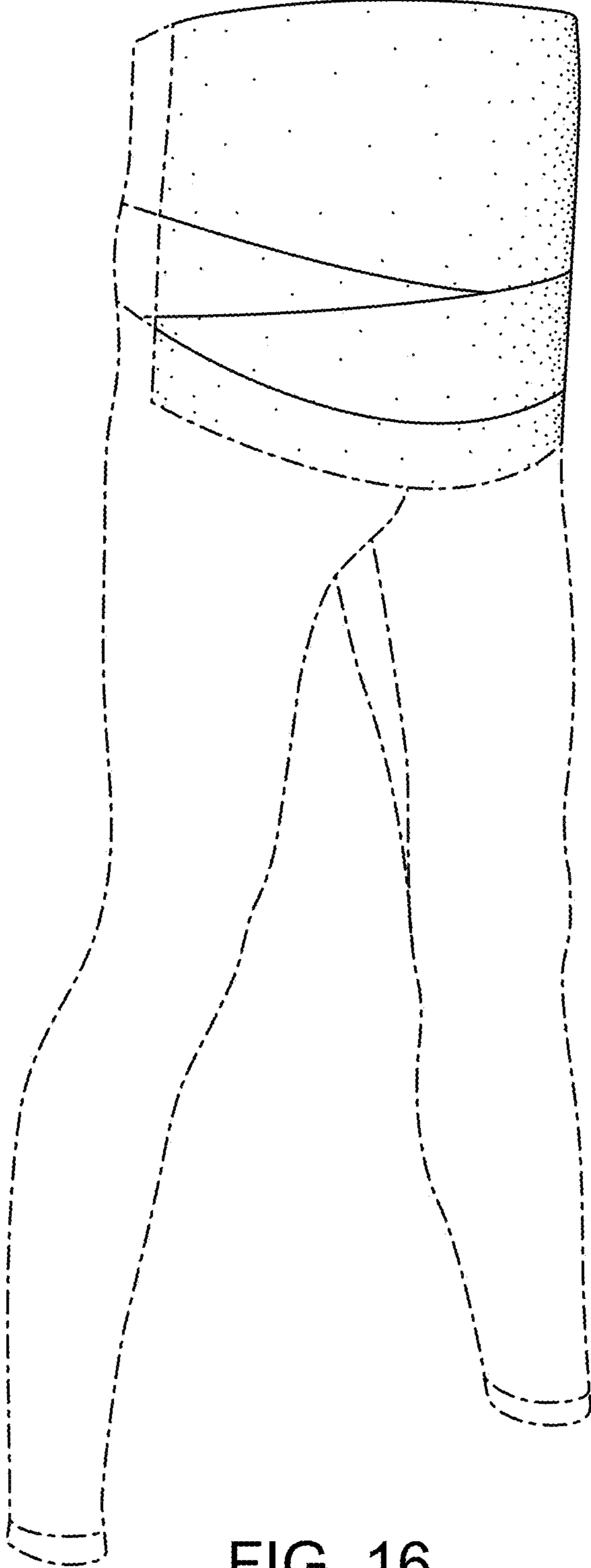

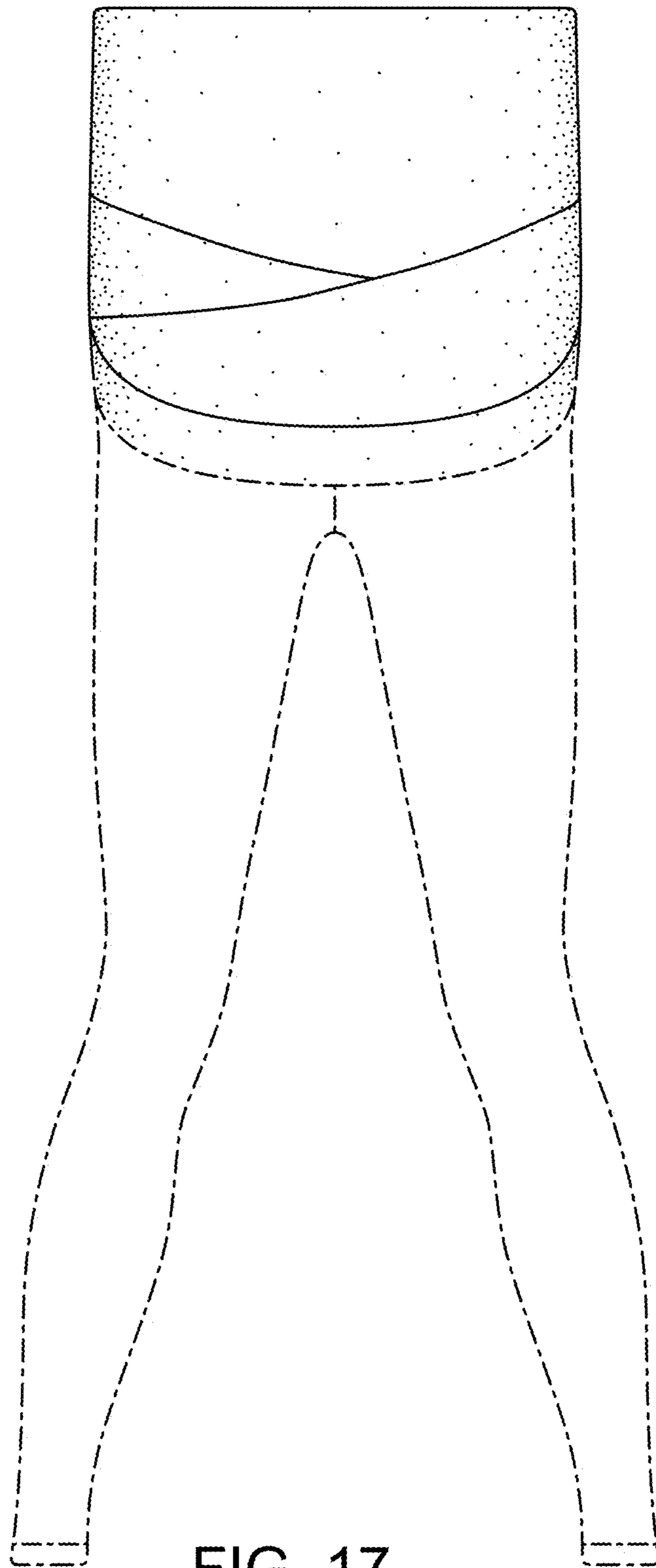

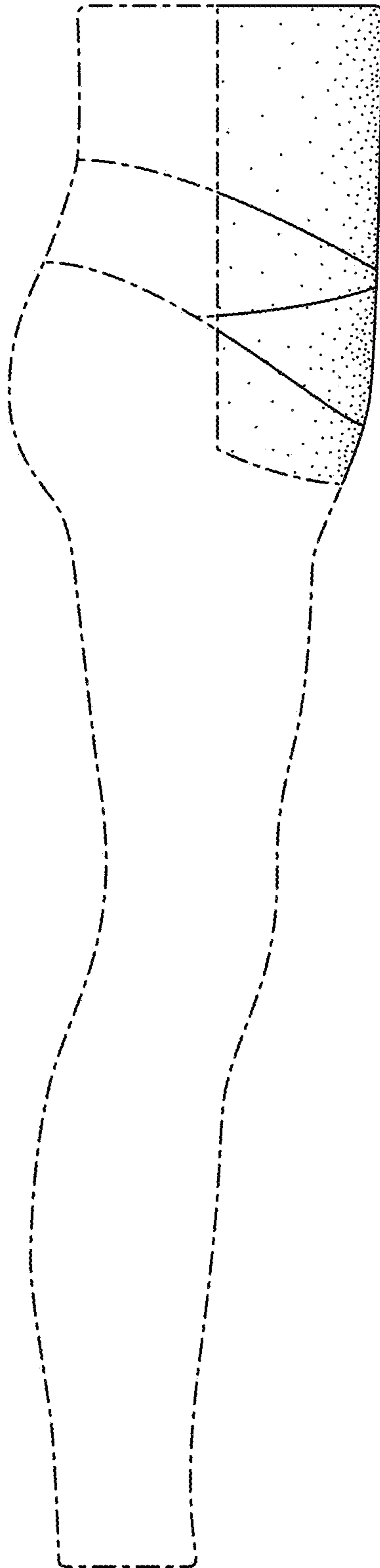

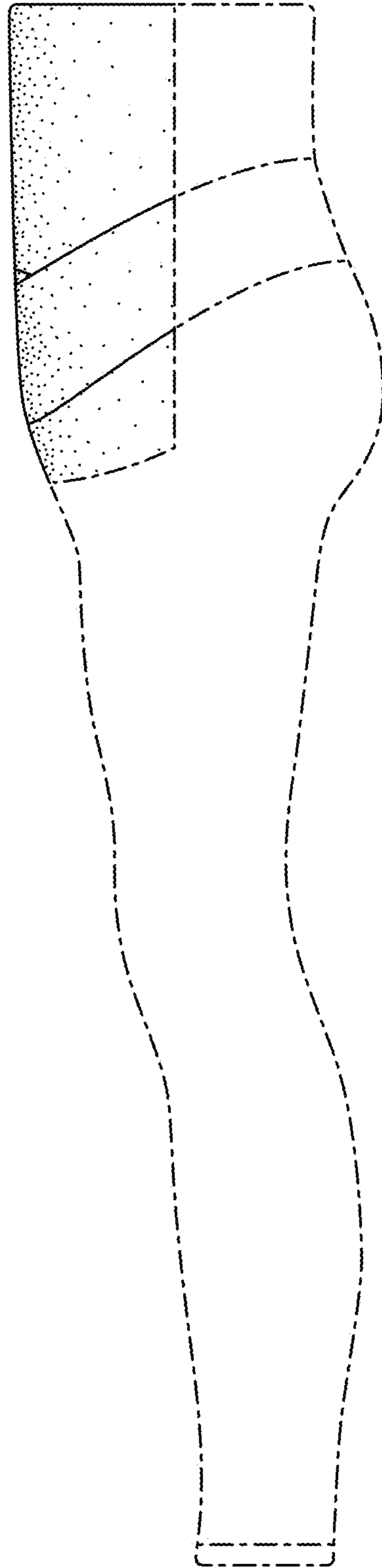

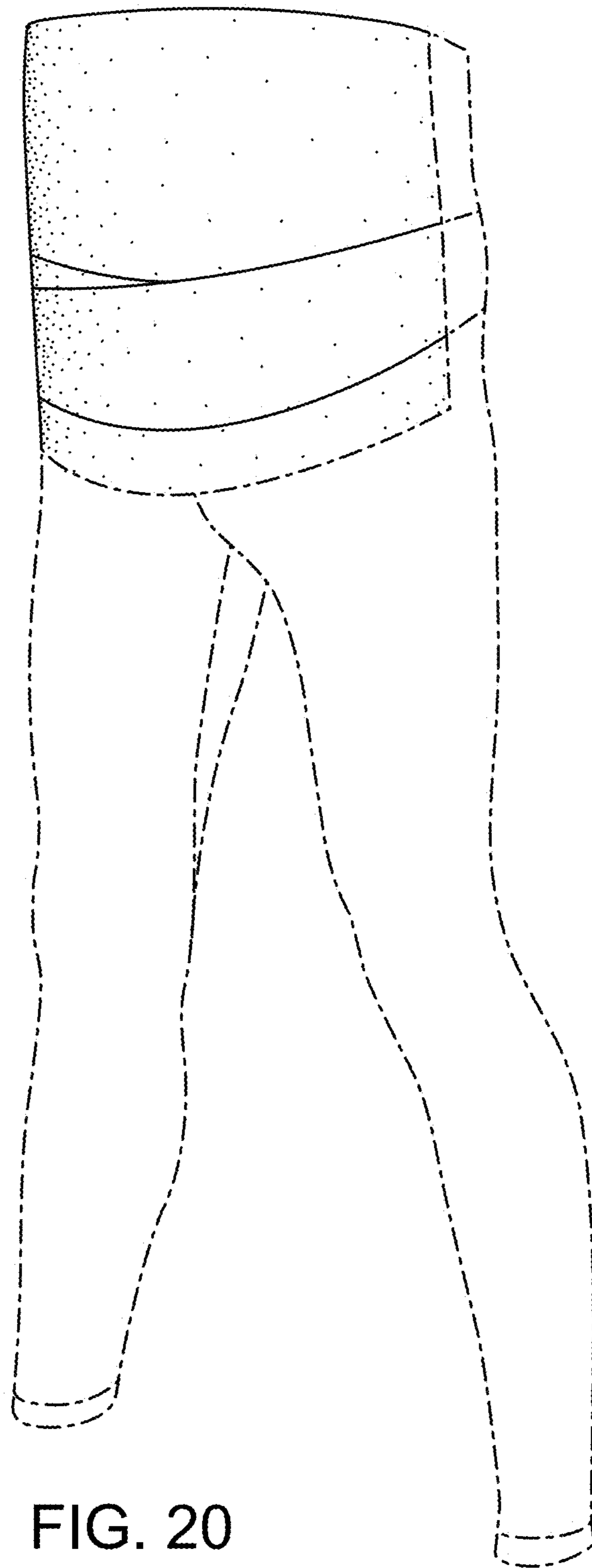
