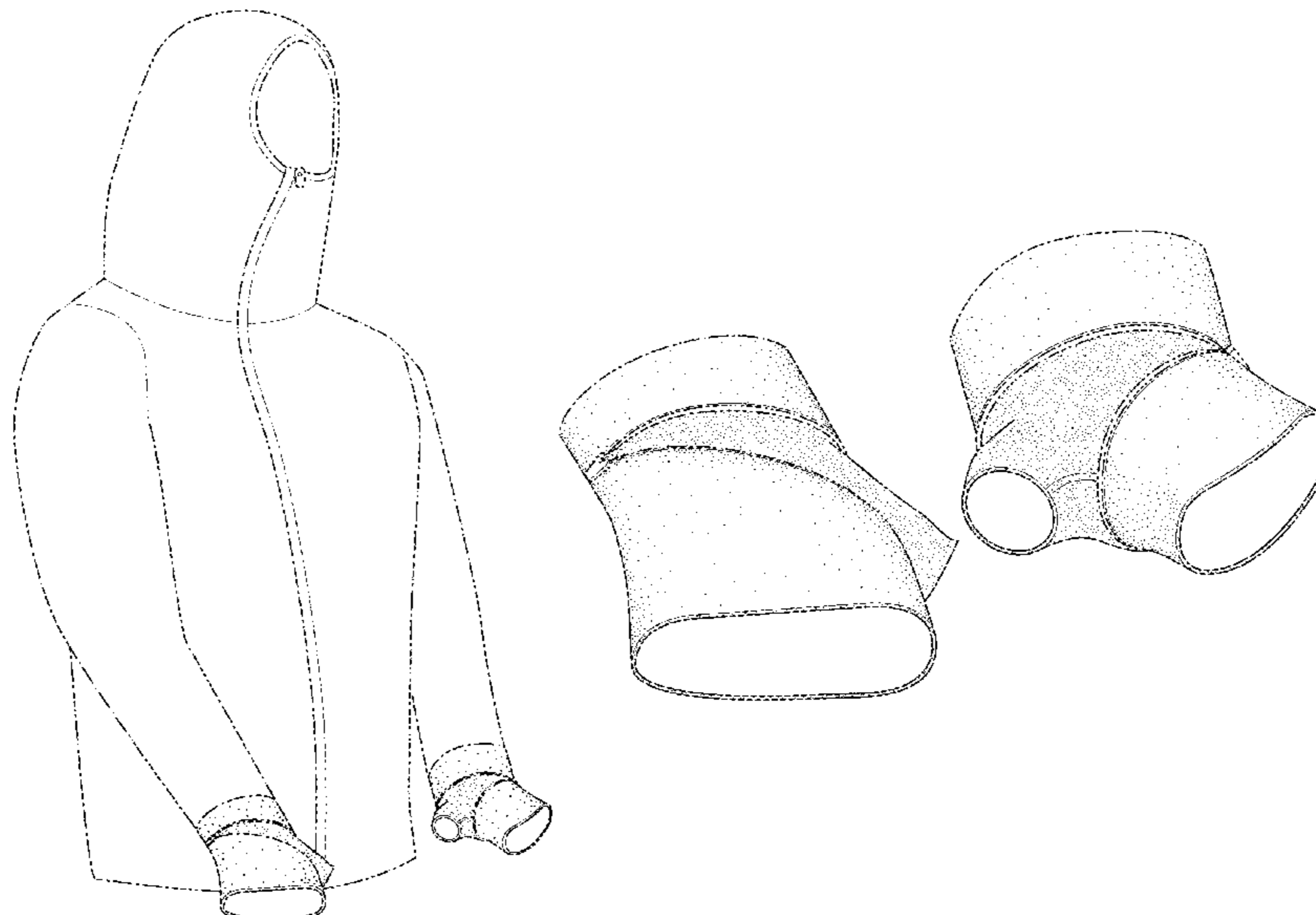
The ornamental design for a jacket, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a jacket showing my new design in an in-use state;
FIG. 2 is a front view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a front right perspective view of the jacket of FIGS. 1-4 in an alternate in-use state;
FIG. 6 is a front view thereof;
FIG. 7 is a right side view thereof;
FIG. 8 is a left side view thereof;
FIG. 9 is an enlarged partial view of the claimed design of FIG. 1 with environment removed for clarity purposes;
FIG. 10 is an enlarged partial view of the claimed design of FIG. 2 with environment removed for clarity purposes;
FIG. 11 is an enlarged partial view of the claimed design of FIG. 3 with environment removed for clarity purposes;
FIG. 12 is an enlarged partial view of the claimed design of FIG. 4 with environment removed for clarity purposes;
FIG. 13 is an enlarged partial view of the claimed design of FIG. 5 with environment removed for clarity purposes;
FIG. 14 is an enlarged partial view of the claimed design of FIG. 6 with environment removed for clarity purposes;

The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The parallel uneven-length broken lines with the shaded areas represent zipper features which form no part of the claimed design. The unshaded interior portion of the sleeve forms no part of the claimed design. The broken lines depicting the remainder of the jacket show features that form no part of the claimed design.

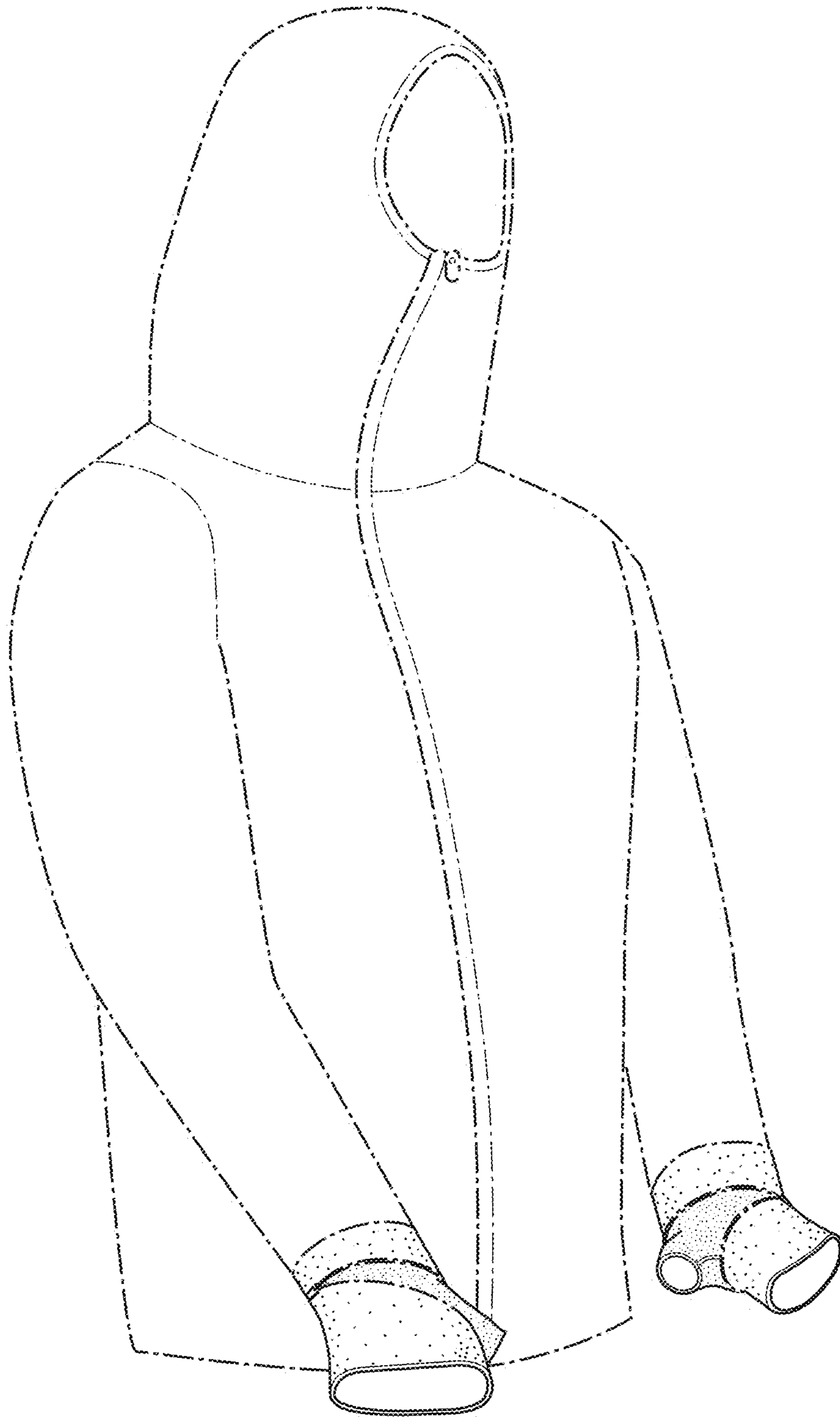

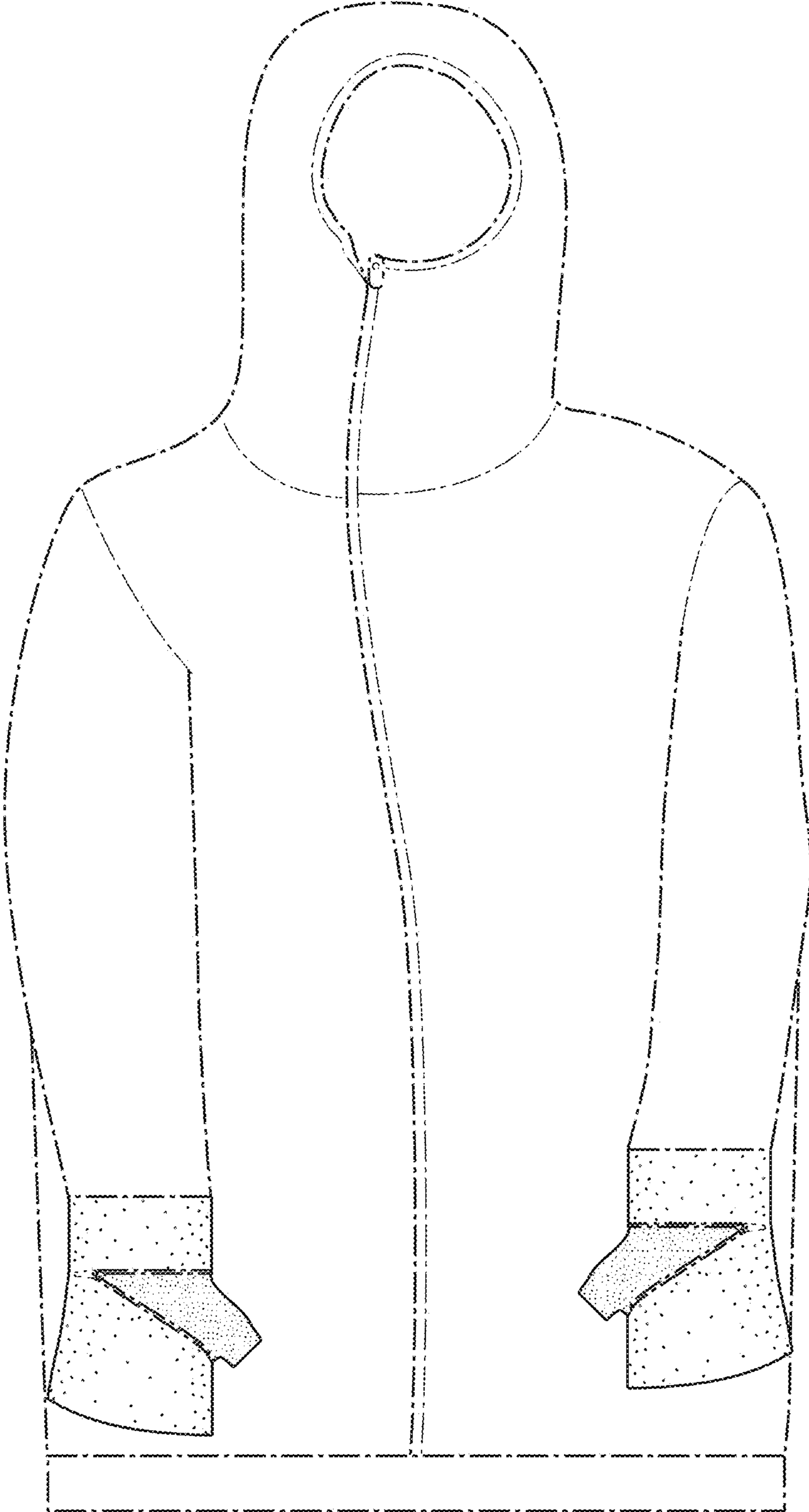

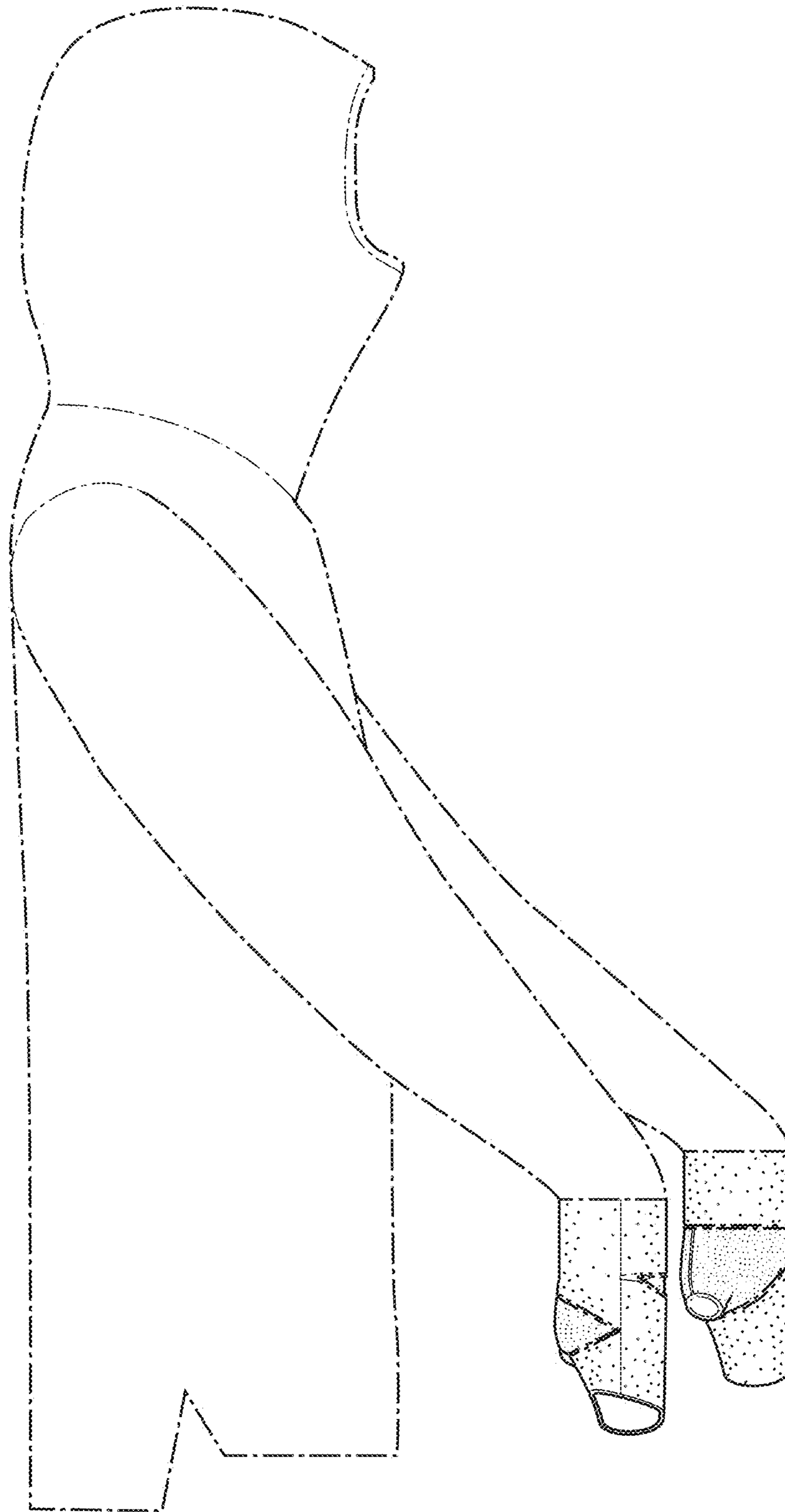

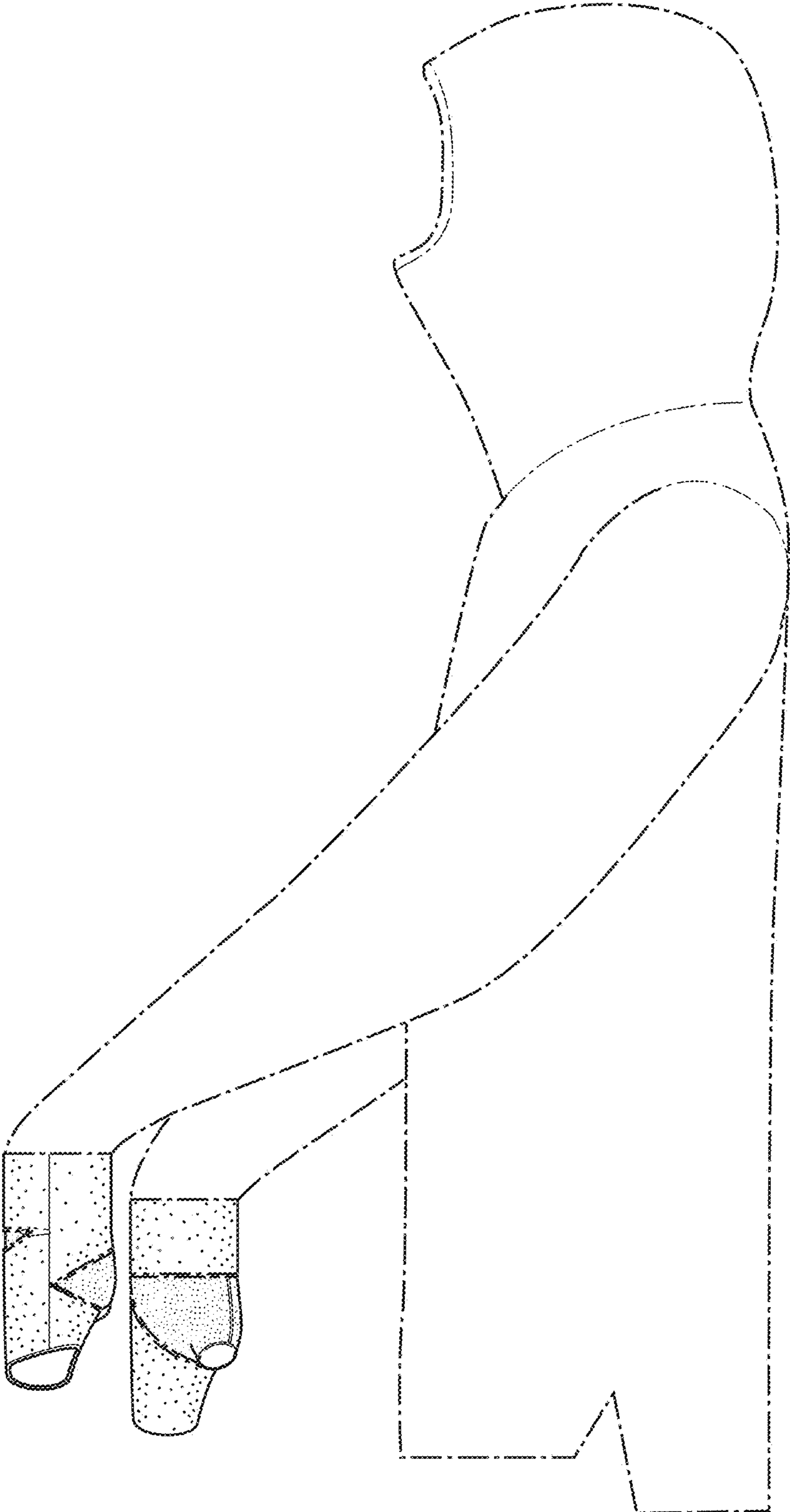

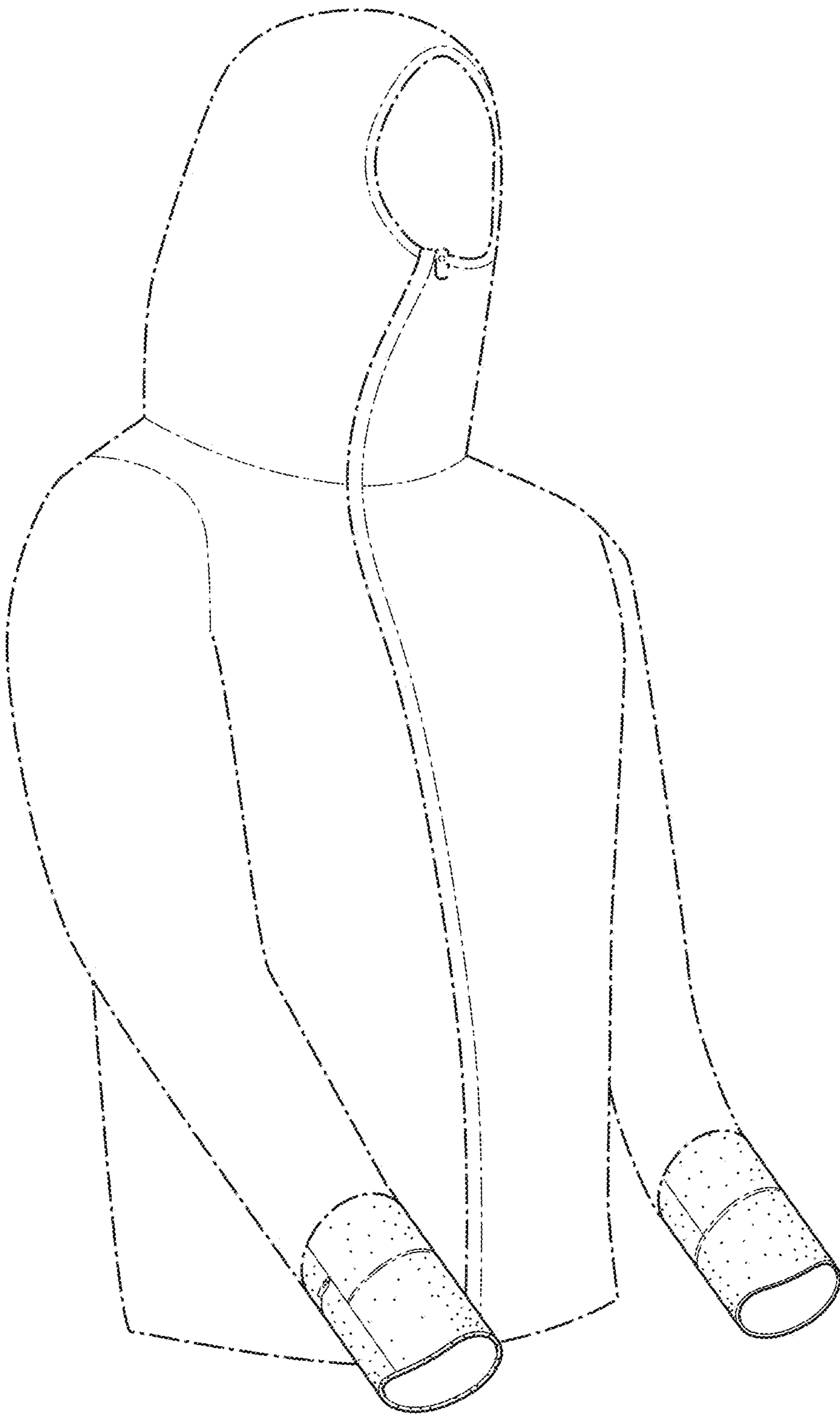

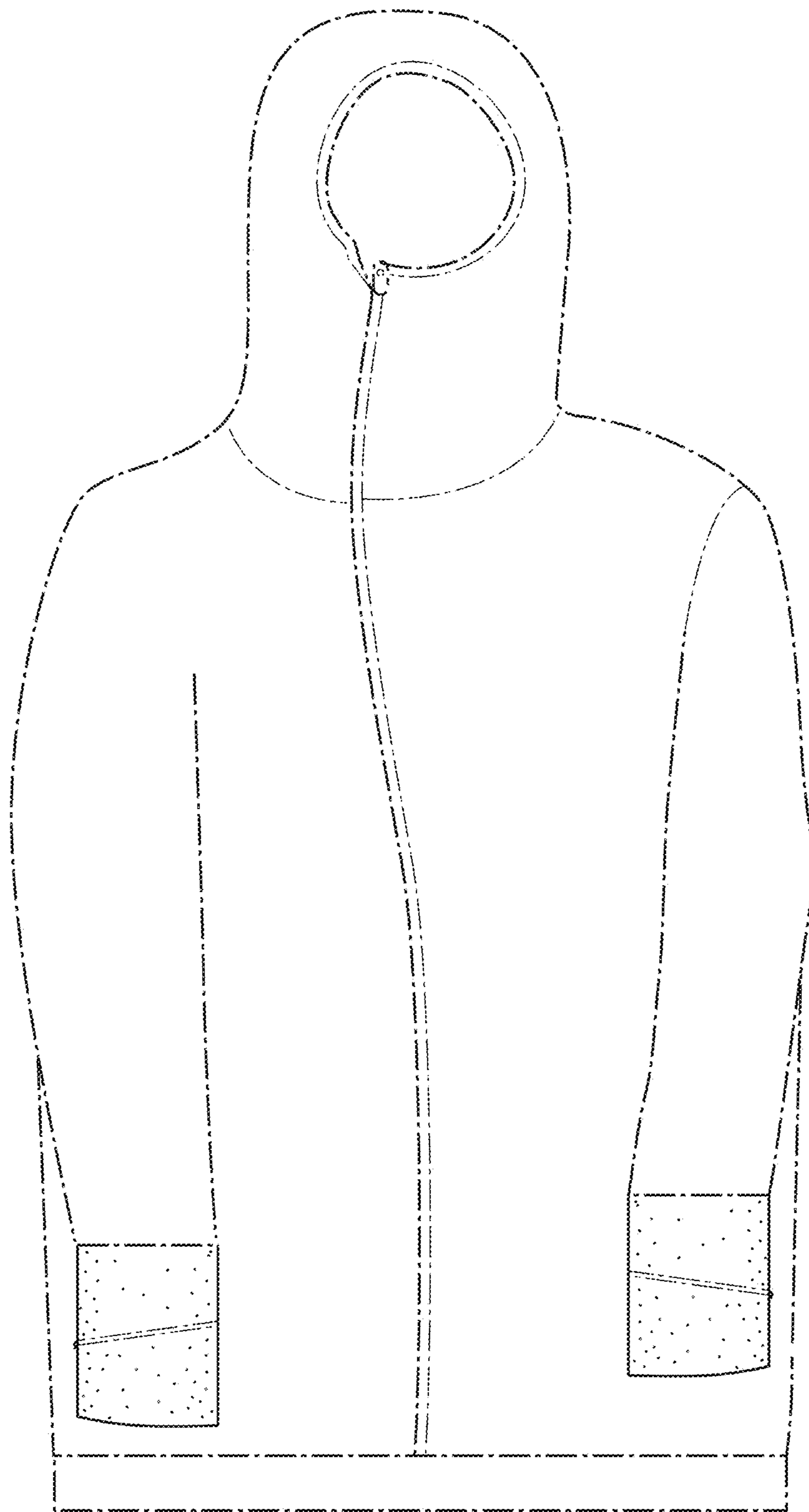

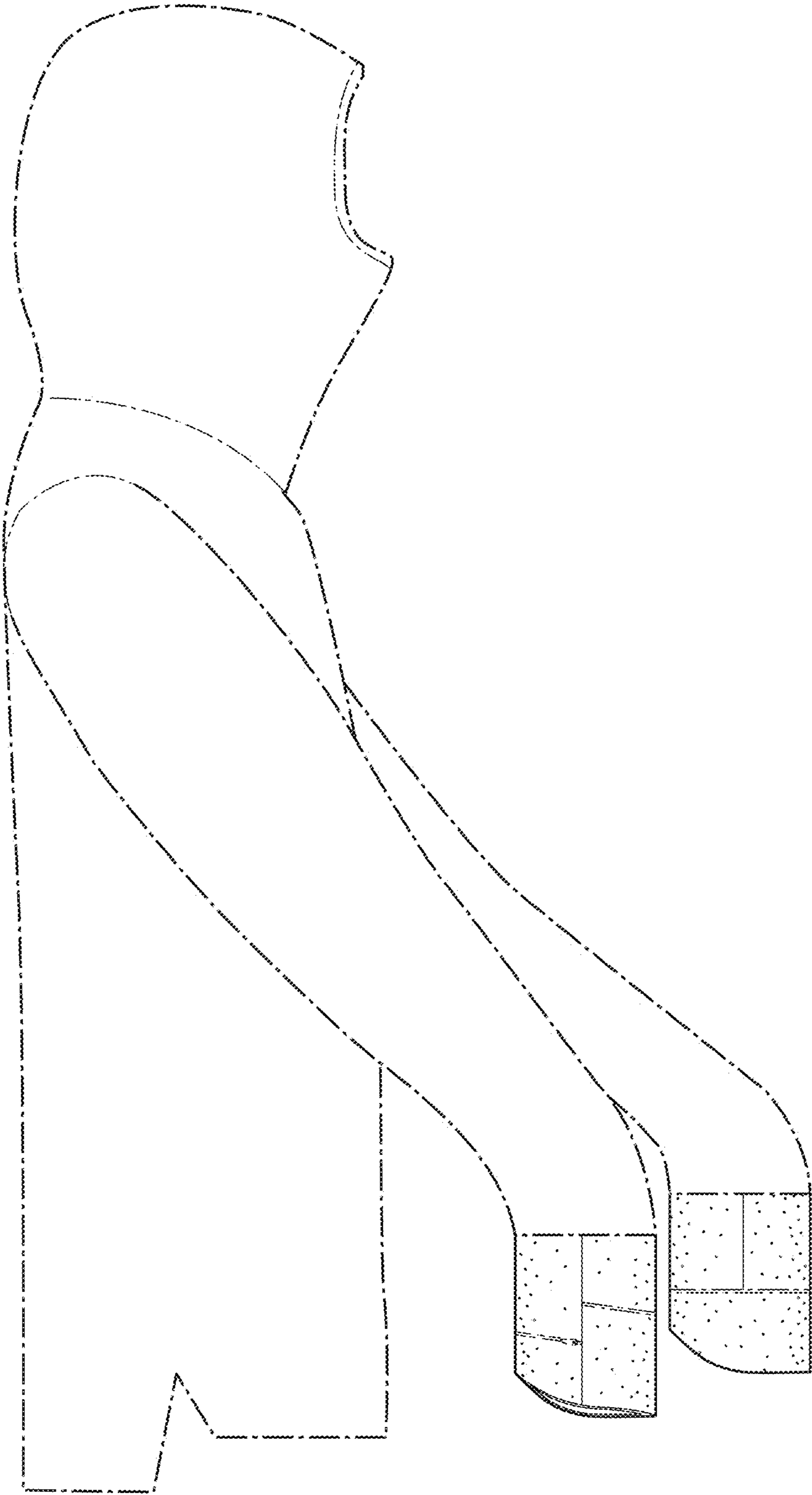

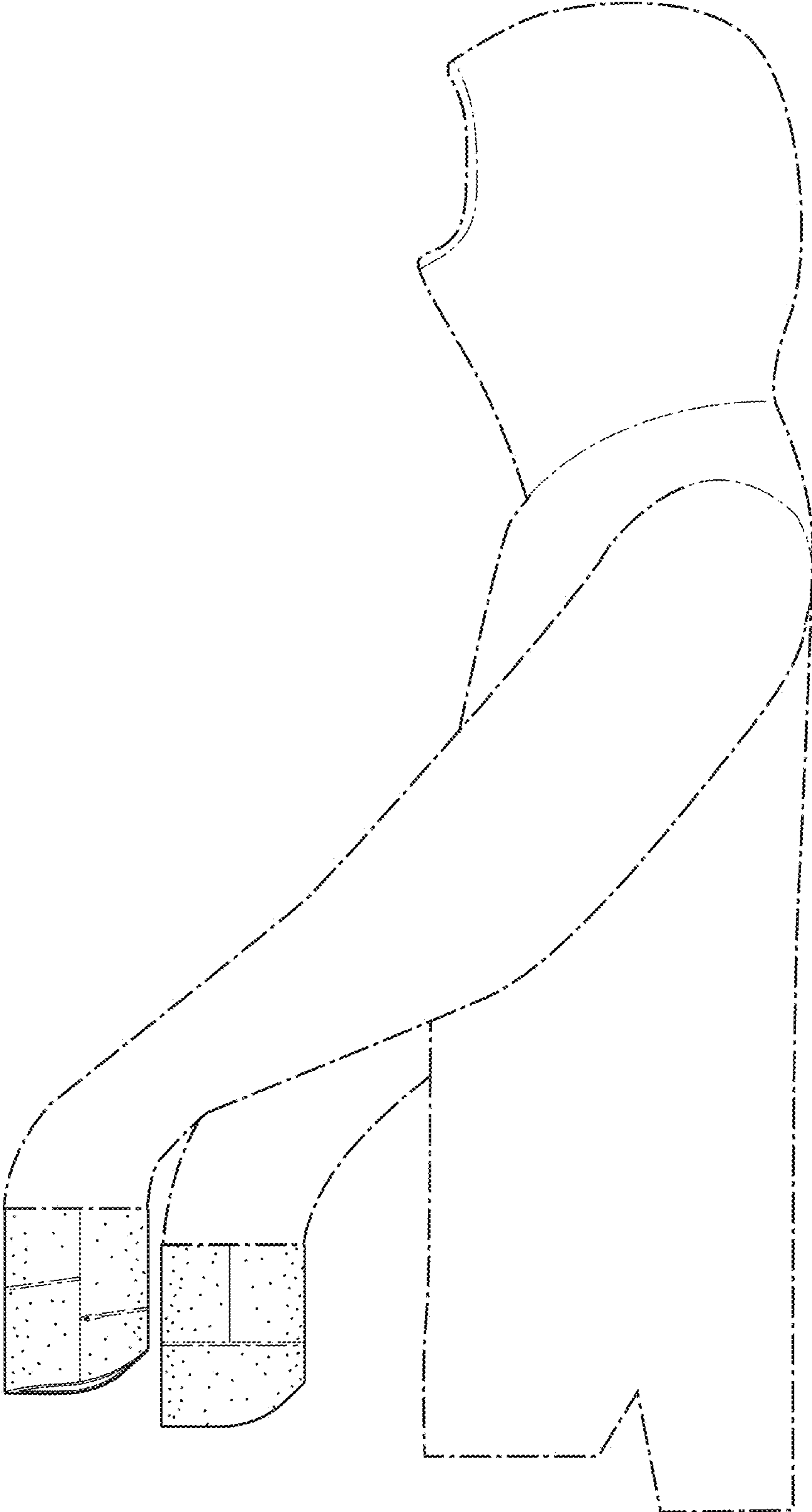

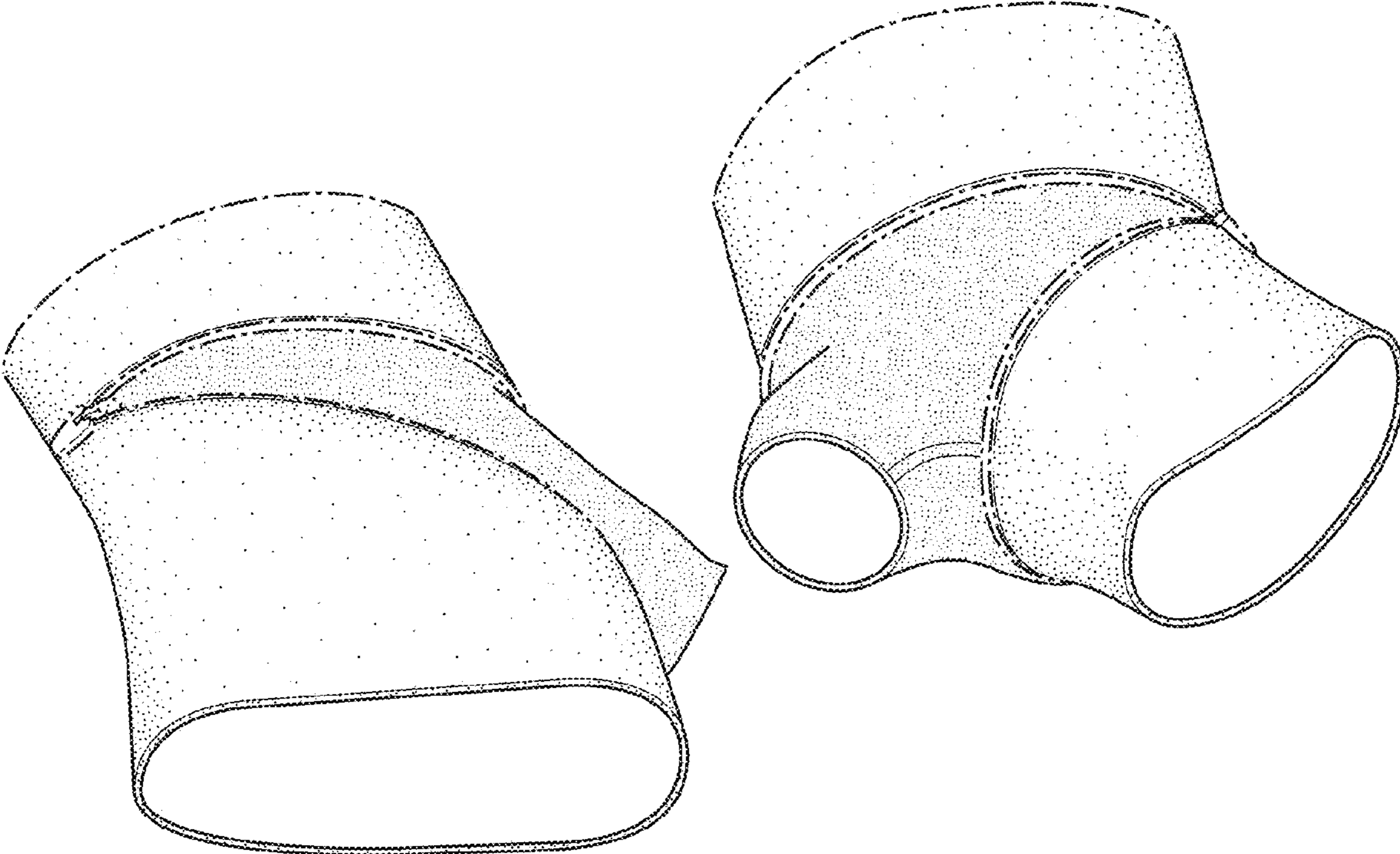

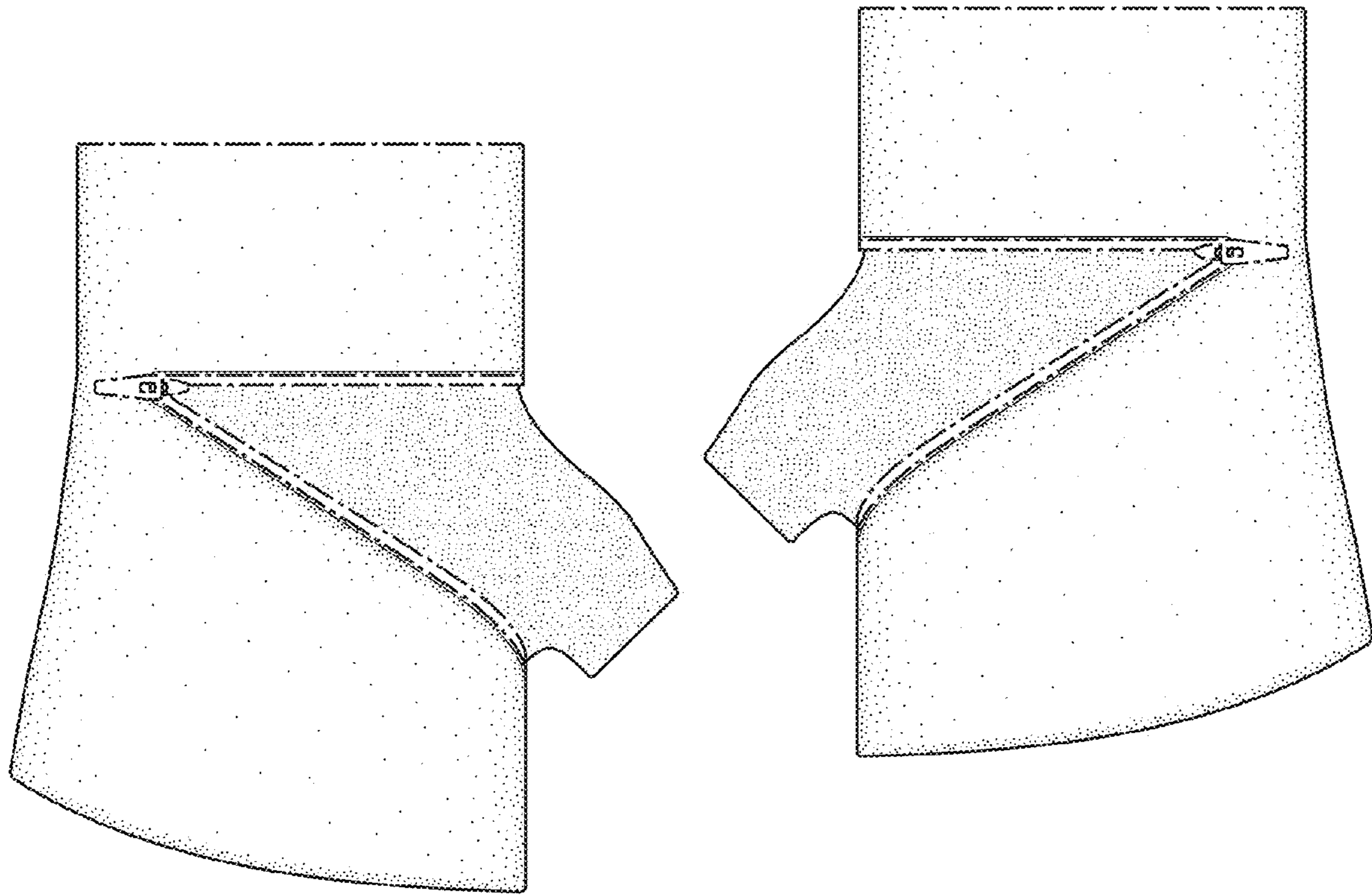

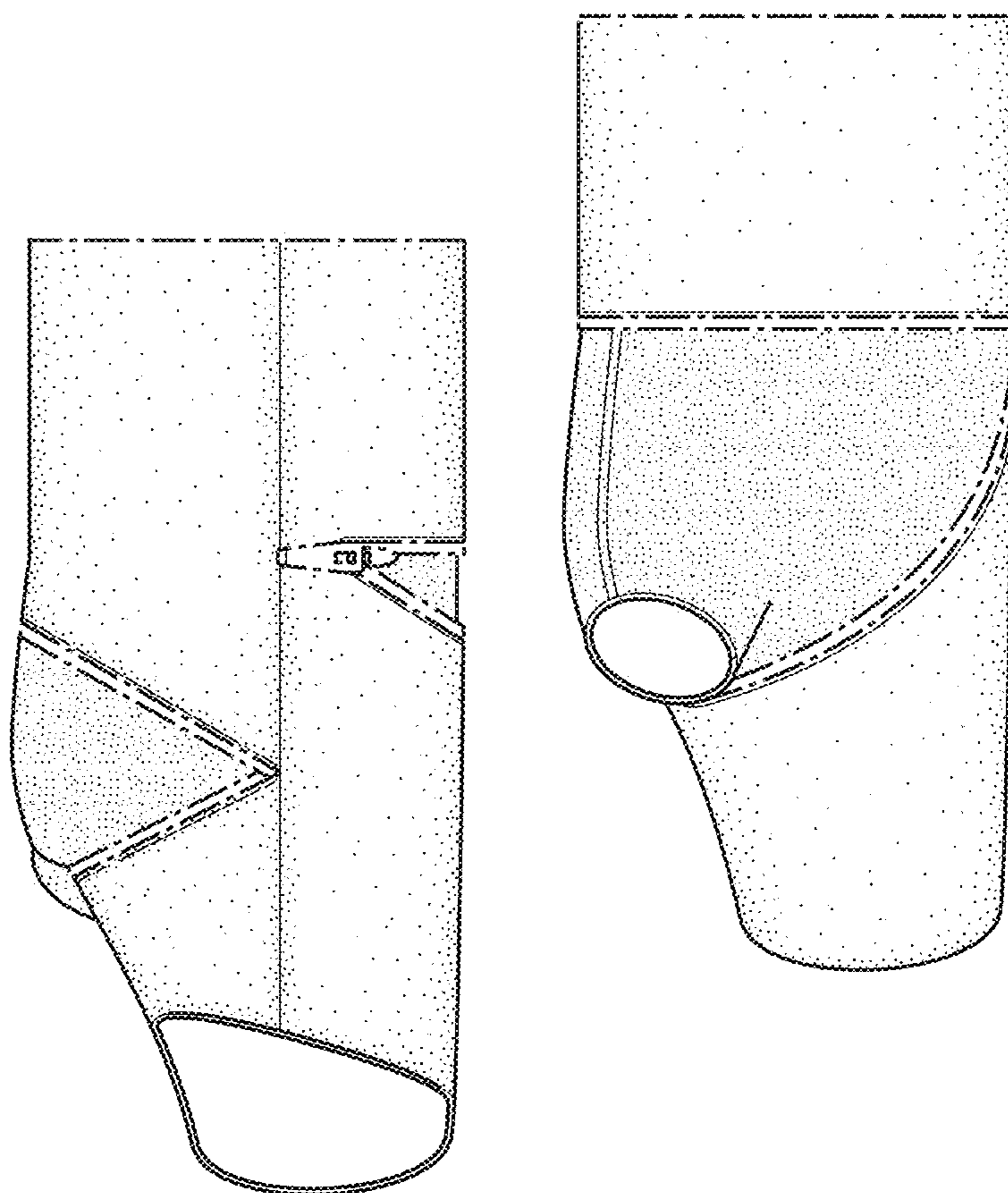

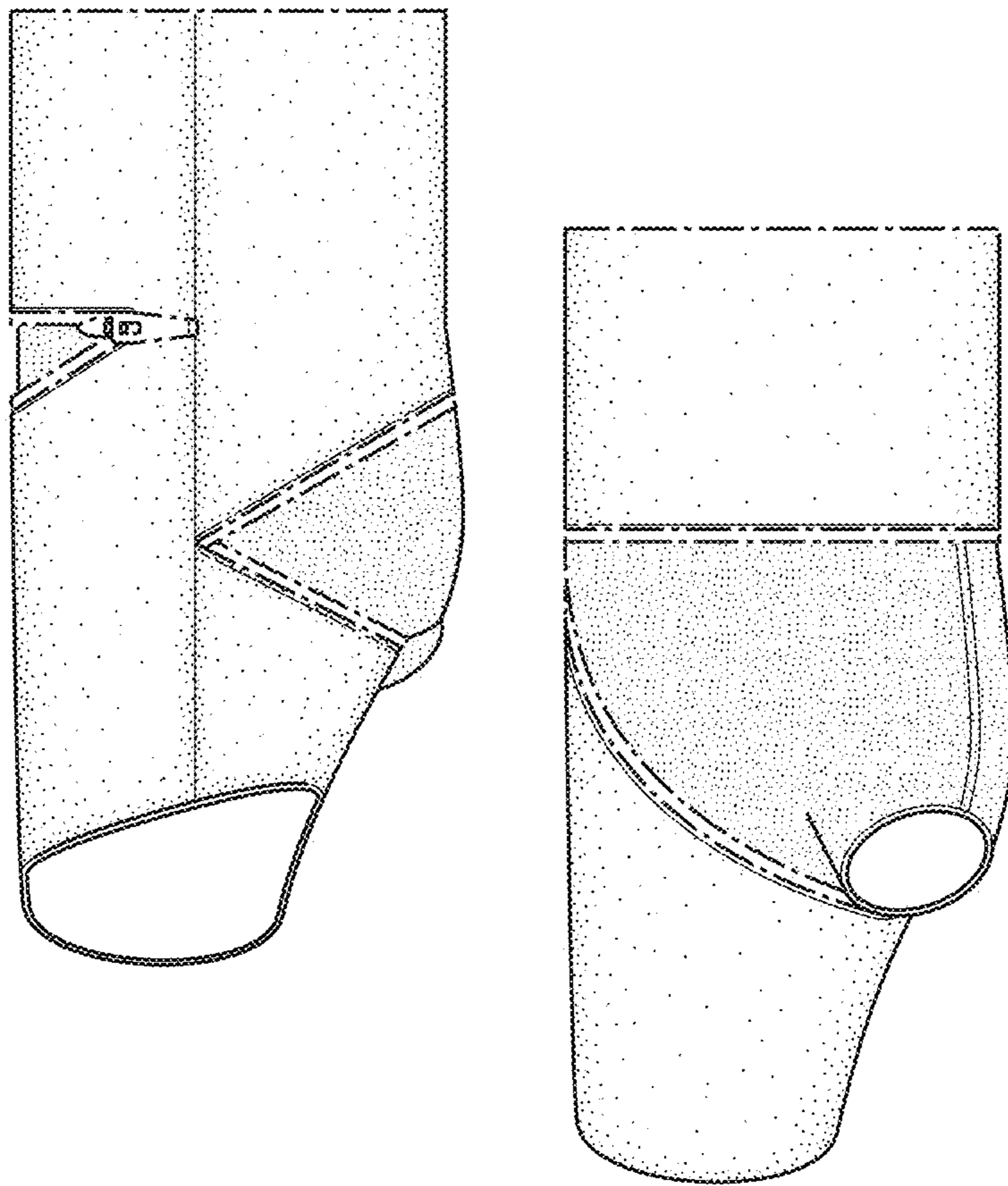

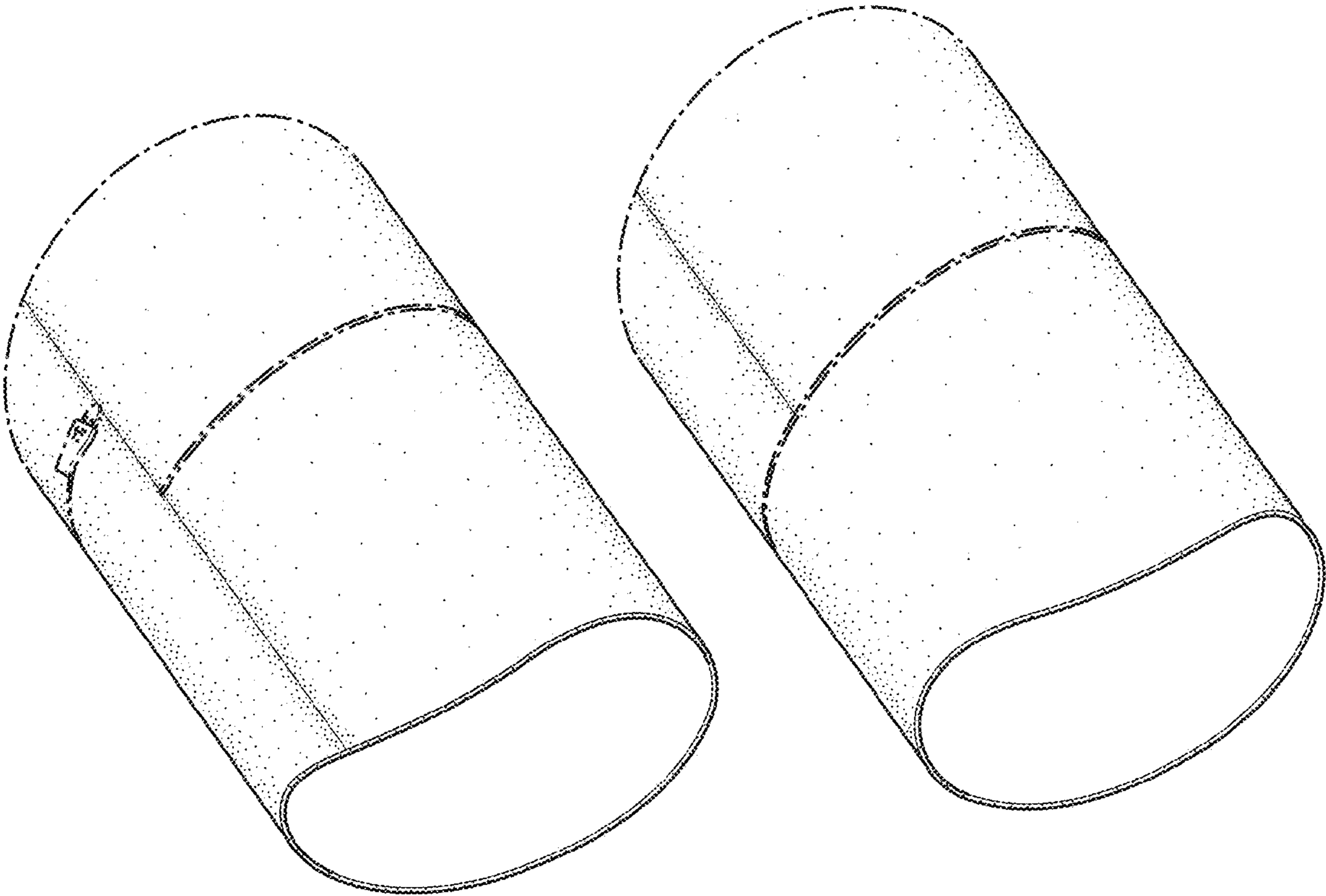

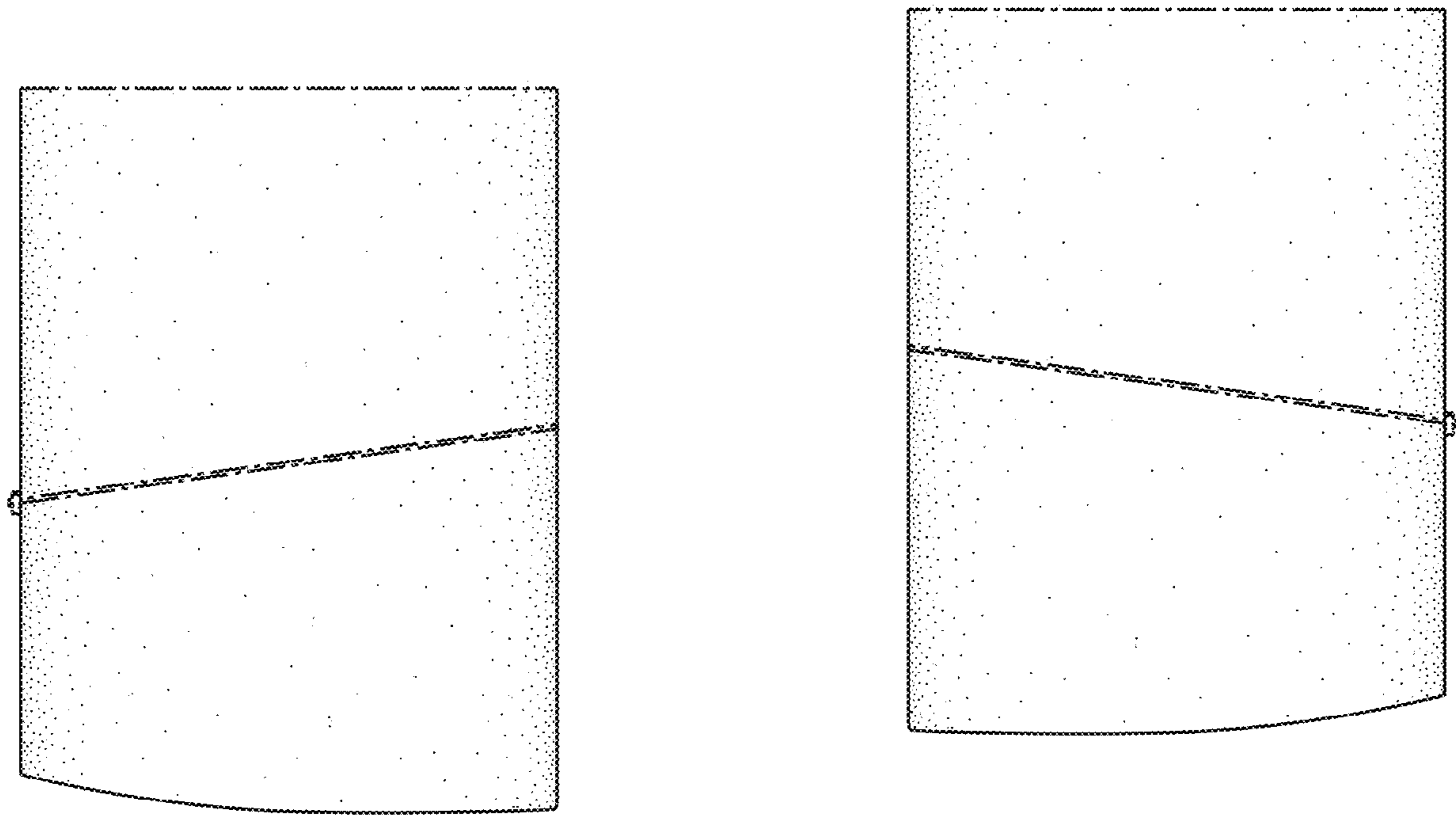

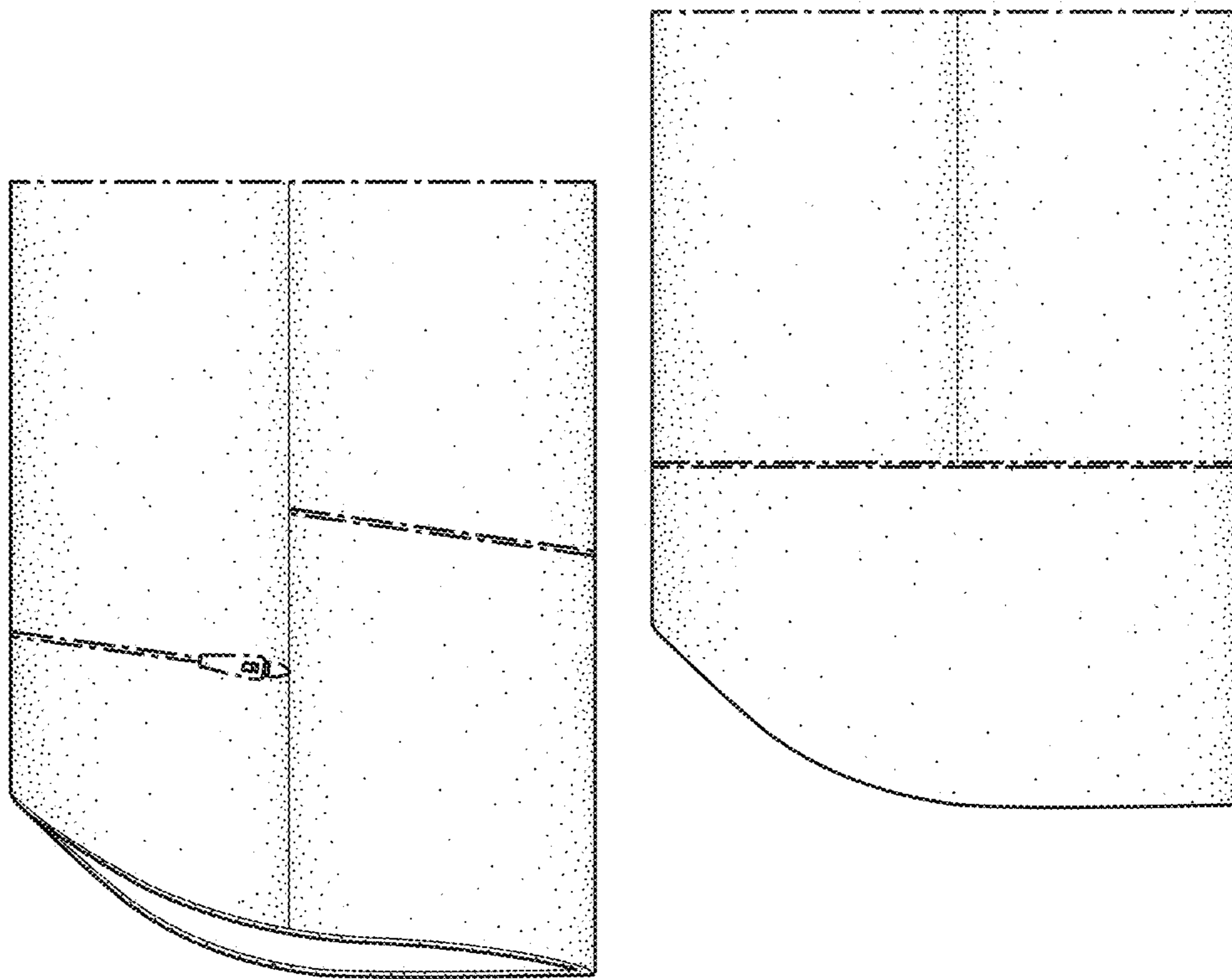

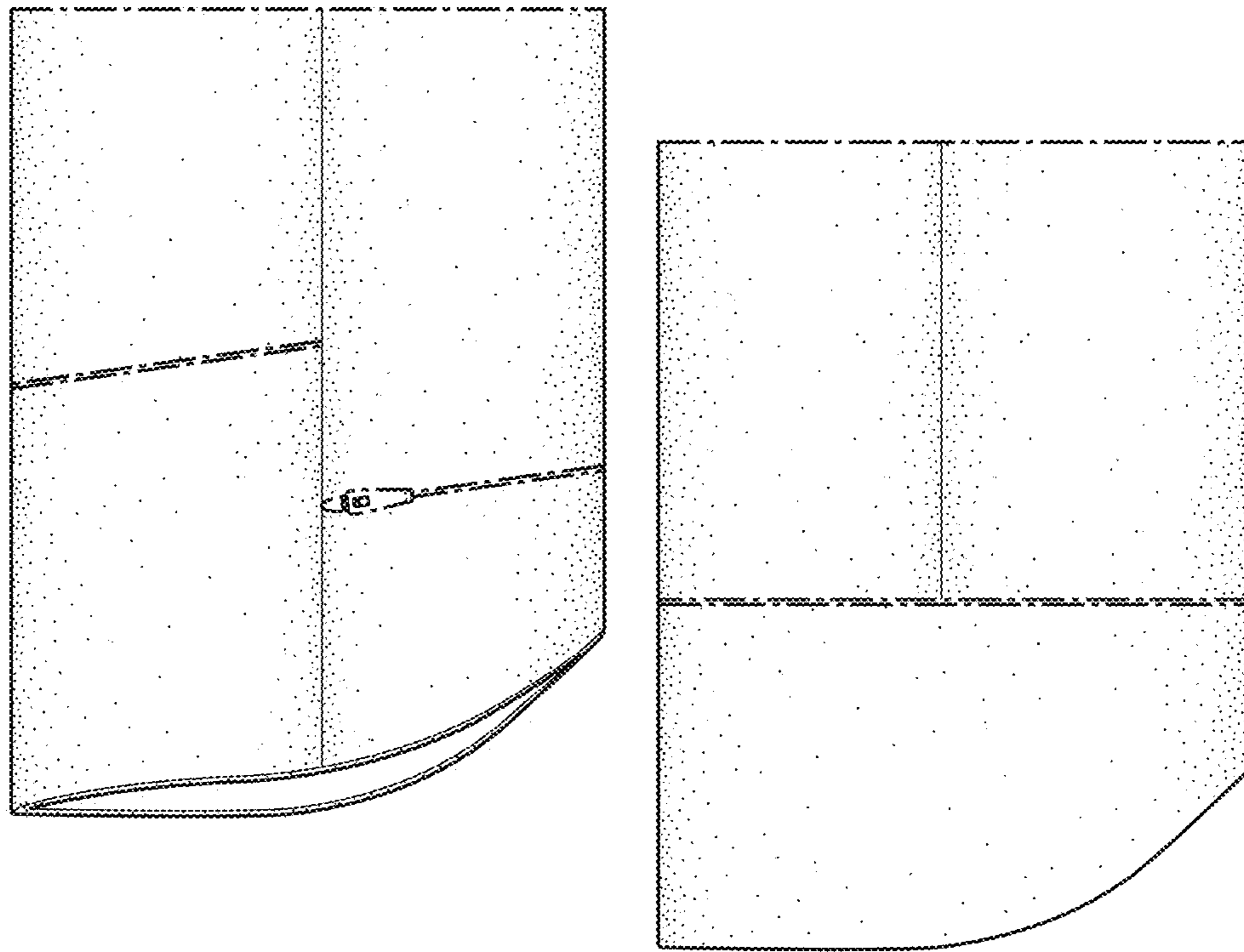
