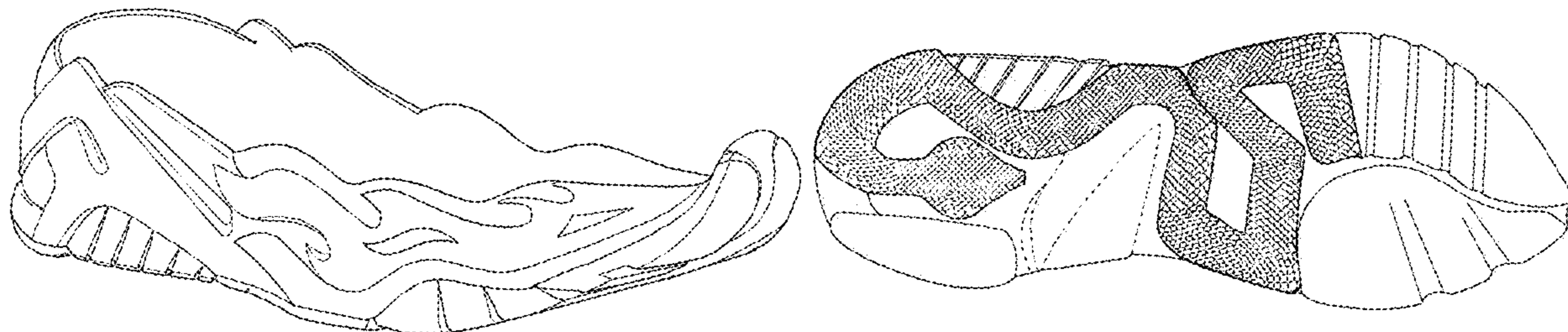
(57) **CLAIM**

The ornamental design for a sole for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sole for footwear, showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a side view thereof;
FIG. 5 is a side view thereof, from a side opposite that of FIG. 4;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

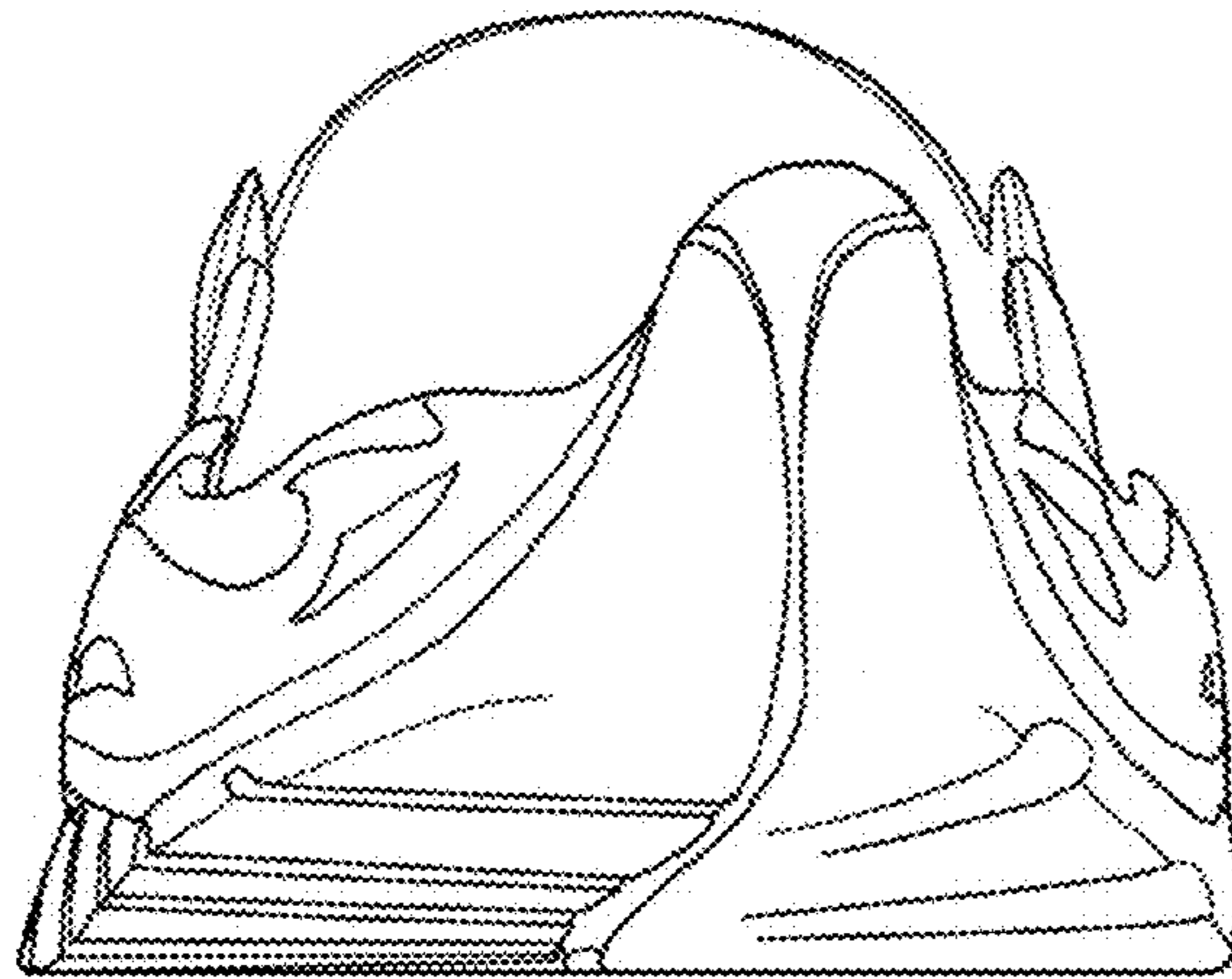

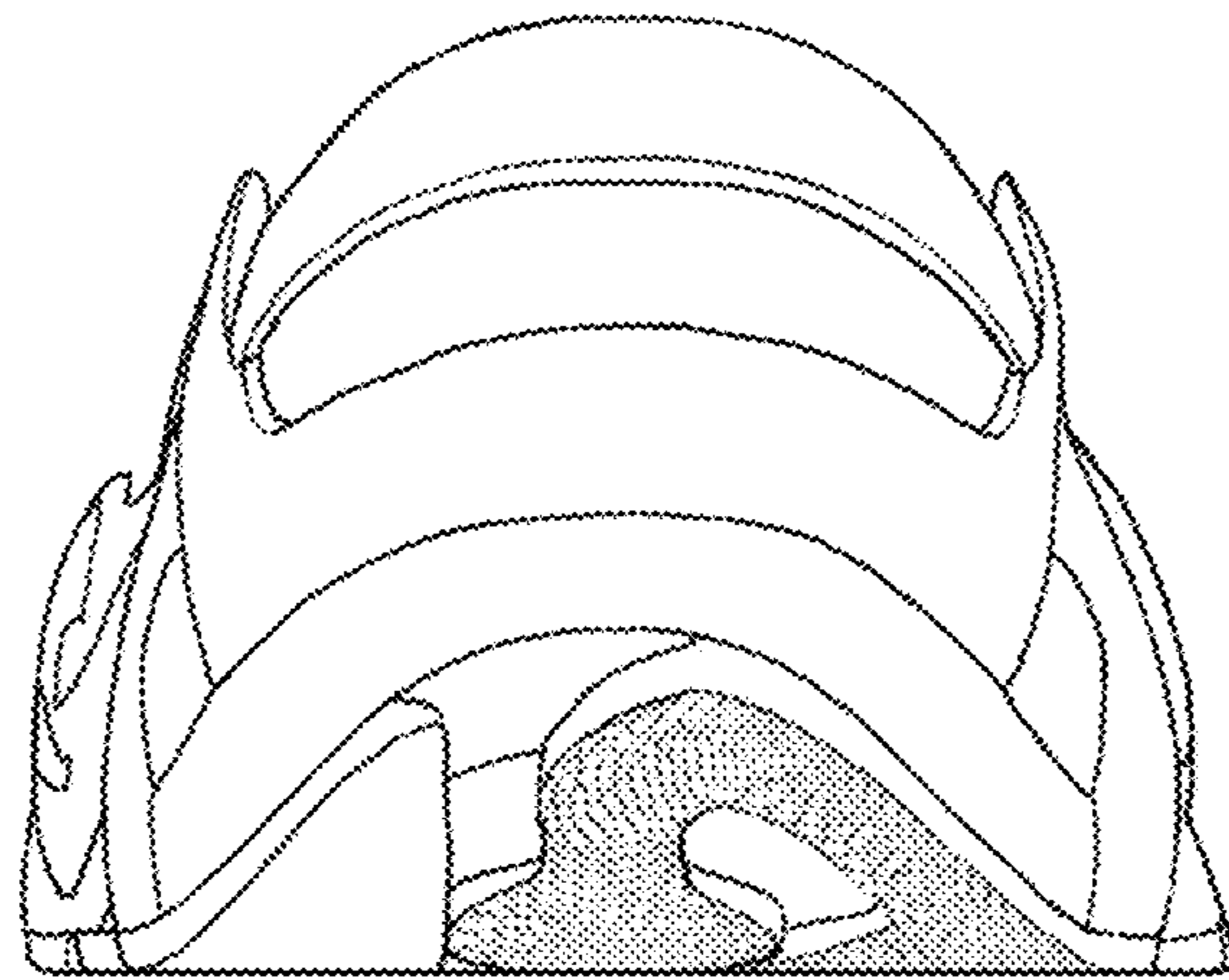

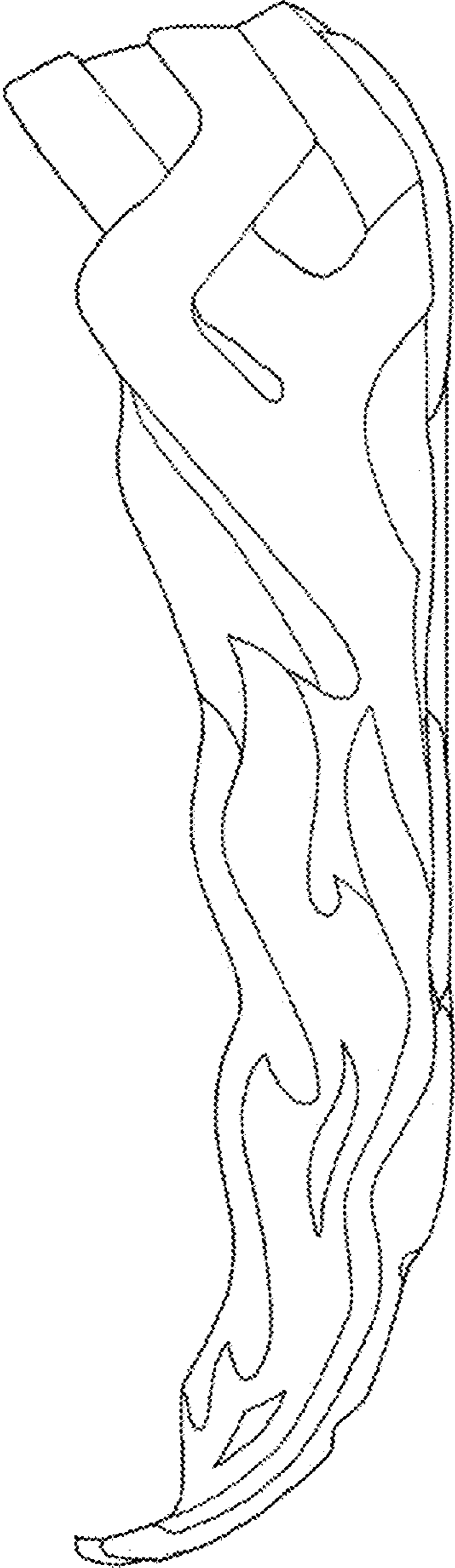

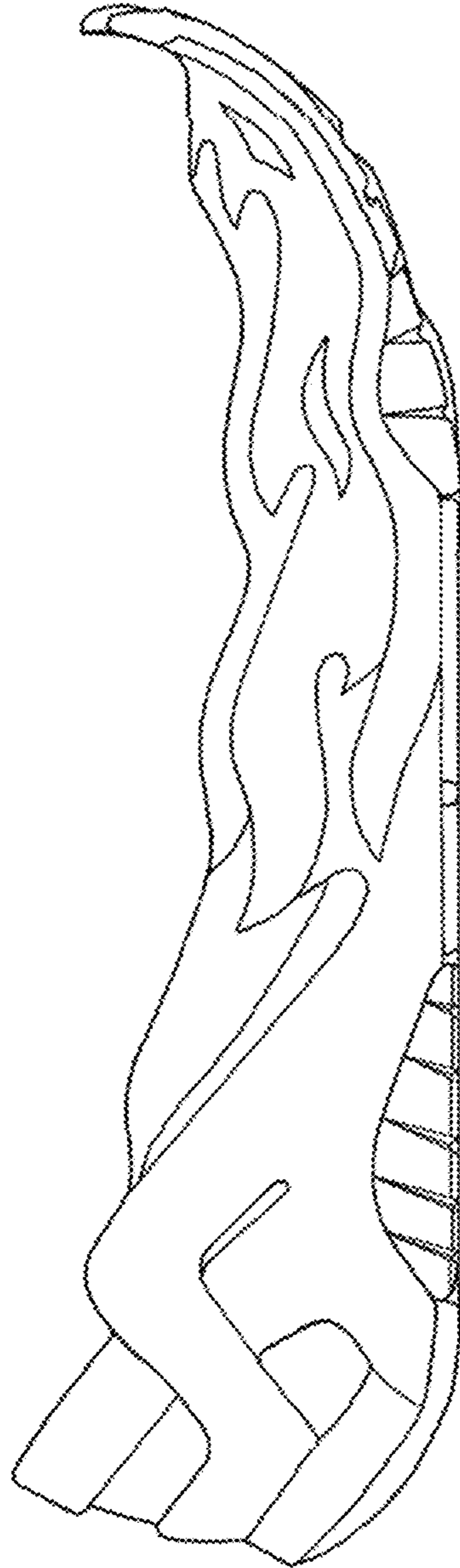

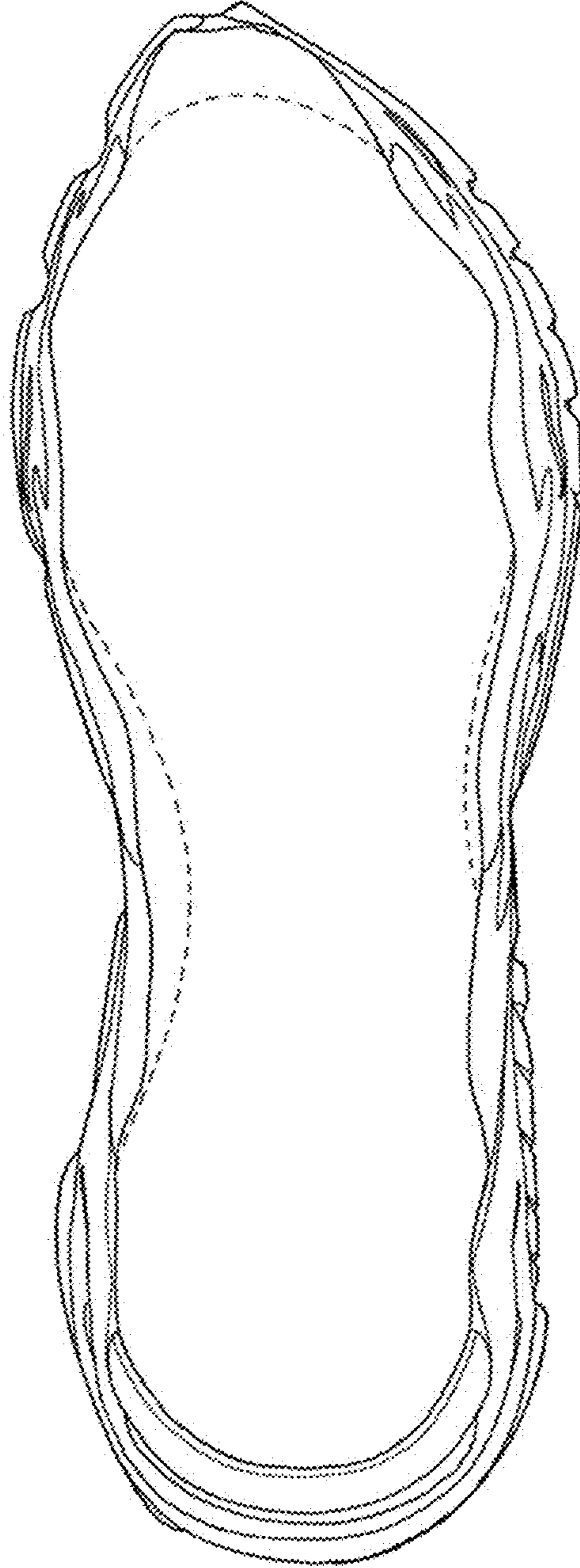

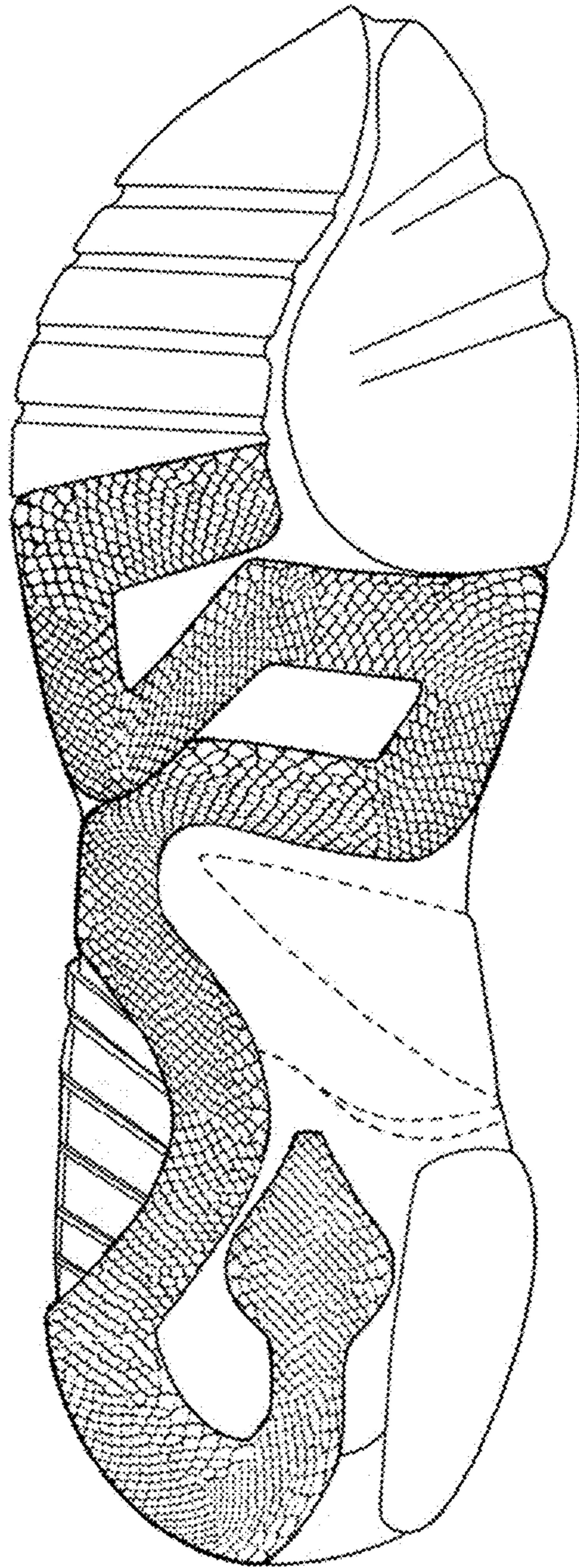
