The ornamental design for a golf shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of the golf shoe outsole of this invention;

FIG. 2 is a medial side elevation view of the golf shoe outsole of this invention;

FIG. 3 is a lateral side elevation view of the golf shoe outsole of this invention;

FIG. 4 is a front elevation view of the golf shoe outsole of this invention;

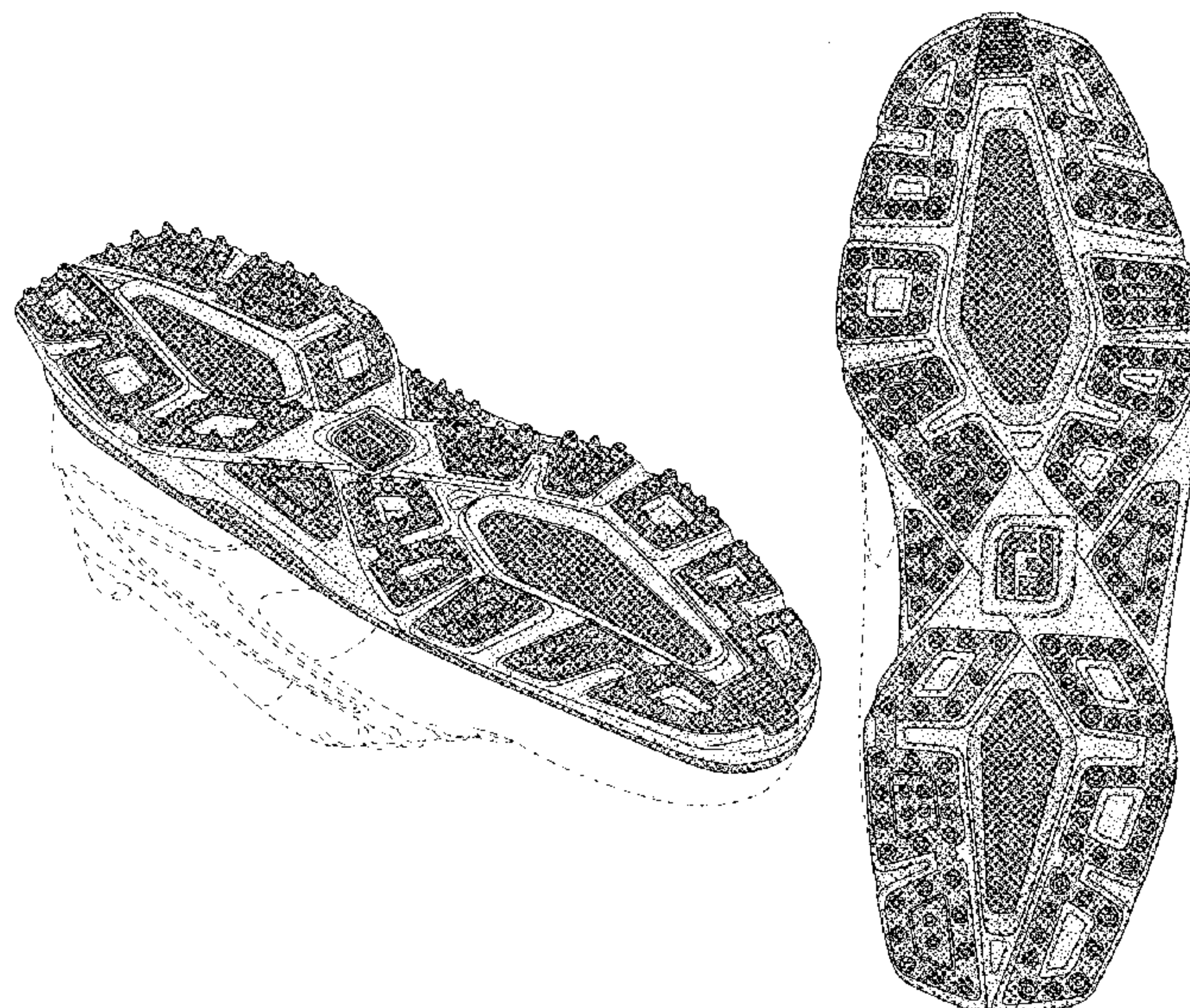
FIG. 5 is a rear elevation view of the golf shoe outsole of this invention;

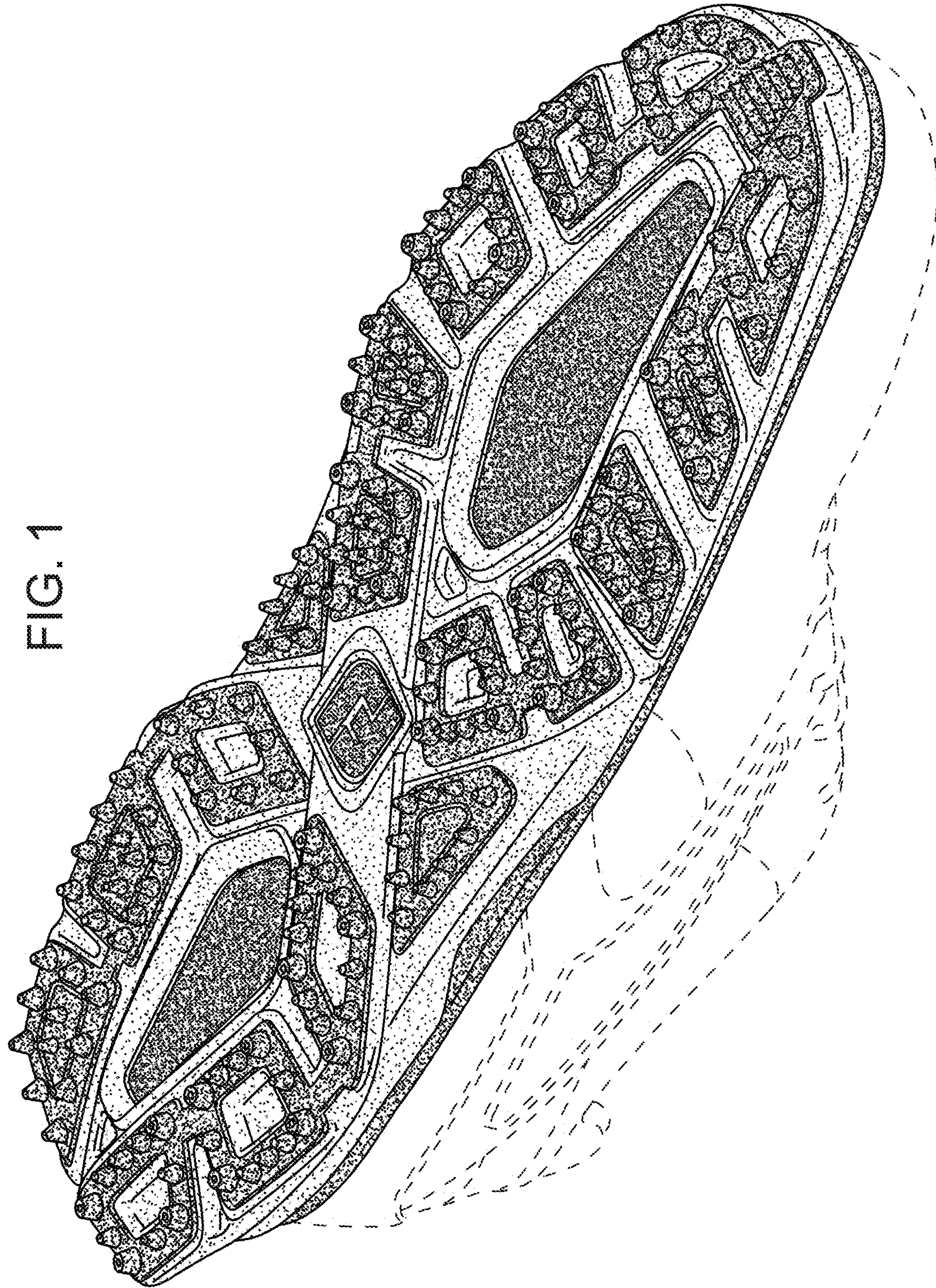

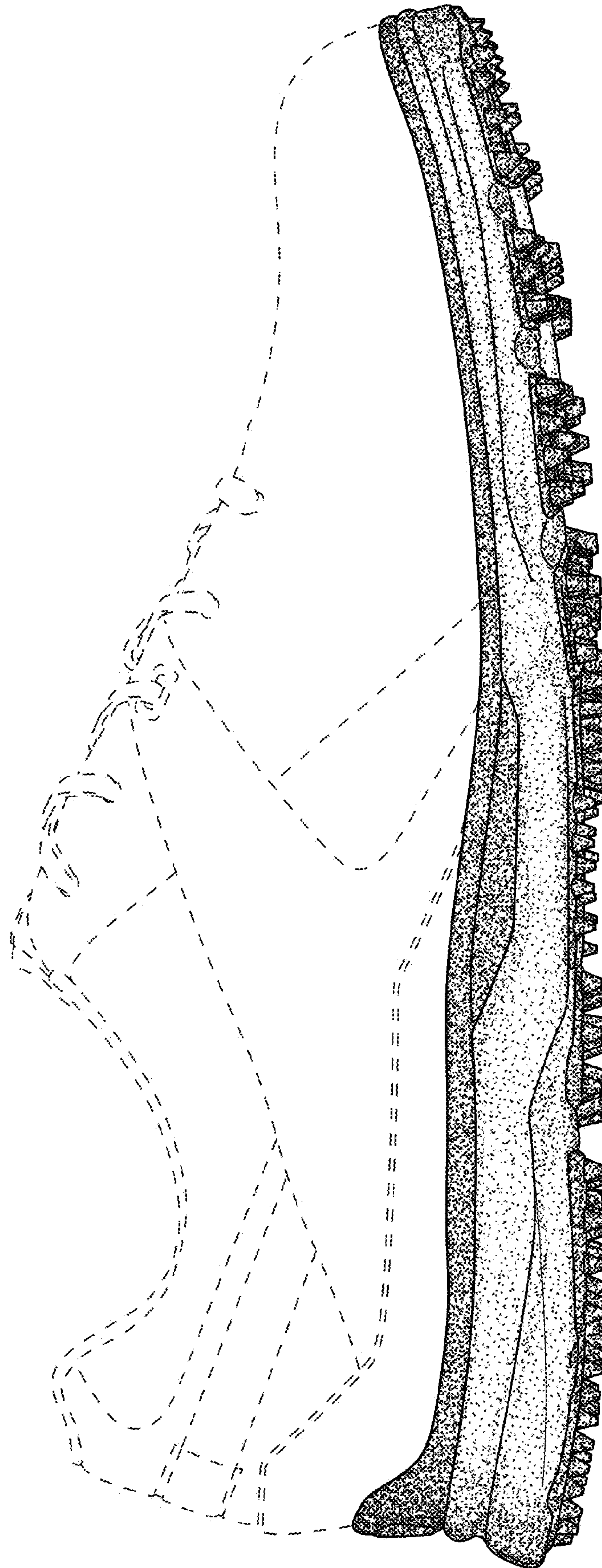

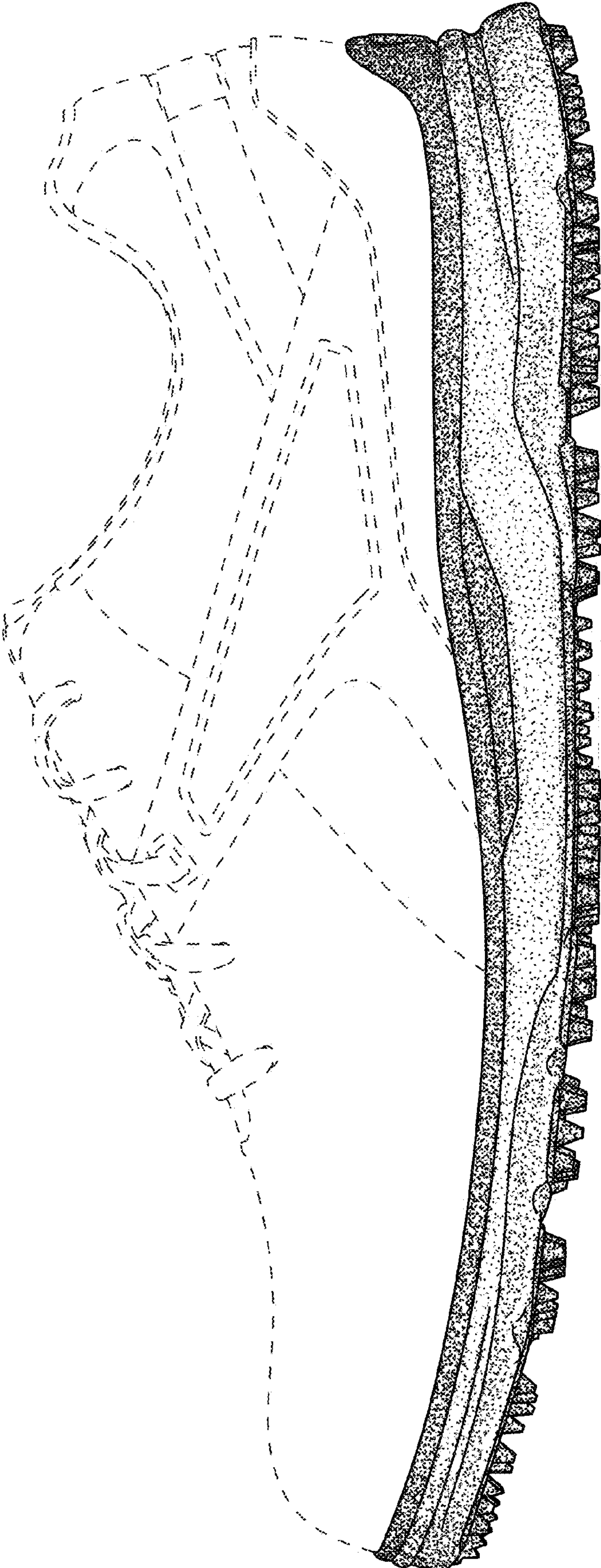

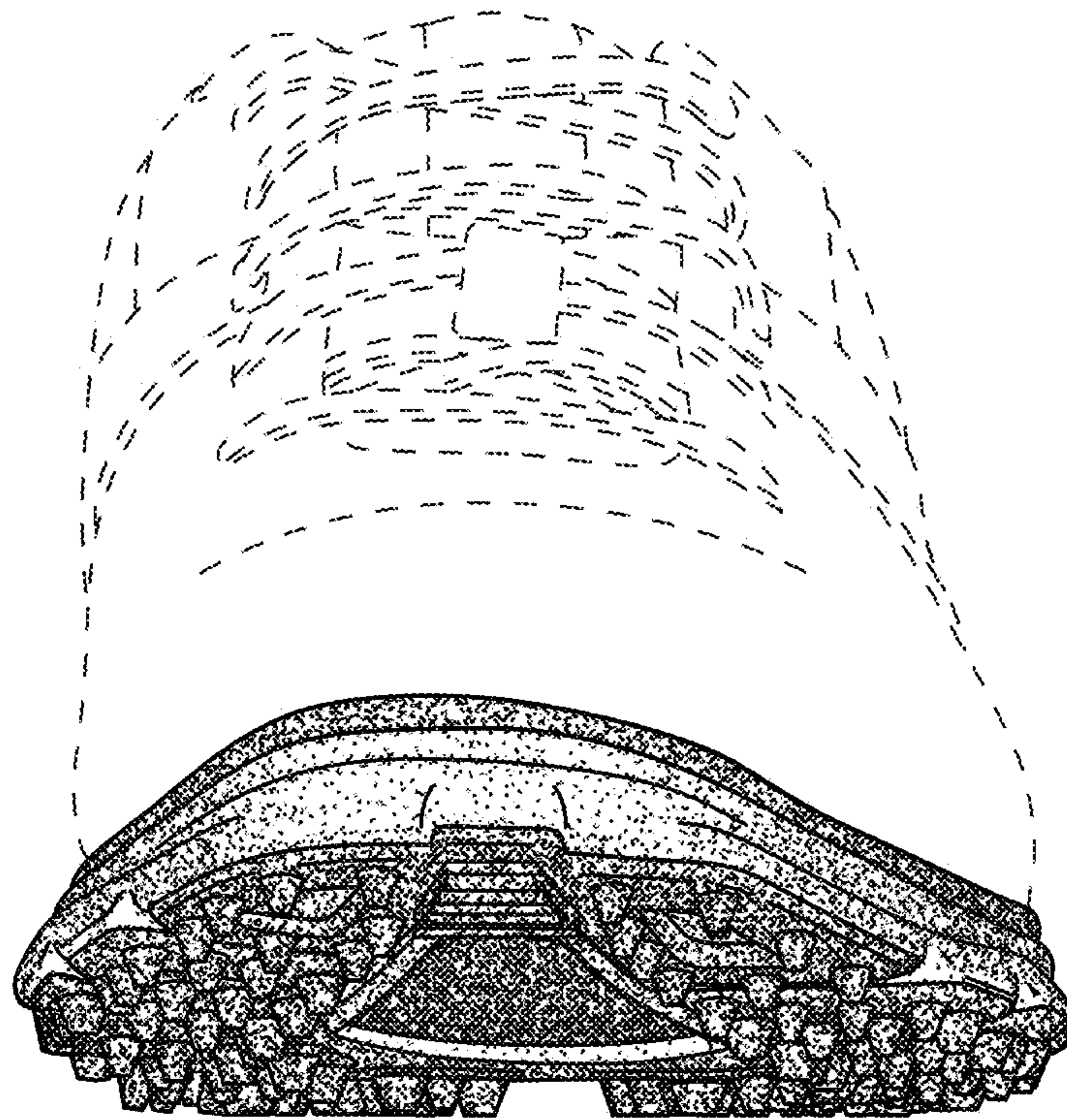

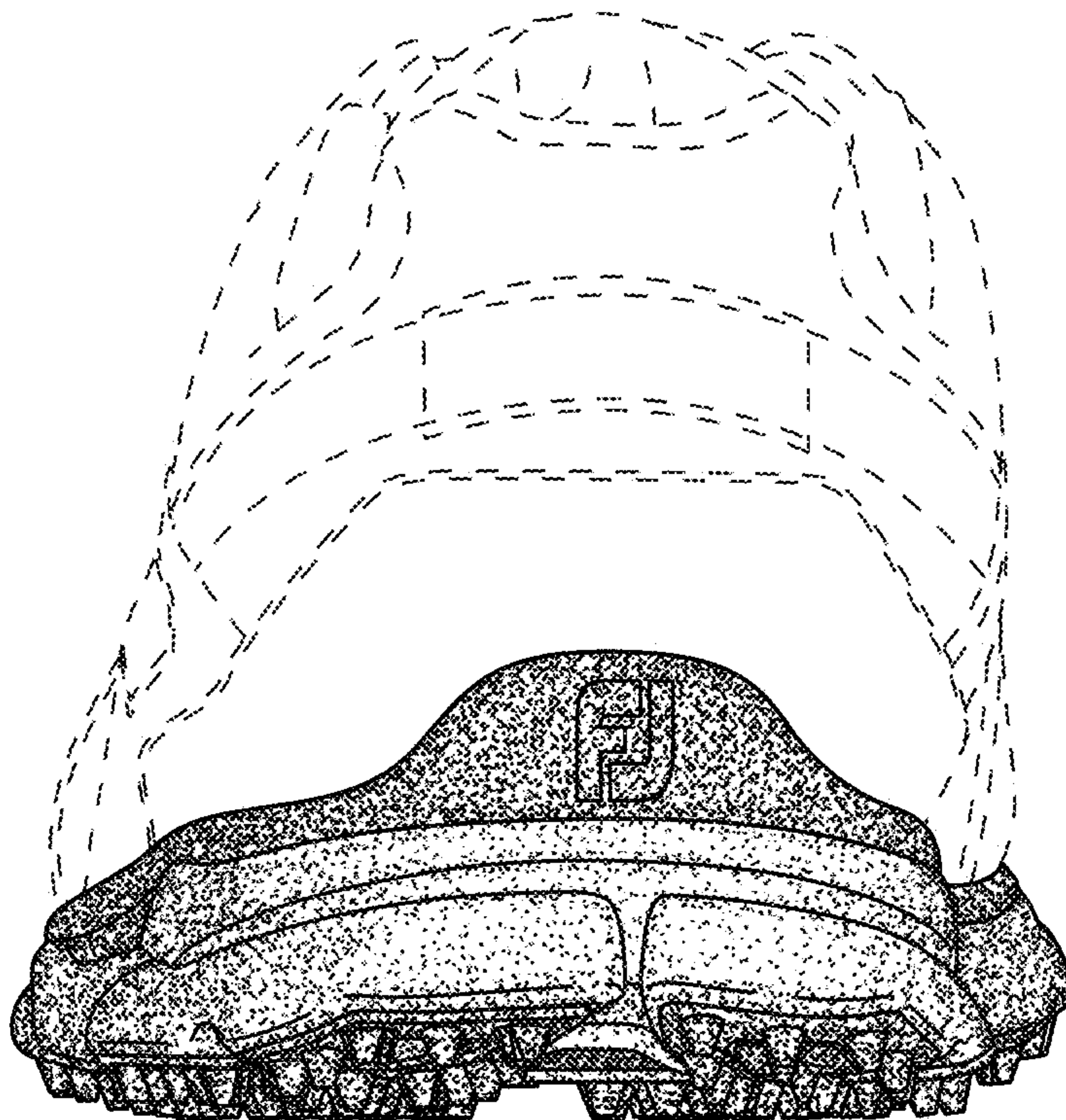

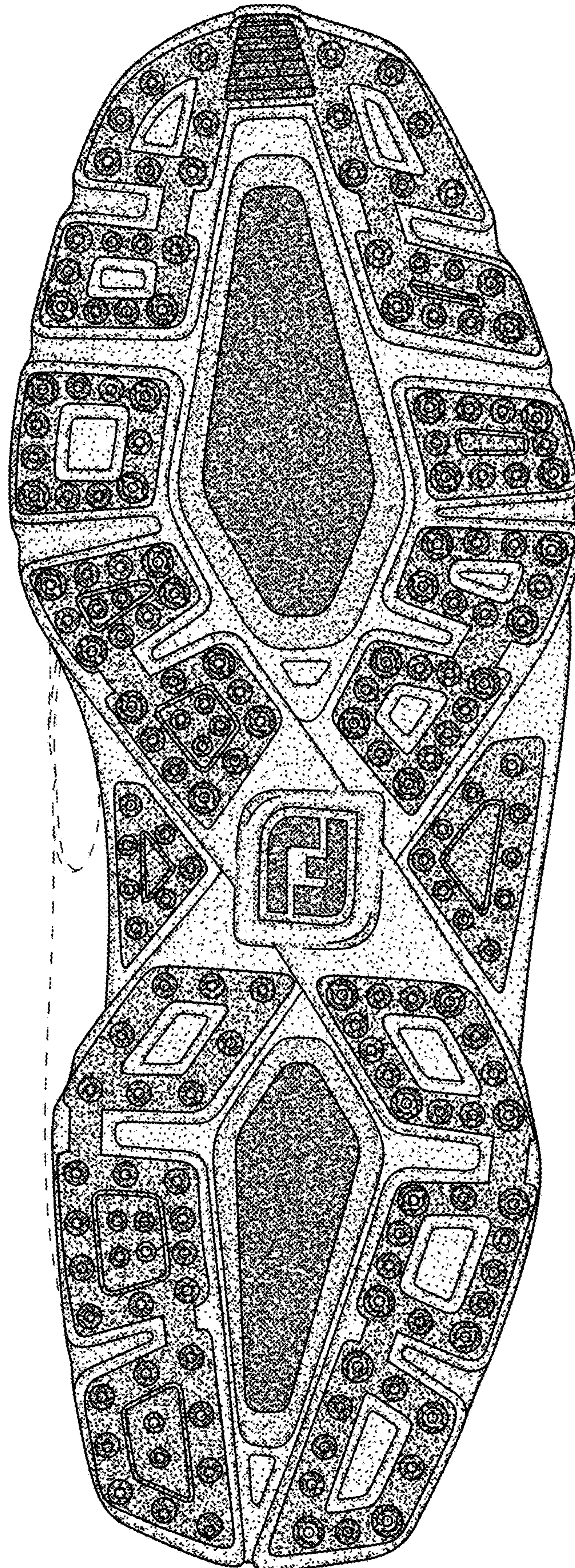
