**DESCRIPTION**

FIG. 1 is a right side elevation view of a side brush, the left side being a mirror image;  
FIG. 2 is a front elevation view thereof, the rear being a mirror image;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a top perspective view thereof; and,  
FIG. 6 is a bottom perspective view thereof.  
The broken lines show portions of the side brush that form no part of the claimed design.

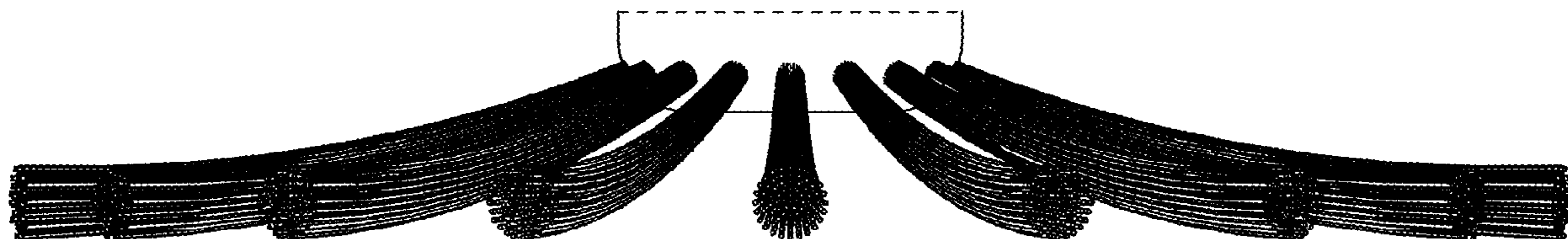

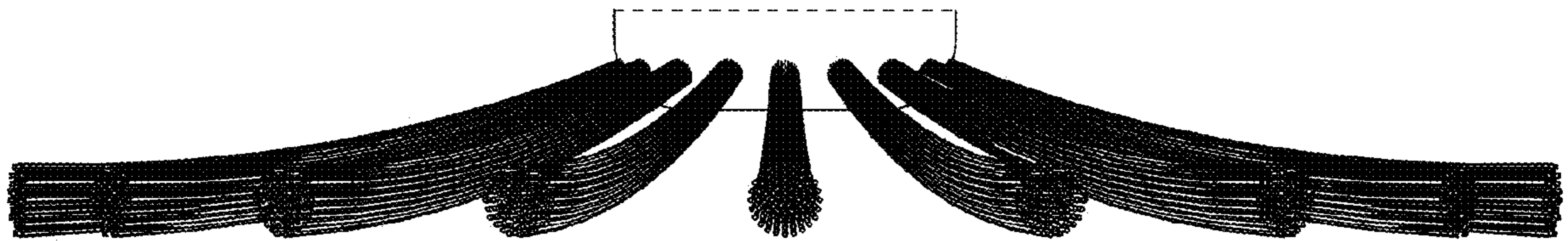

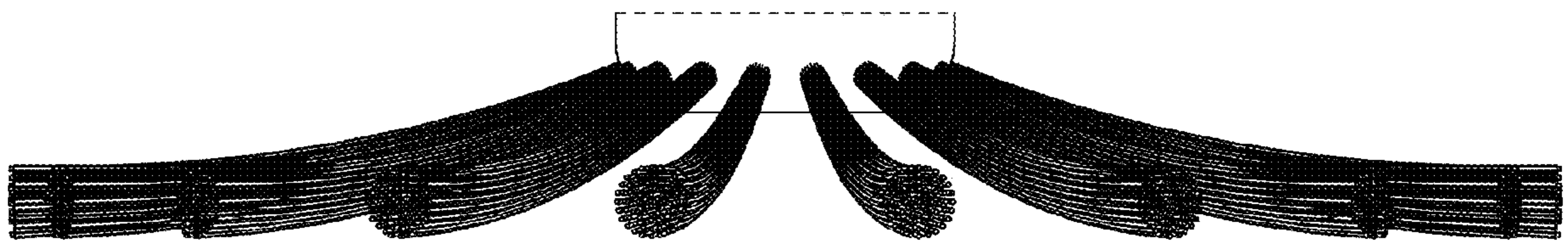

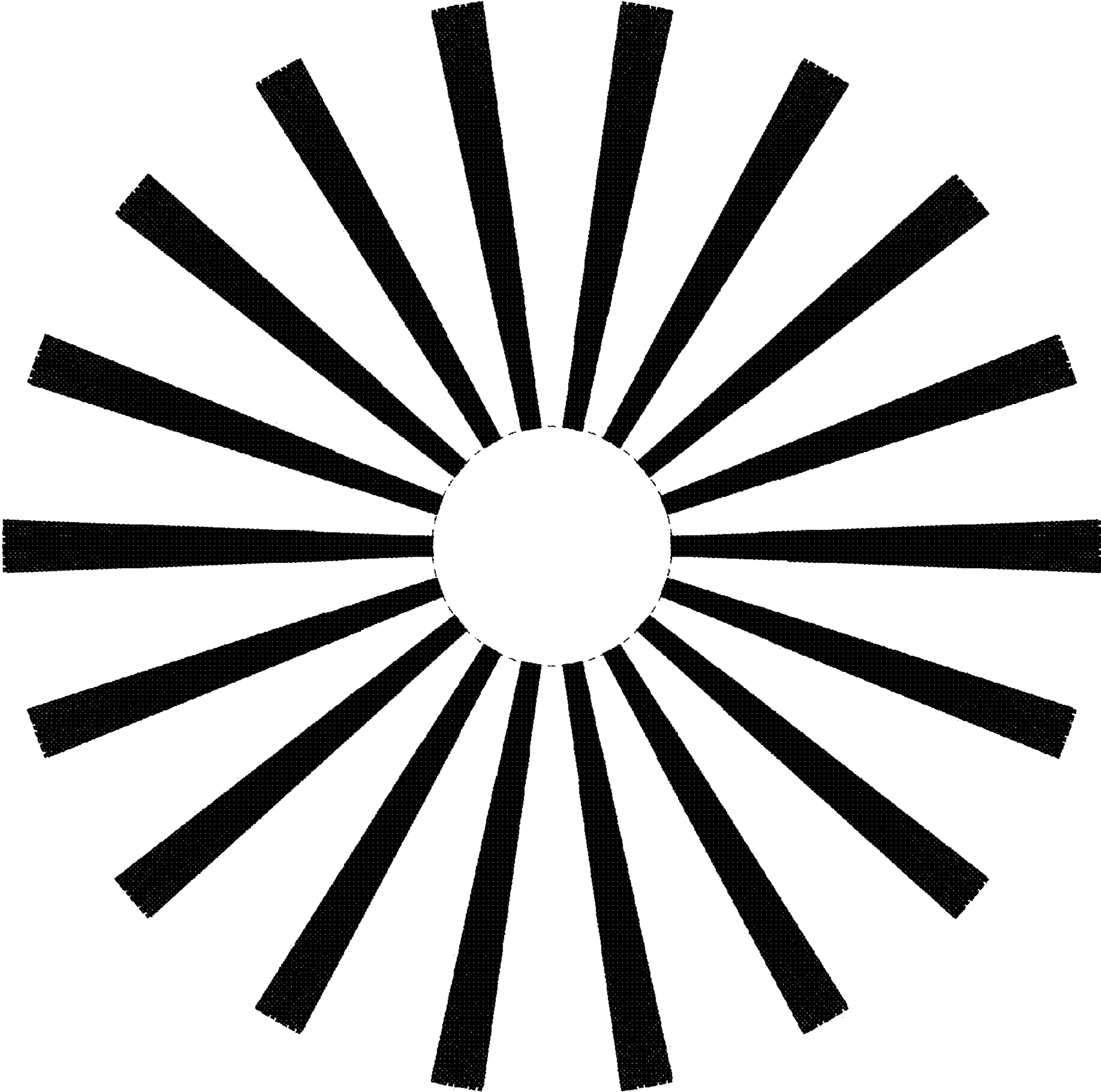

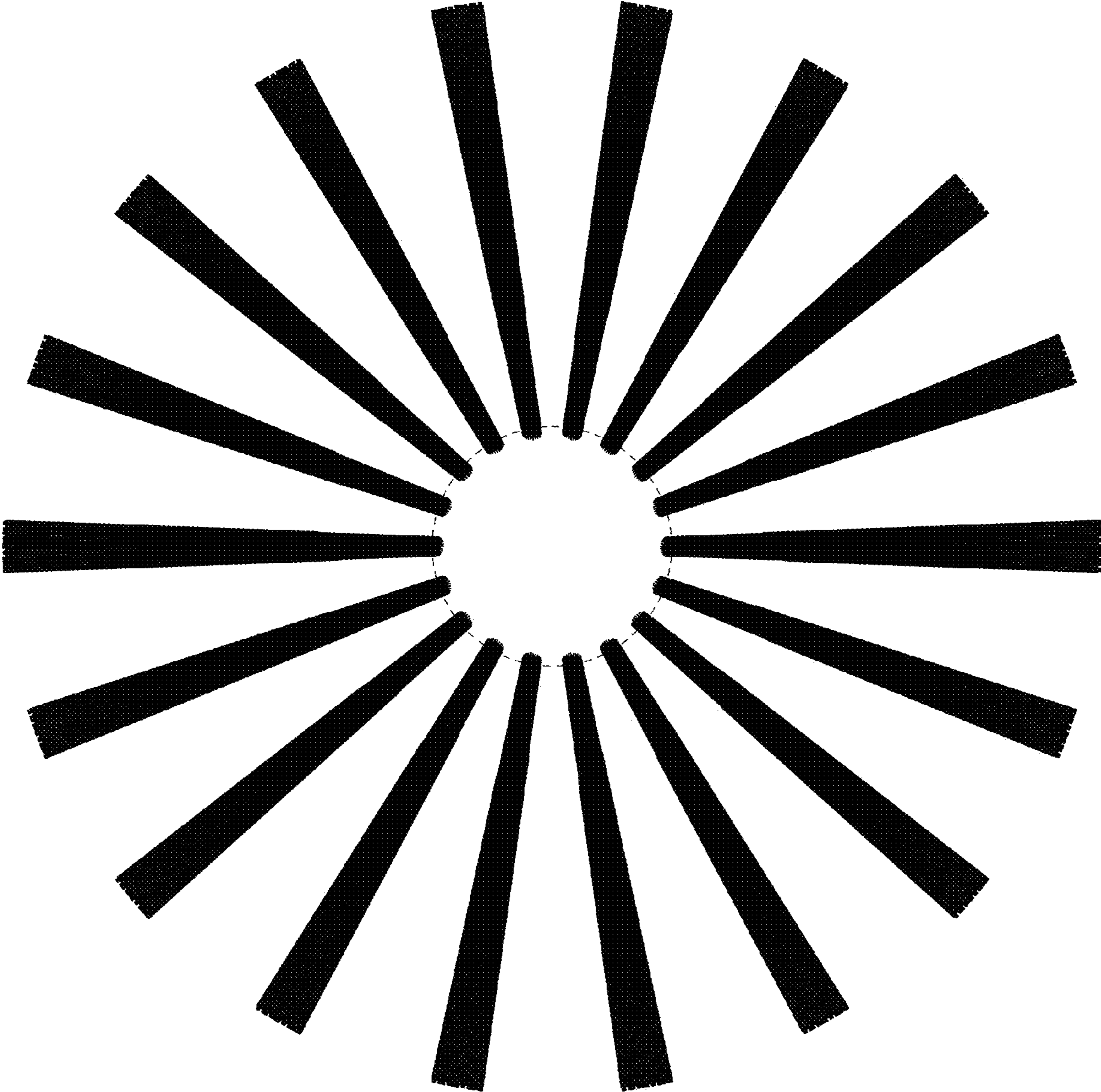

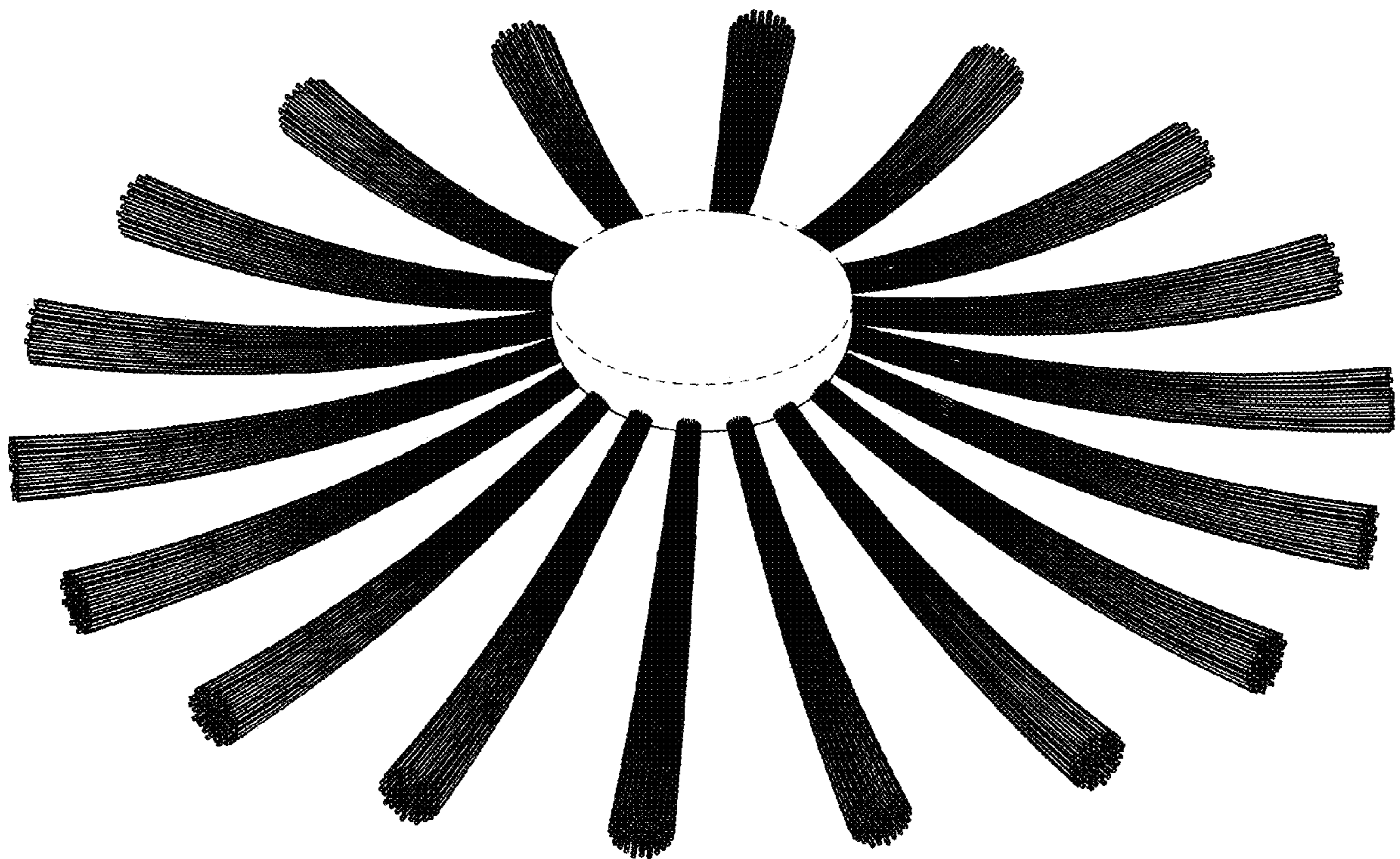
