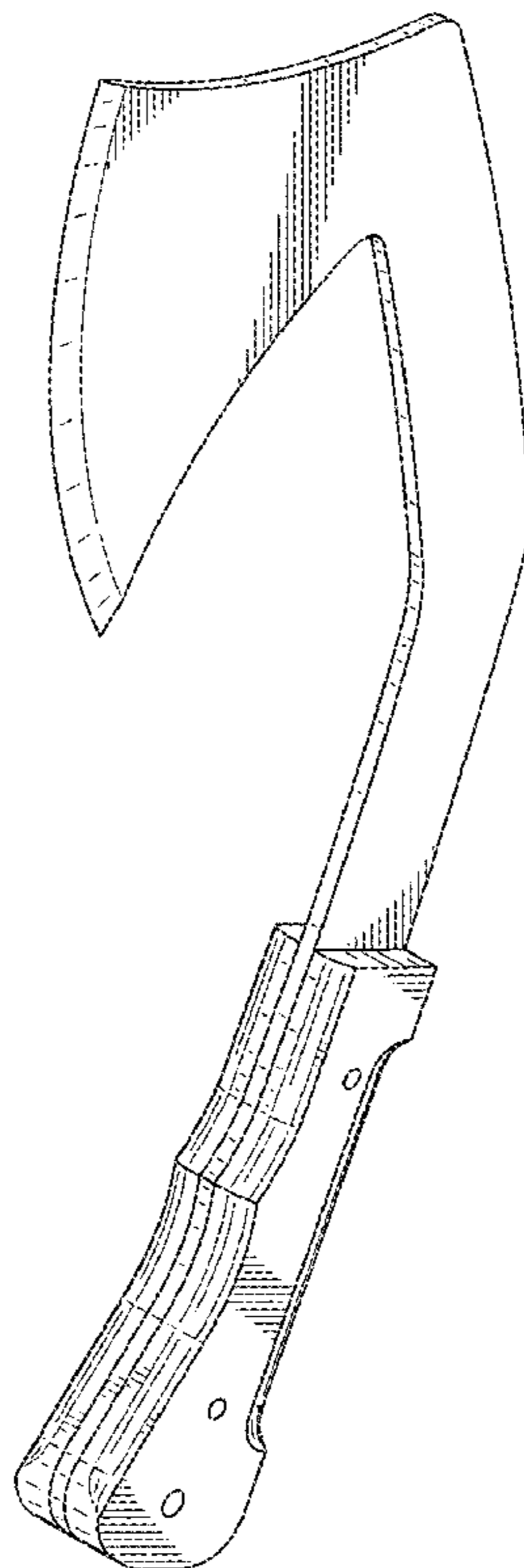
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric top, front, right view of an axe showing my new design;

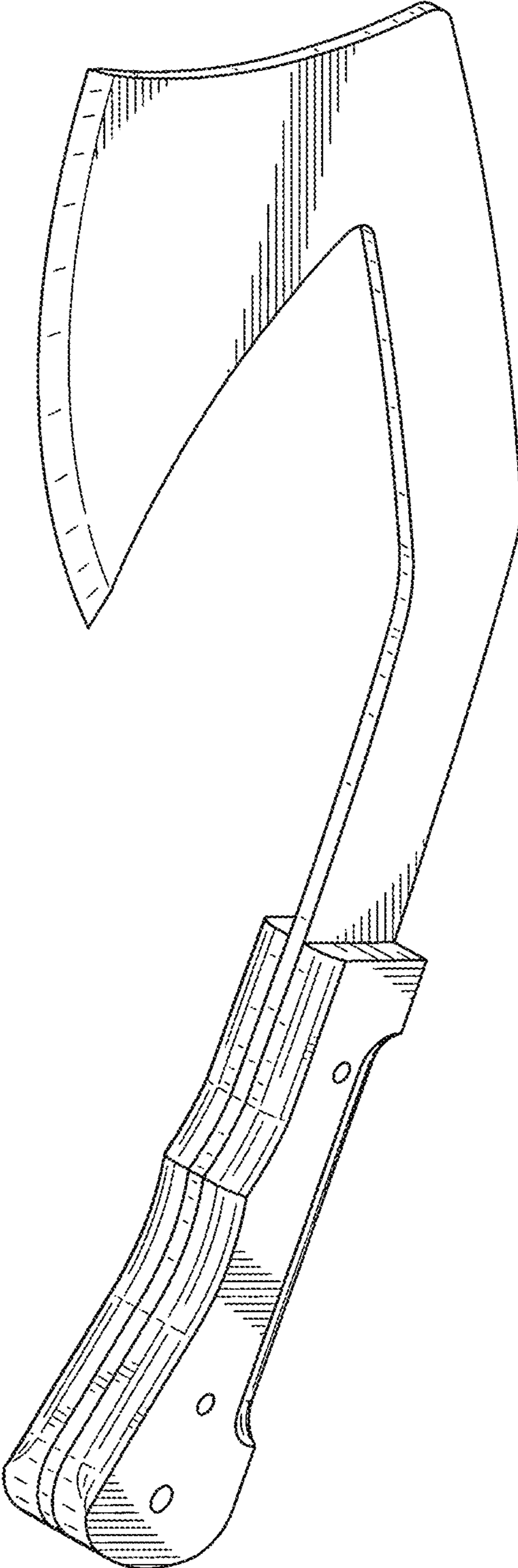

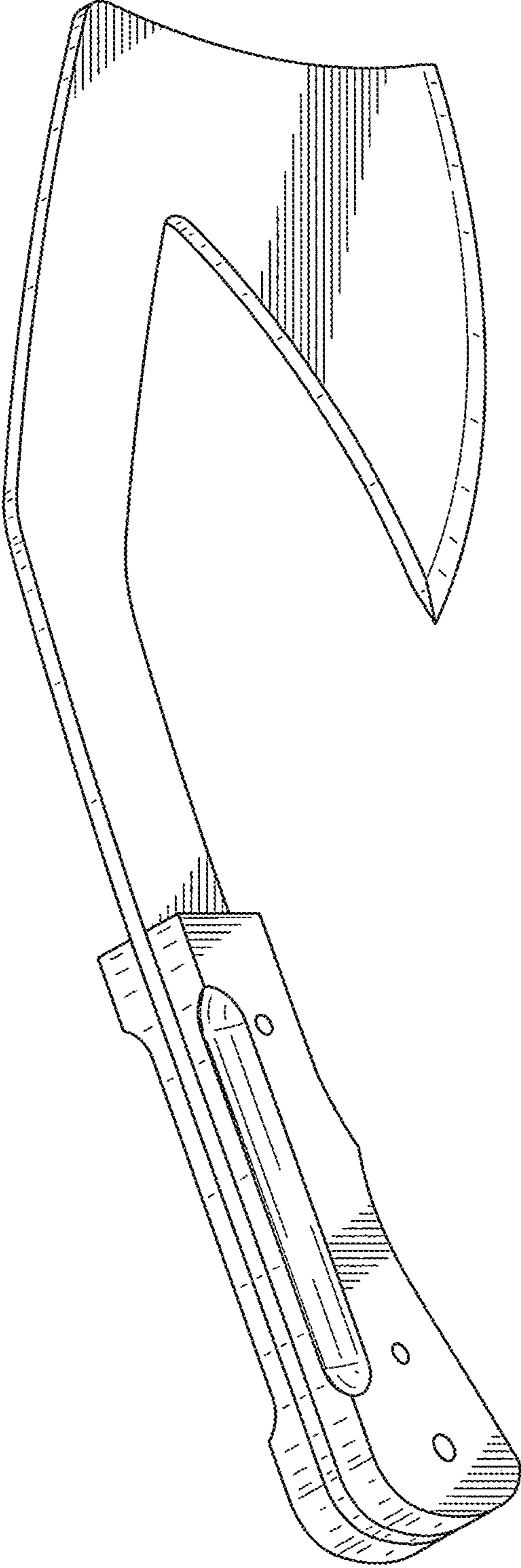

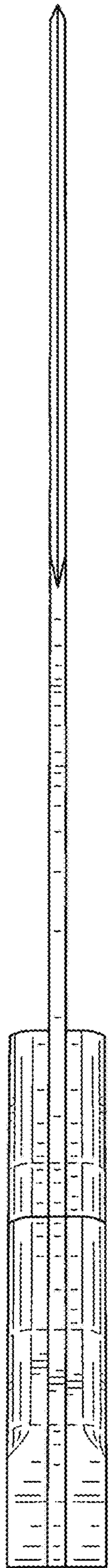

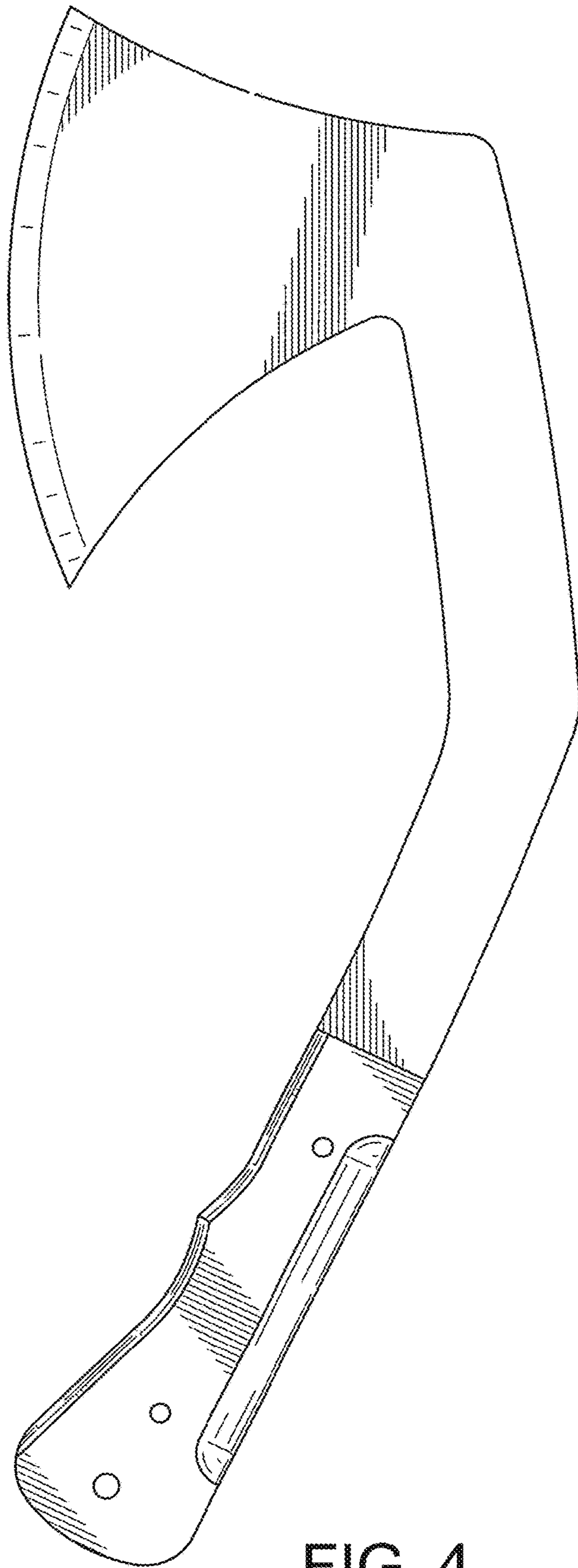

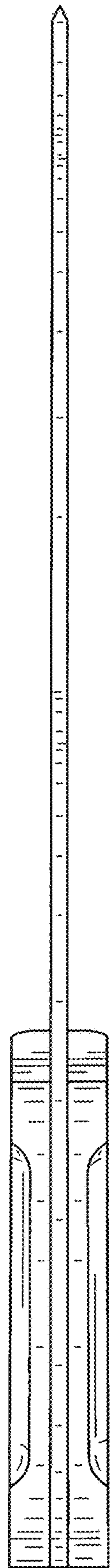

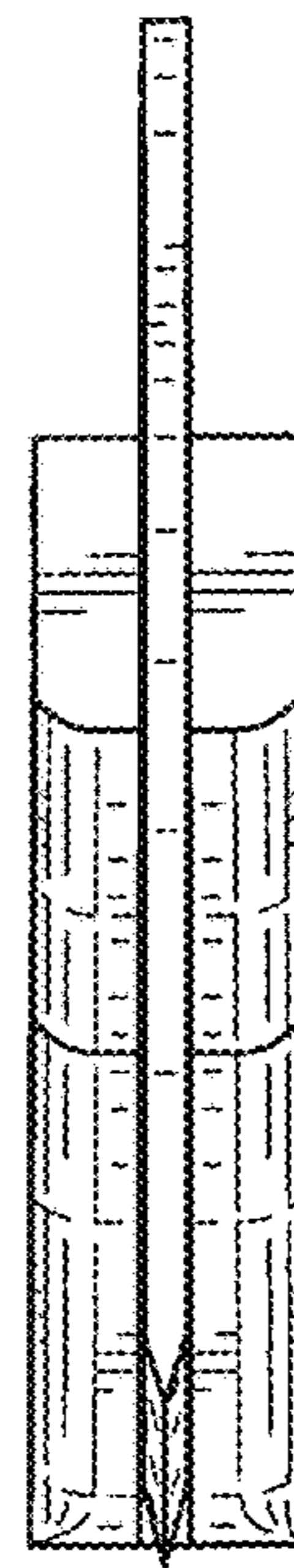

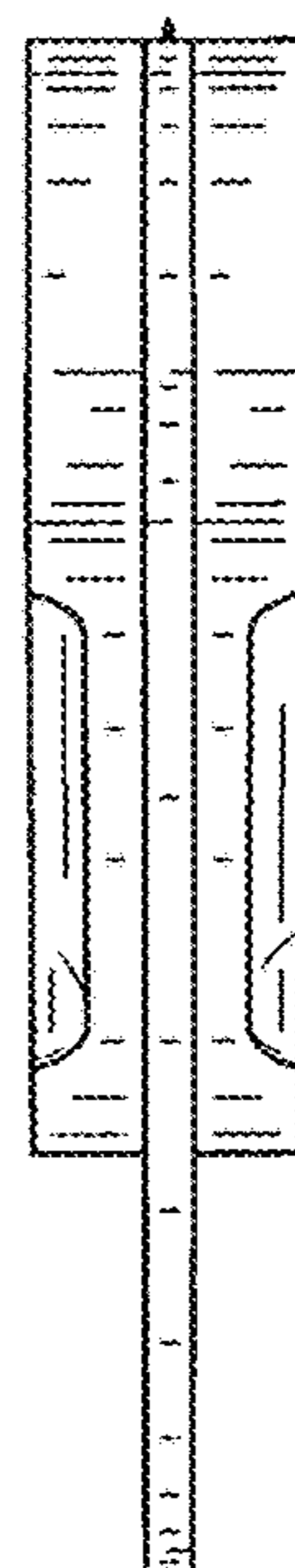
