FIG. 11 is a bottom view thereof.

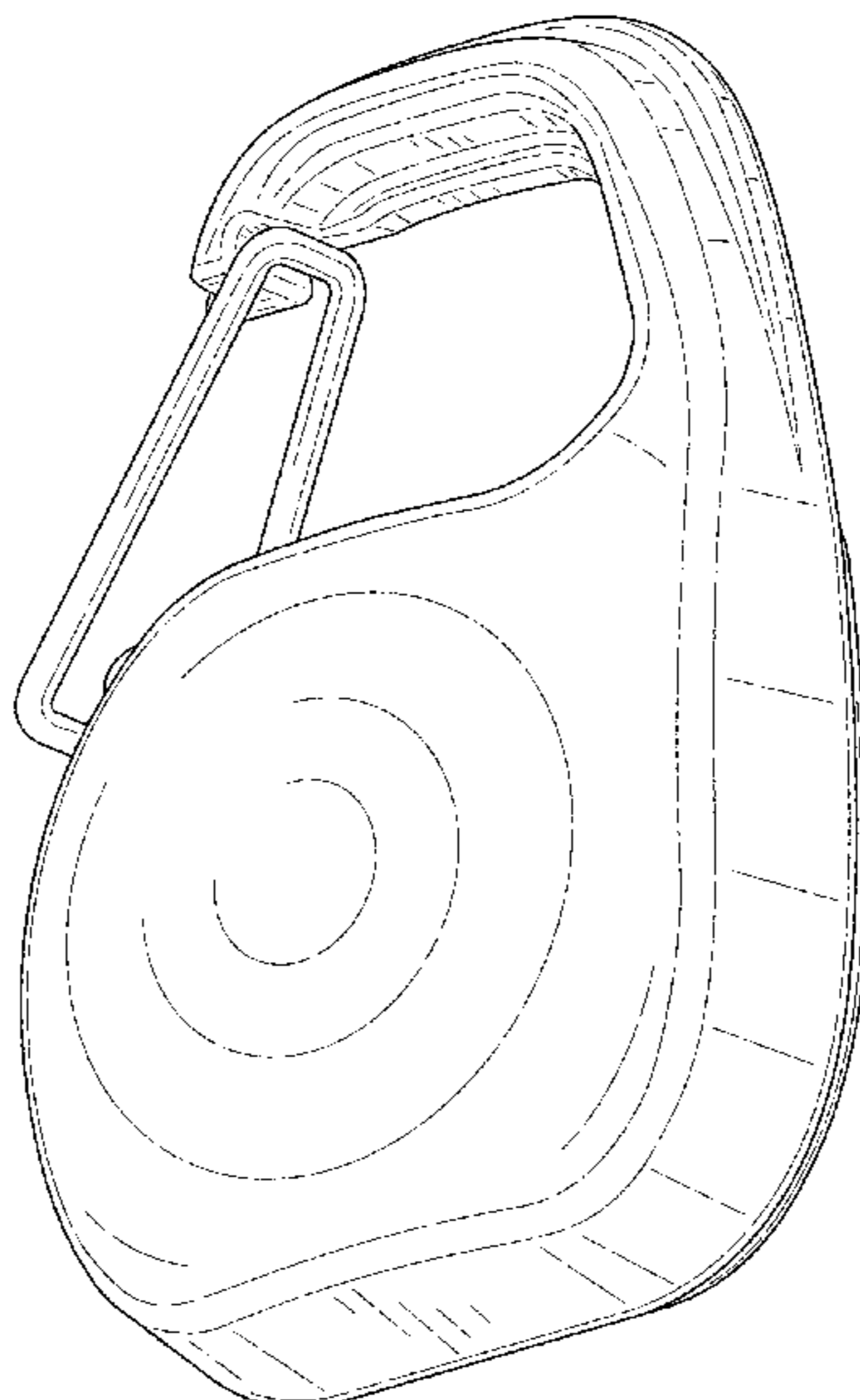

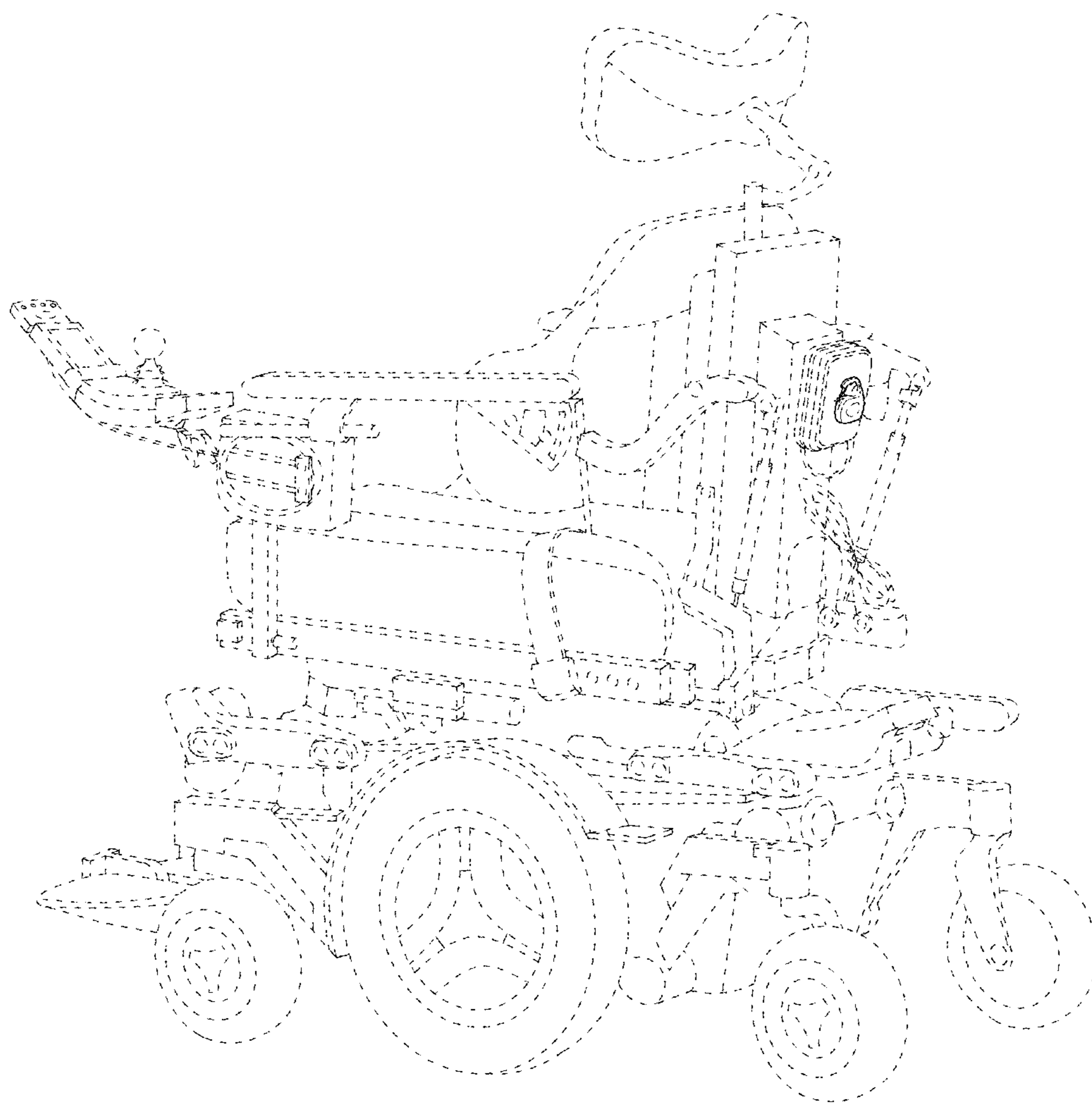

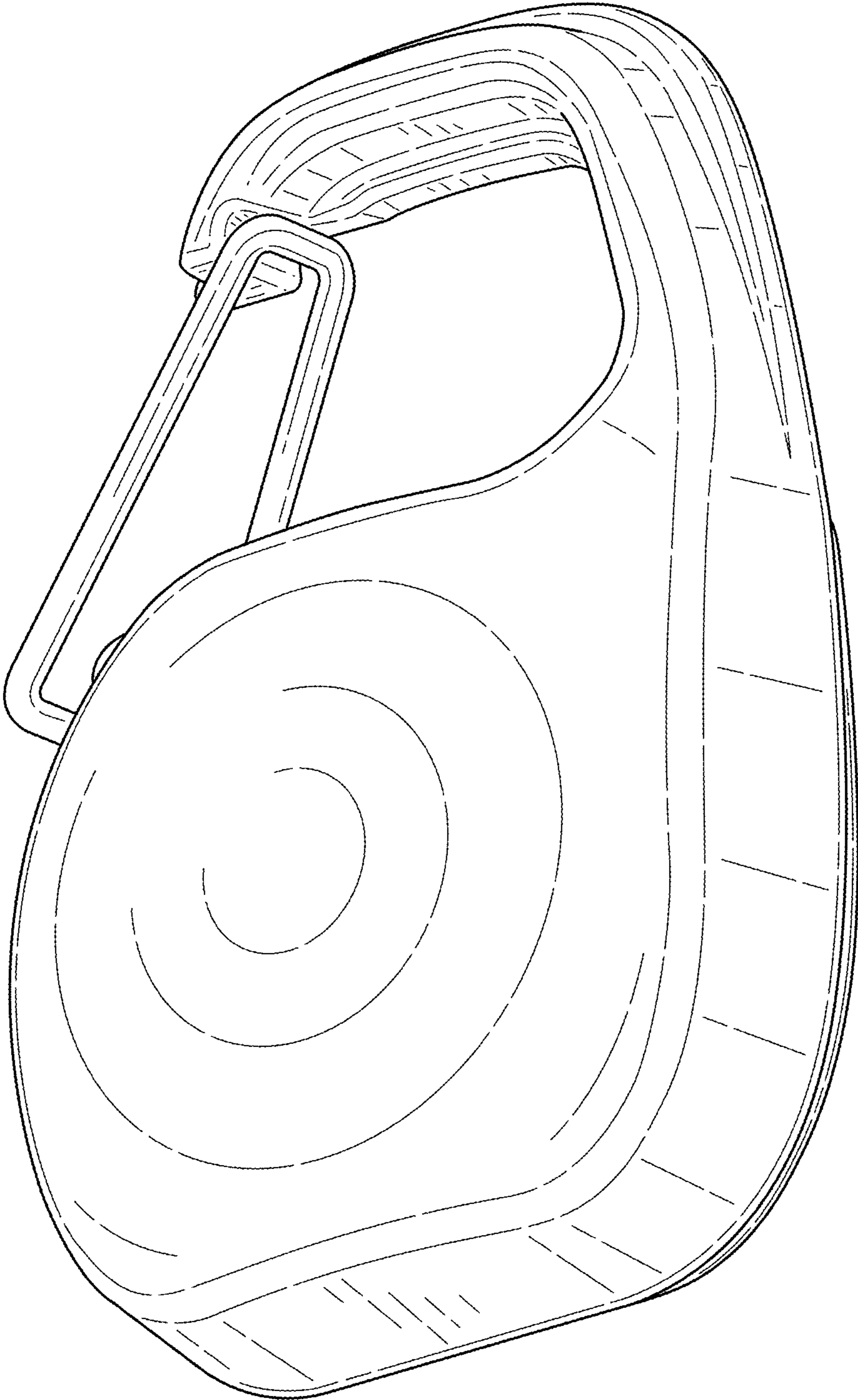

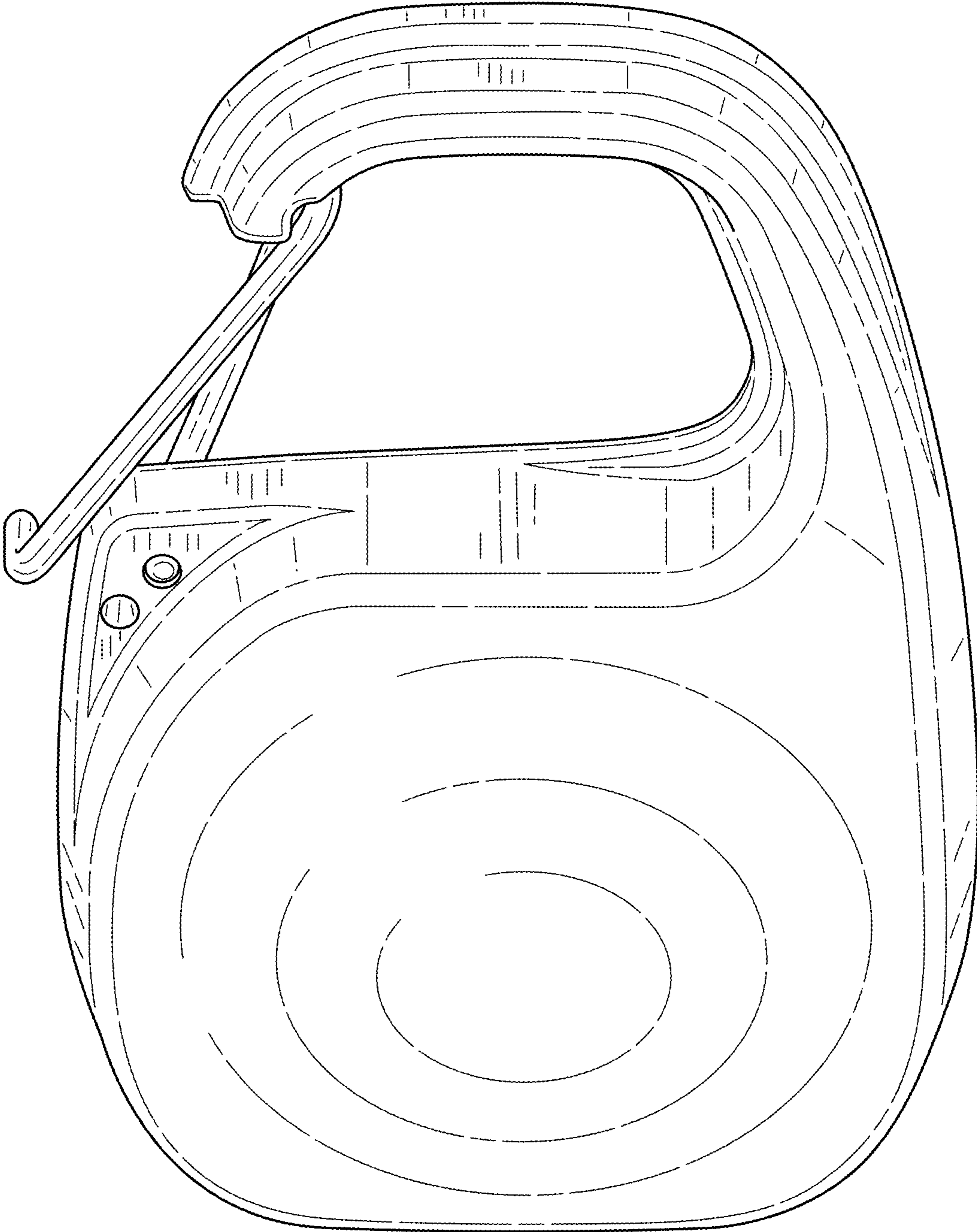

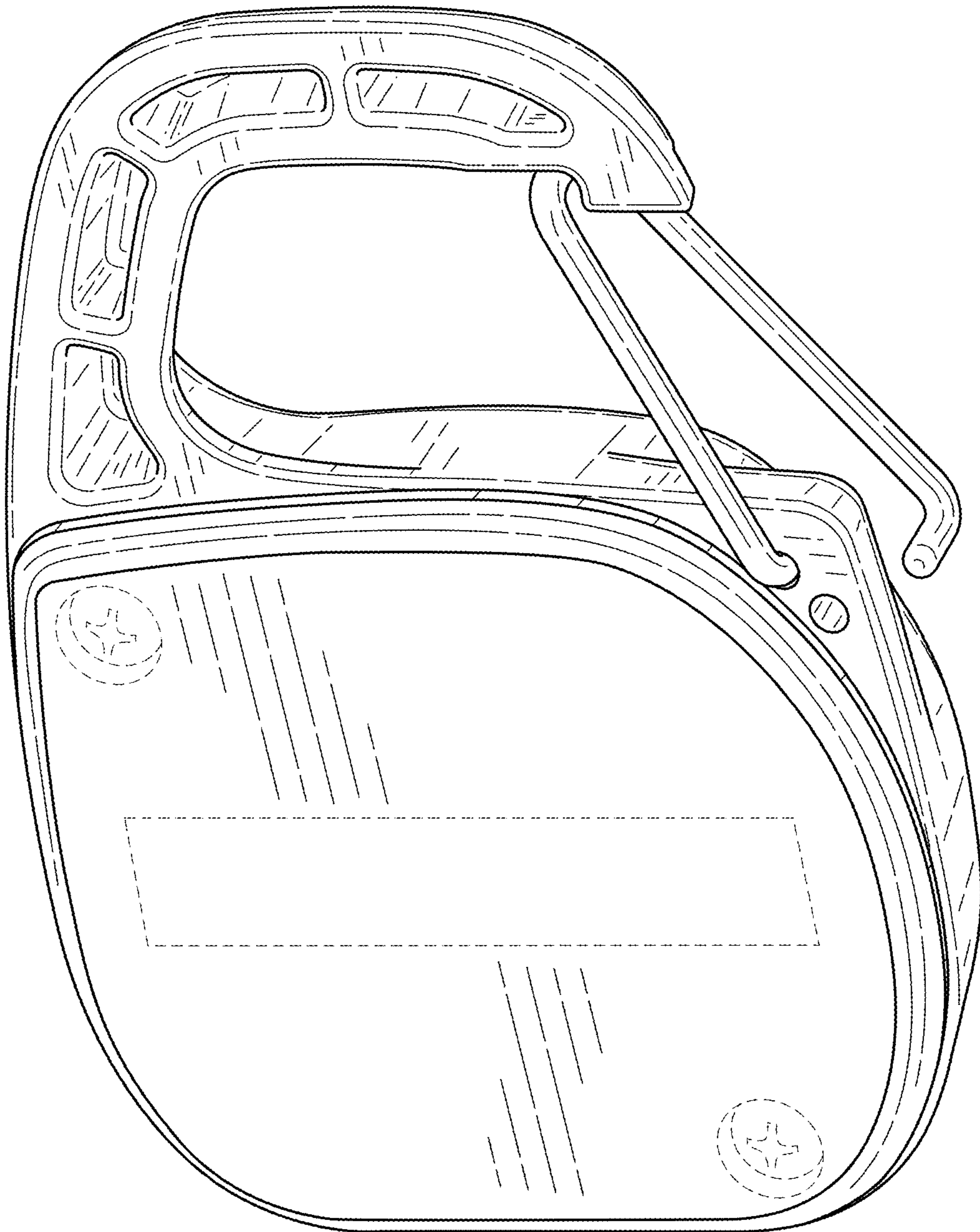

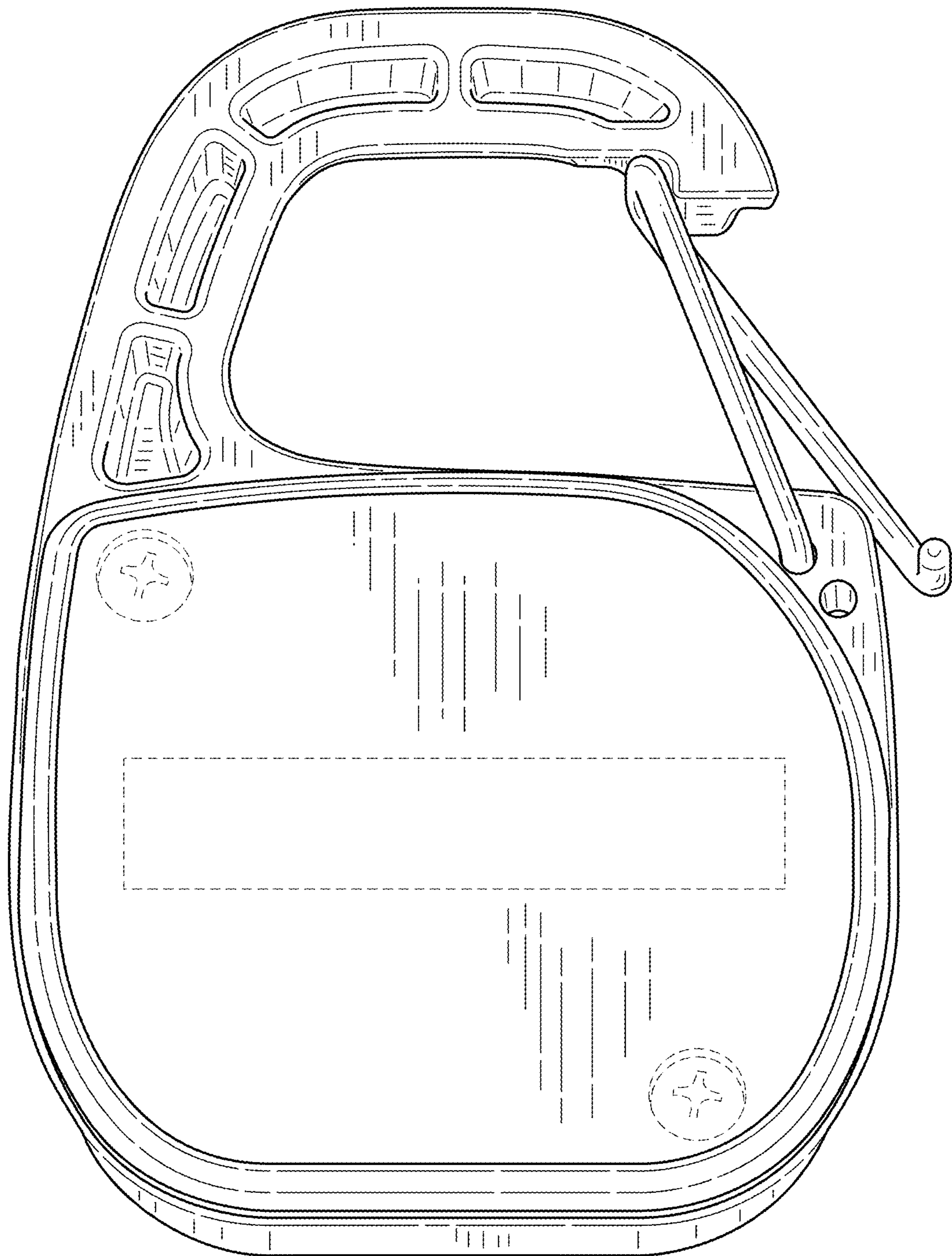

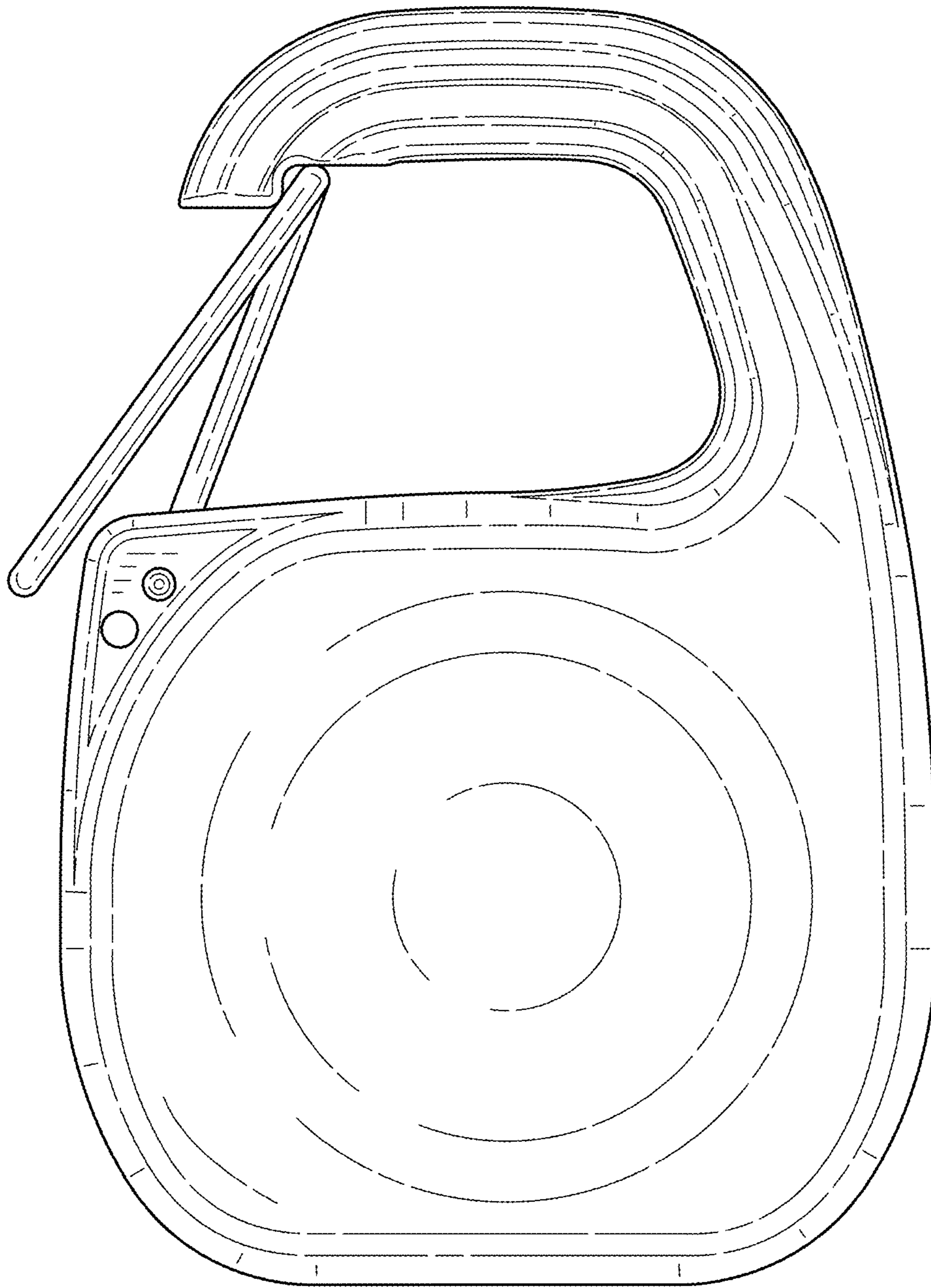

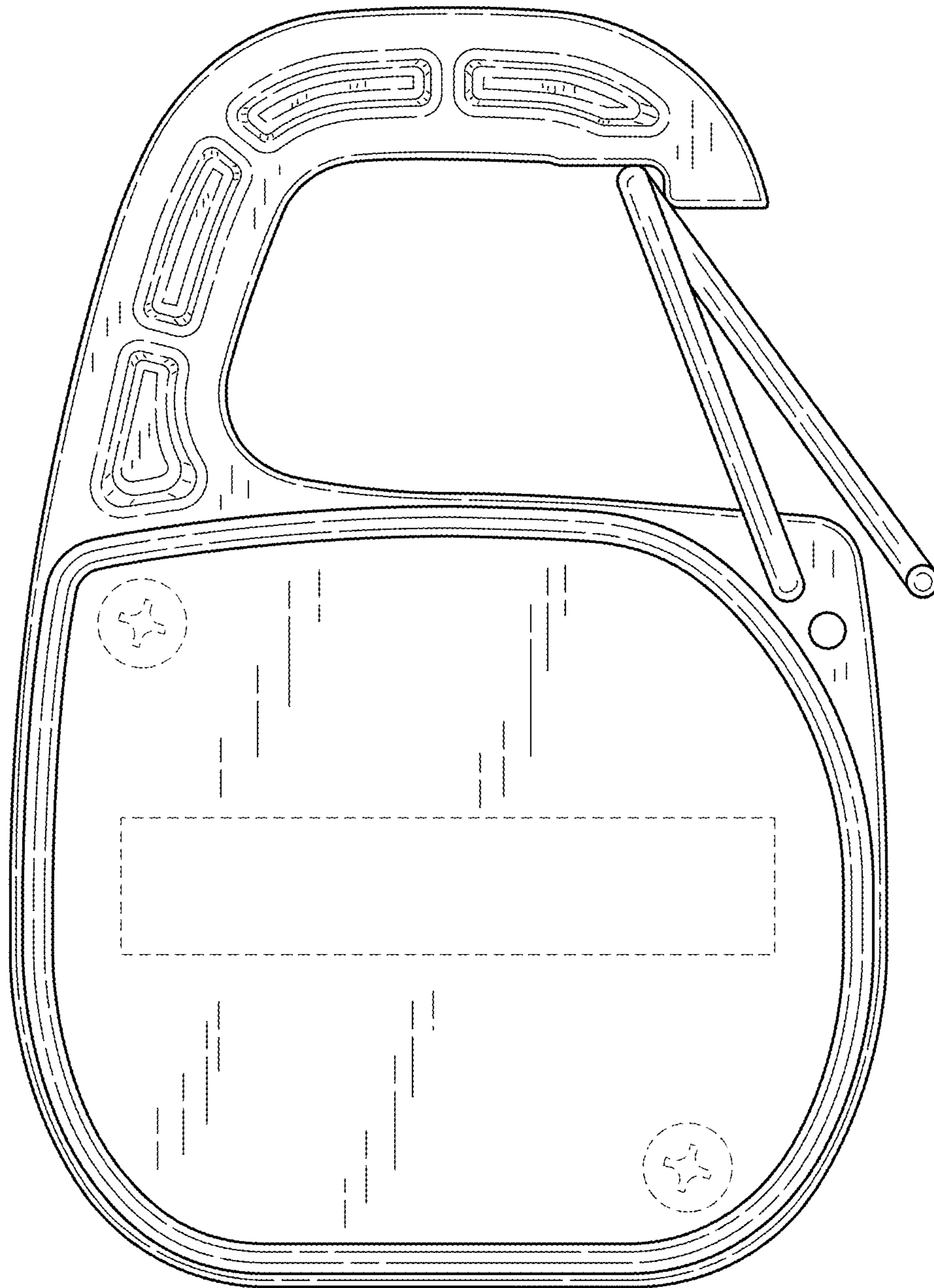

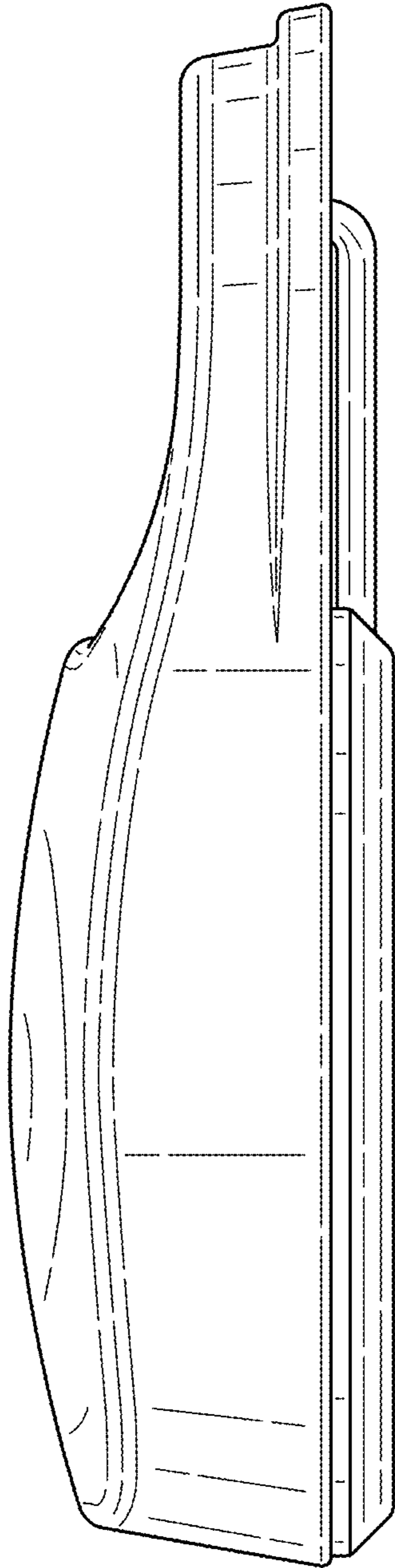

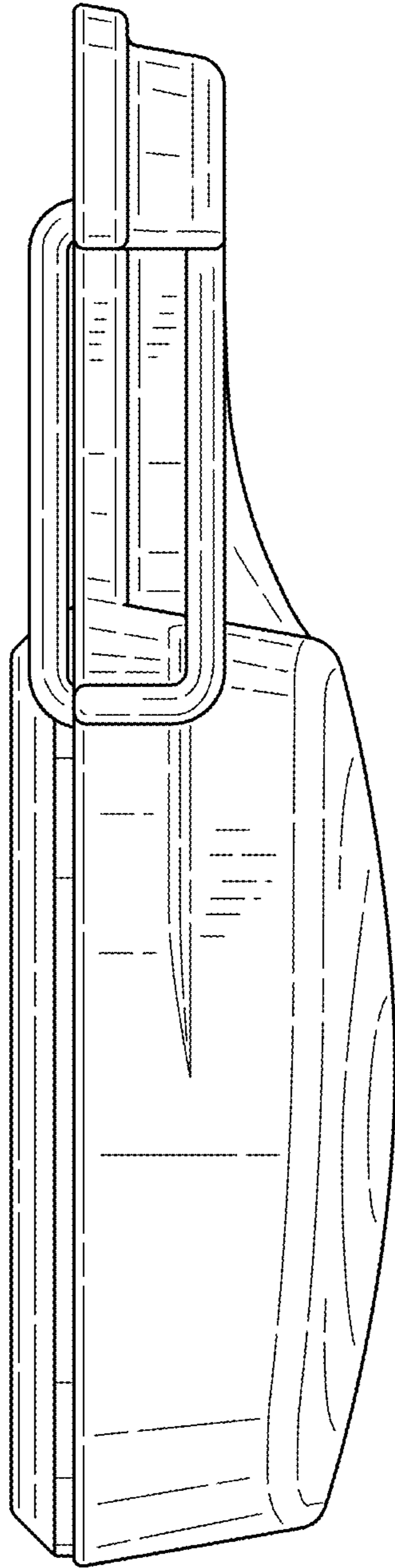

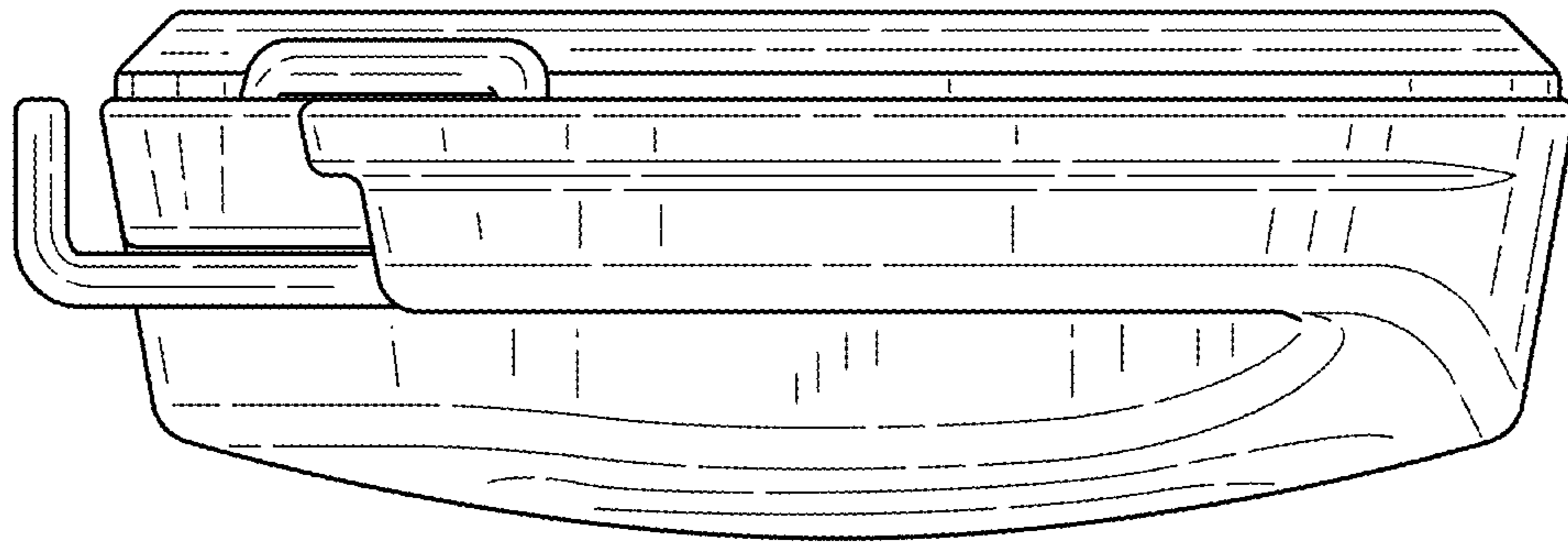

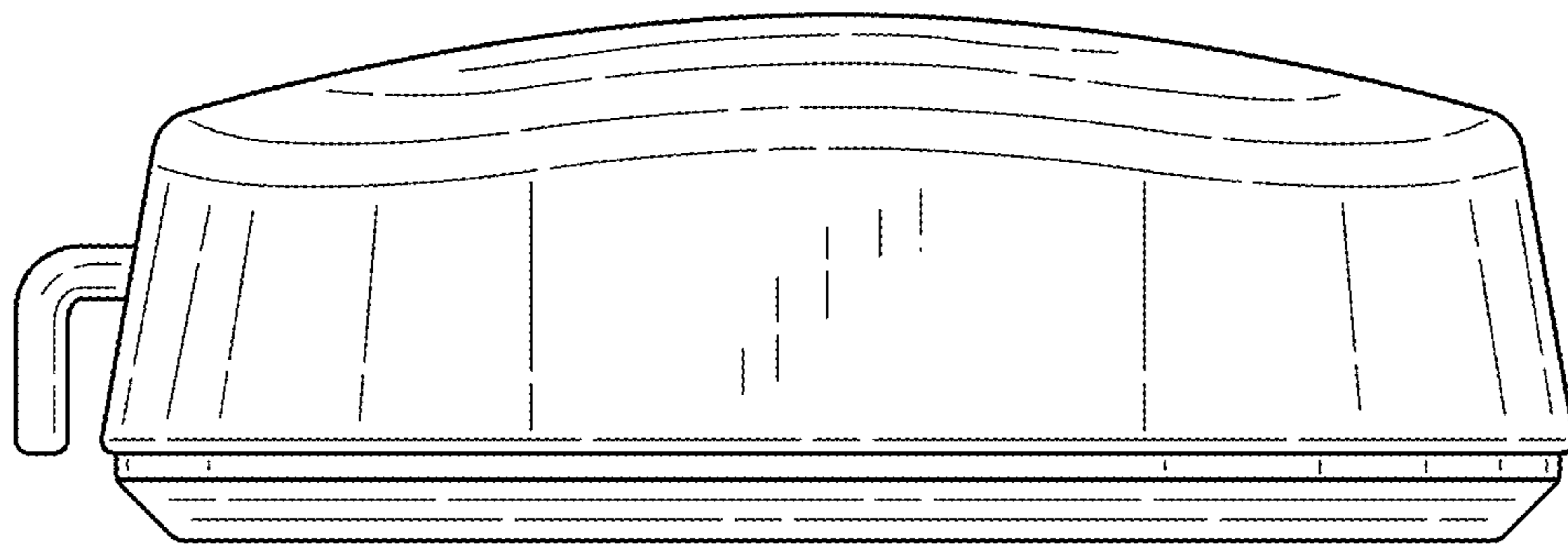
