FIG. 17 shows an enlarged detail front elevation view of the tip portion thereof; and,

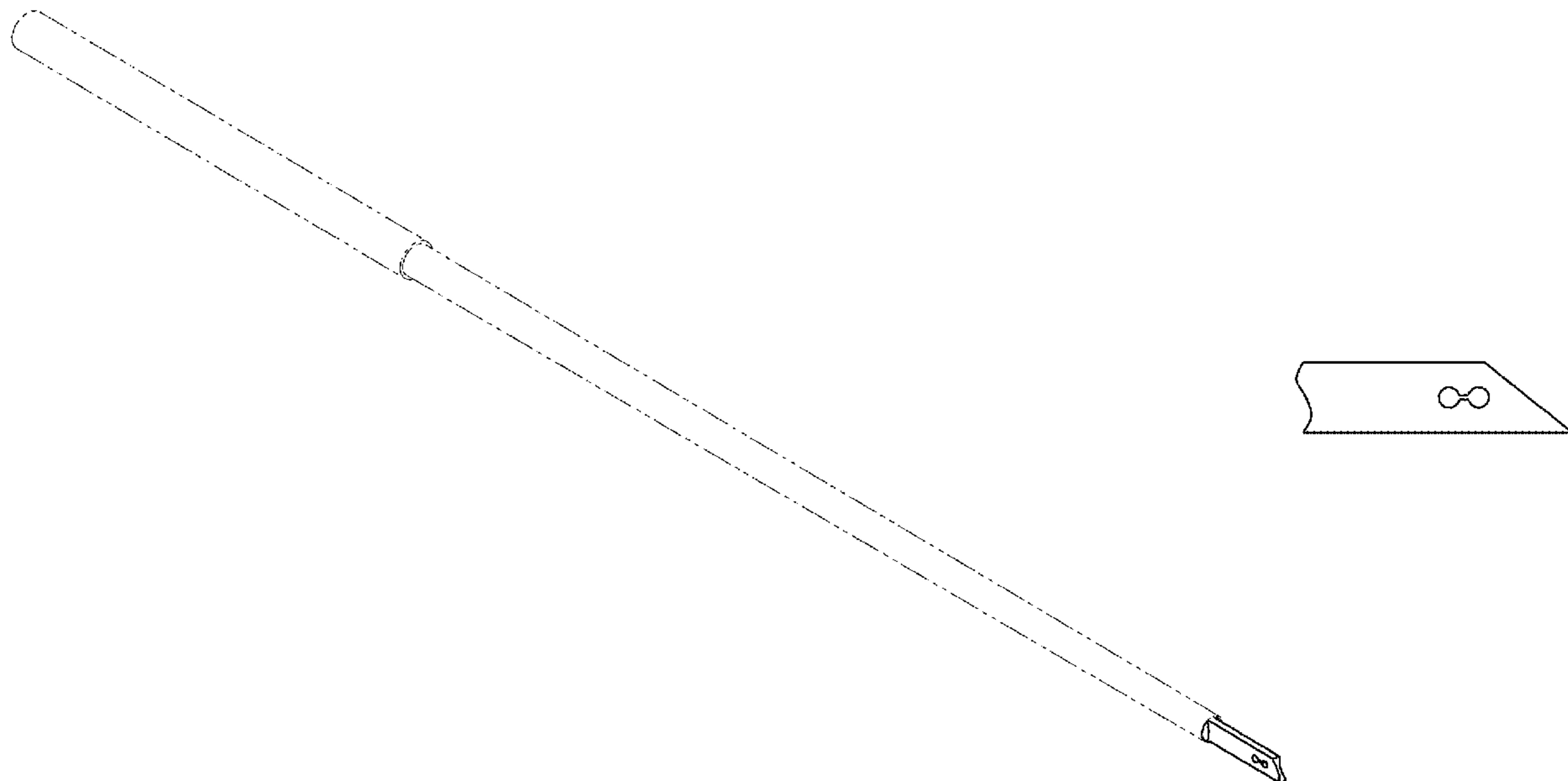
FIG. 18 shows an enlarged detail right side elevation view of the tip portion thereof.

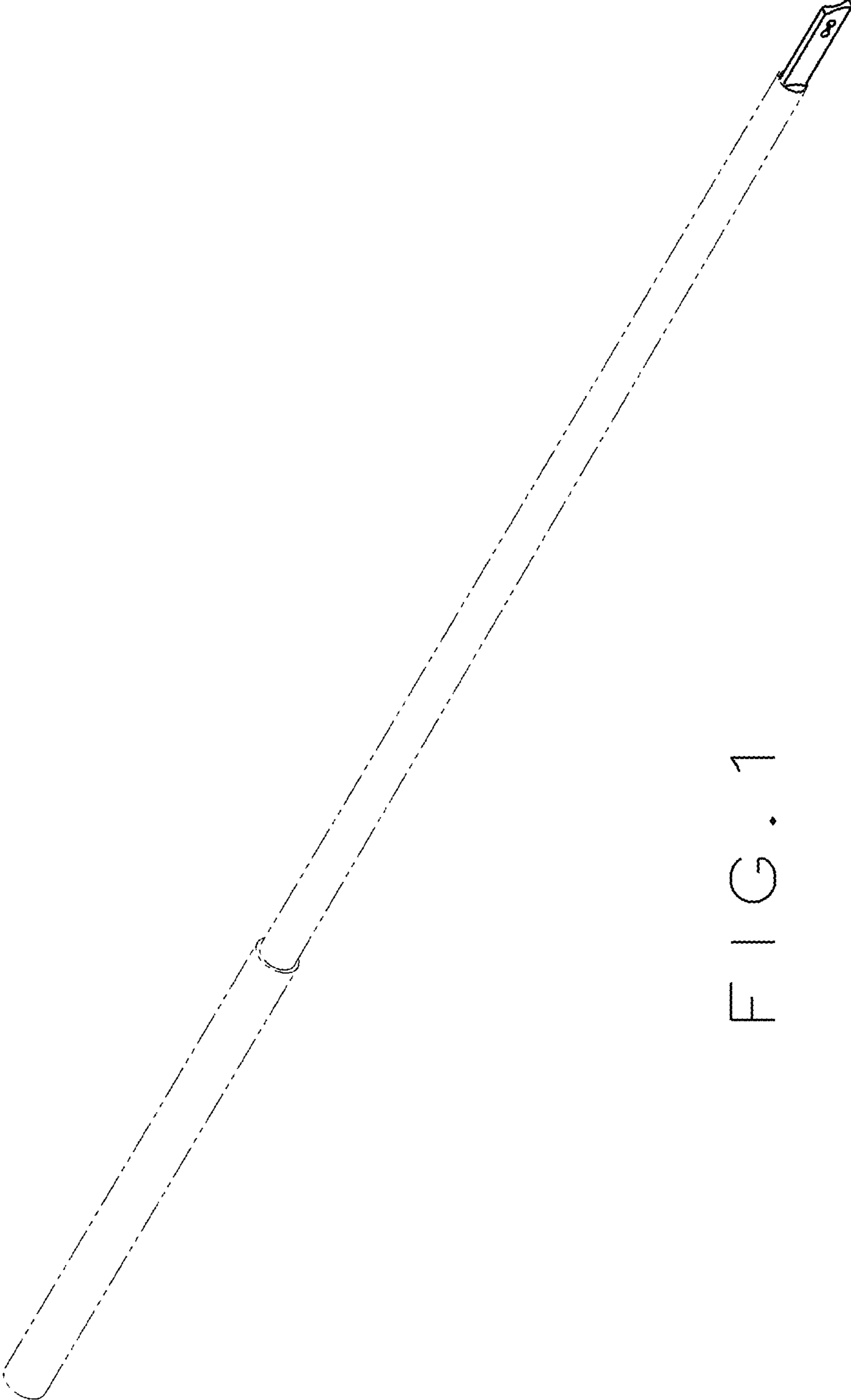

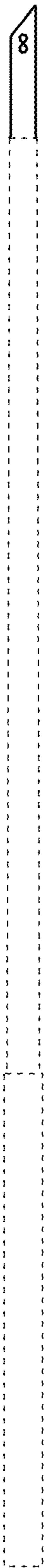

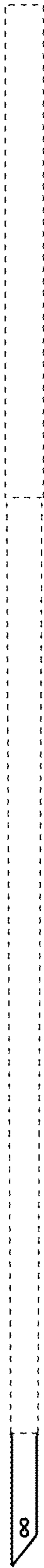

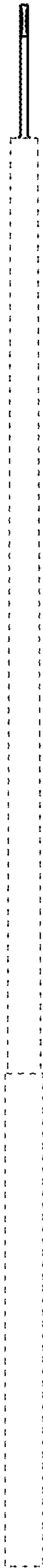

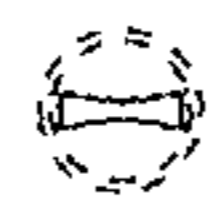

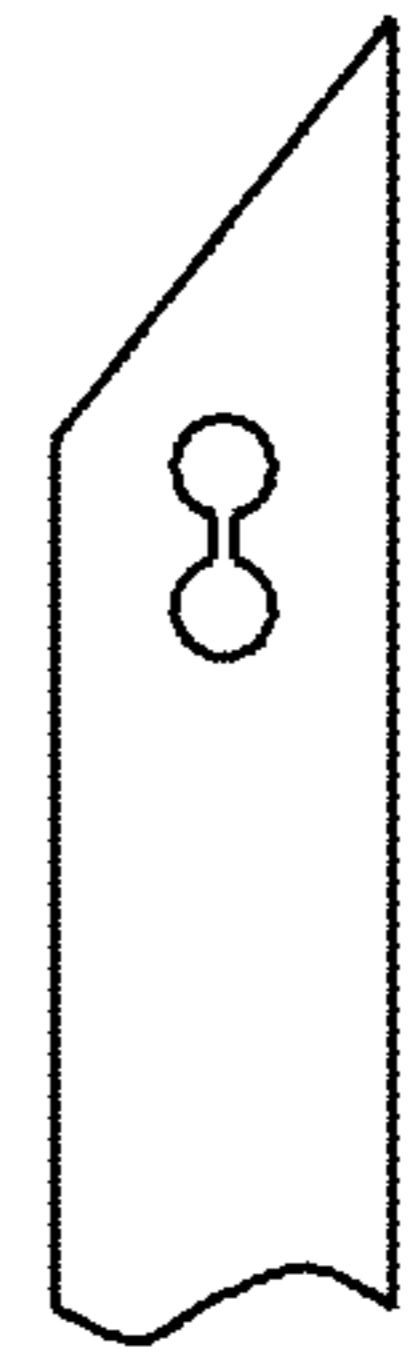

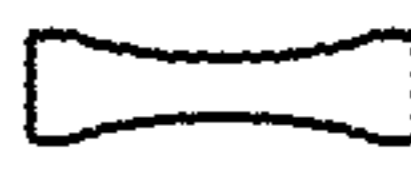

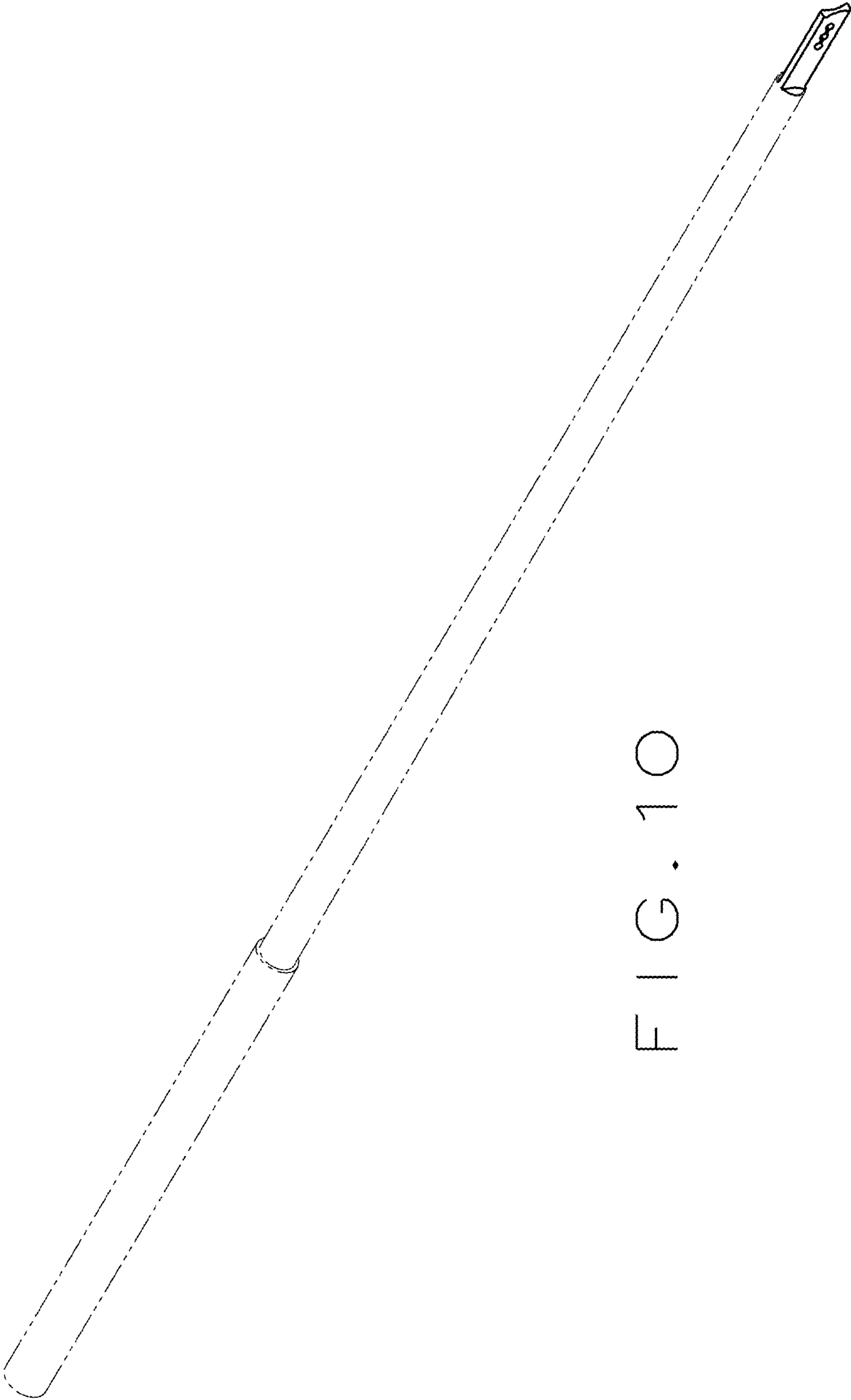

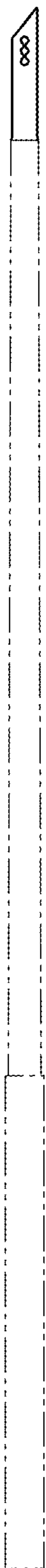

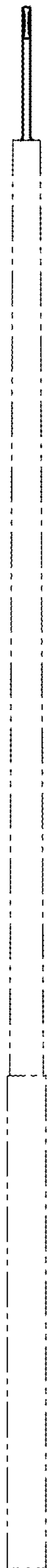

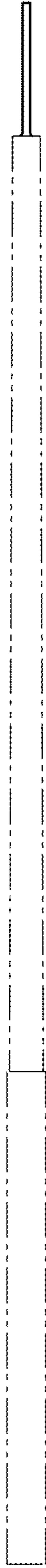

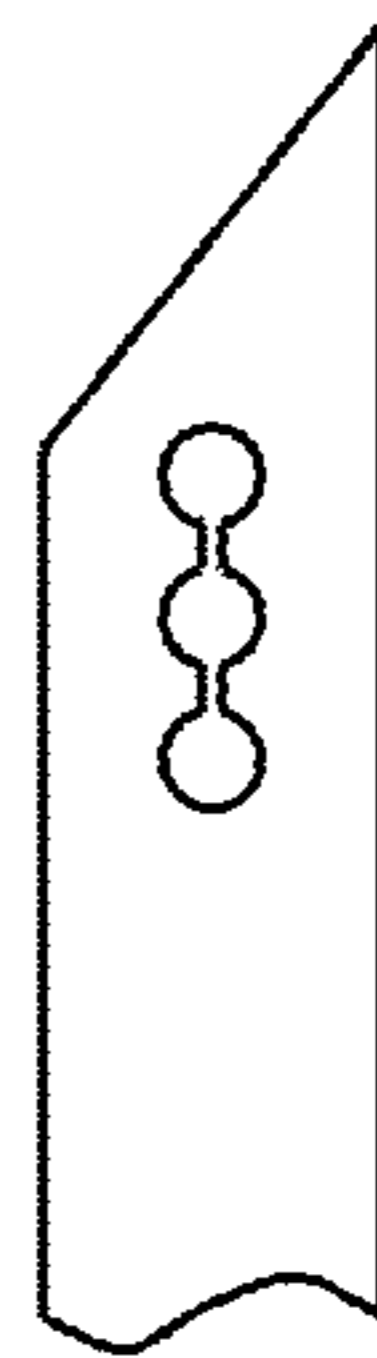

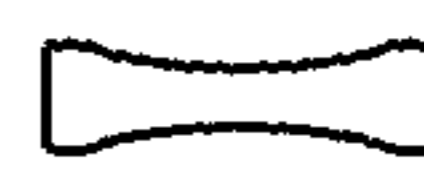
