(57) **CLAIM**

The ornamental design for a spherical lid, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a spherical lid showing my new design;

FIG. 14 is a bottom view thereof;

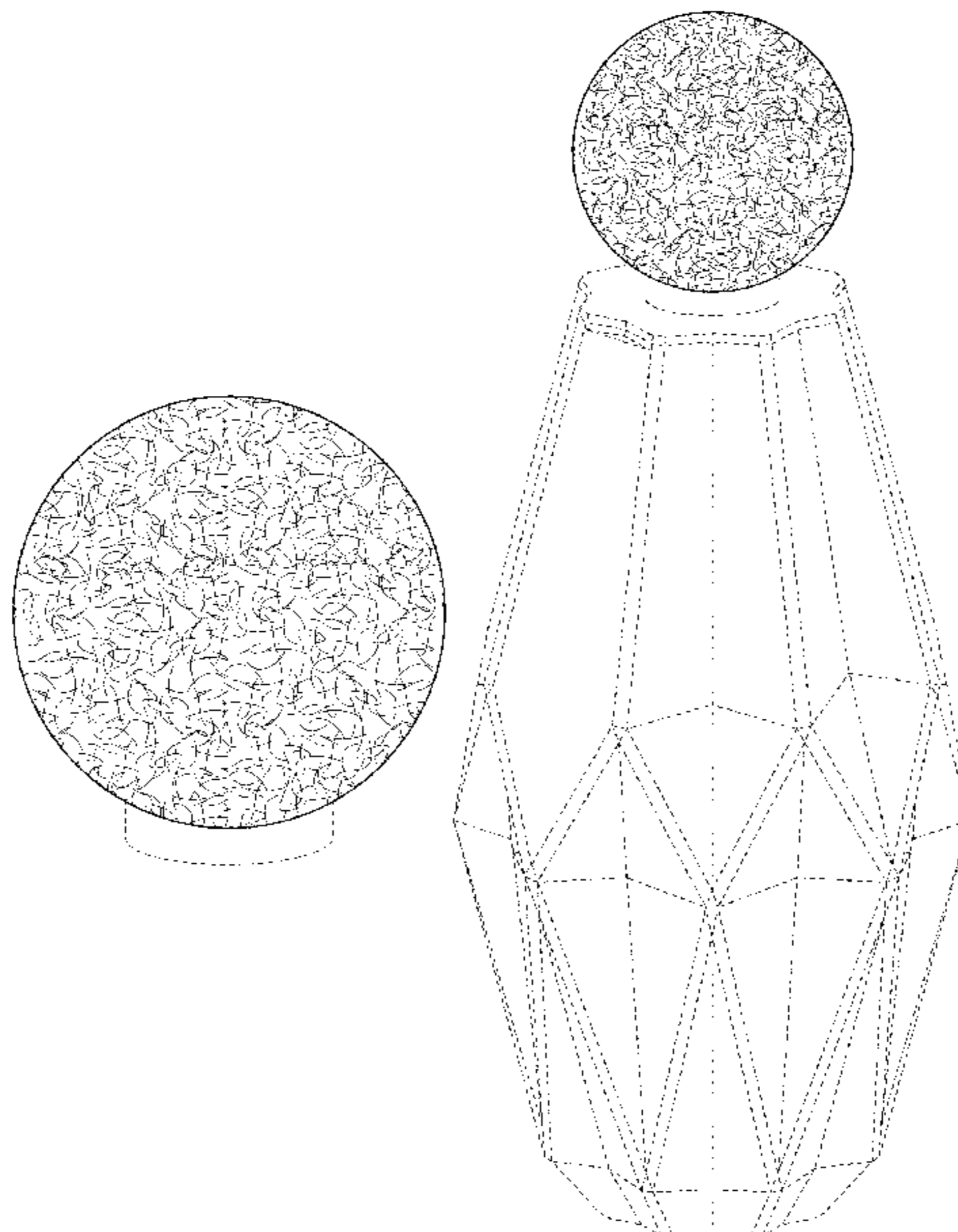
FIG. 15 is a front perspective view of the spherical lid shown in FIG. 8 in the environment of a lipstick case; and,

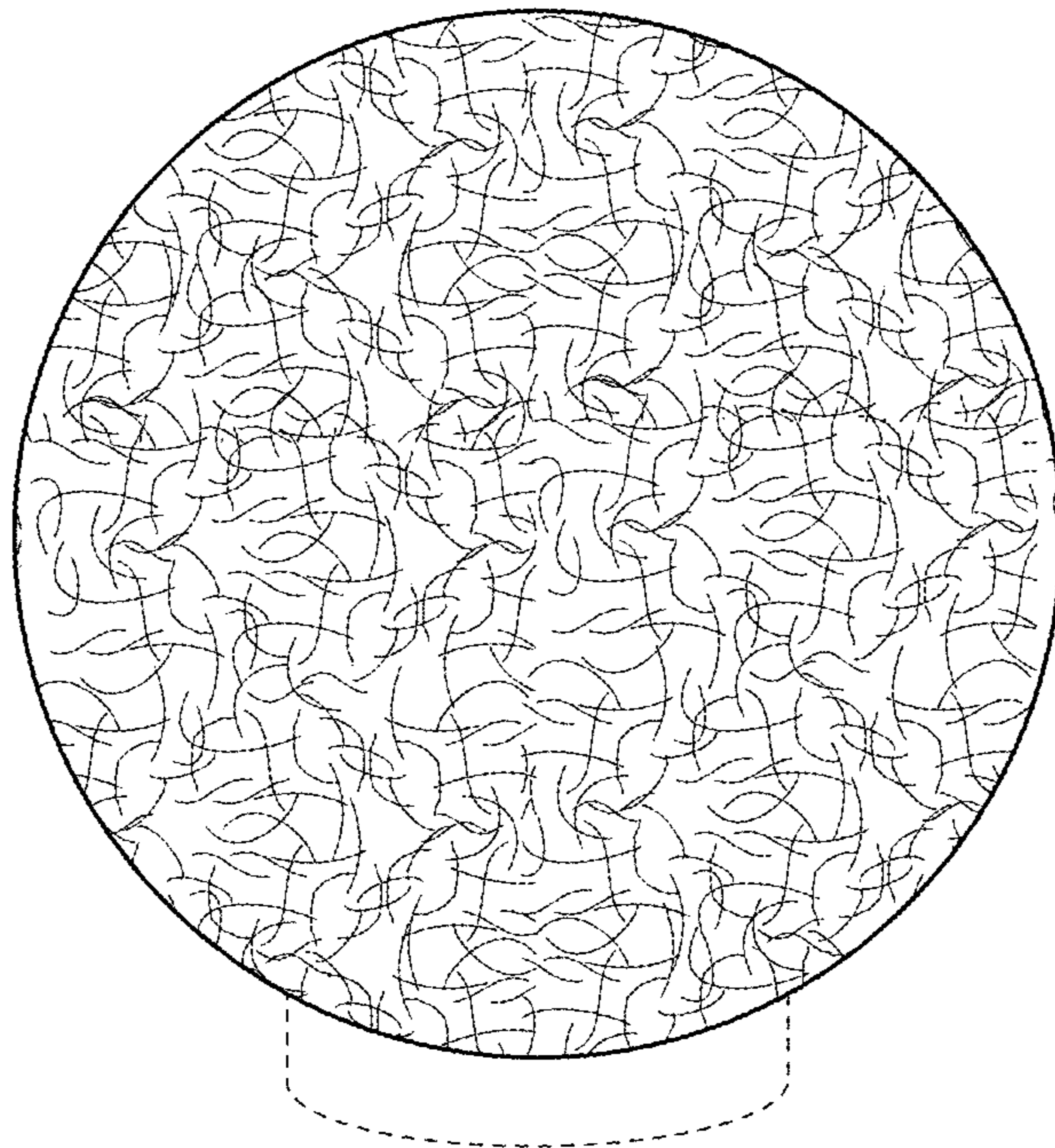

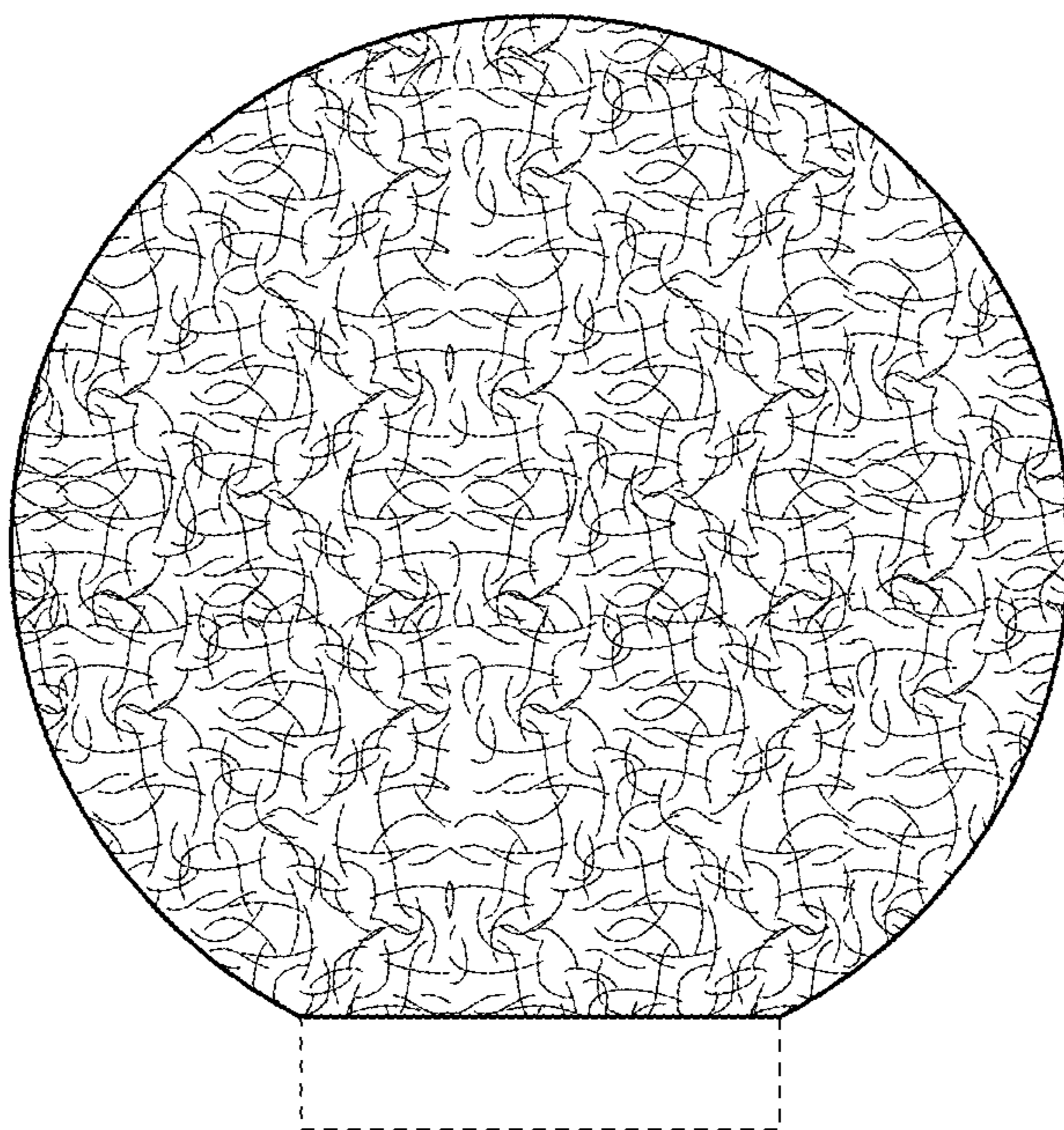

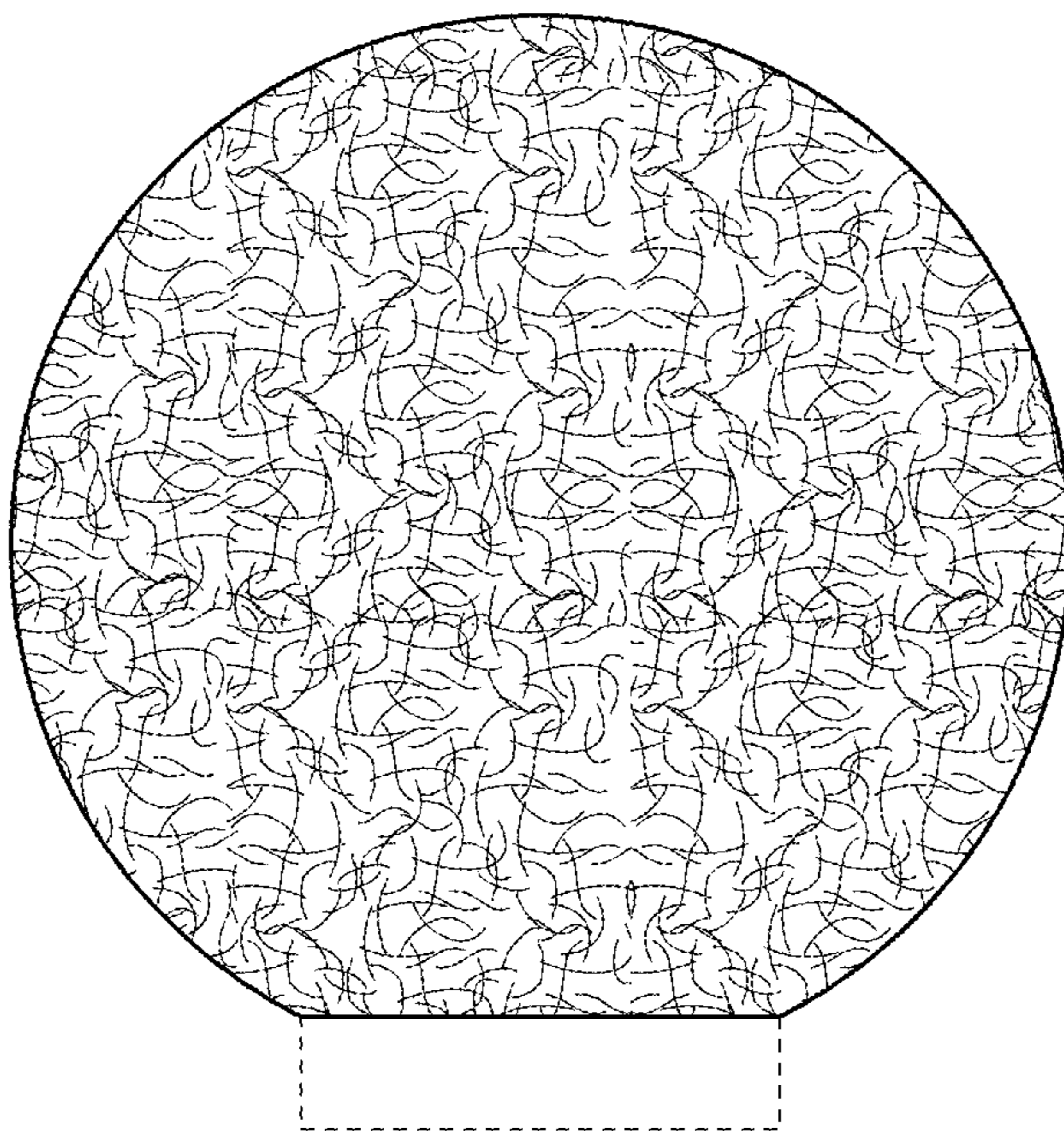

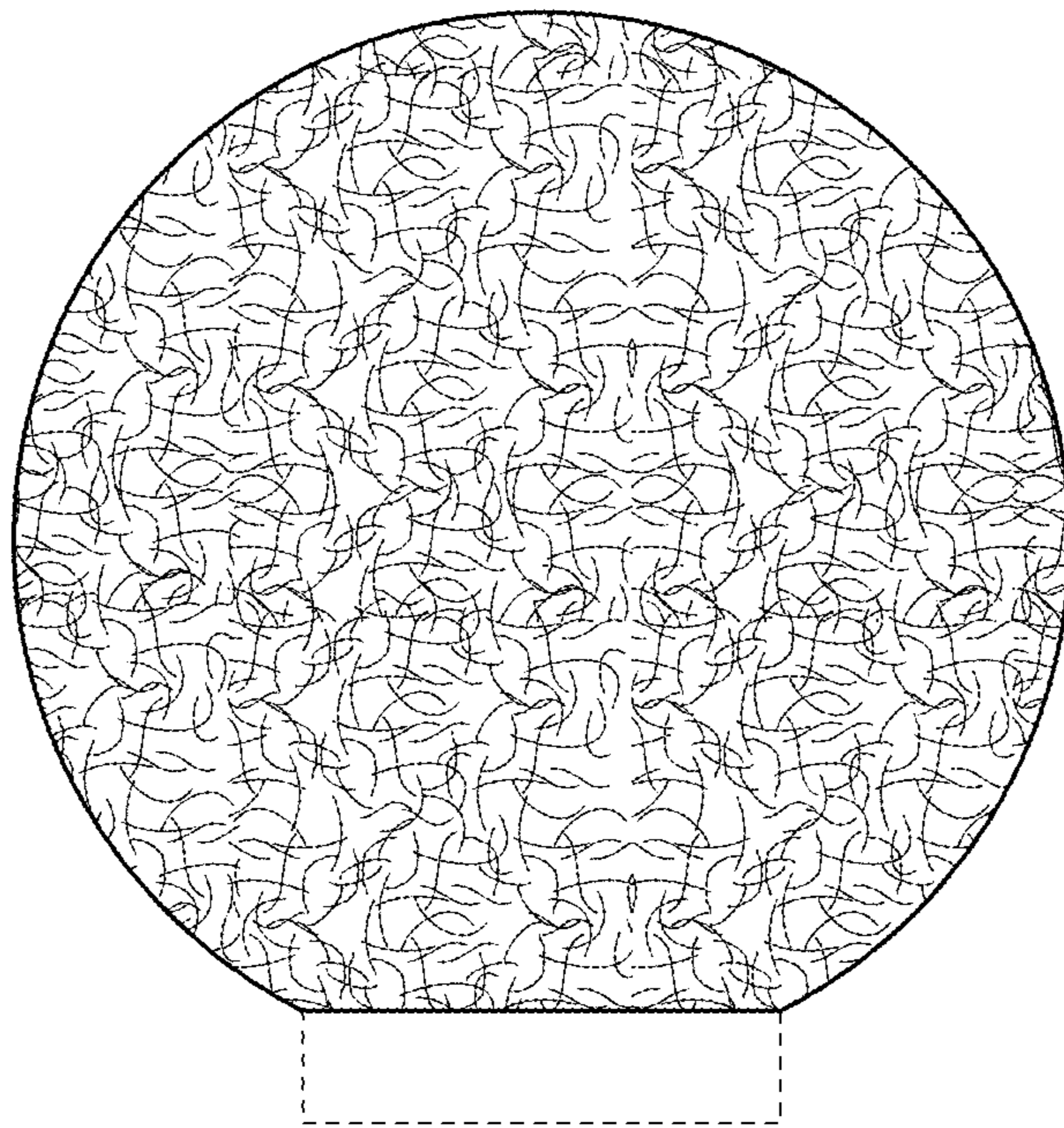

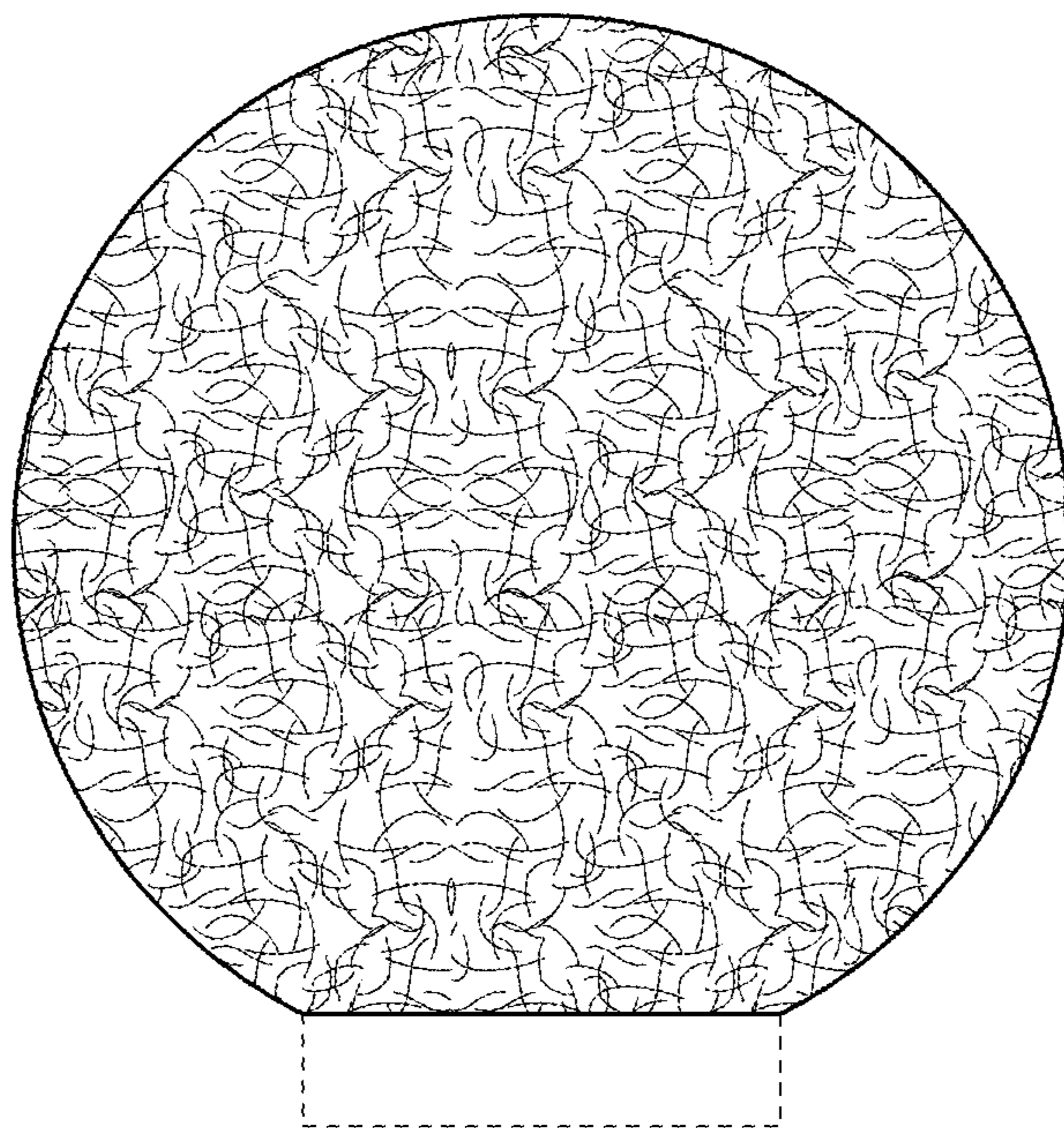

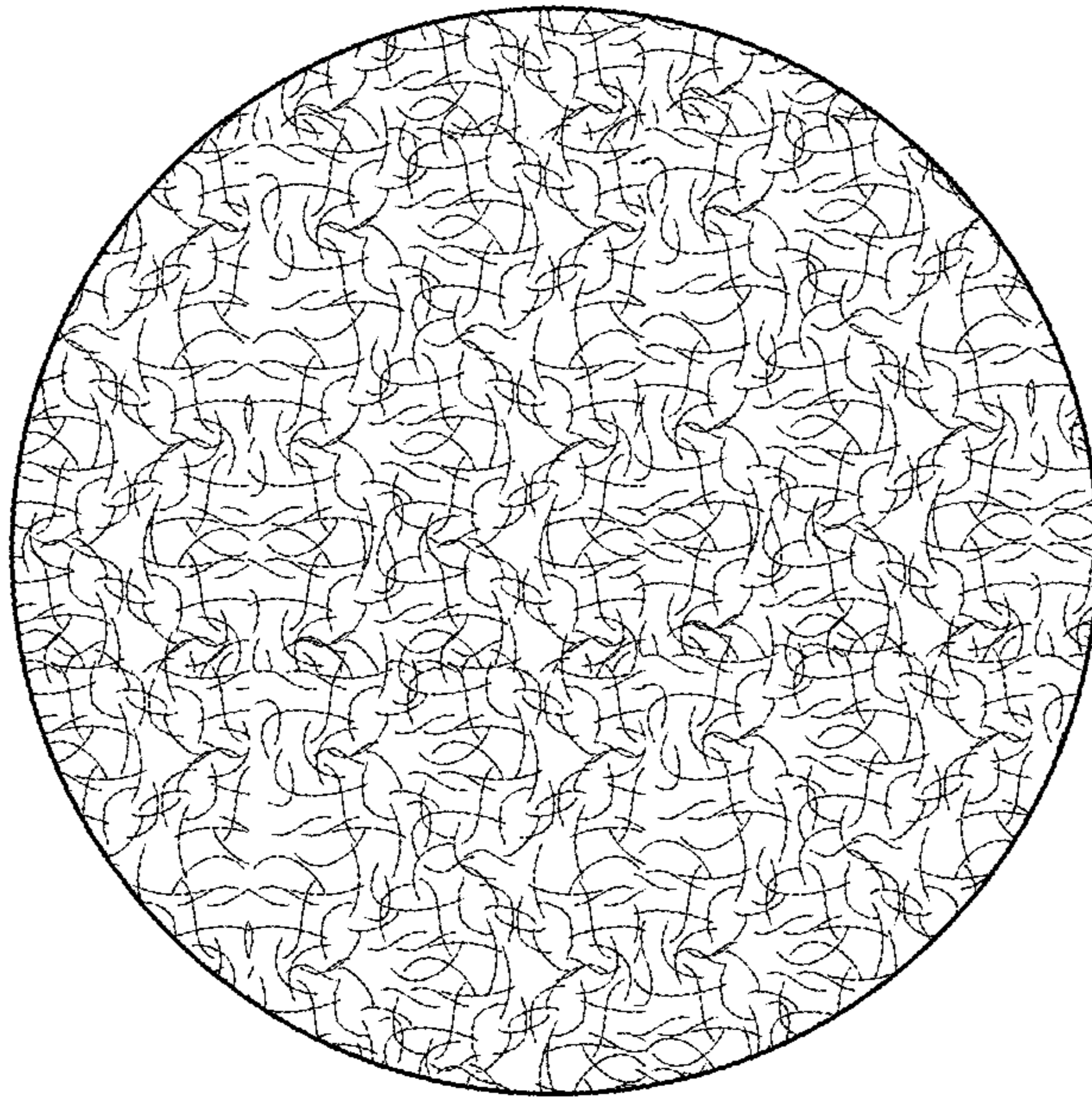

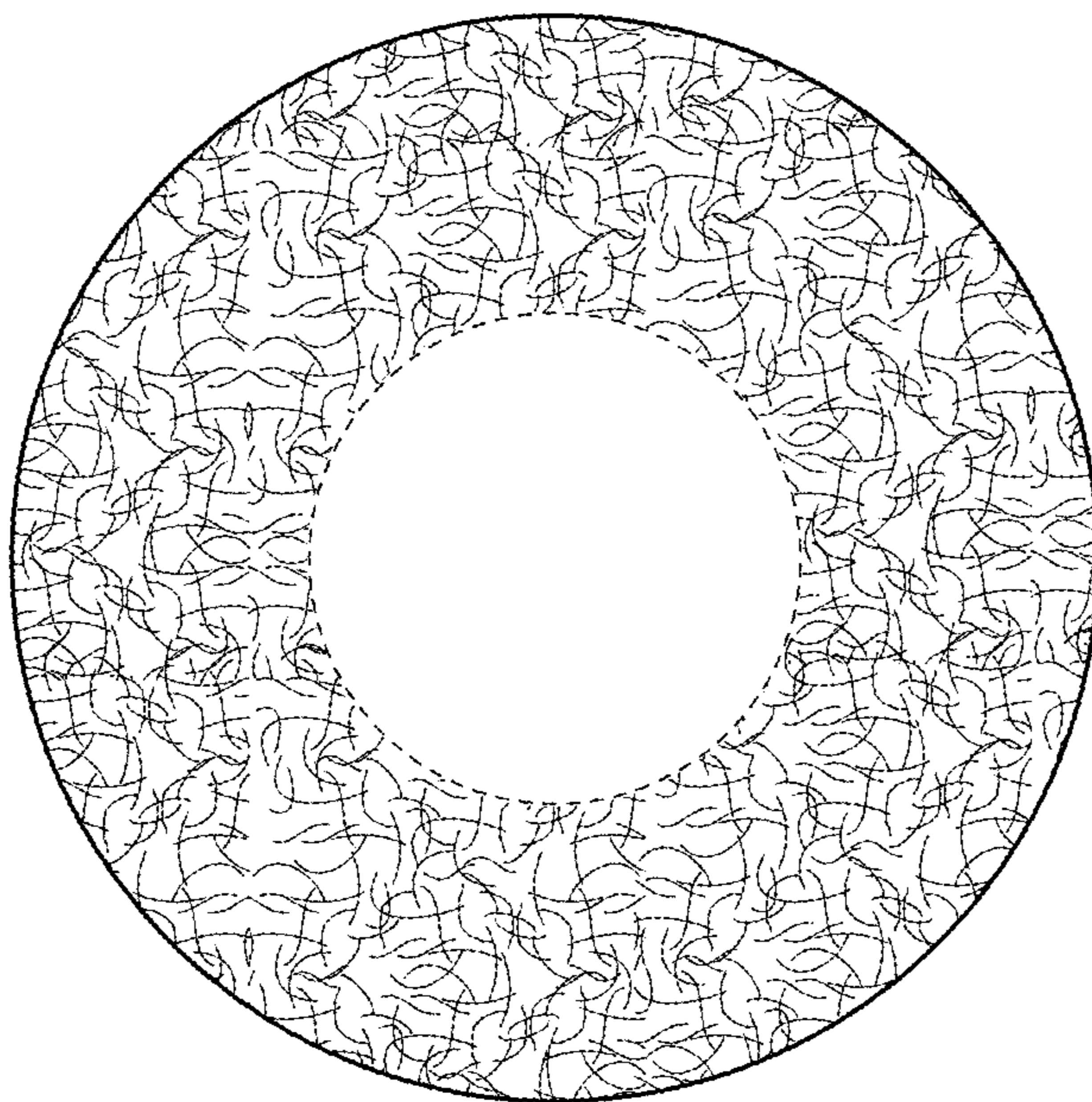

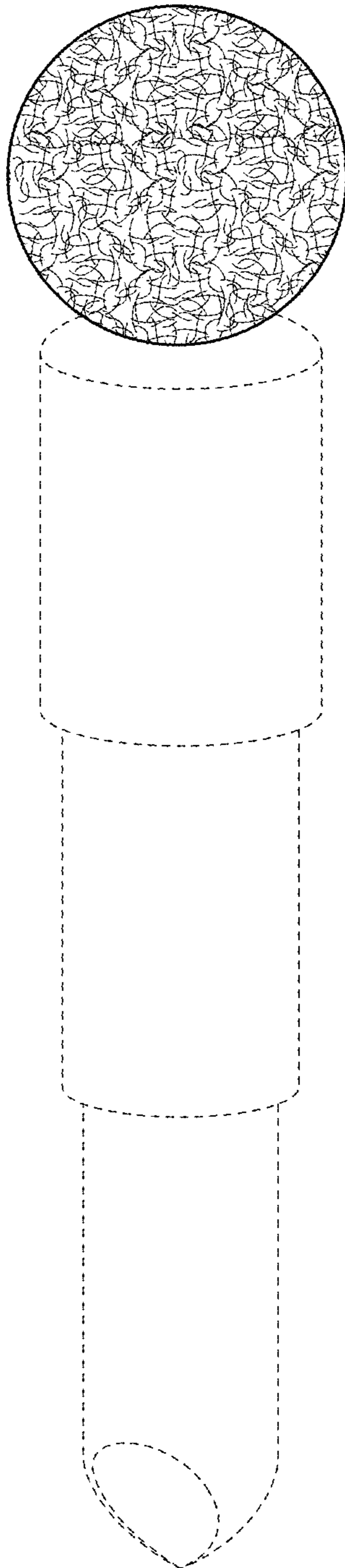

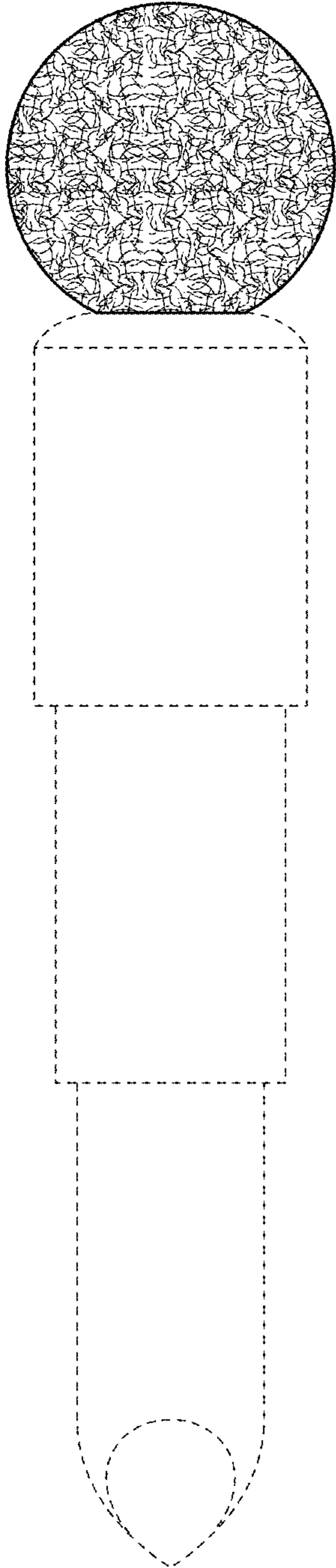

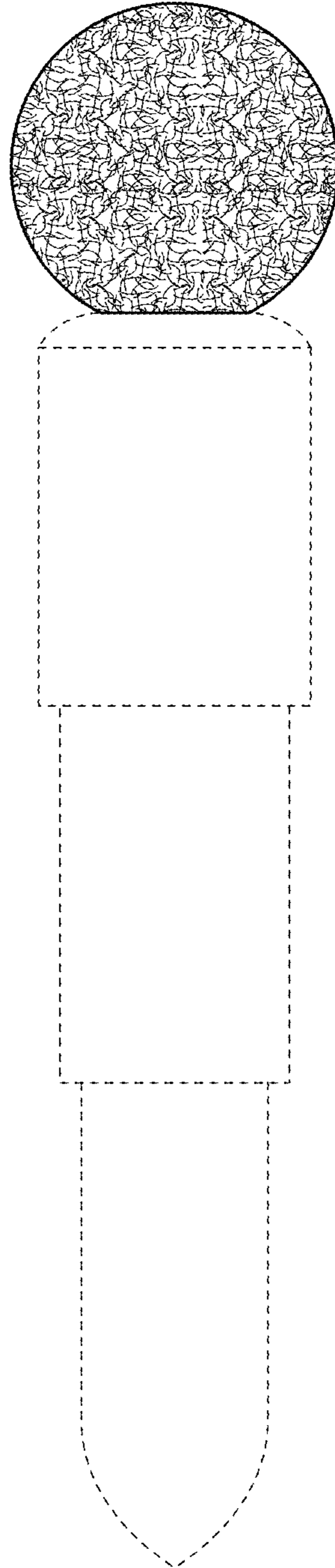

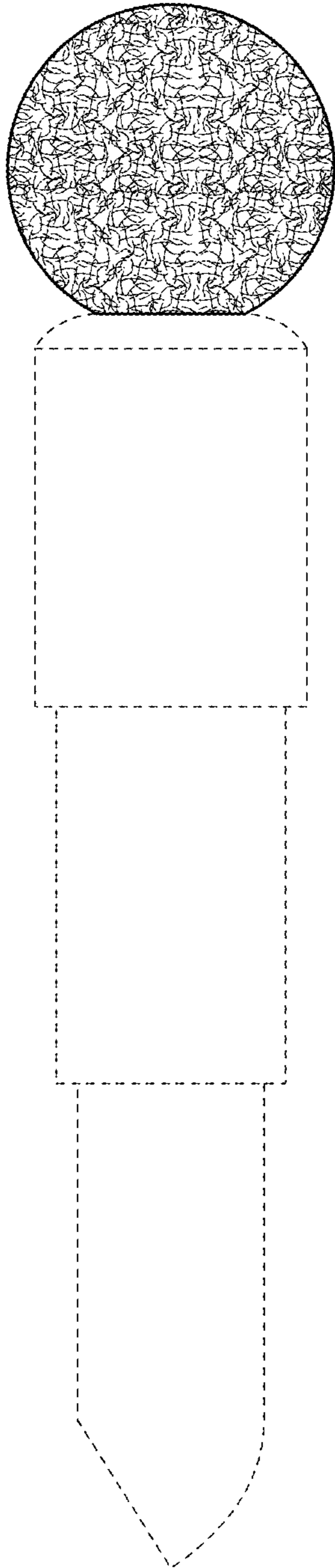

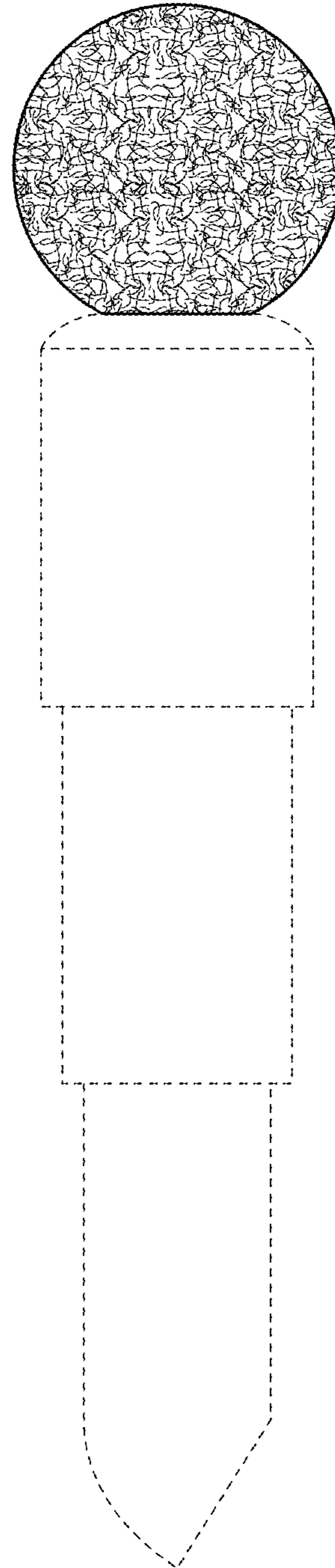

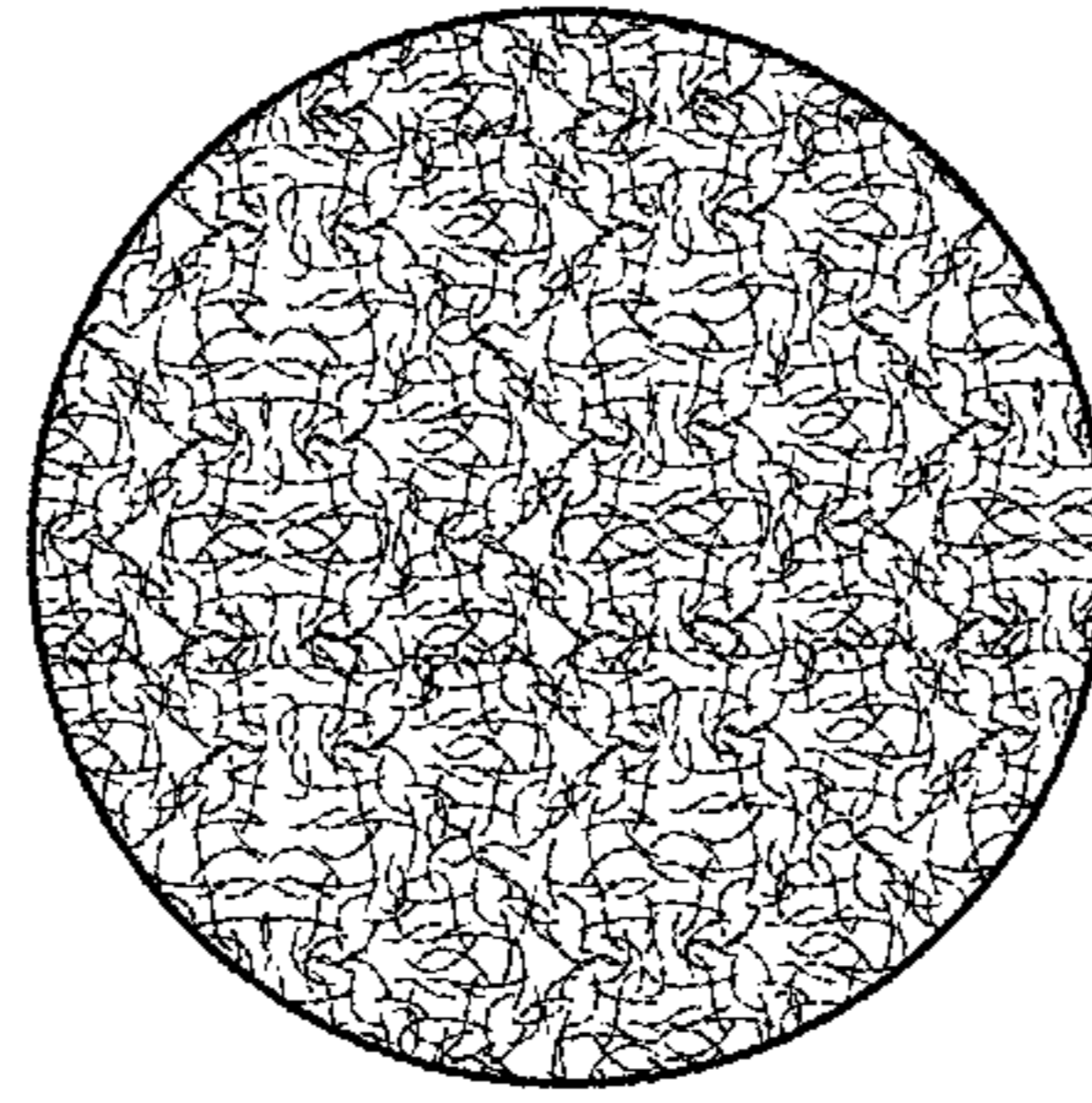

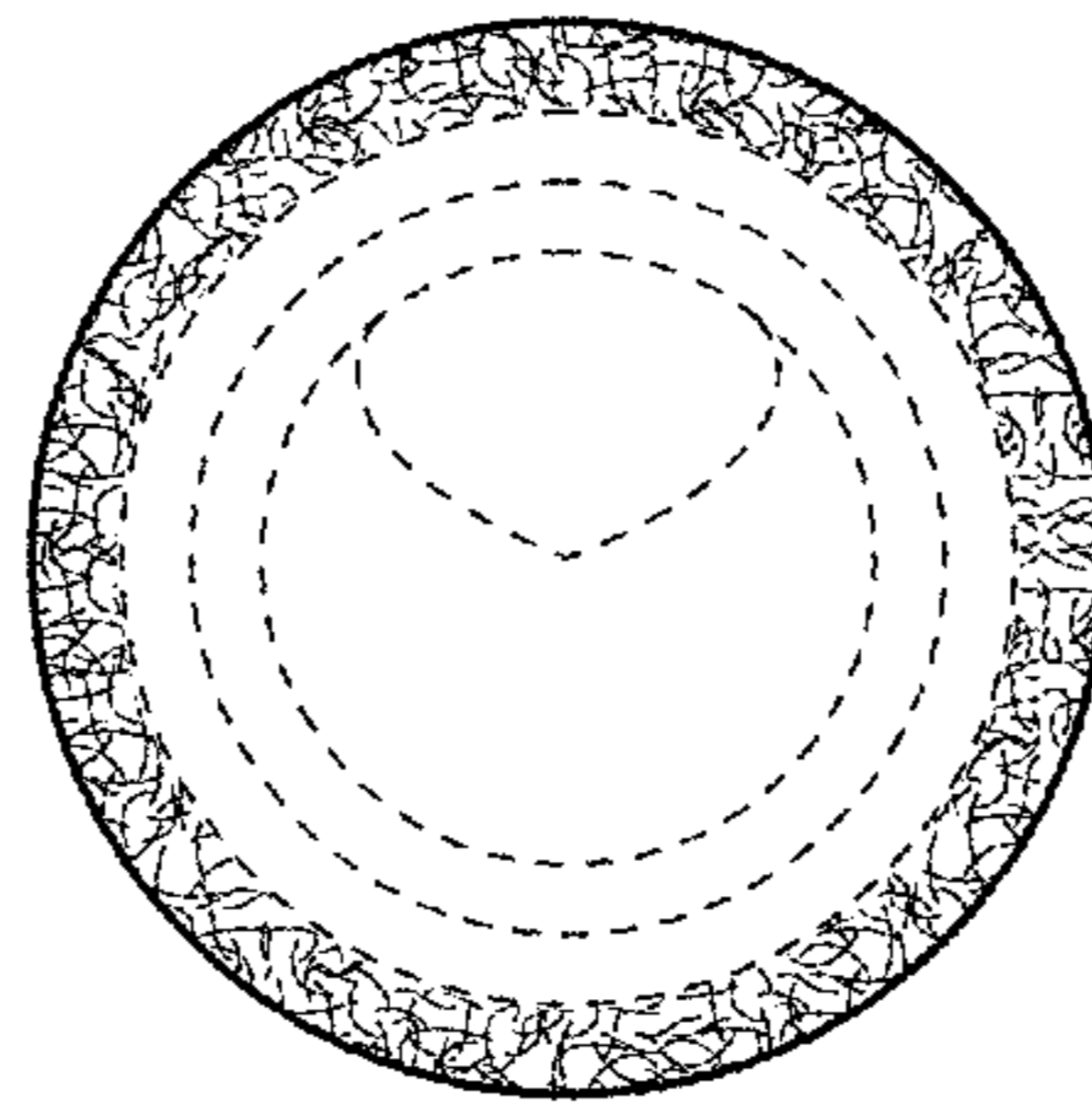

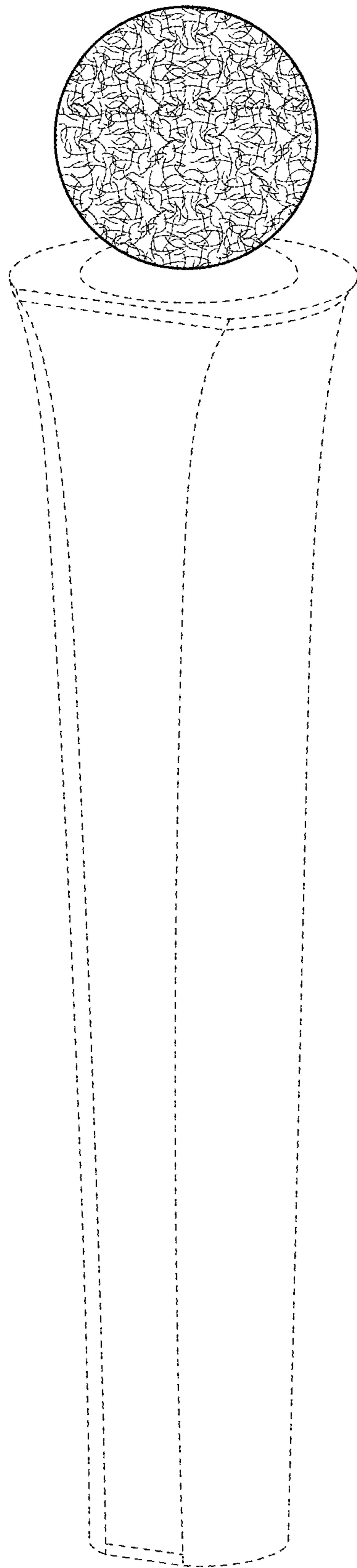

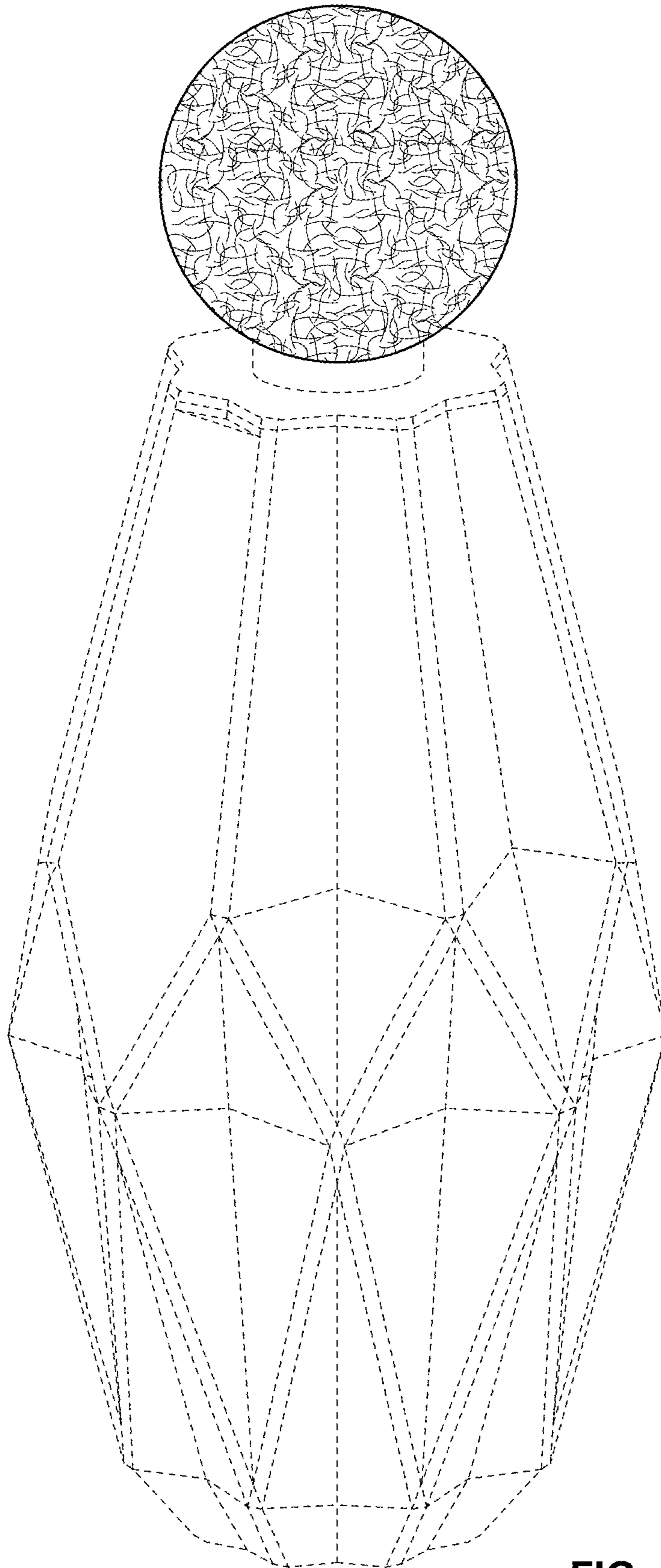
