The ornamental design for a cosmetic container, as shown and described.

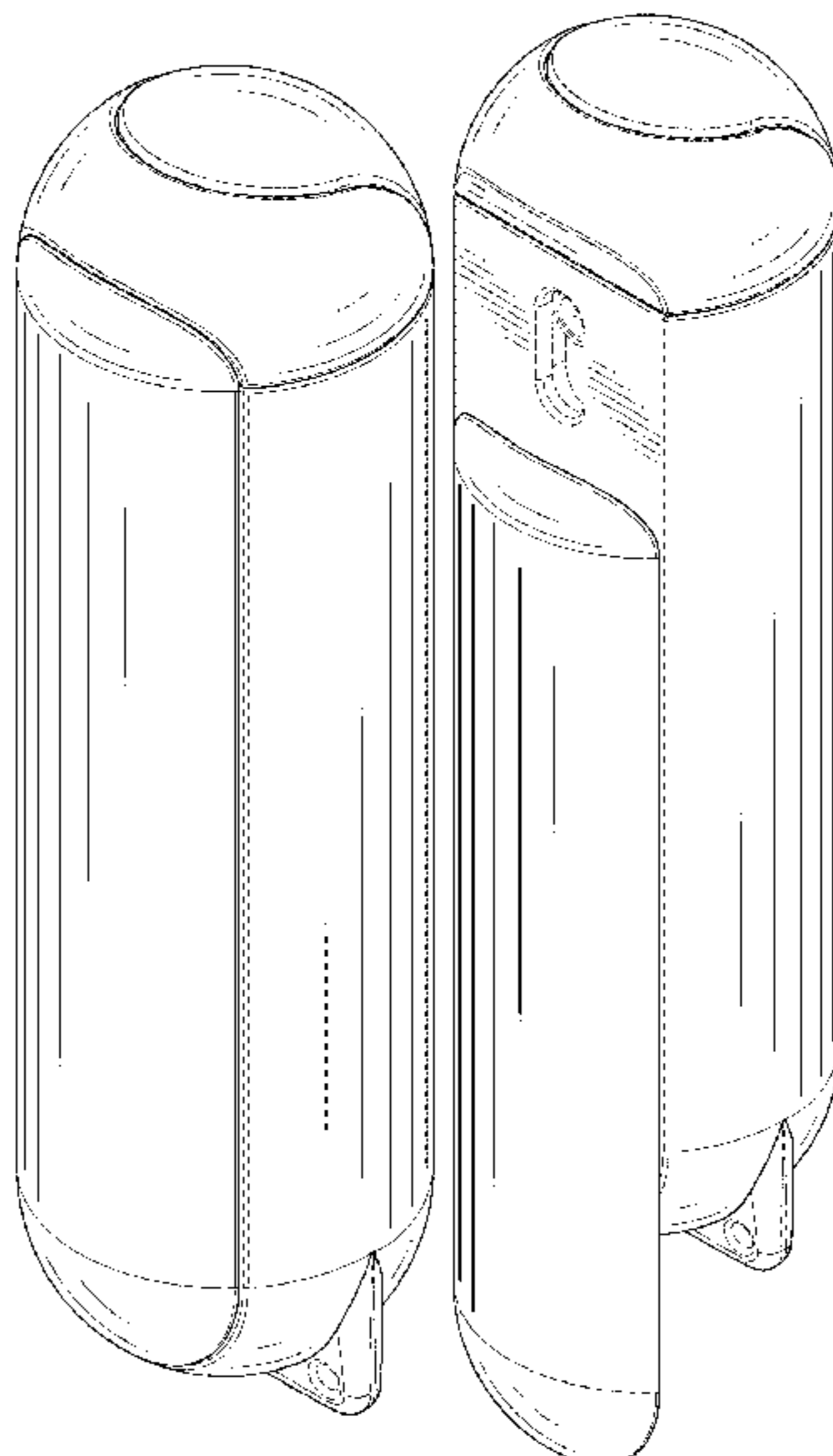
DESCRIPTION

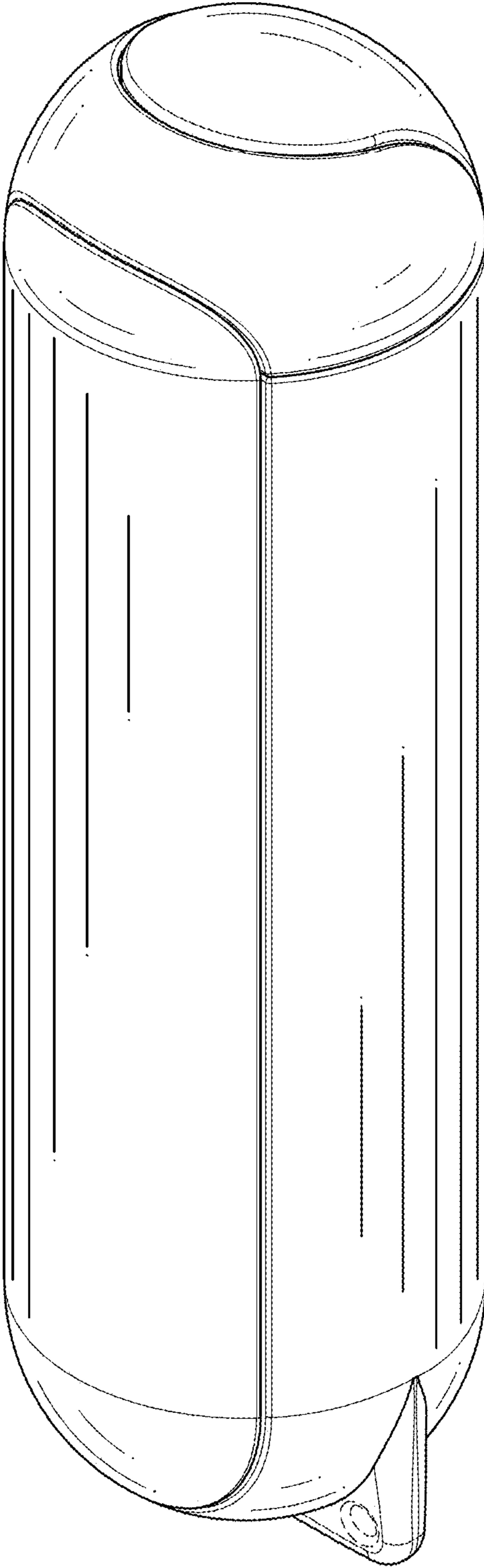

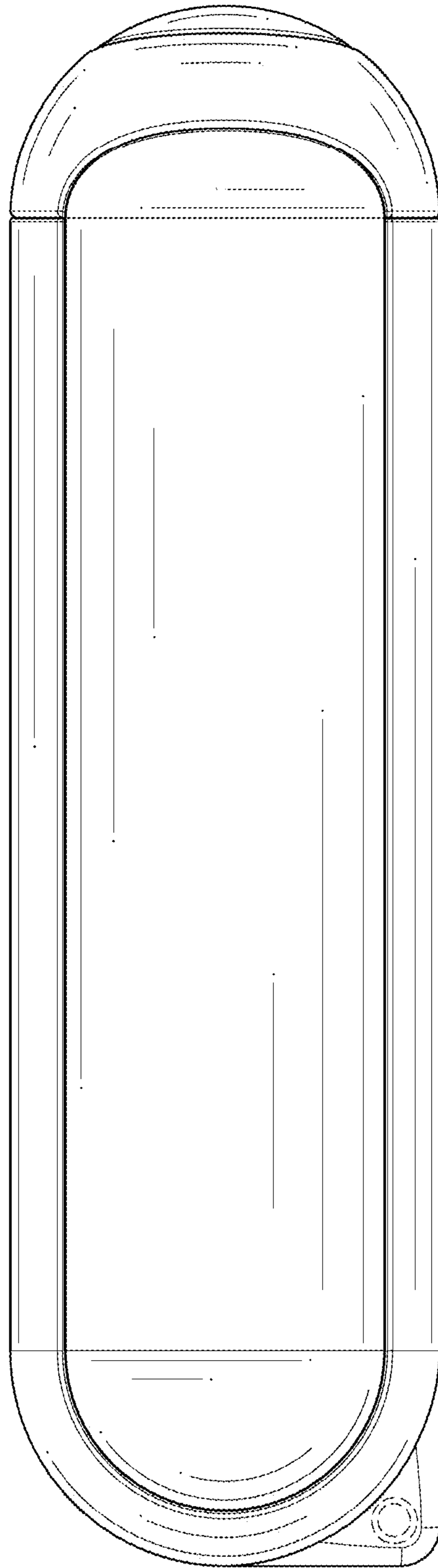

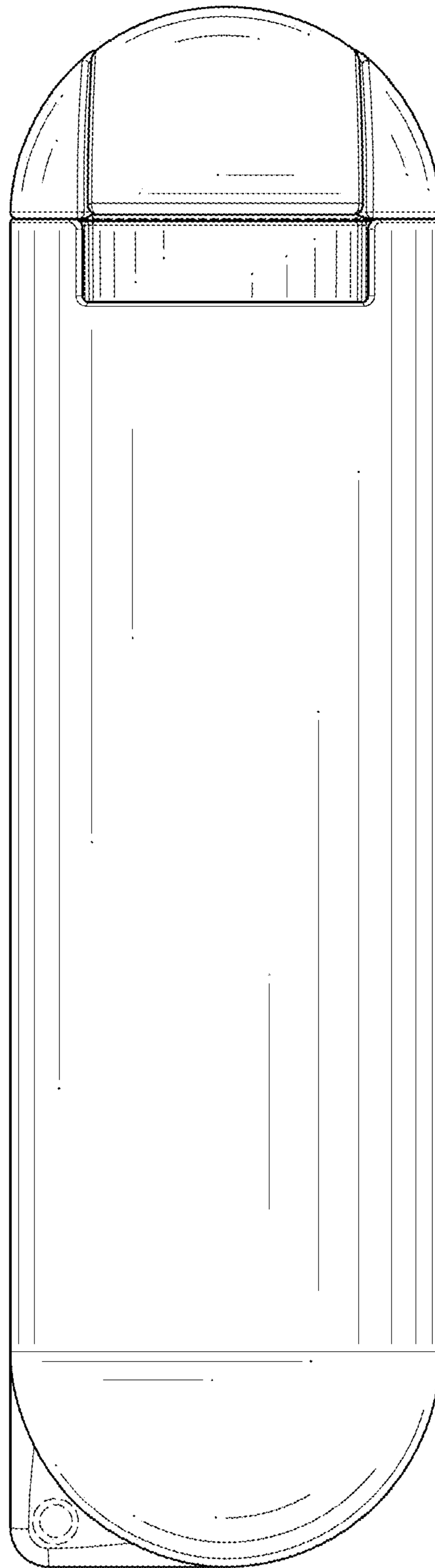

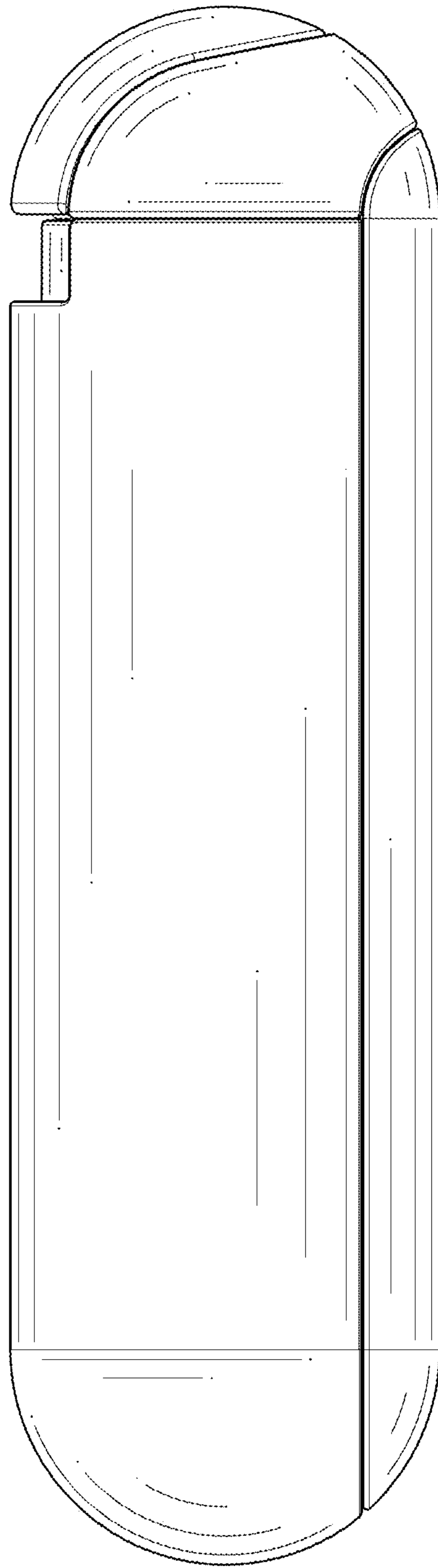

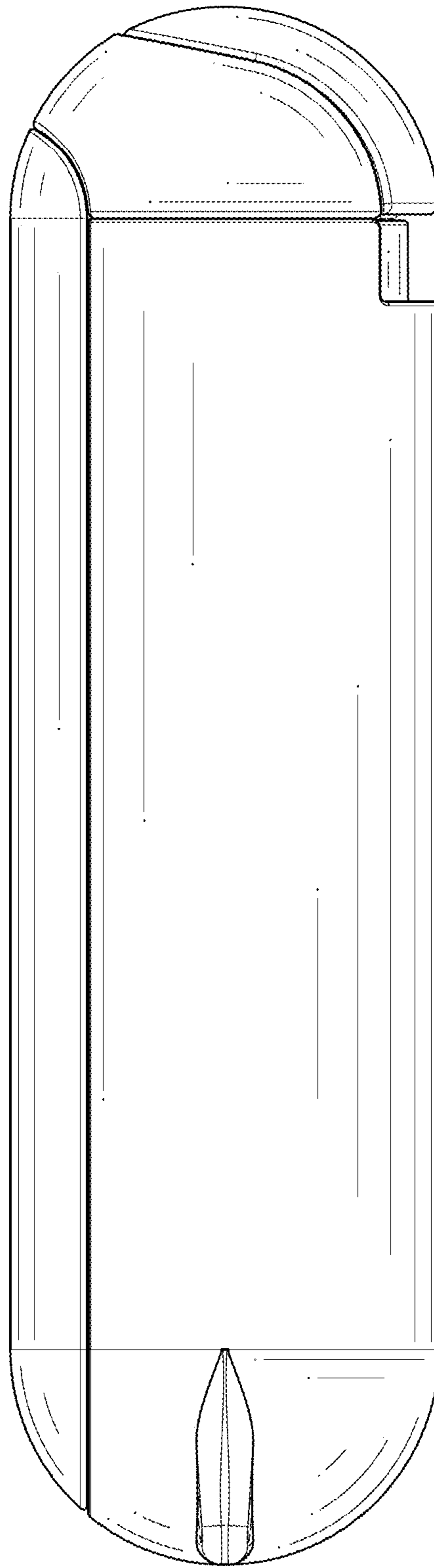

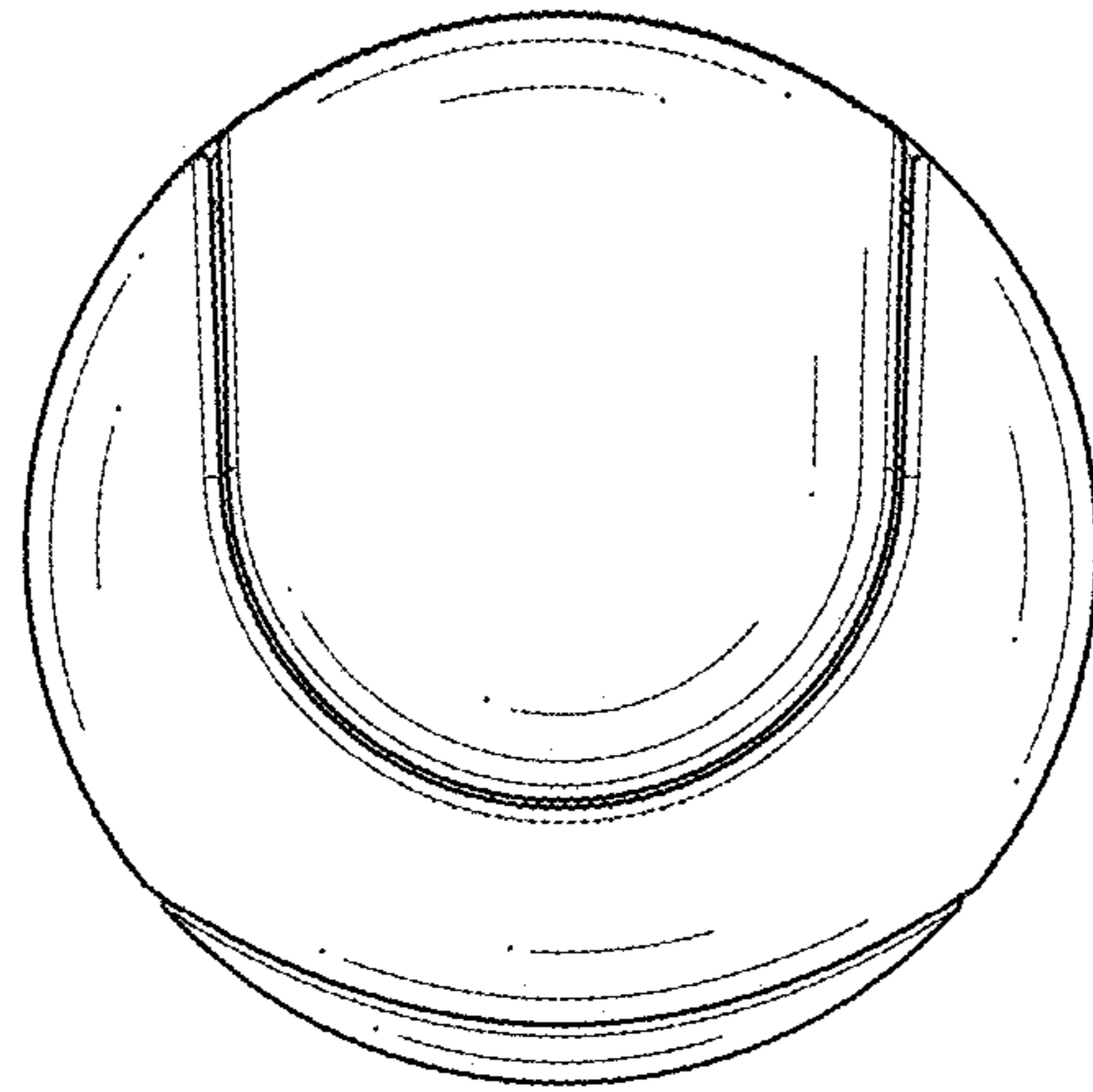

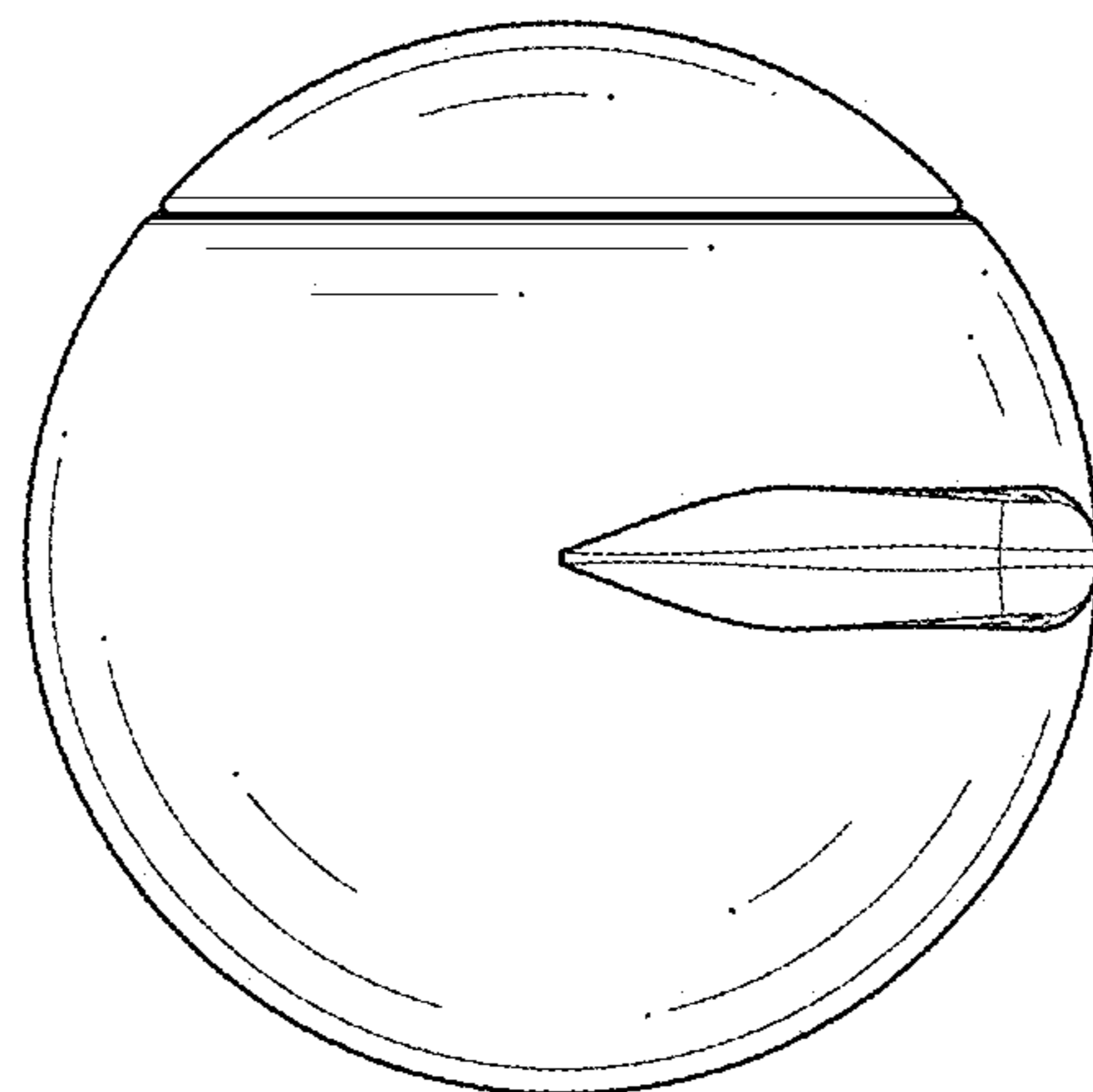

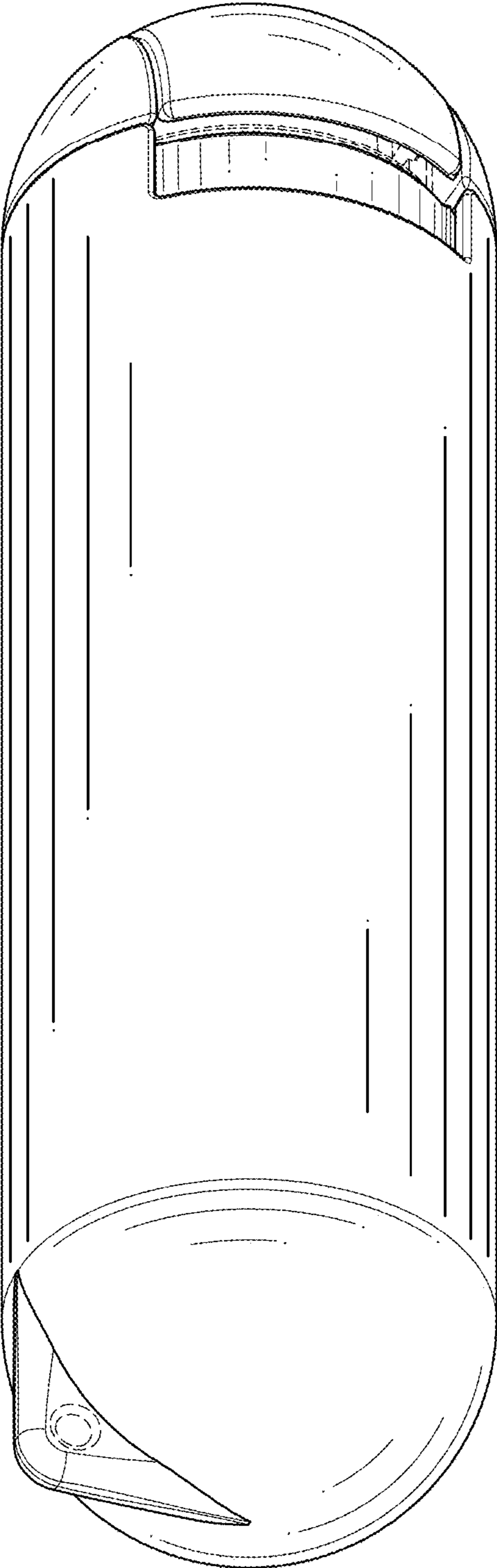

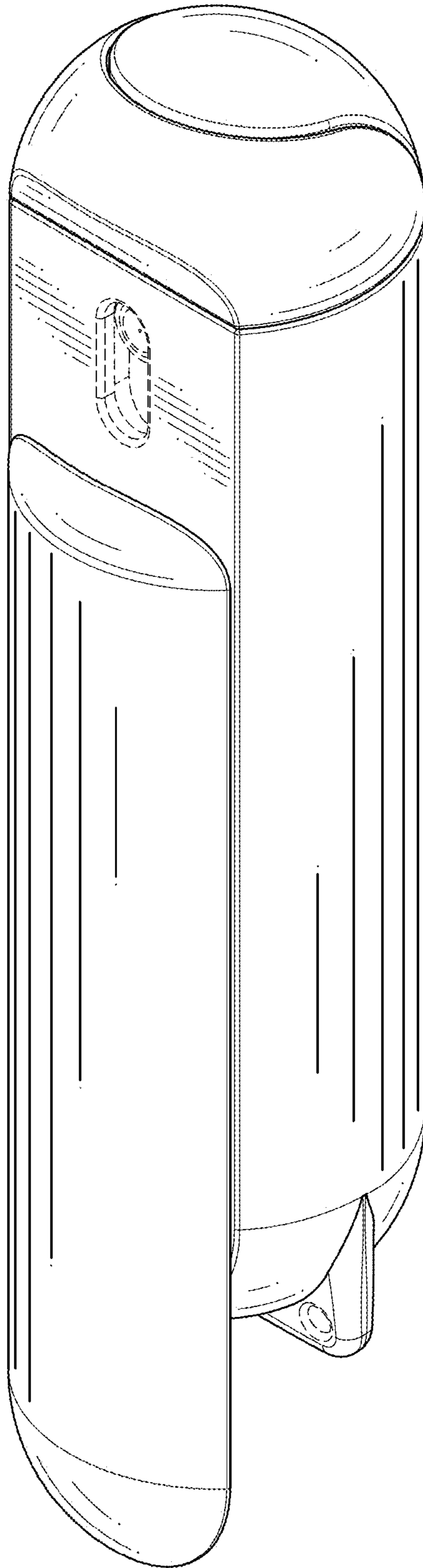
