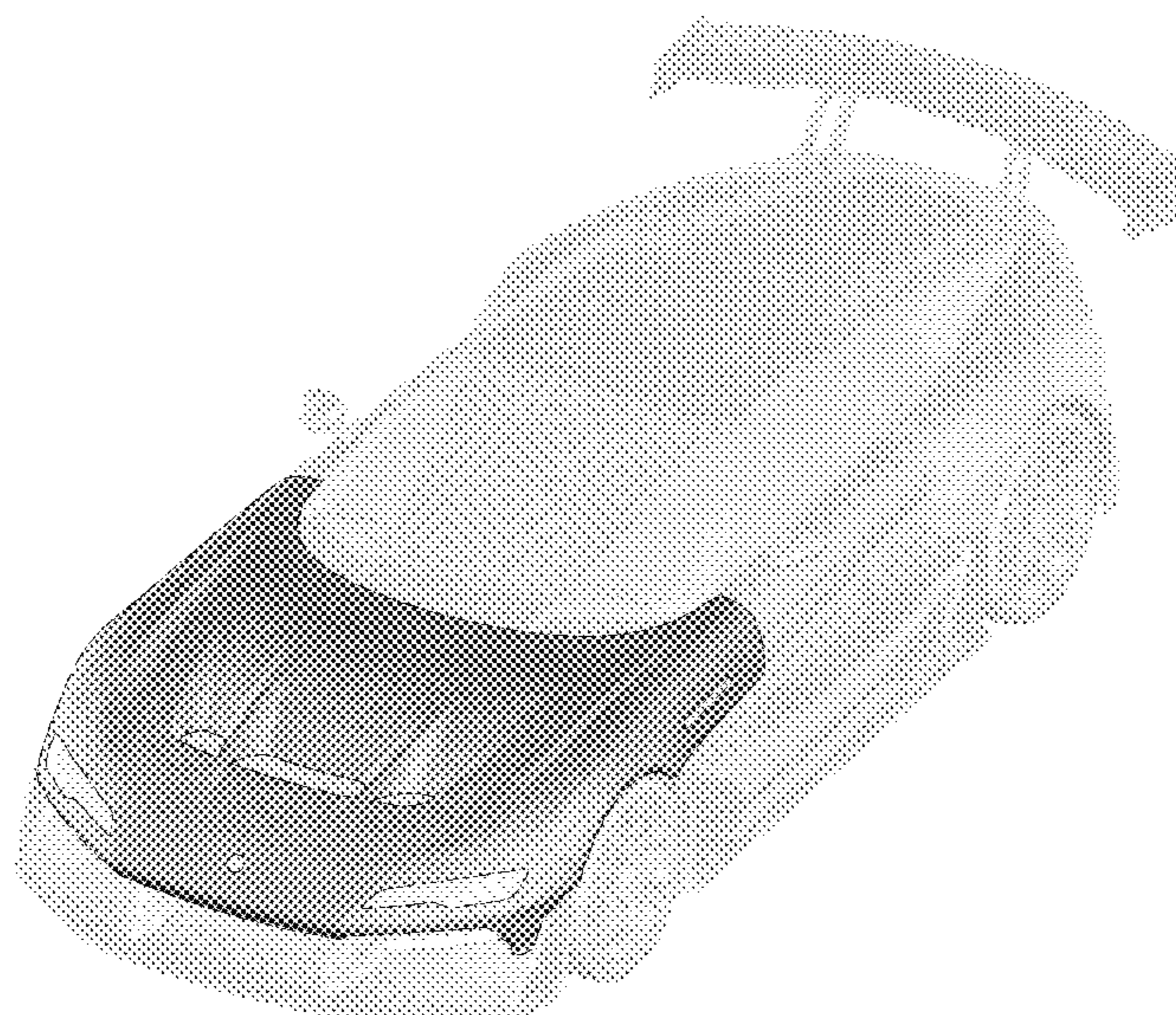
(57) **CLAIM**

The ornamental design for a vehicle hood, as shown and
described.

DESCRIPTION

FIG. 1 is a top front perspective view of a vehicle hood
showing our new design;
FIG. 2 is a top rear perspective view of the vehicle hood of
FIG. 1;
FIG. 3 is a front view of the vehicle hood of FIG. 1;
FIG. 4 is a rear view of the vehicle hood of FIG. 1;
FIG. 5 is left side view of the vehicle hood of FIG. 1;
FIG. 6 is right side view of the vehicle hood of FIG. 1;
FIG. 7 is top view of the vehicle hood of FIG. 1; and,
FIG. 8 is bottom view of the vehicle hood of FIG. 1.
Dot-dash pattern broken lines form a boundary between the
claimed vehicle hood and unclaimed environment. Neither
the broken lines nor the lighter areas surrounding or sur-
rounded by the broken lines form any part of the claimed
design.

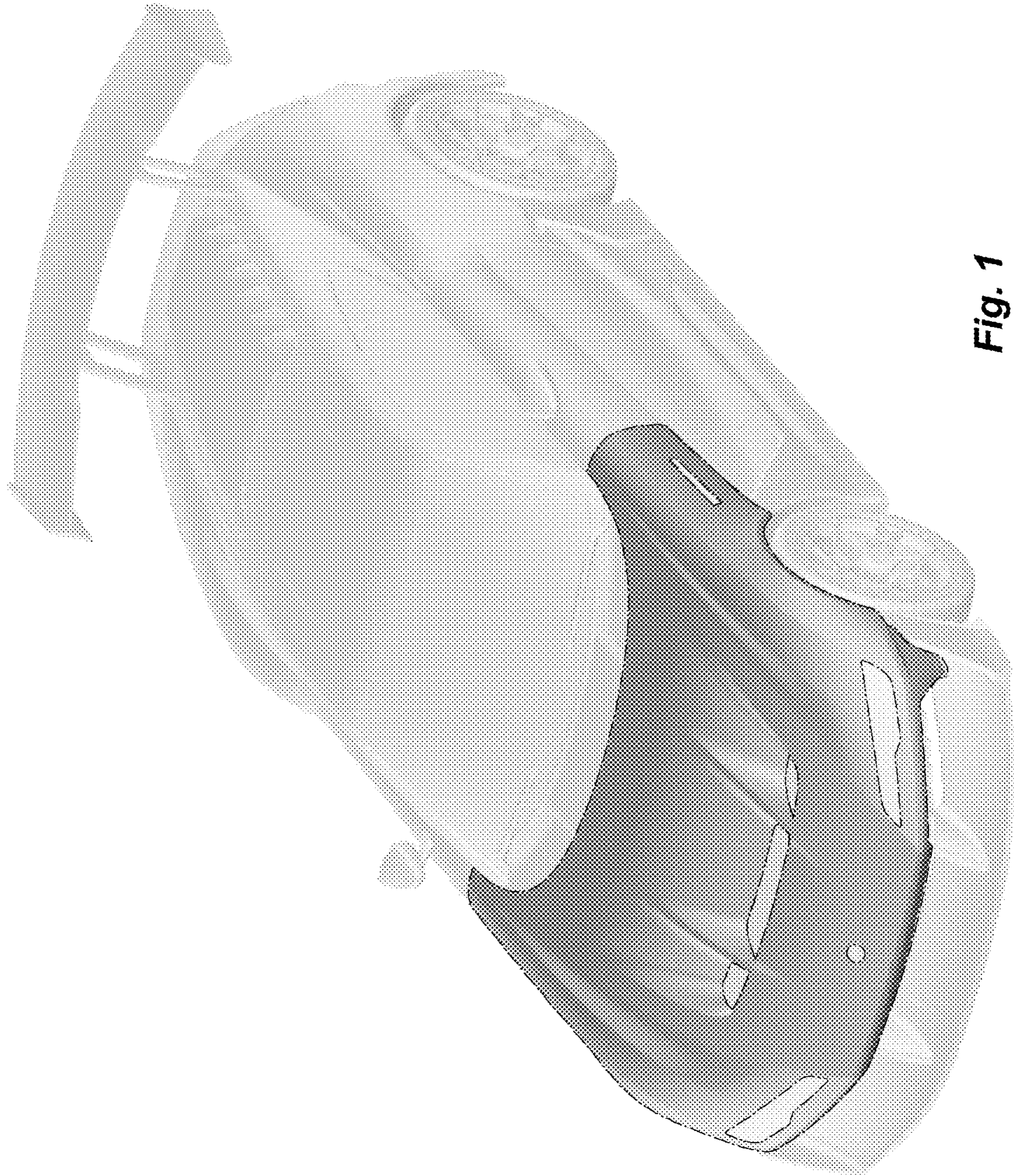

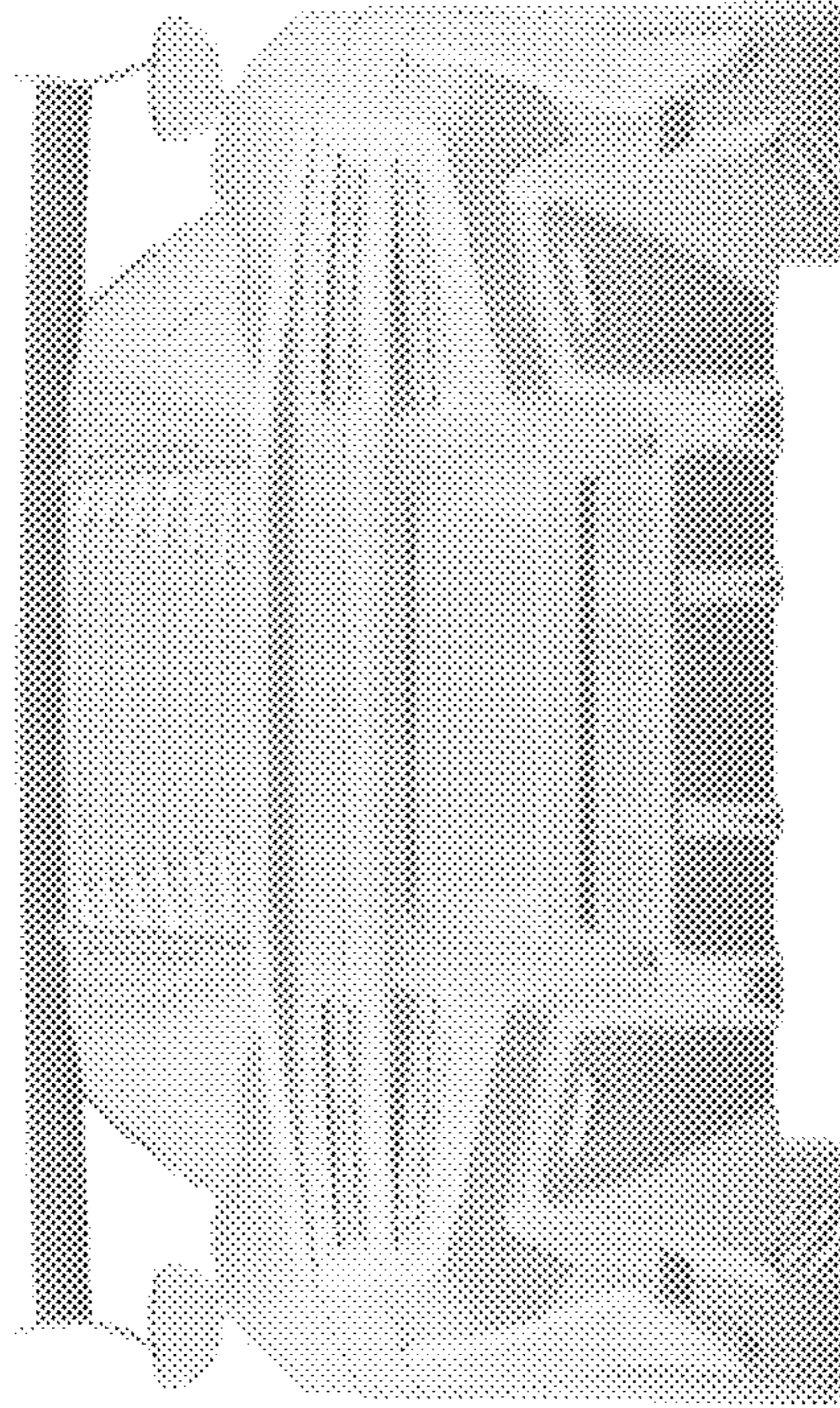

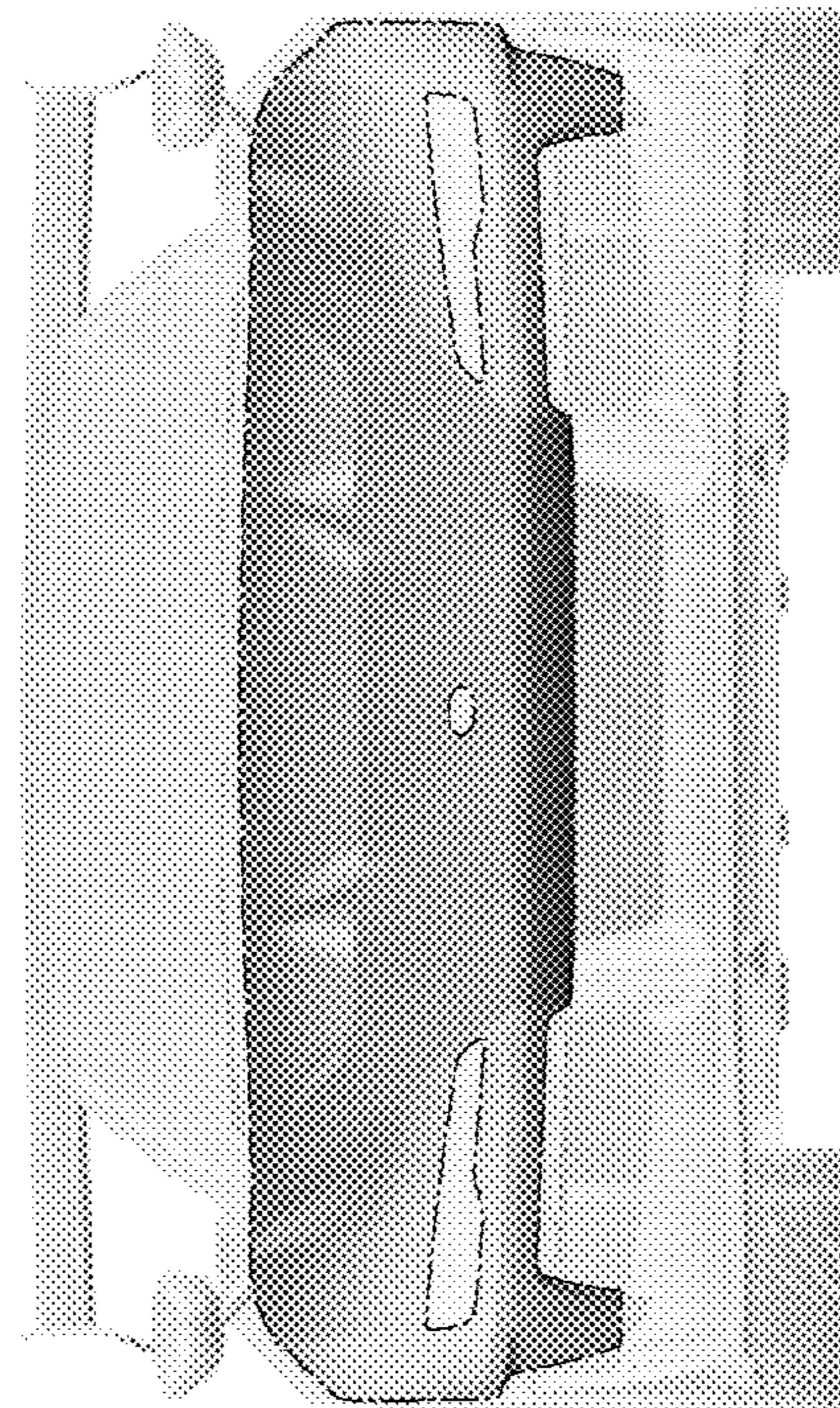

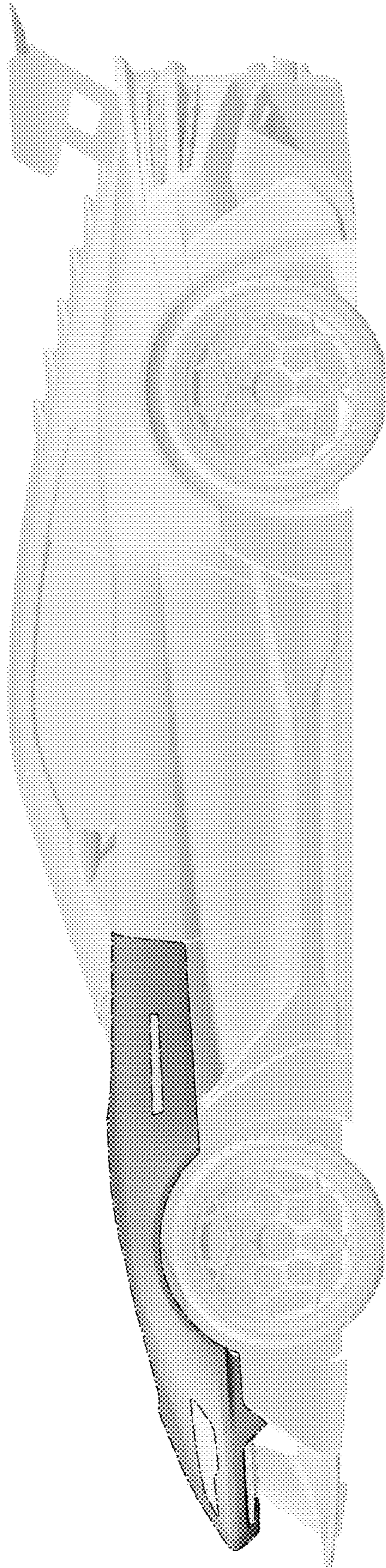

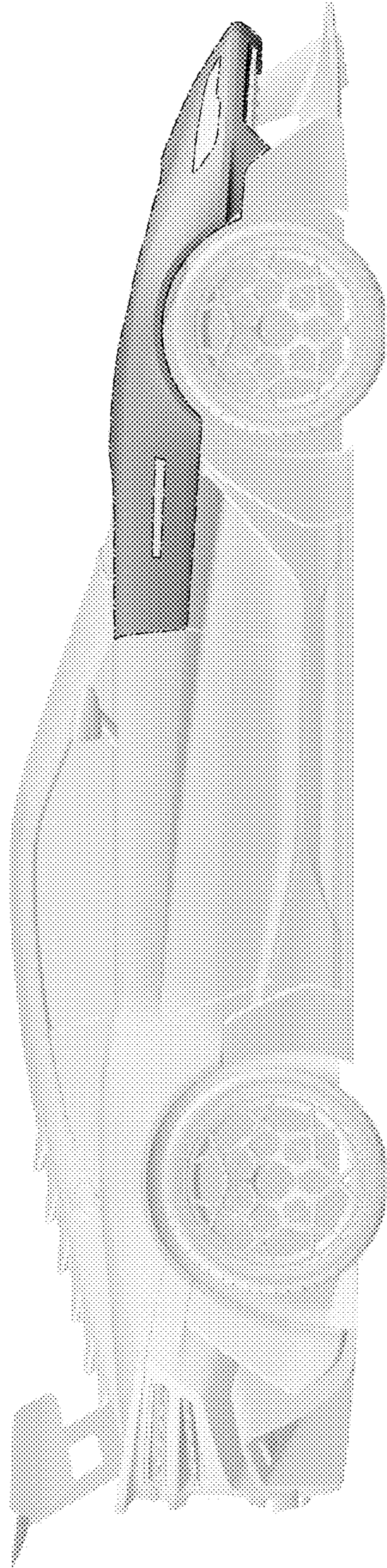

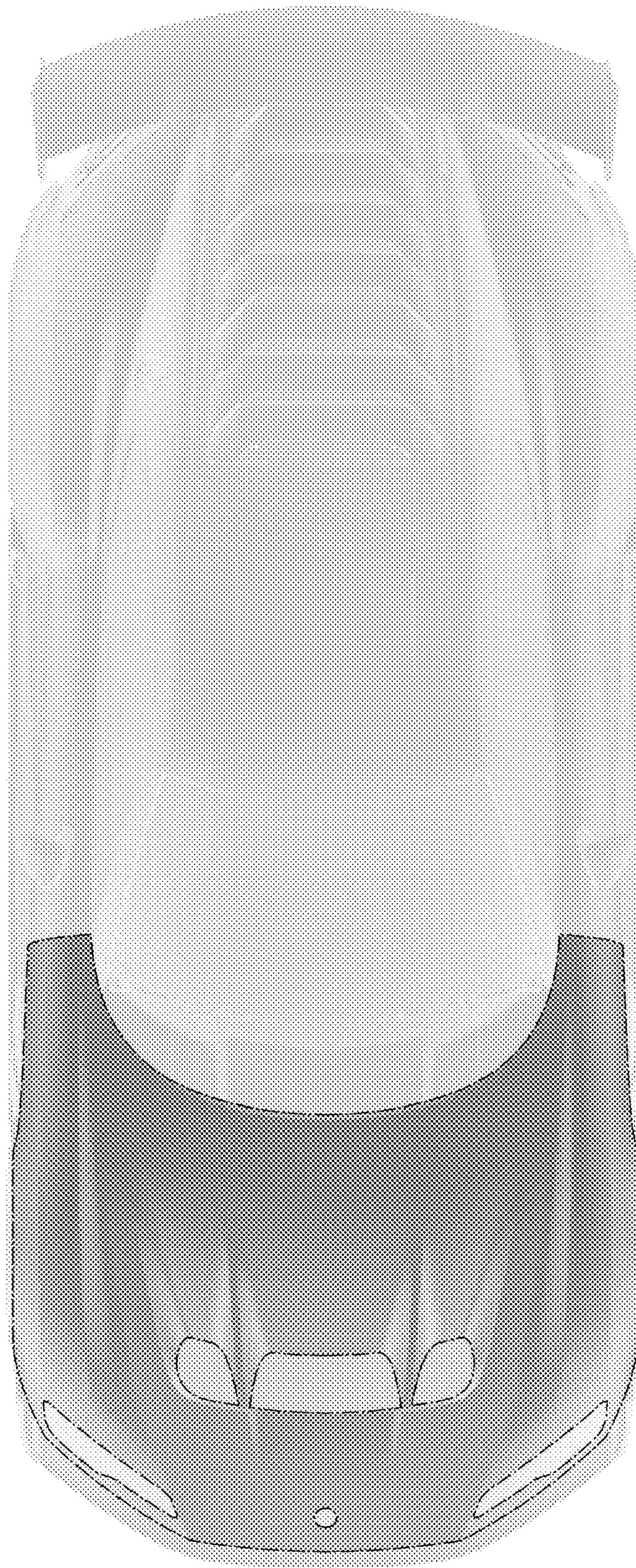

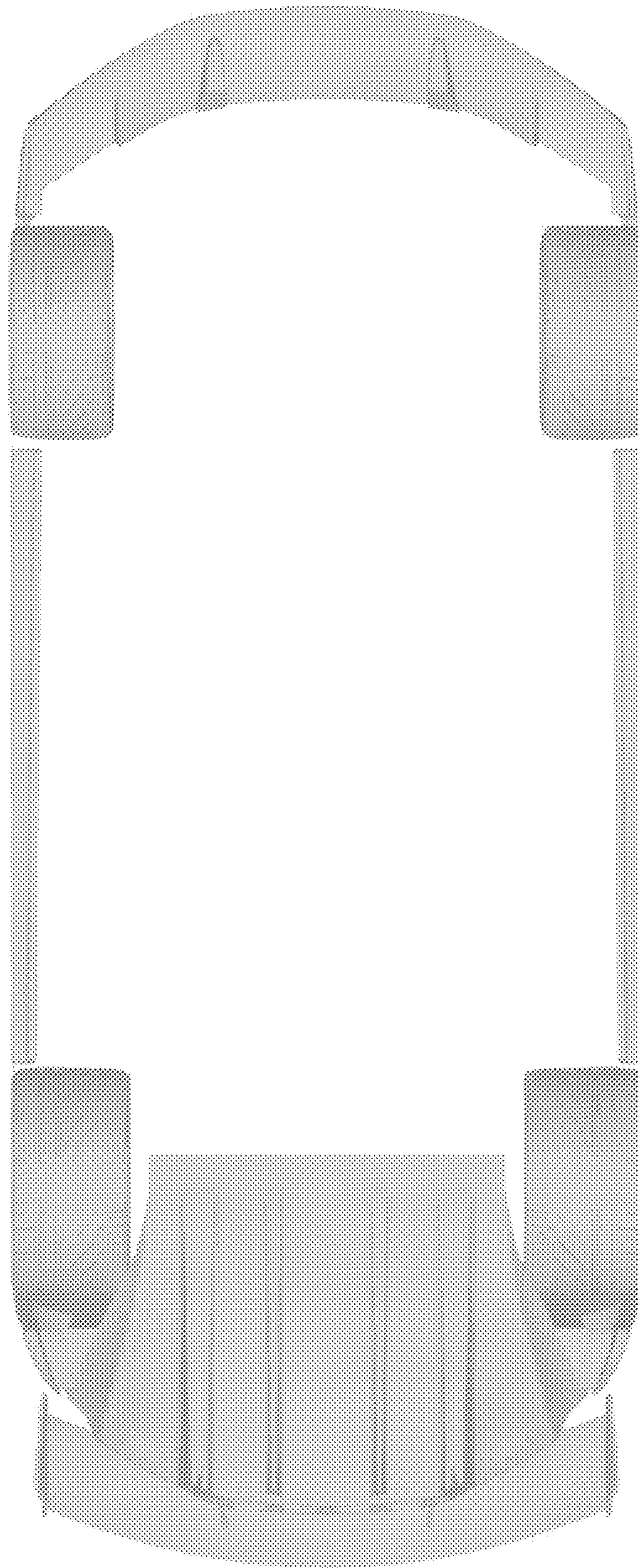
