(57) **CLAIM**

The ornamental design for a jack plate with cutouts, with cylinder having a remote pump, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a manual jack plate with cutouts showing my new design;
FIG. 2 is a rear elevational view;
FIG. 3 is a left side elevational view;
FIG. 4 is a right side elevational view;
FIG. 5 is a top plan view;
FIG. 6 is a bottom plan view; and,
FIG. 7 is a left and rear perspective view, with the rear plate removed for ease of illustration.

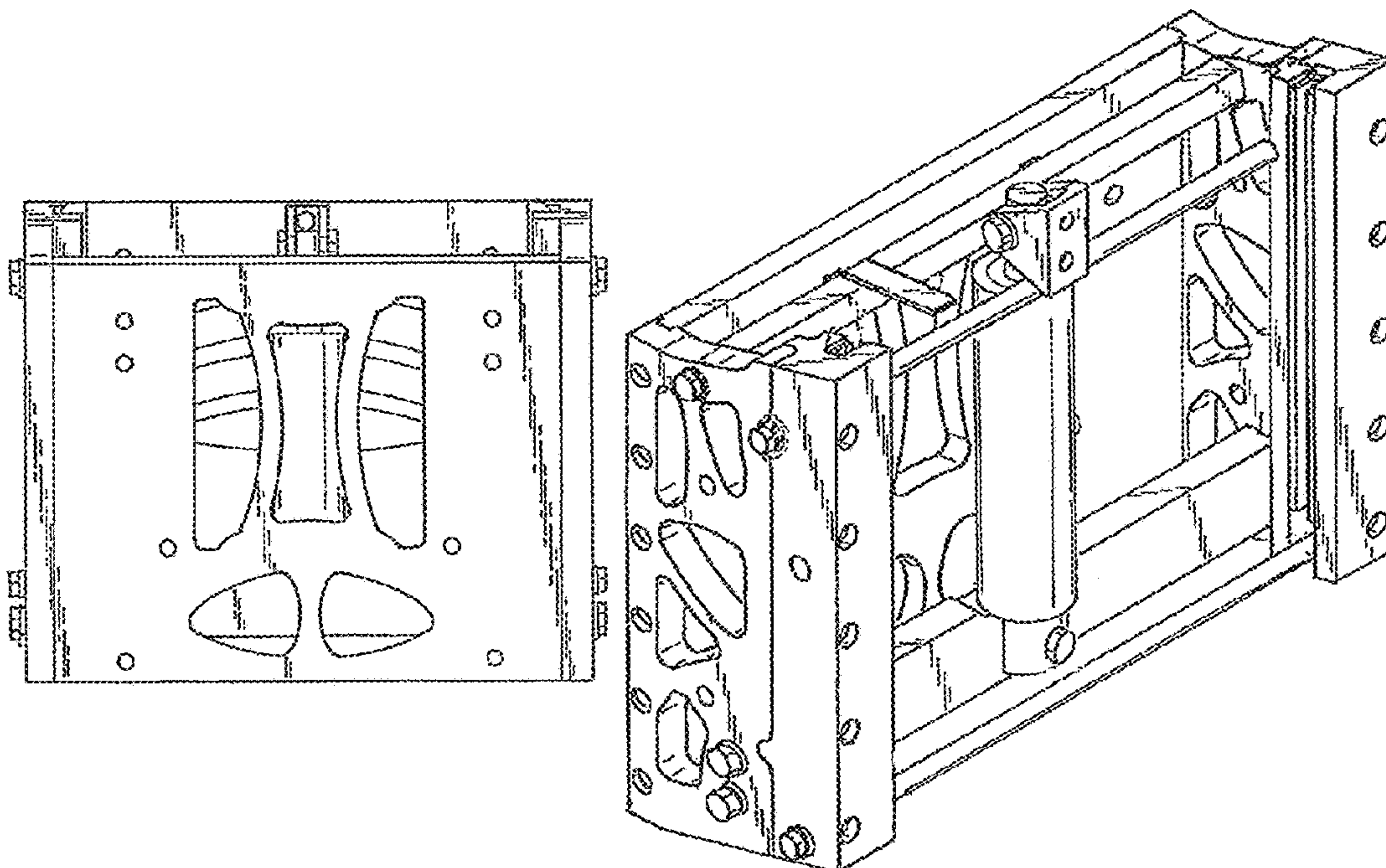

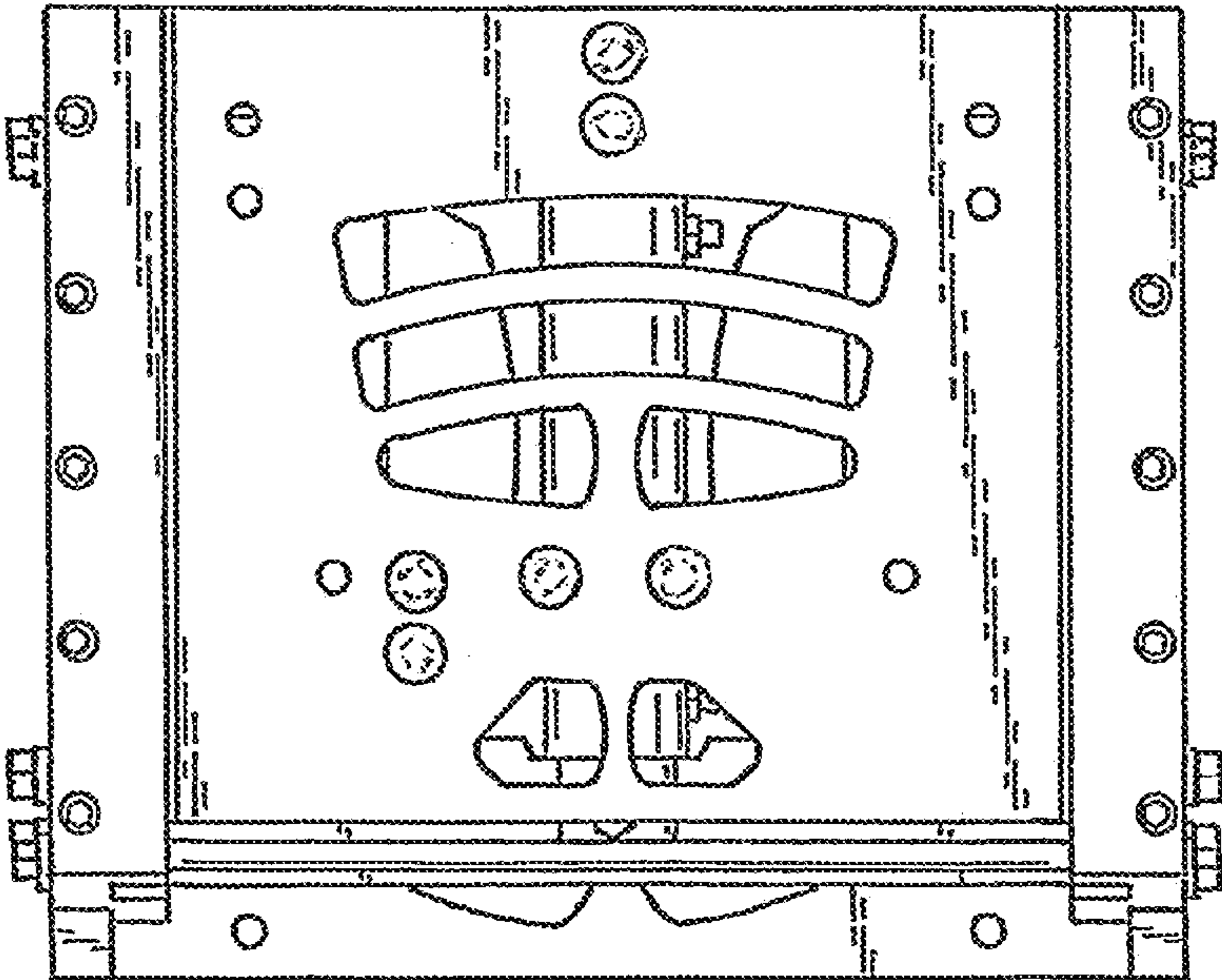
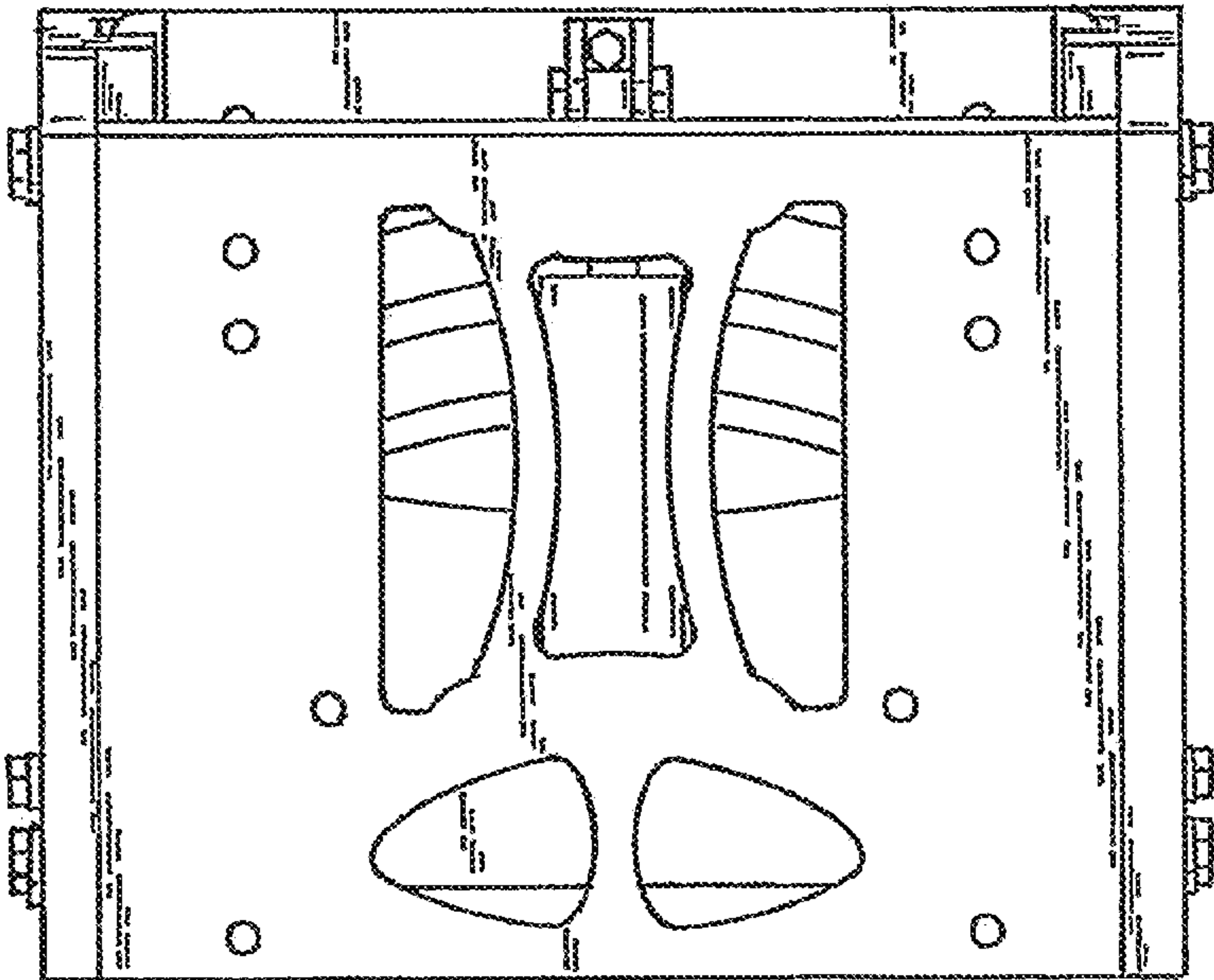

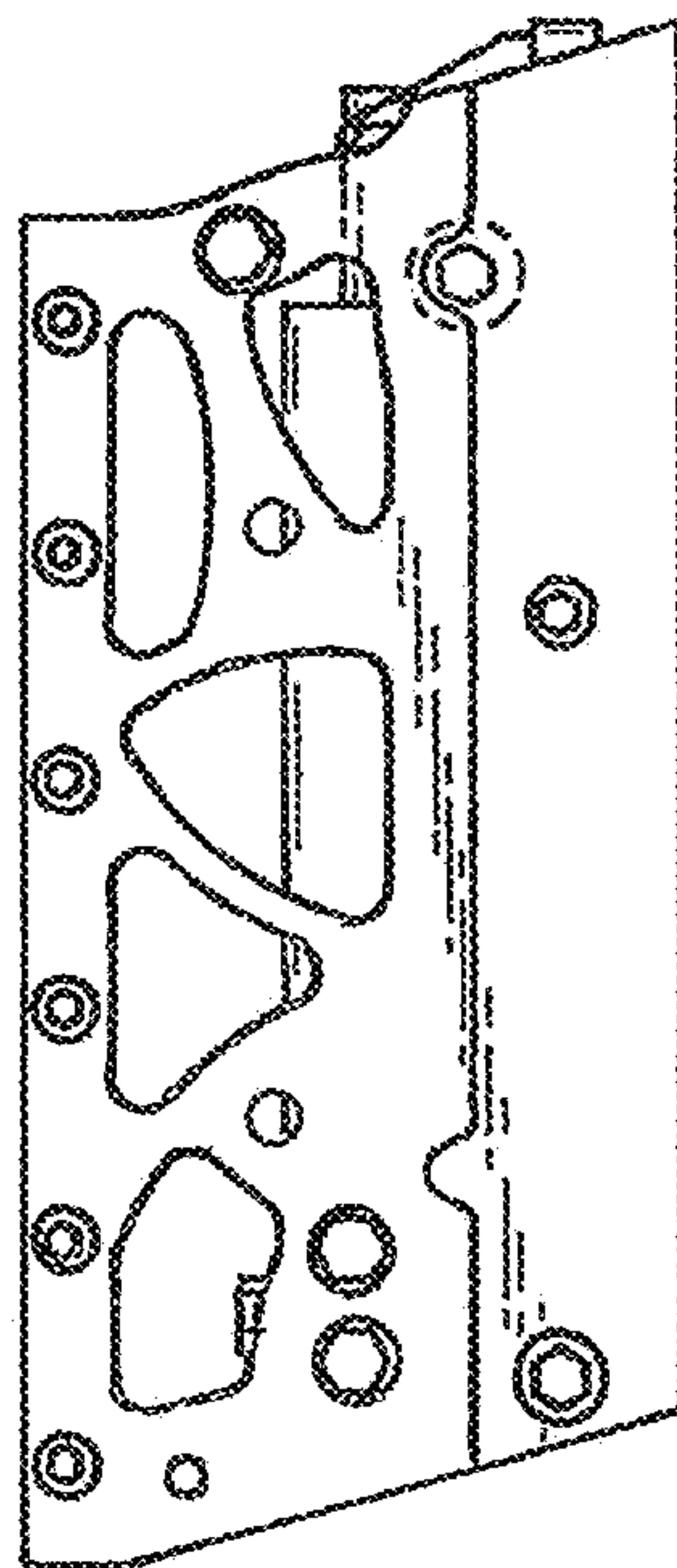

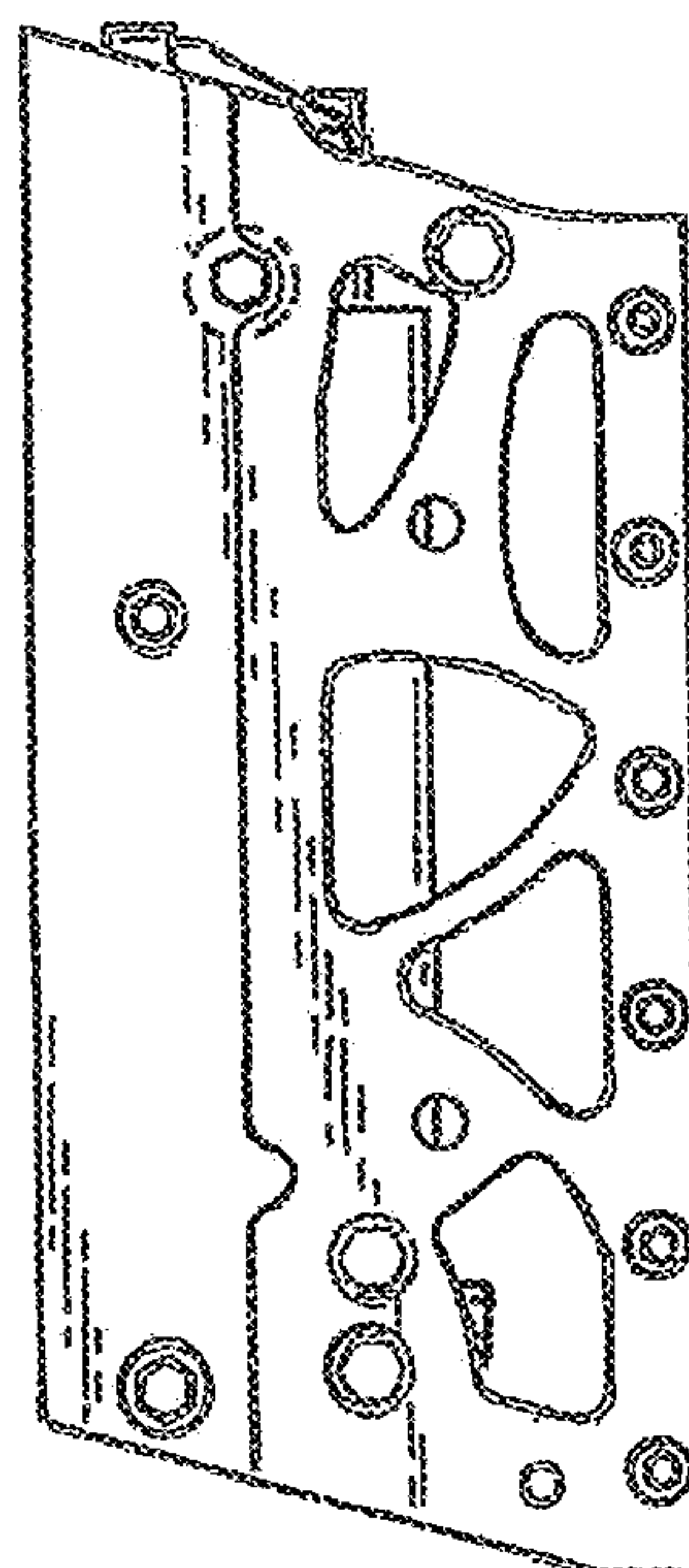

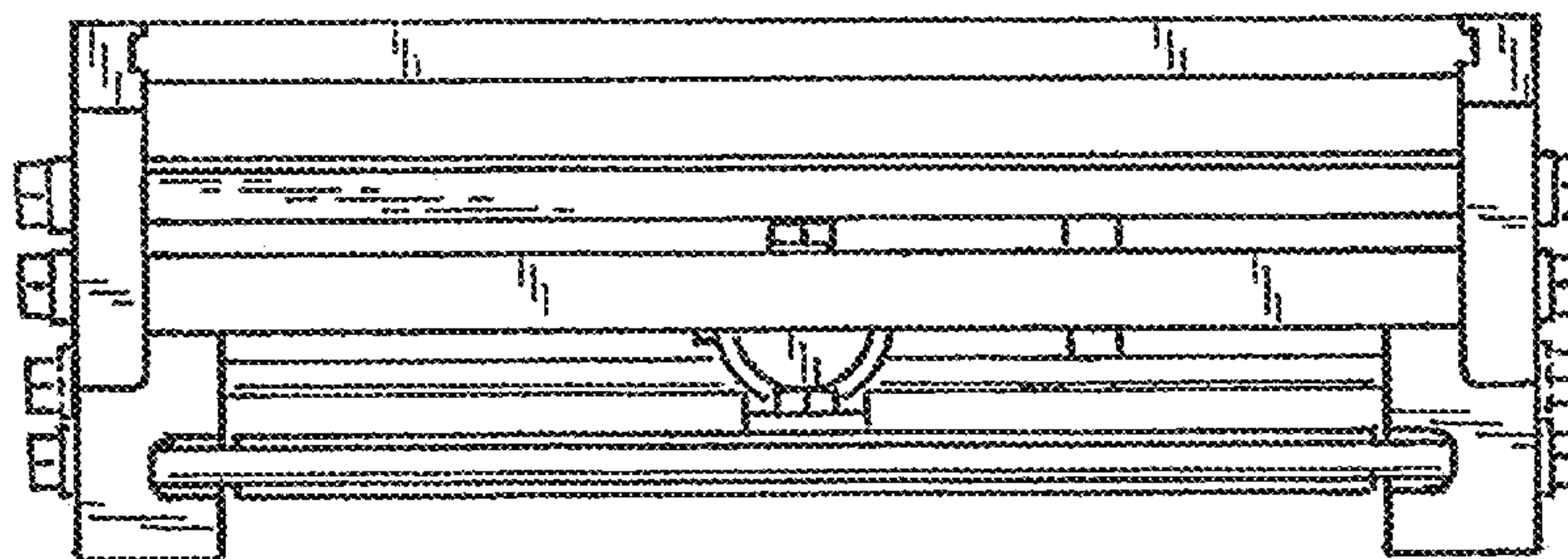
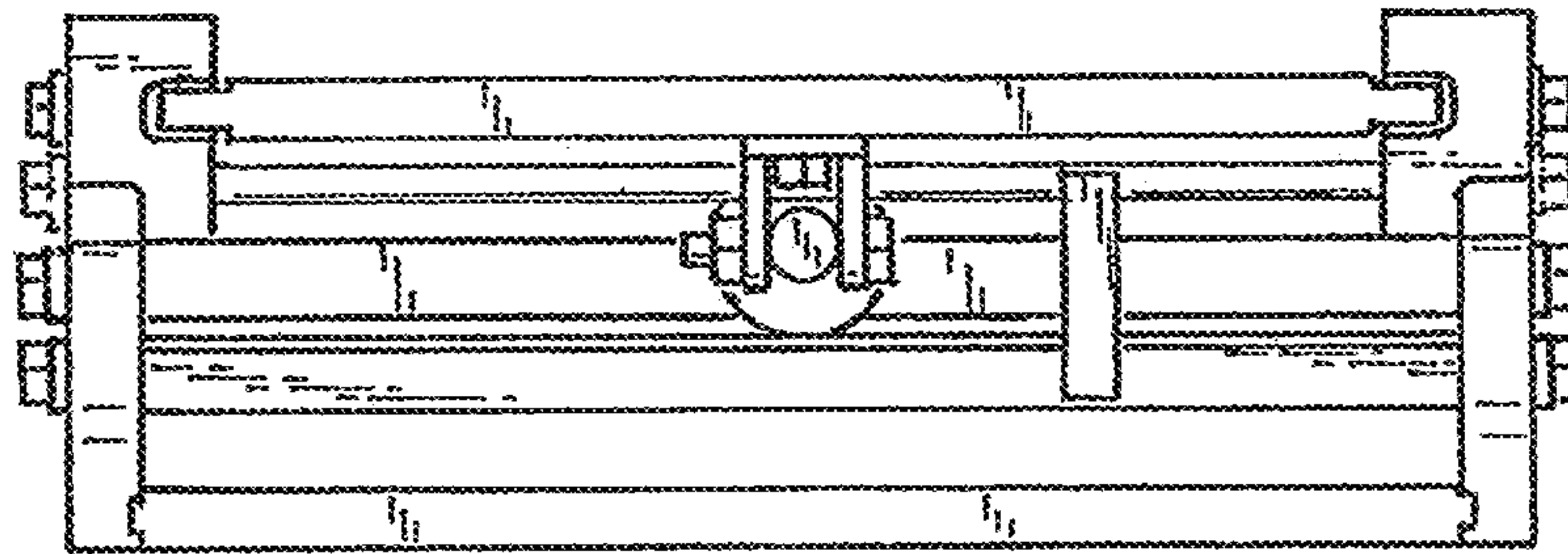

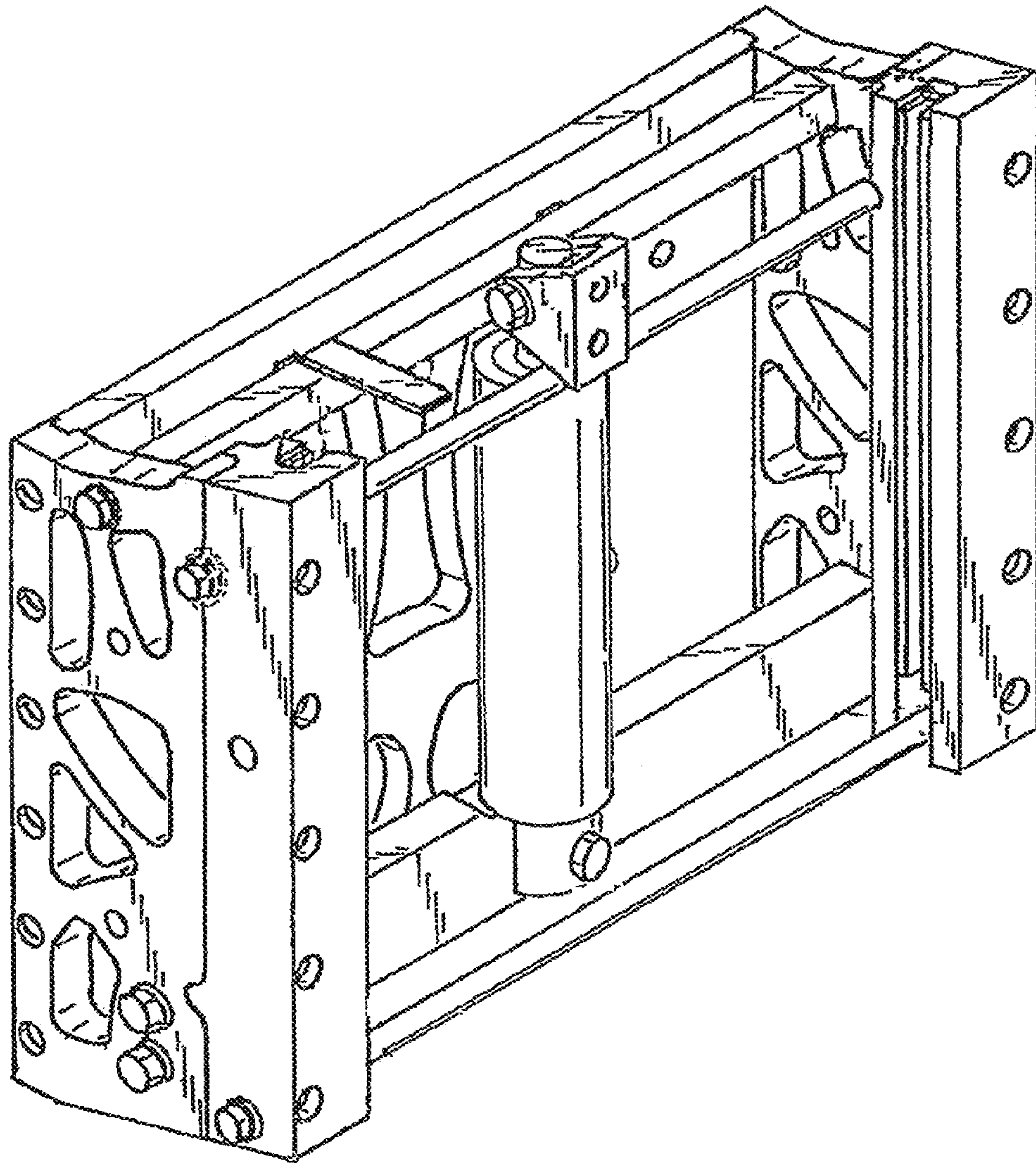
