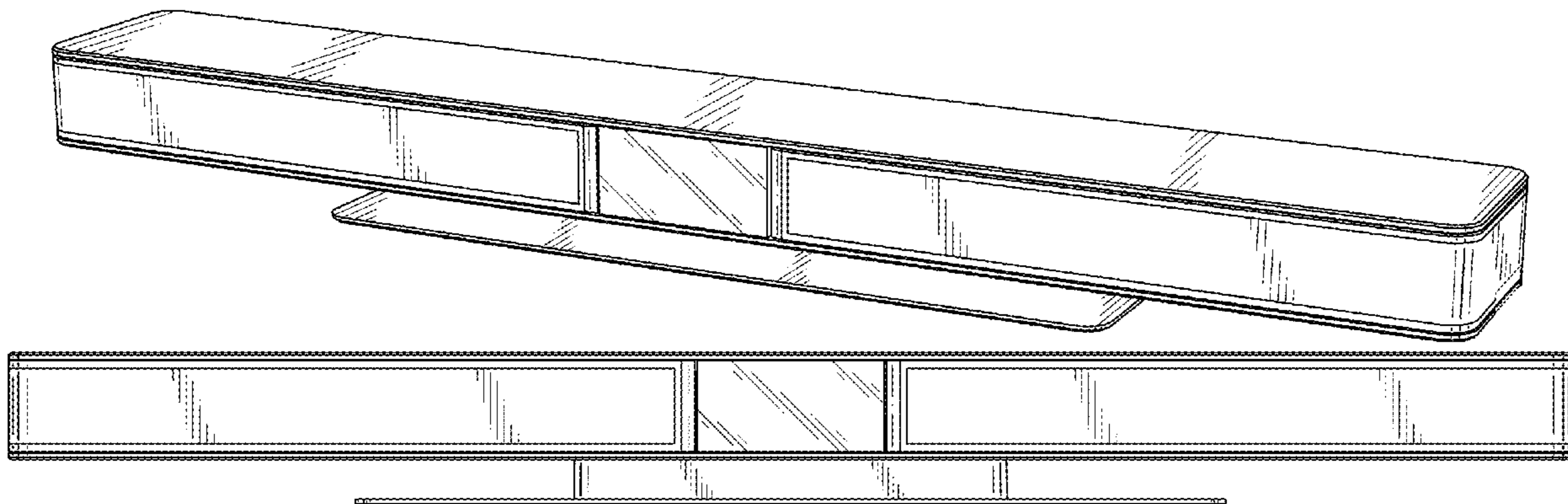
(57) **CLAIM**

The ornamental design for audio-video conferencing device, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an audio-video conferencing device as seen from the front, top and right side; FIG. 2 is a front view thereof; FIG. 3 is a top view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a left side view thereof; and, FIG. 7 is a right side view thereof. The broken dotted lines in the drawings depict portions of the audio-video conferencing device that form no part of the claimed design.

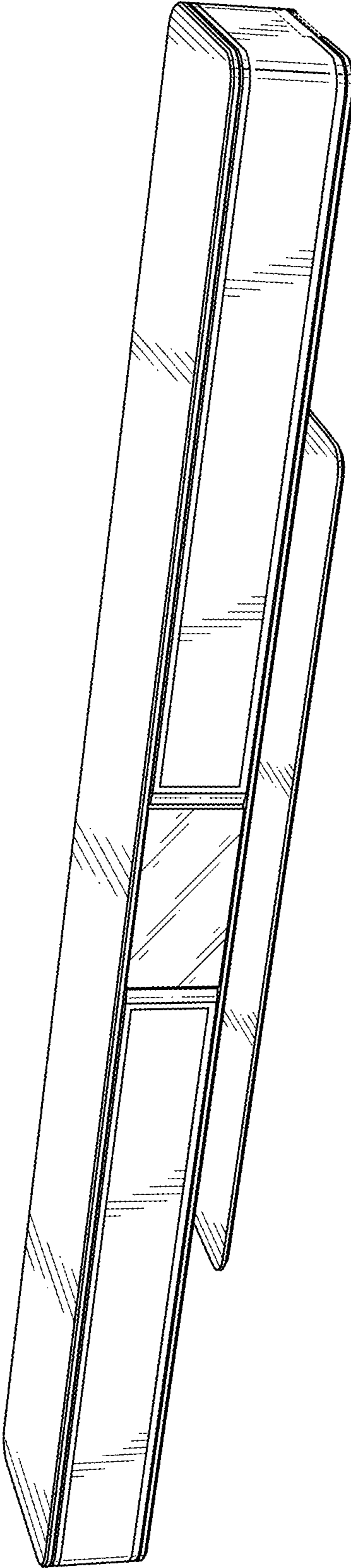

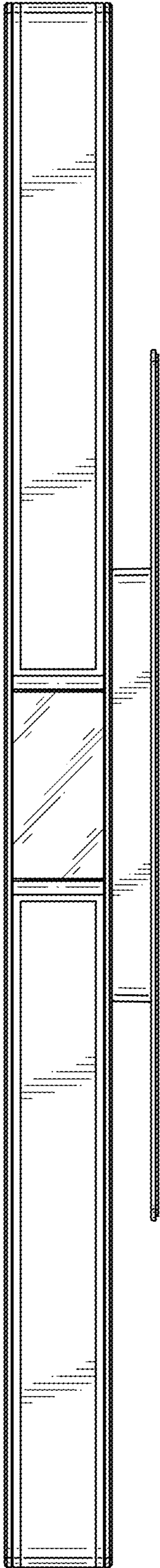

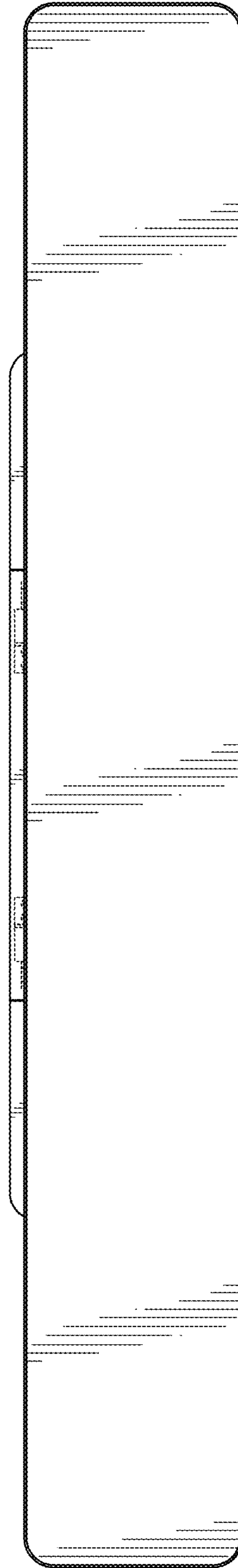

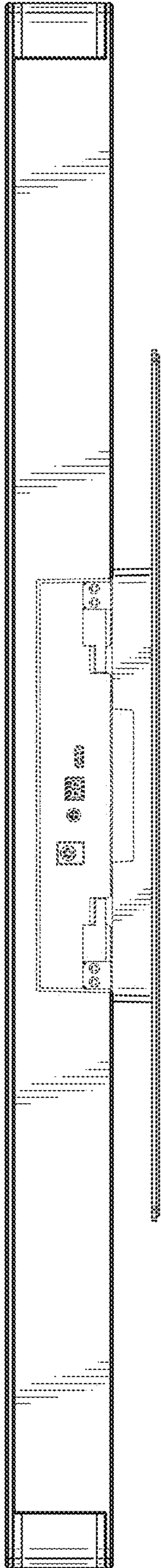

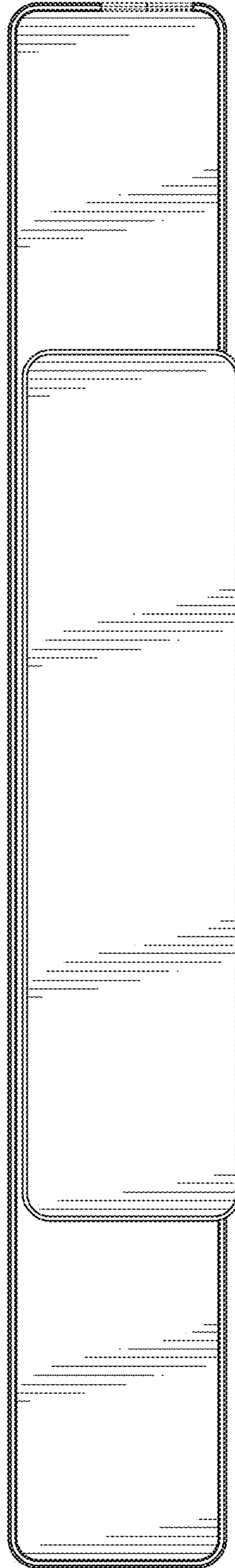

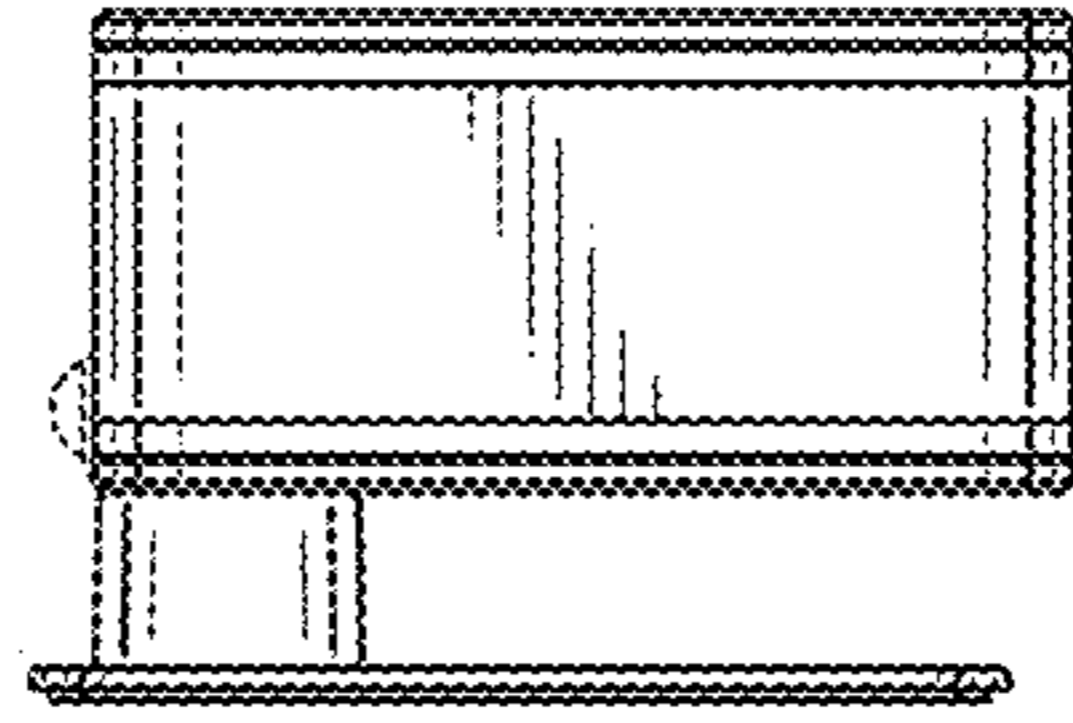

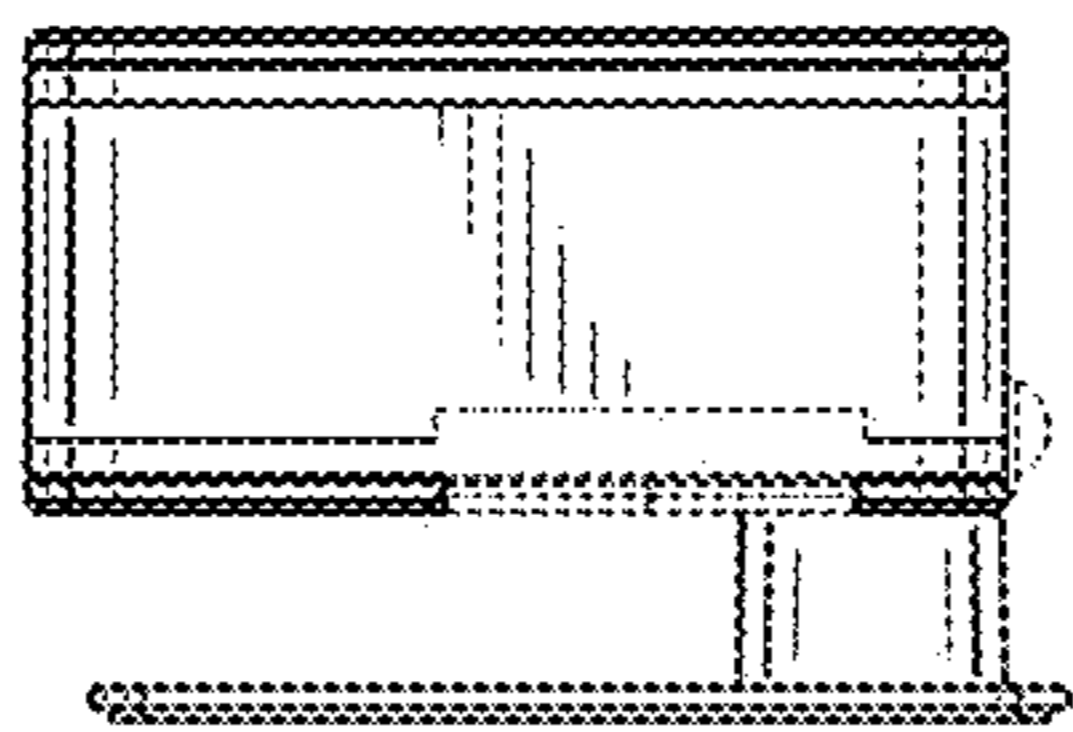
