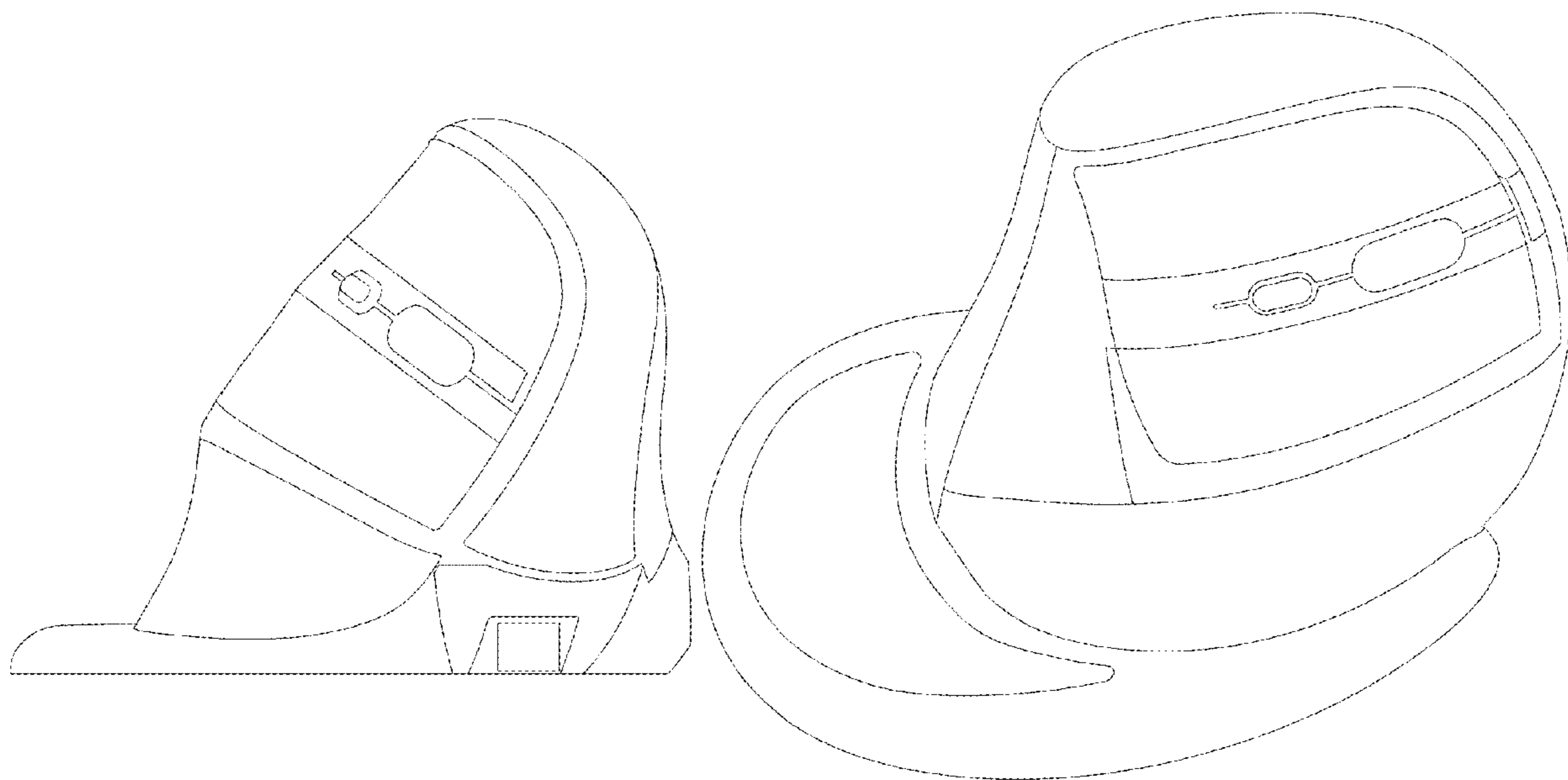
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of an ergonomic mouse, showing my new design;

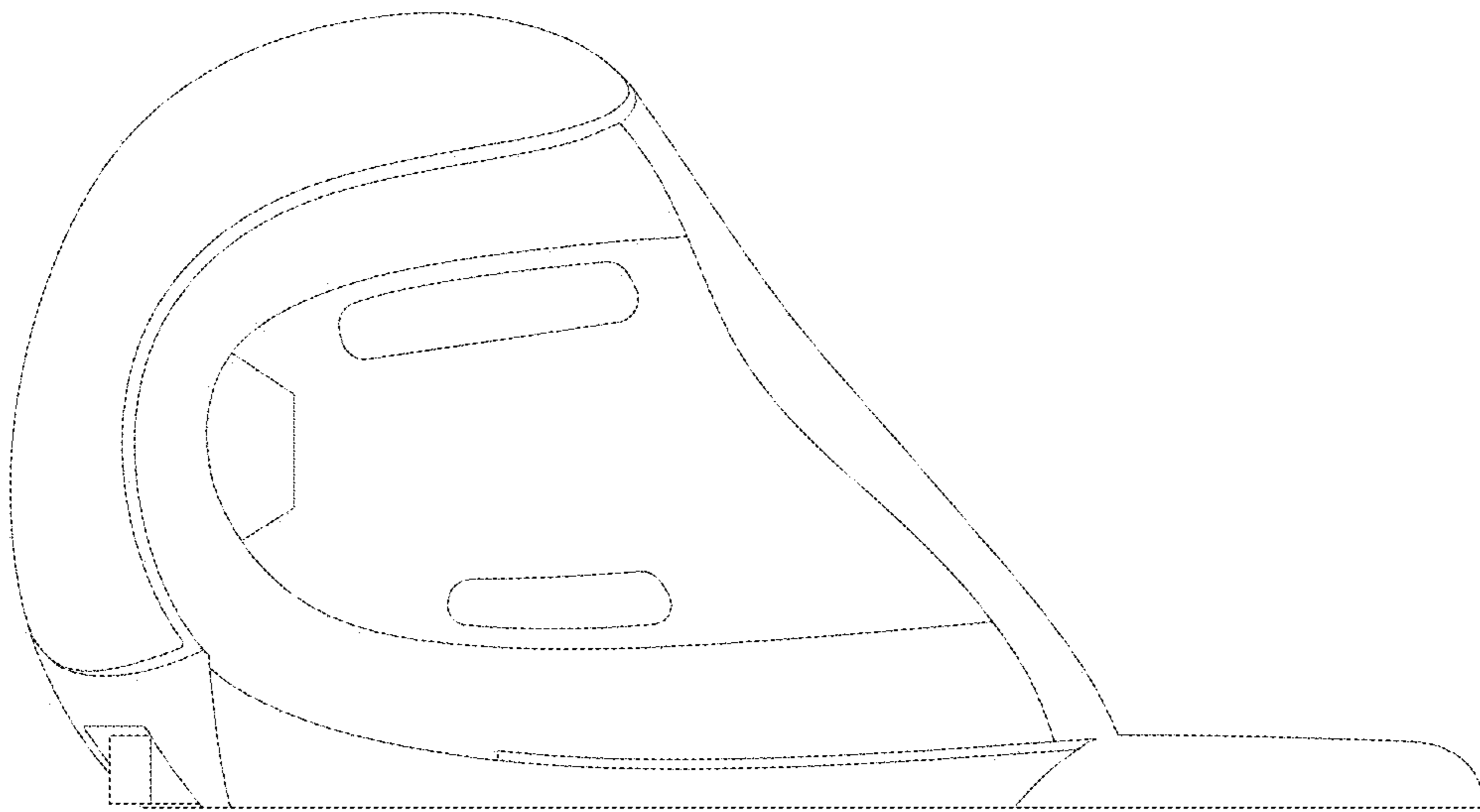

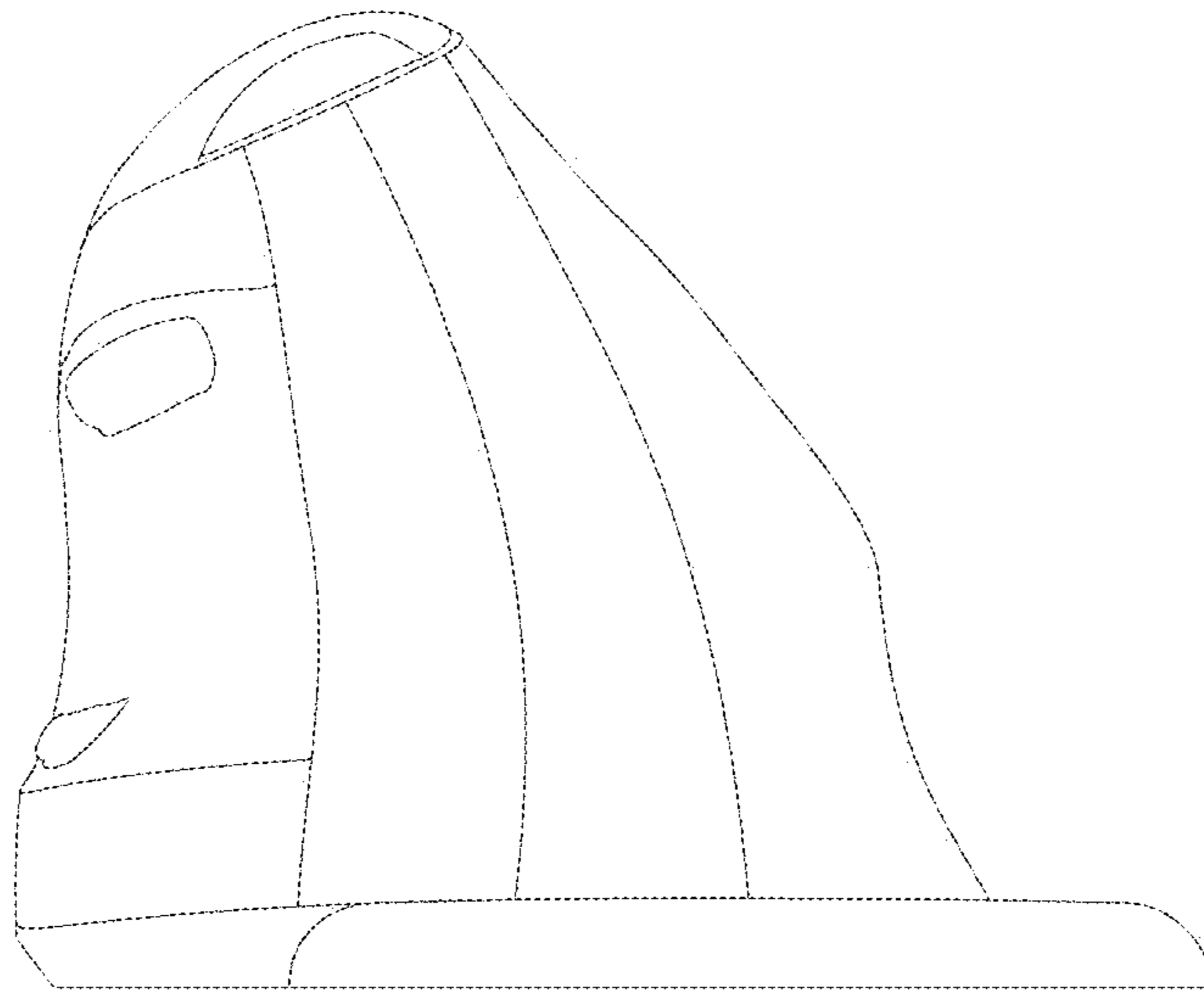

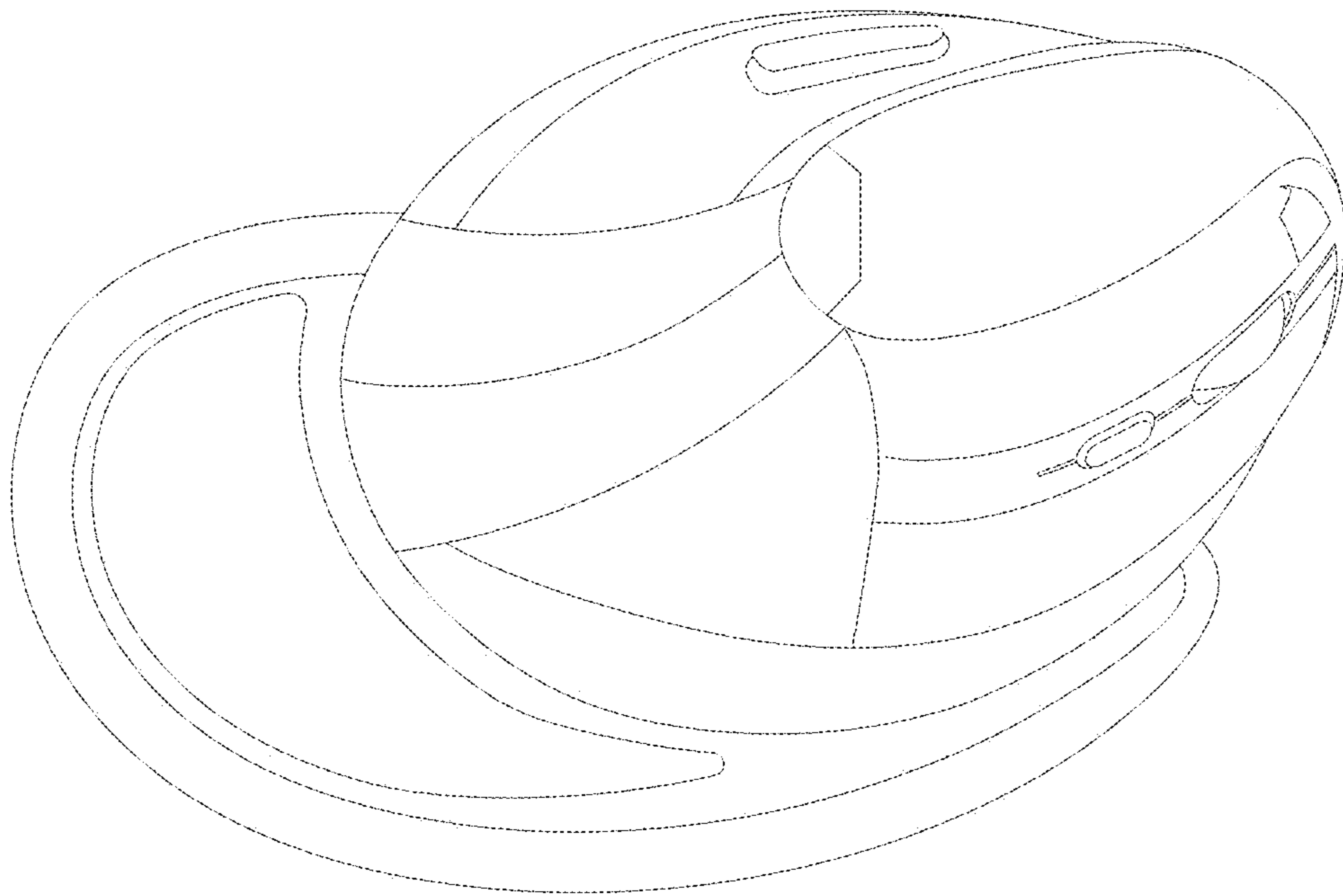

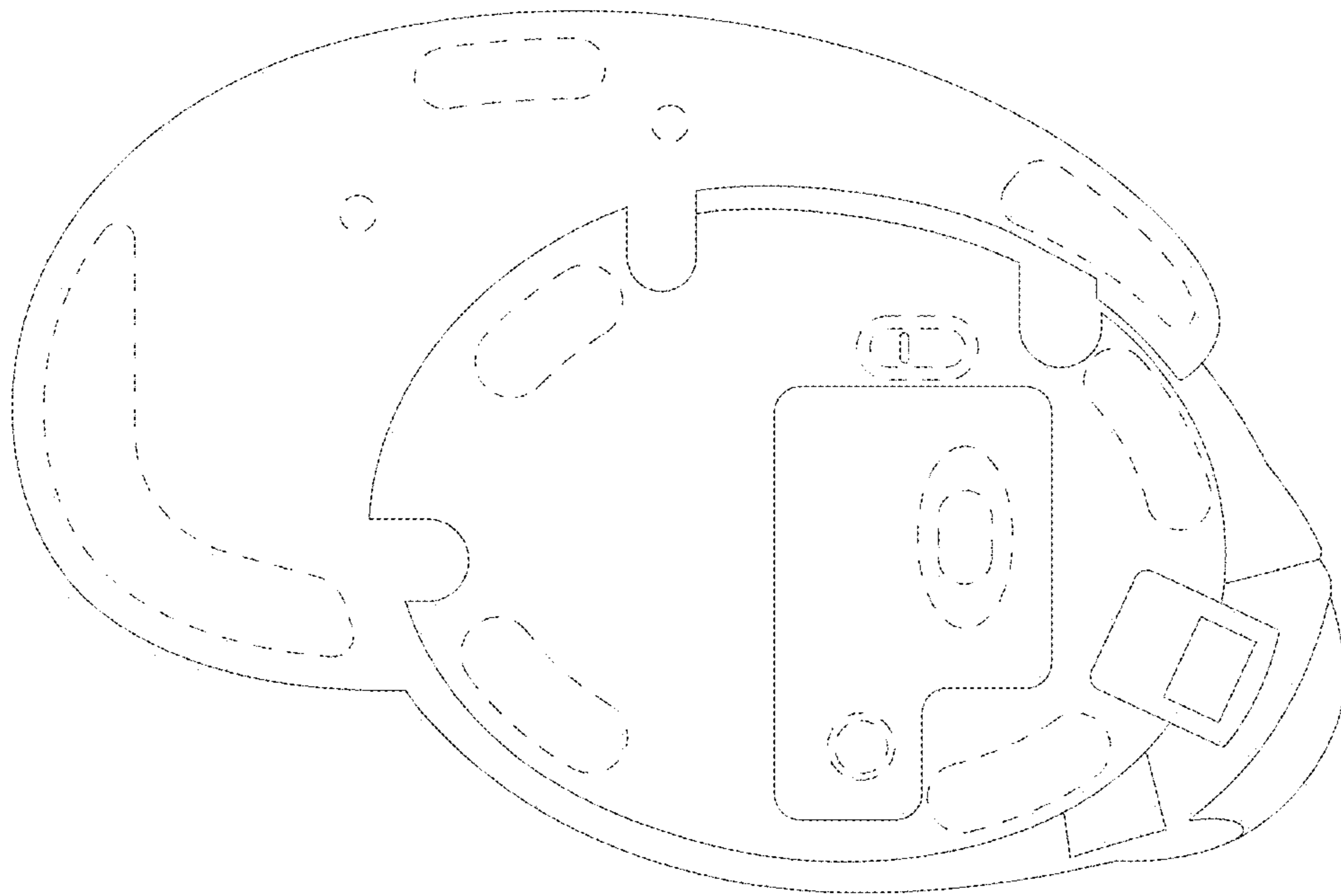

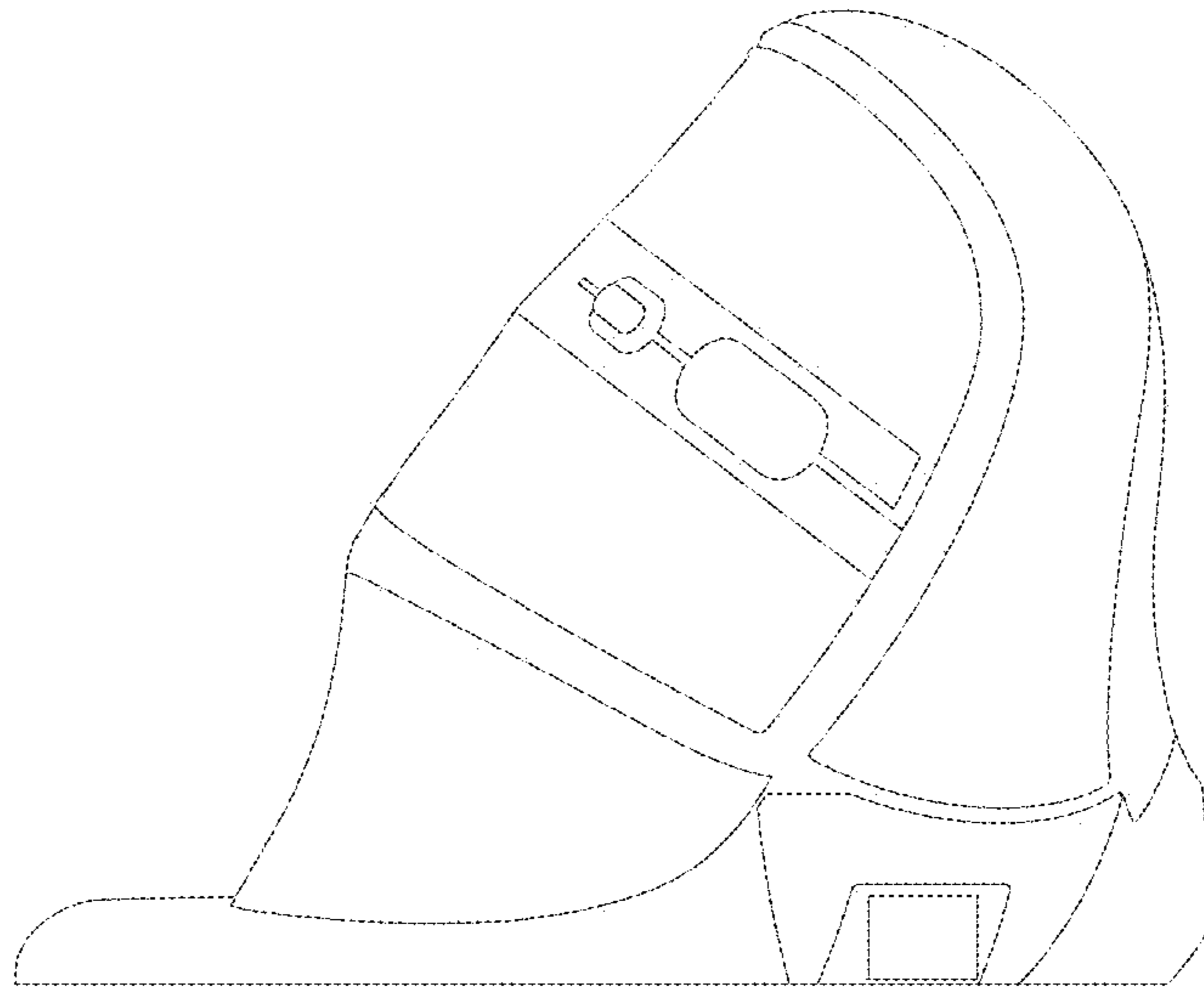

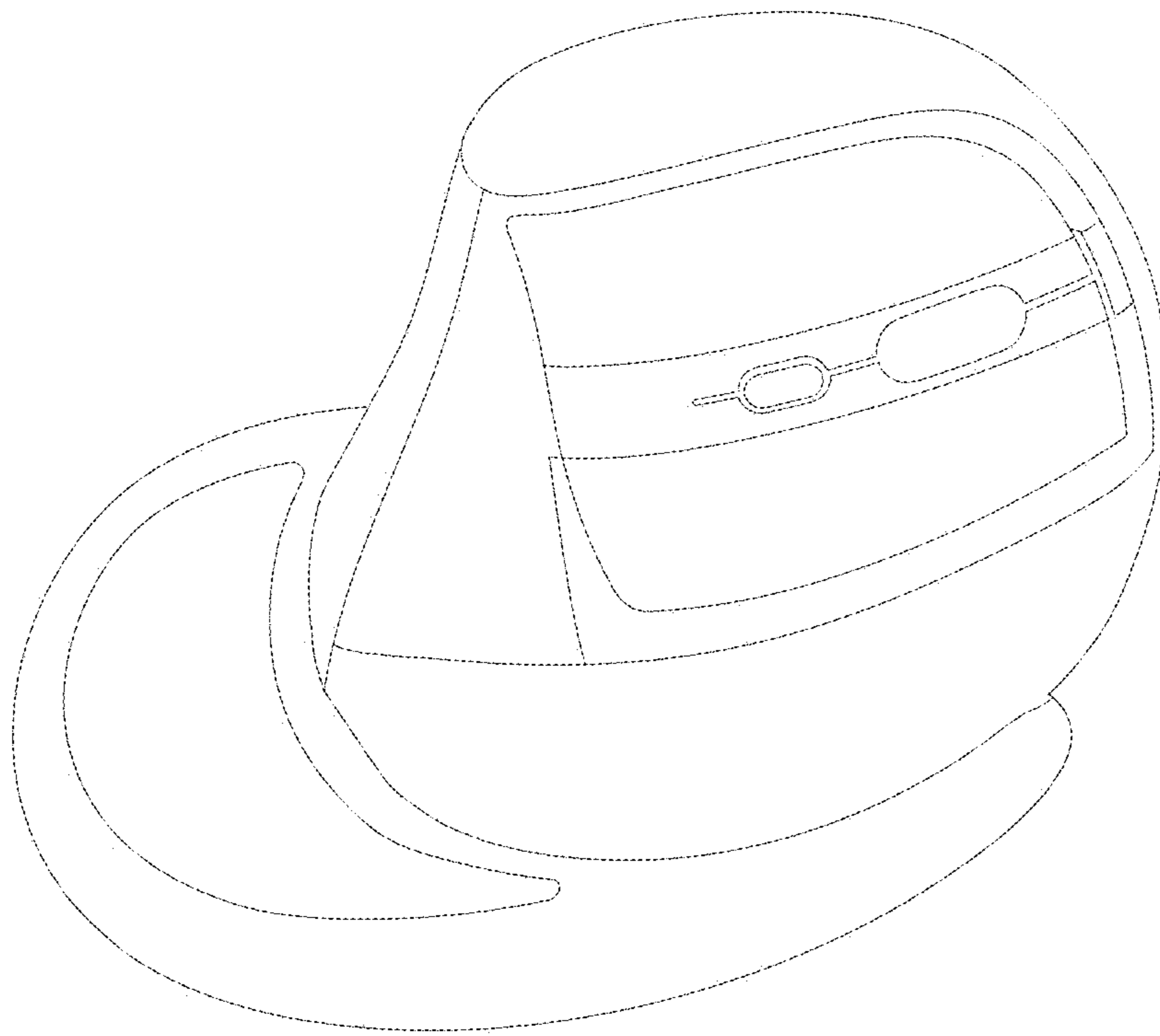

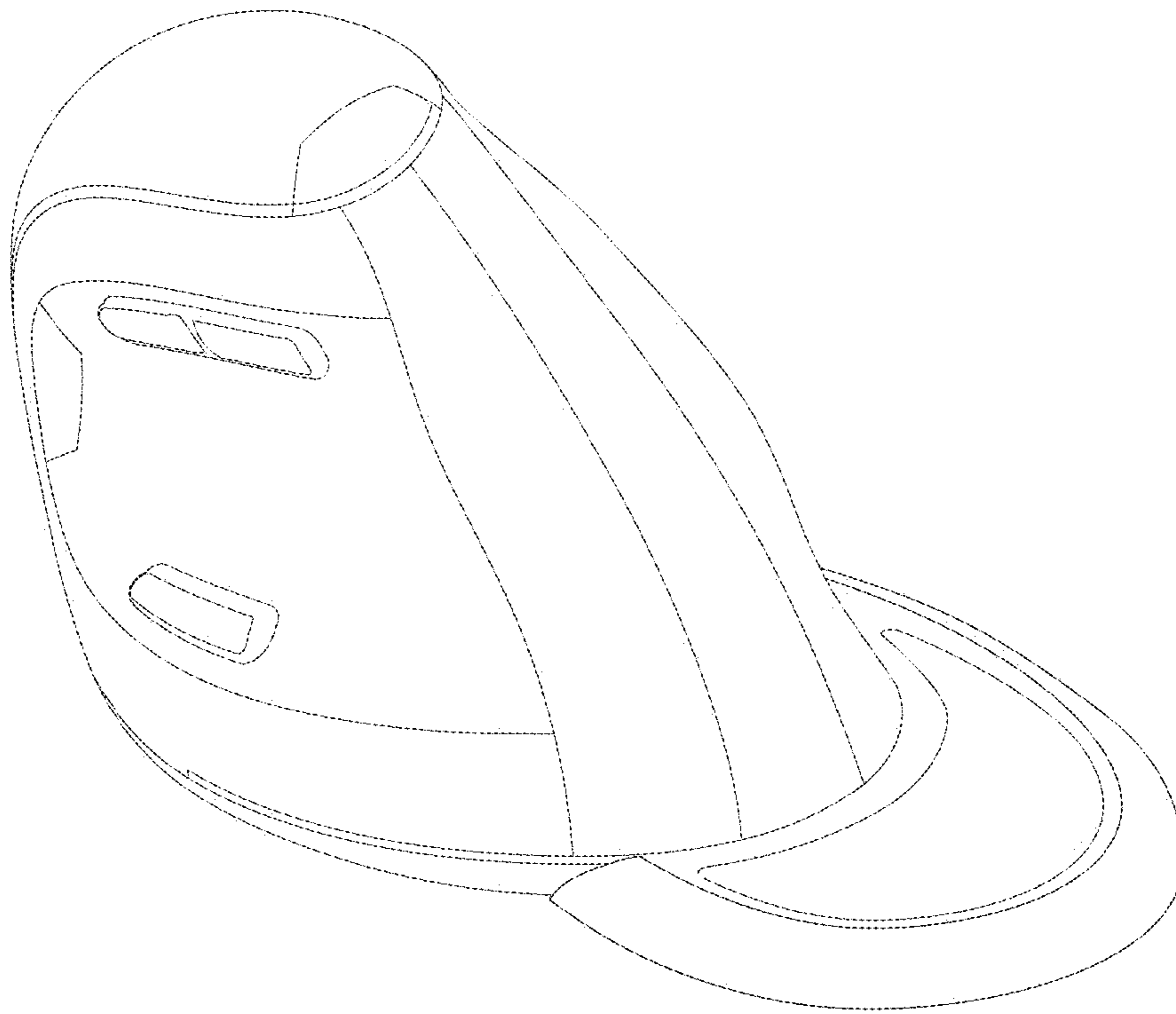
