**DESCRIPTION**

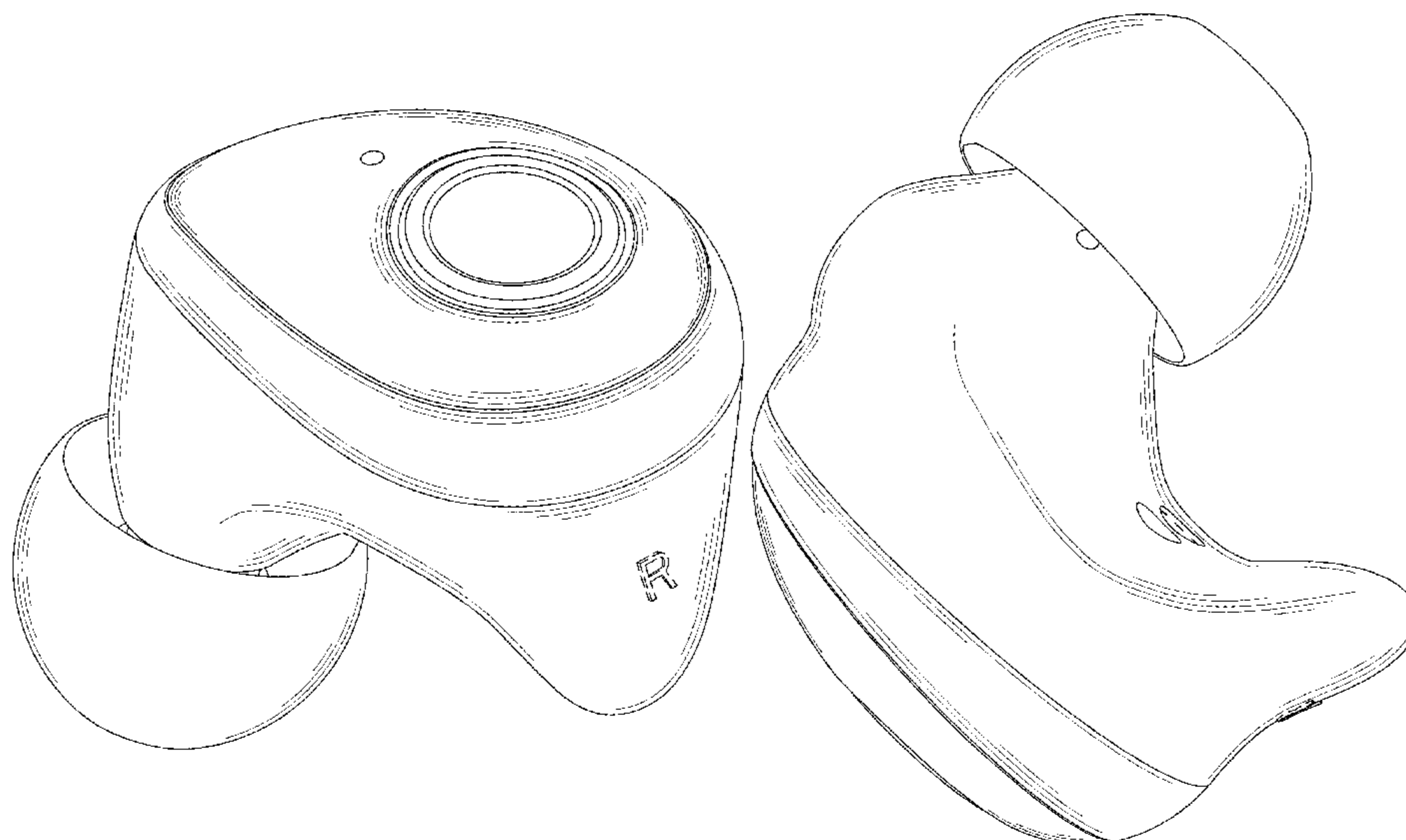
FIG. 1 is a first perspective view of a wireless headset showing my new design;

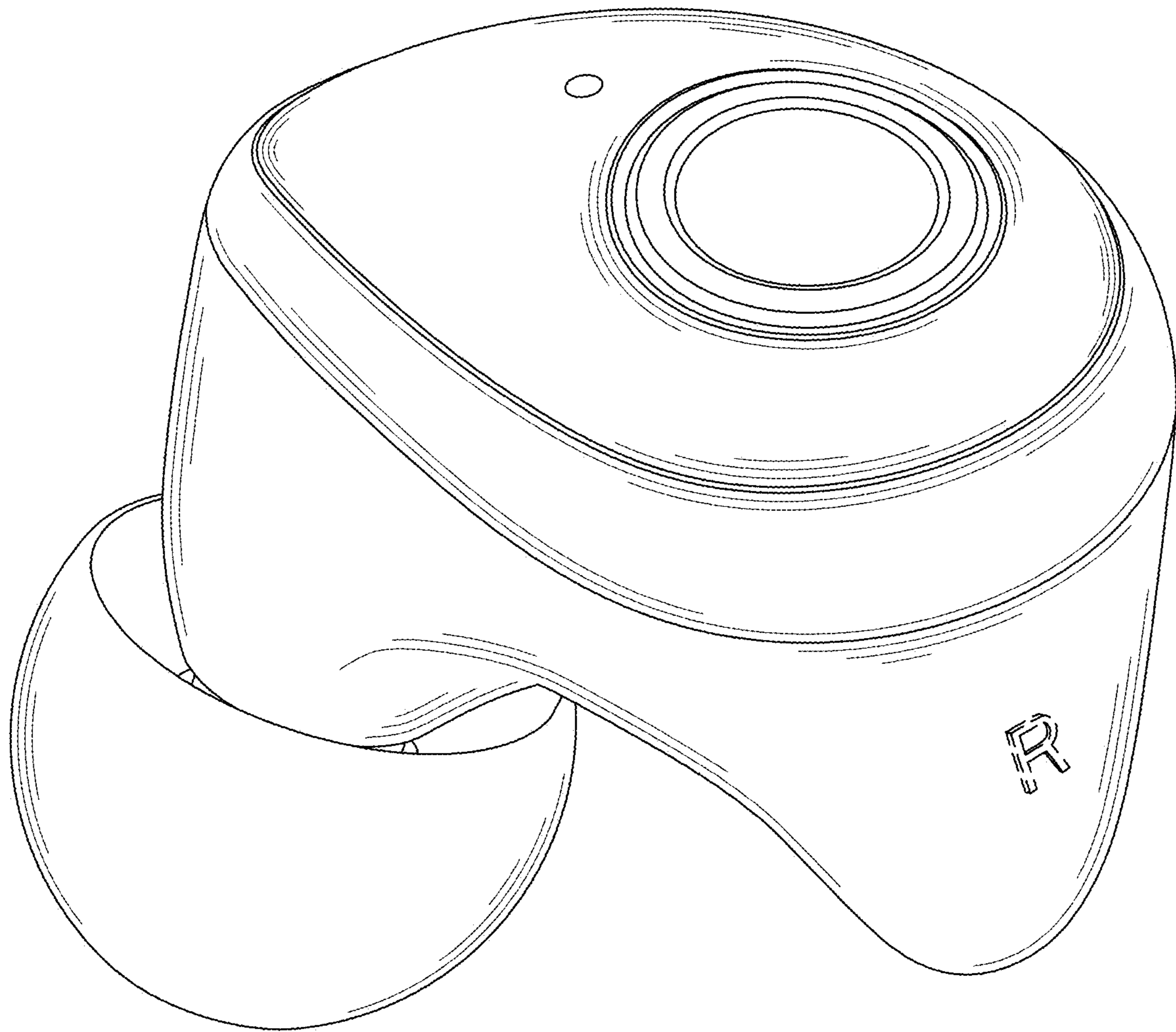

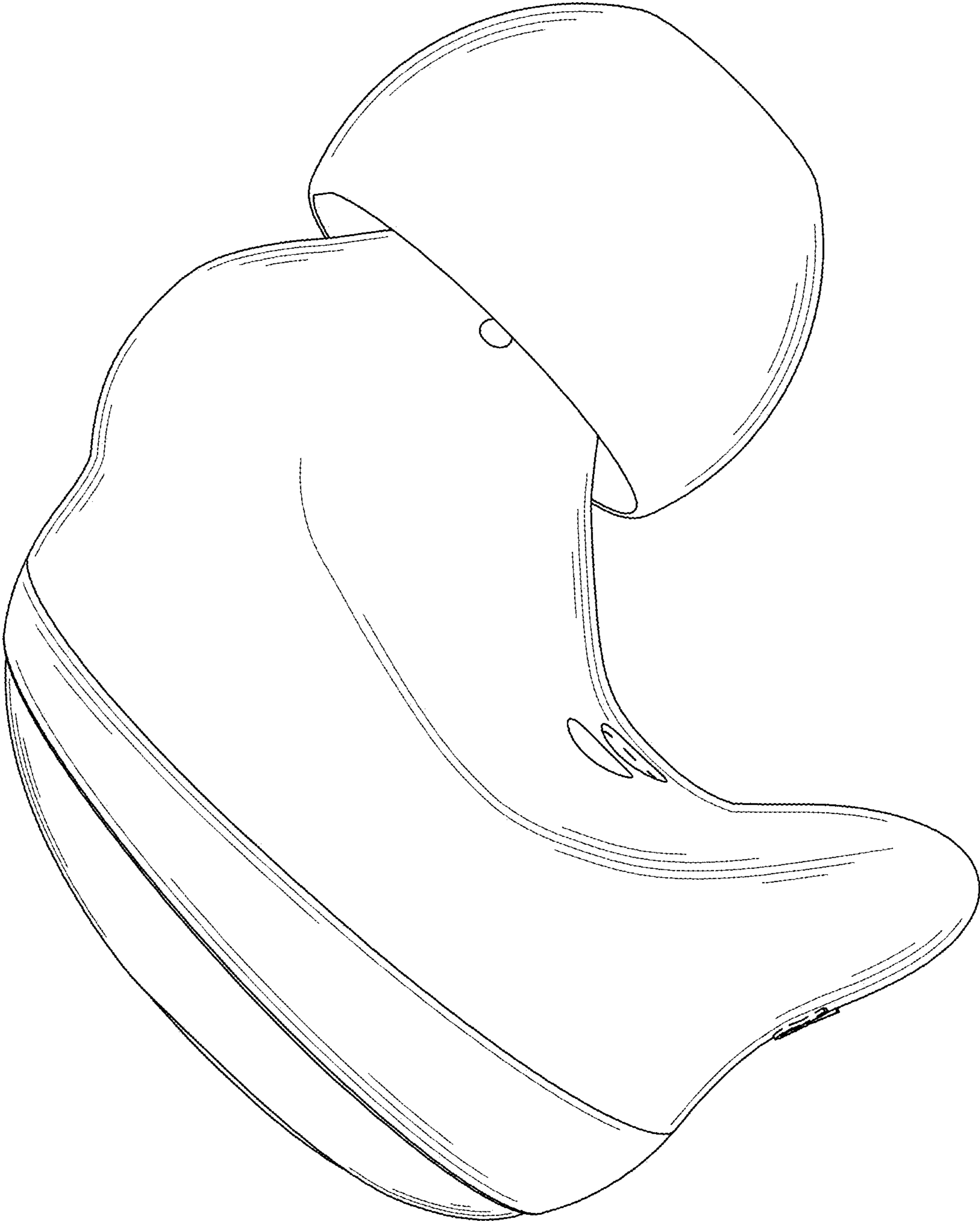

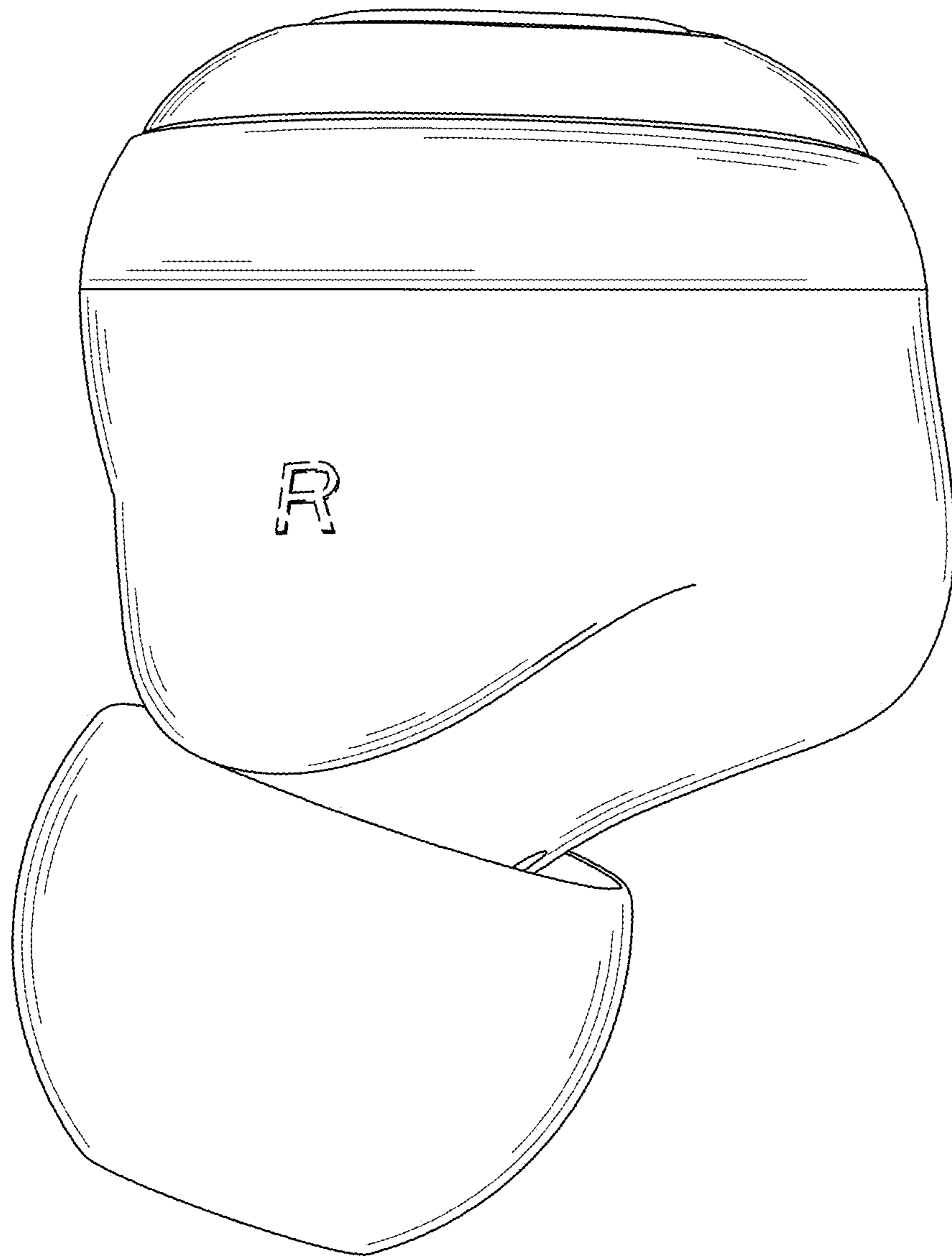

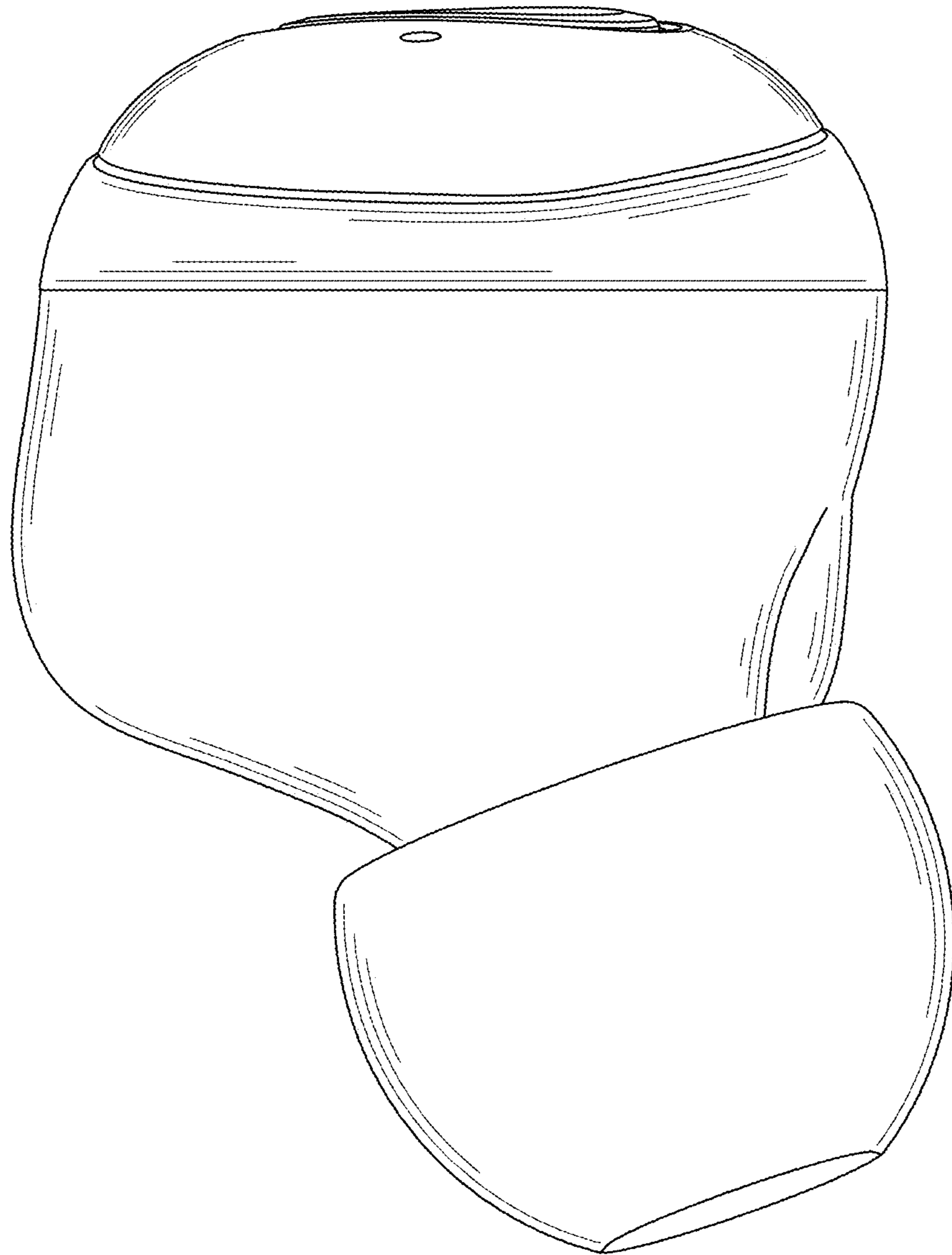

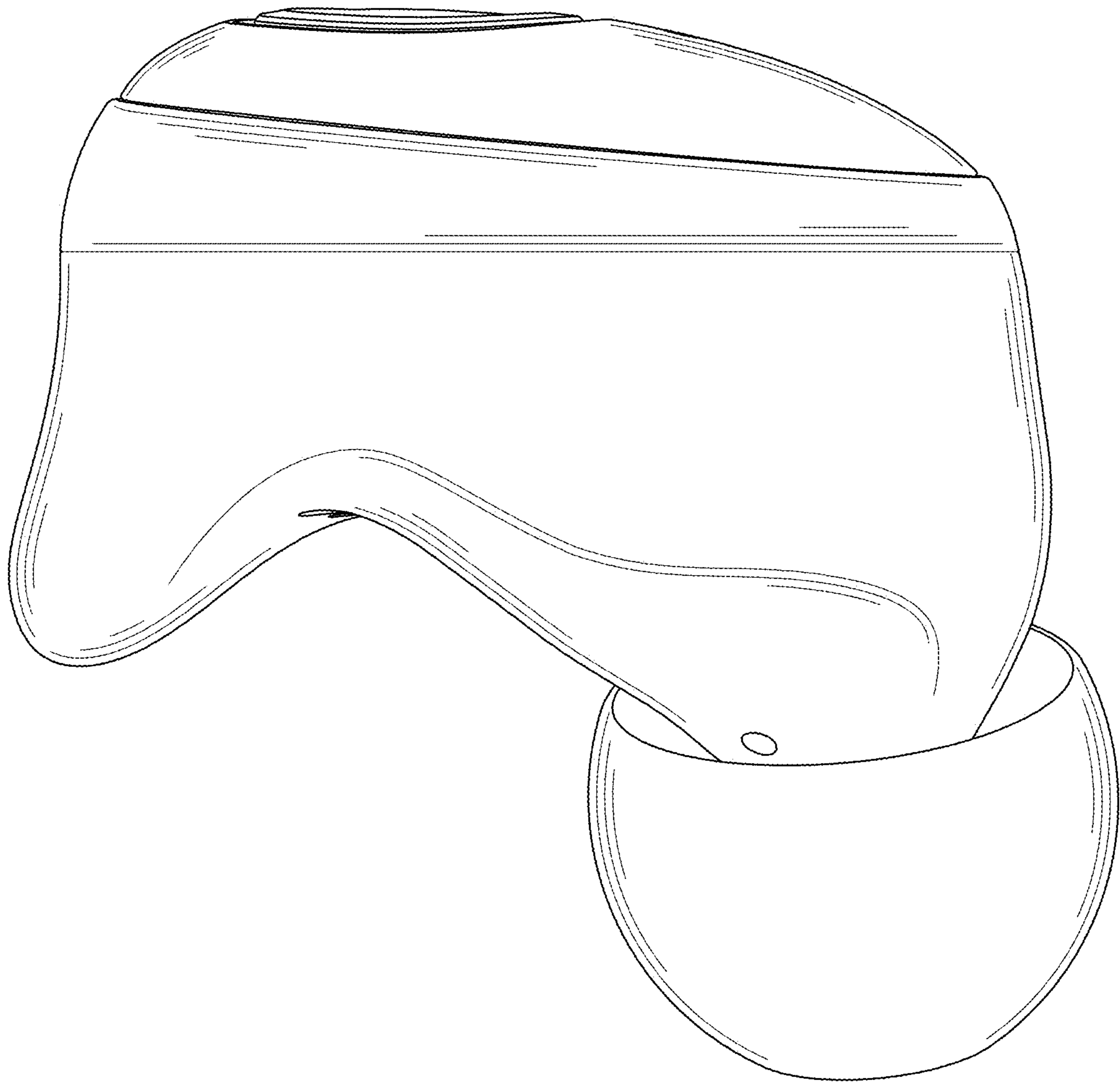

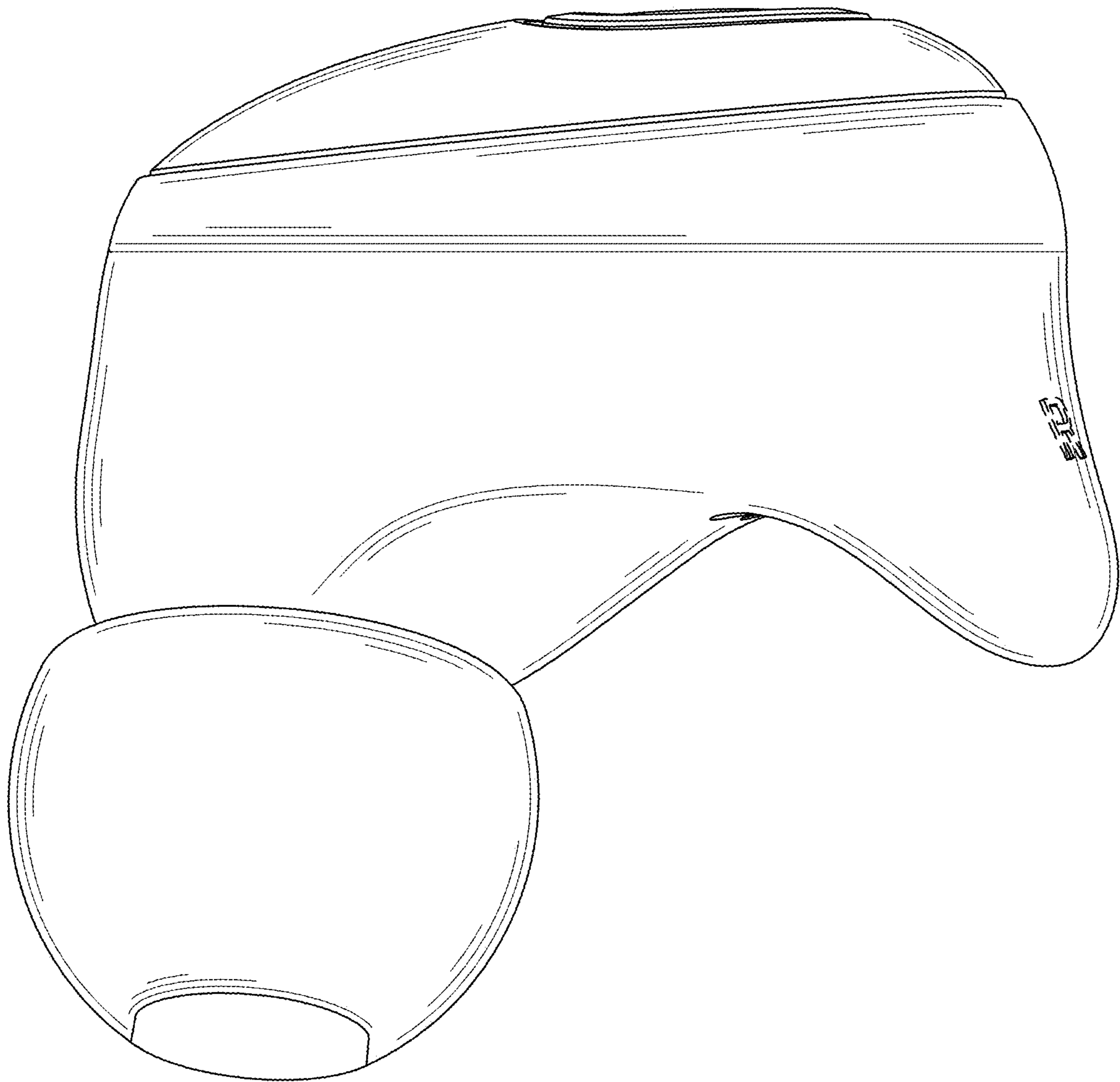

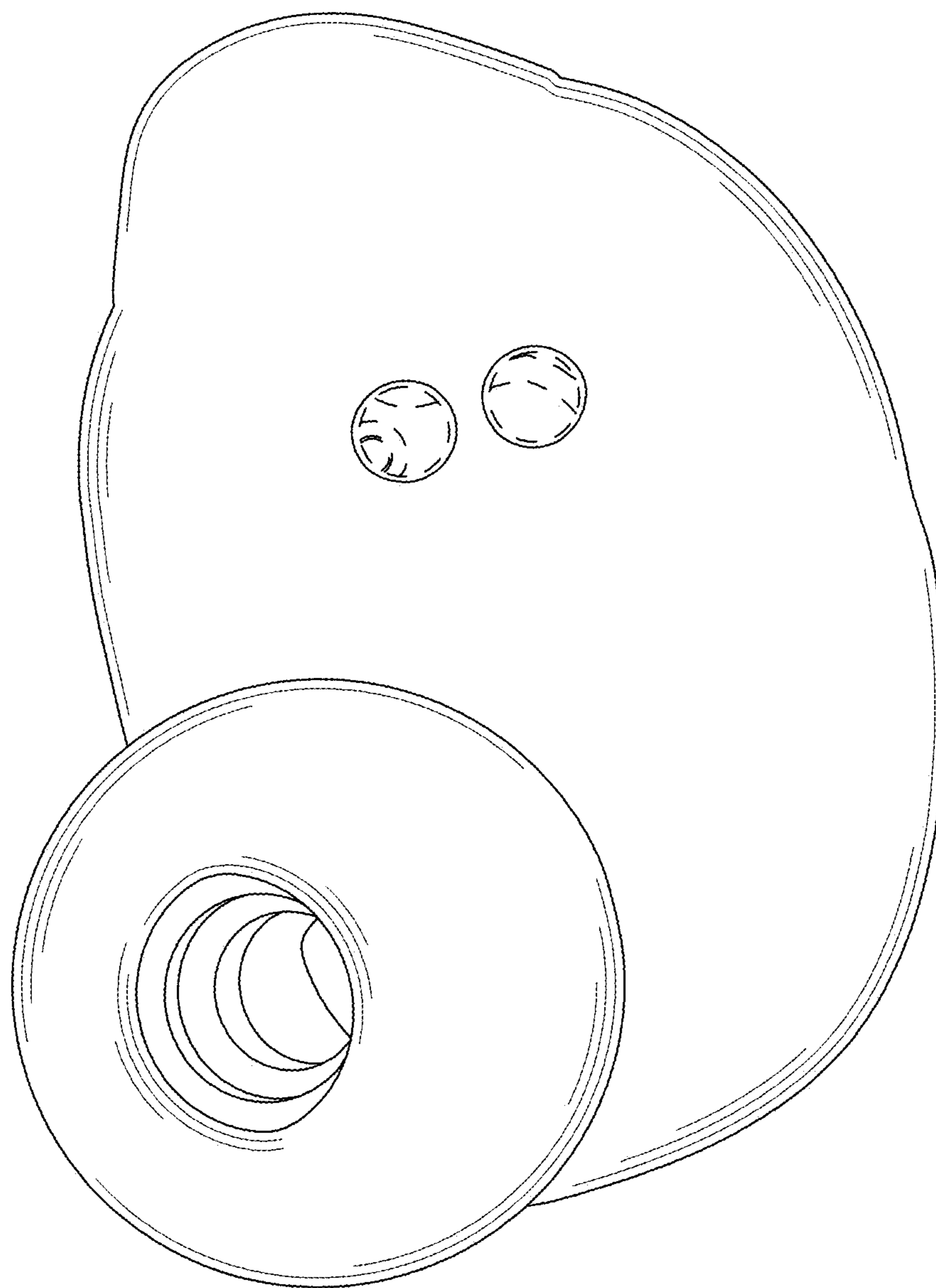

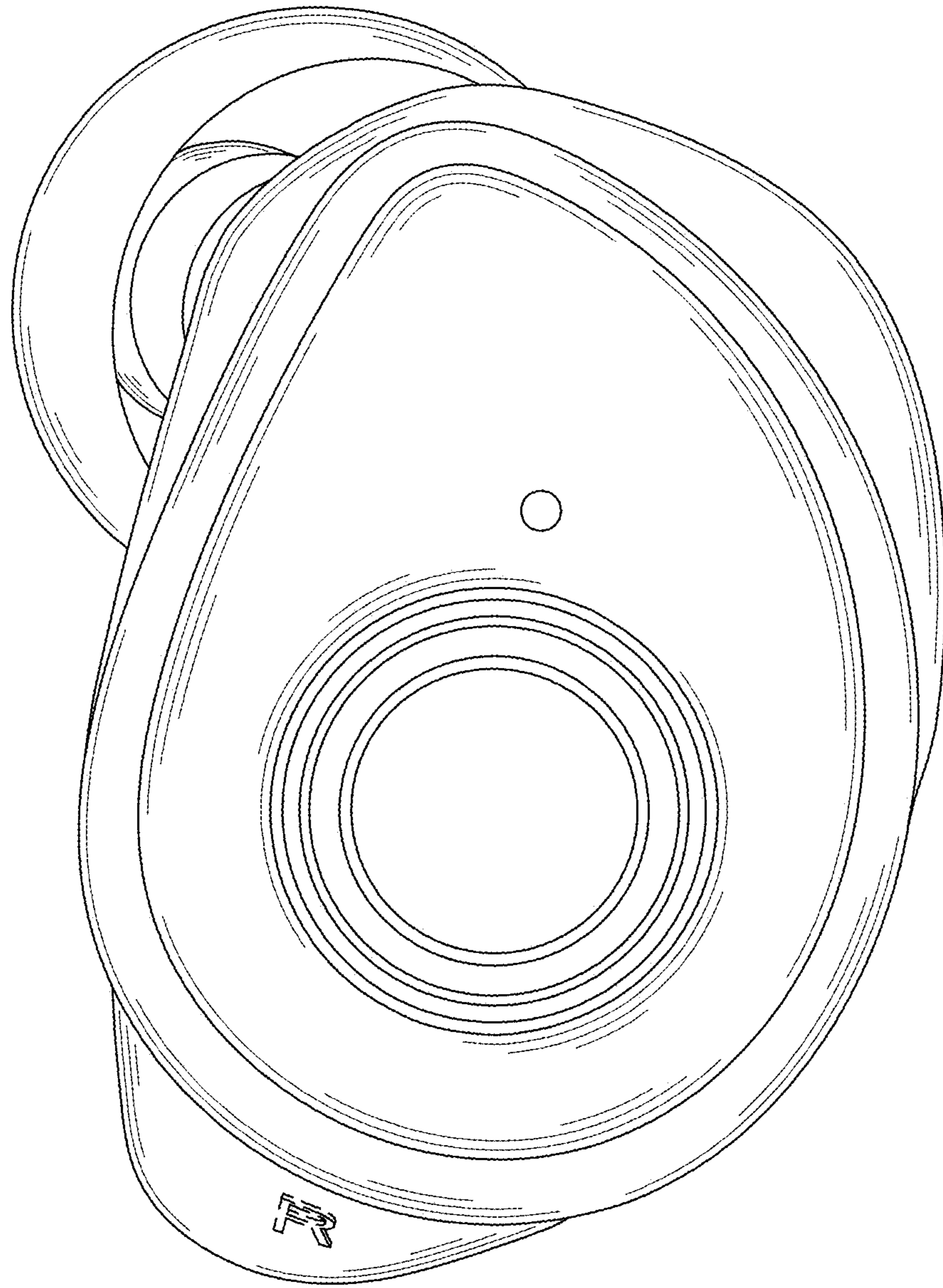
