(57) **CLAIM**

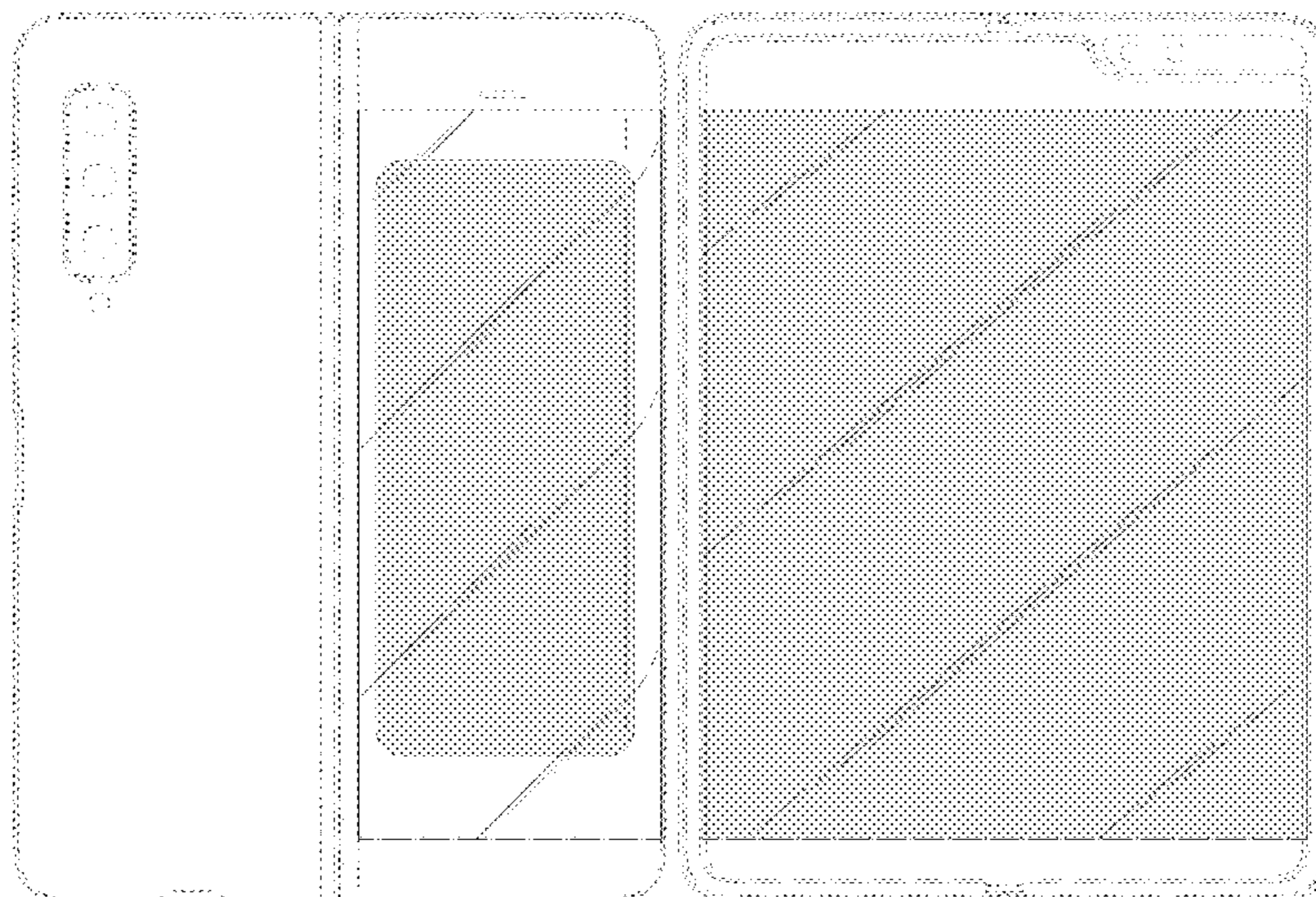
The ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile phone showing our new design according to a first embodiment; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a front perspective view of a mobile phone showing our new design according to a second embodiment; FIG. 9 is a front elevation view thereof; FIG. 10 is a rear elevation view thereof; FIG. 11 is a left side elevation view thereof; FIG. 12 is a right side elevation view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof.

The evenly-spaced dashed broken lines in the figures depict portions of the mobile phone that form no part of the claimed design. The dot-dash broken lines in the figures define the bounds of the claim and form no part of the claimed design. The gray overlay shown over the surfaces included in the claim shows a lack of color contrast between the areas in which it is used and is not representative of any color or tonality.

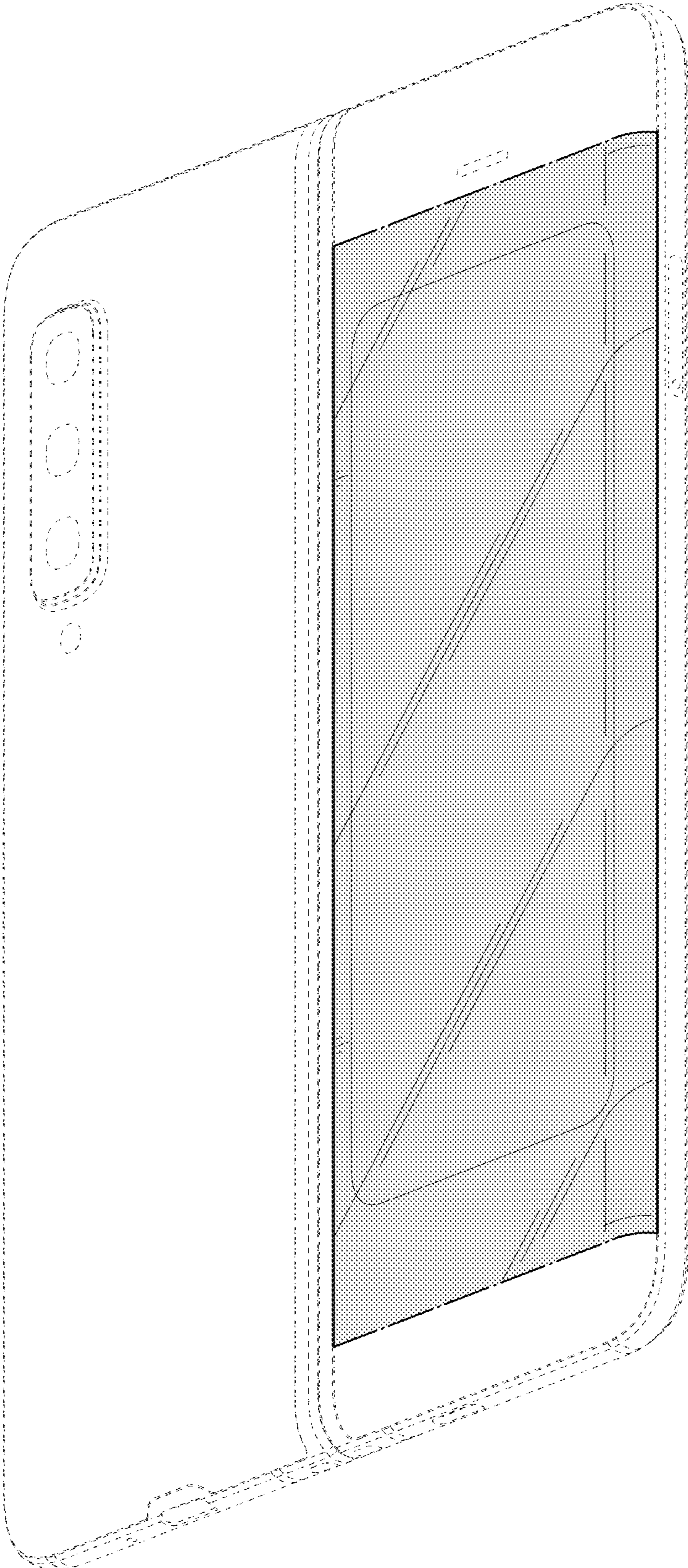

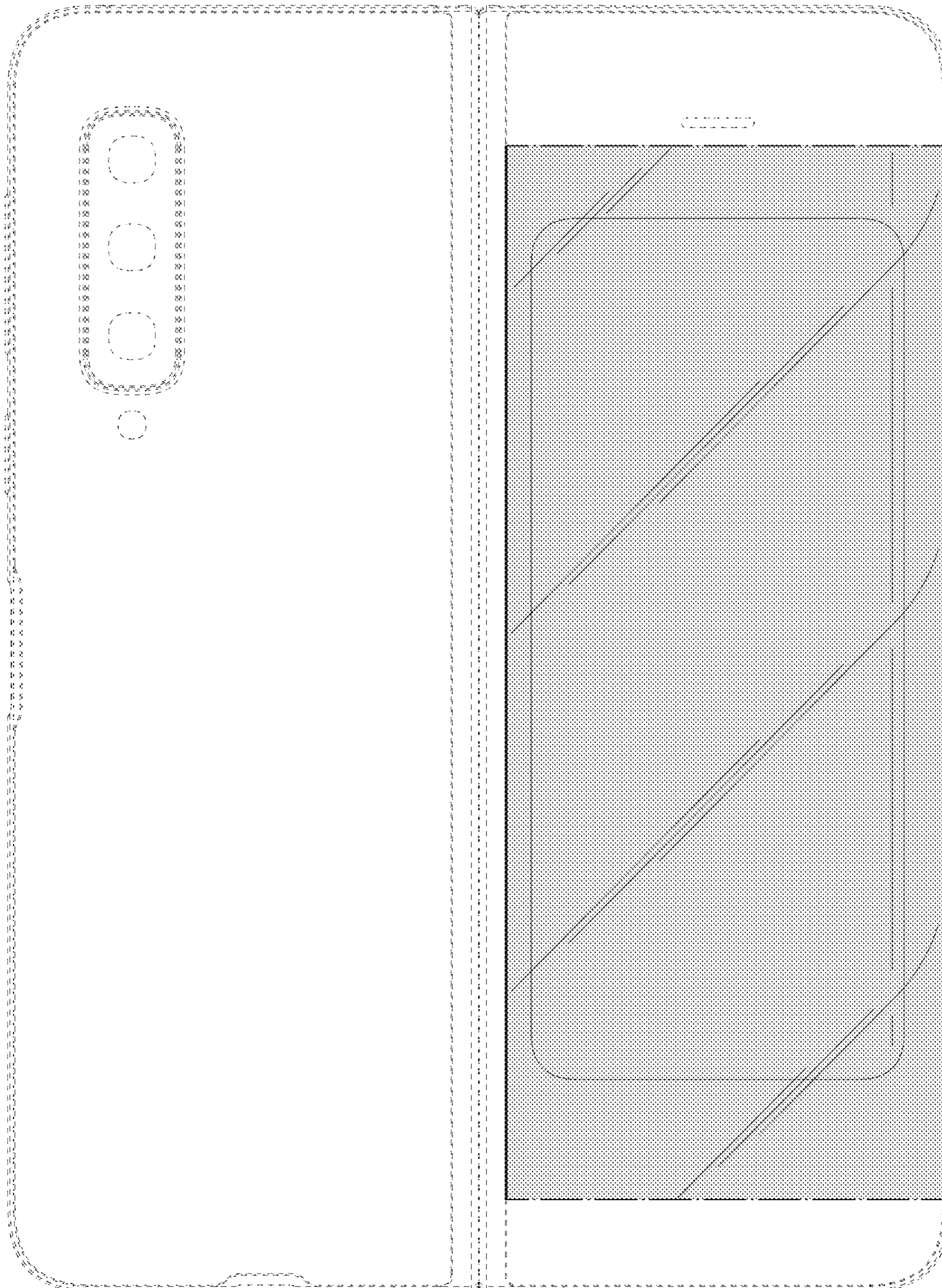

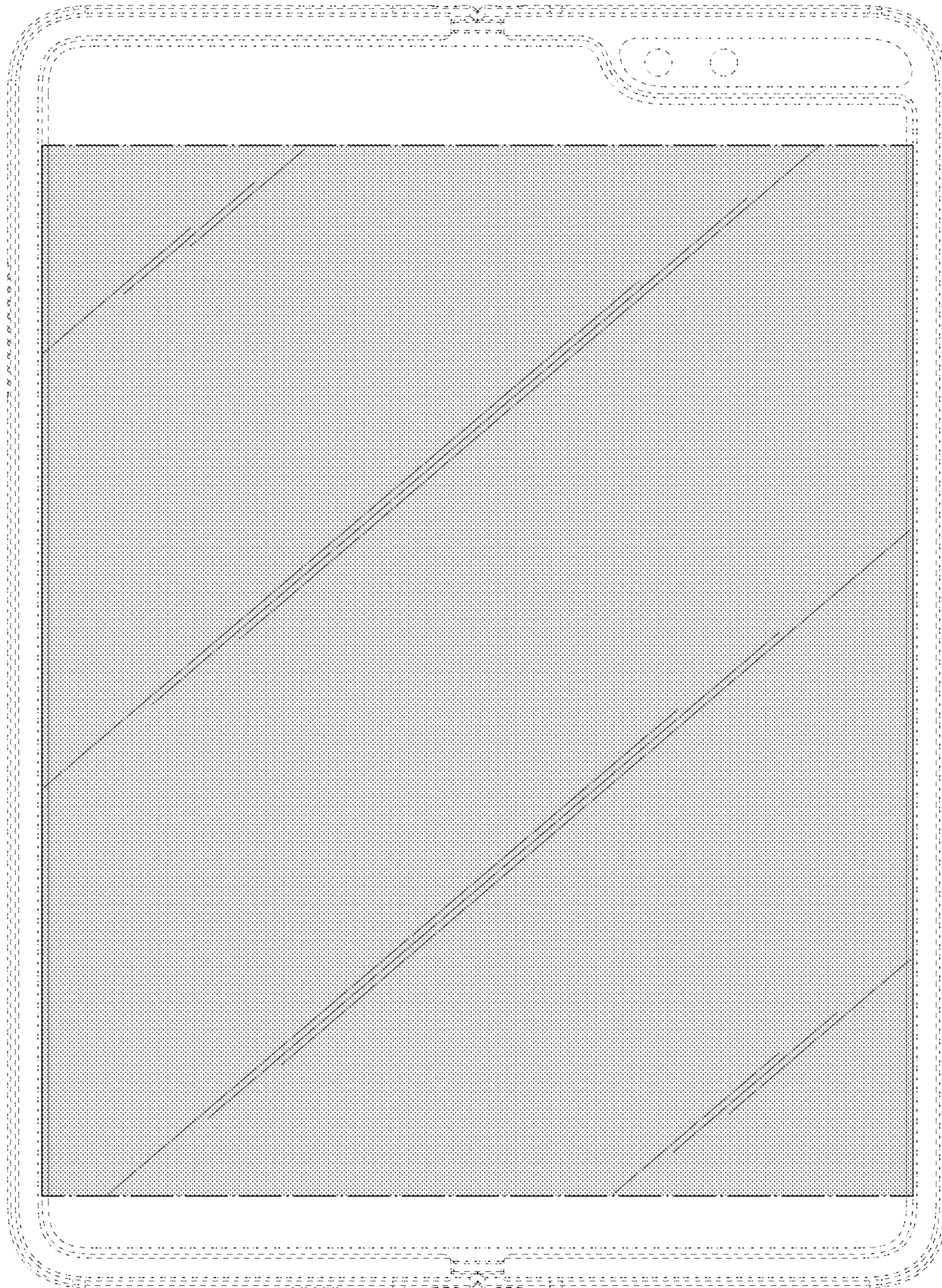

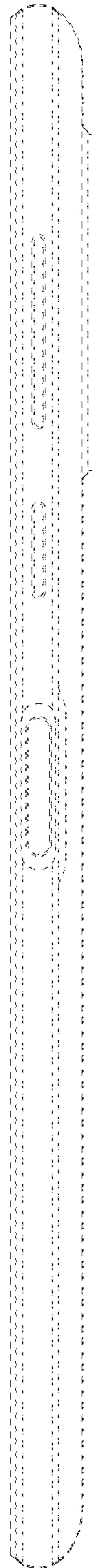

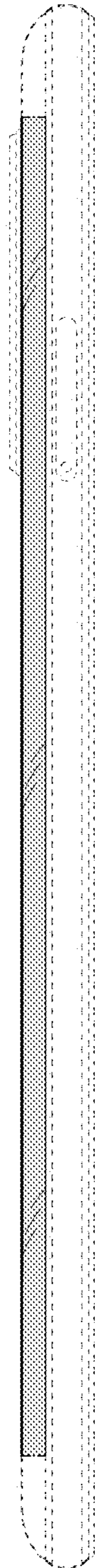

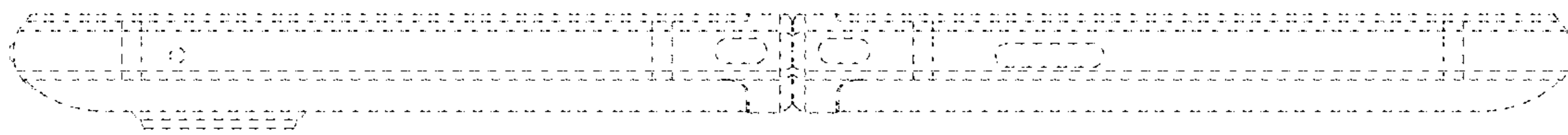

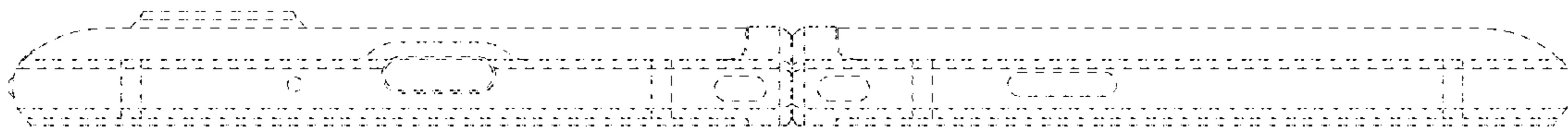

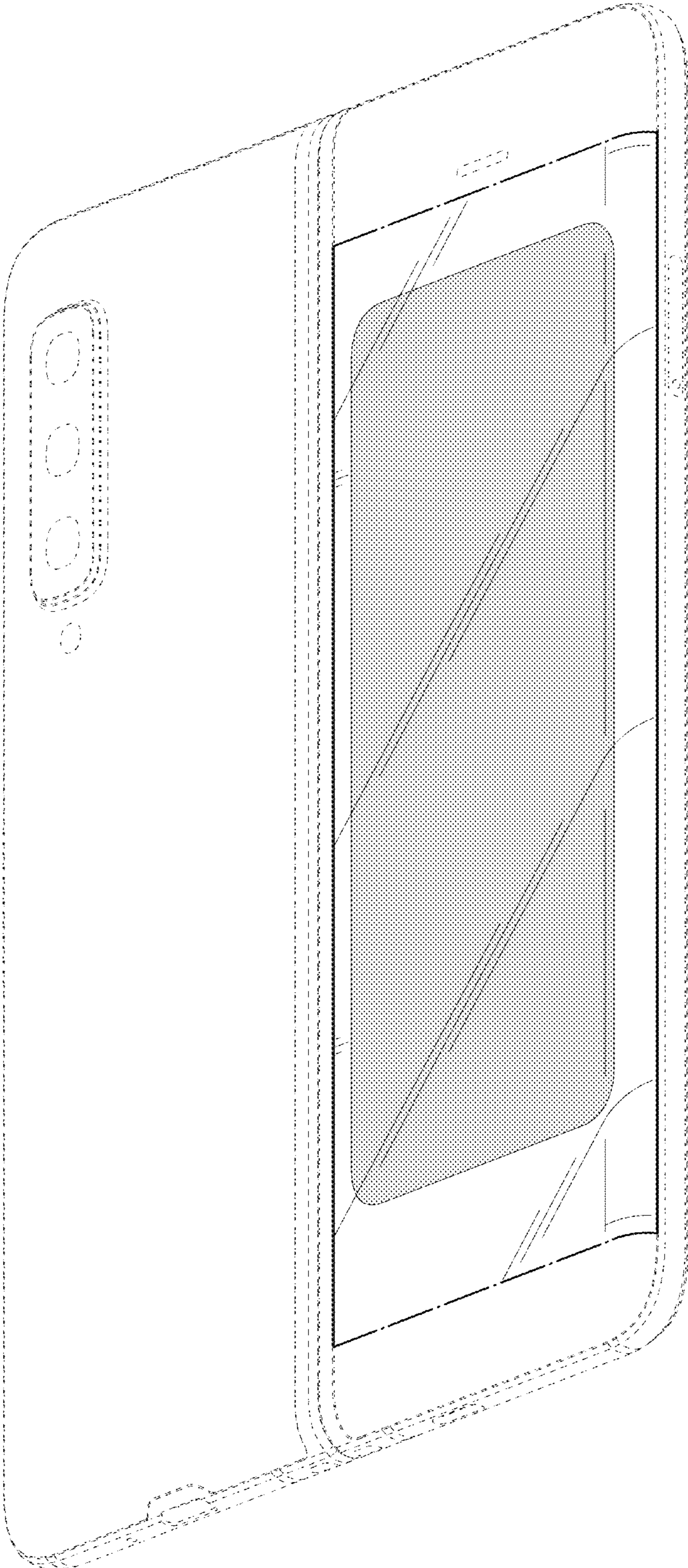

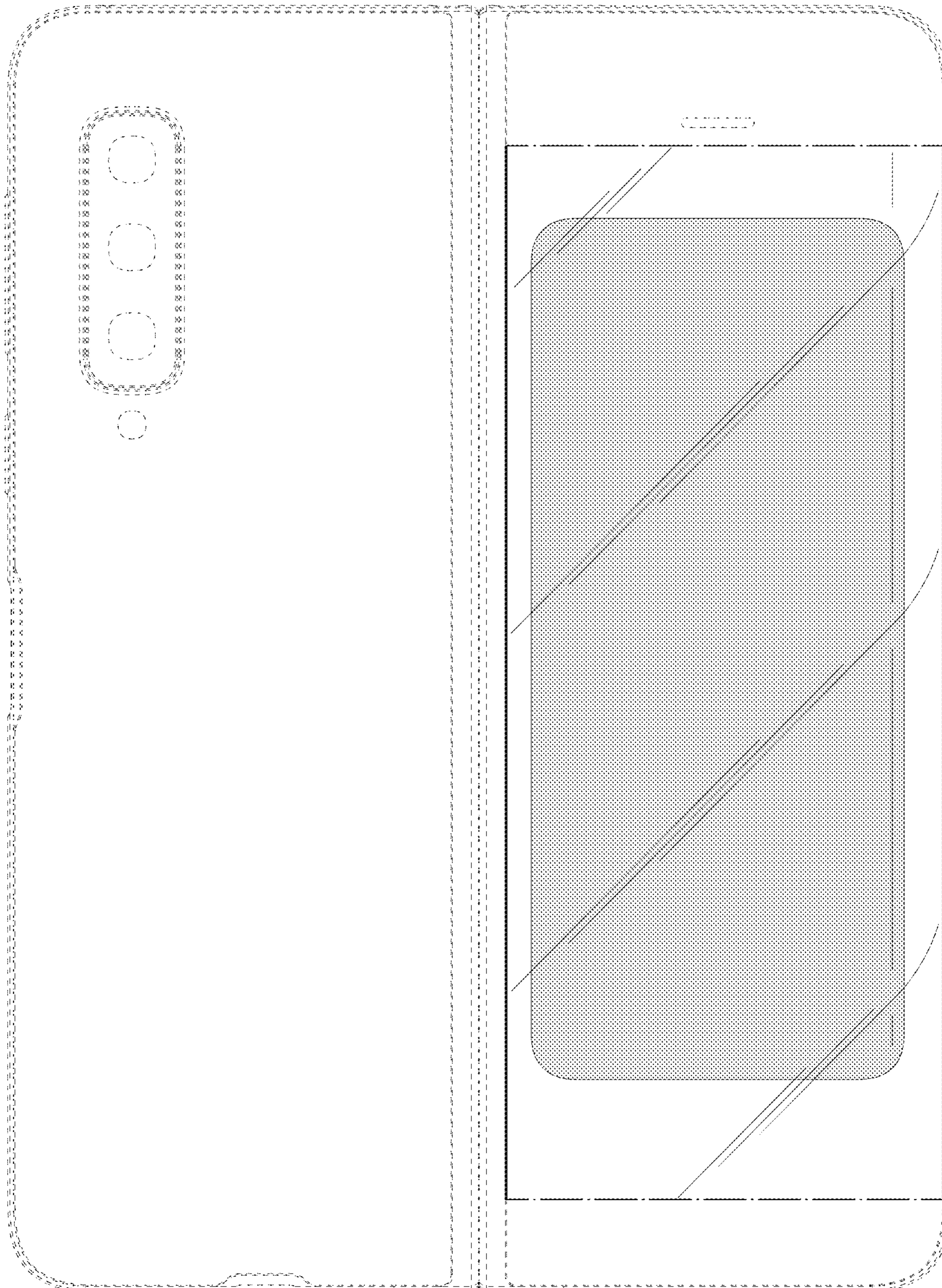

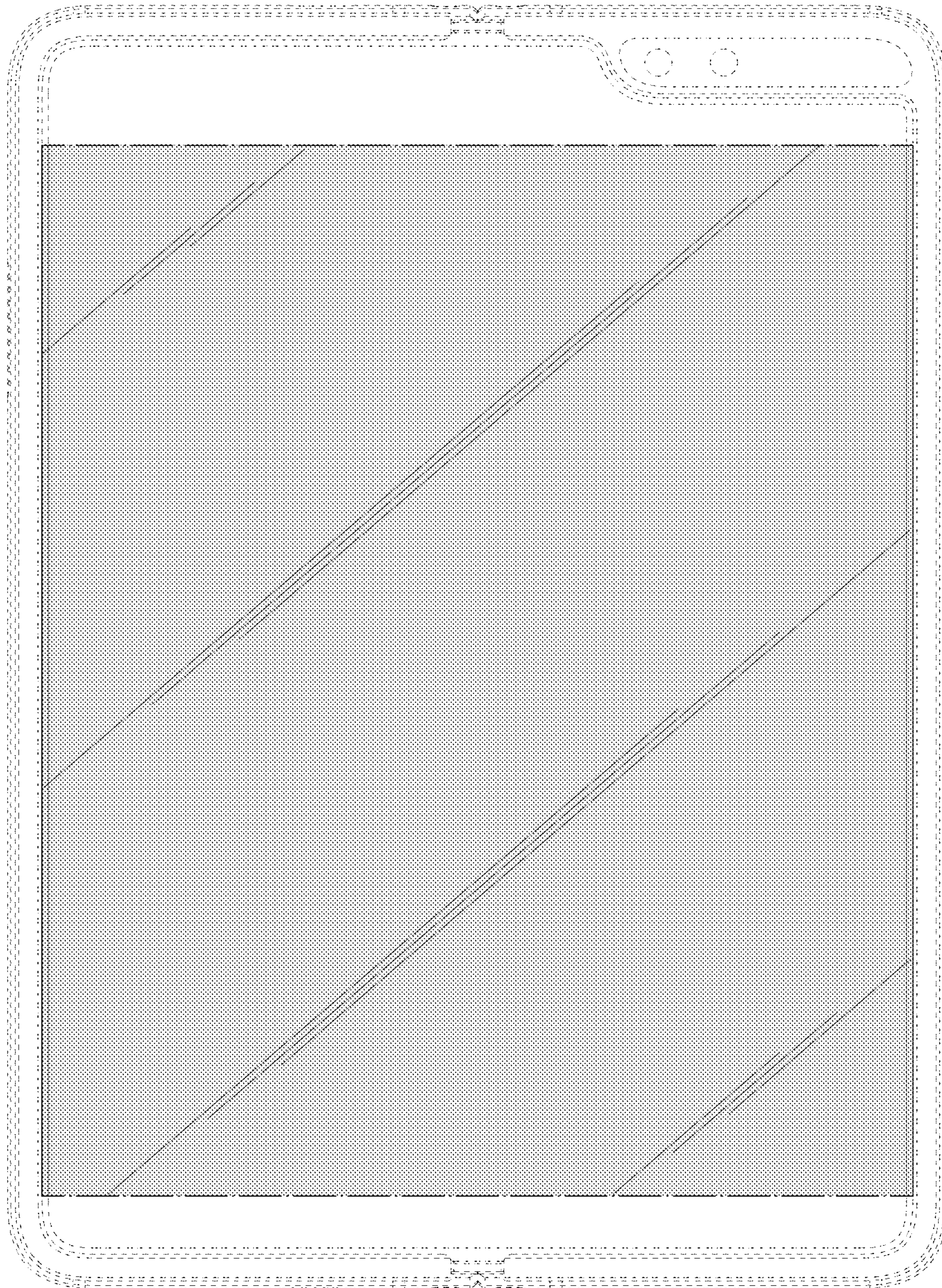

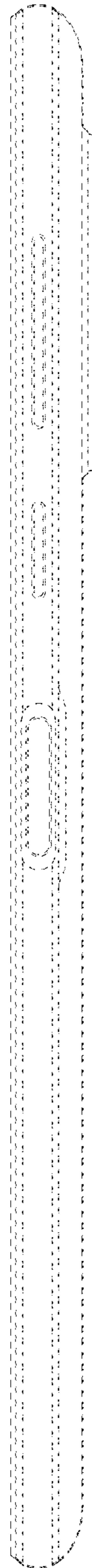

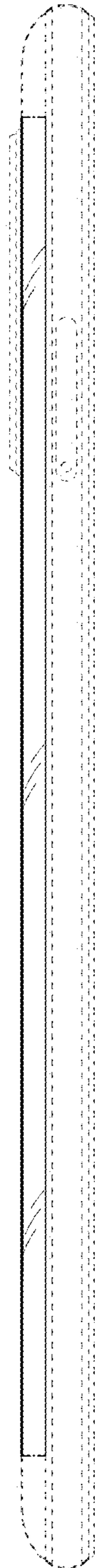

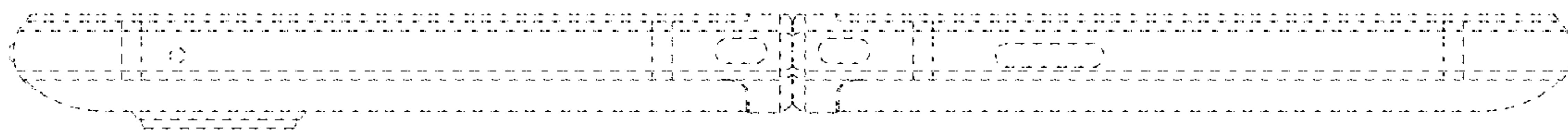
