I claim the ornamental design for a pickup kiosk, as shown and described.

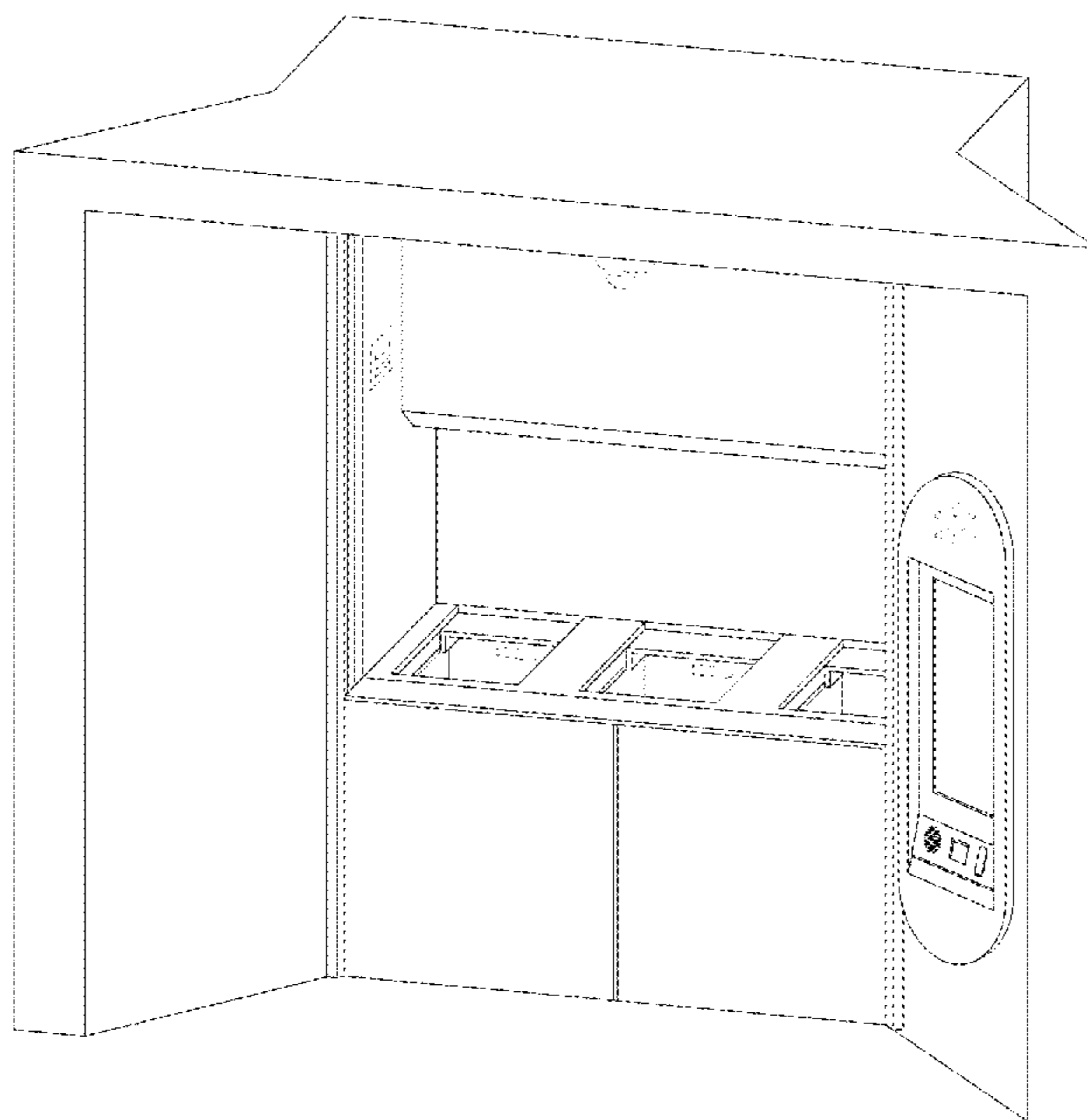
DESCRIPTION

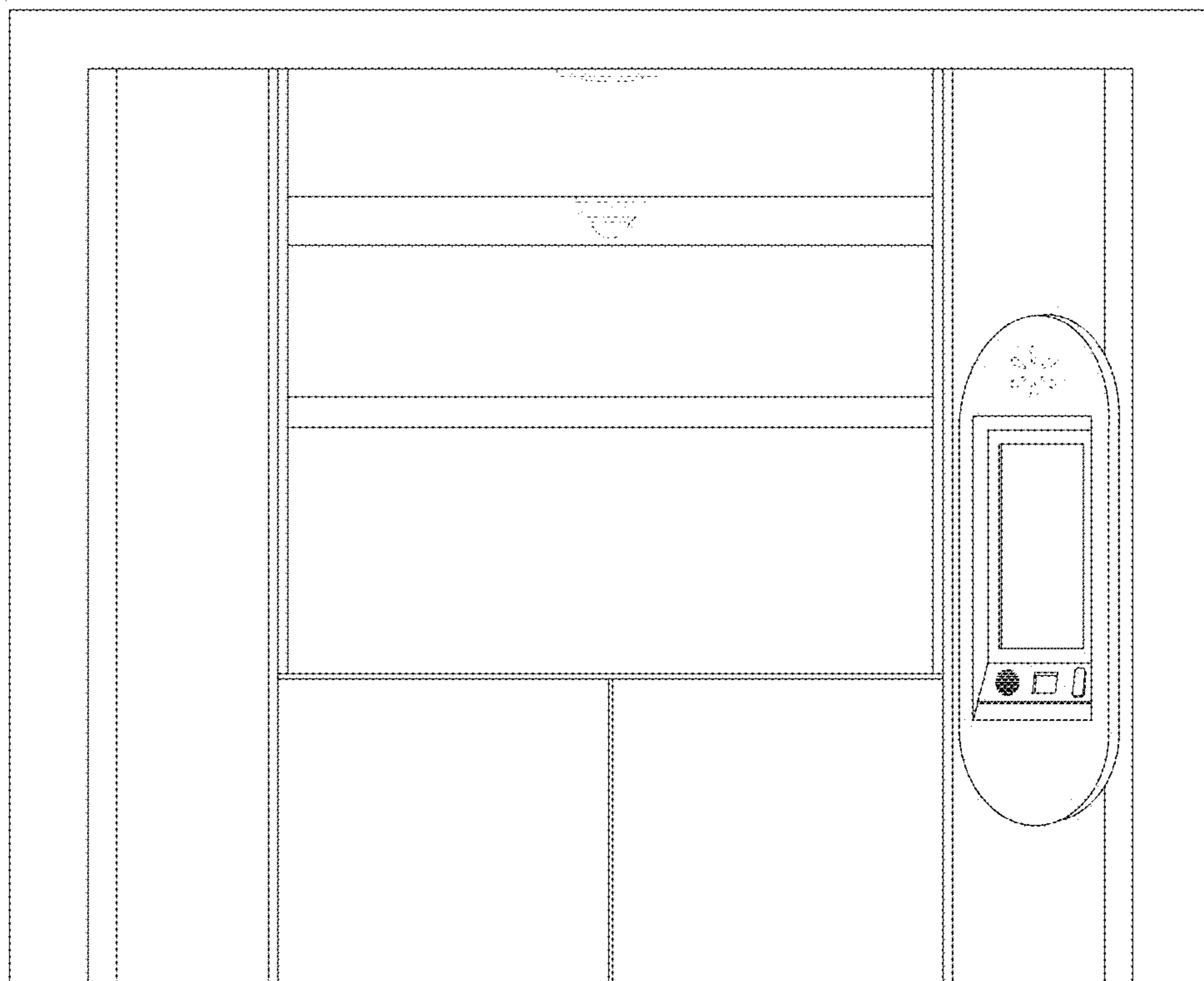

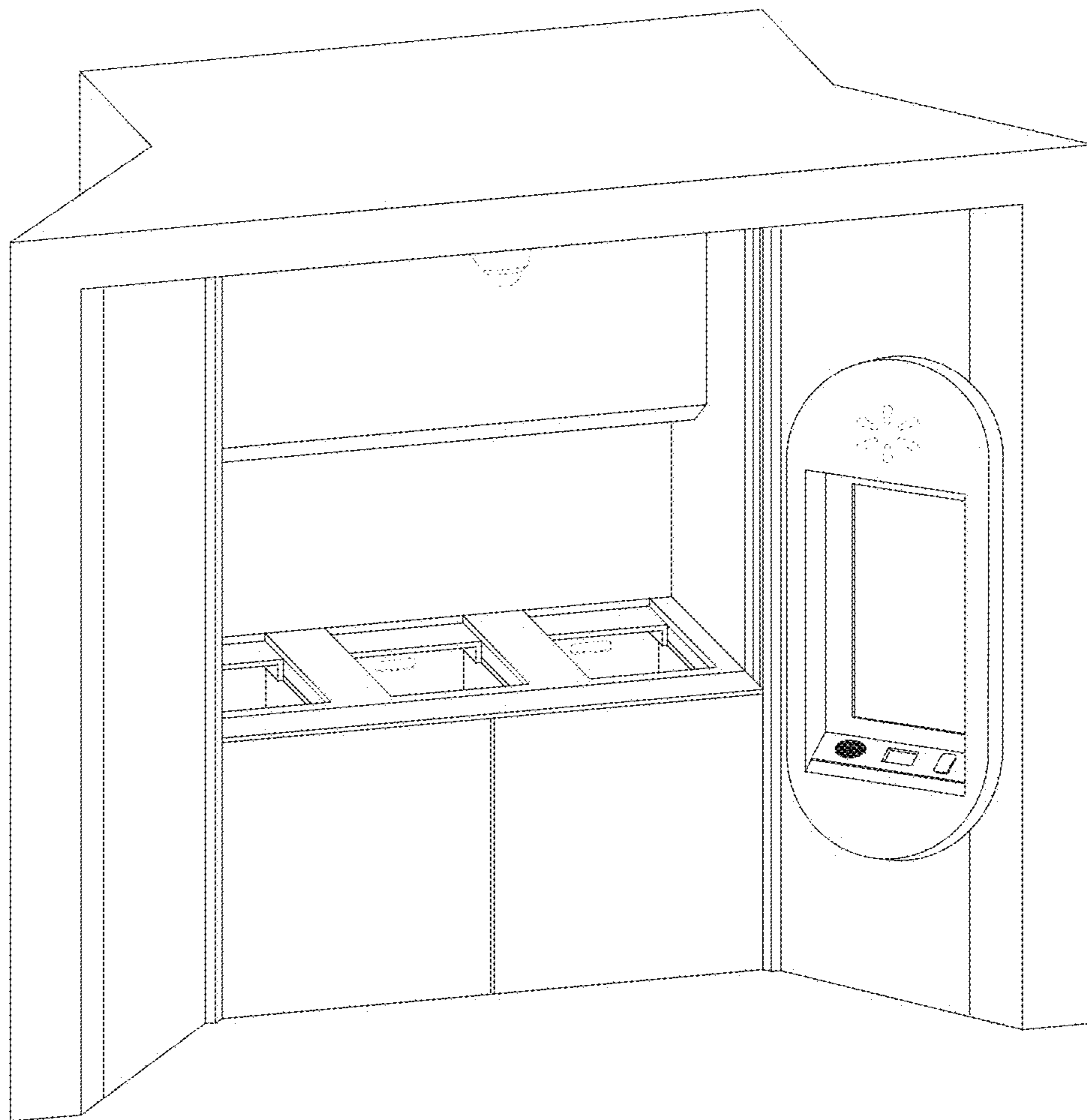

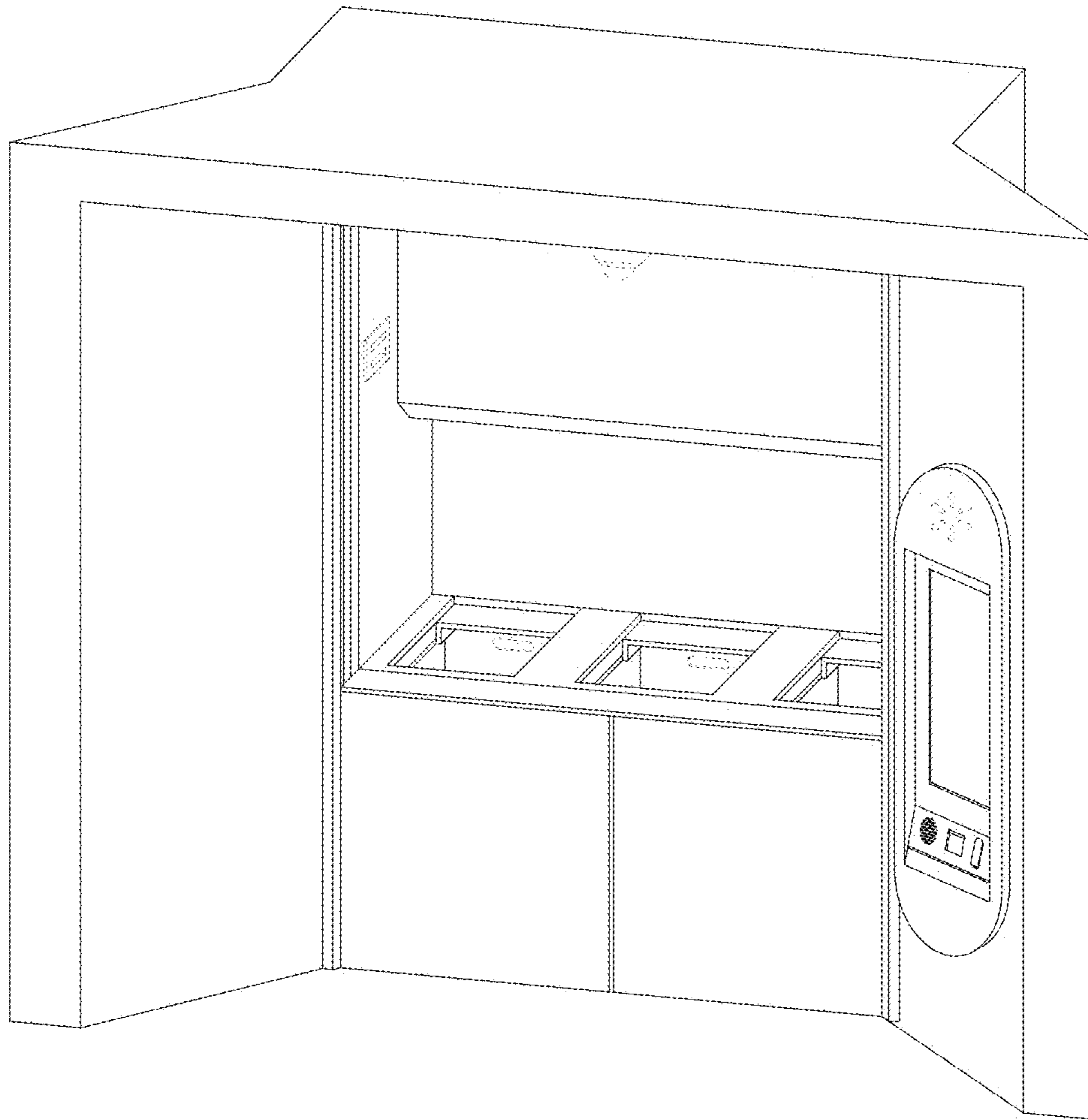

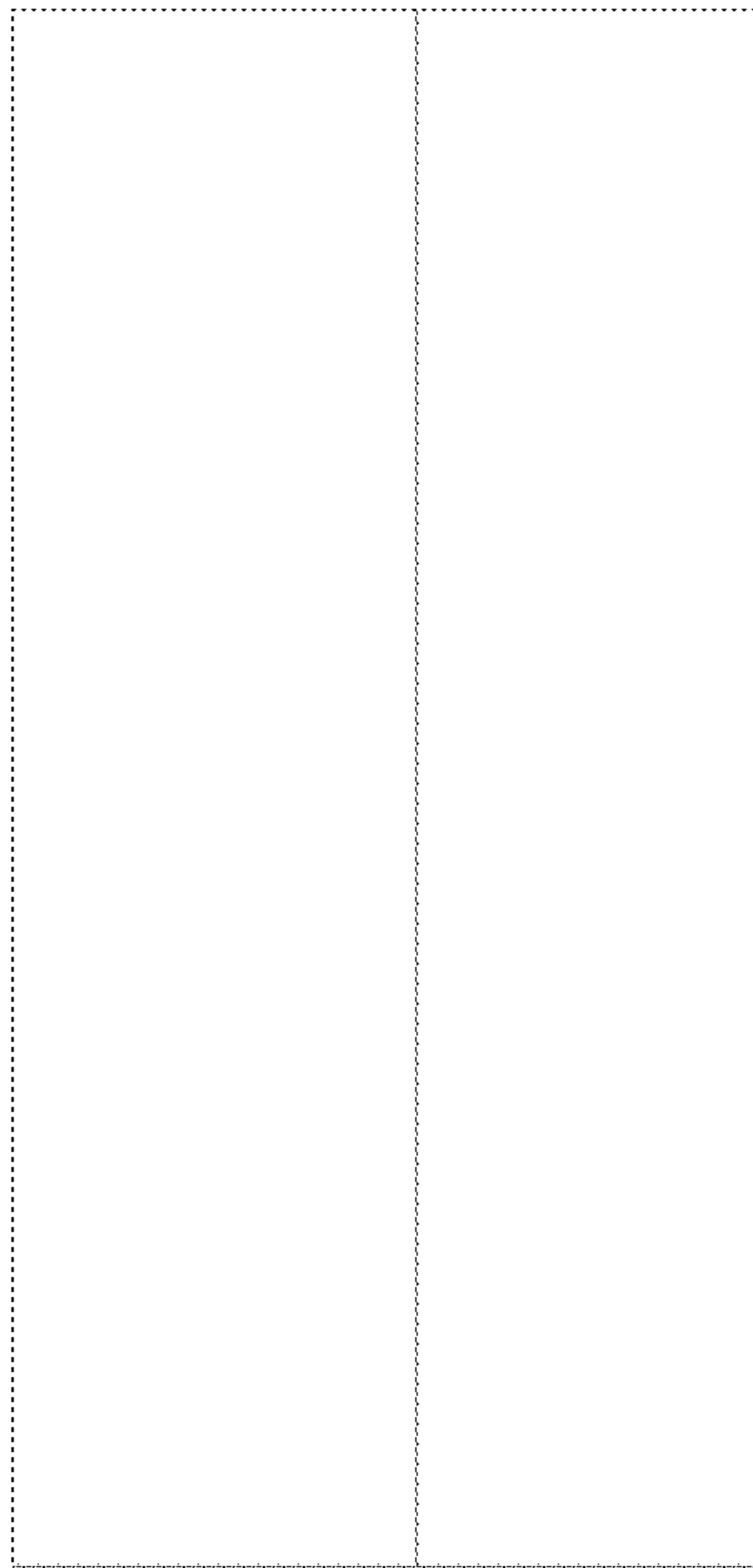

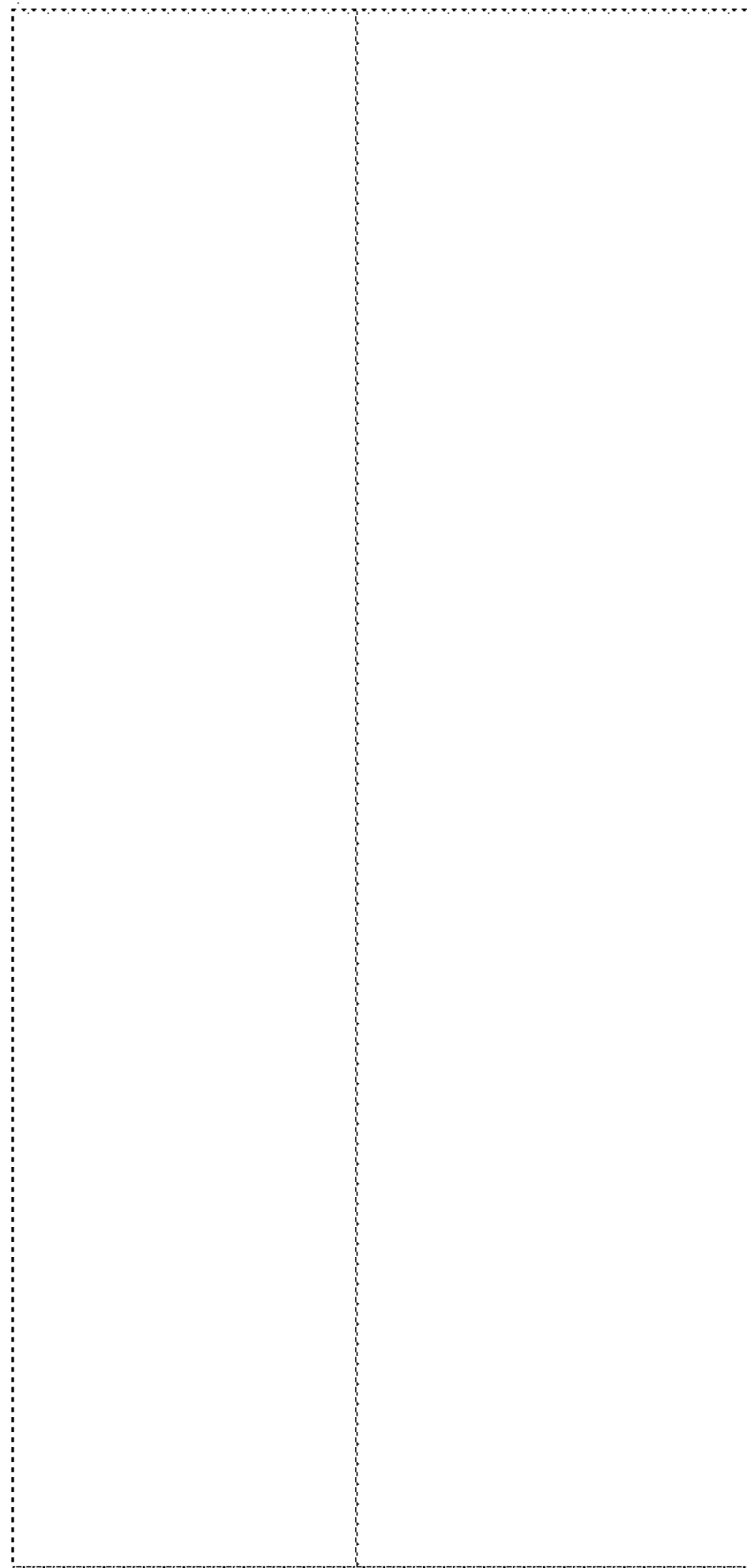
