The ornamental design for a foldable display positioning assembly, as shown and described.

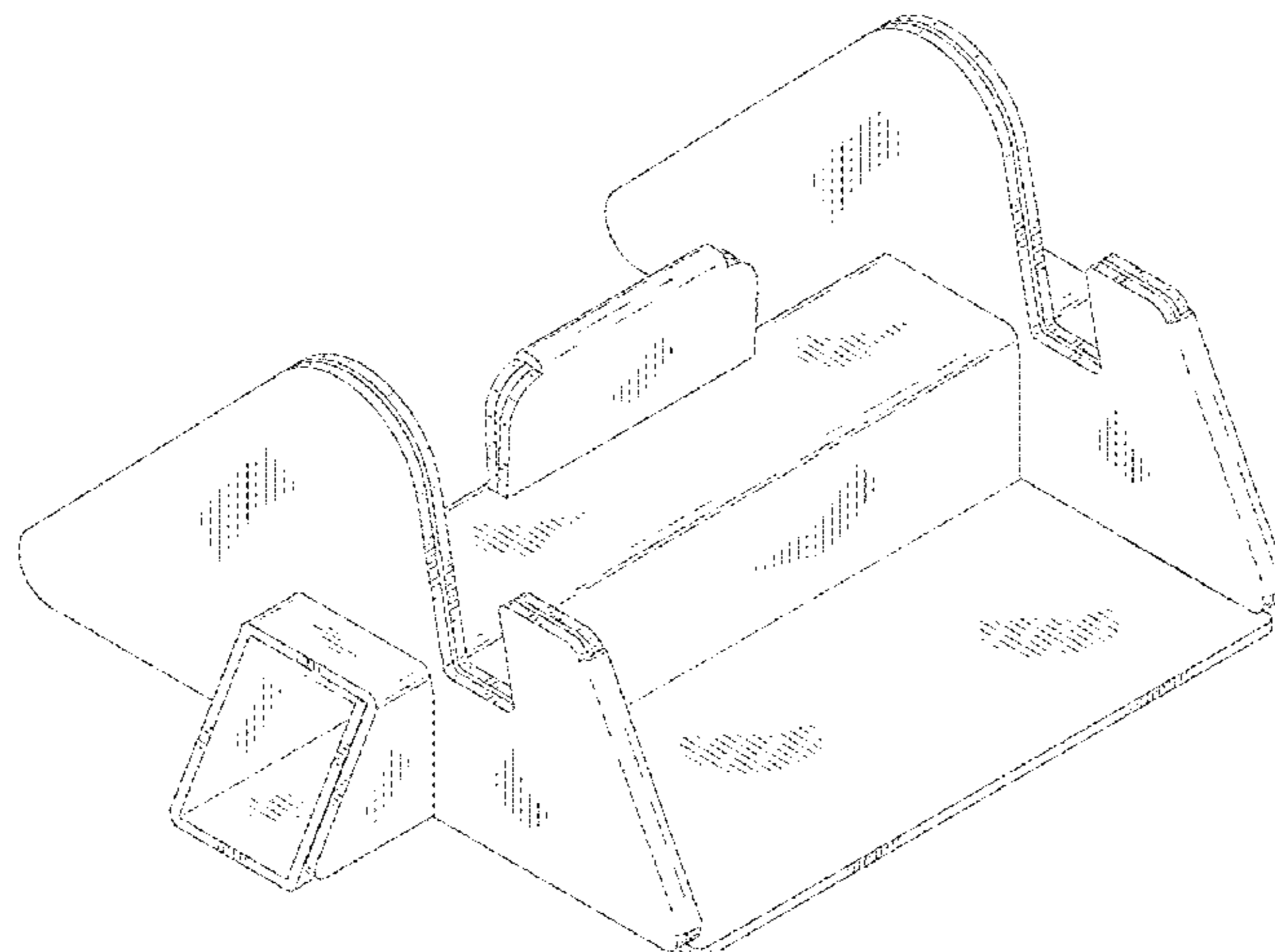


FIG. 32 is a top perspective view of a different and unfolded portion of the foldable display positioning assembly shown separately for clarity of illustration.

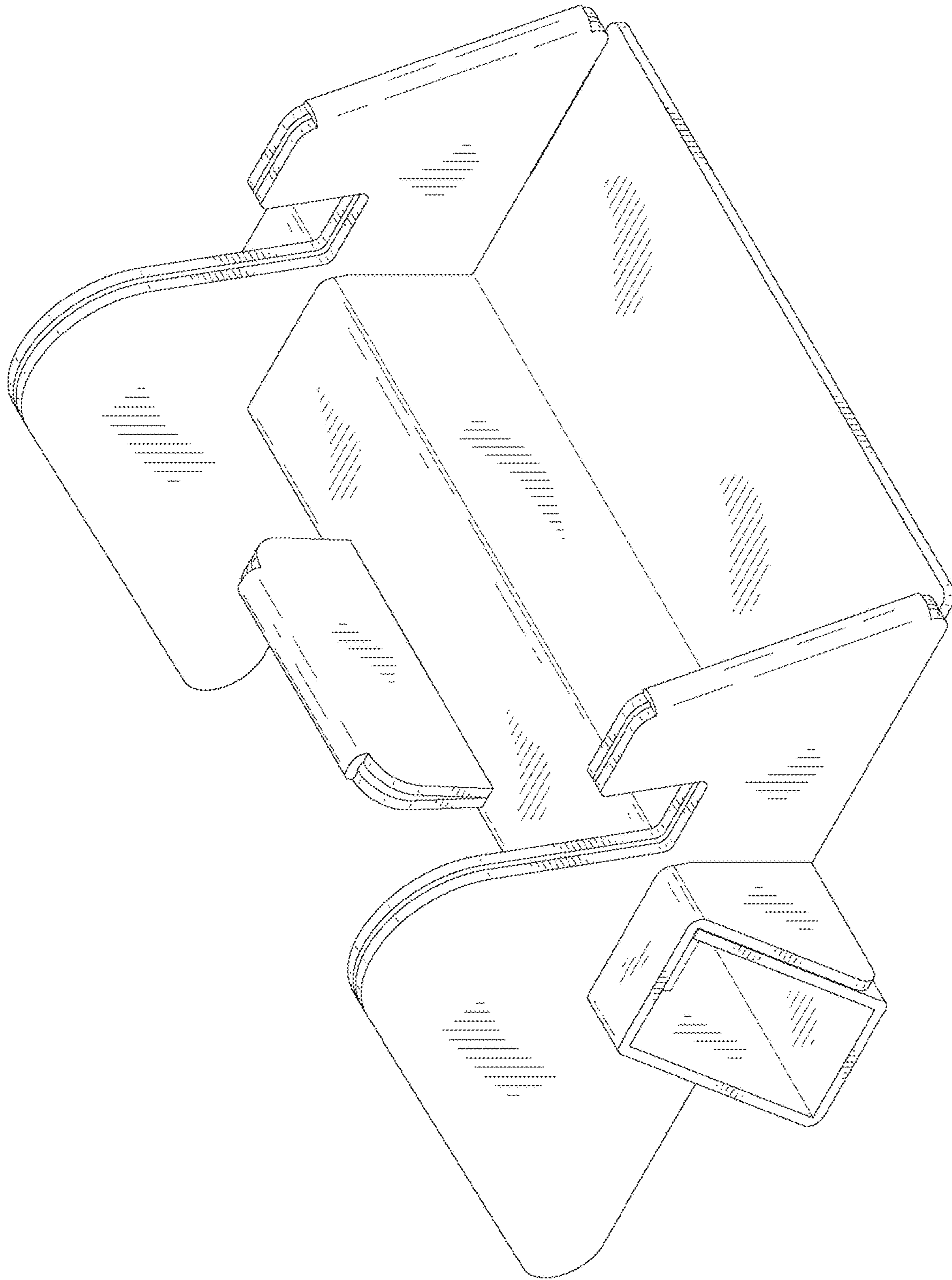

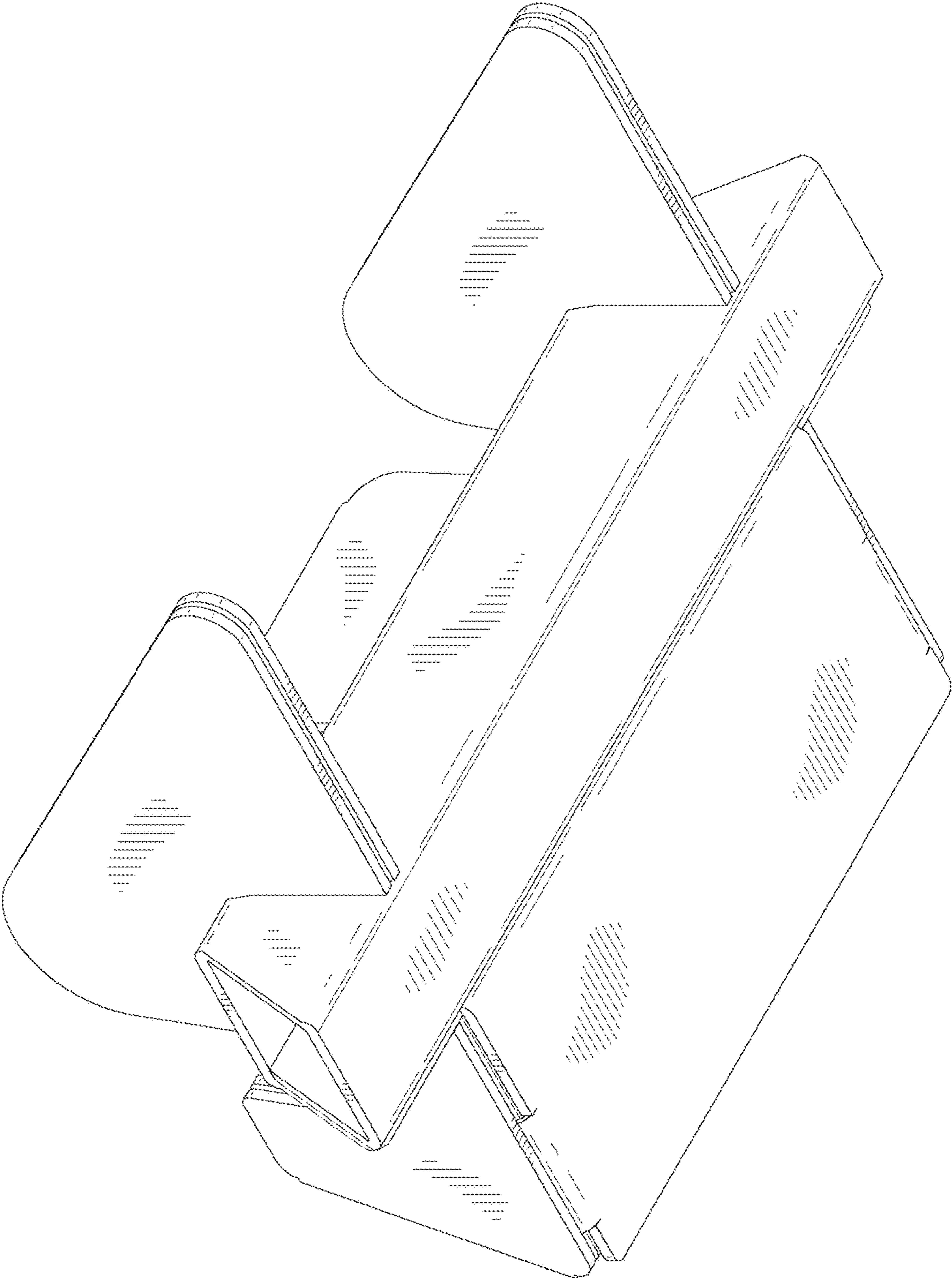

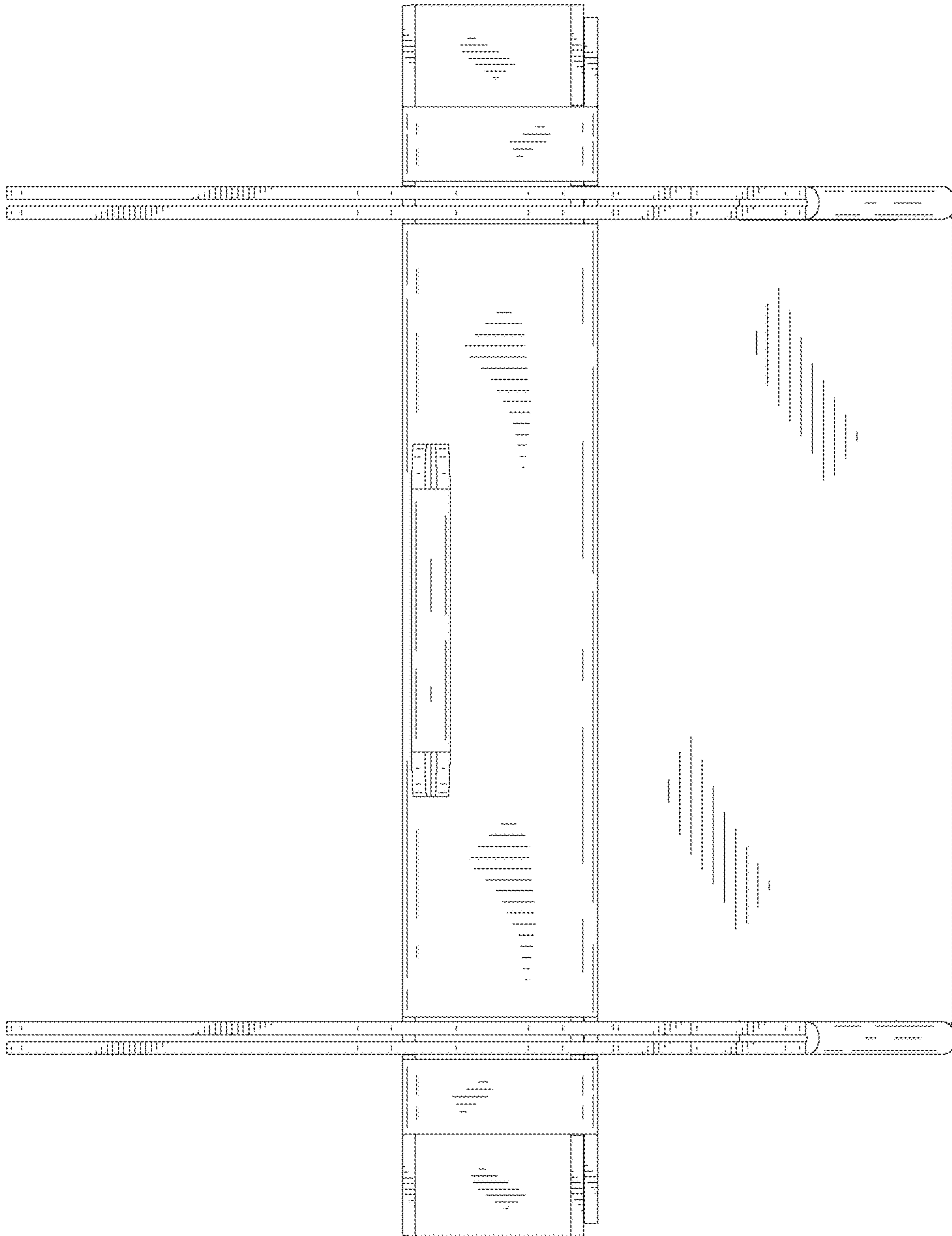

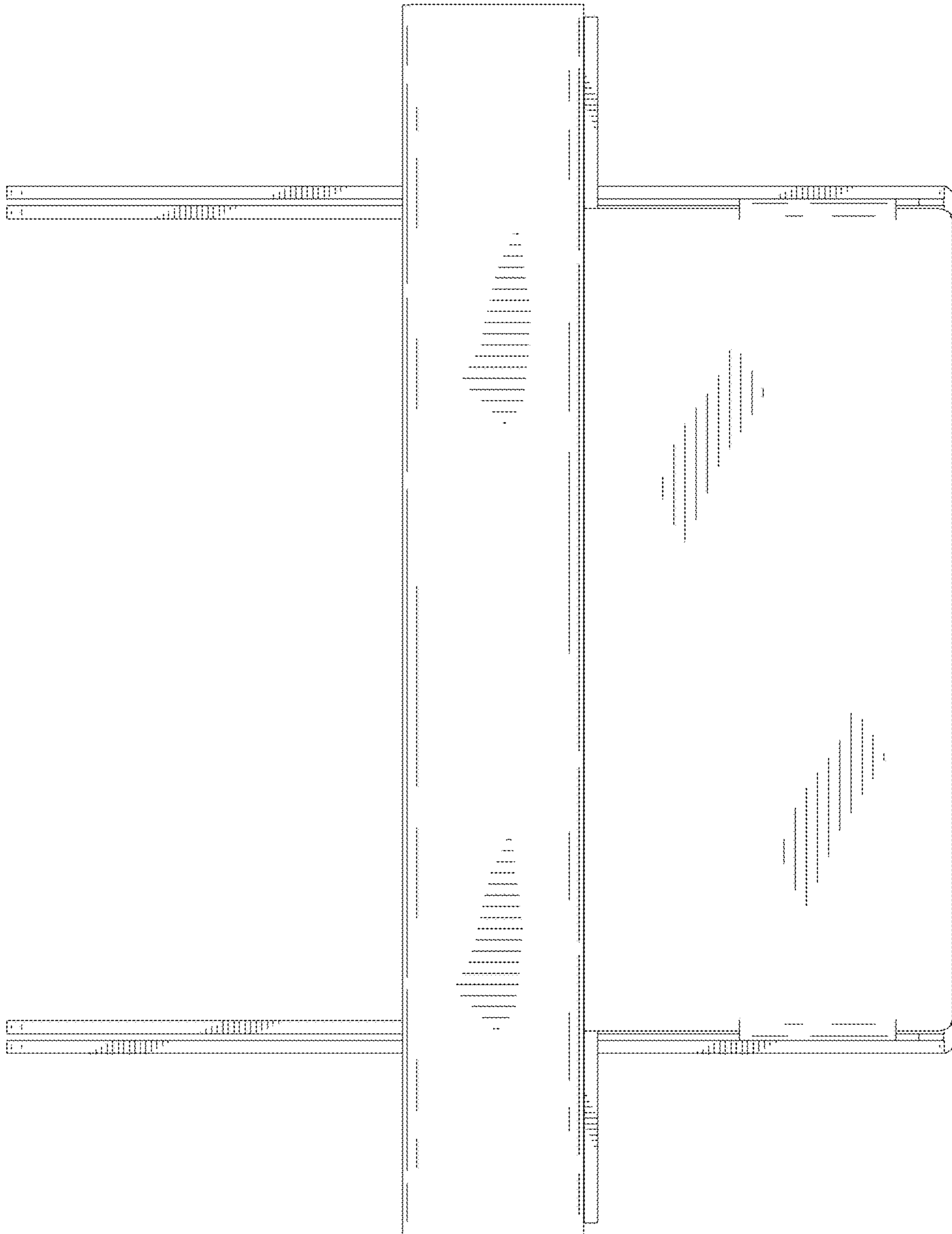

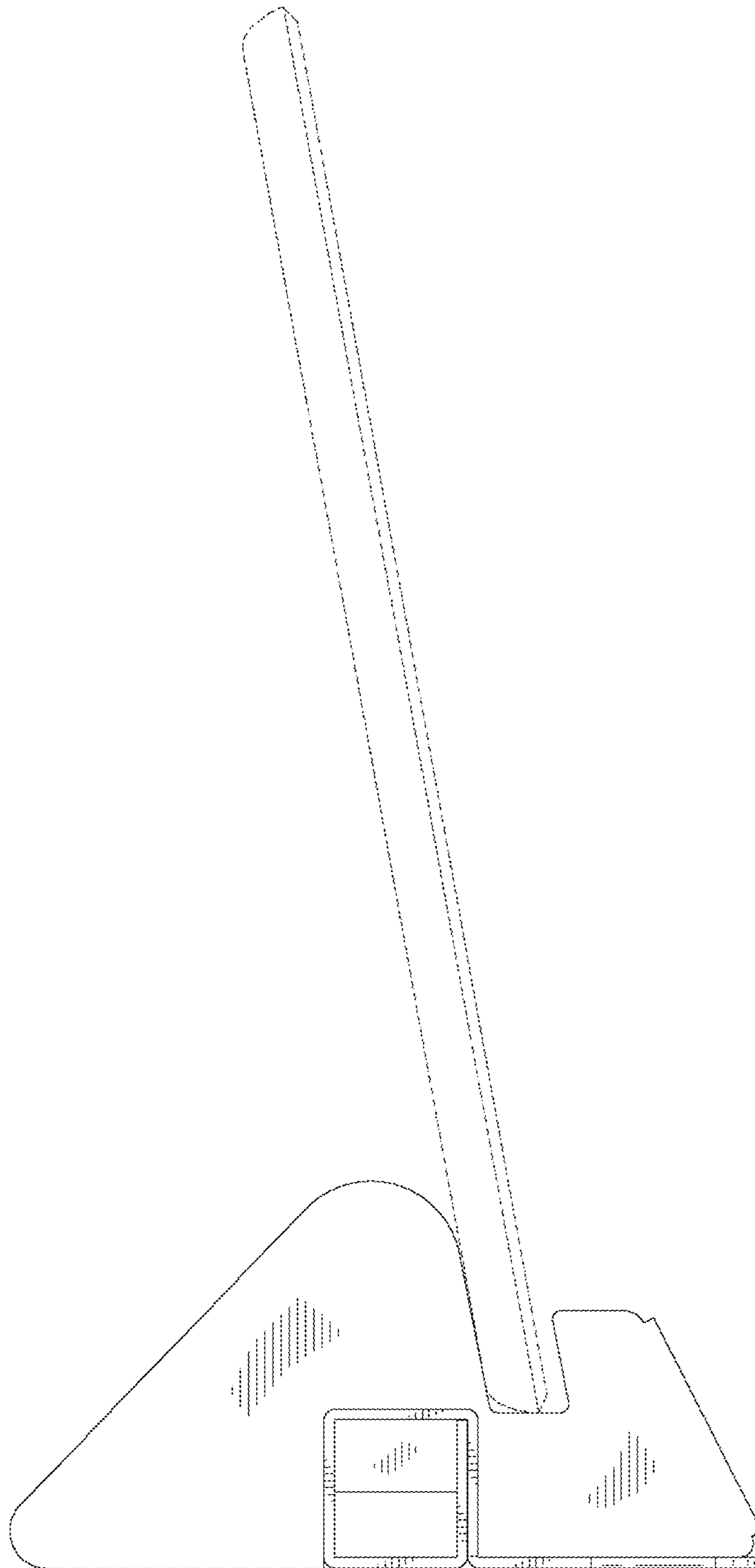

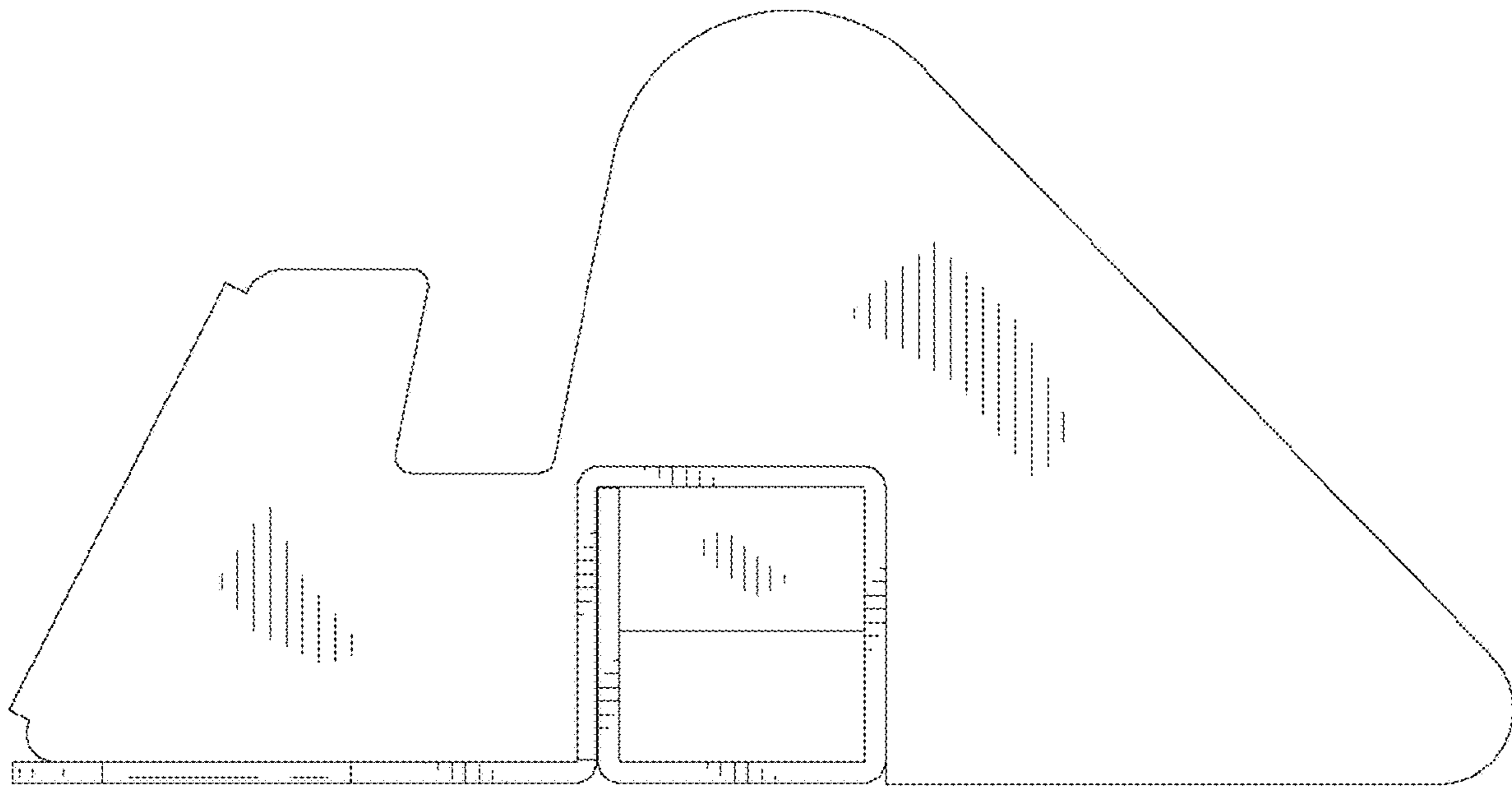

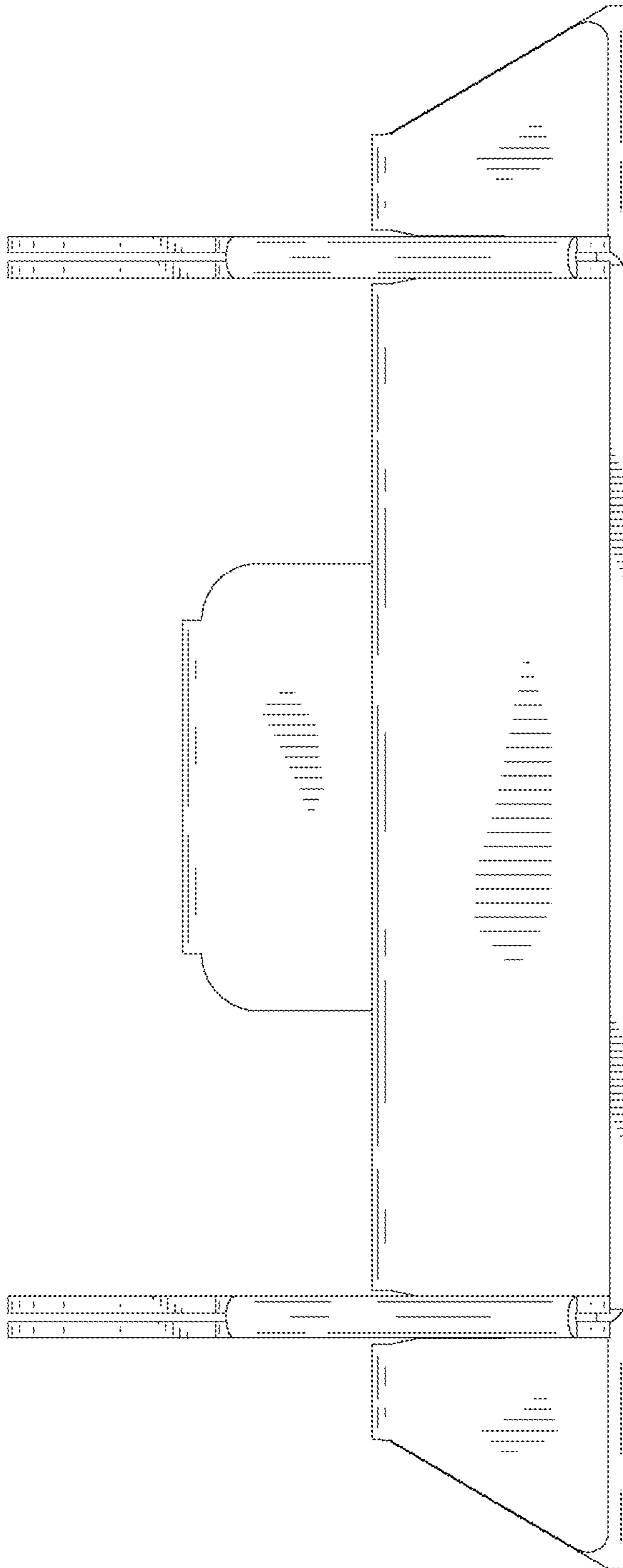

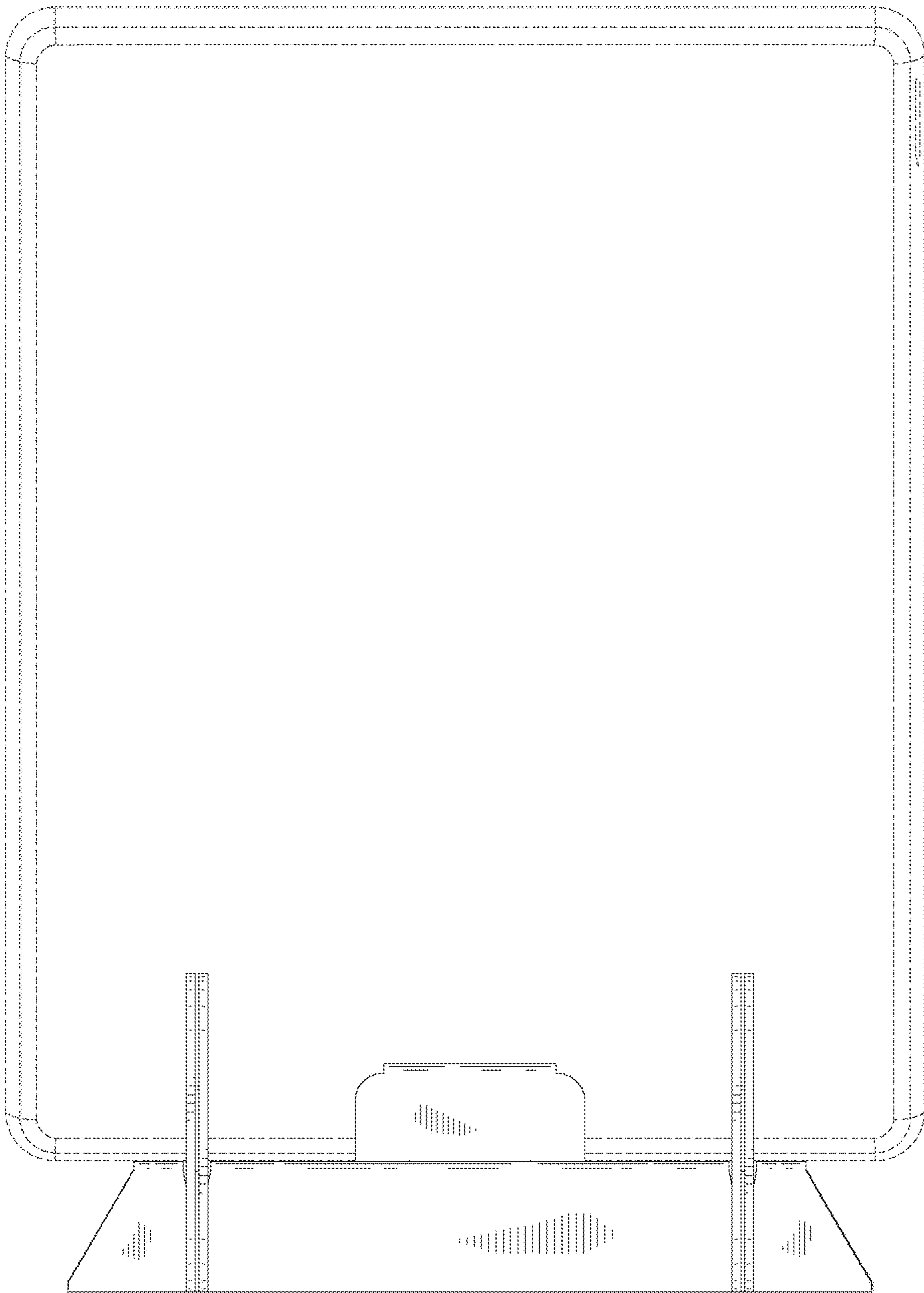

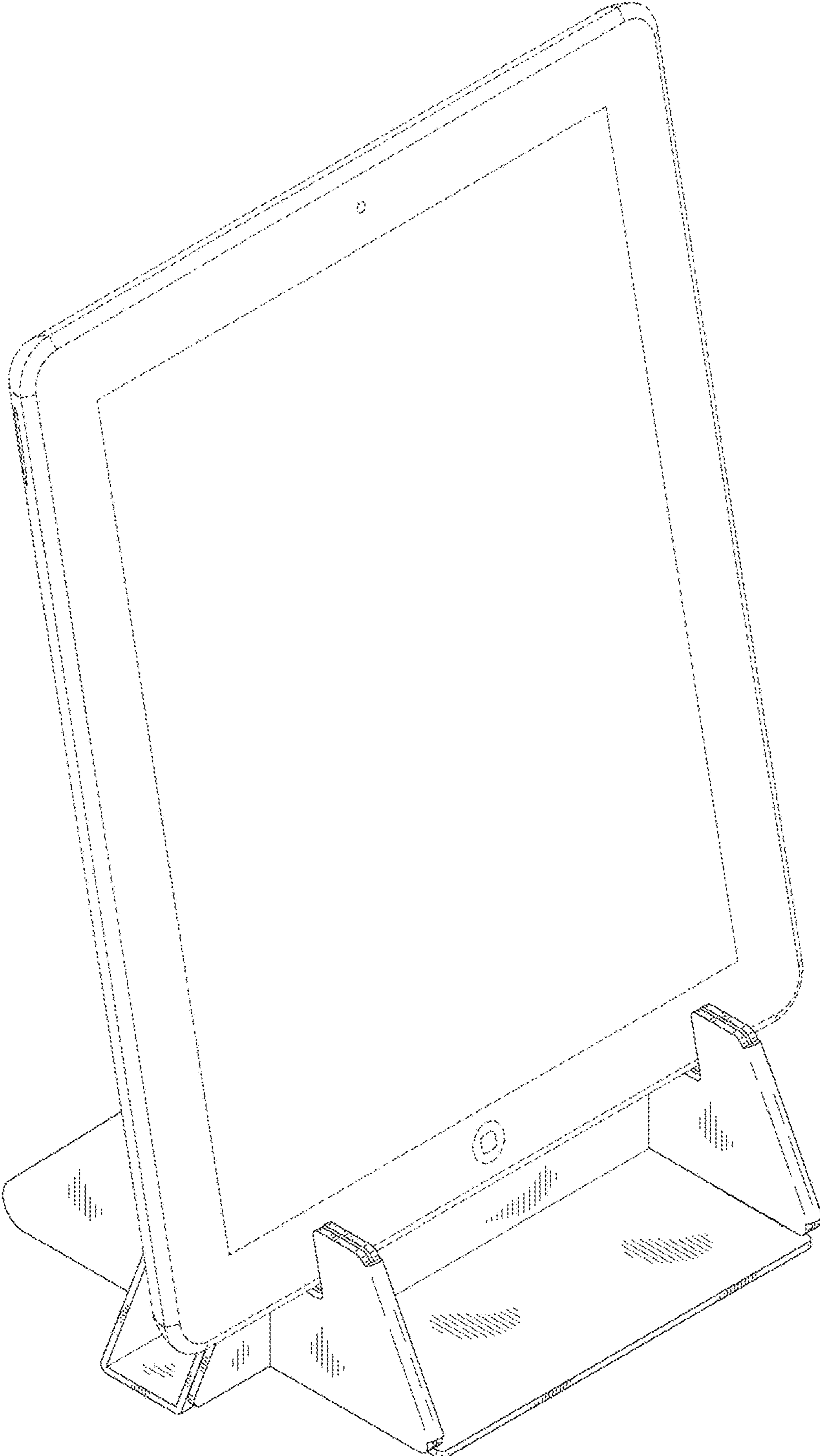

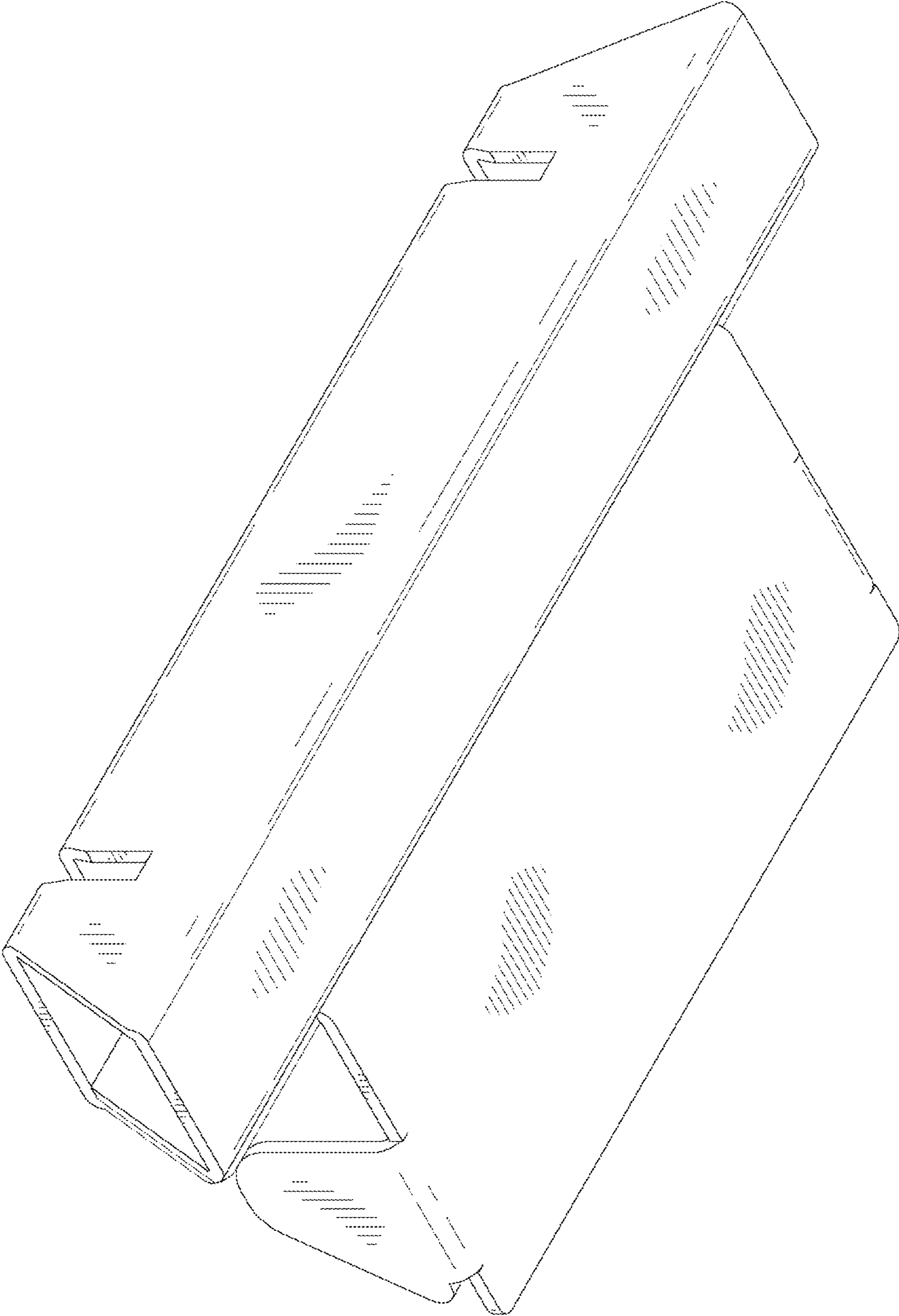

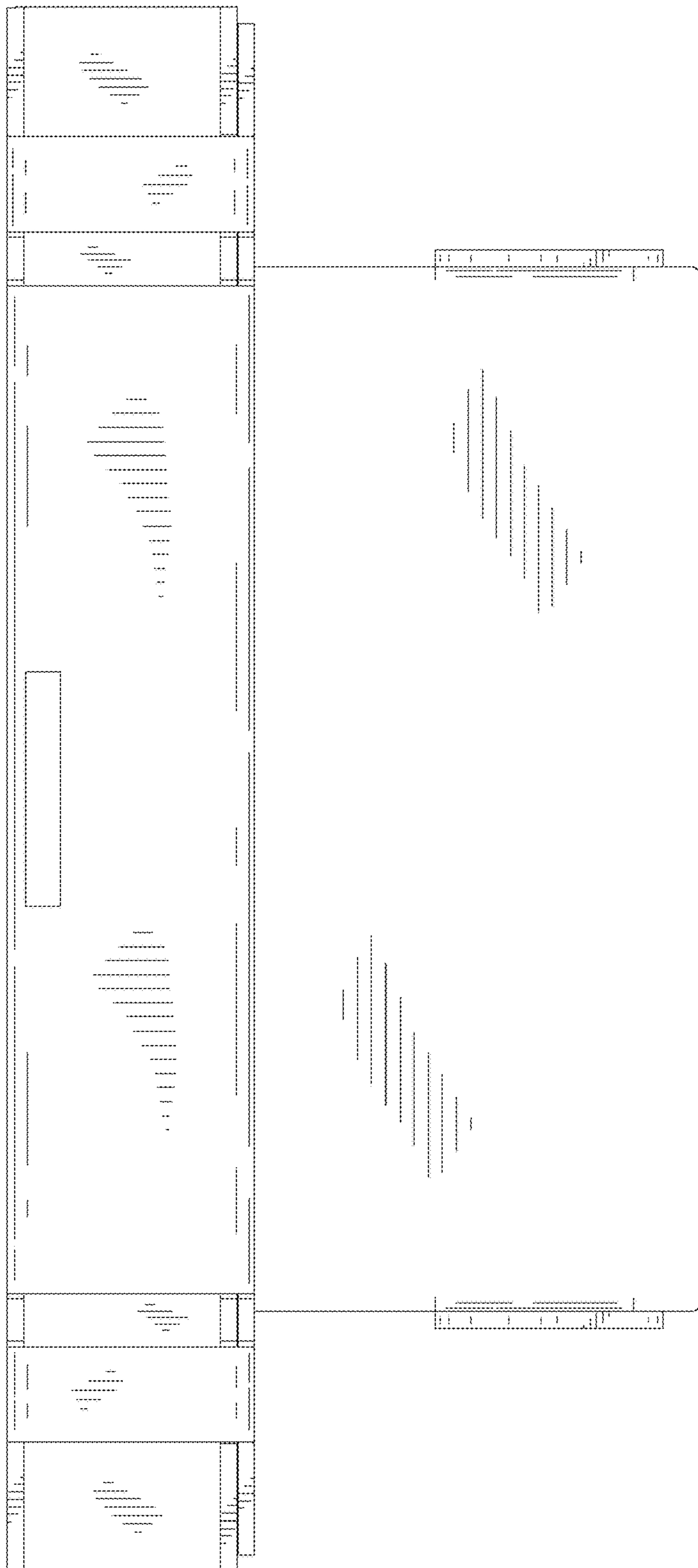

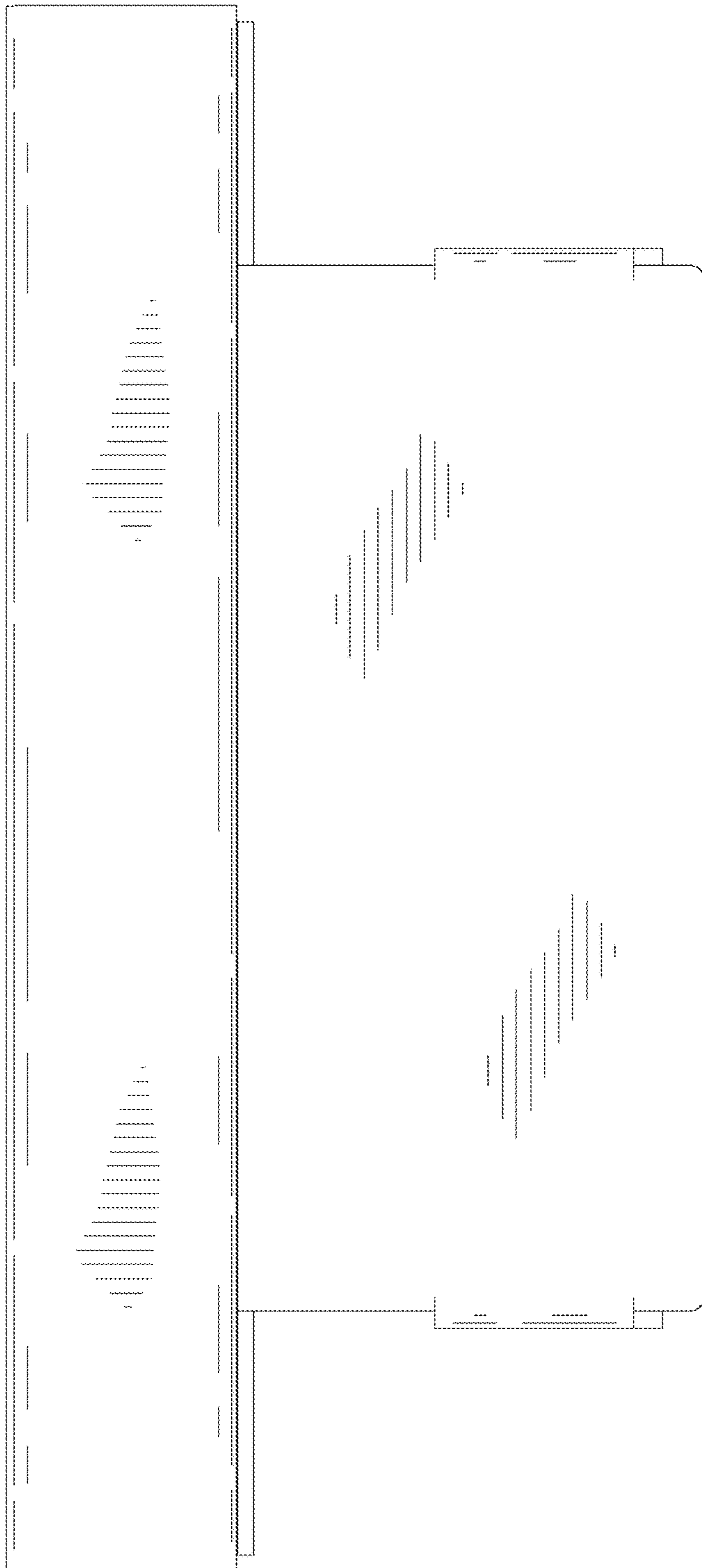

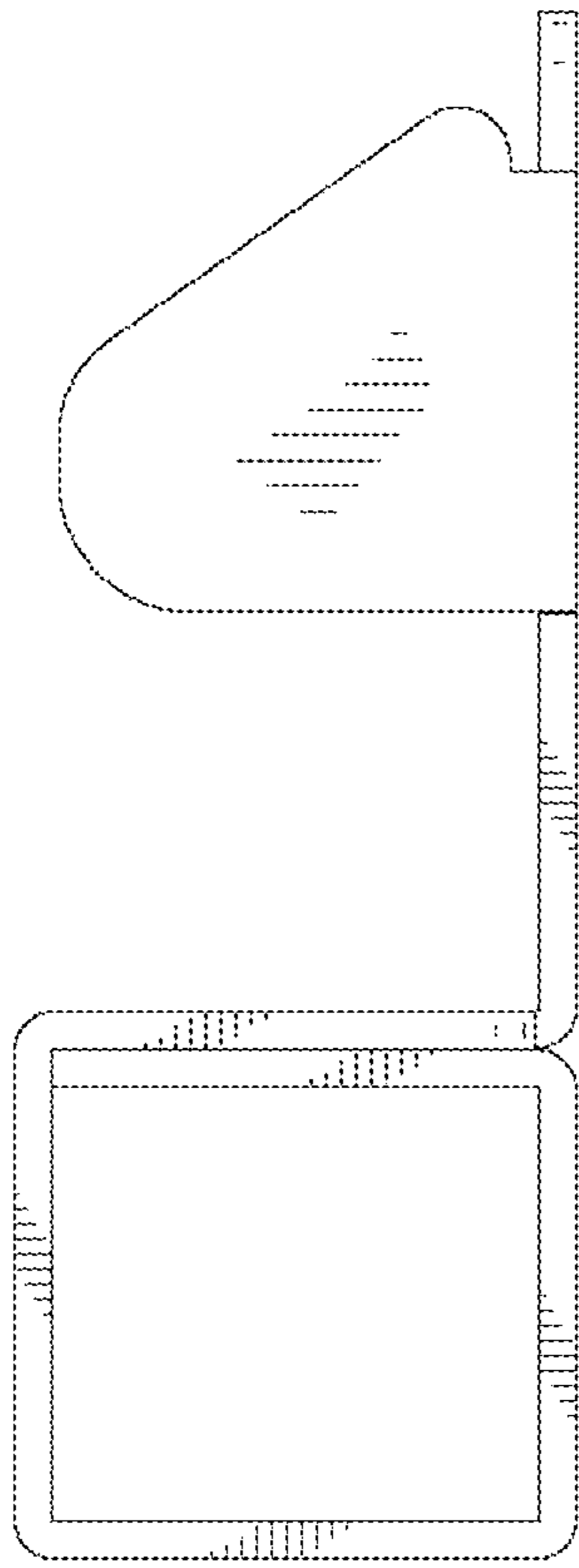

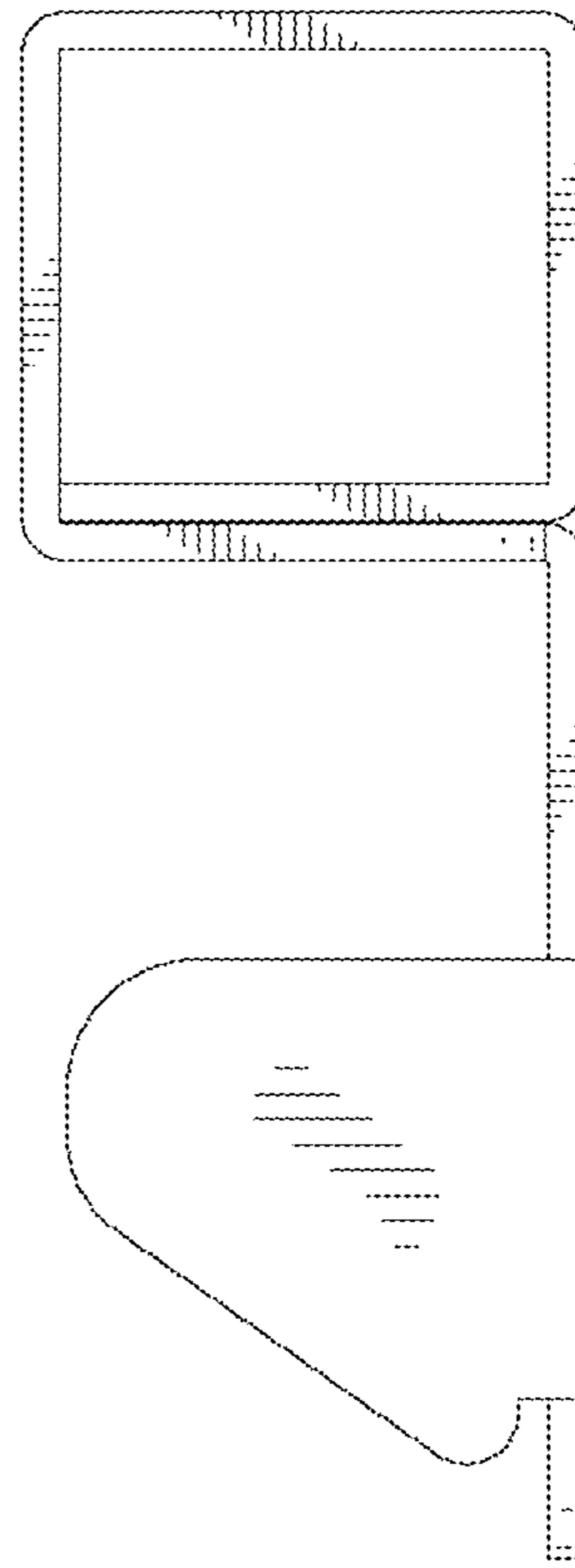

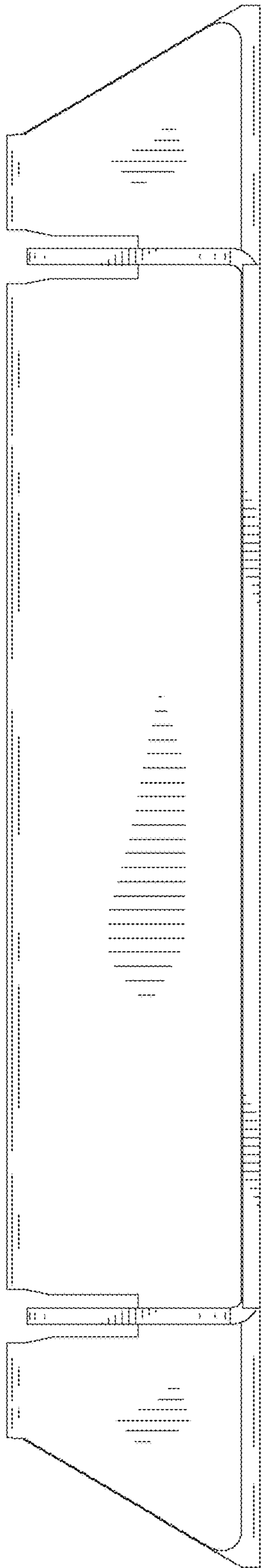

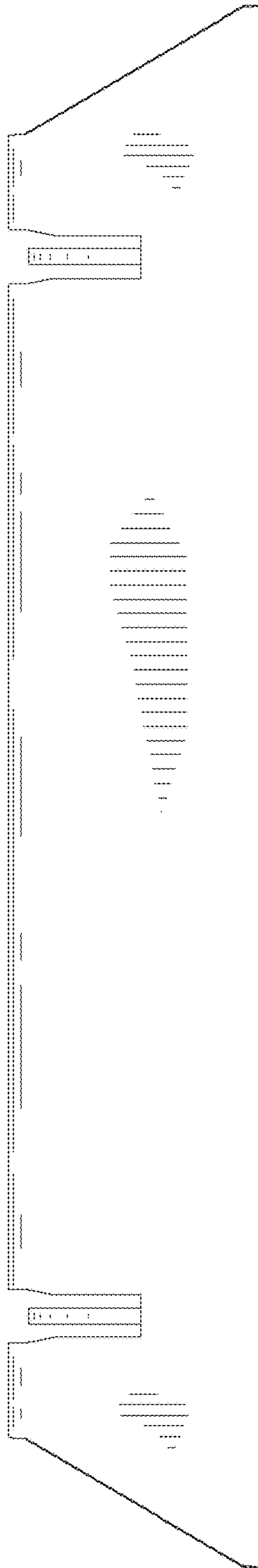

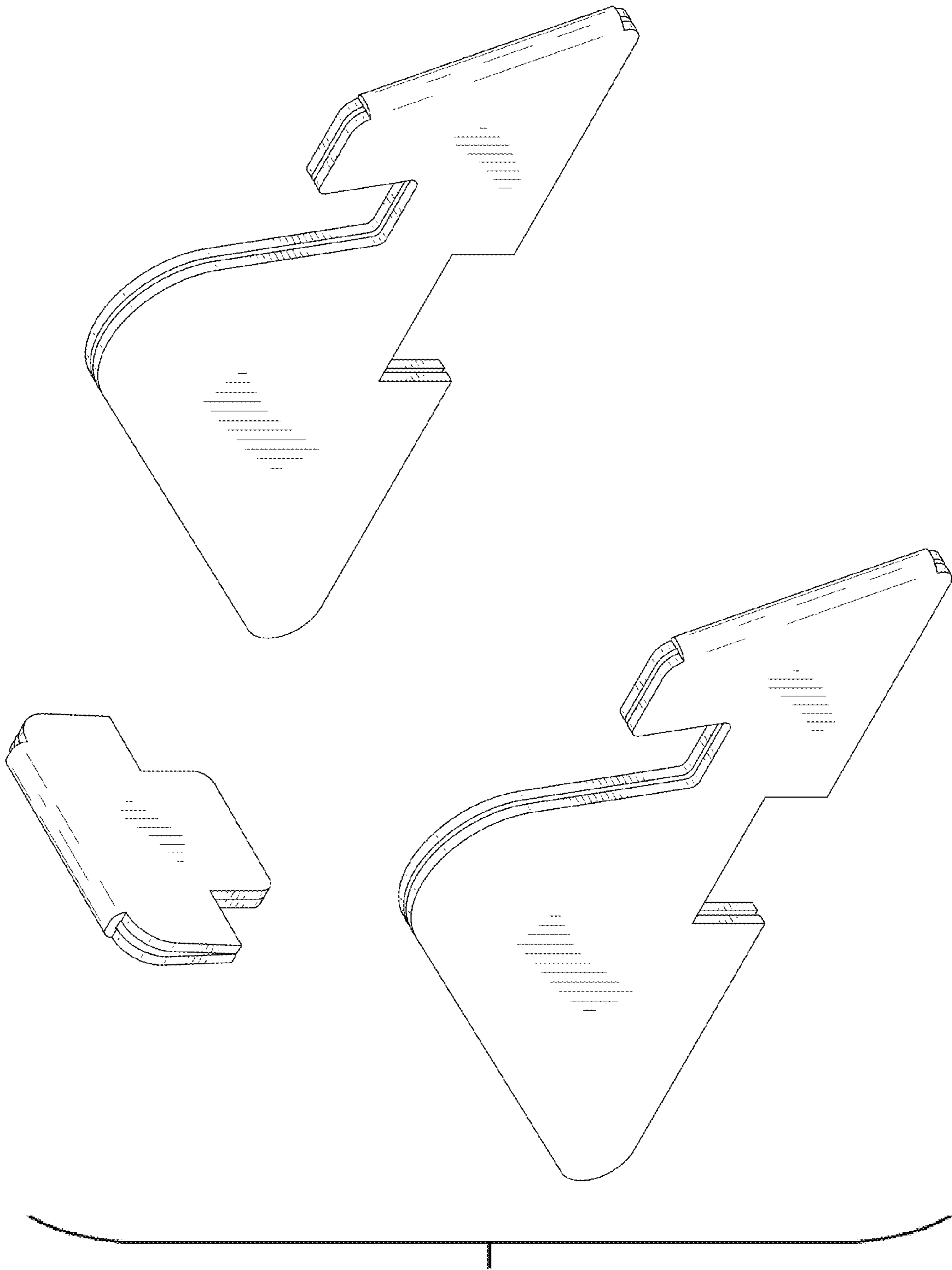

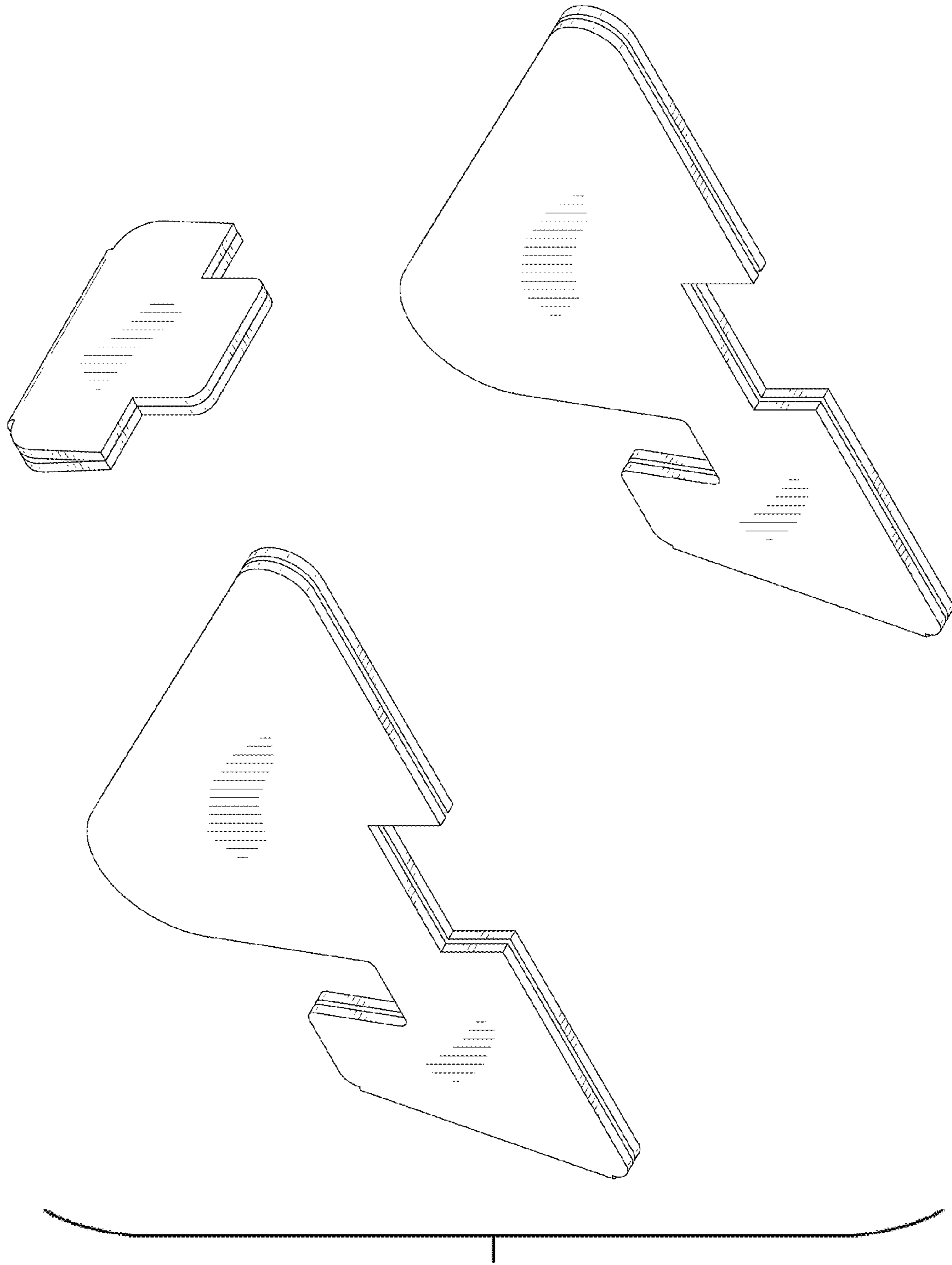

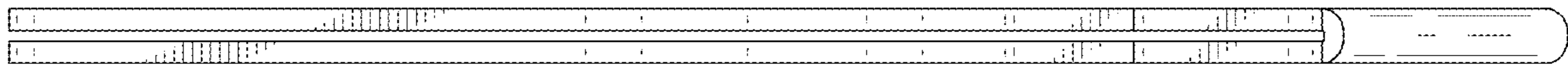
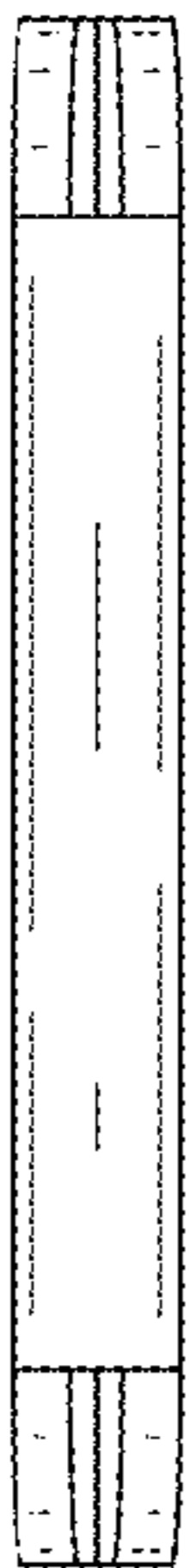
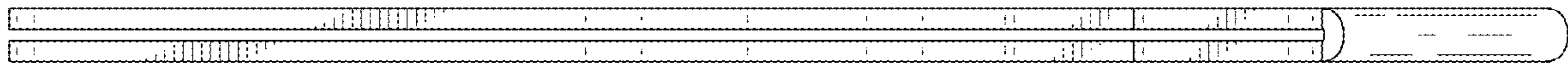

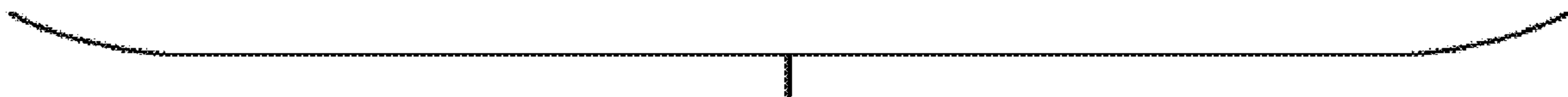
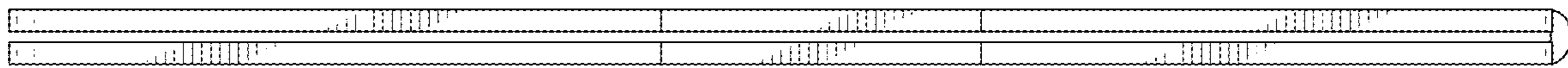
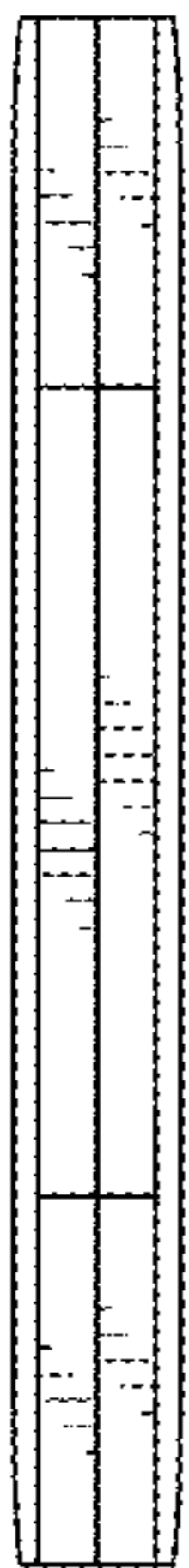
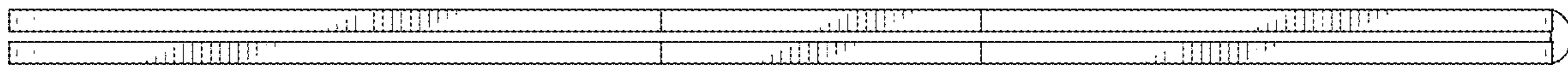

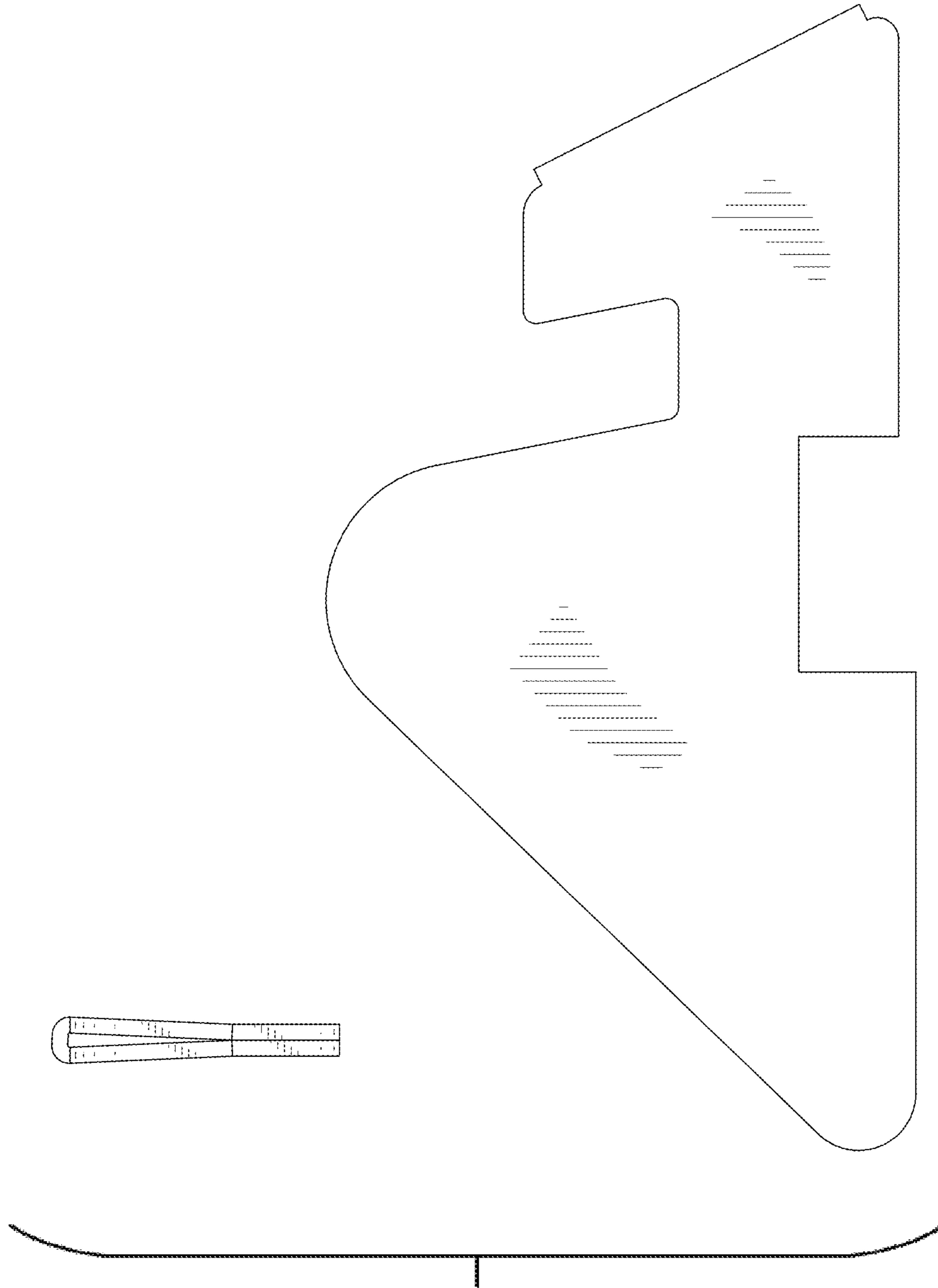

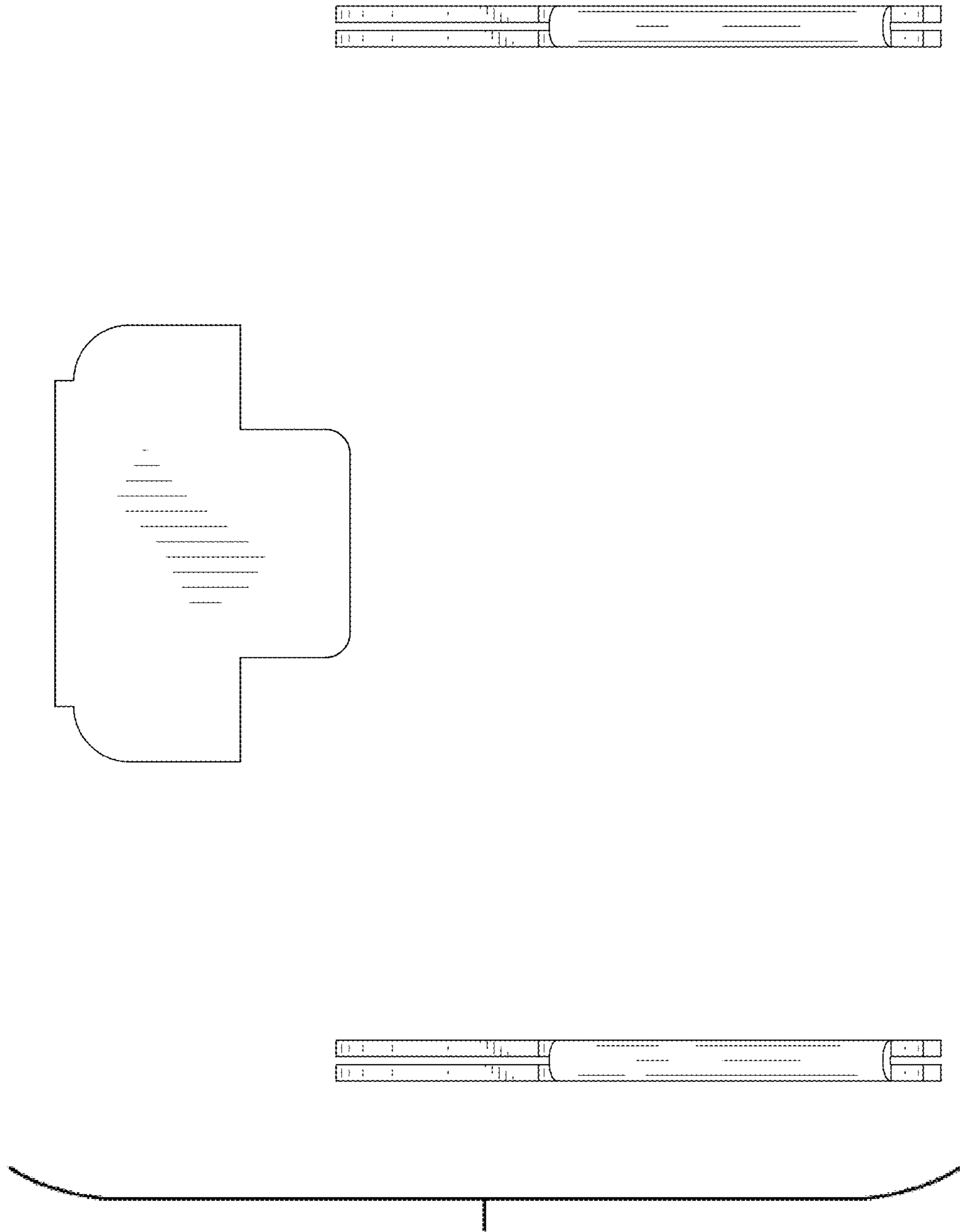

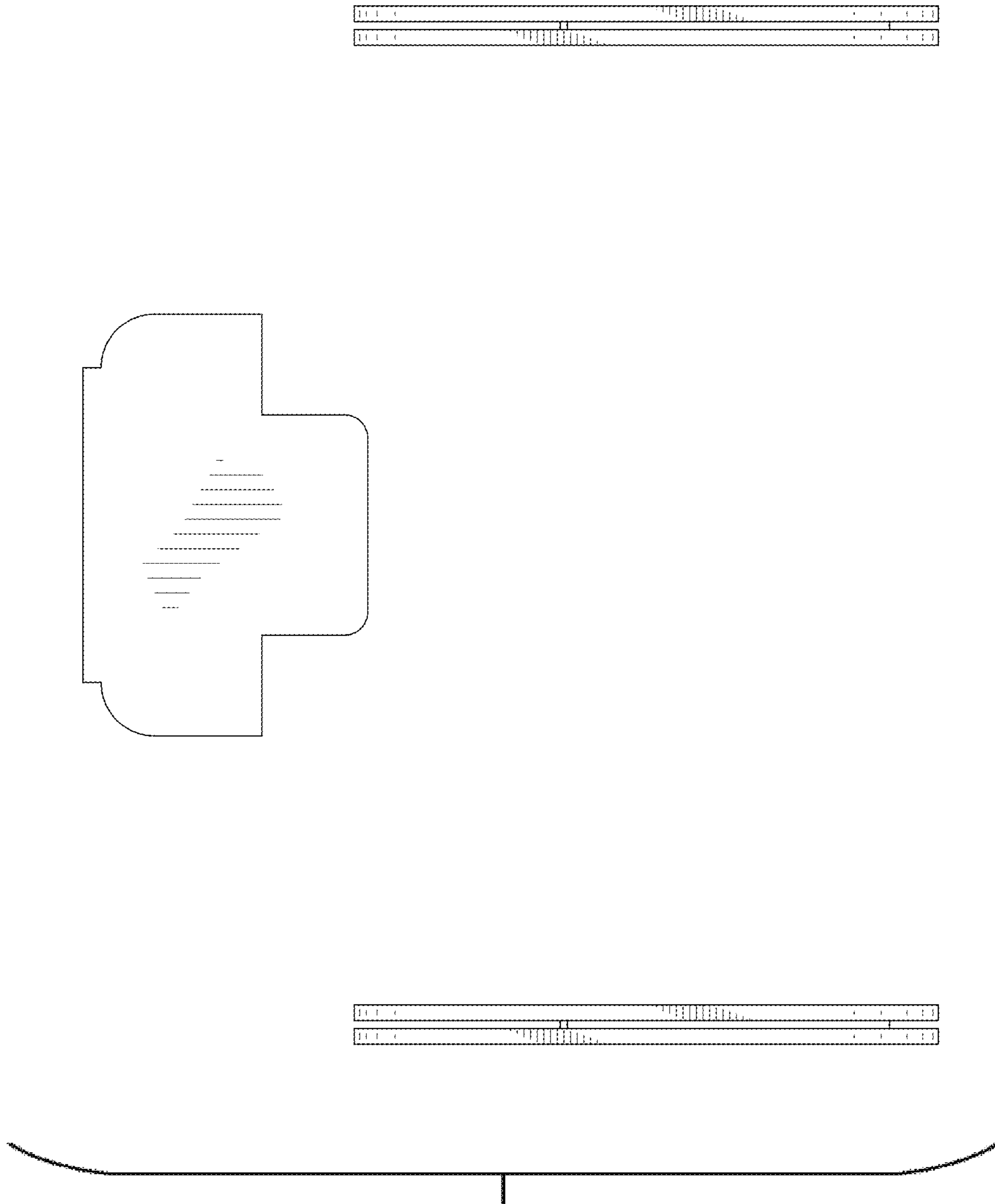

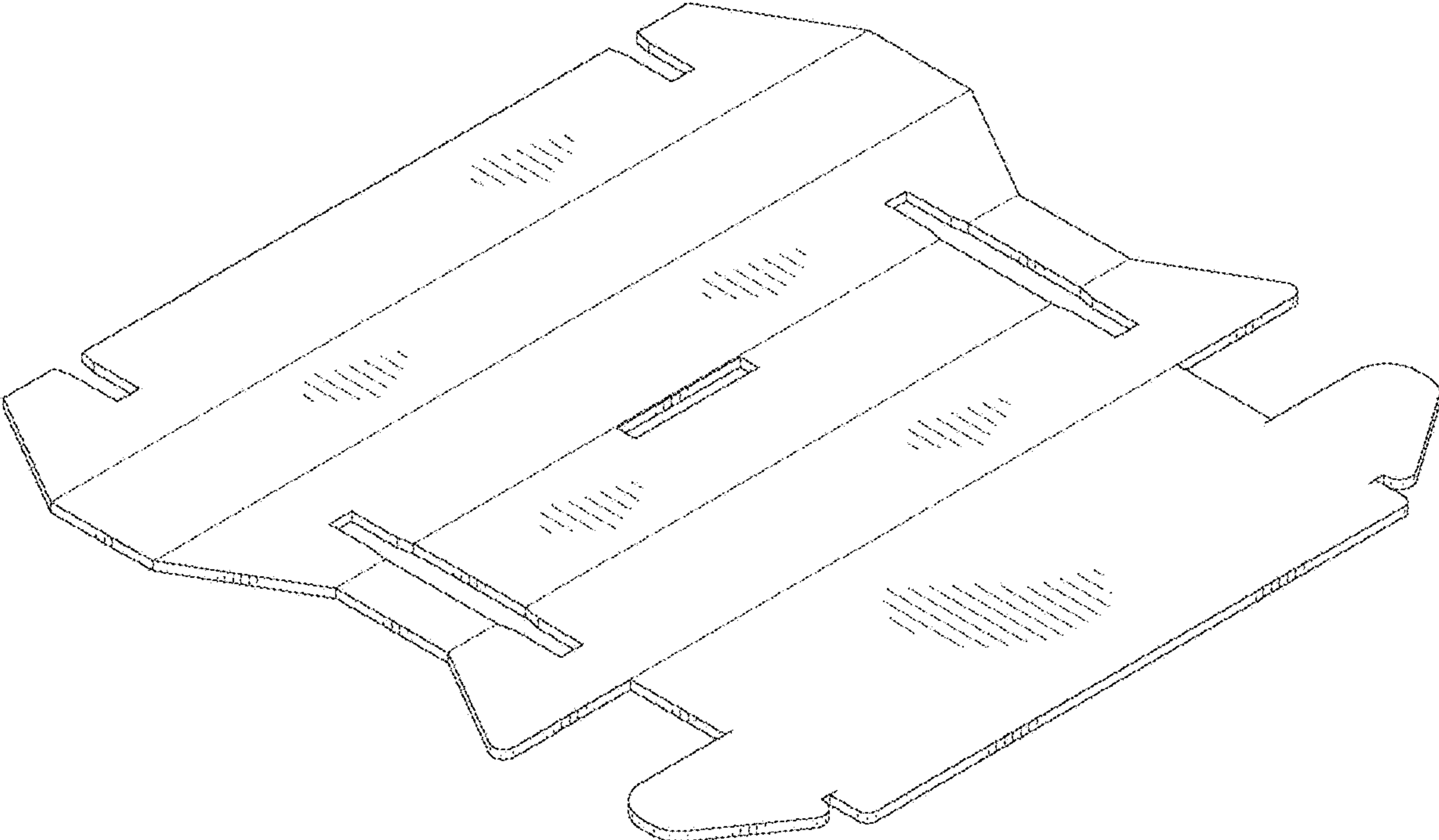

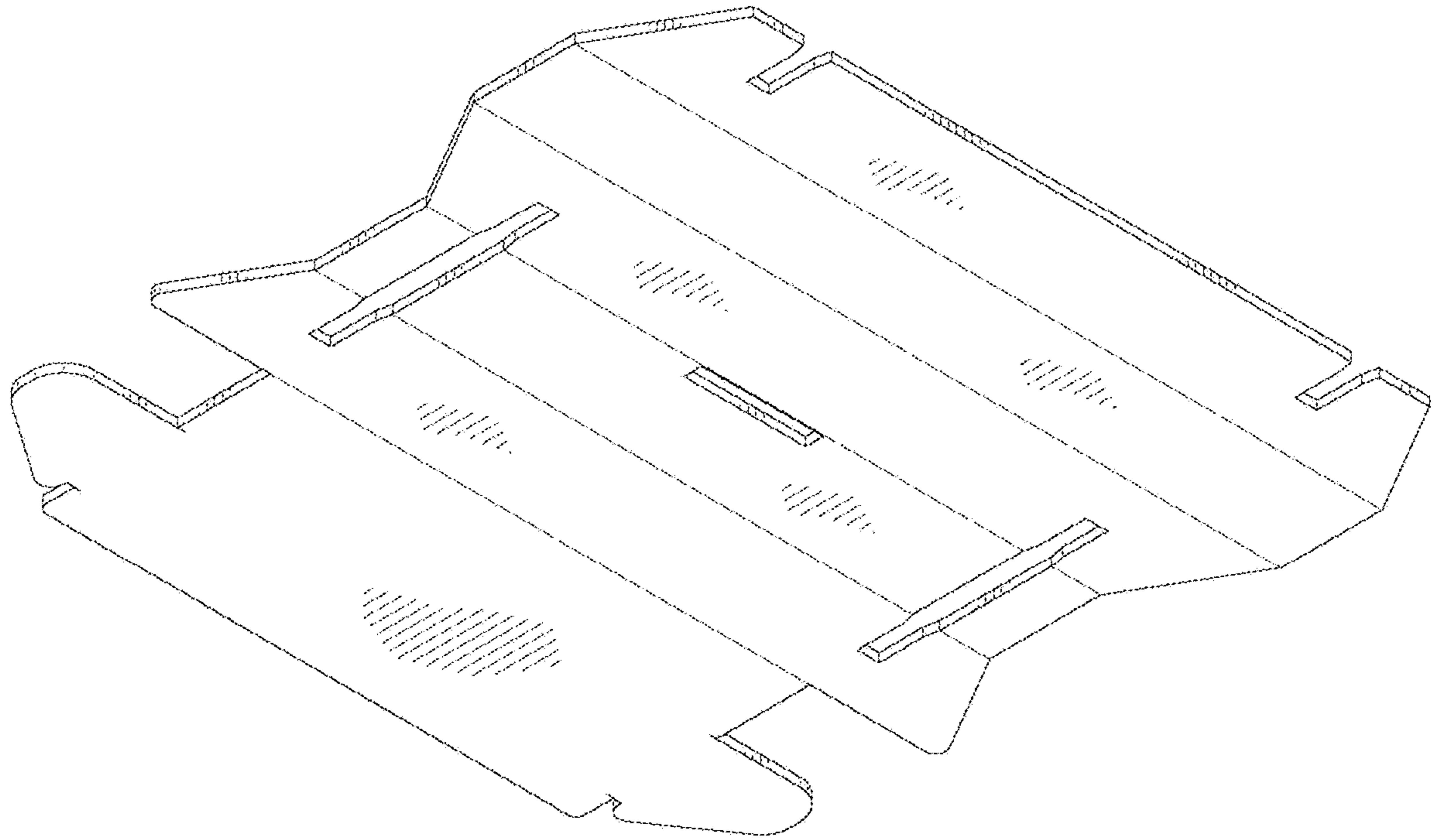

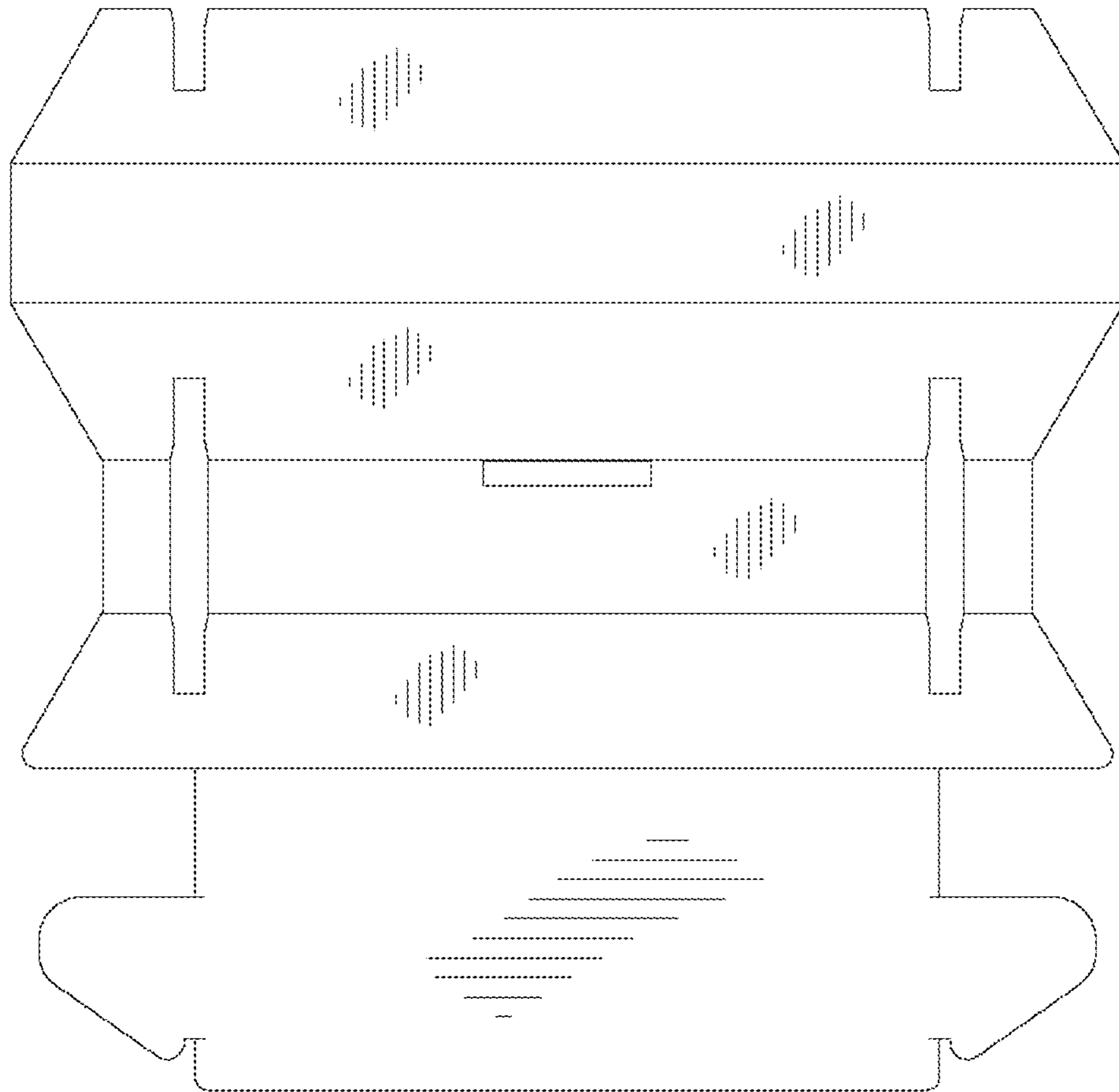

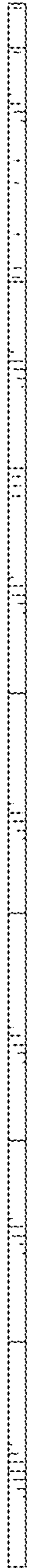

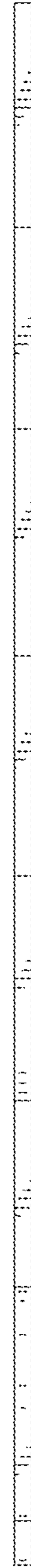

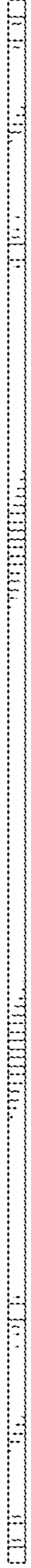

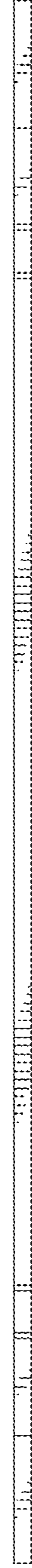

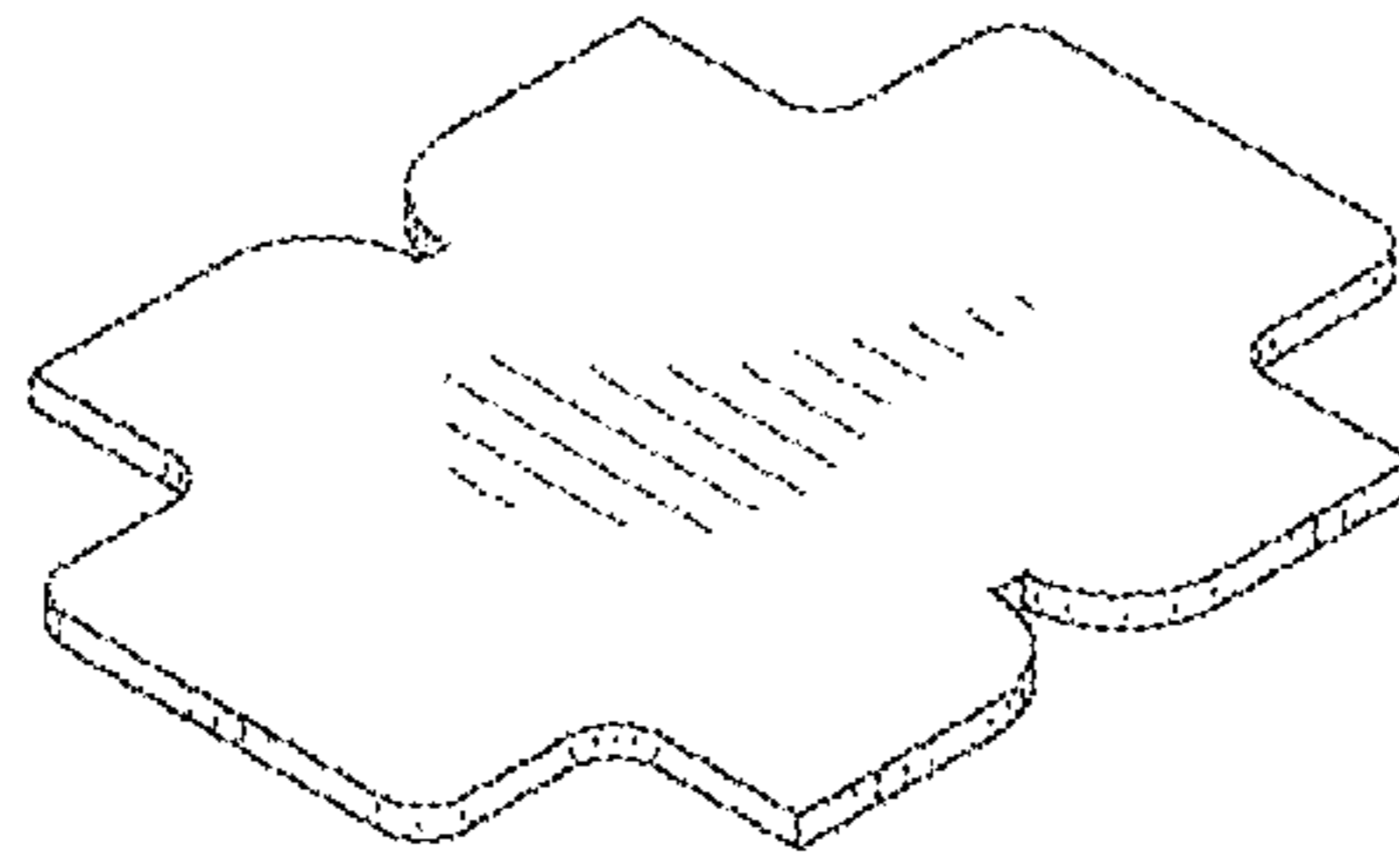

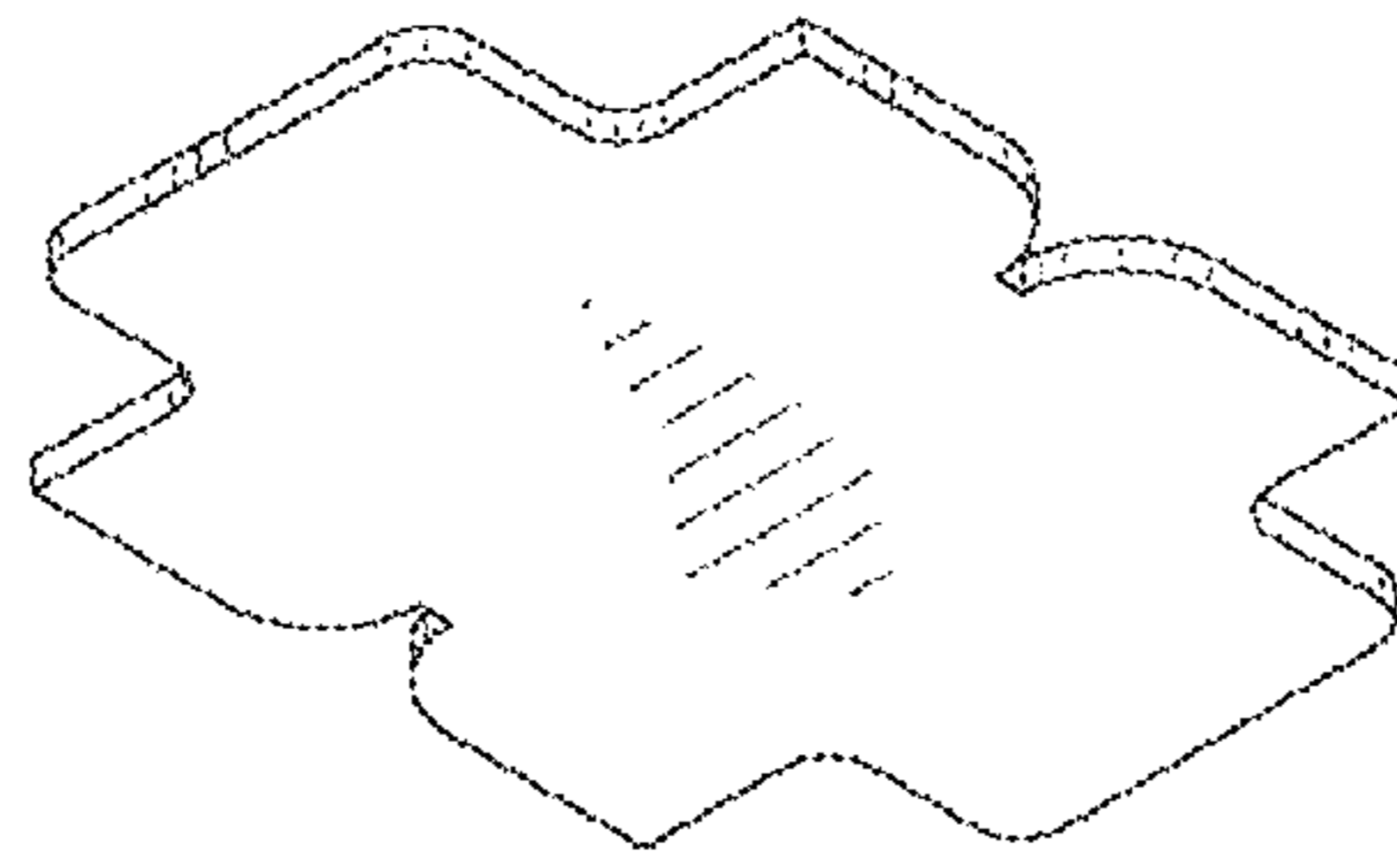

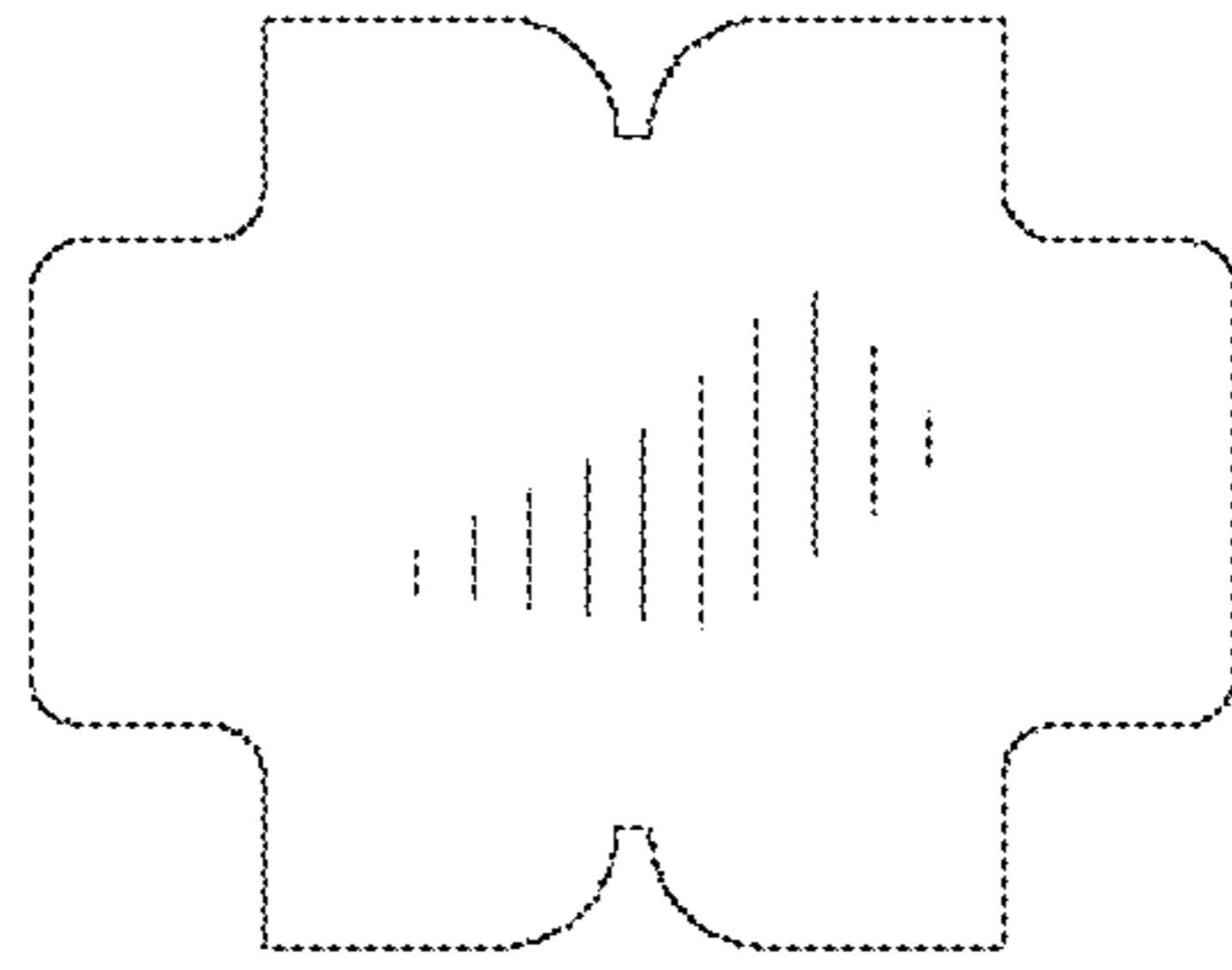

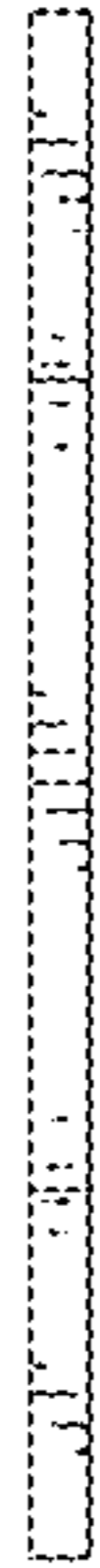

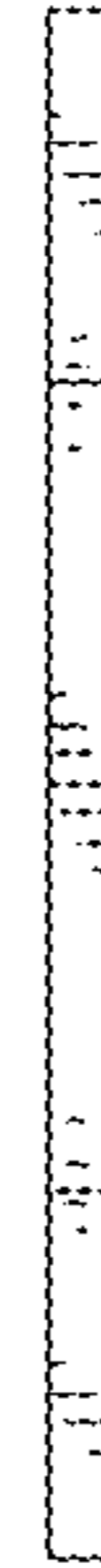

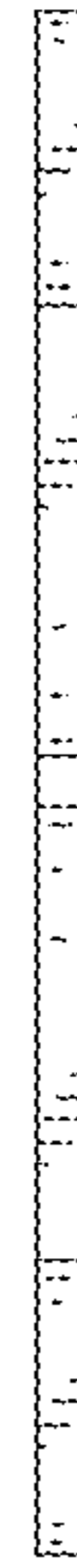

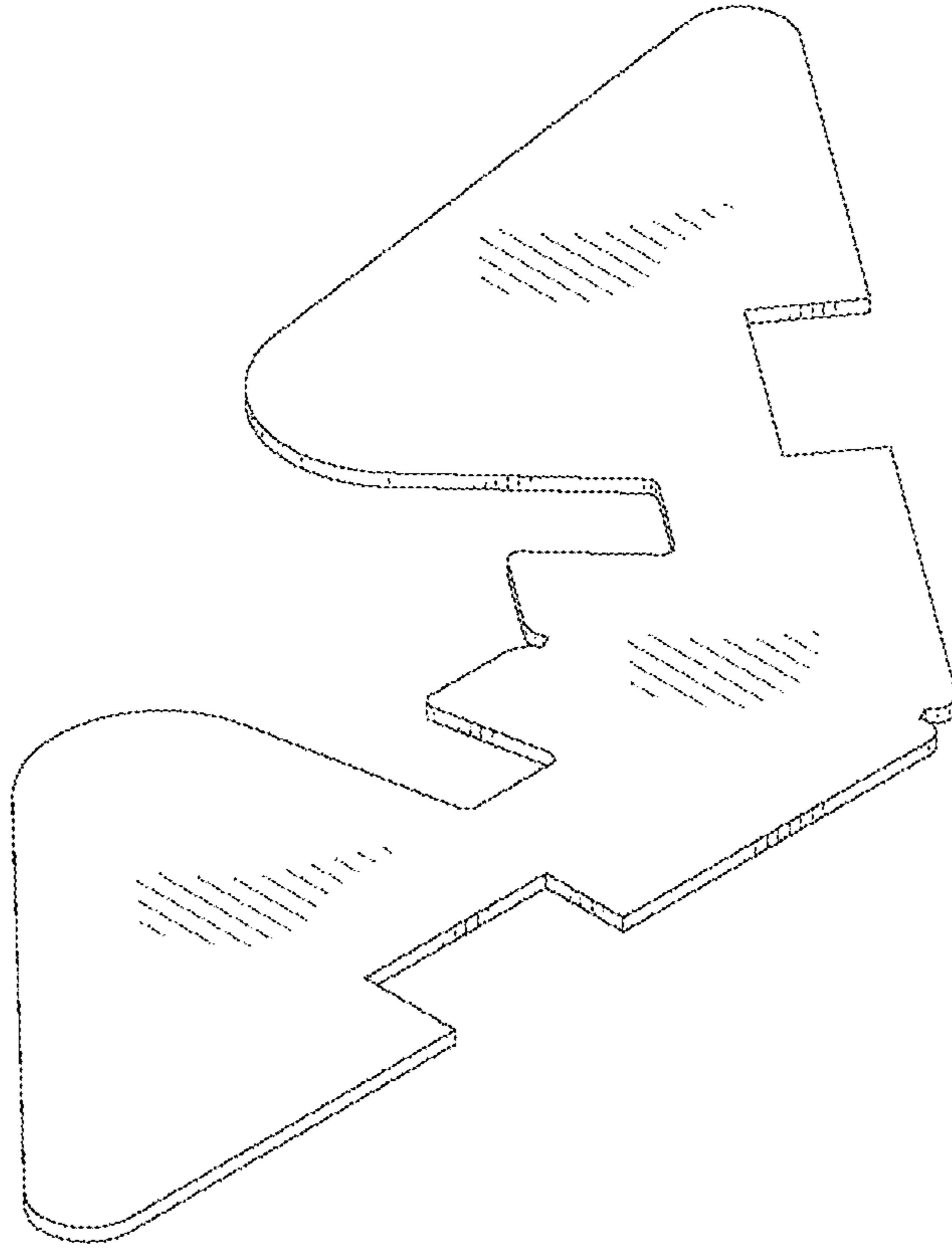

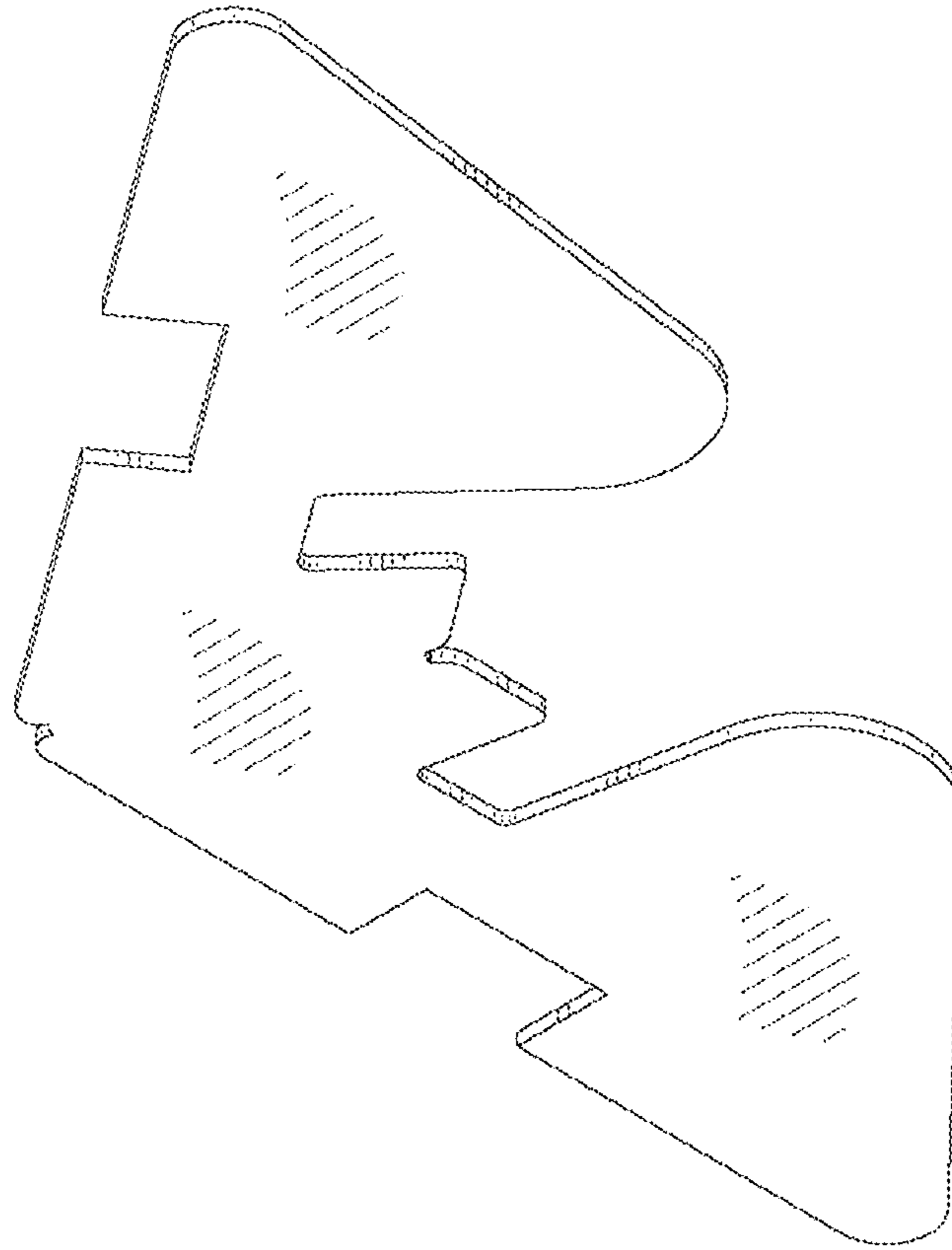

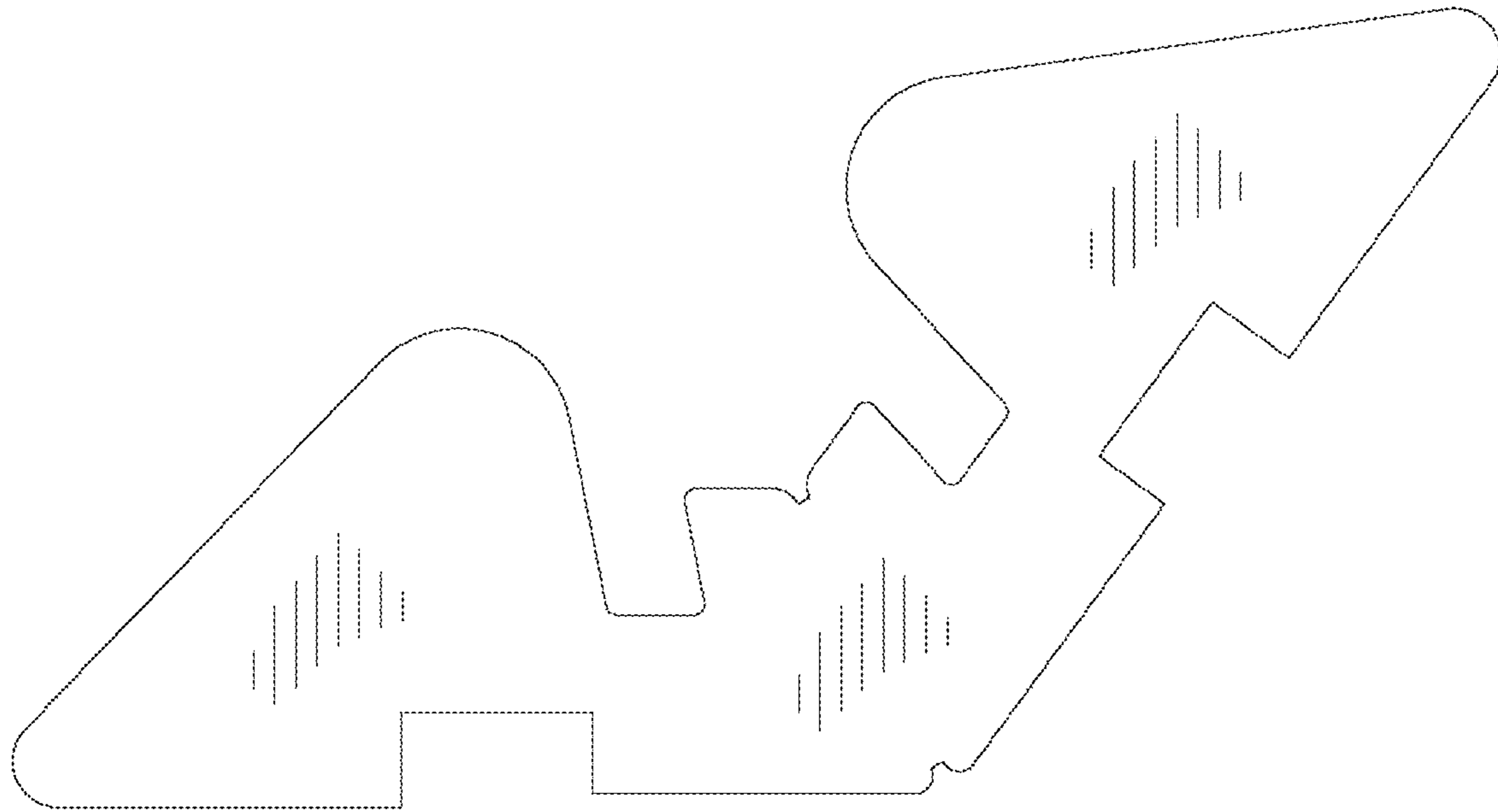

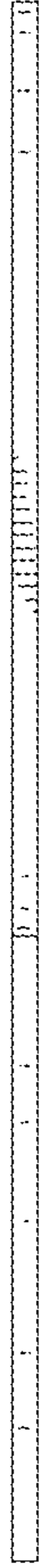

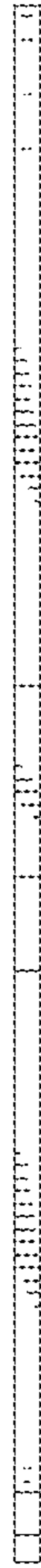
