FIG. 26 is a front view of a twelfth frame thereof;

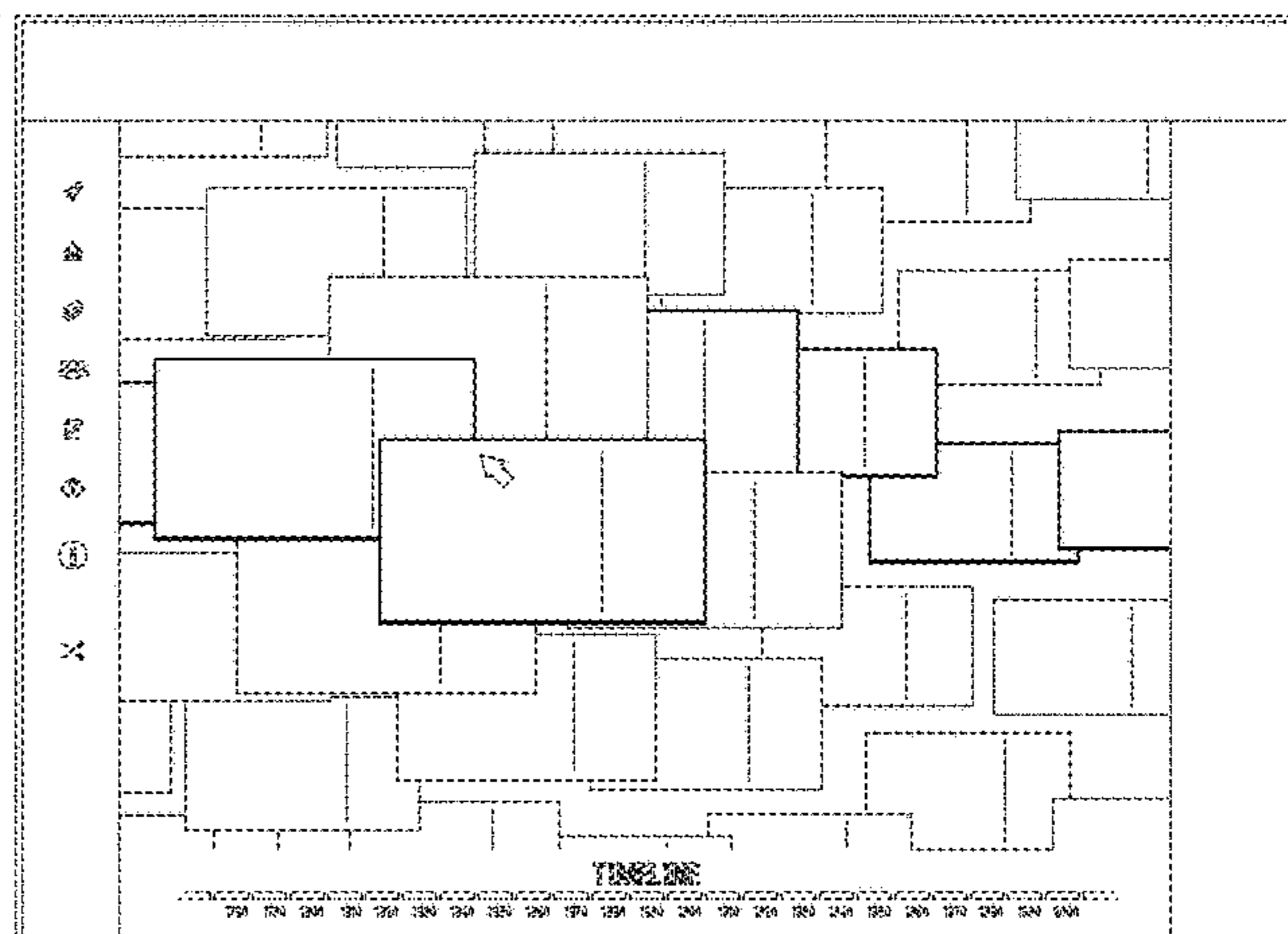
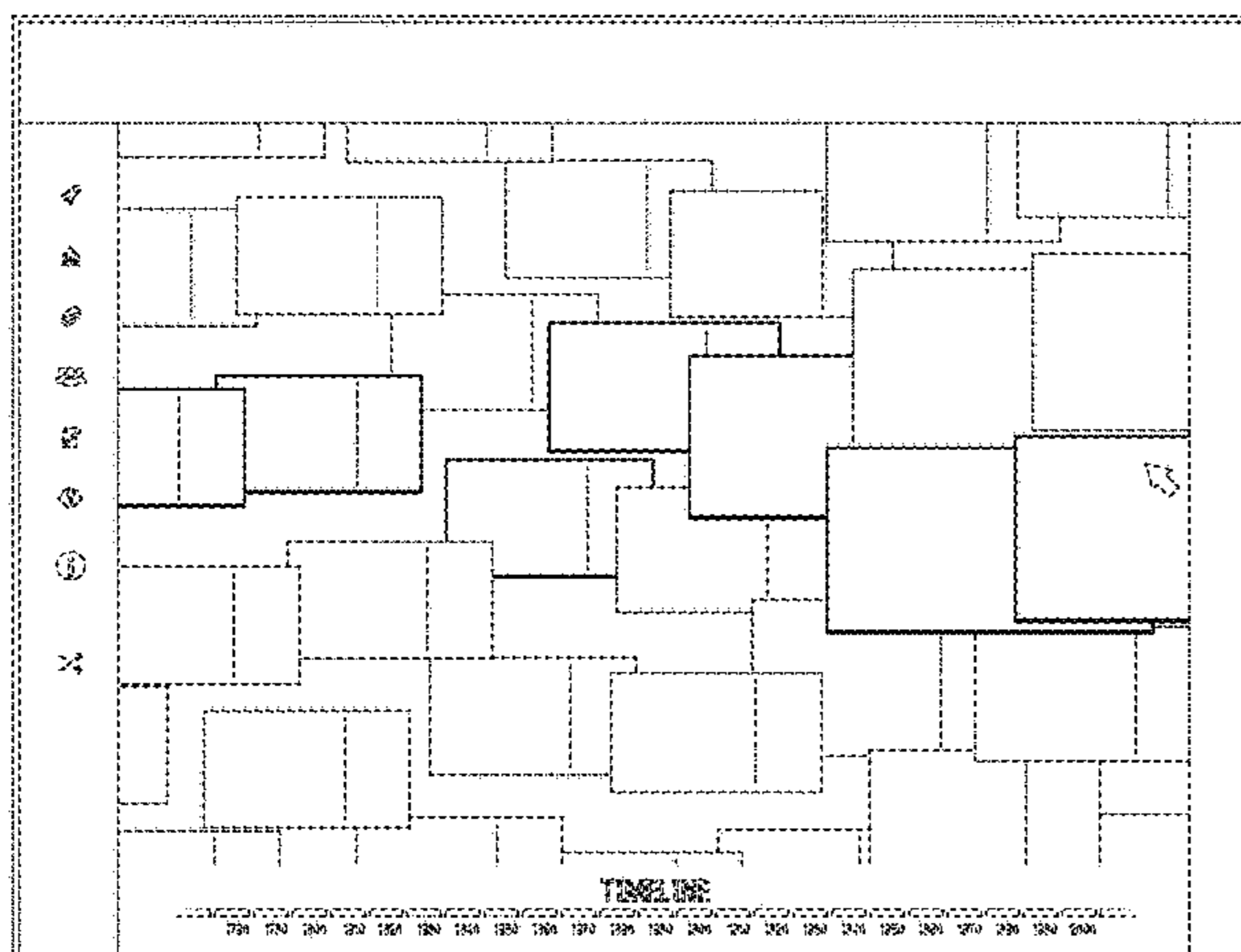
FIG. 27 is a front view of a thirteenth frame thereof; and,

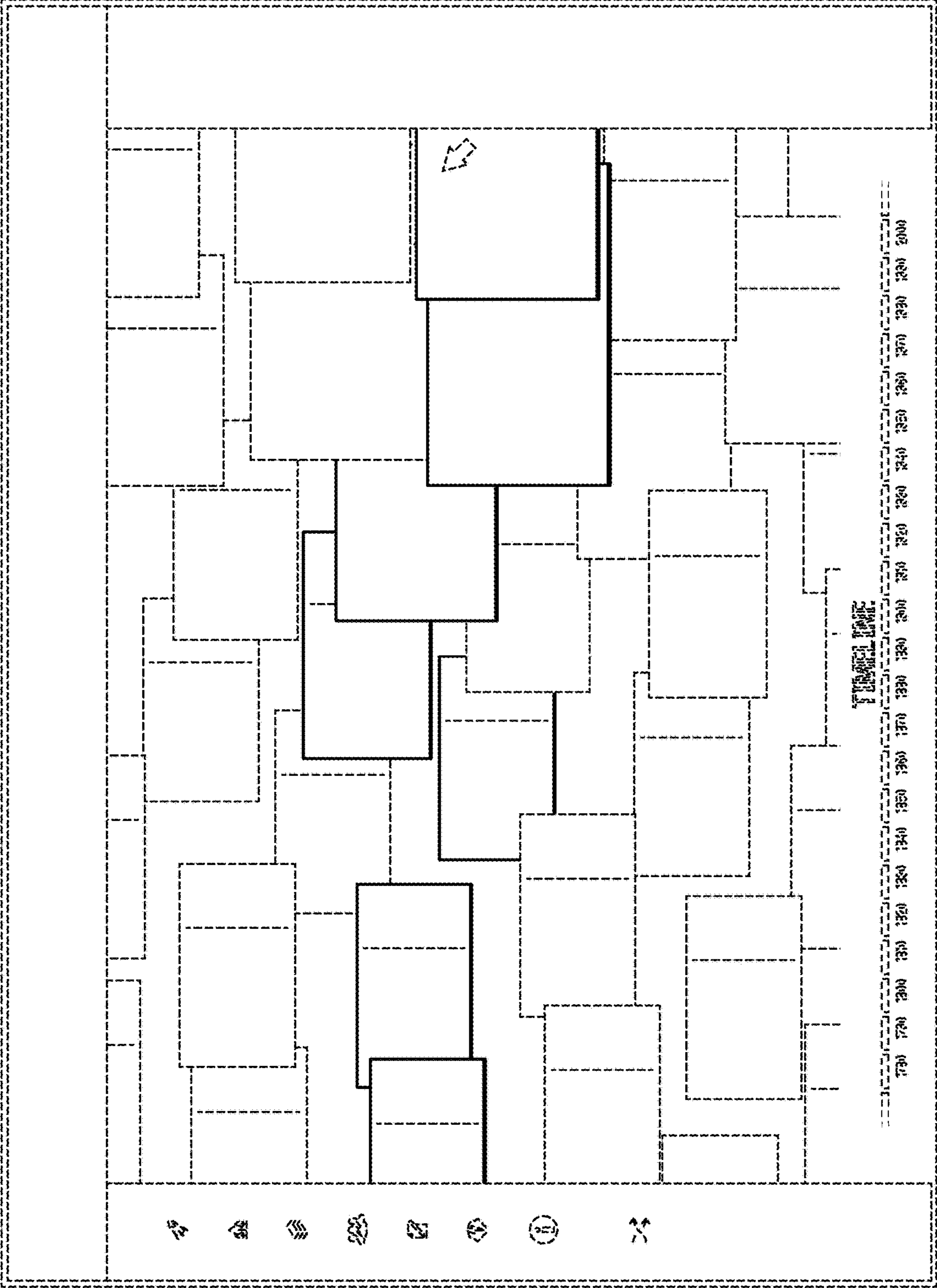

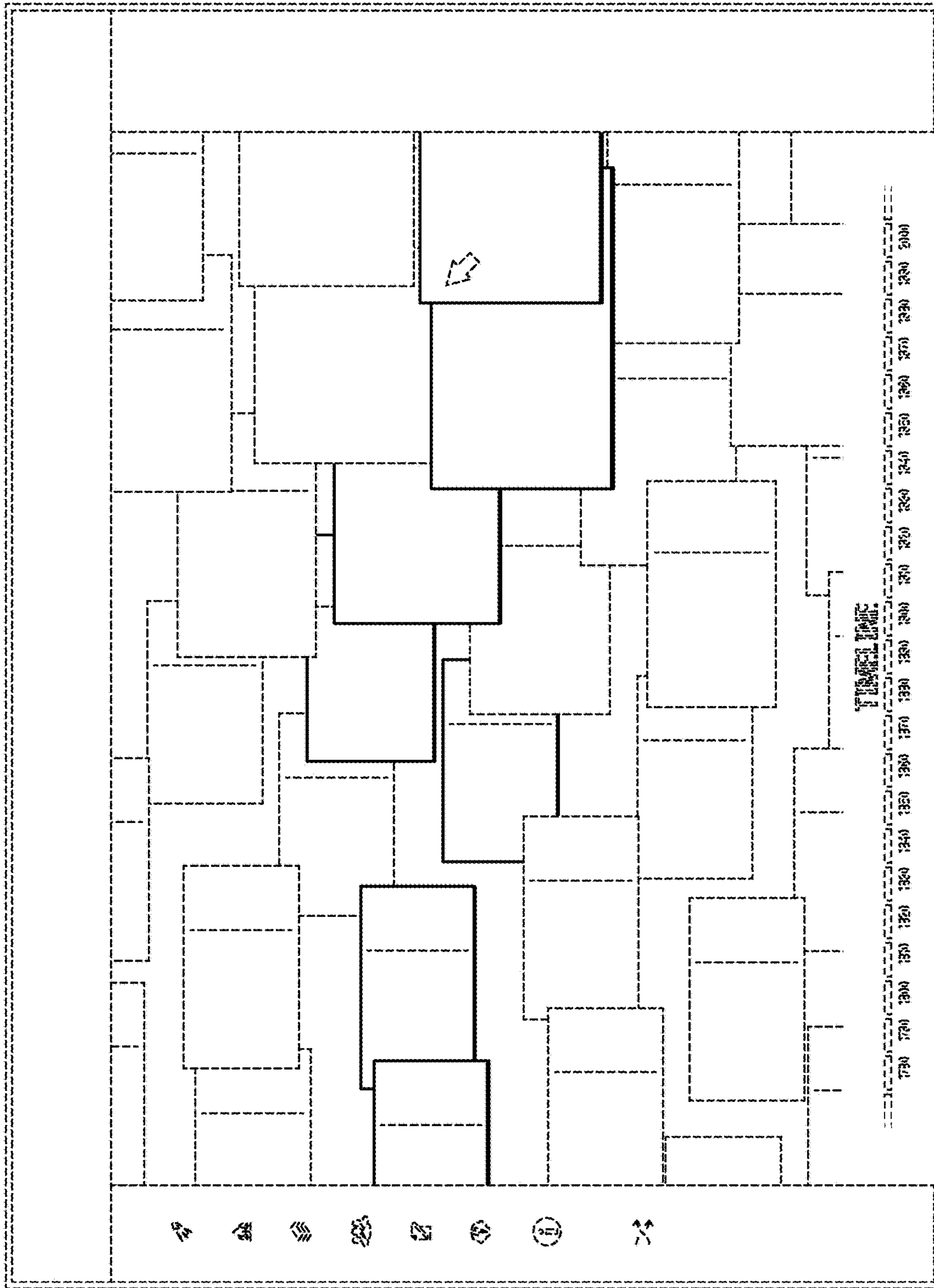

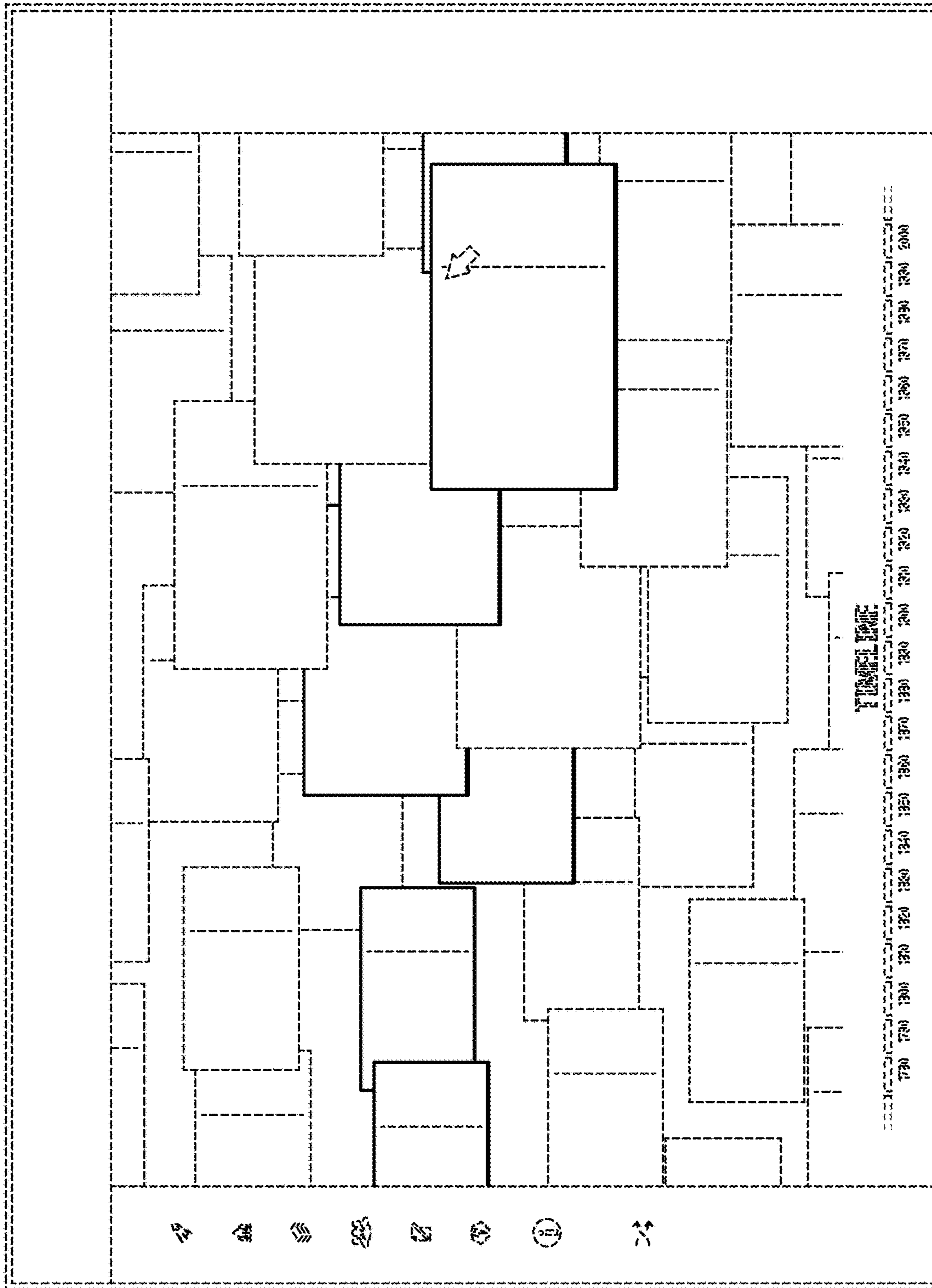

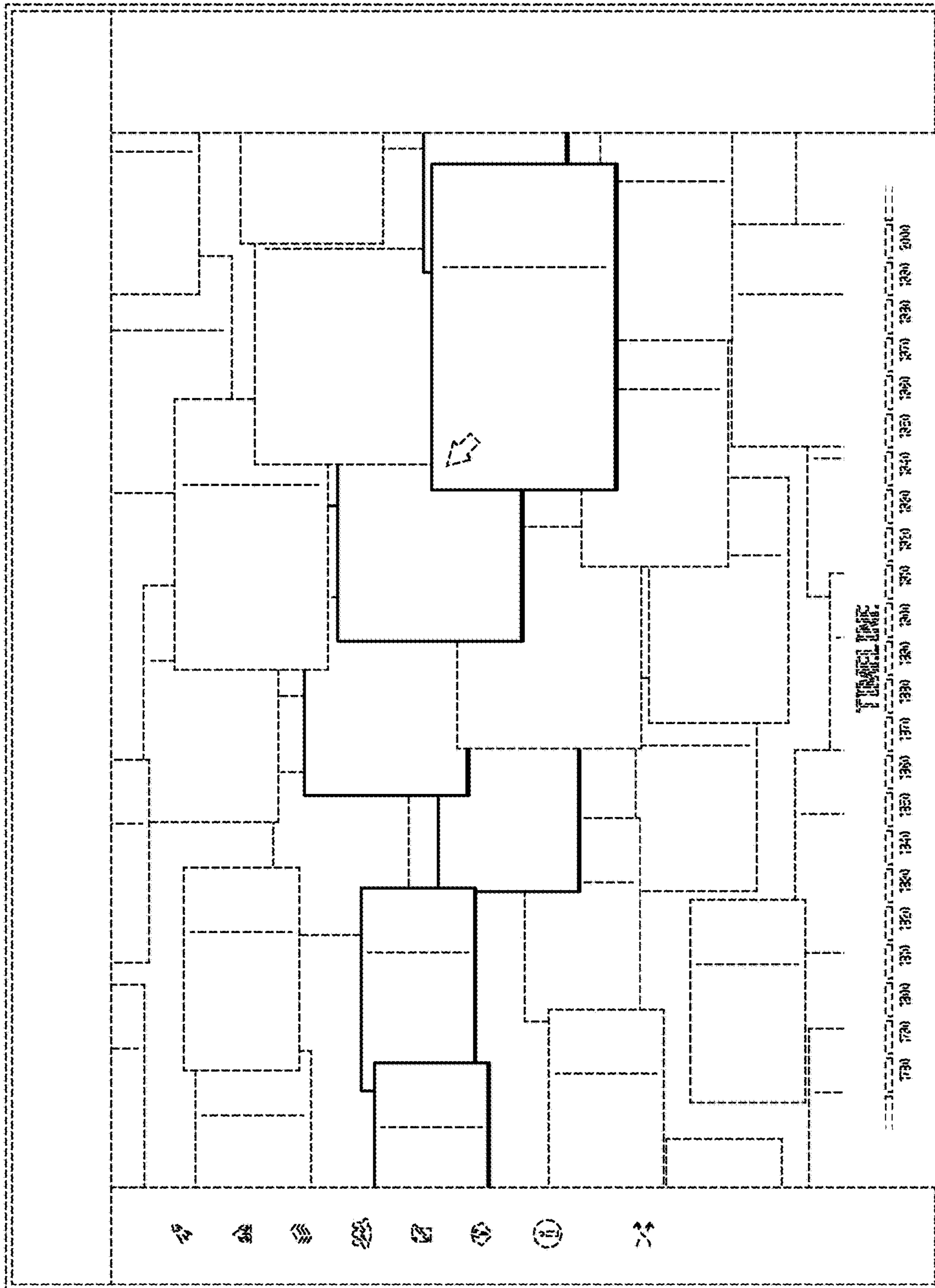

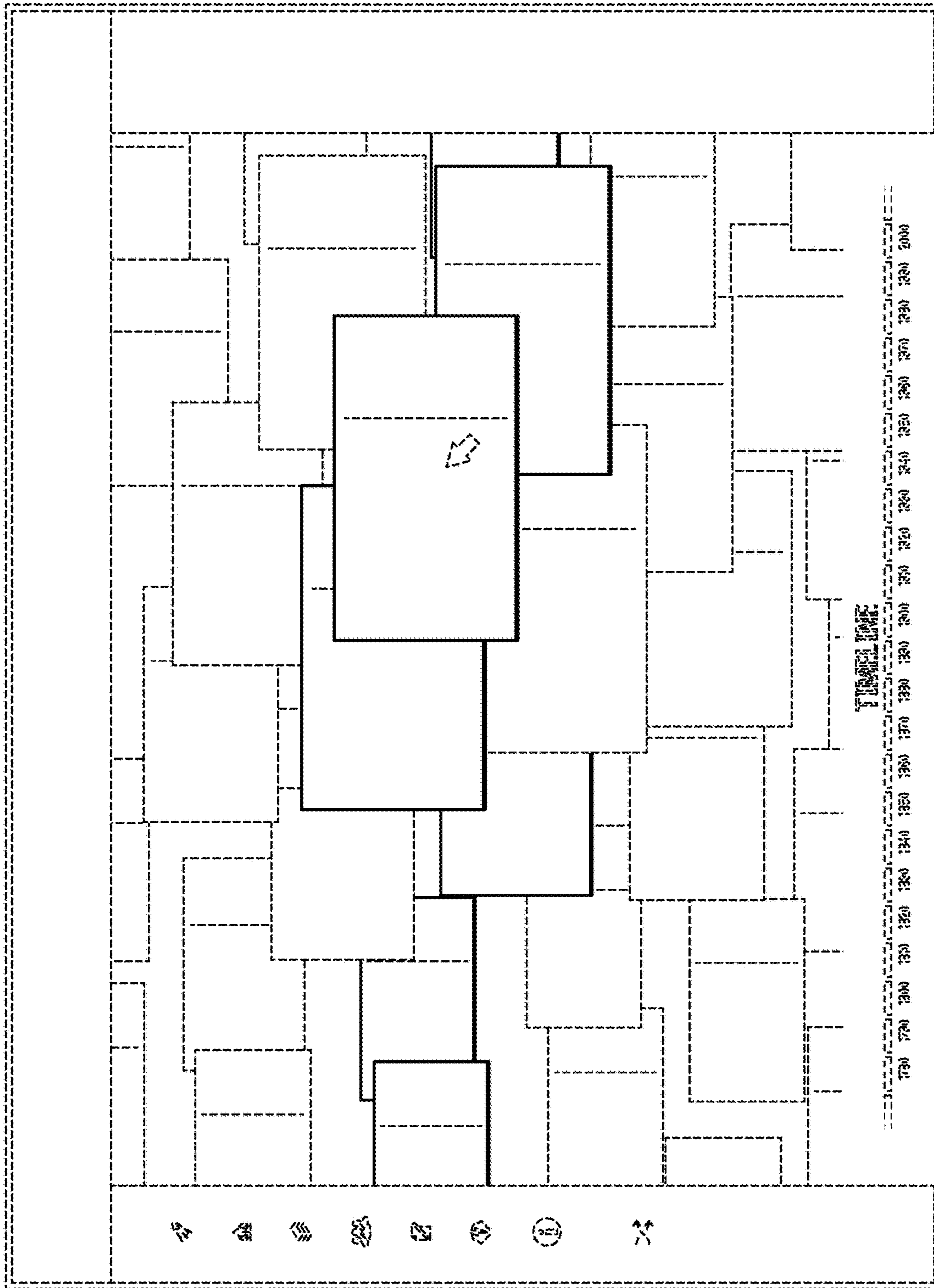

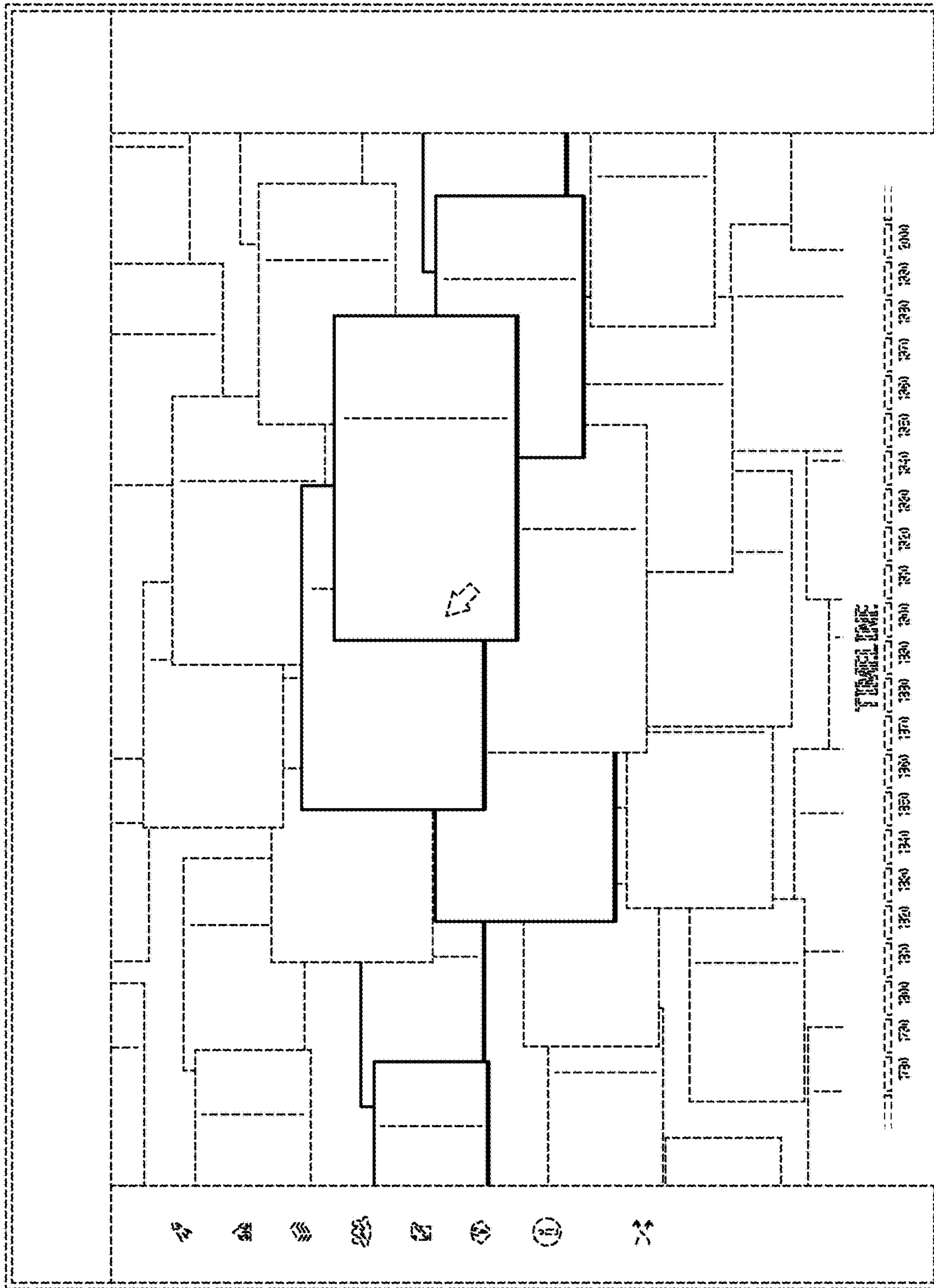

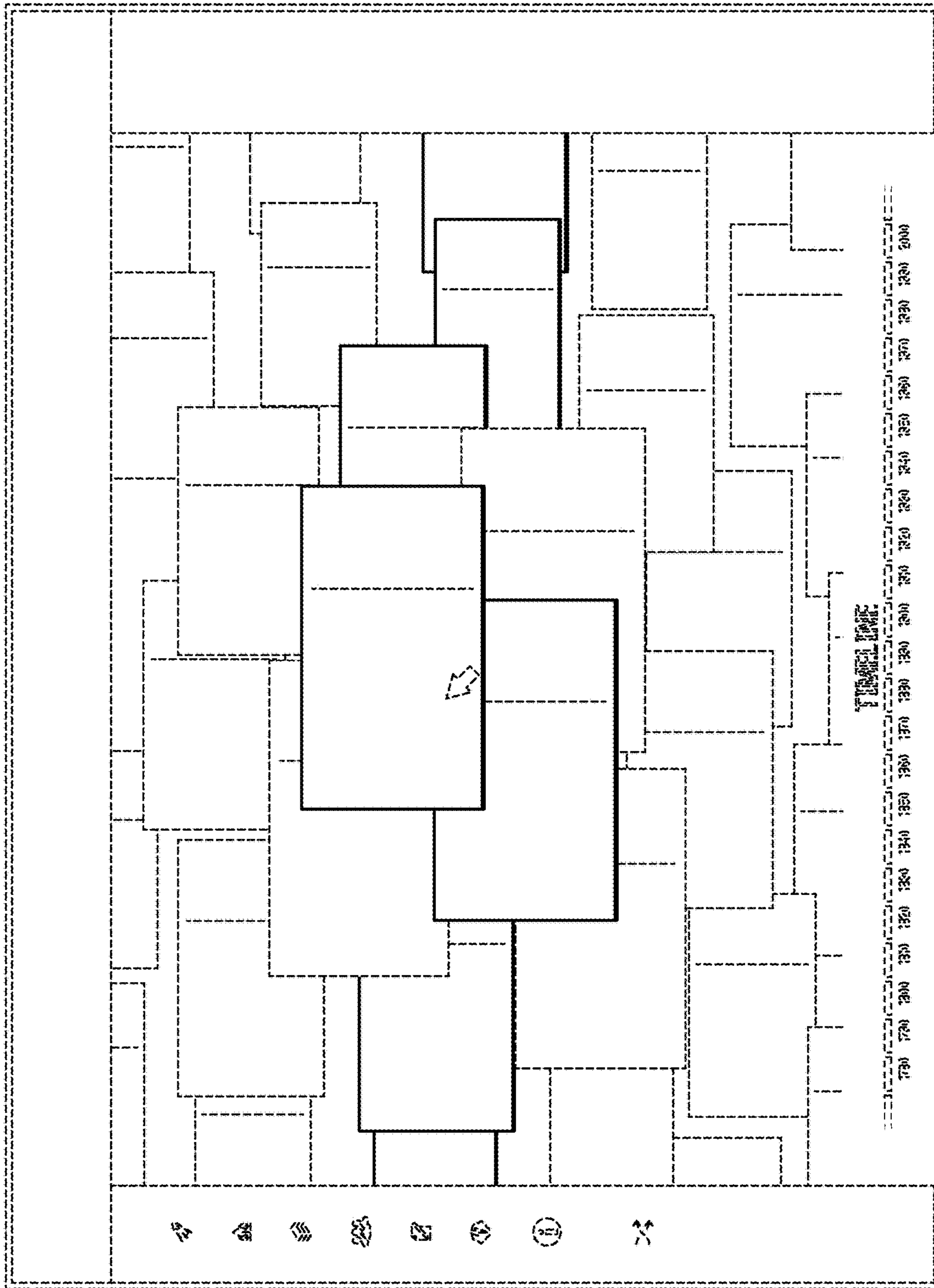

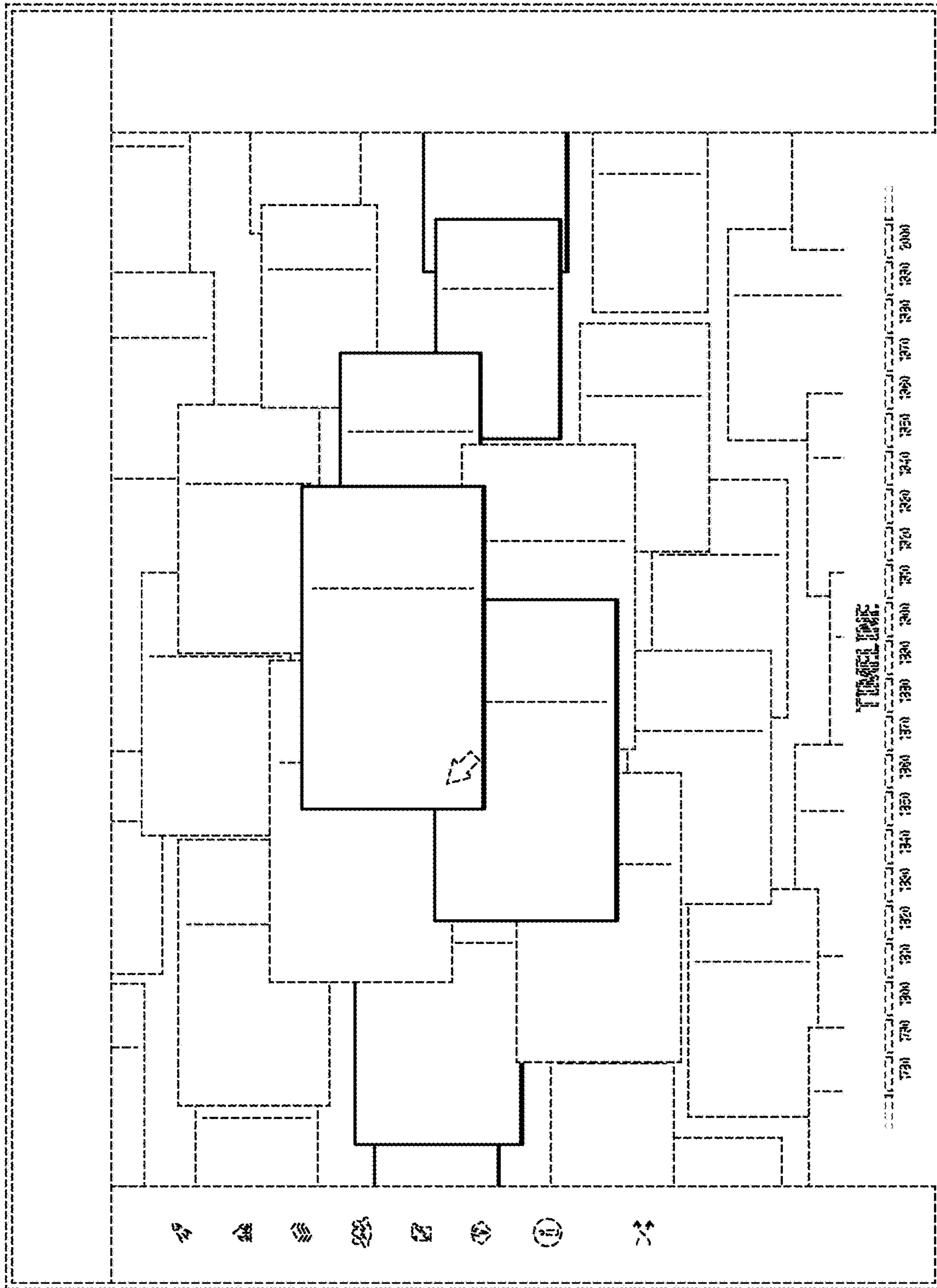

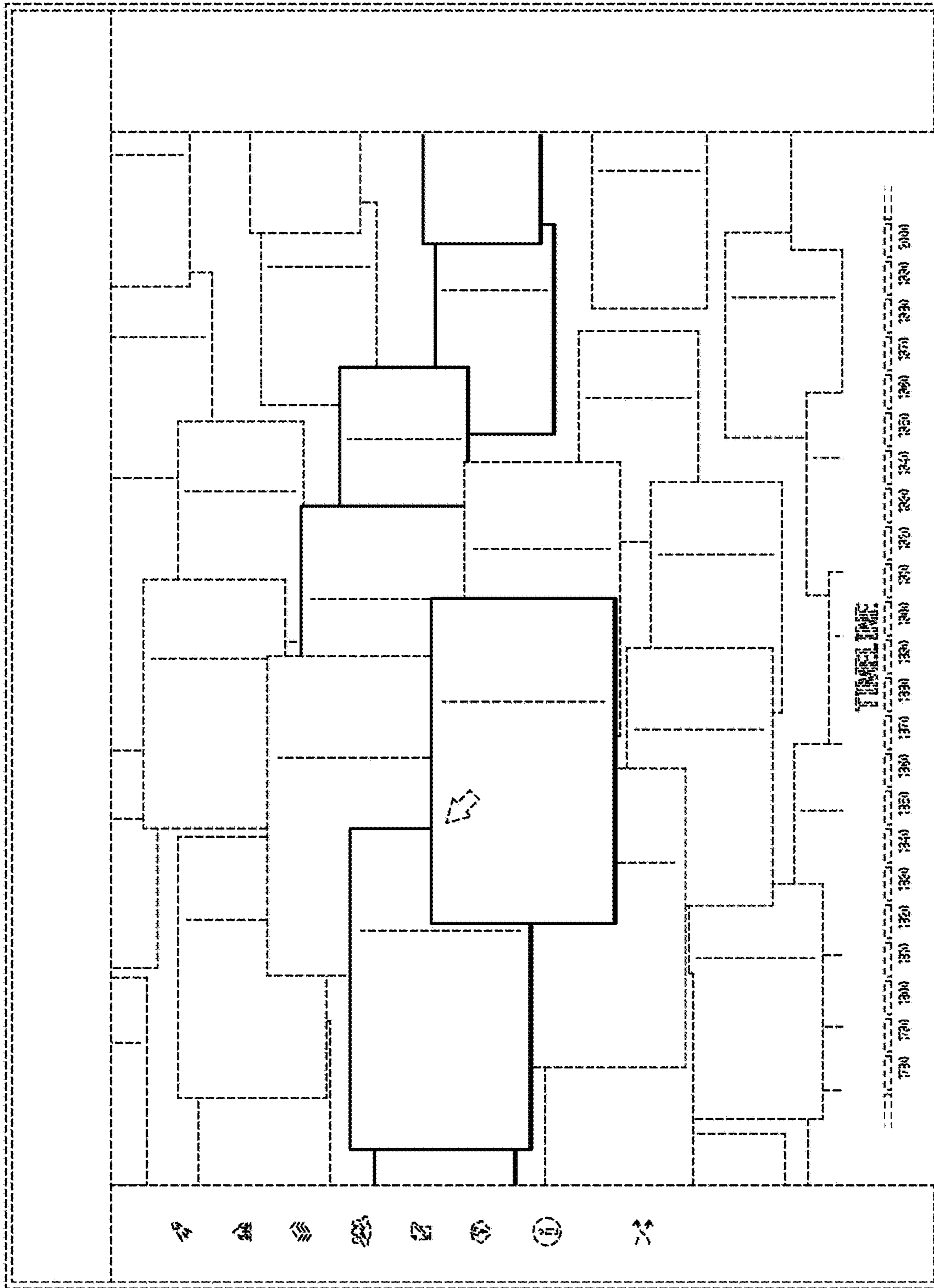

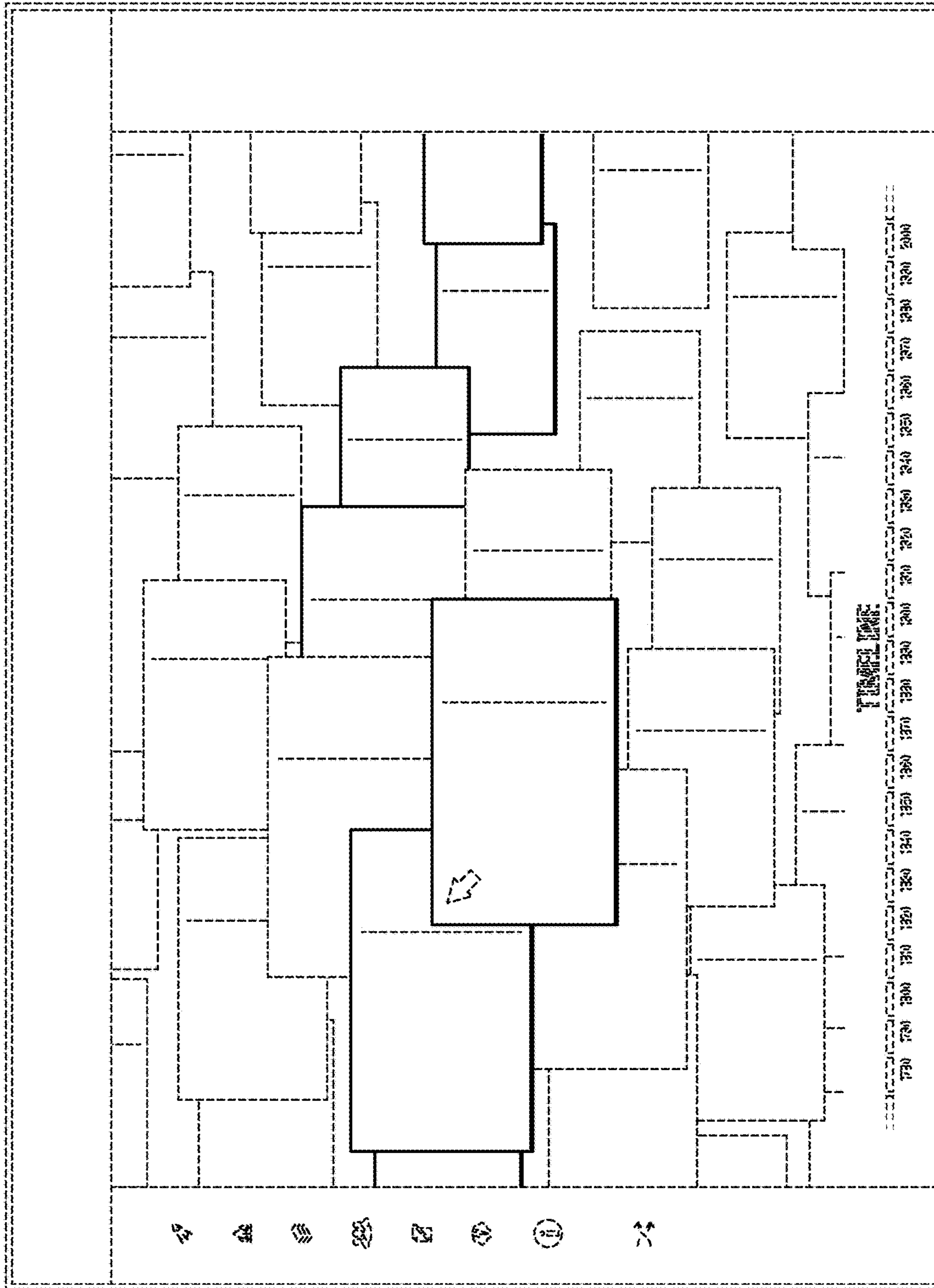

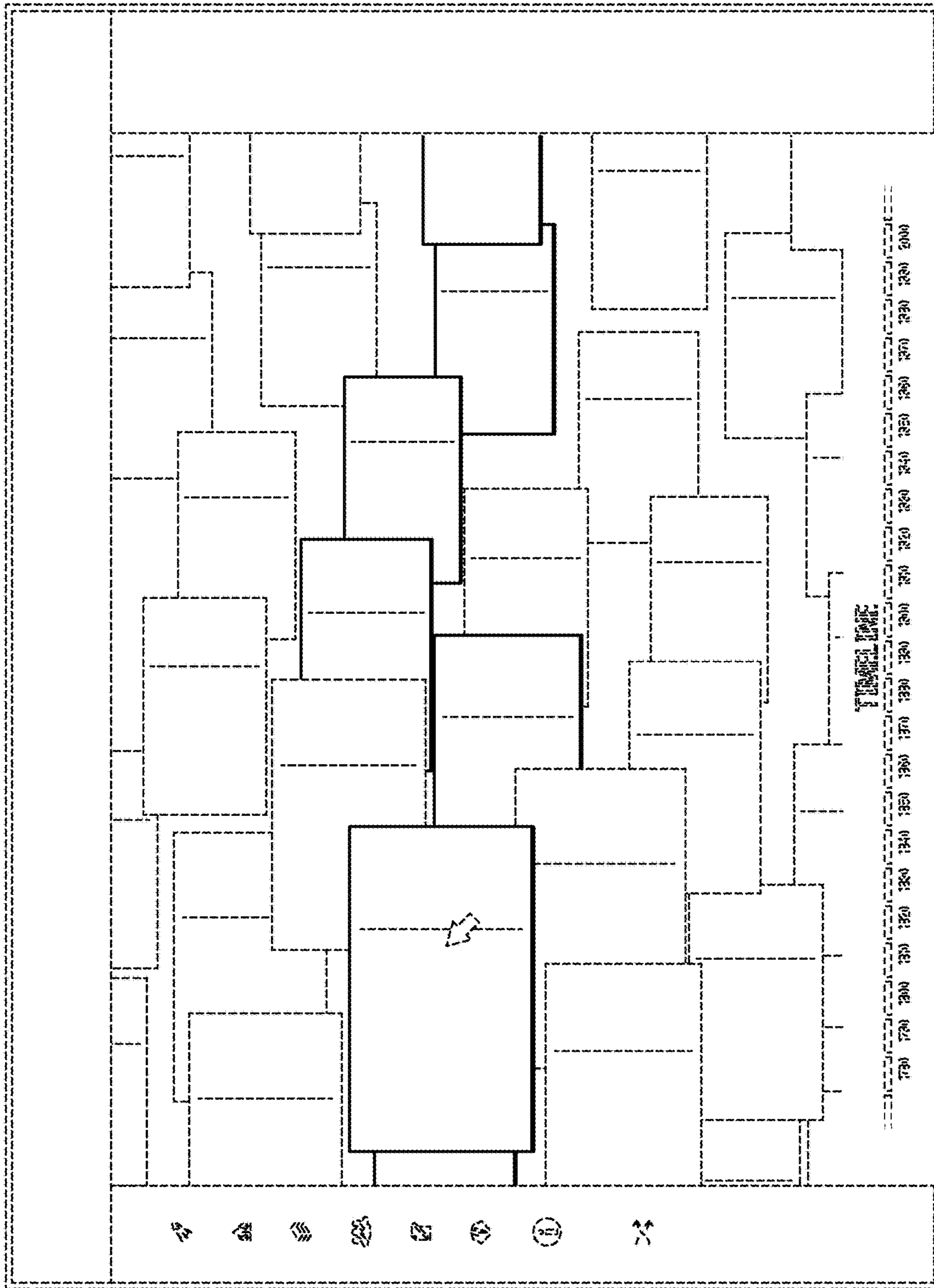

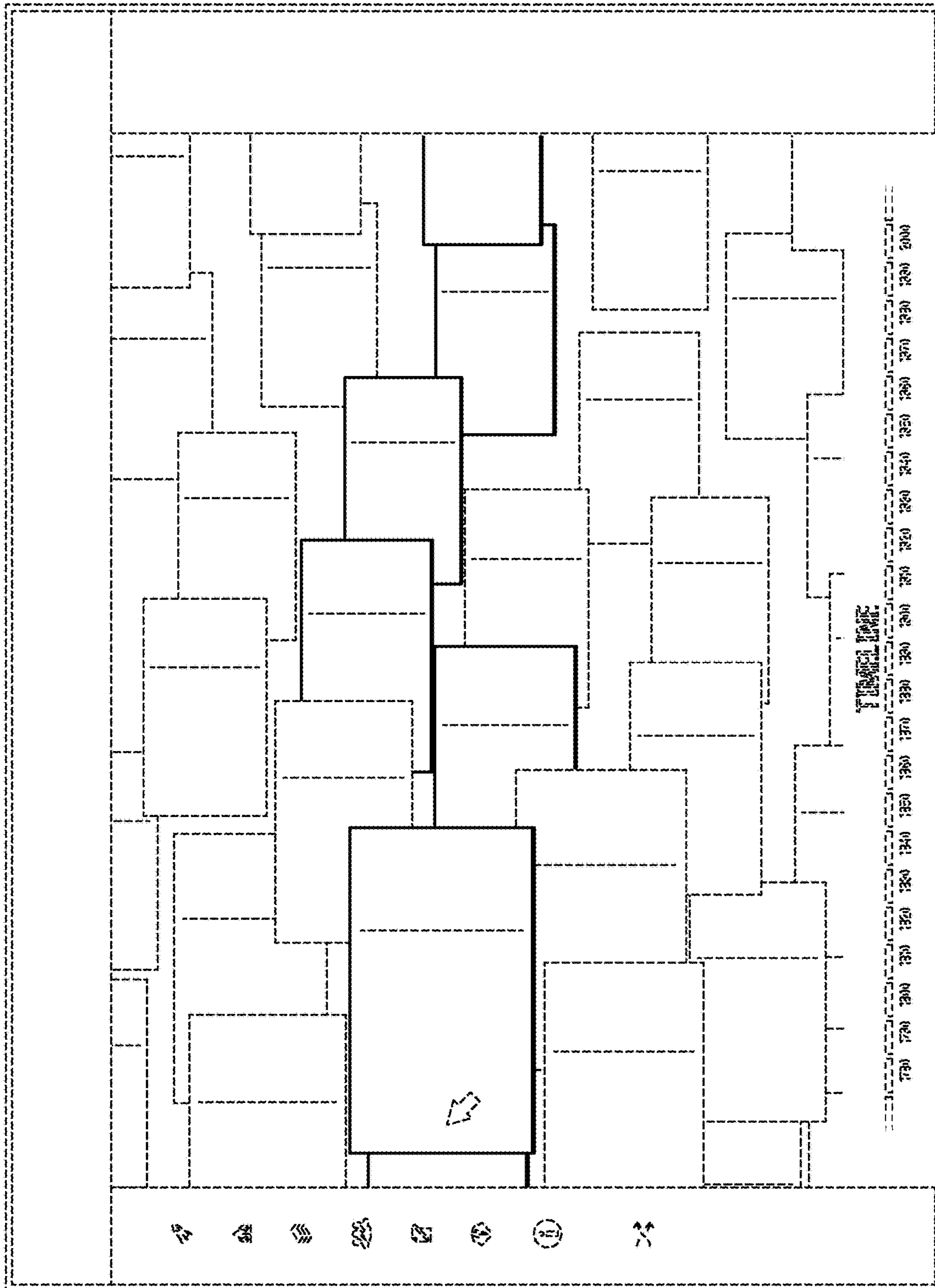

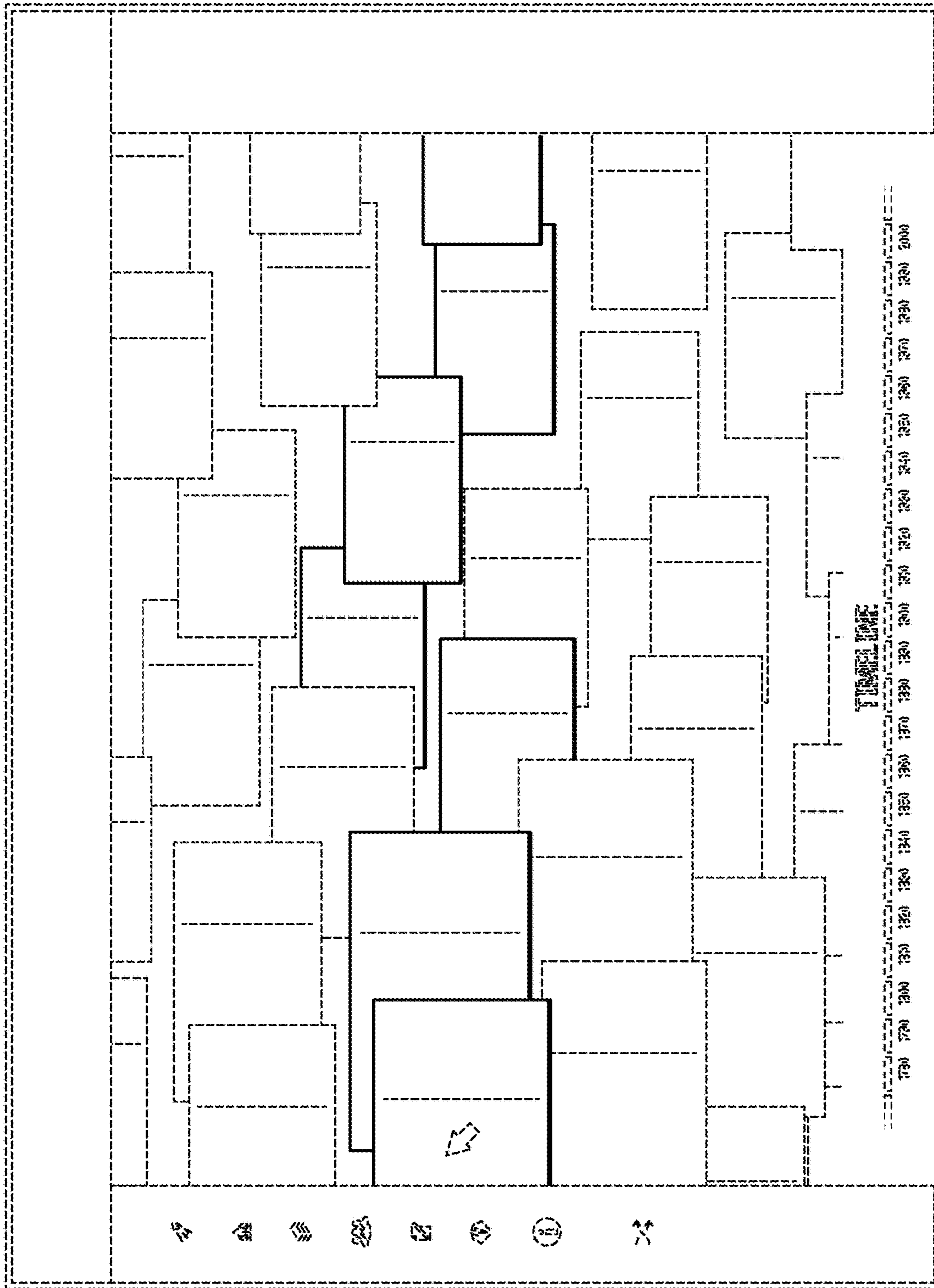

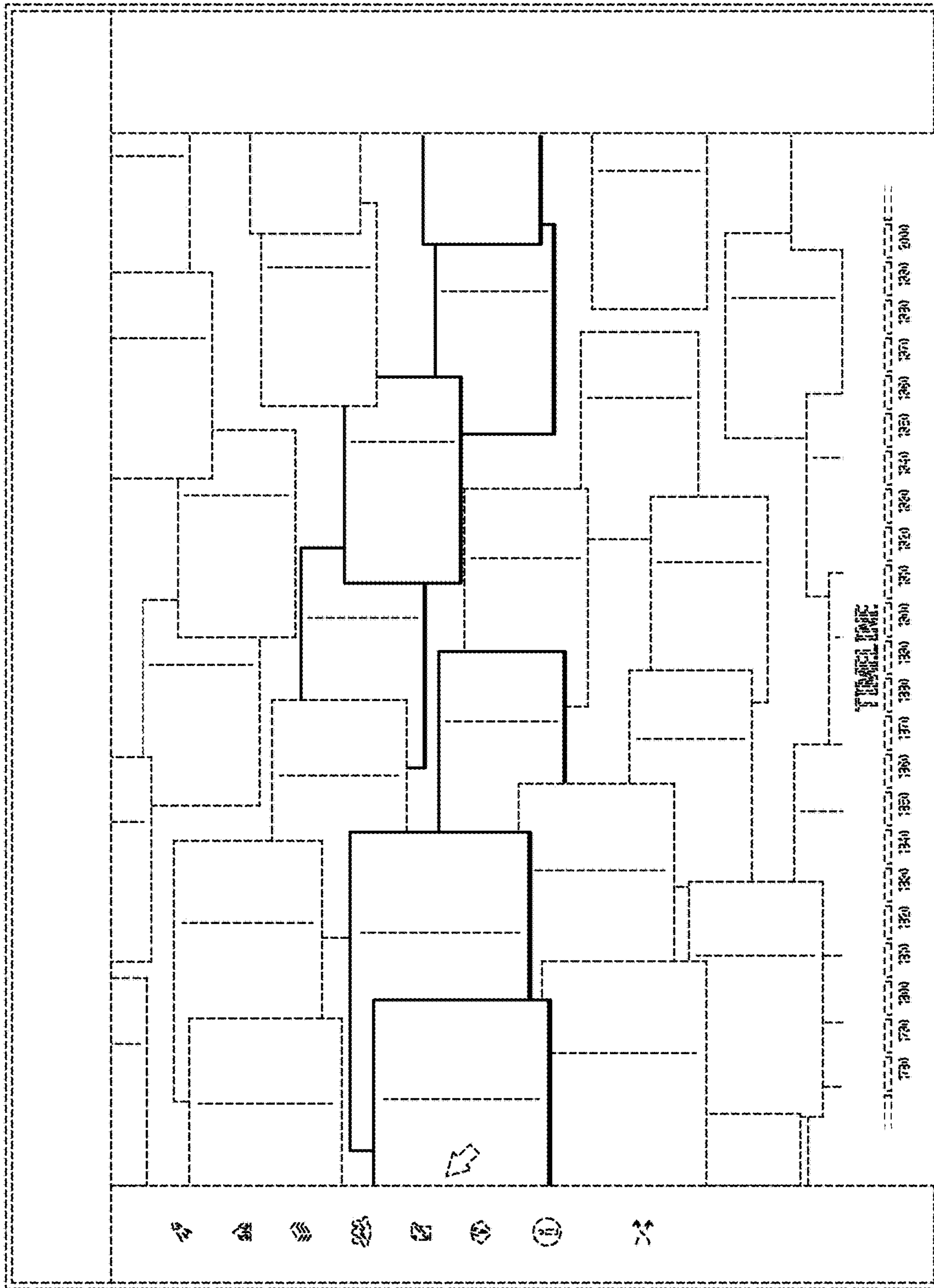

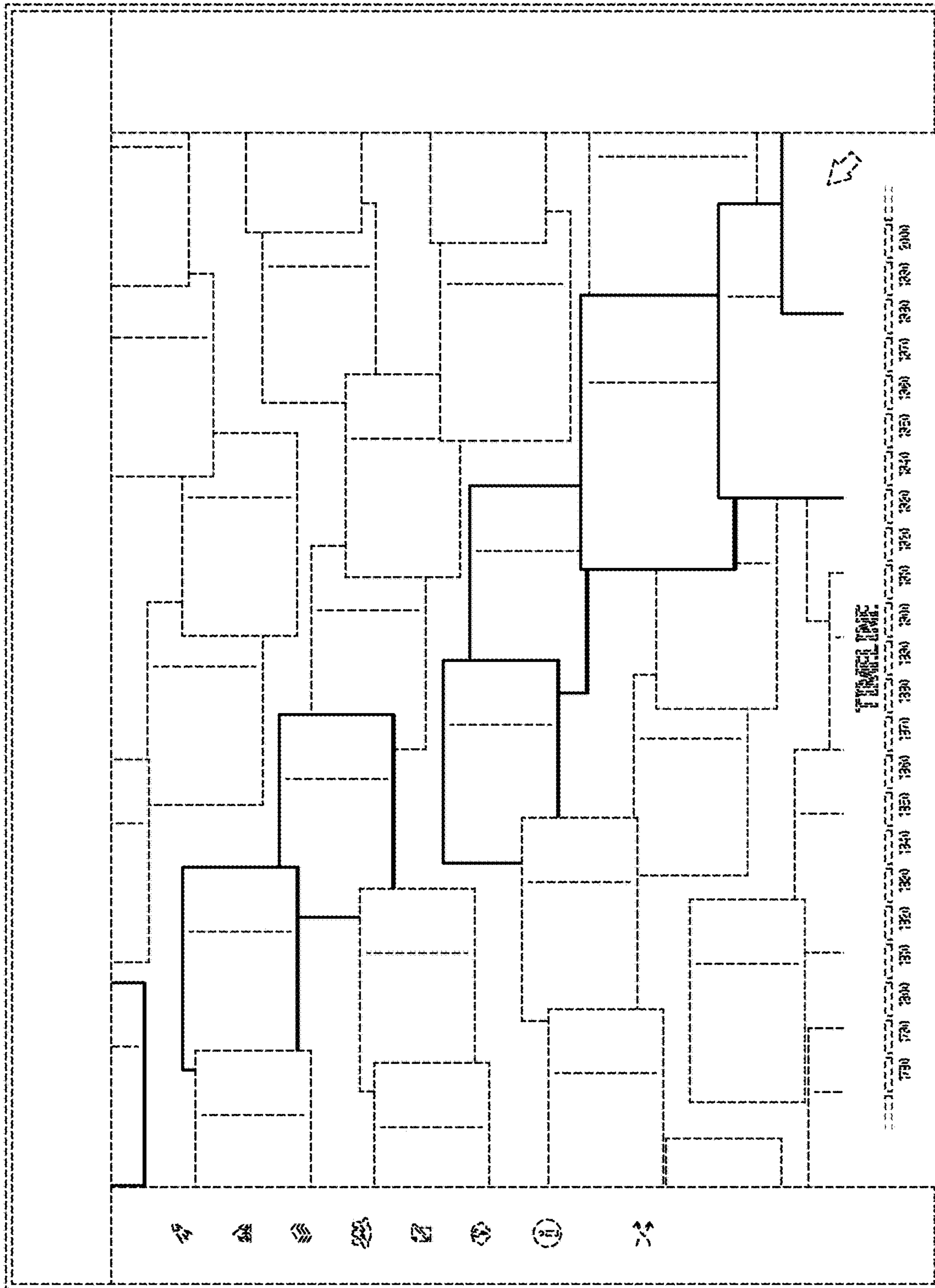

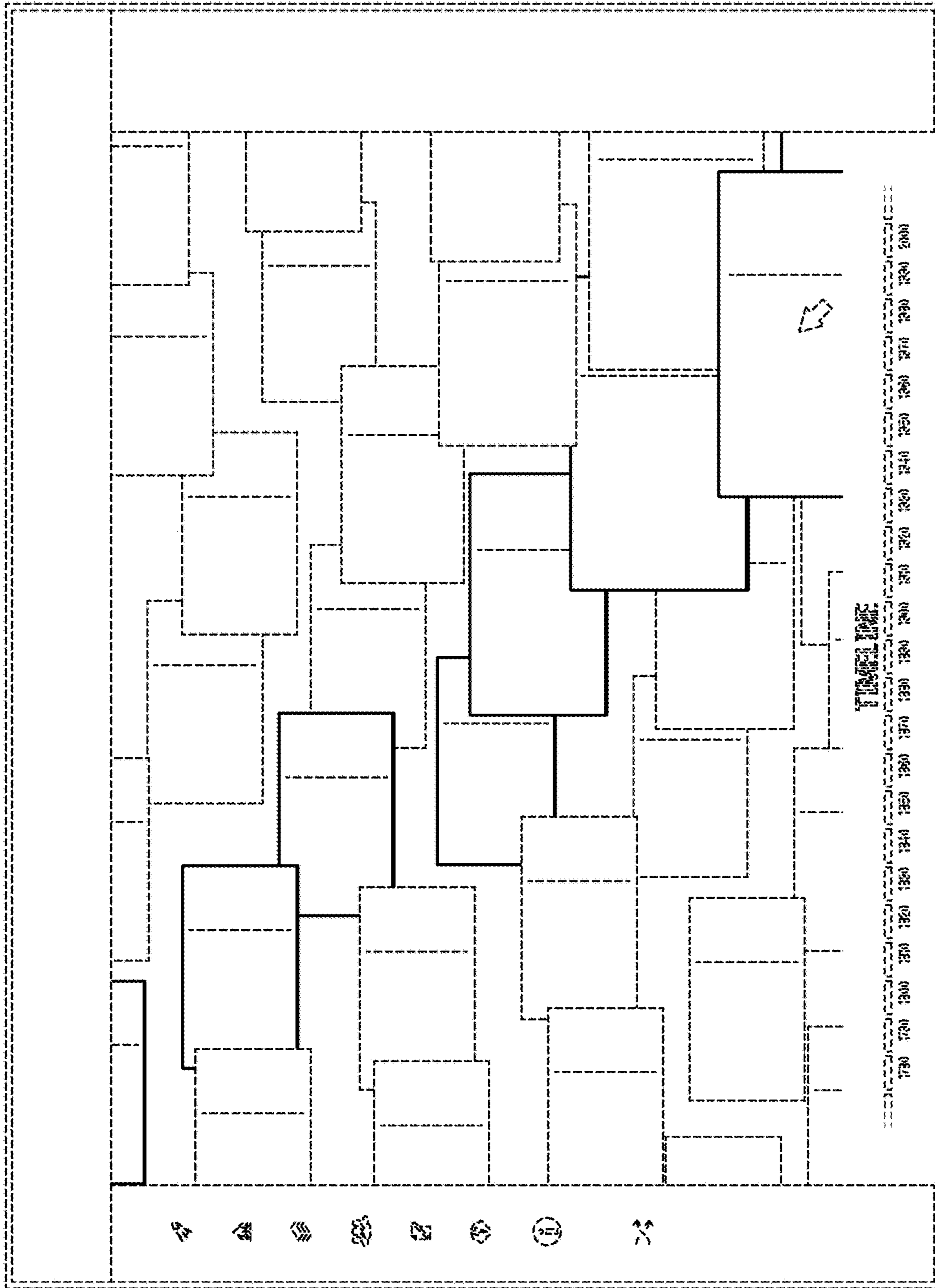

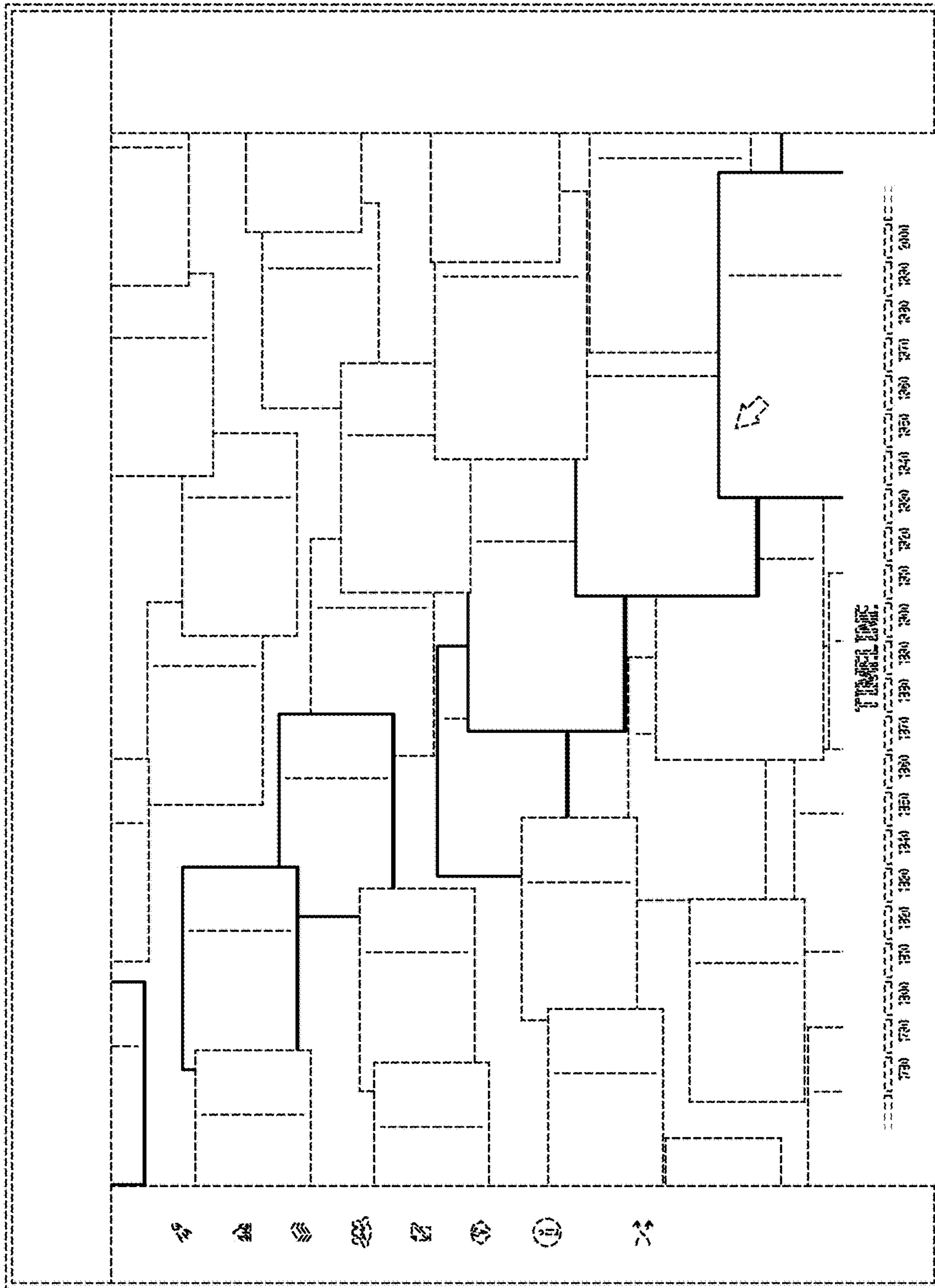

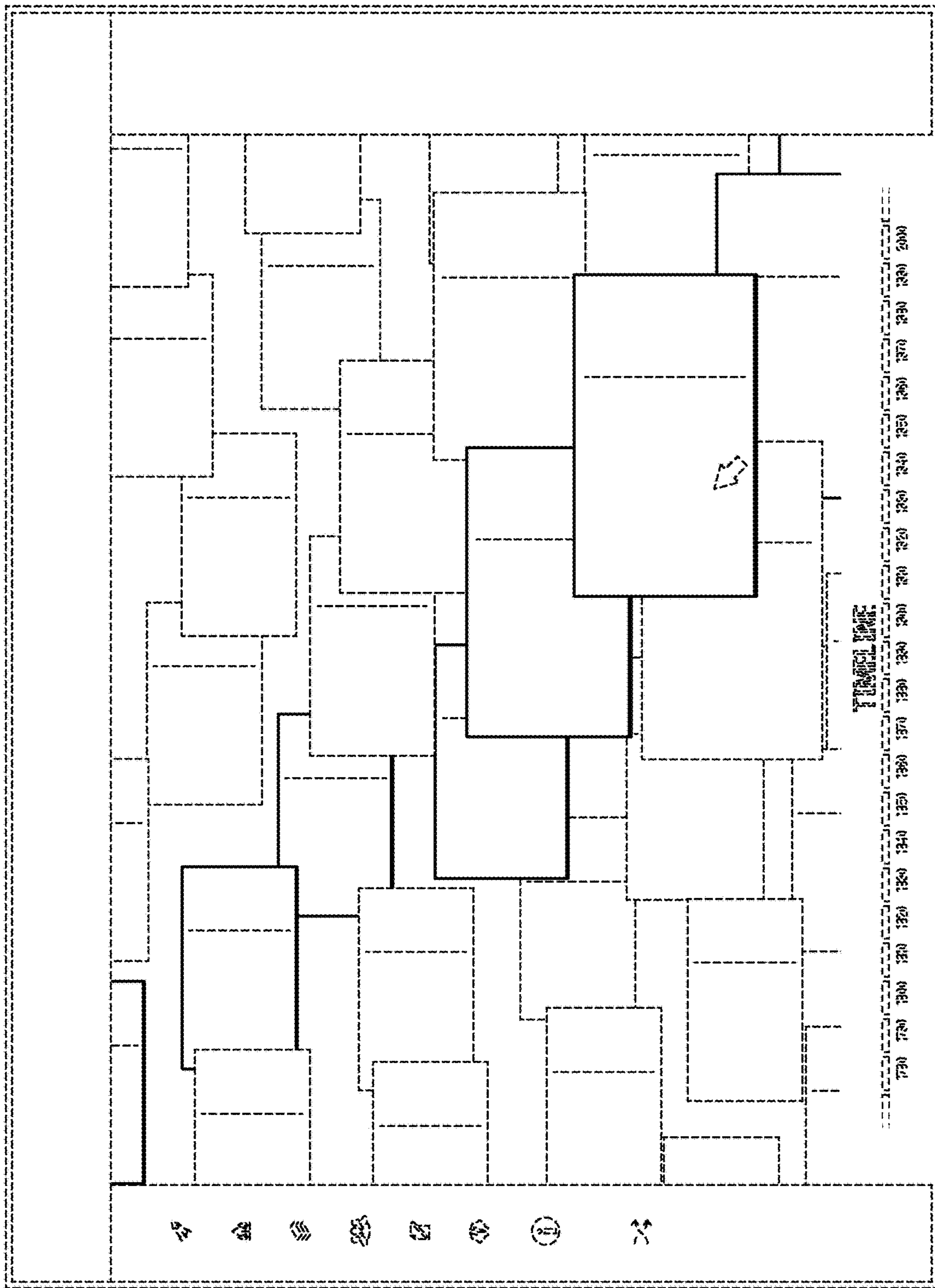

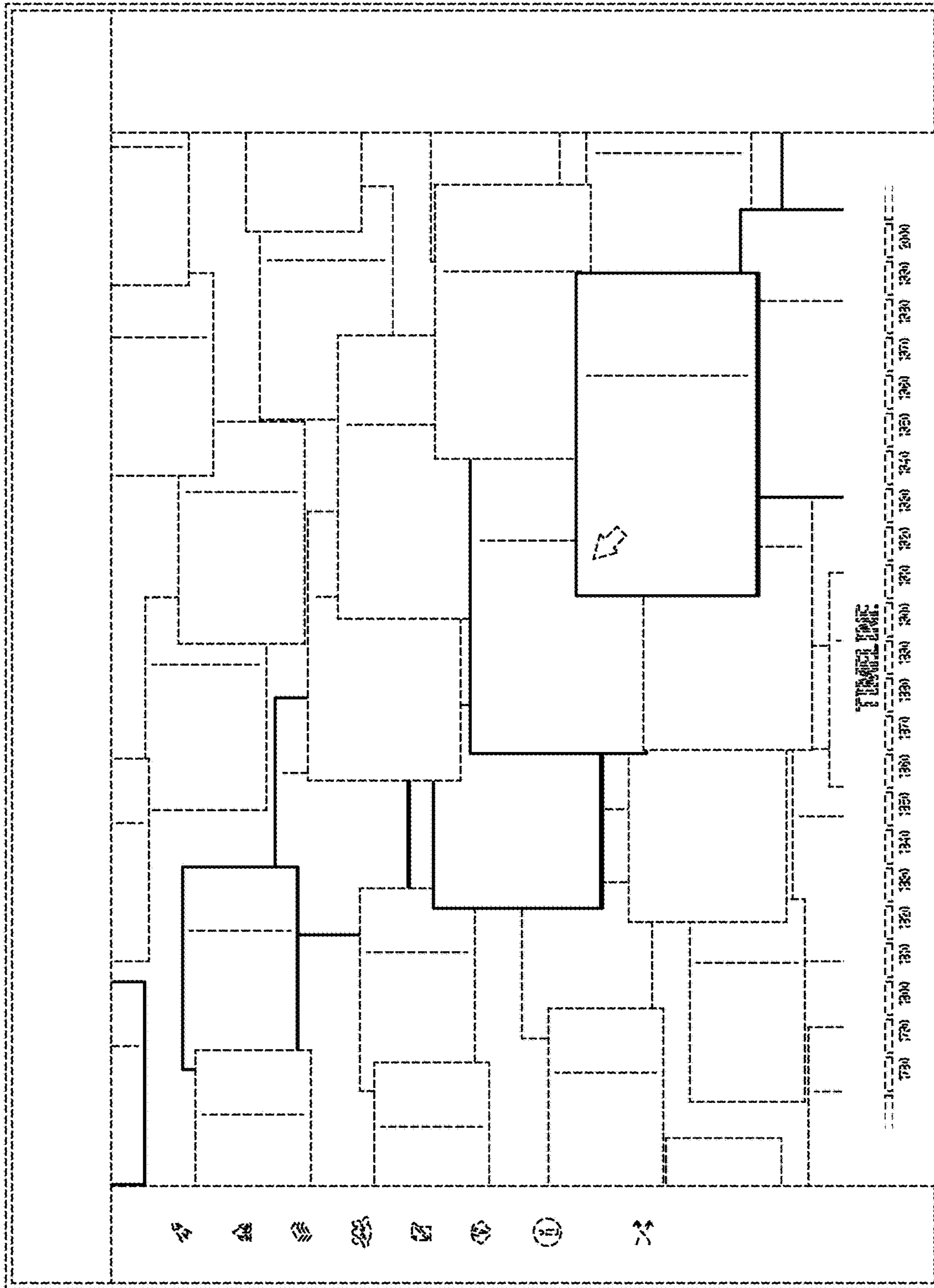

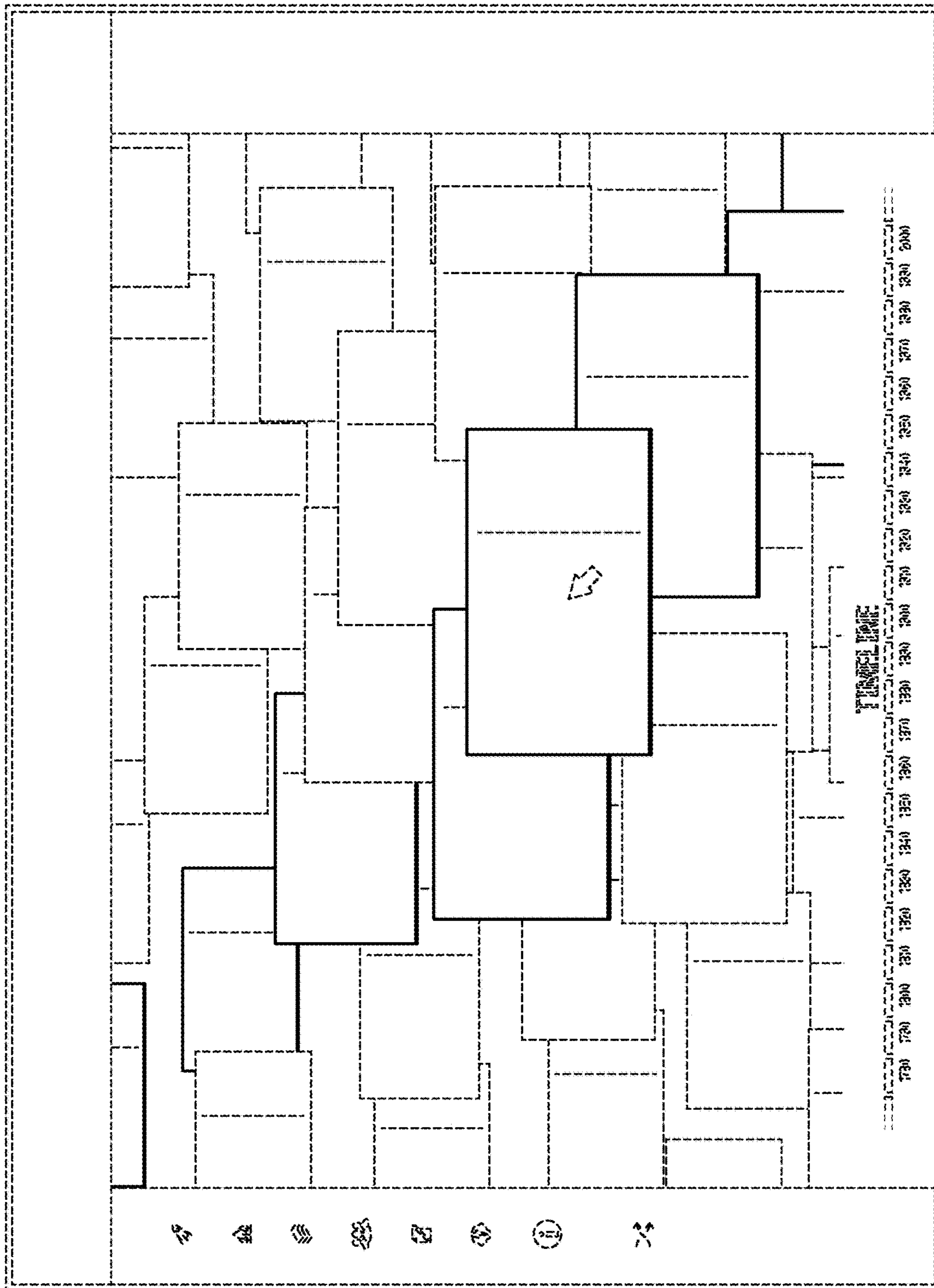

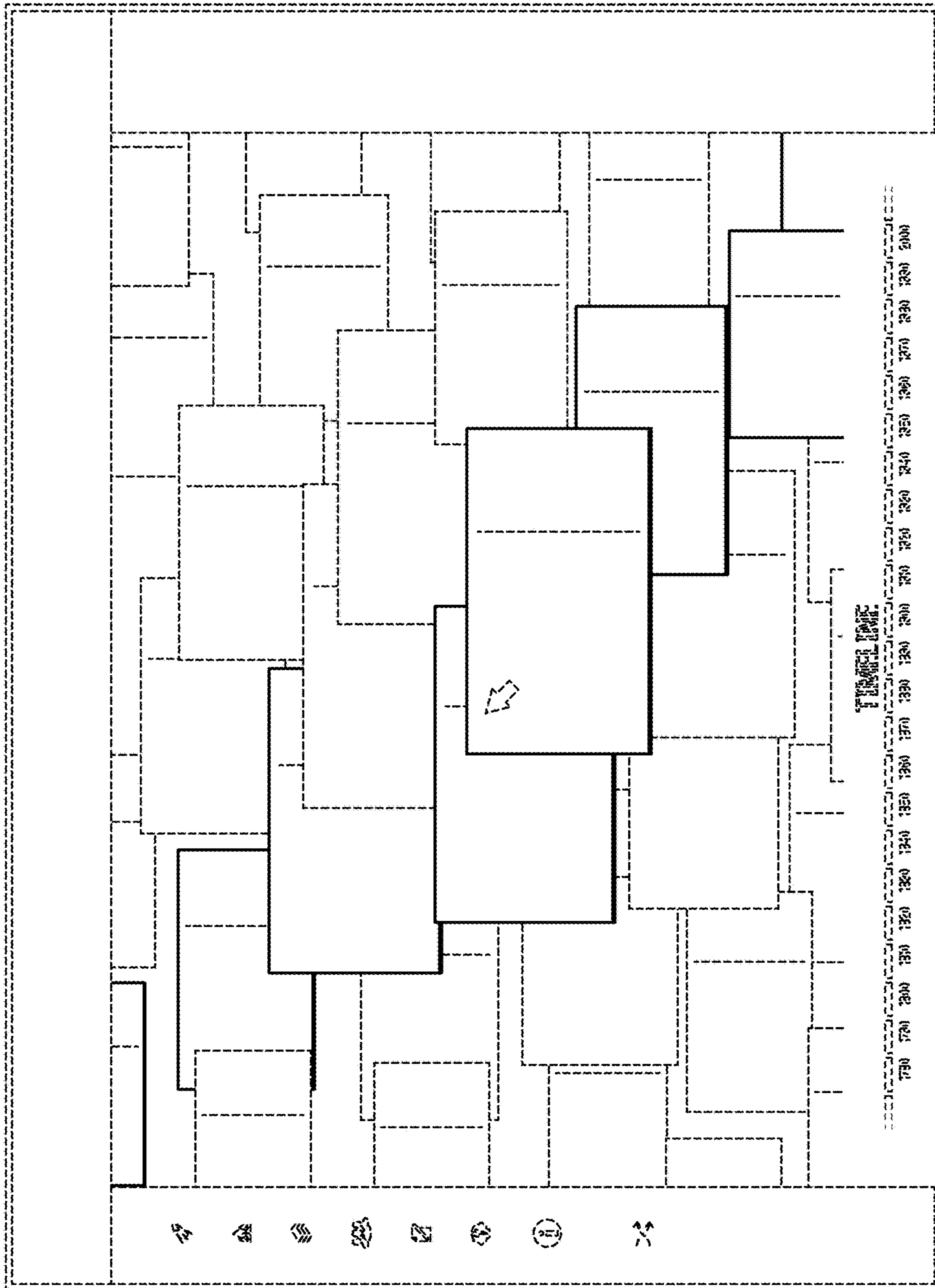

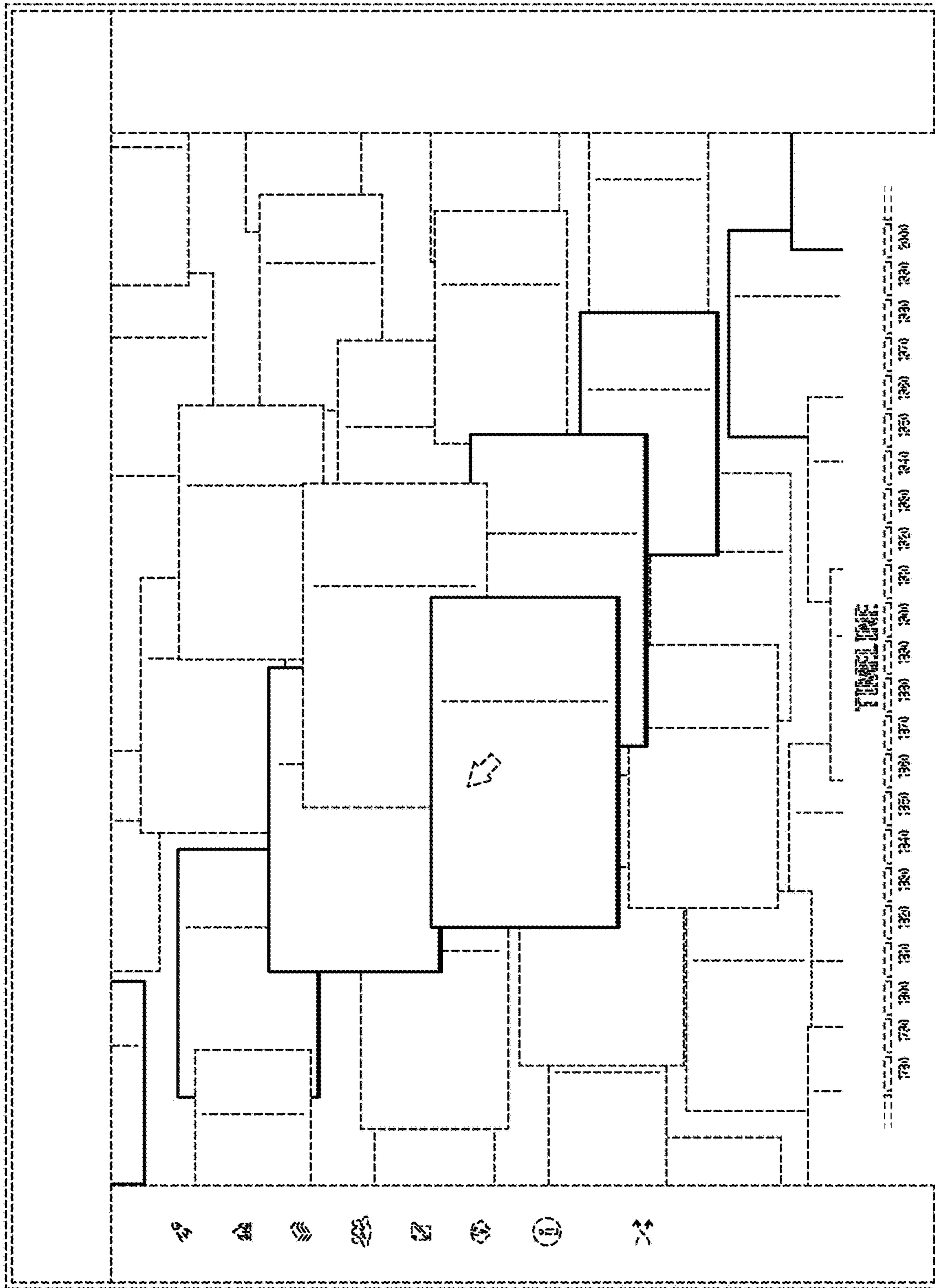

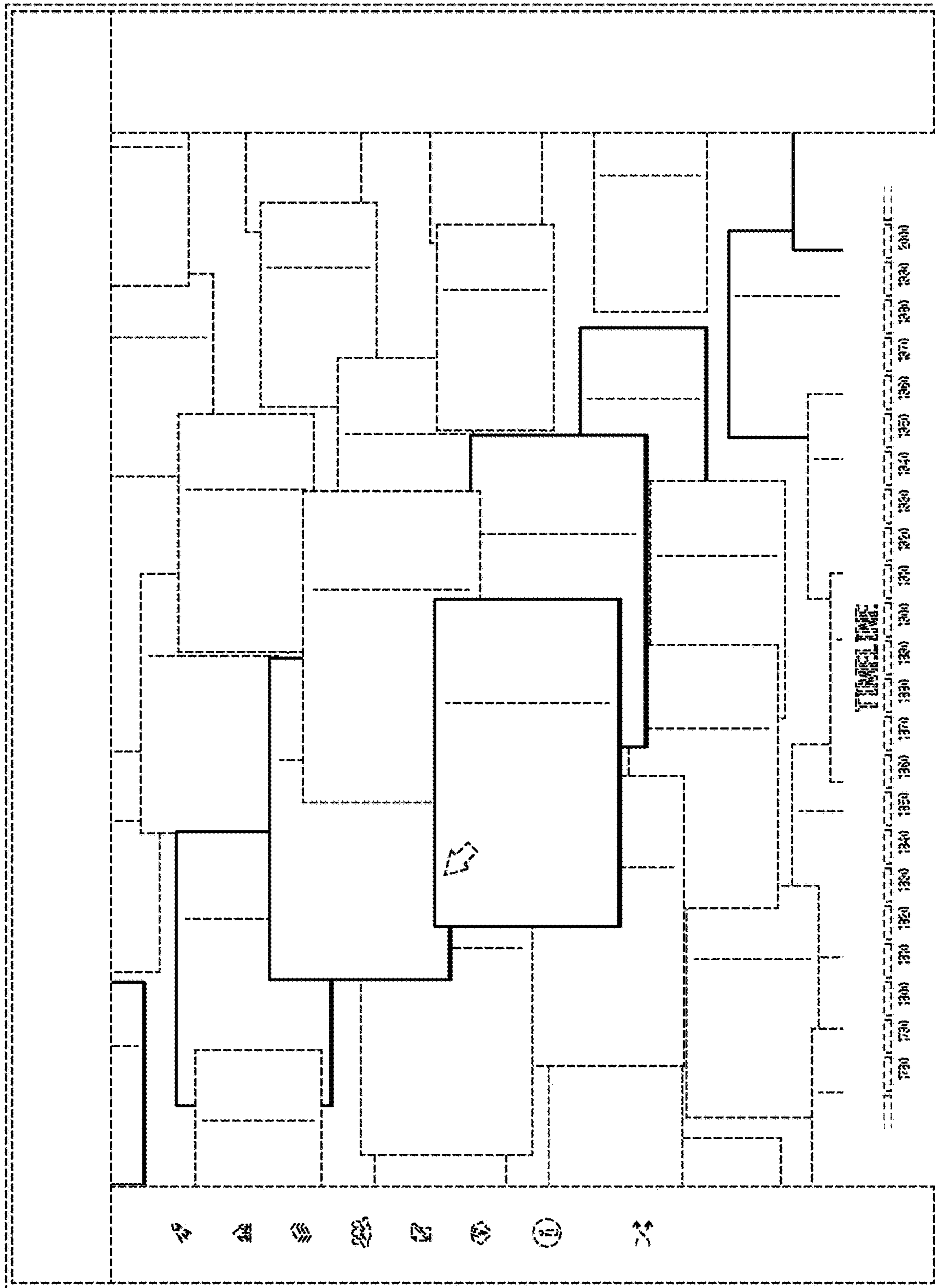

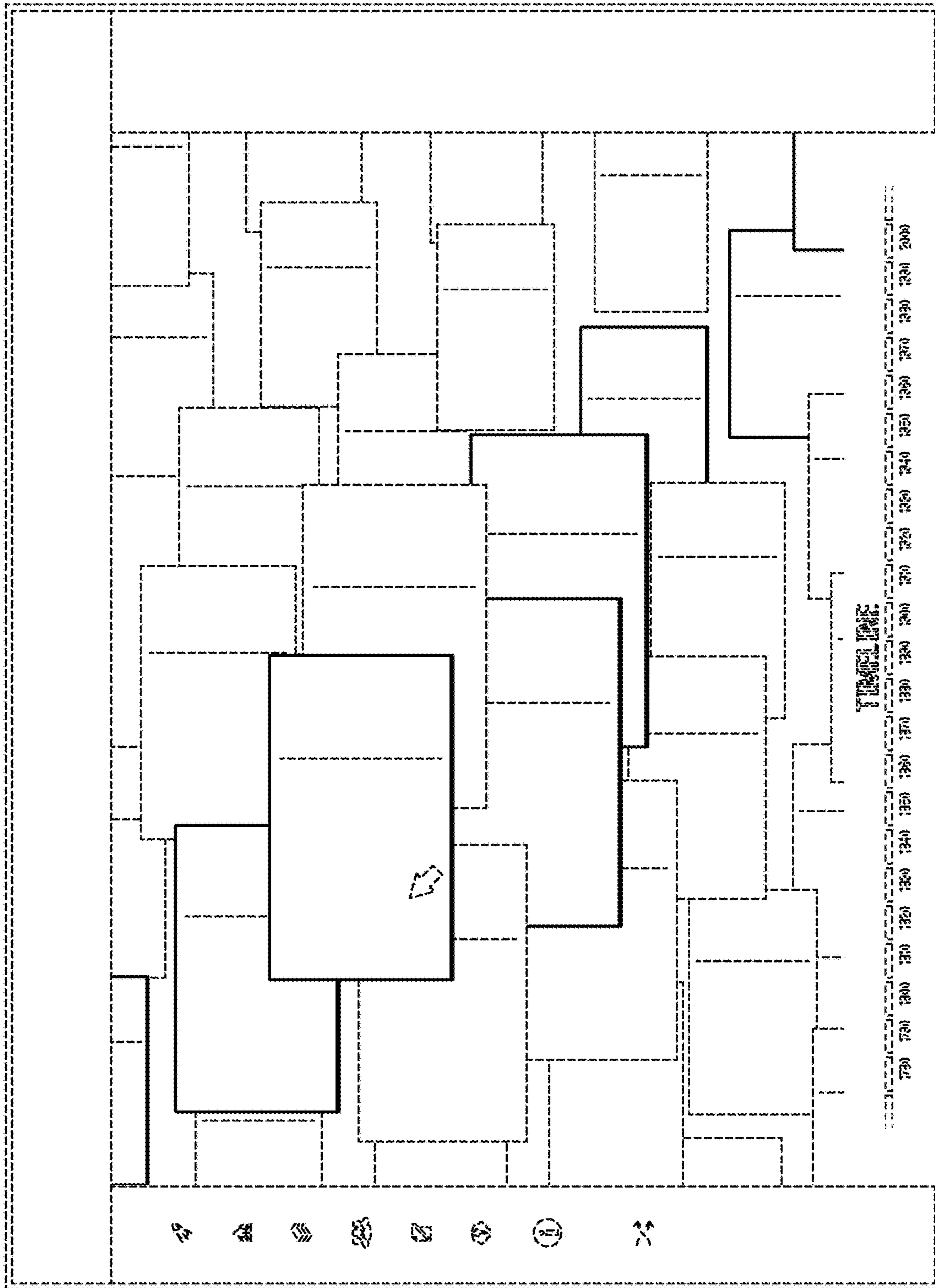

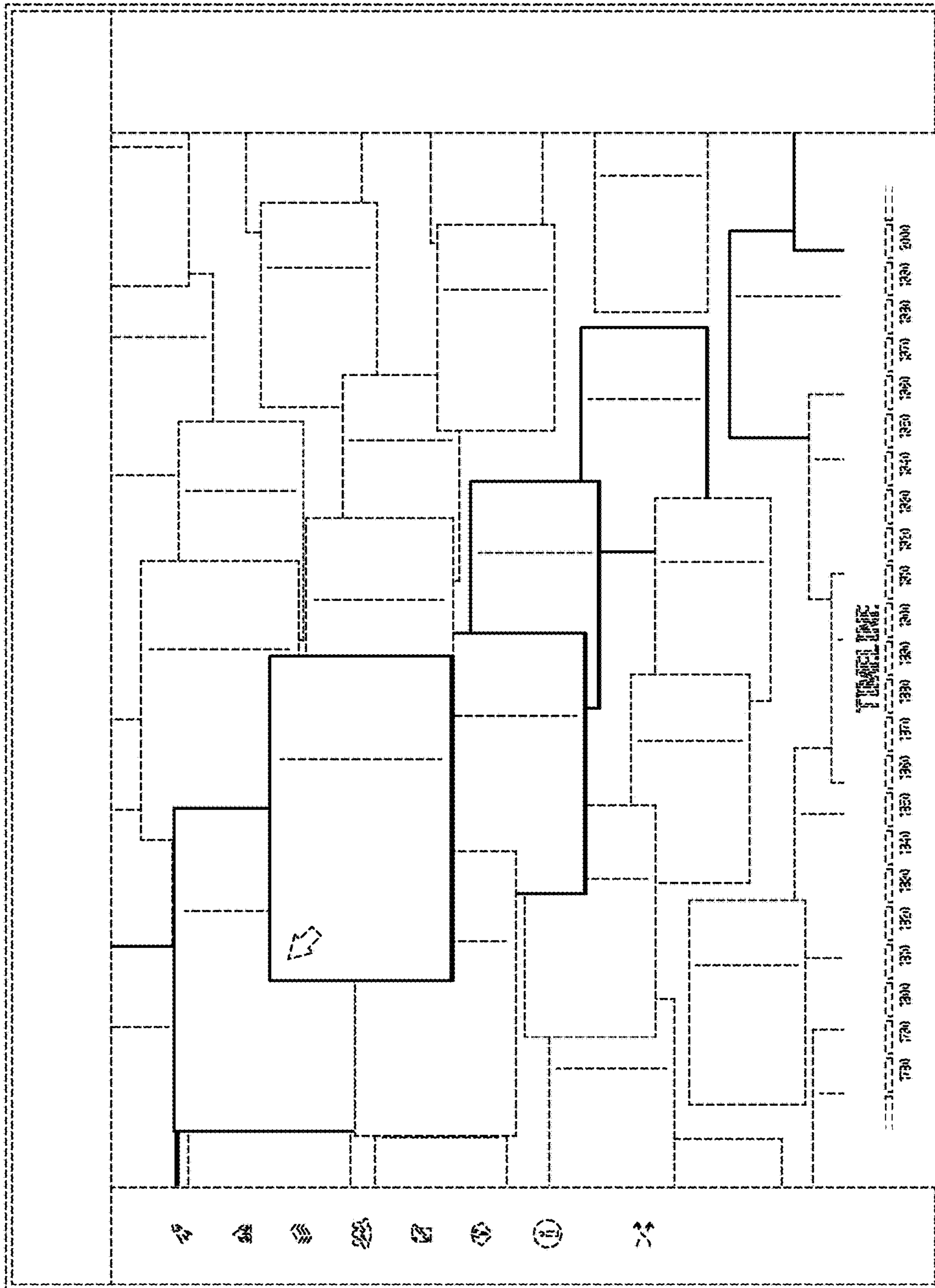

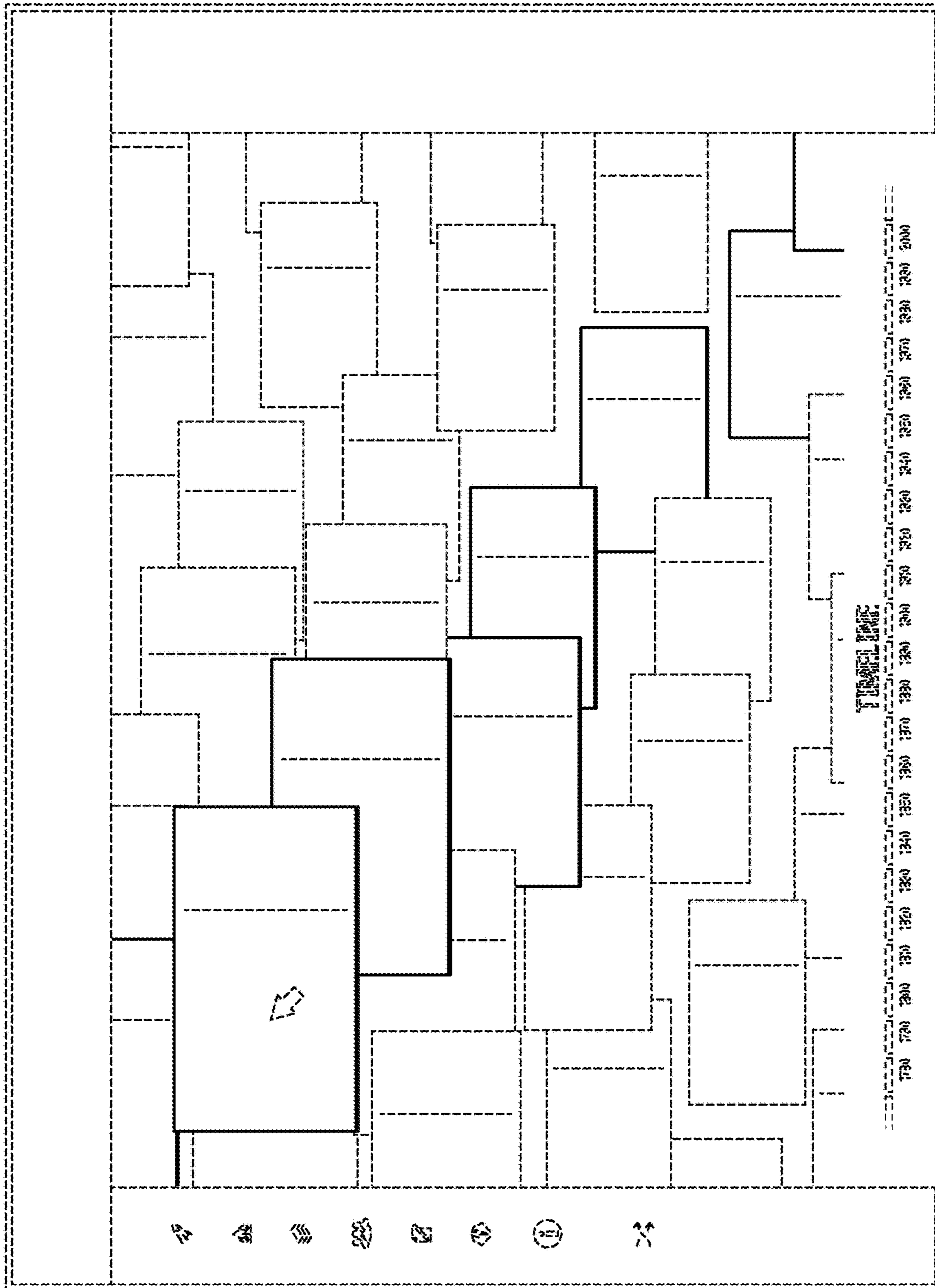
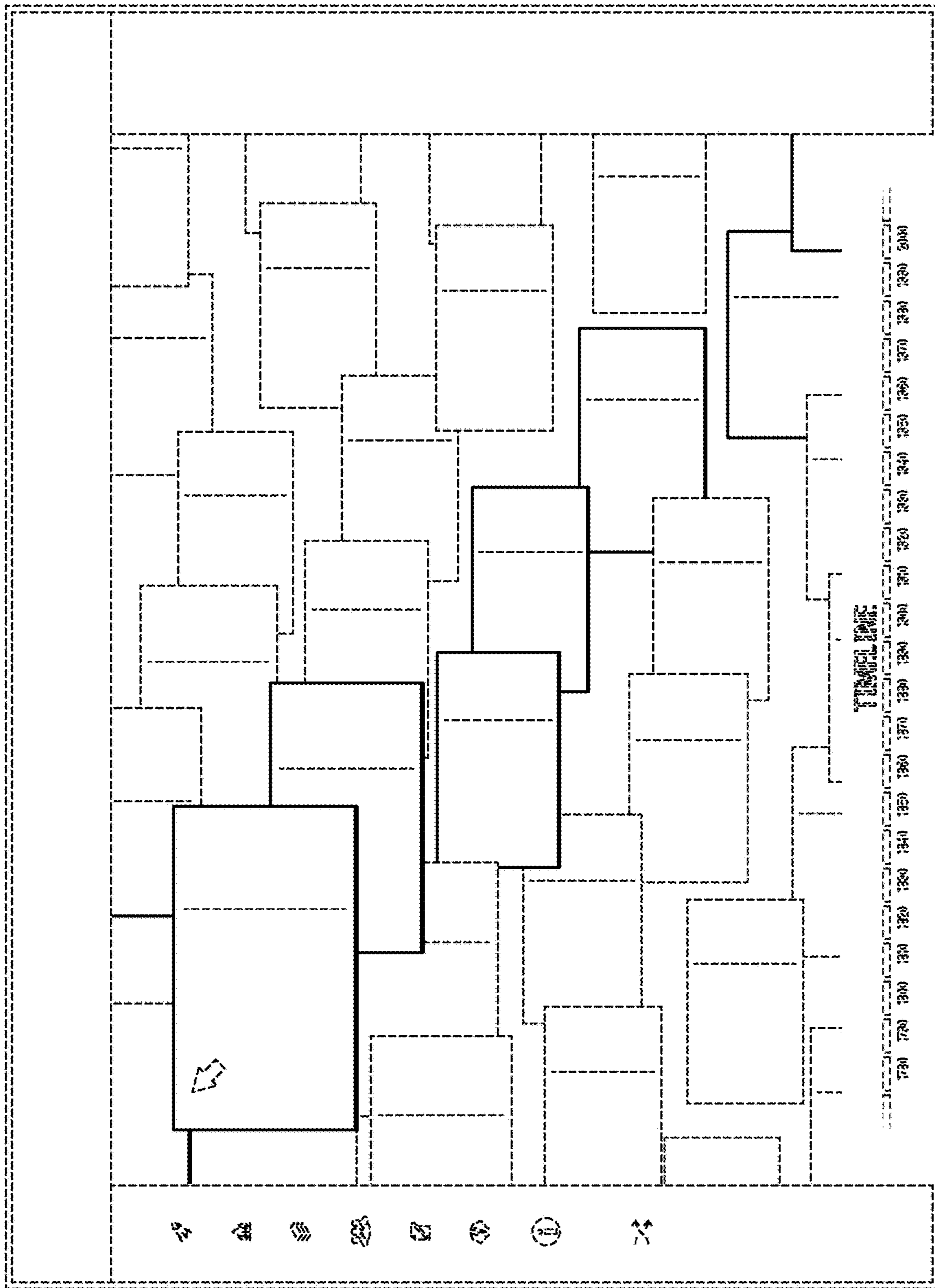

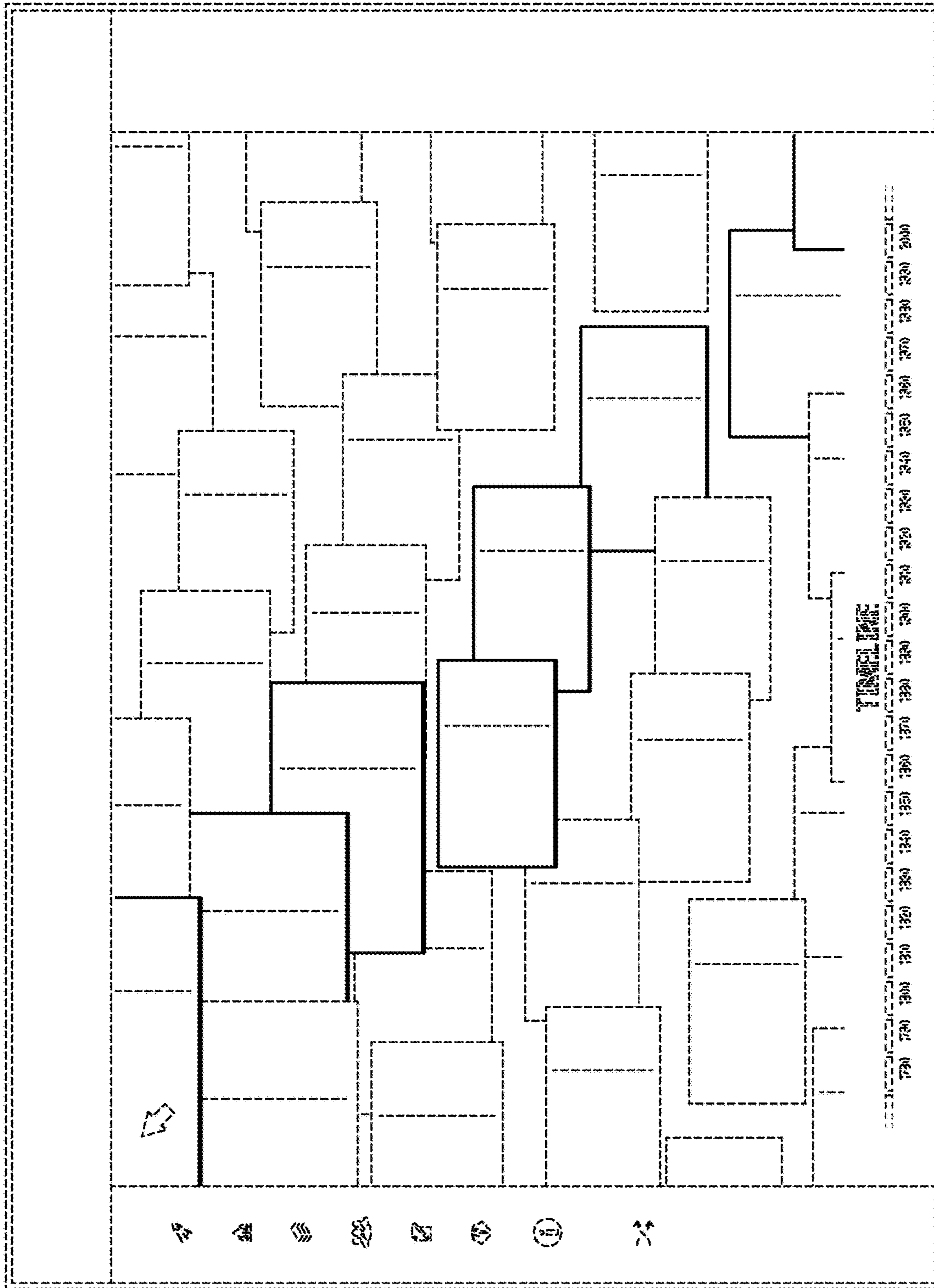
