FIG. 6 is a sixth image thereof; and,

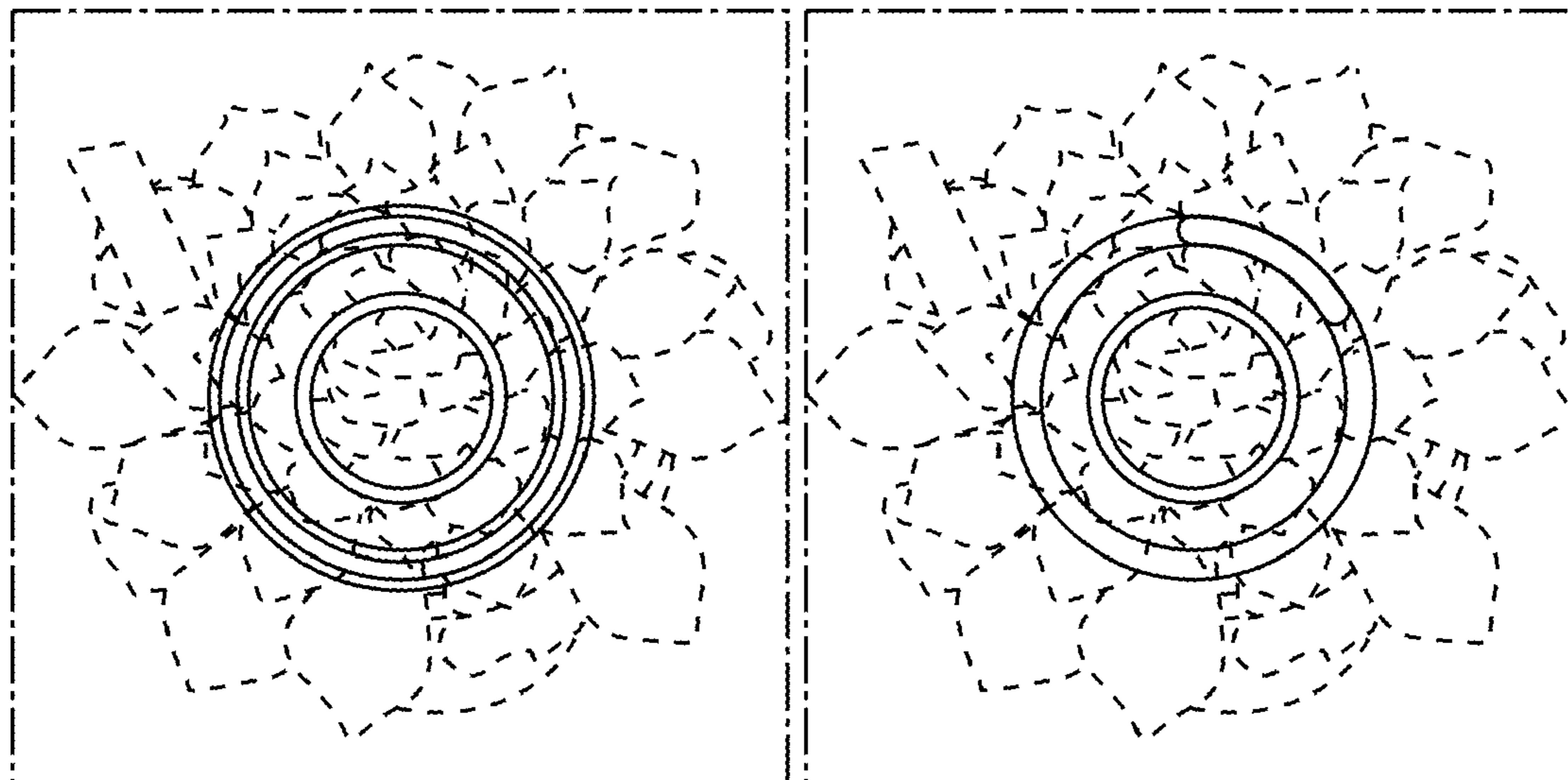
FIG. 7 is a seventh image thereof.

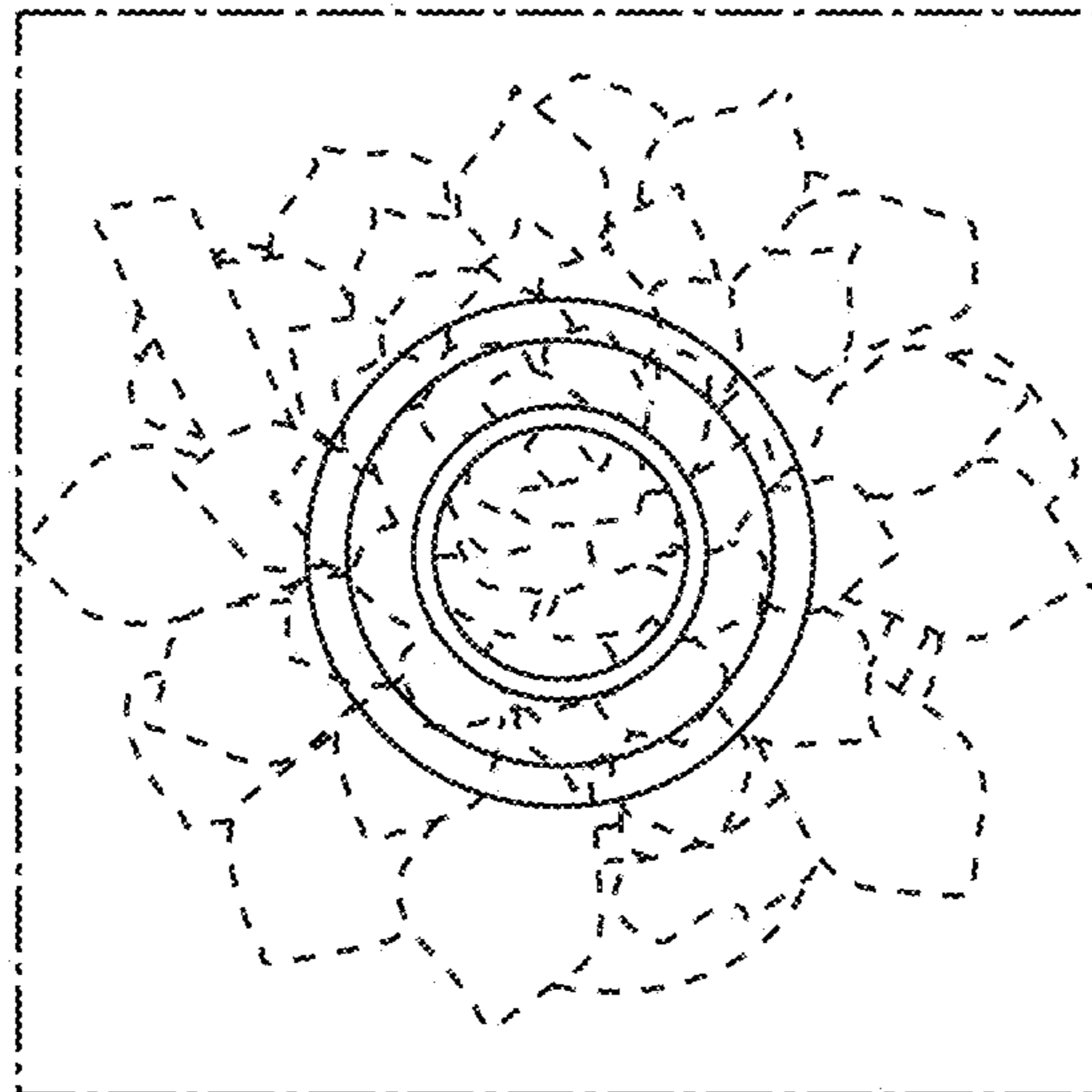

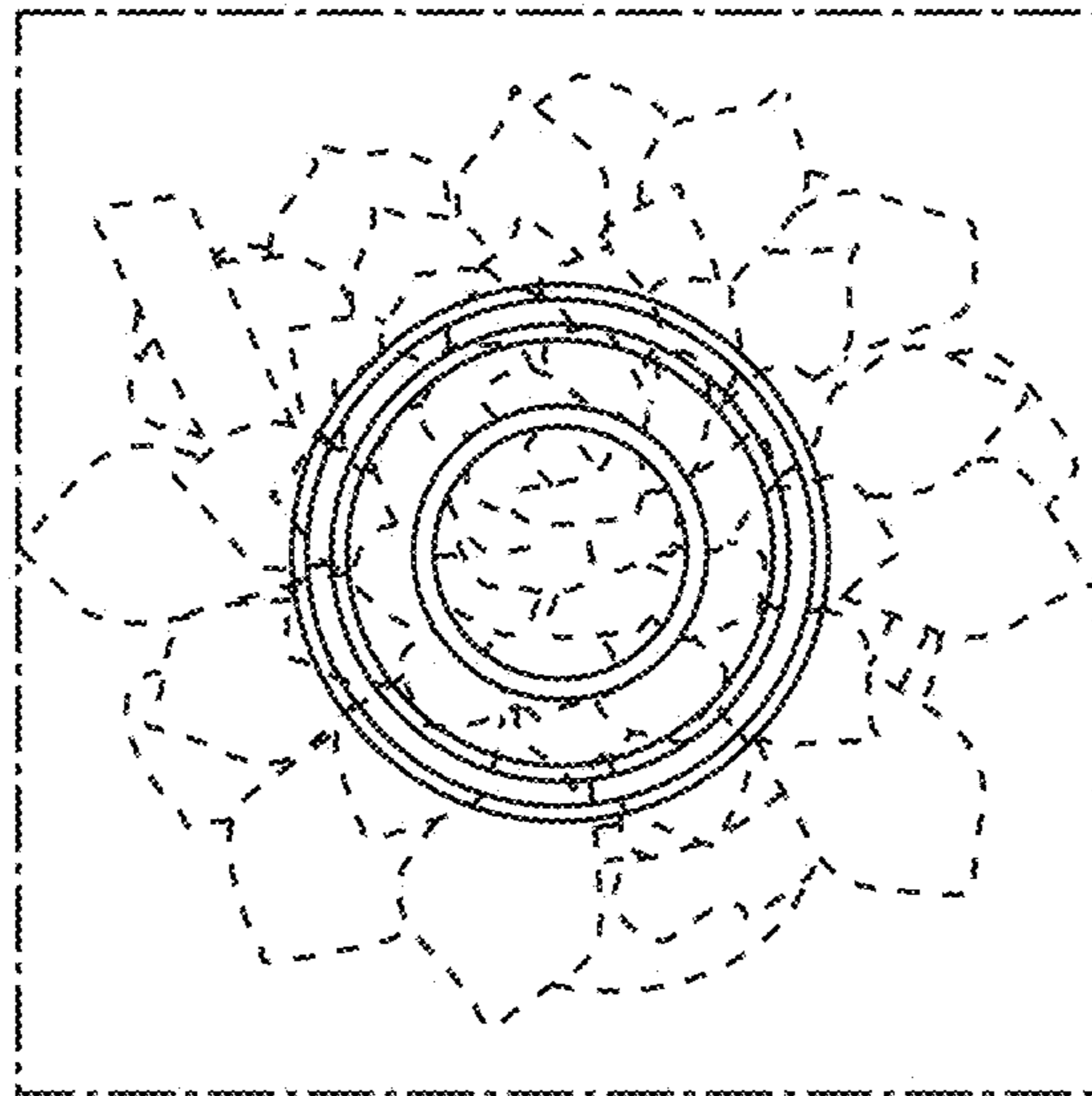

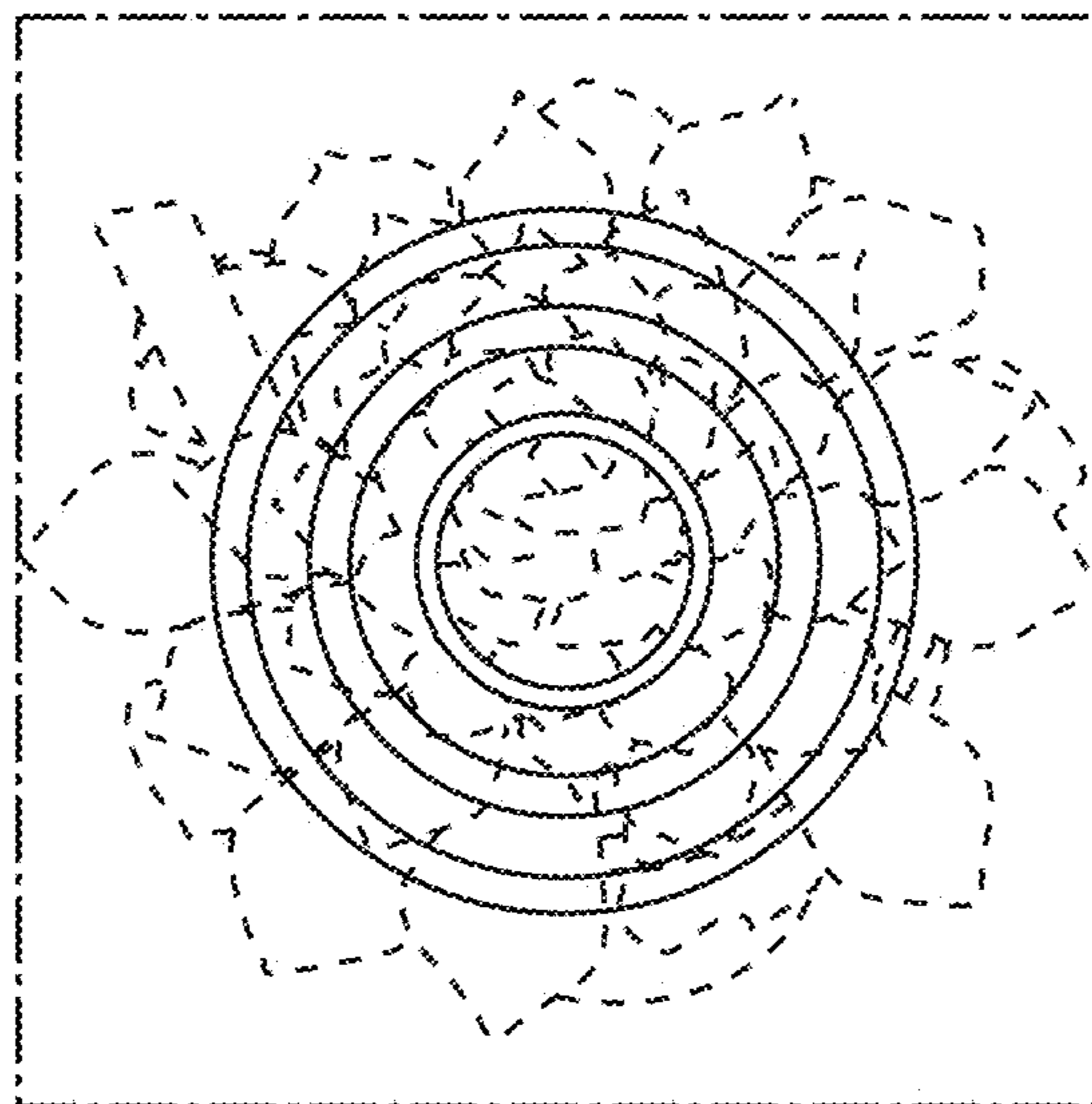

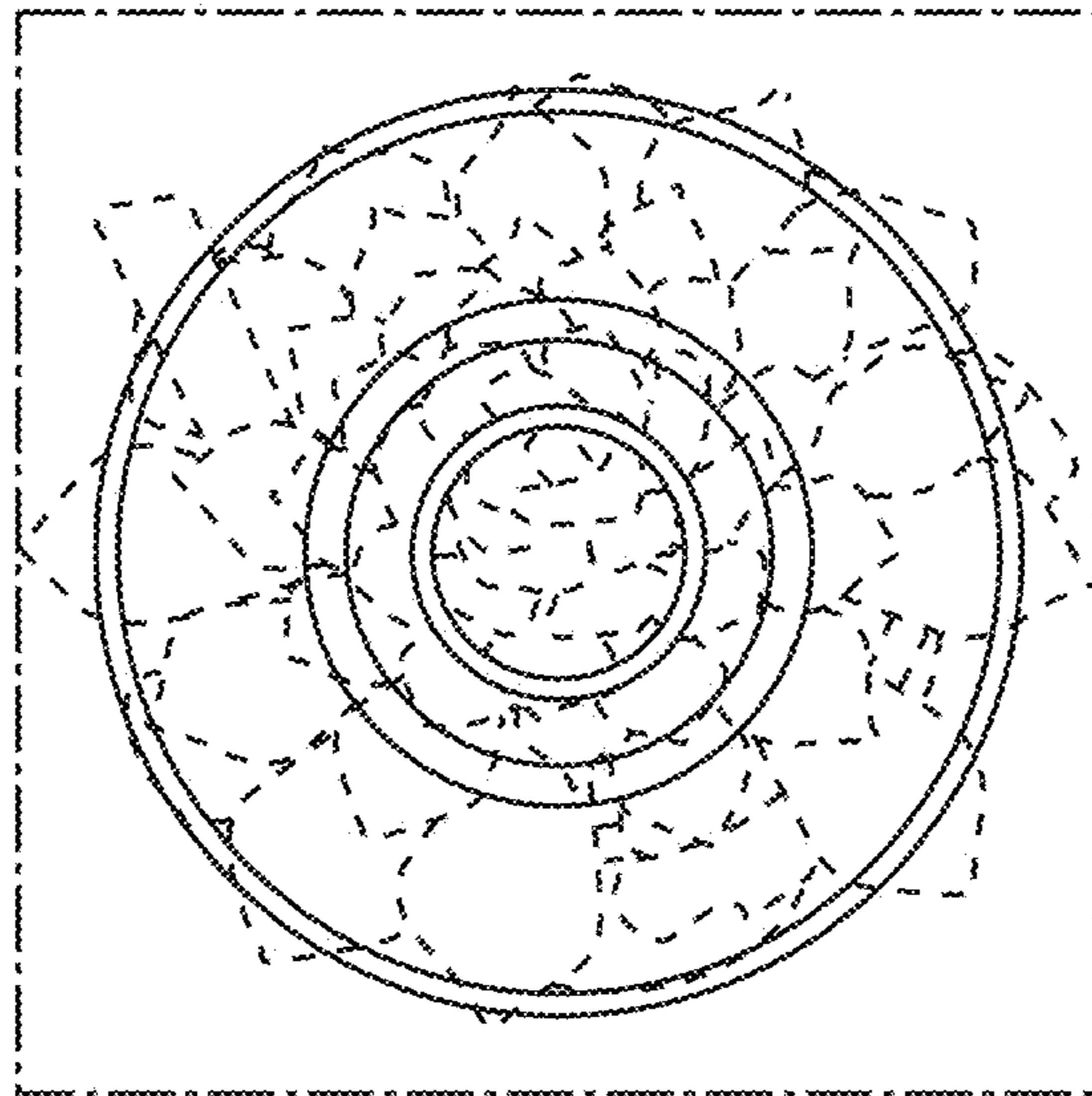

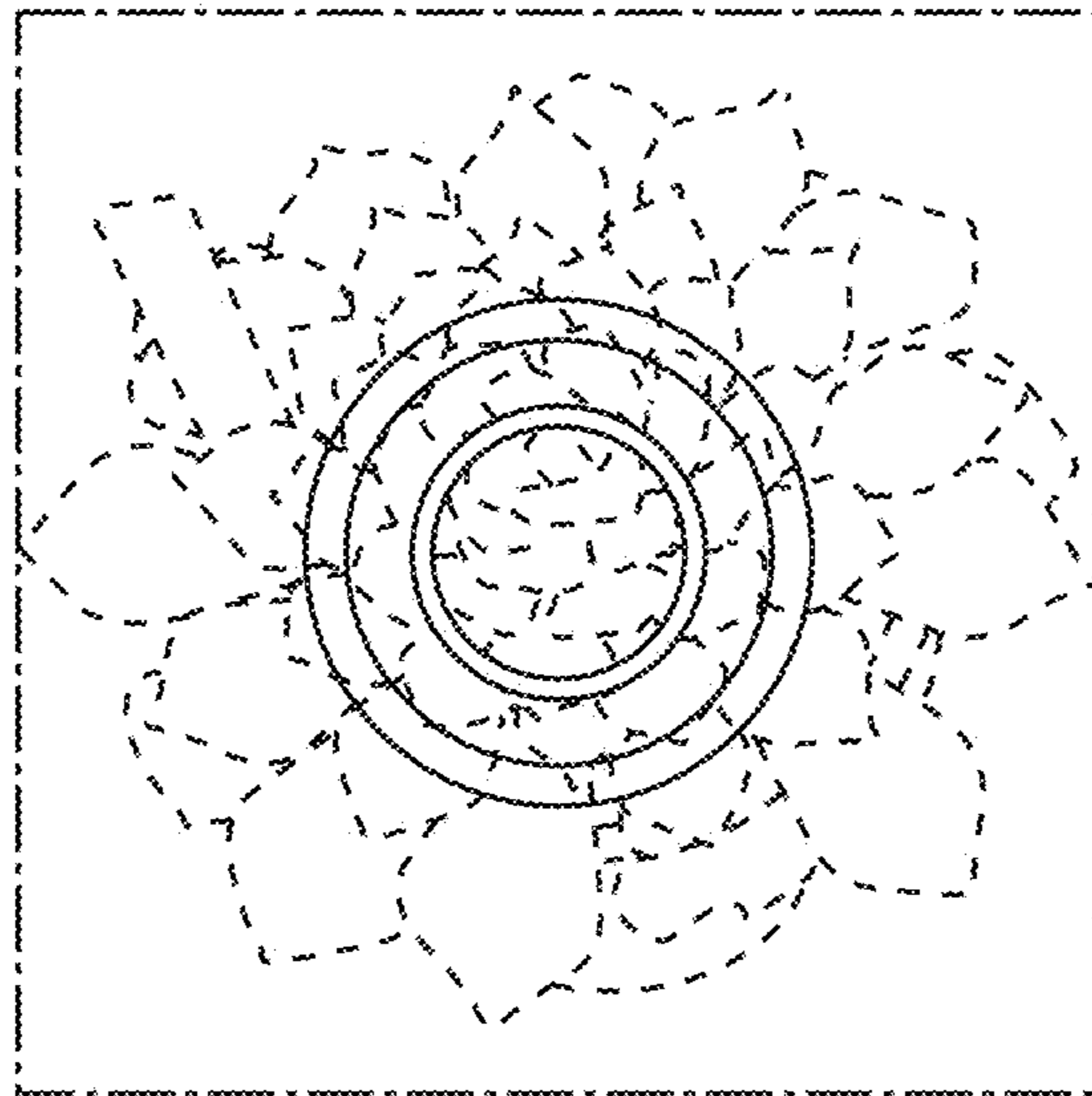

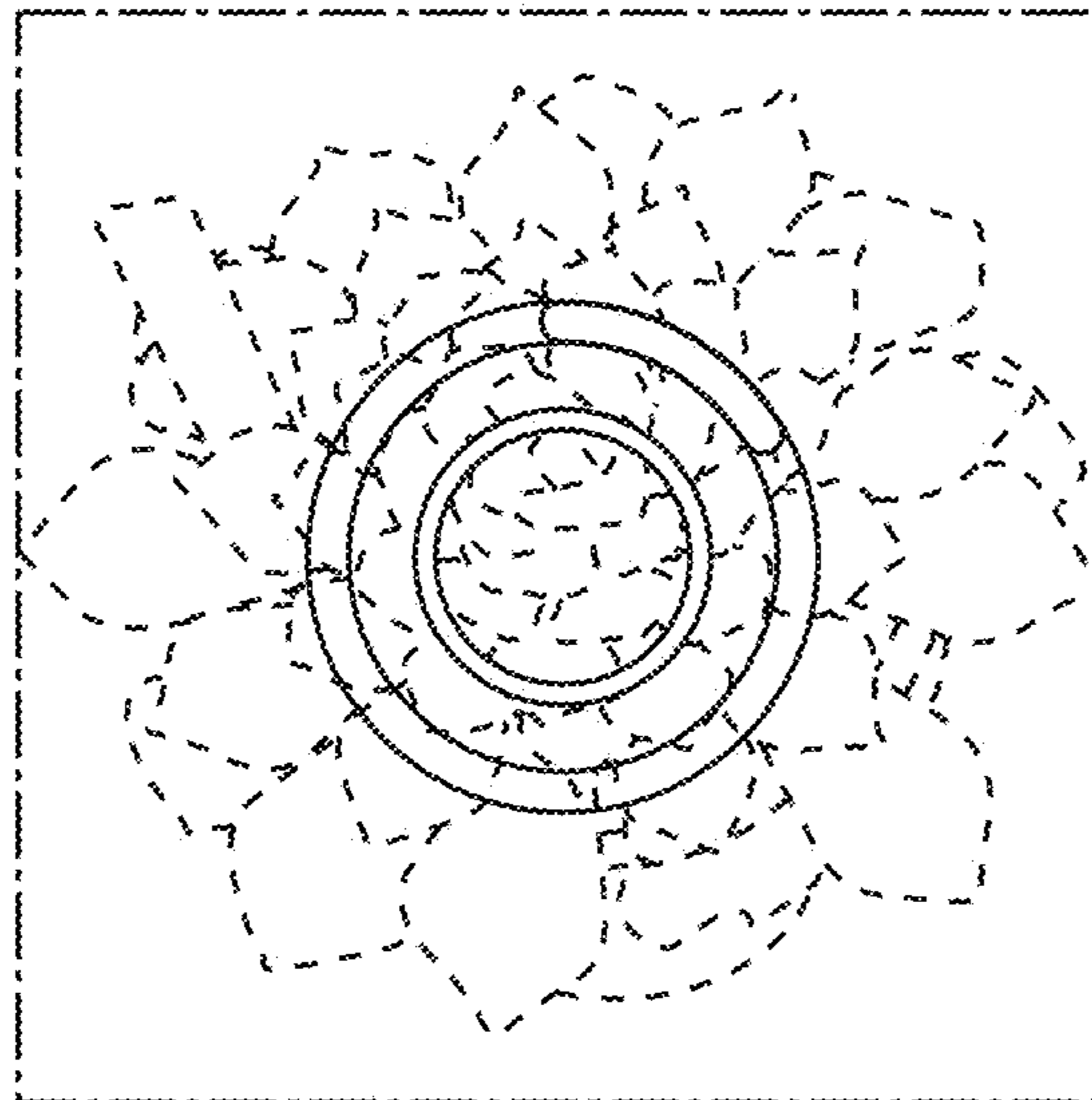

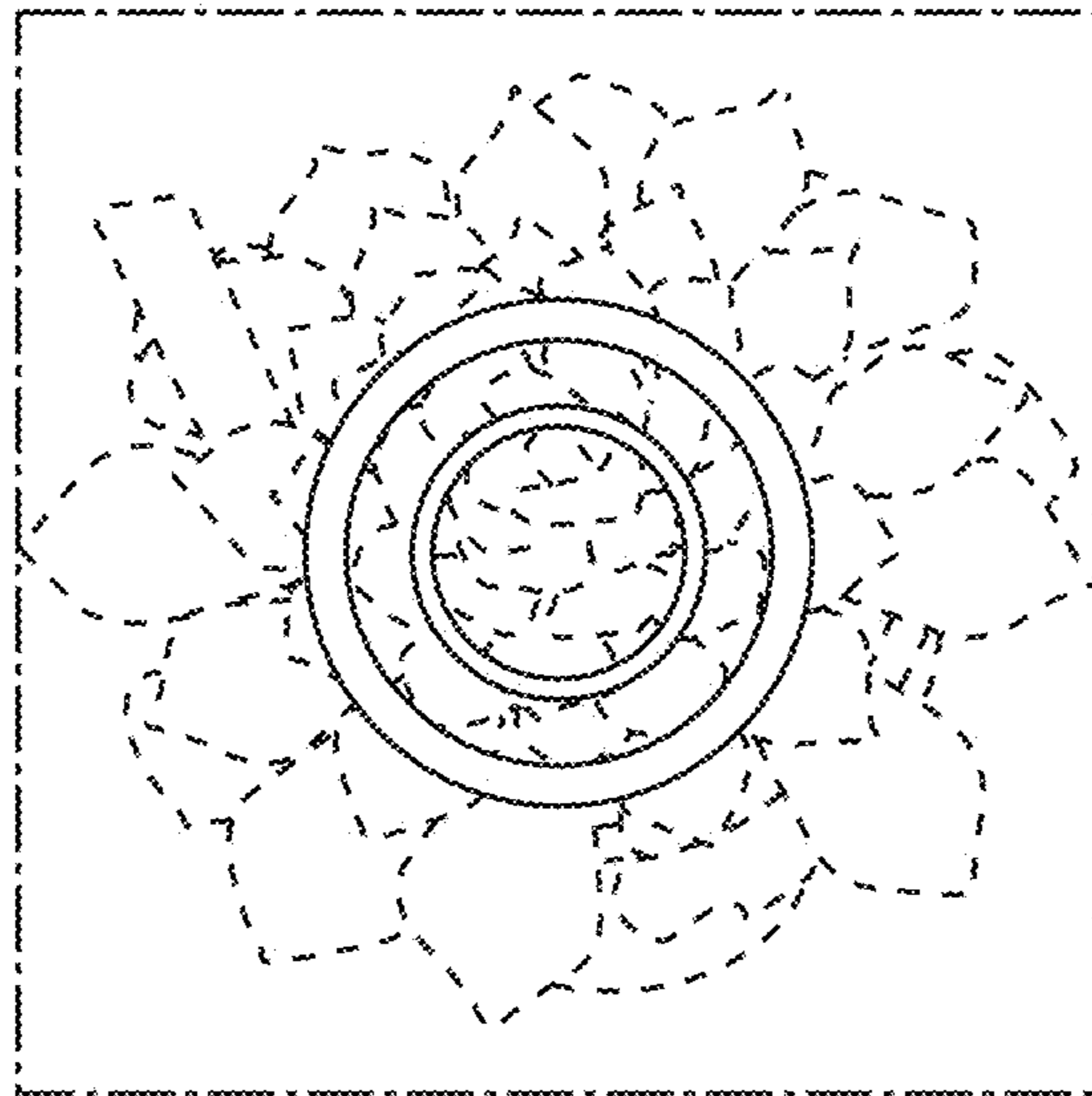
