The ornamental design for an air compressor for a vehicle, as shown and described.

DESCRIPTION

FIG. 7 is a left side view thereof.

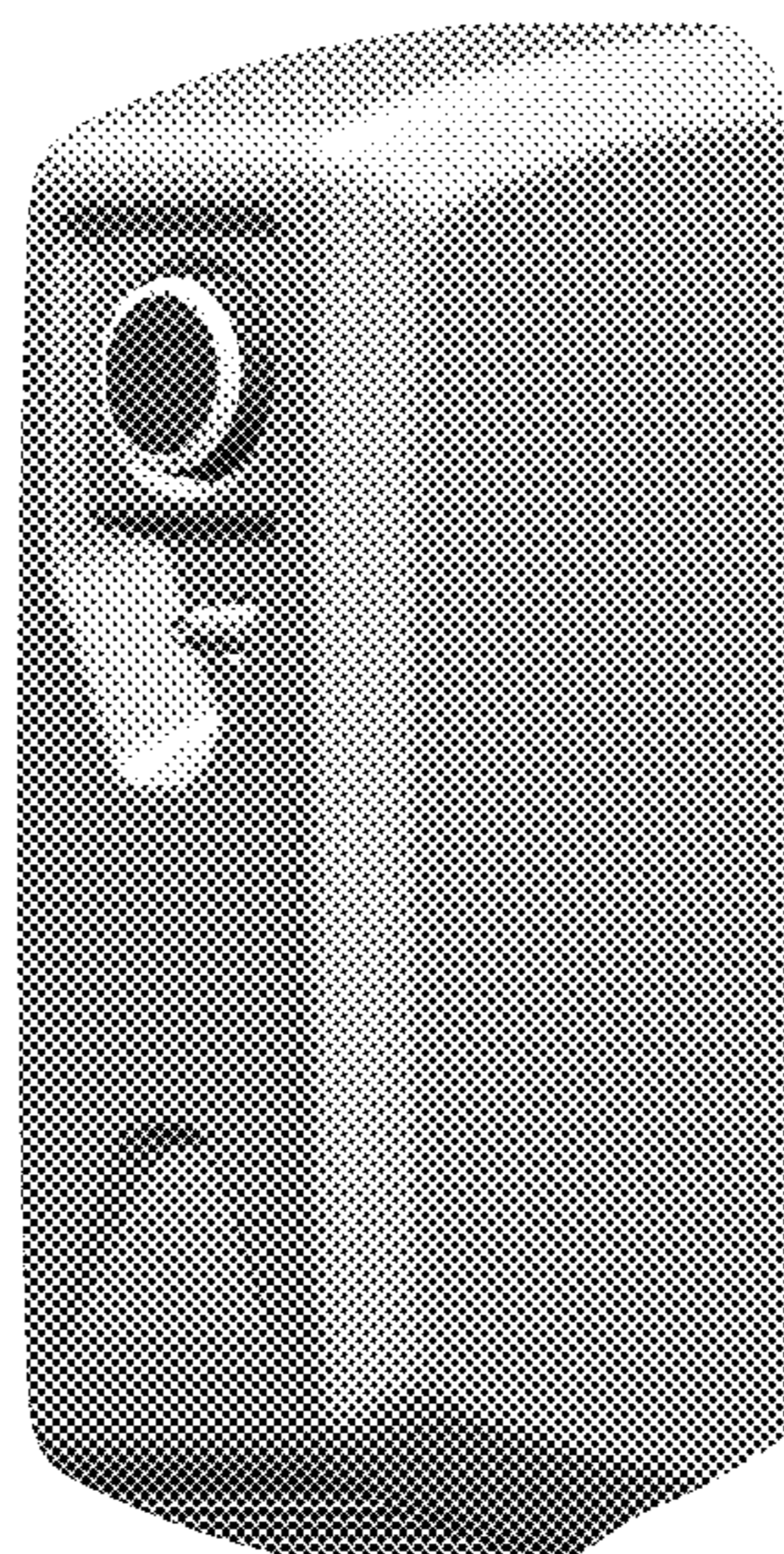
FIG. 8 is a right side view thereof.

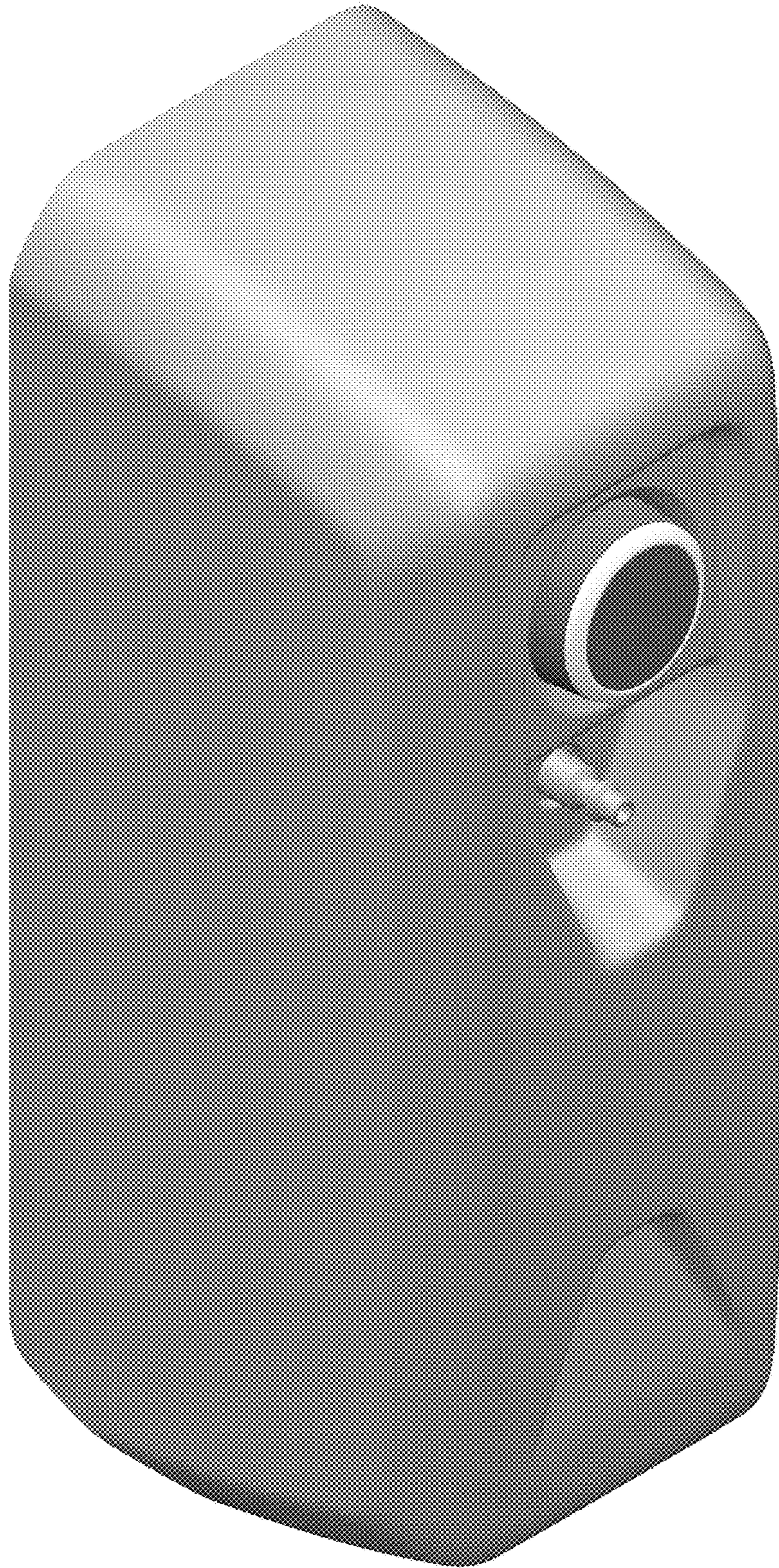

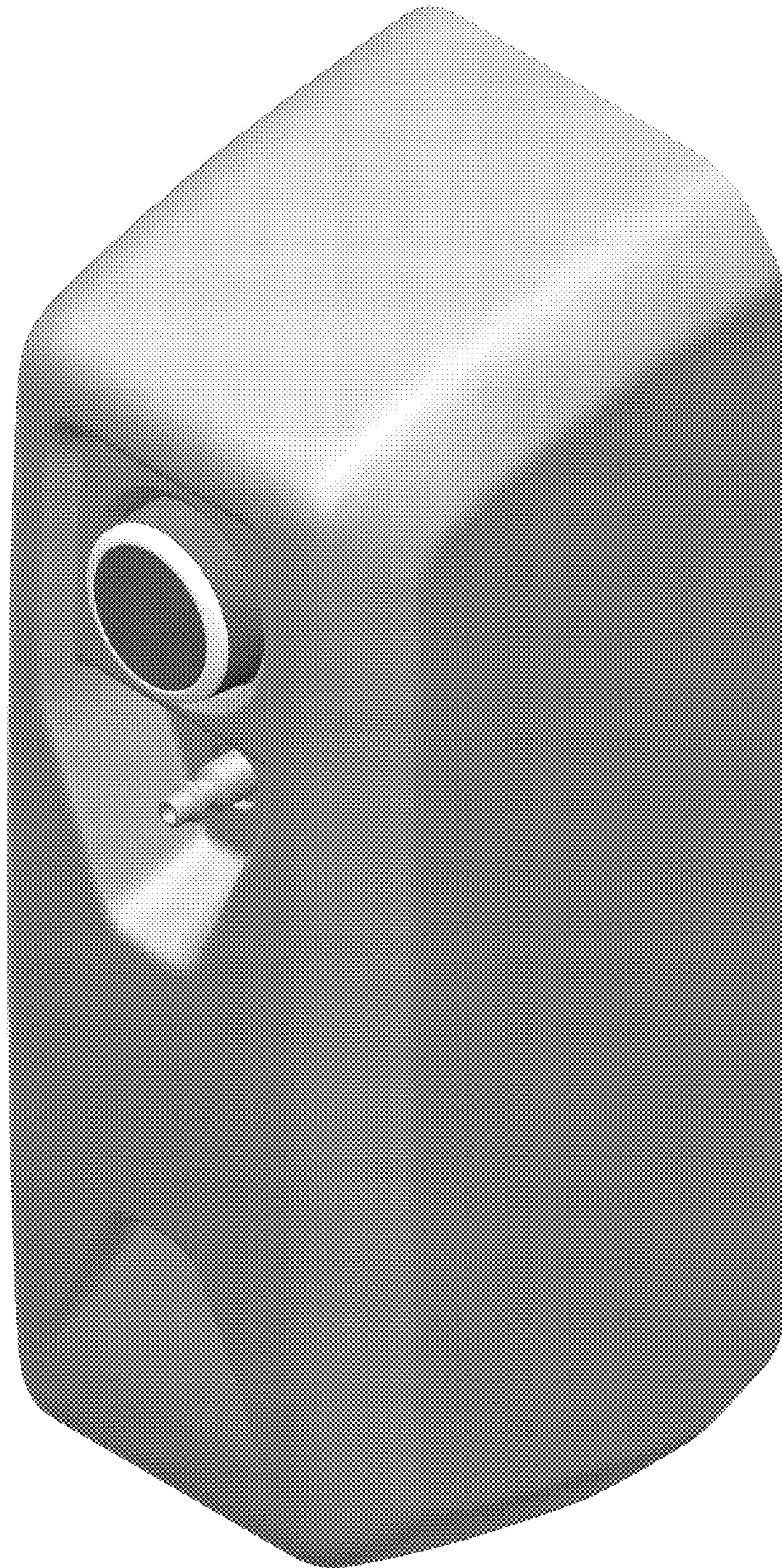

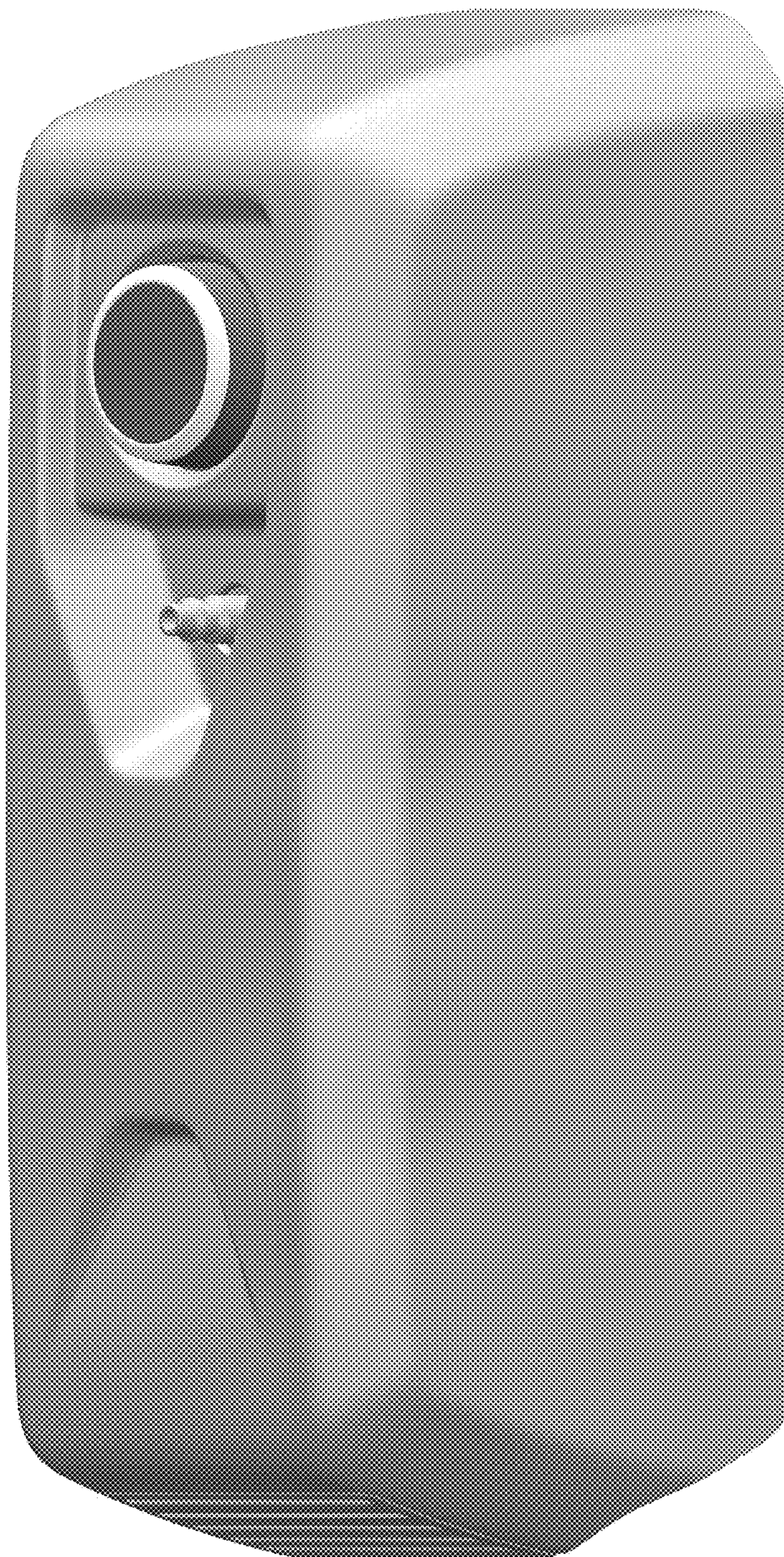

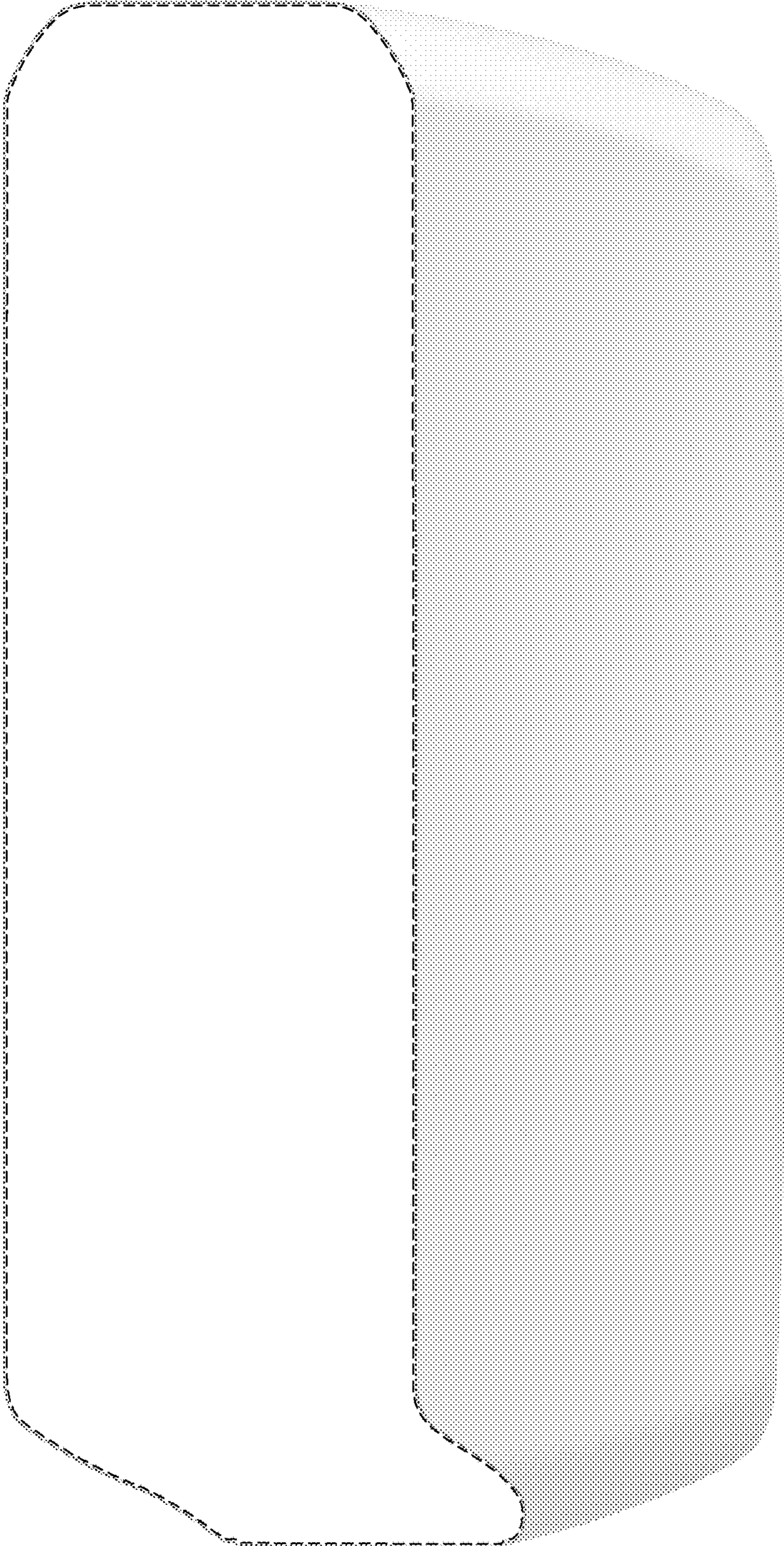

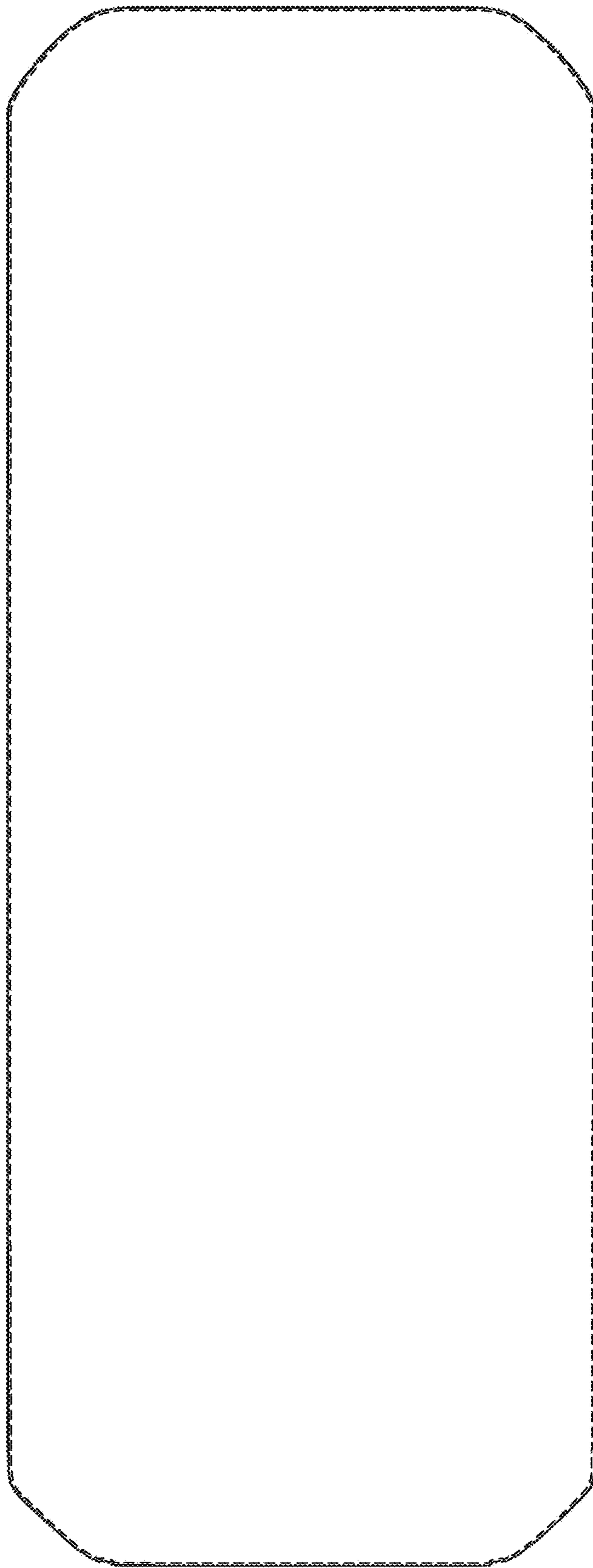

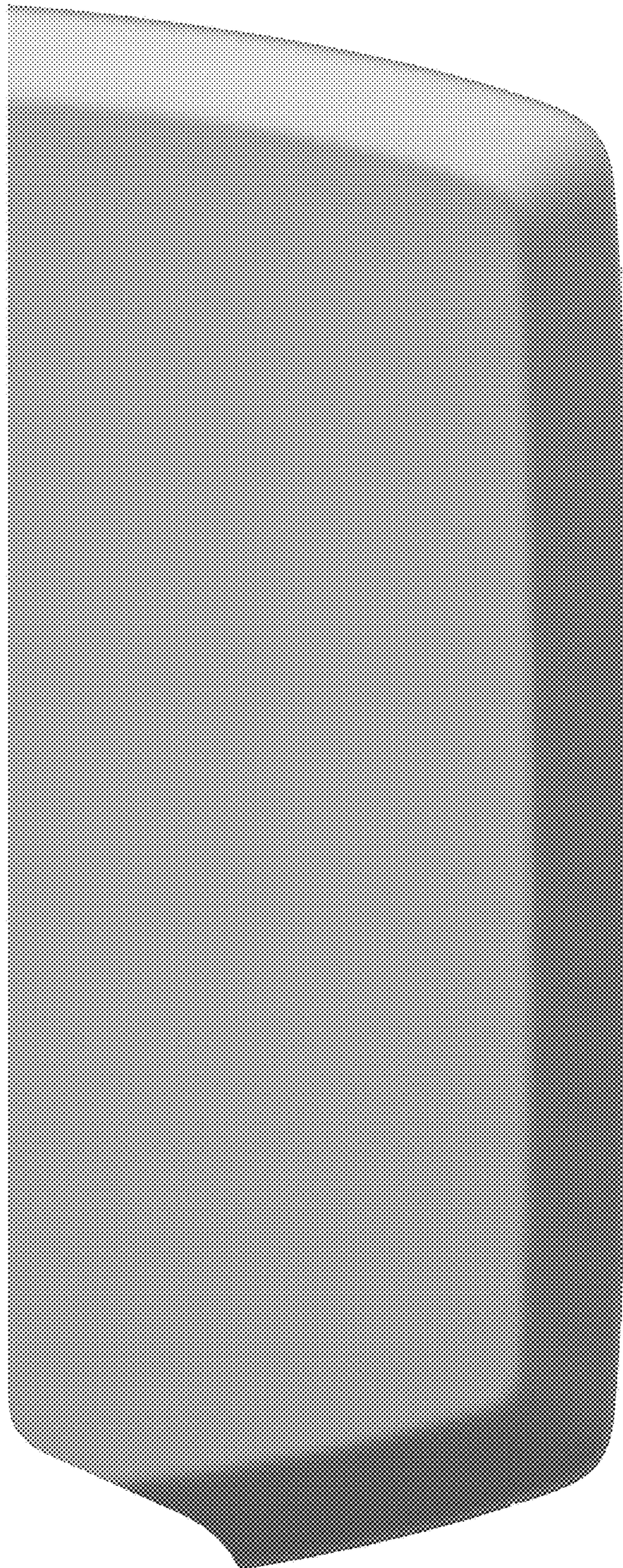

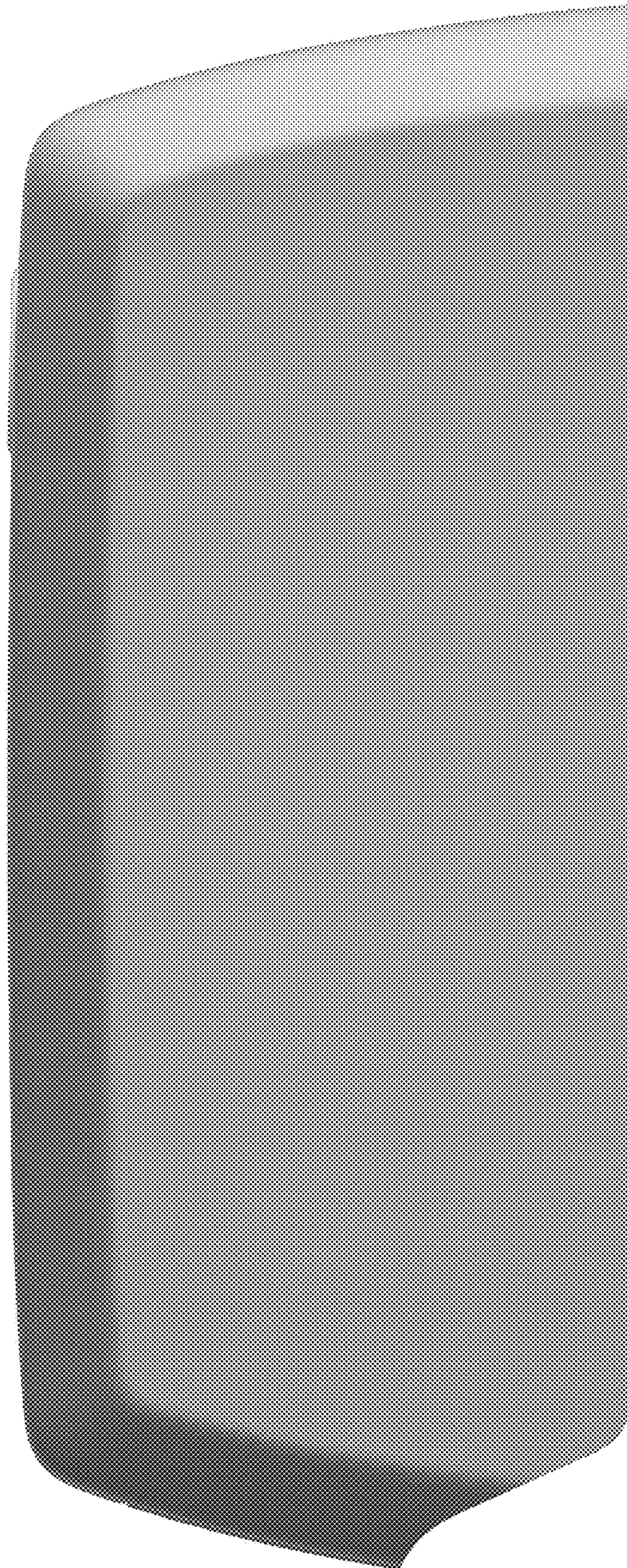
