(57) **CLAIM**

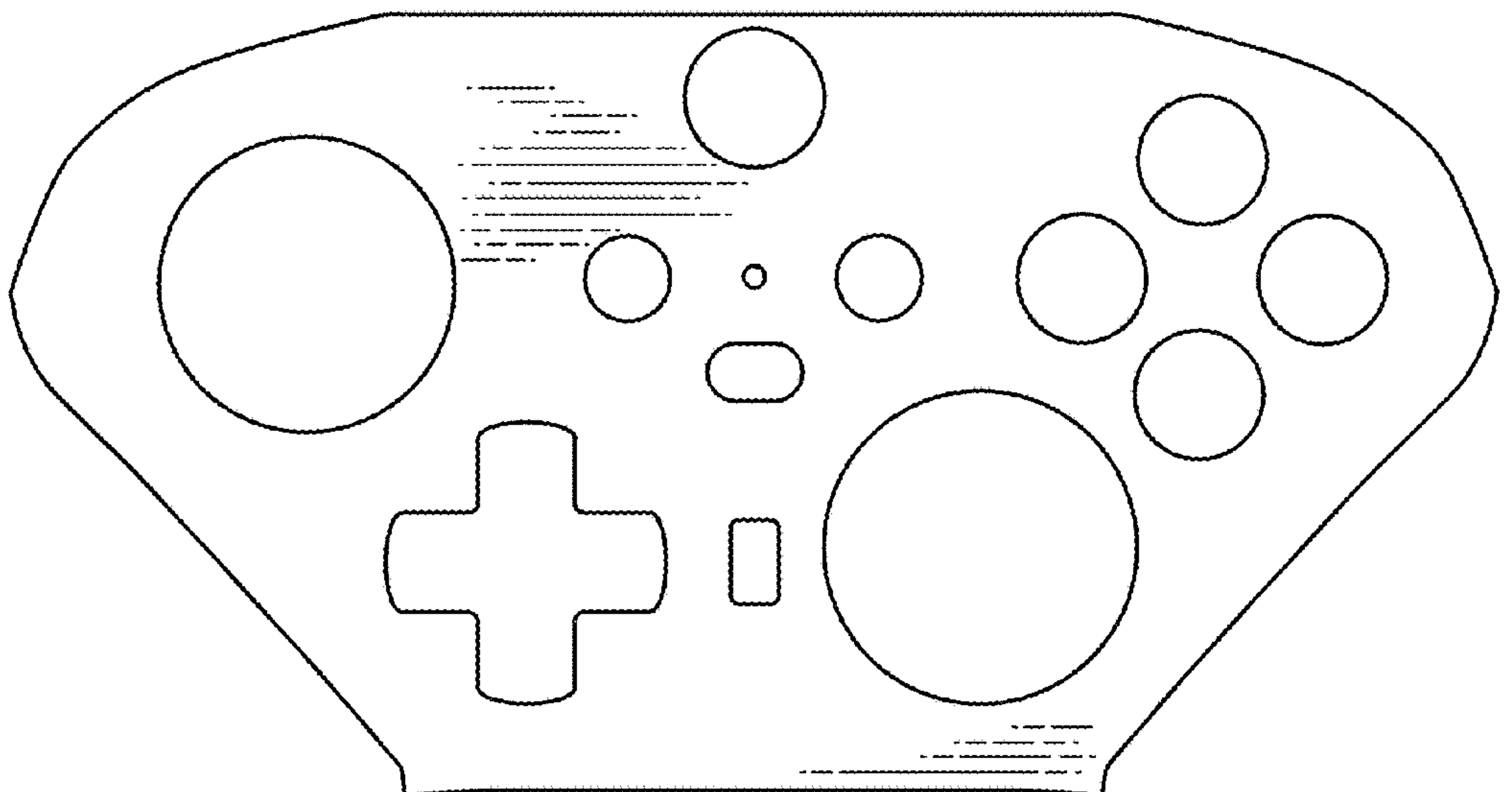
The ornamental design for a skin cover for a game controller, as shown and described.

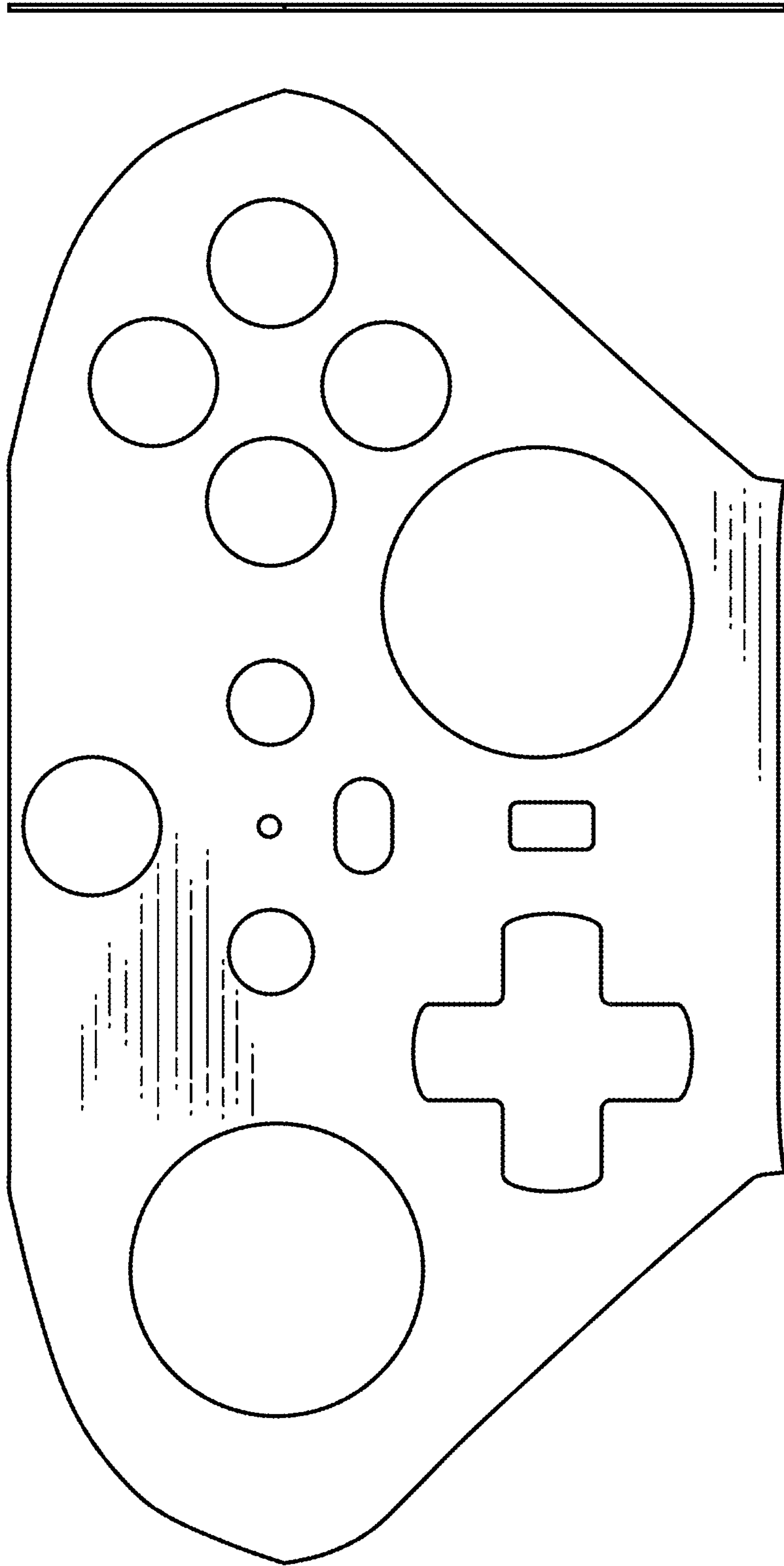

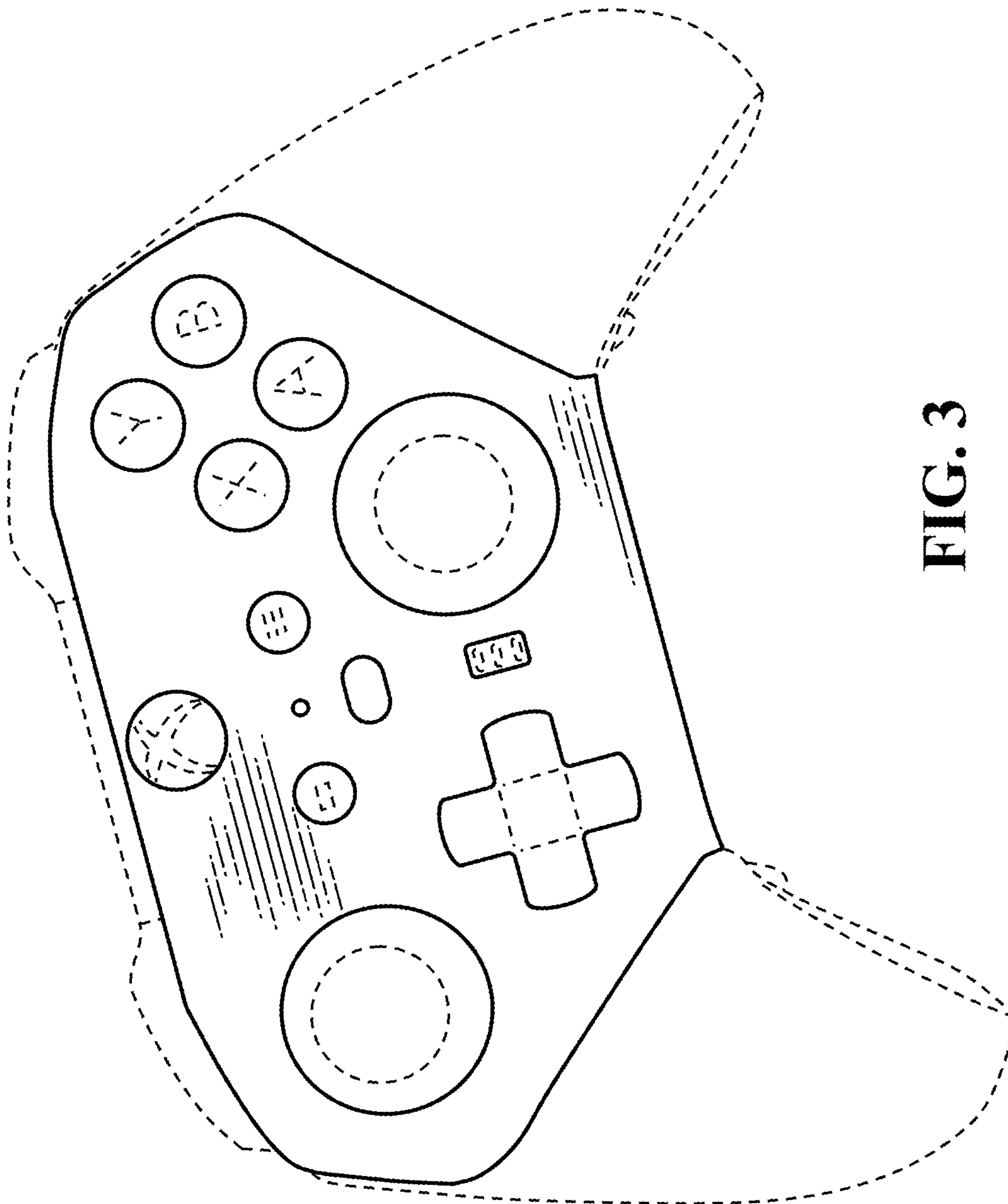
