(57) **CLAIM**

The ornamental design for a spinner device, as shown and described.

**DESCRIPTION**

This application is related to U.S. patent application Ser. No. 29/702,422 filed on Aug. 19, 2019, titled inflatable towable vehicle including spinner system, which is herein incorporated by reference in its entirety.

FIG. 4 is a rear side elevation view thereof;

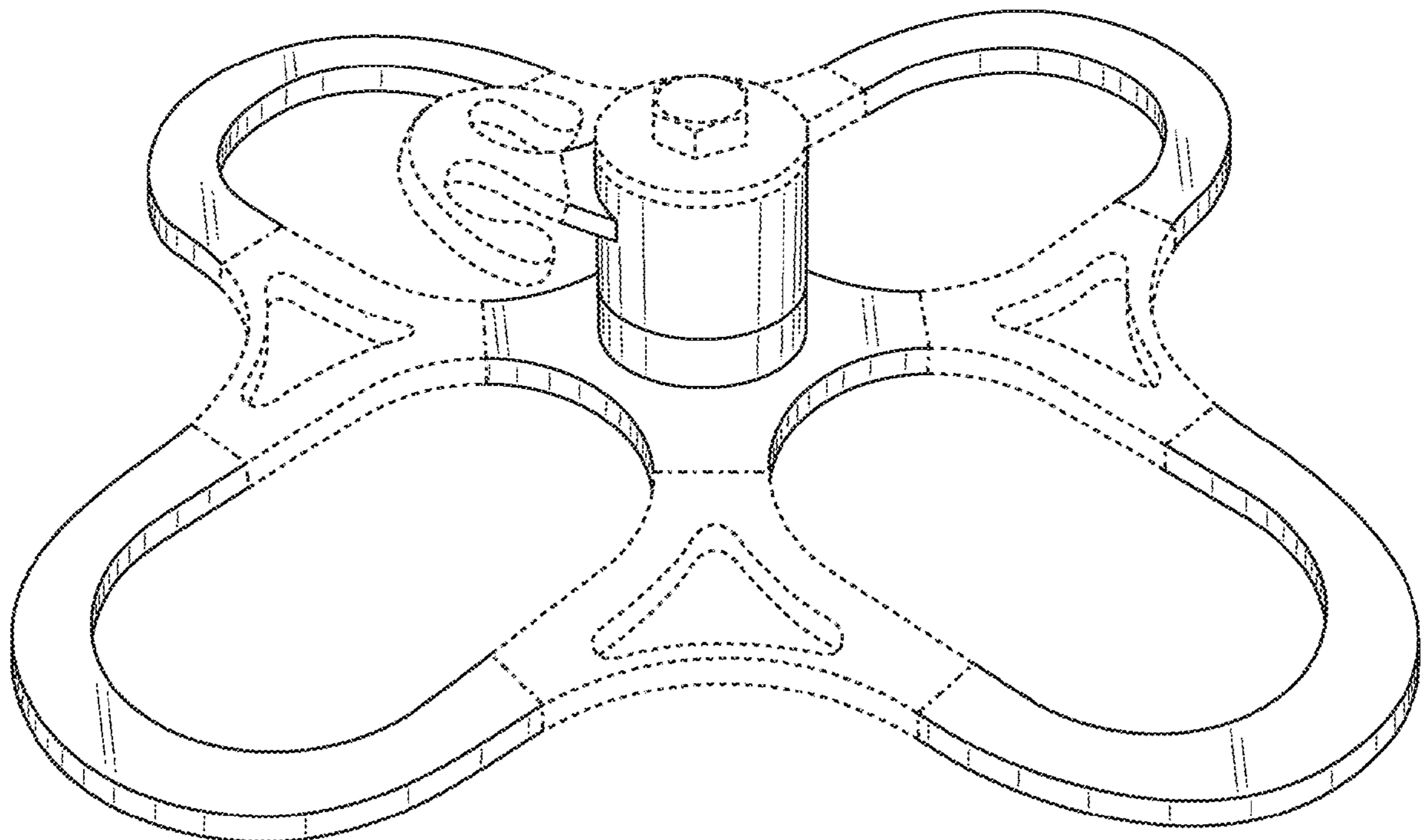
FIG. 5 is a front side elevation view thereof;

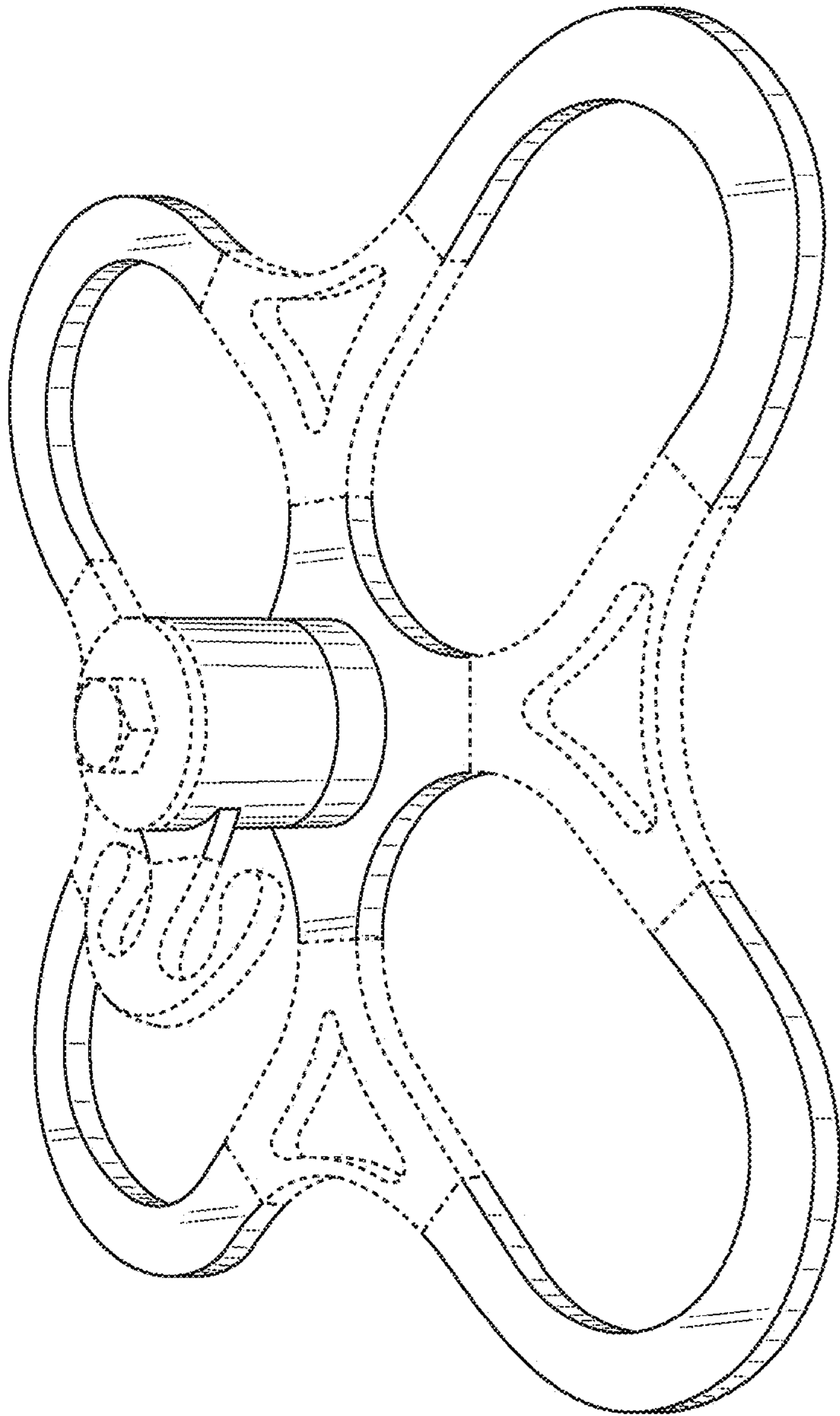

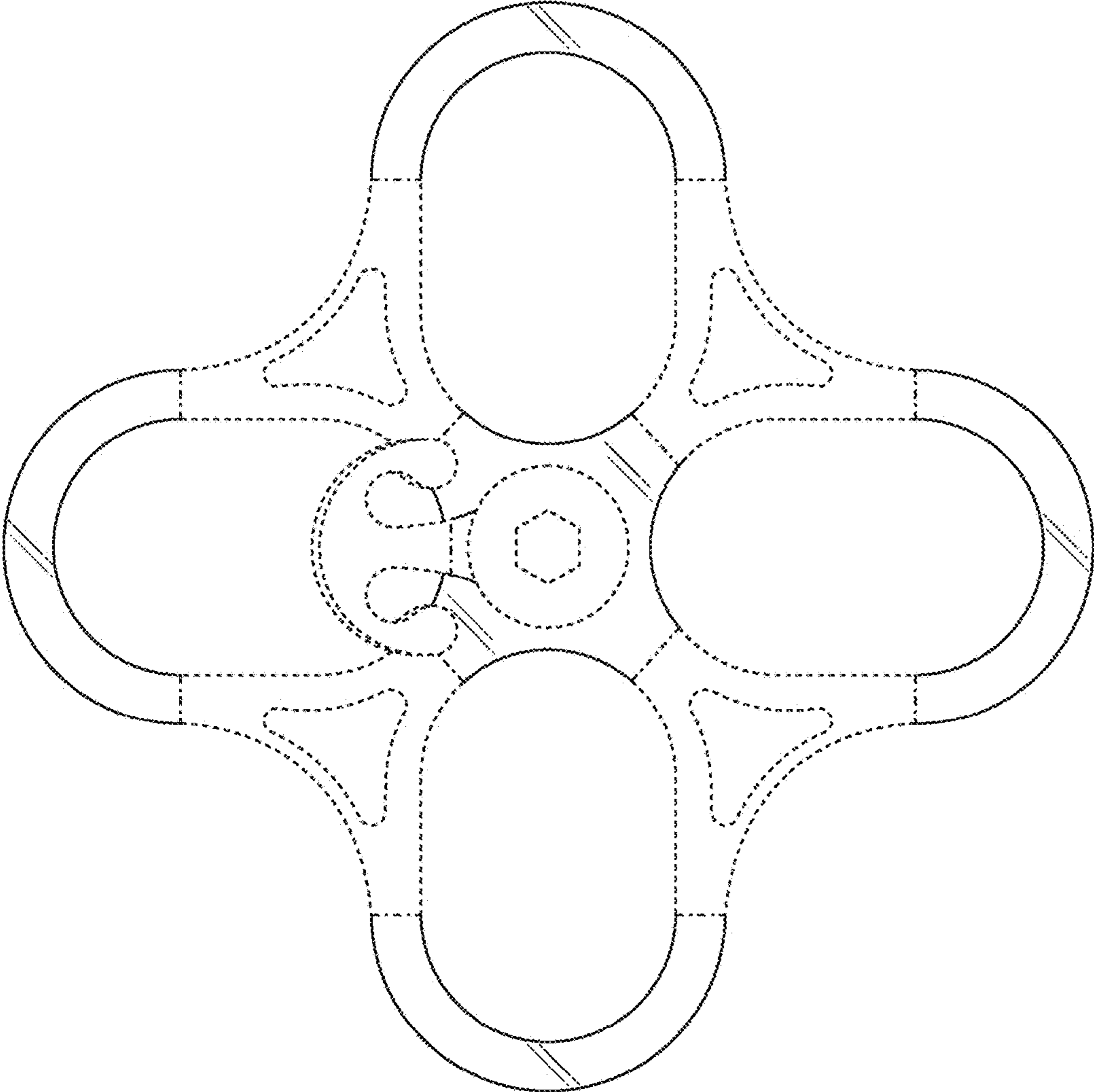

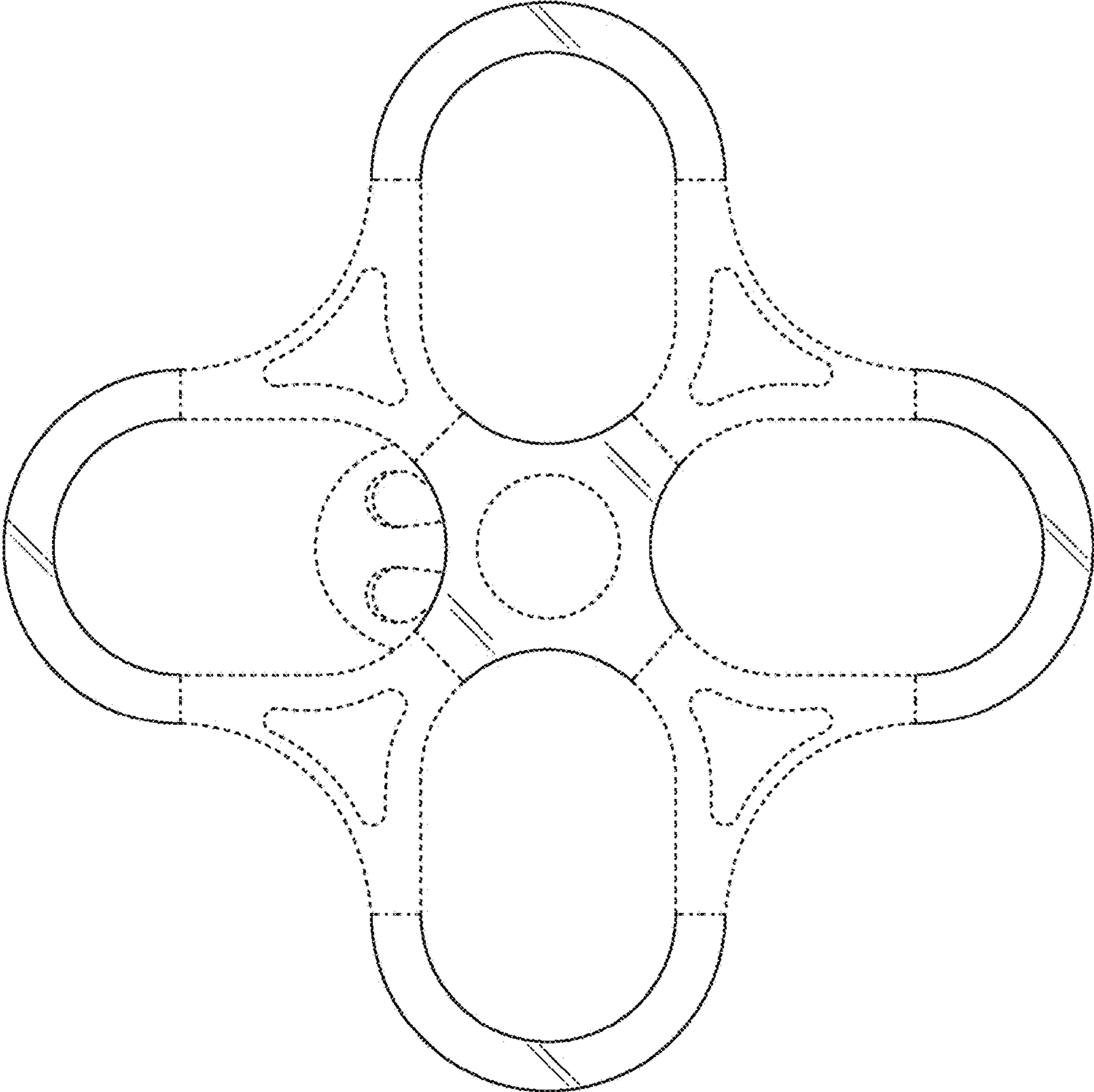

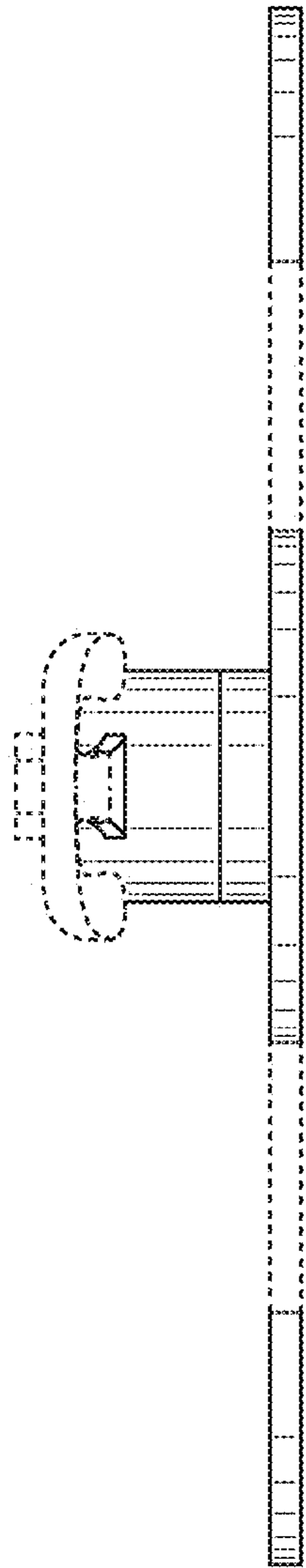

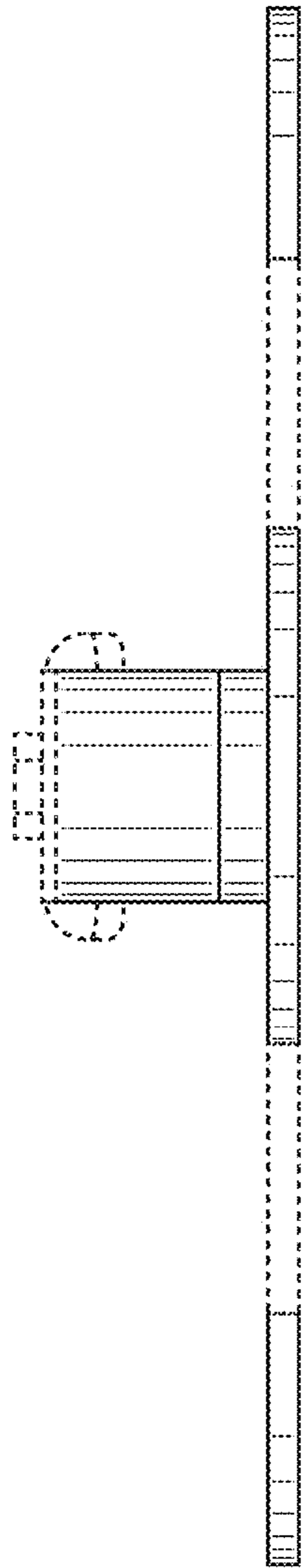

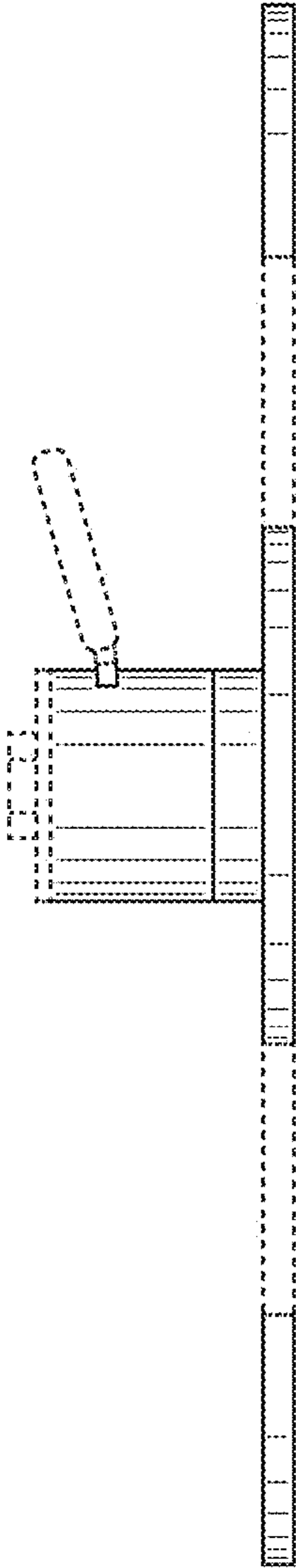

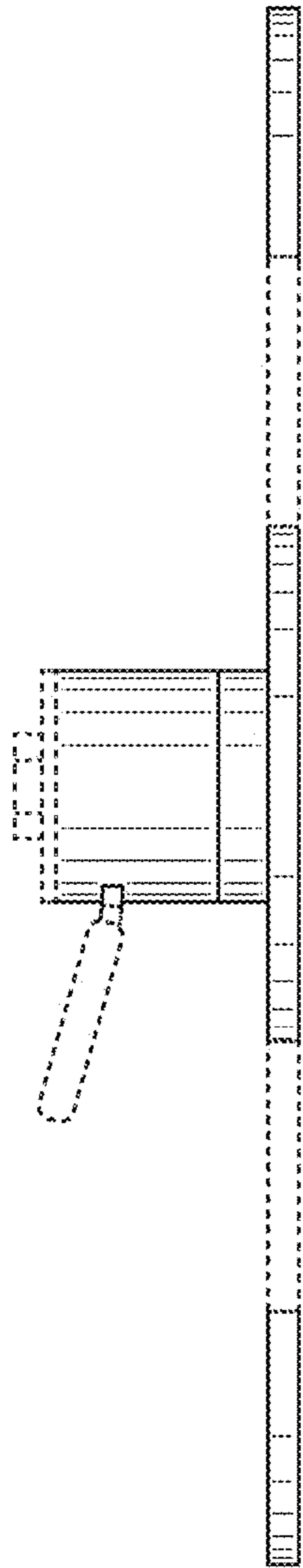
