FIG. 1.3 is a back view thereof;

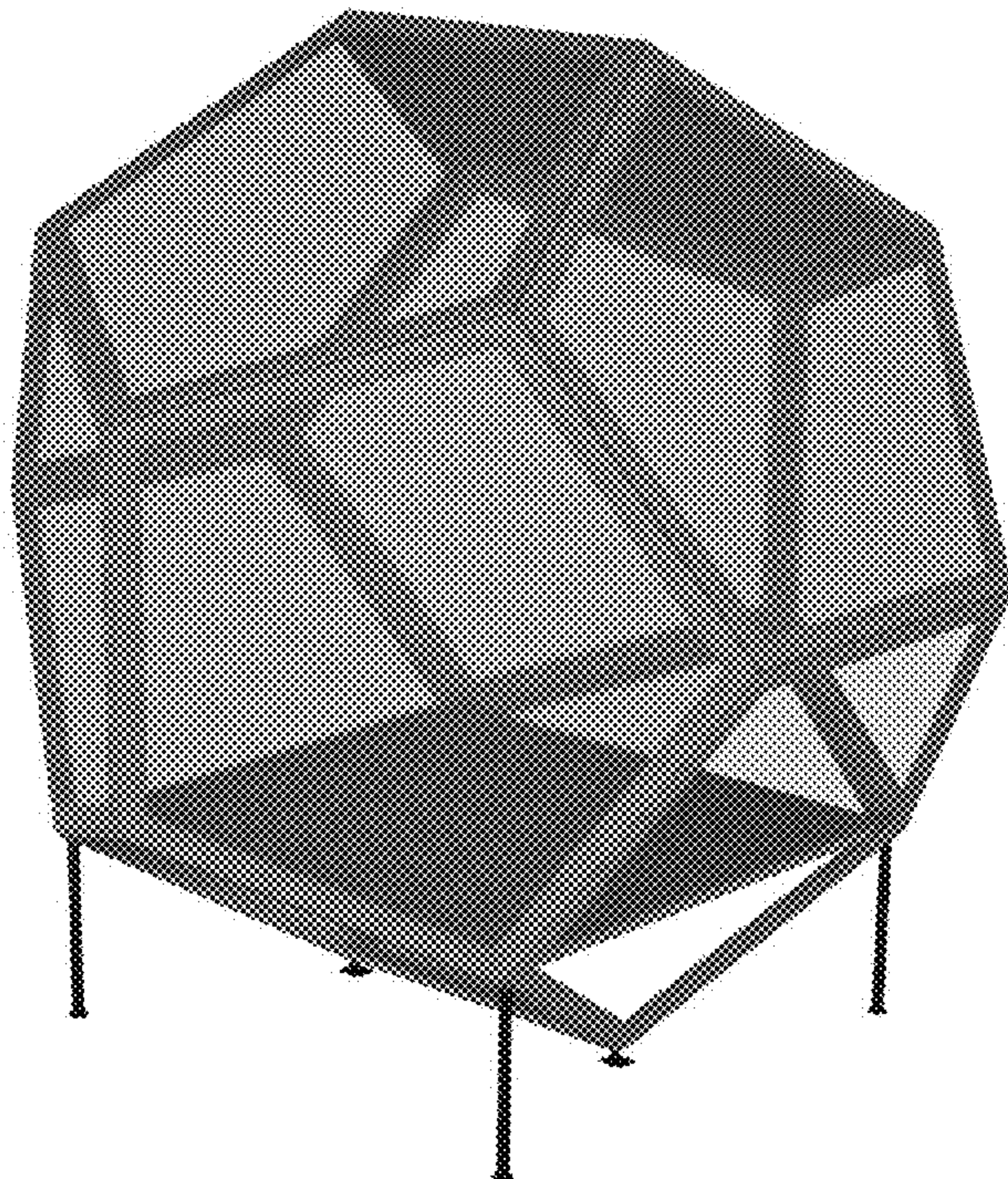
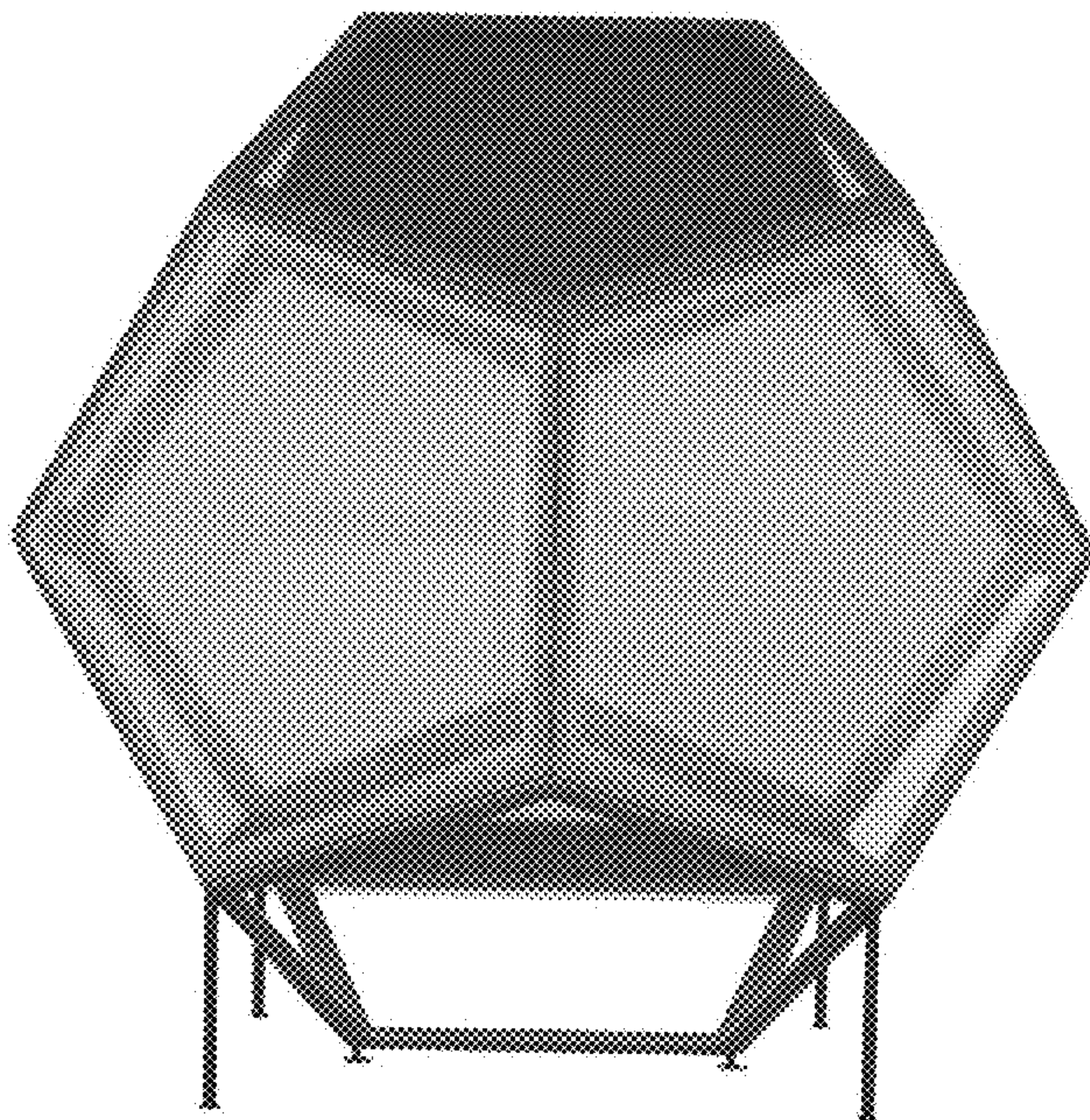
FIG. 1.4 is a top view thereof;

FIG. 1.5 is a perspective view thereof;

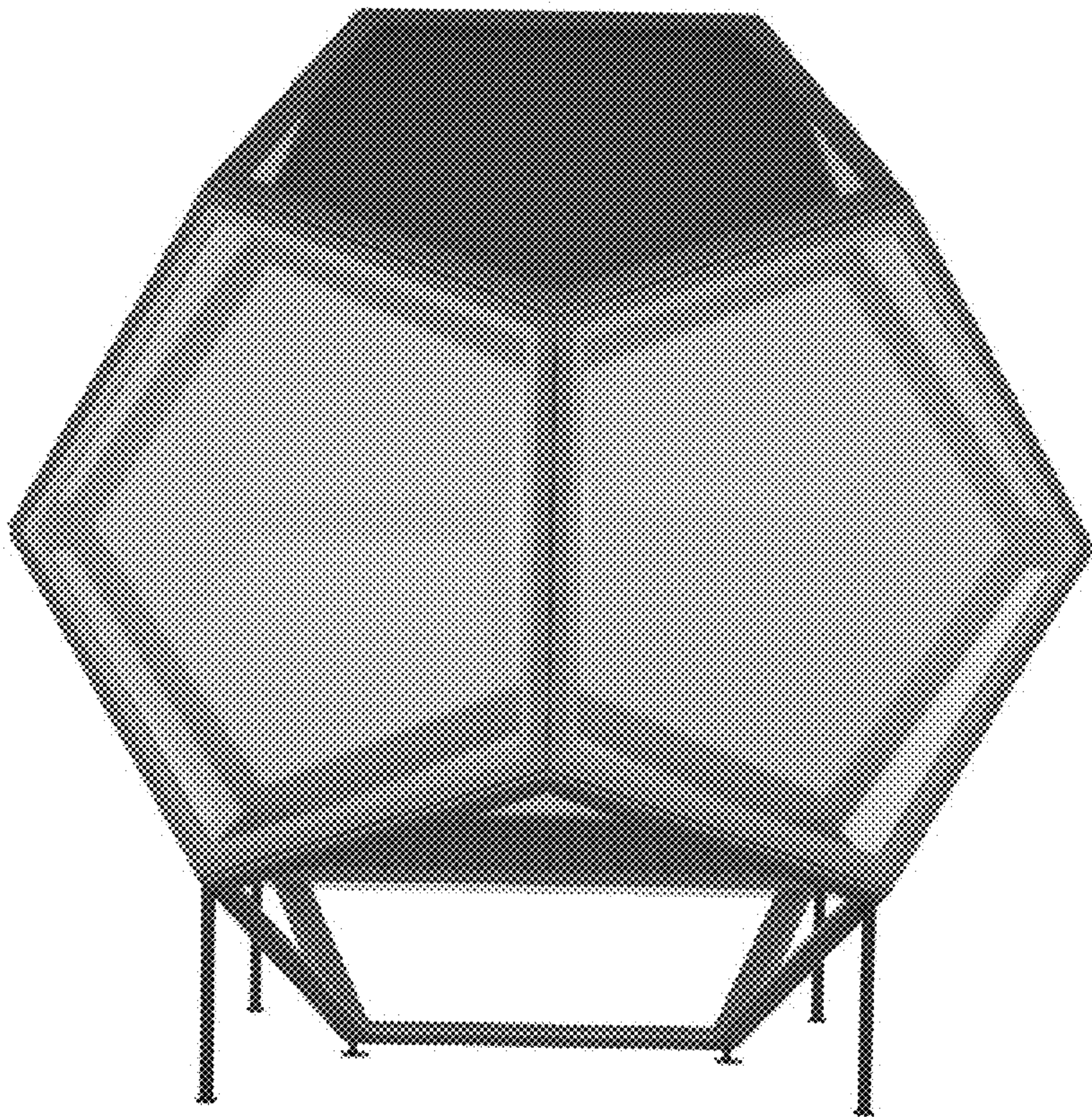
FIG. 1.6 is another perspective view thereof; and

FIG. 1.7 is a front view thereof.

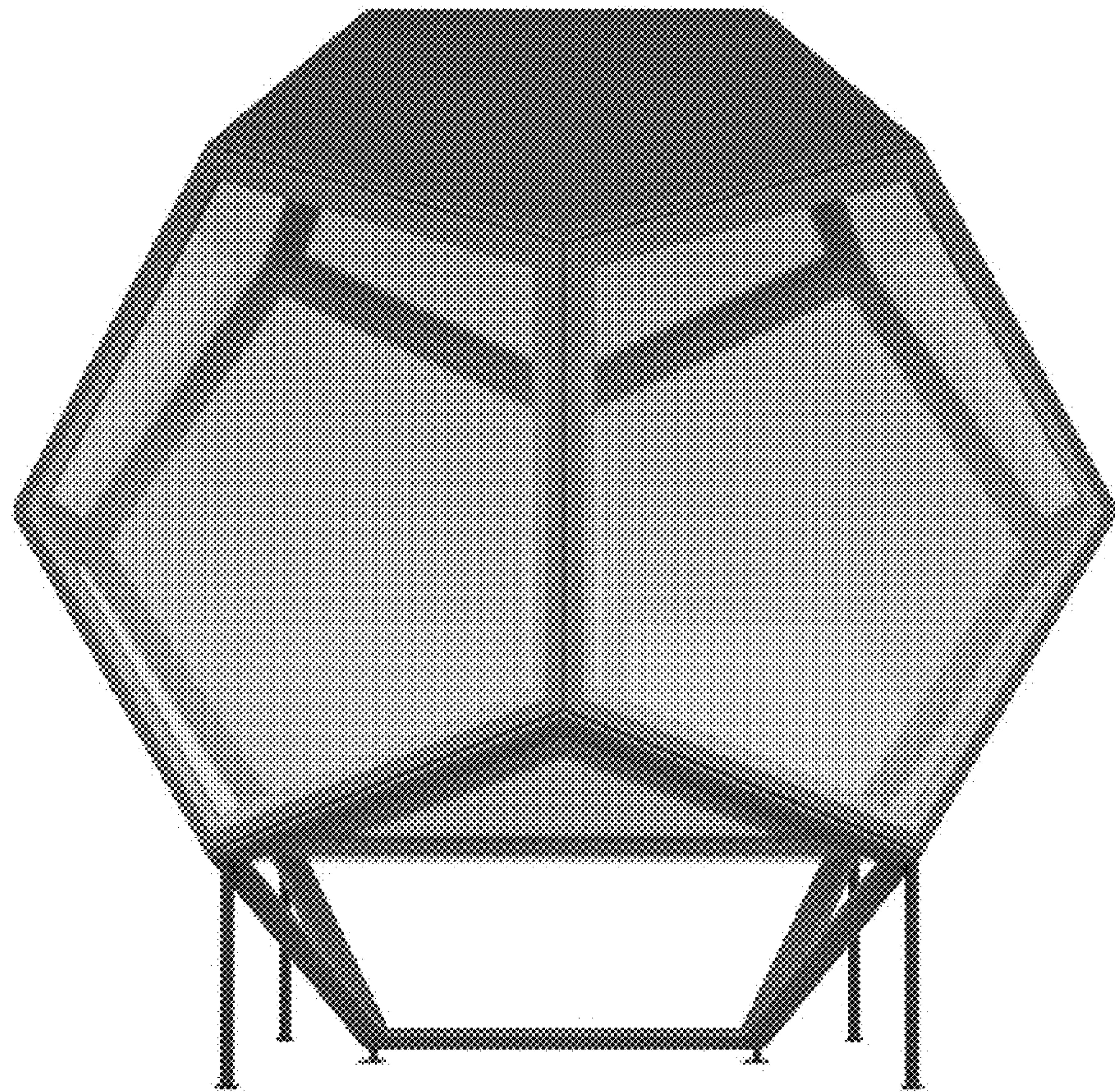

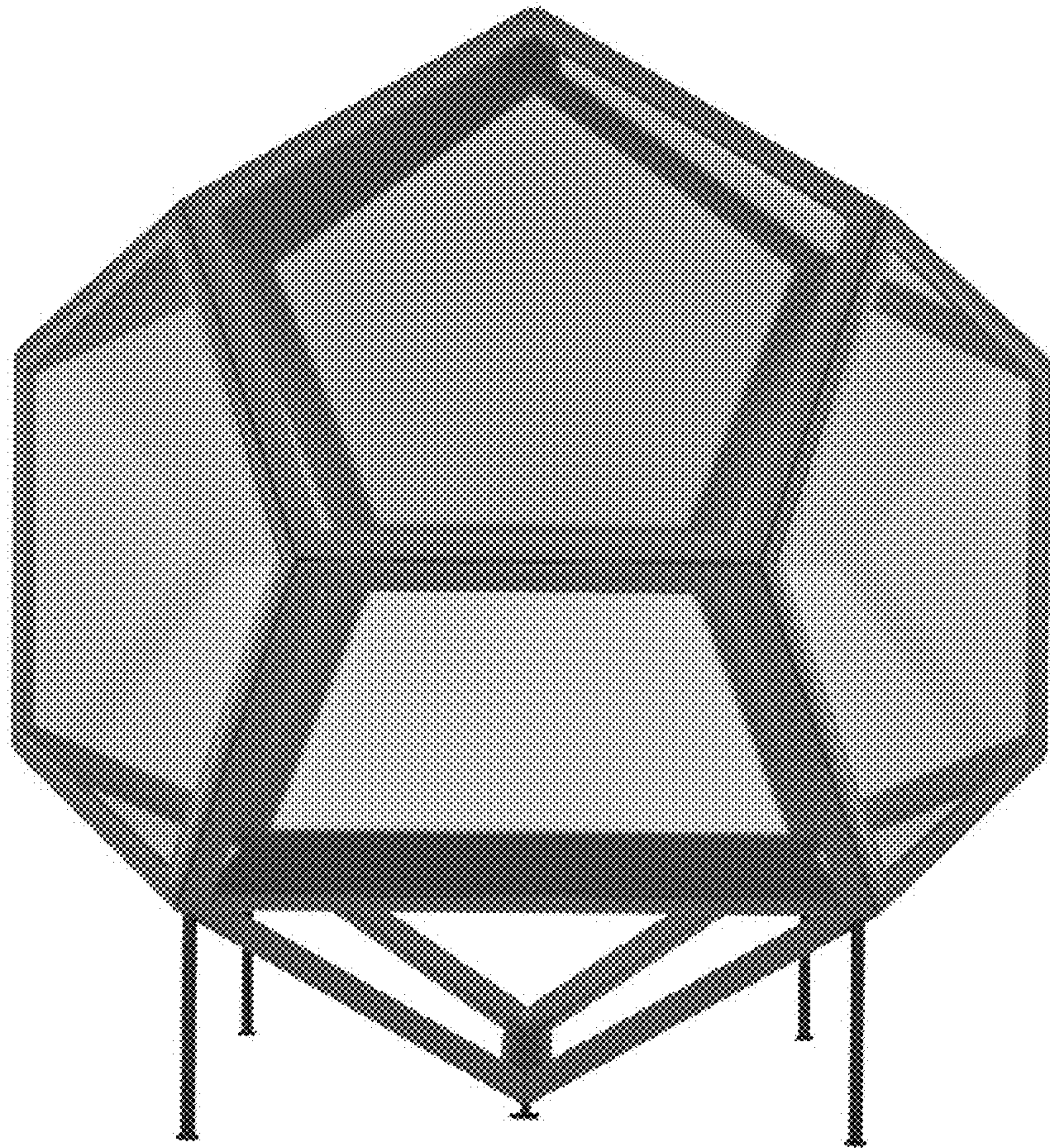

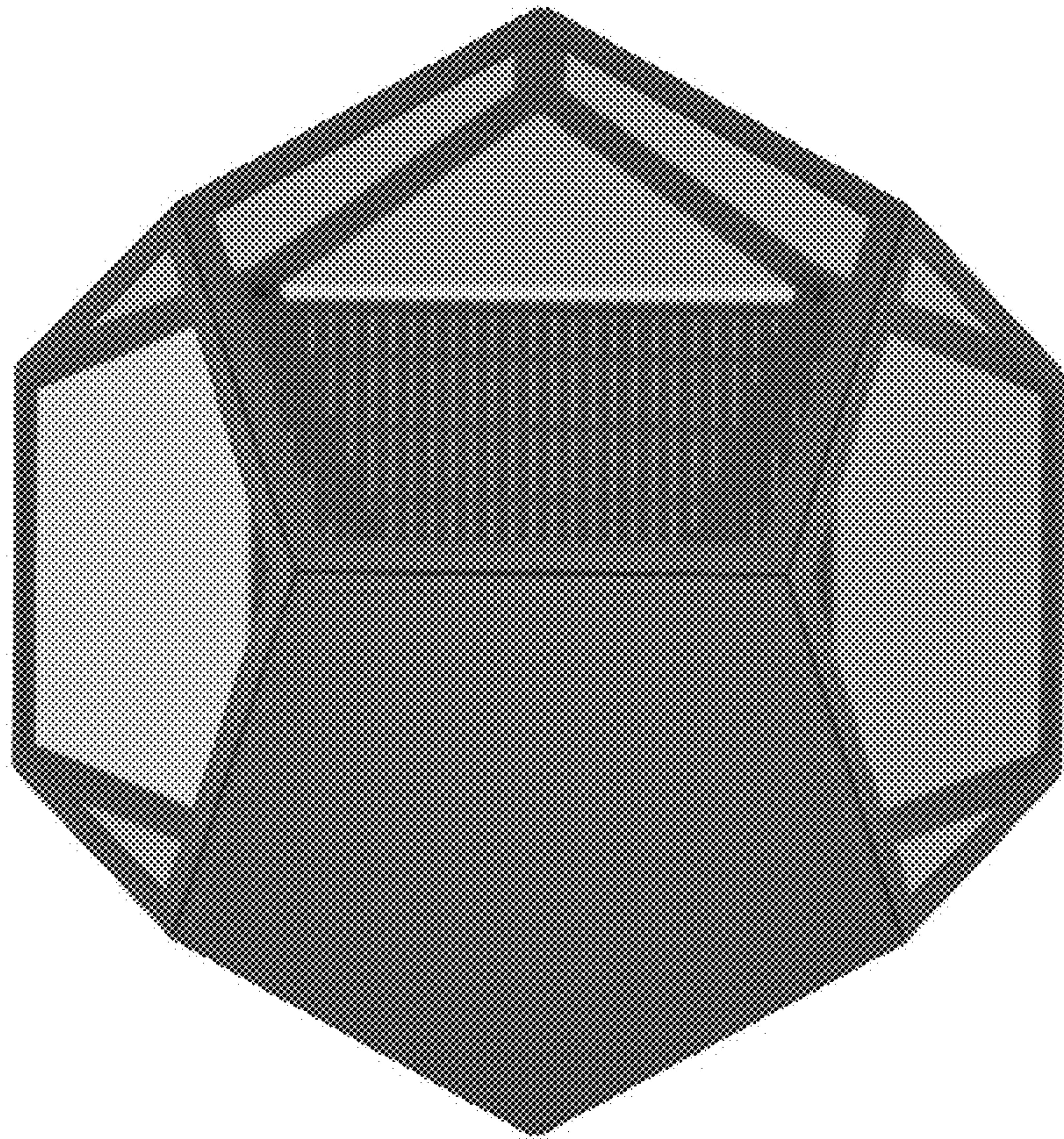

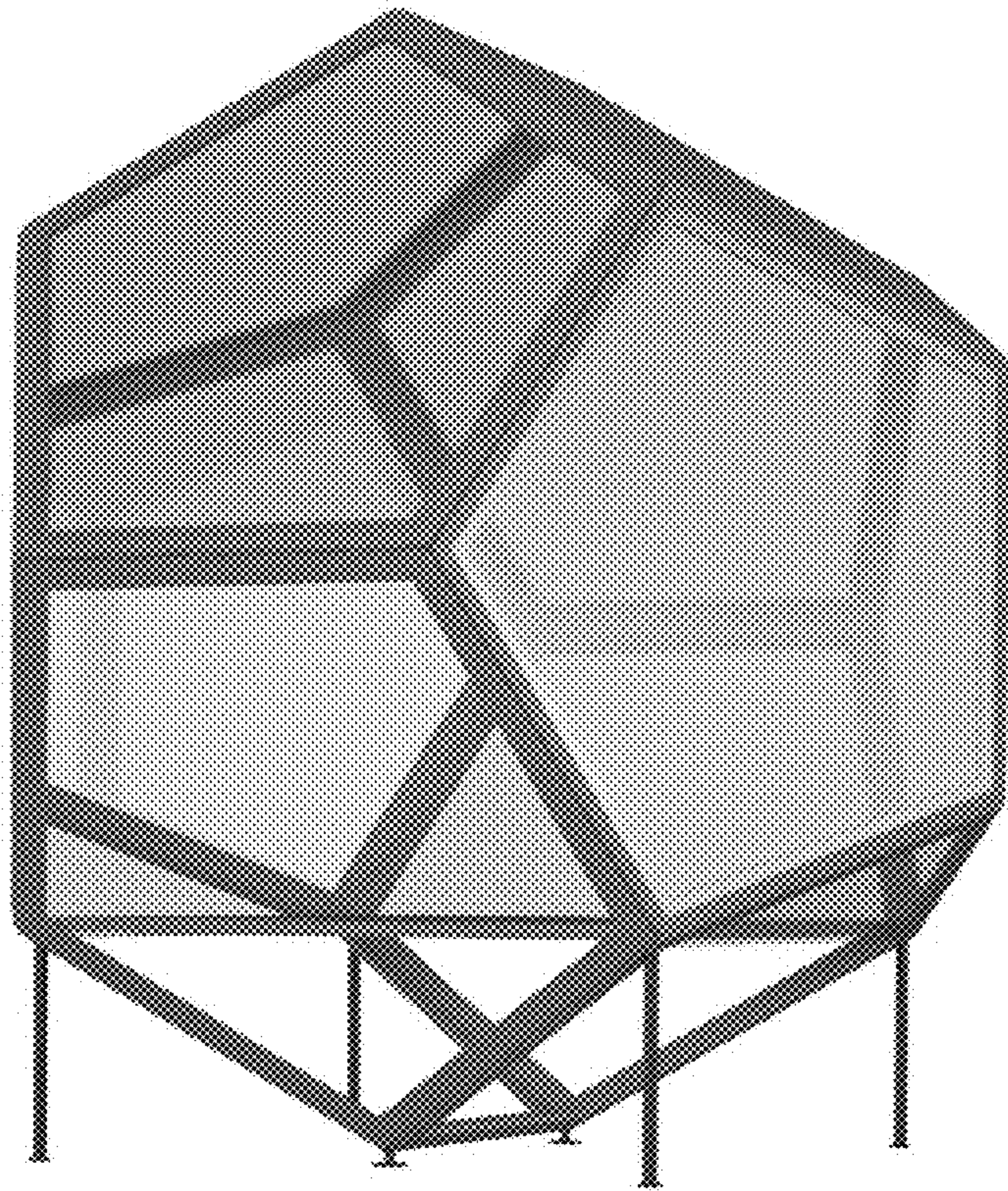

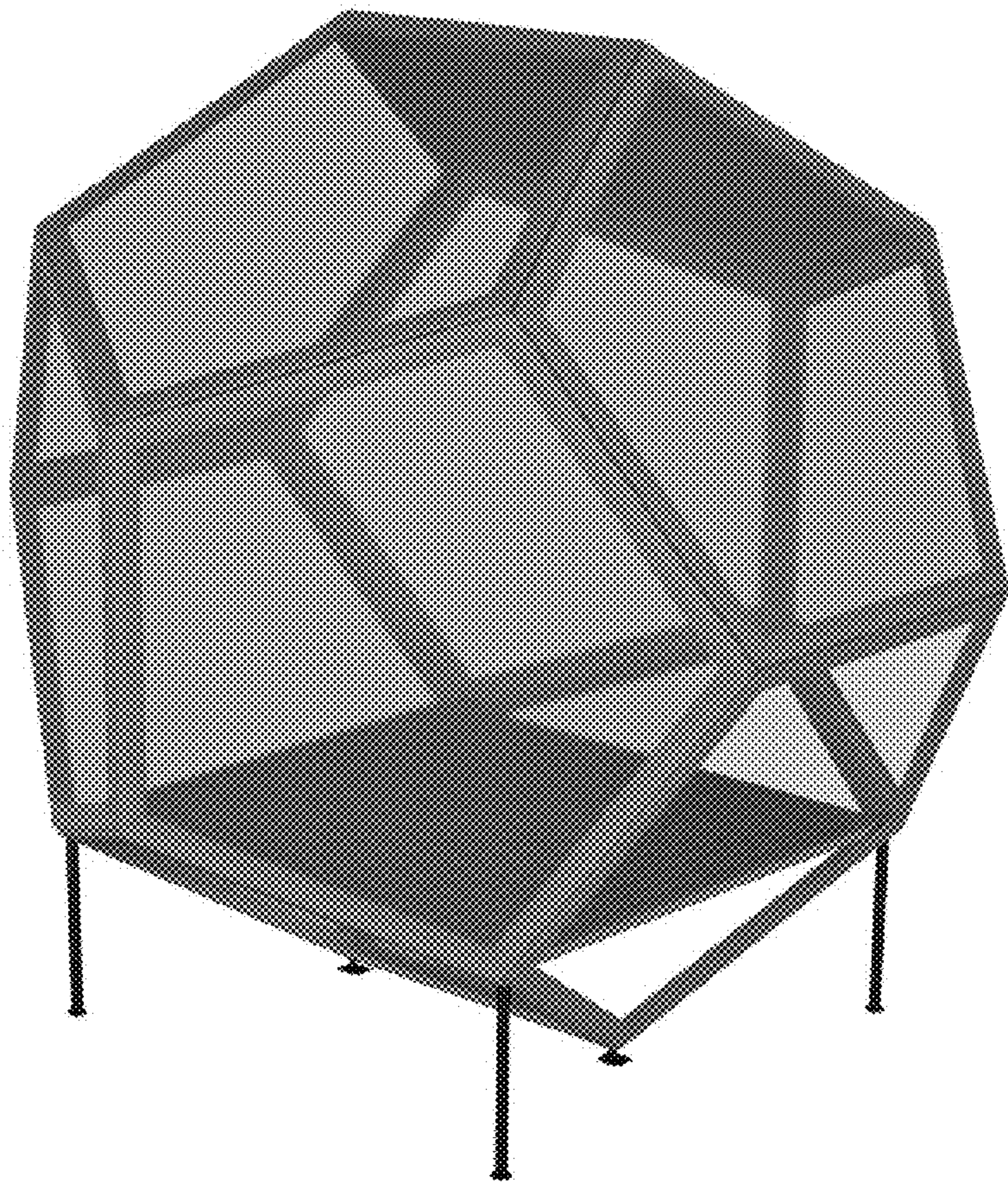
