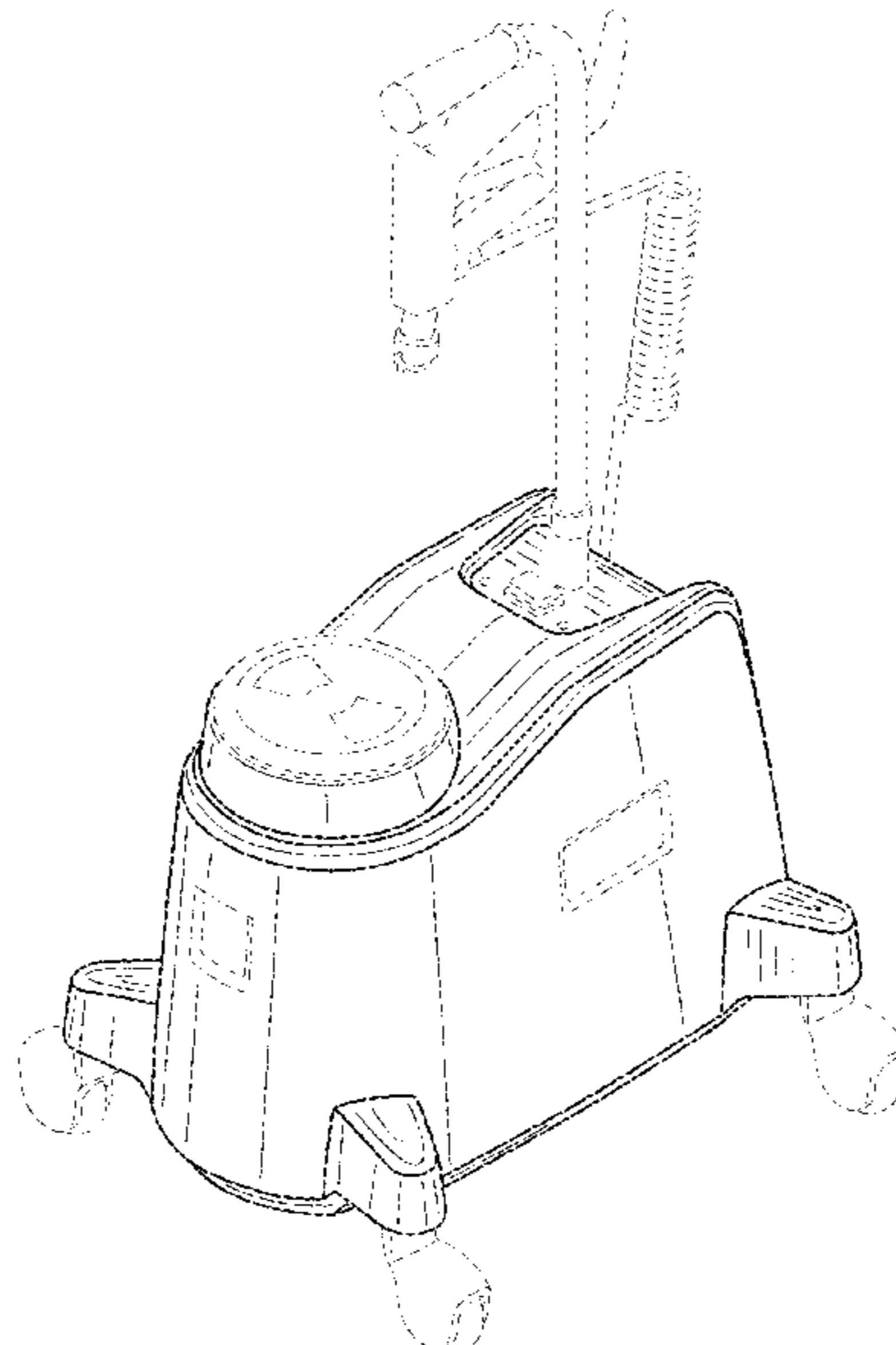
(57) **CLAIM**

The ornamental design of a portable cleaning device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective of the portable cleaning device; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right elevation view thereof; FIG. 5 is a left elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines depict portions of the portable cleaning device that form no part of the claimed design.

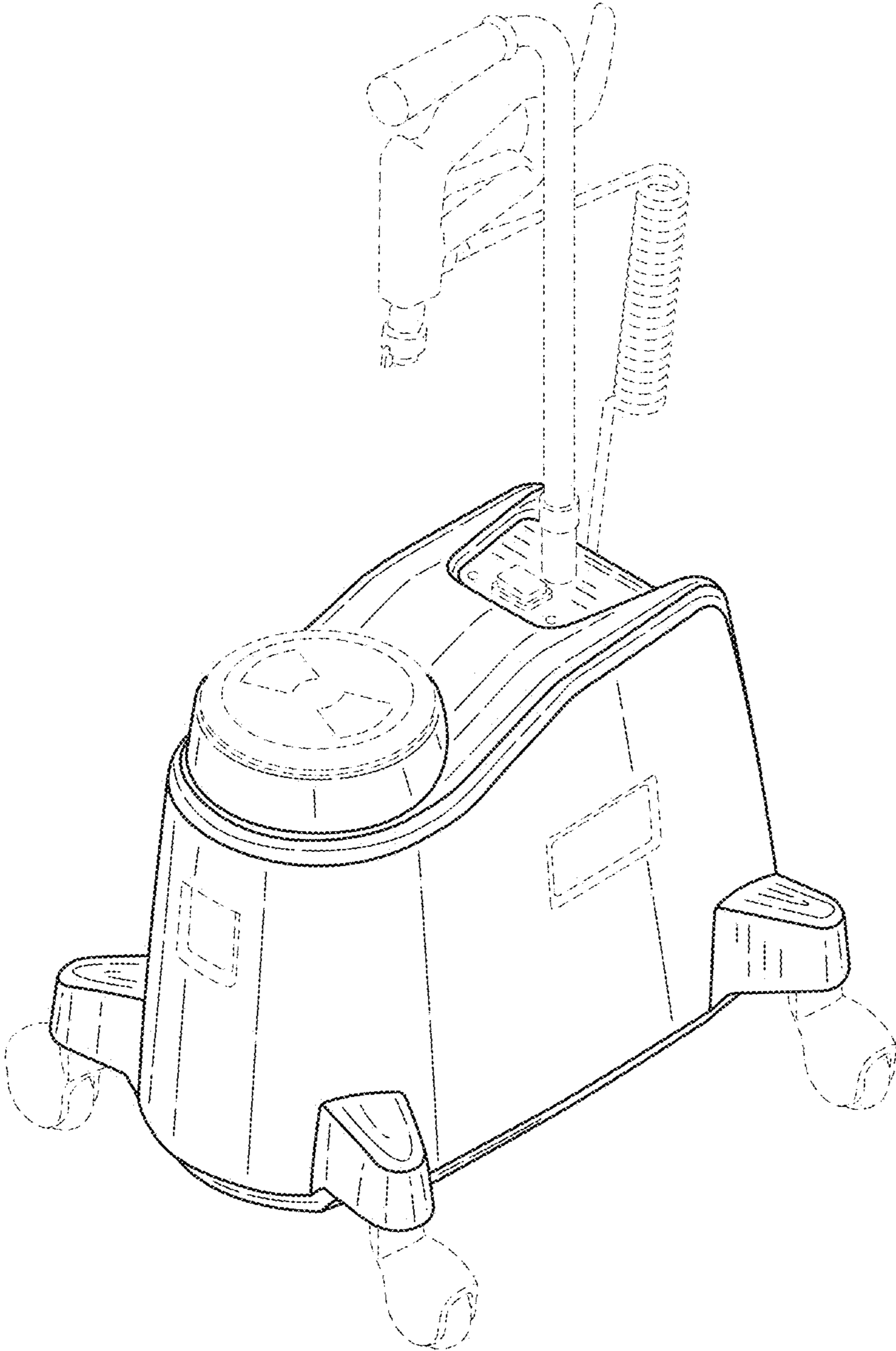

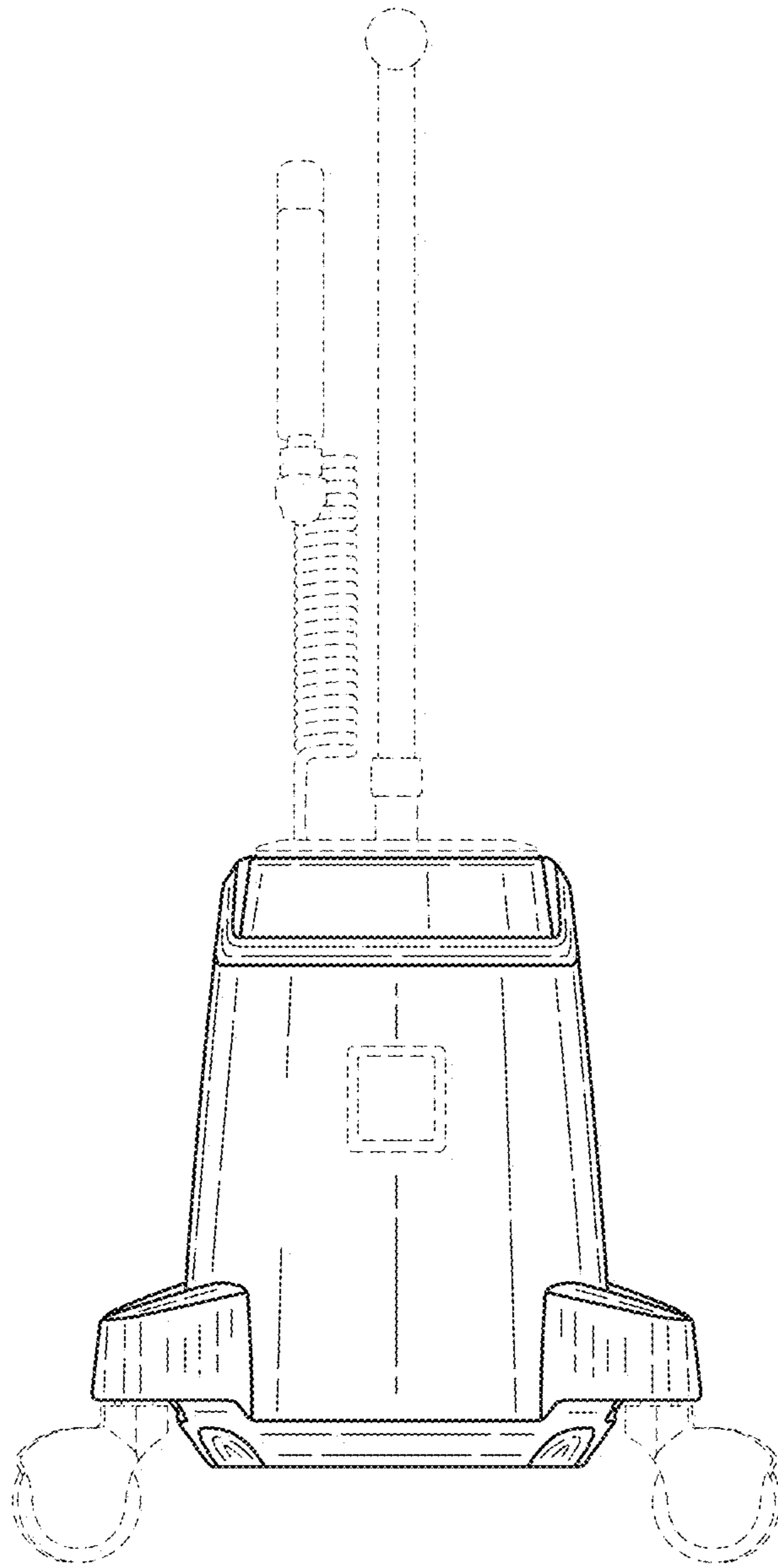

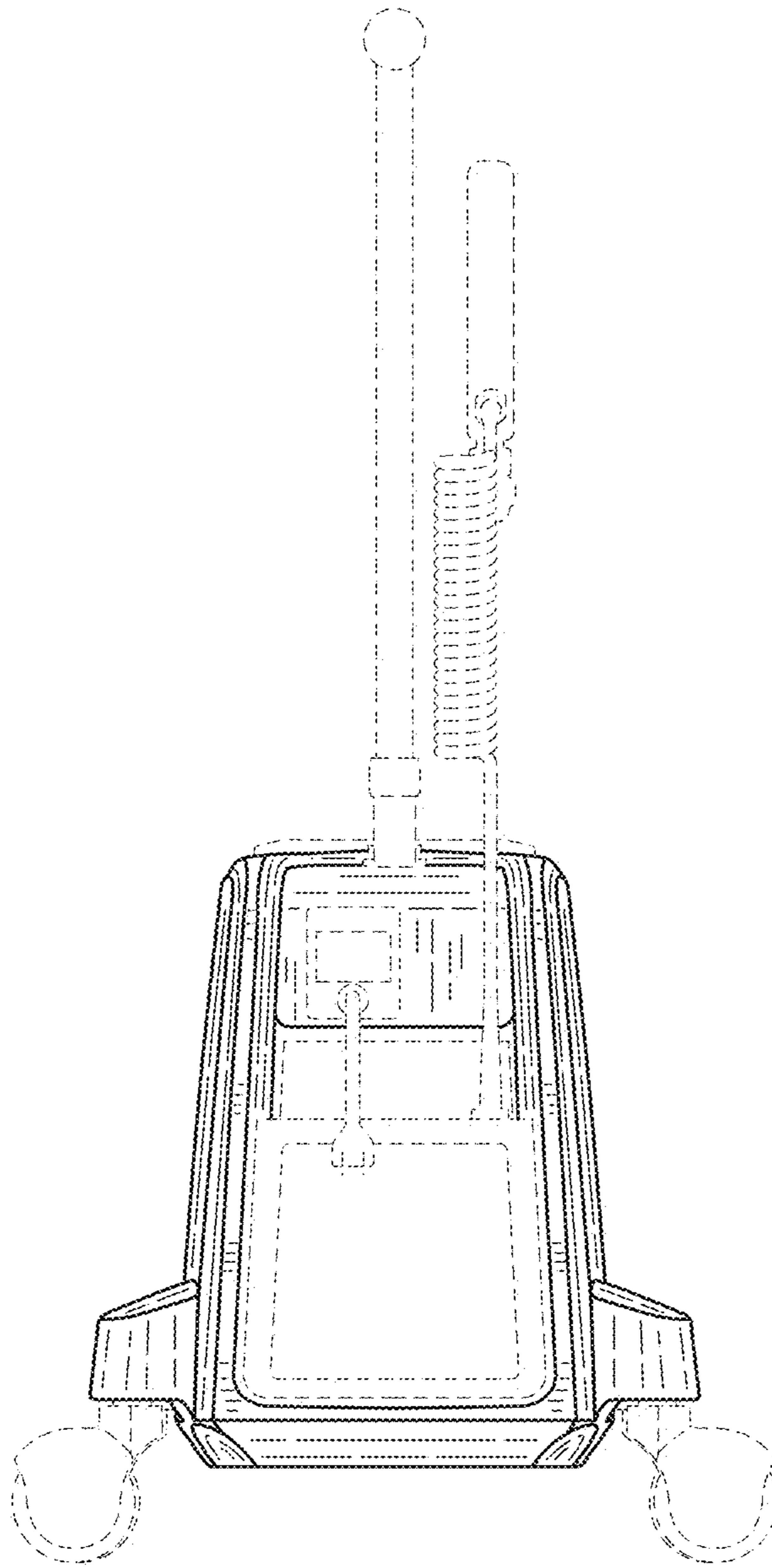

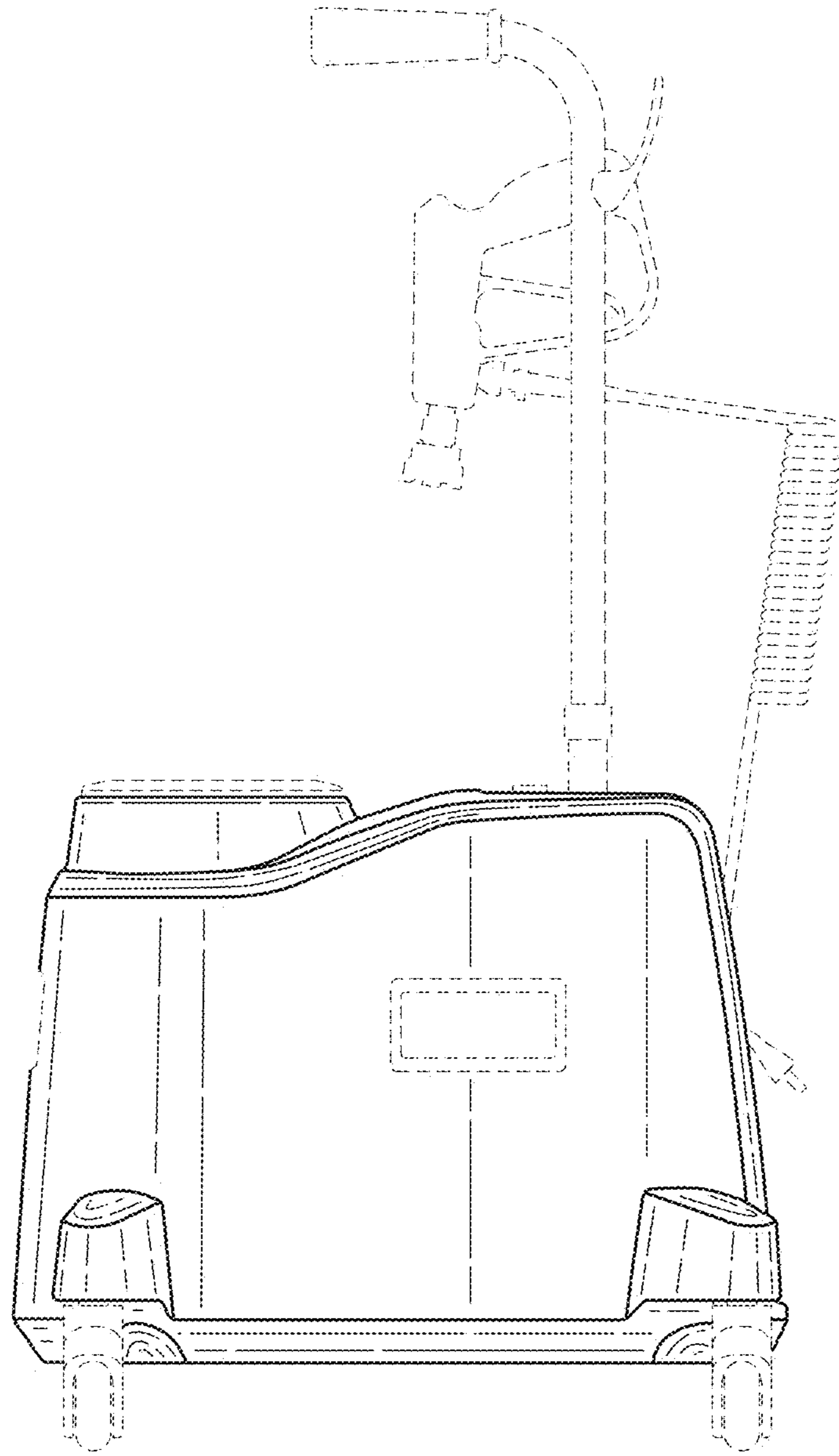

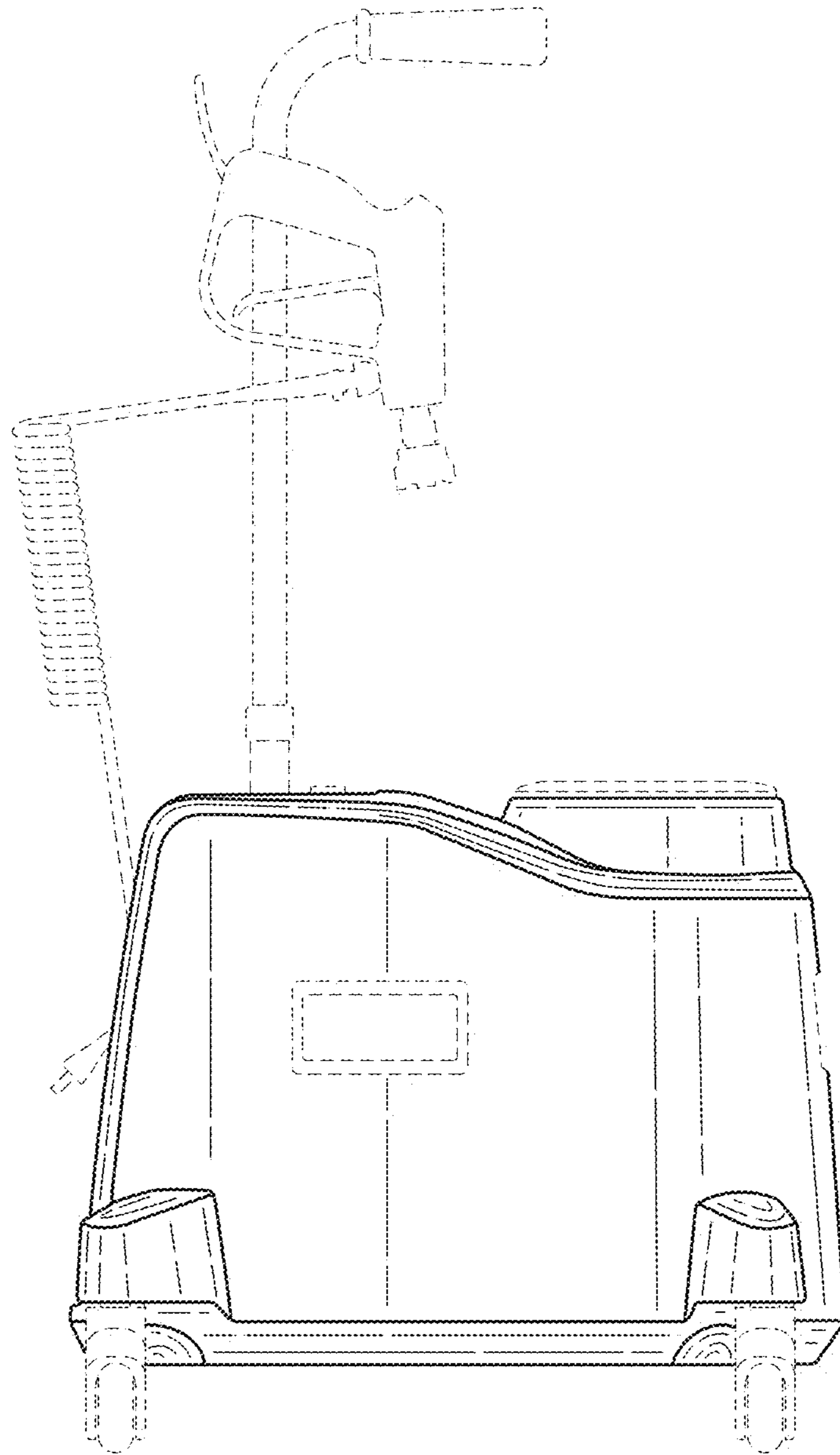

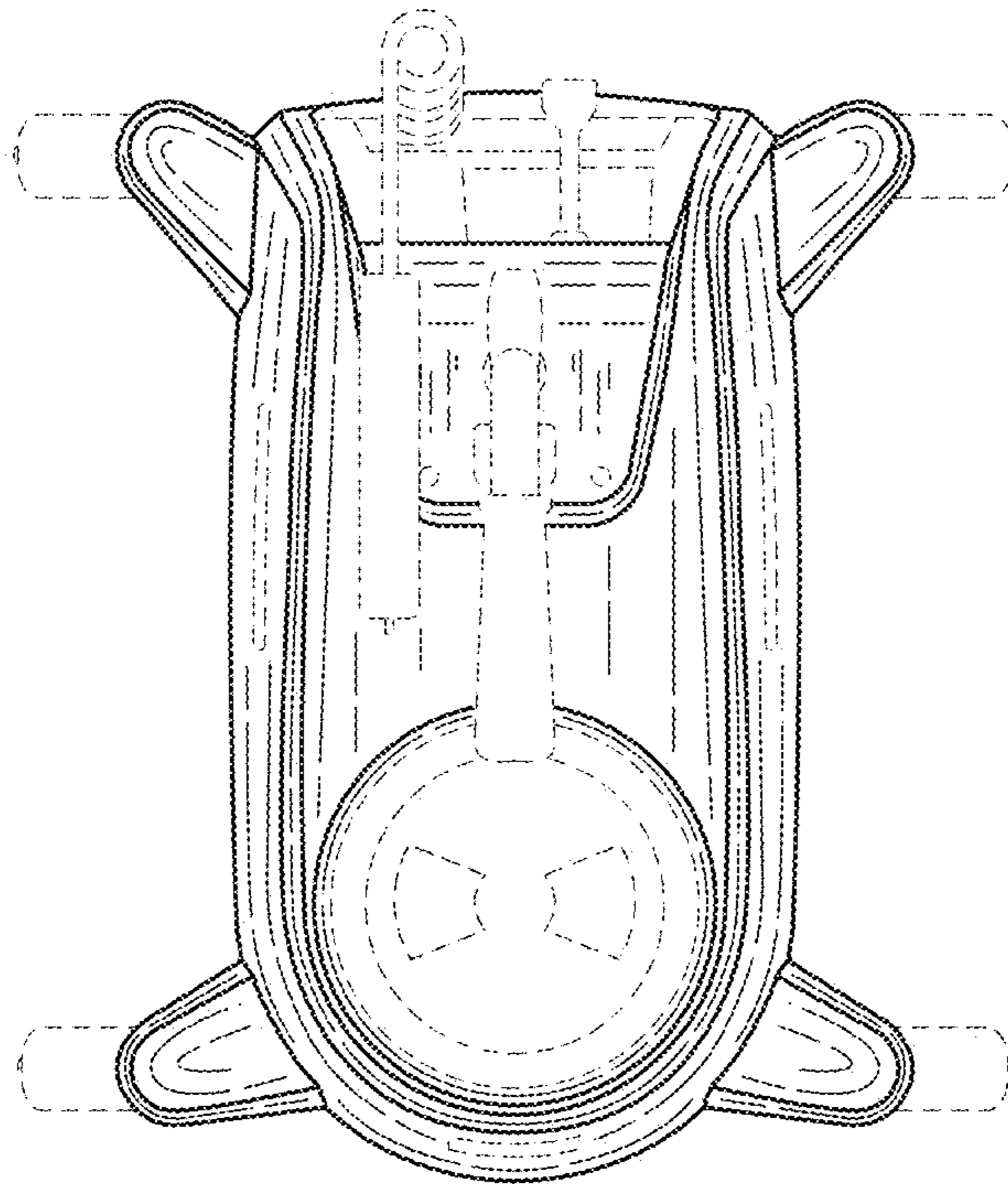

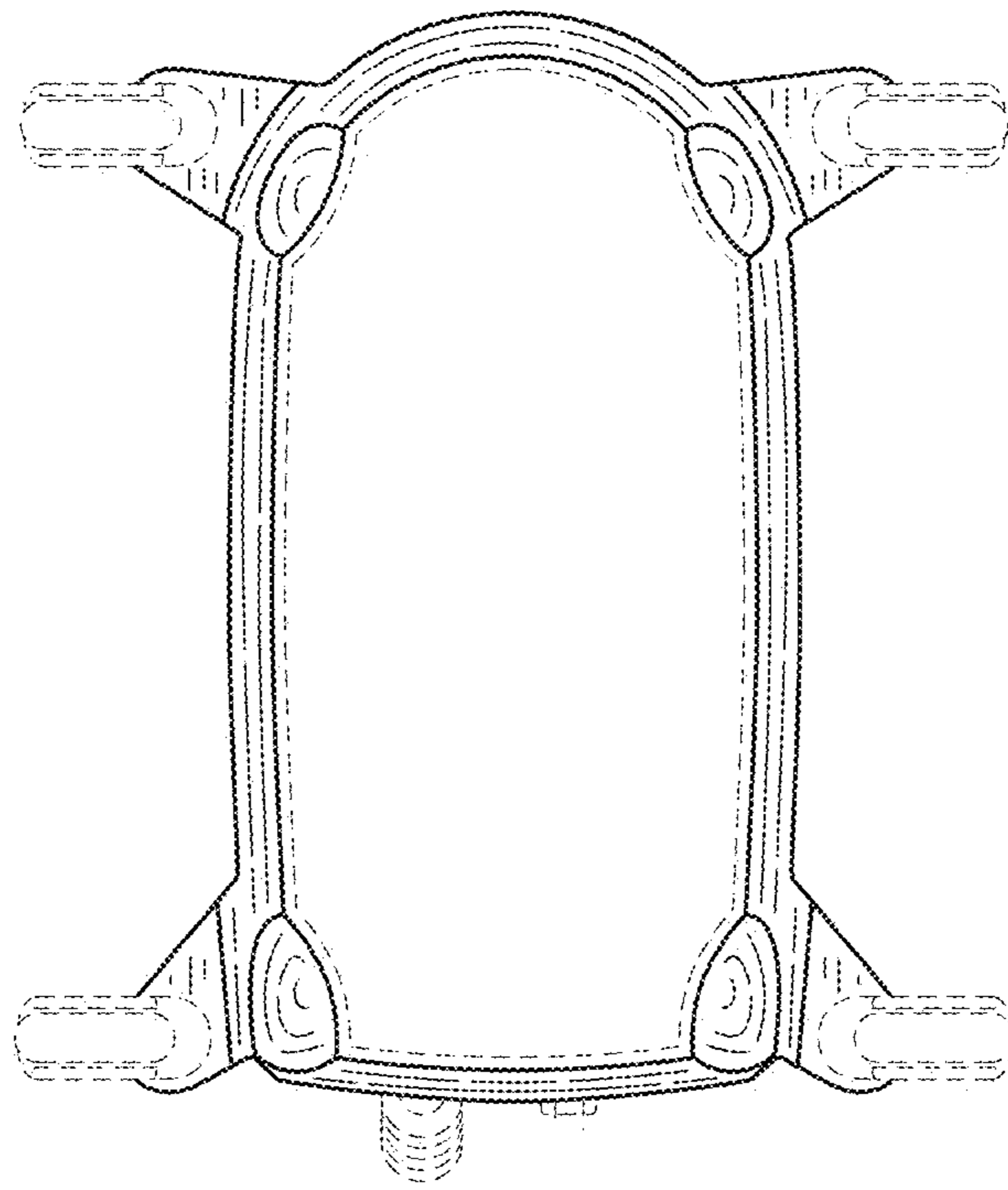
