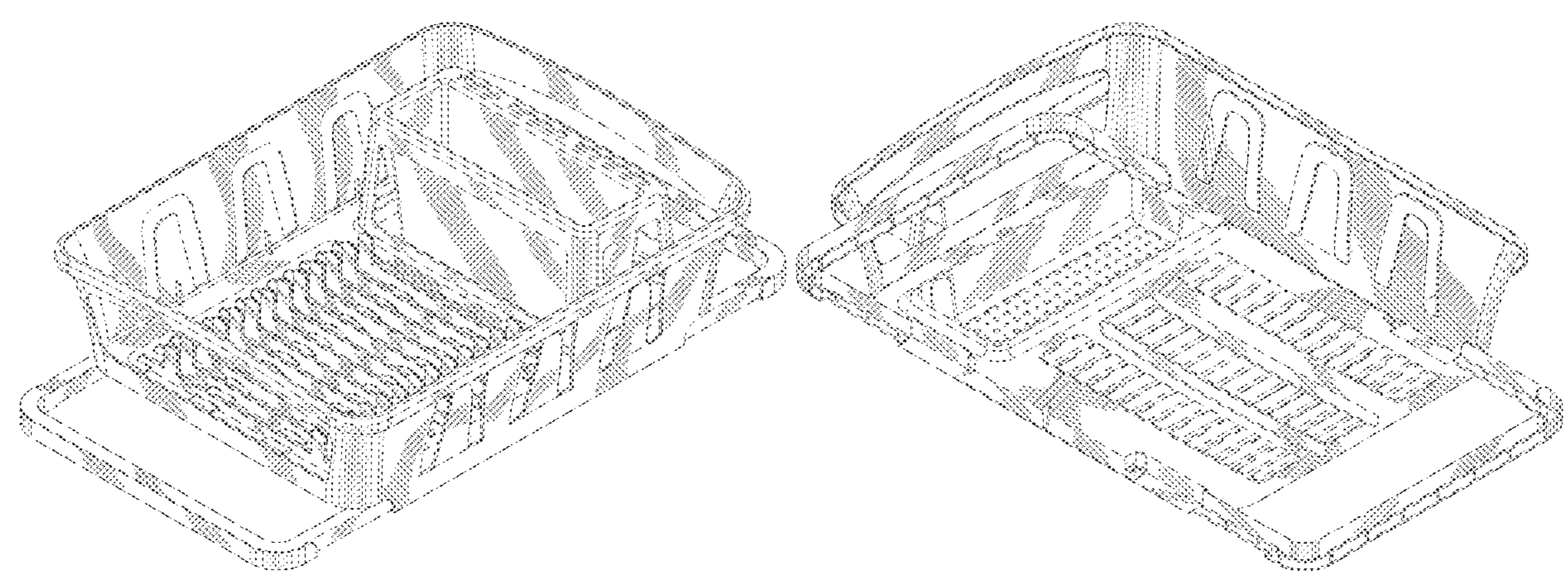

DESCRIPTION
FIG. 1 is a top front perspective view of the dish rack of the present invention;
FIG. 2 is a top rear perspective view of the dish rack shown in FIG. 1;
FIG. 3 is a bottom front perspective view of the dish rack shown in FIG. 1;

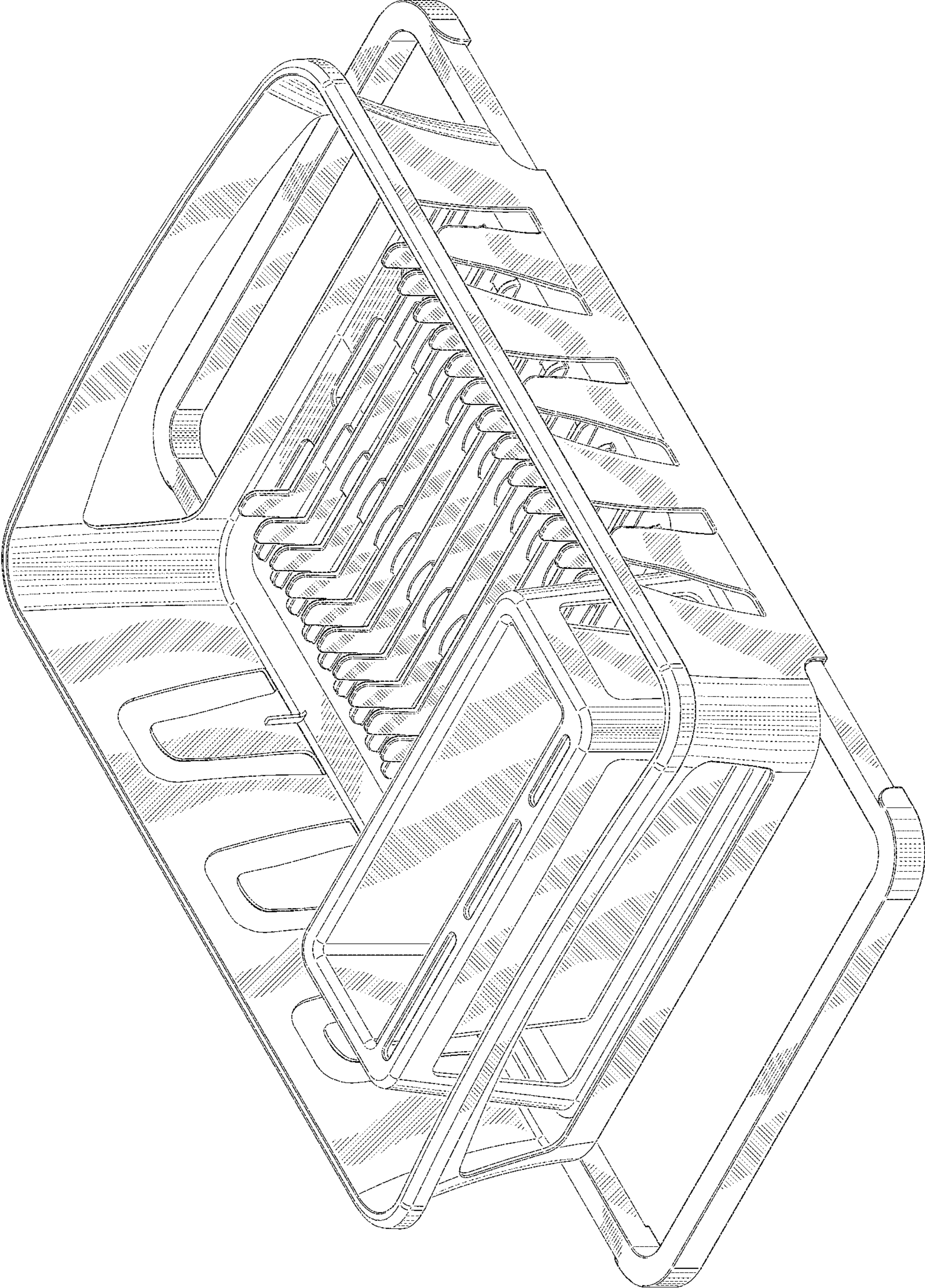

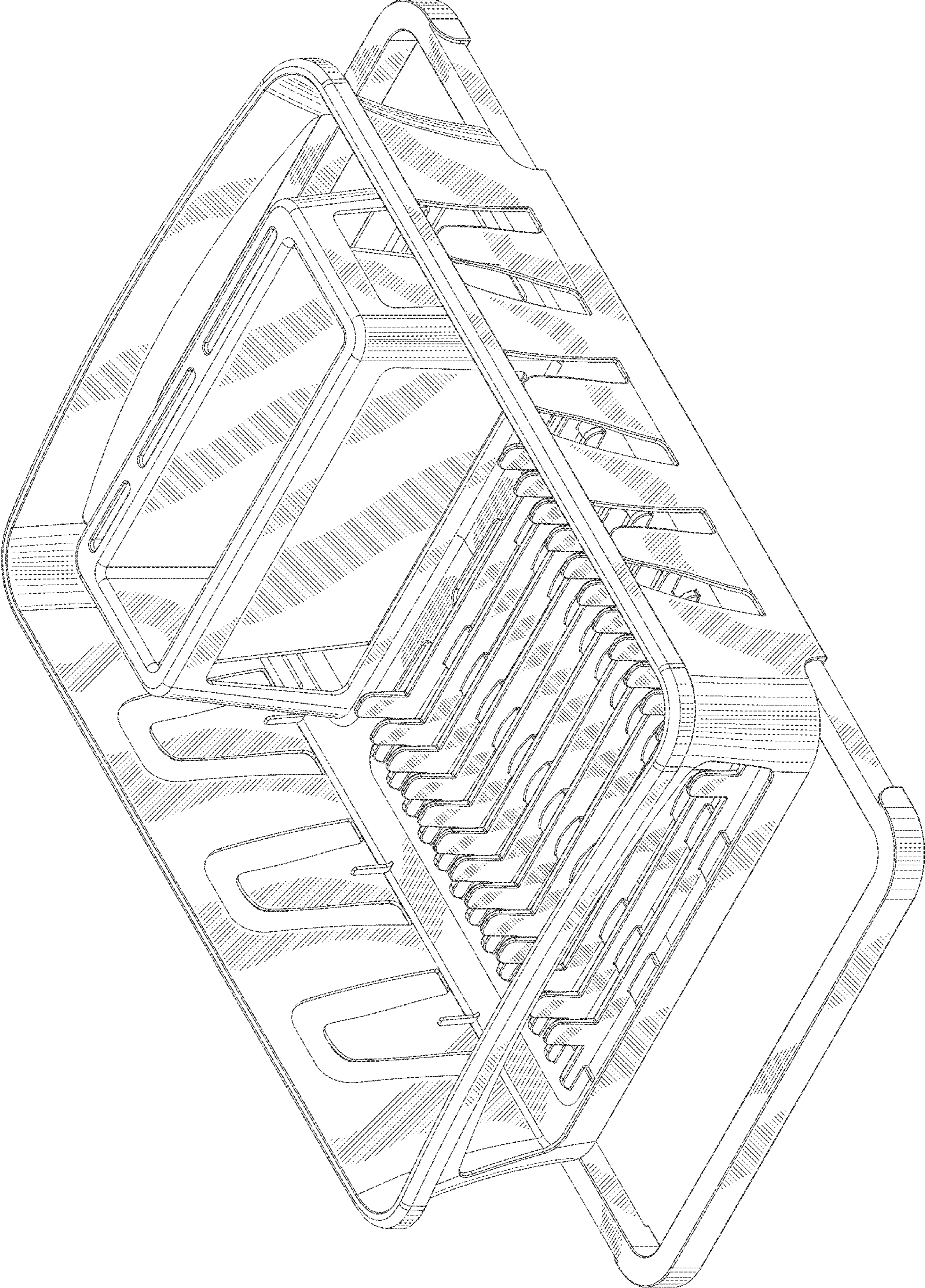

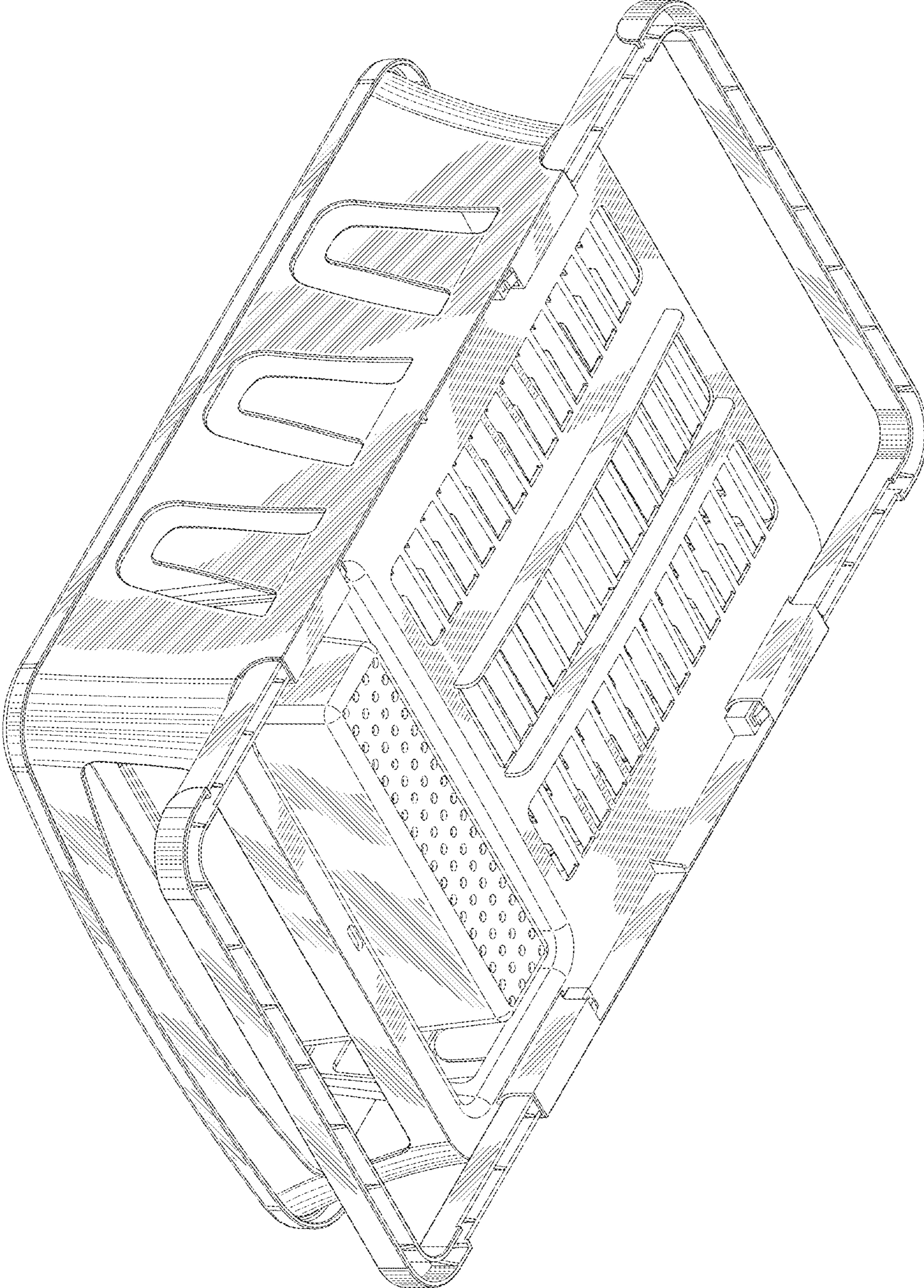

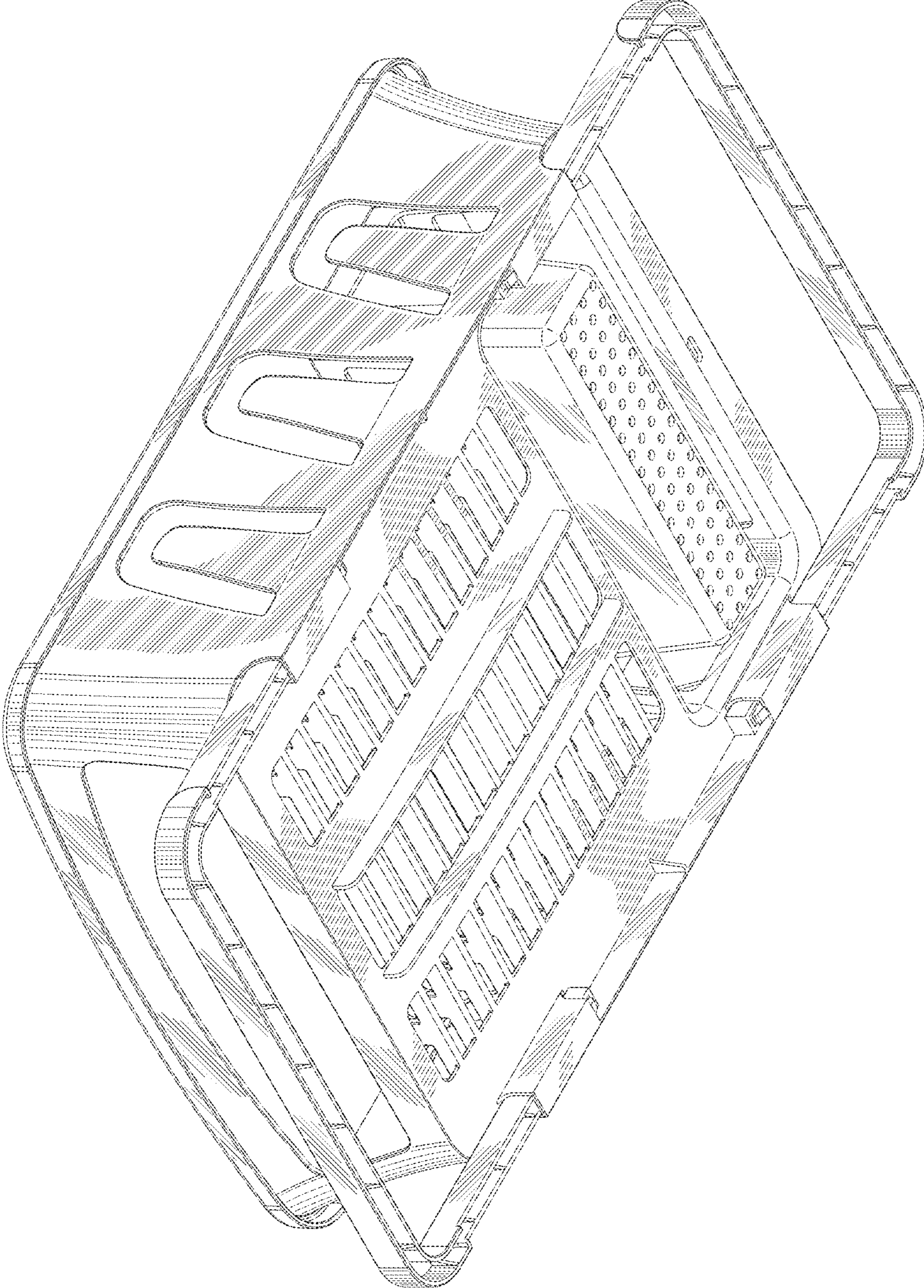

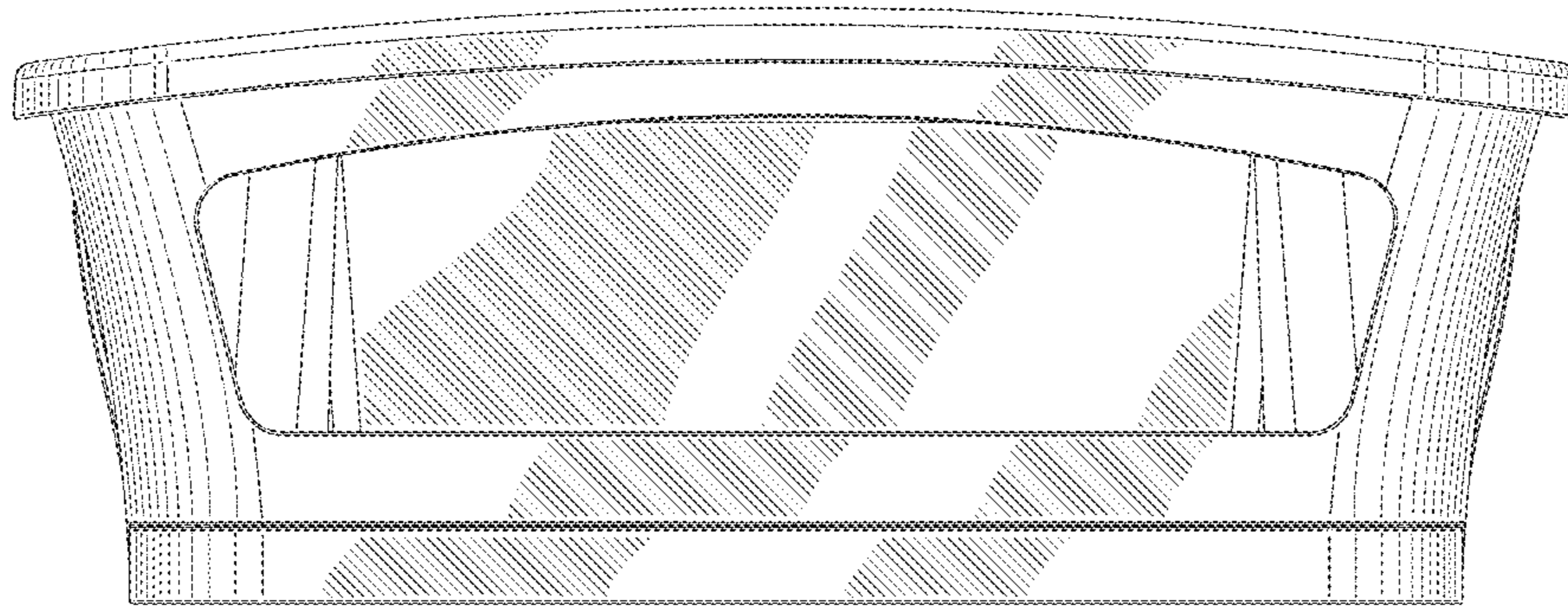

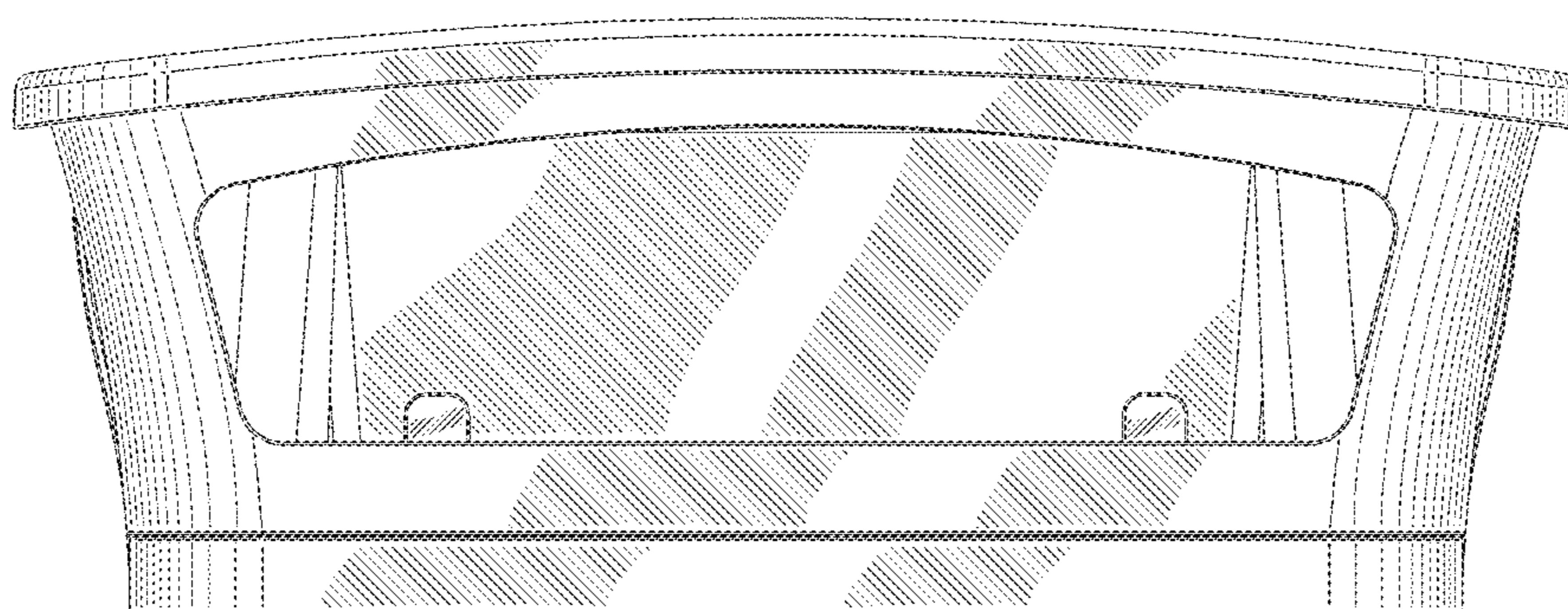

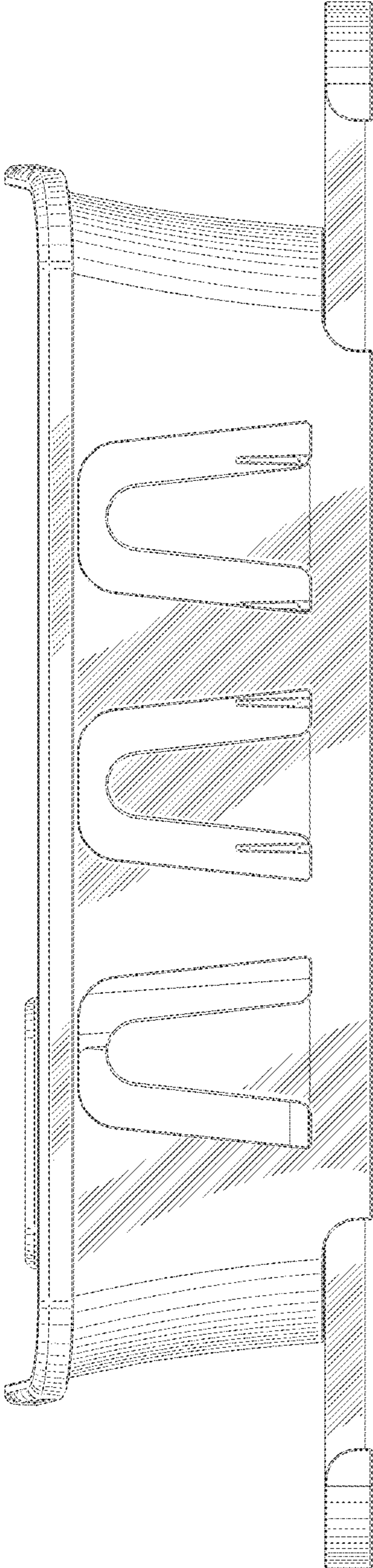

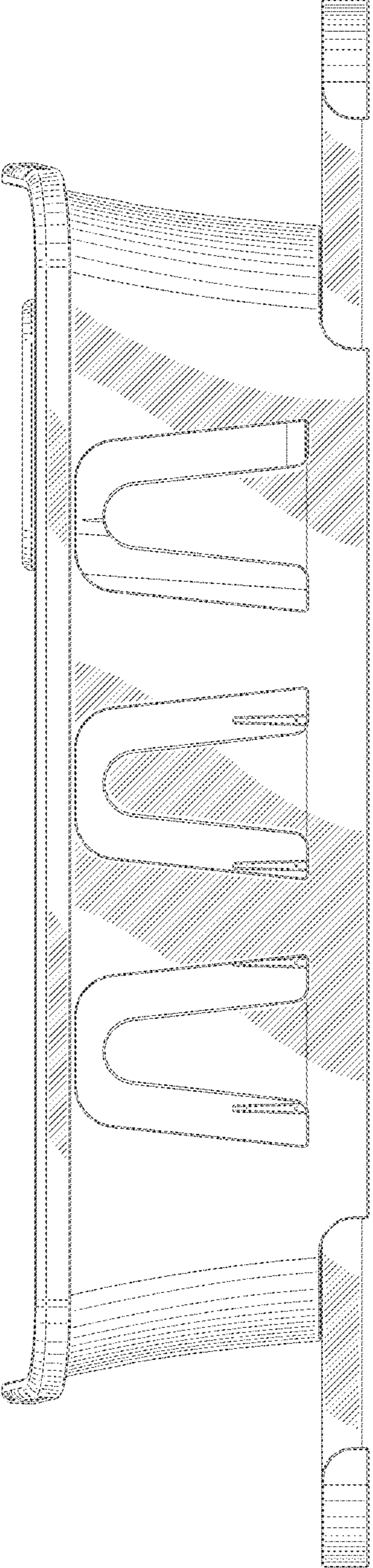

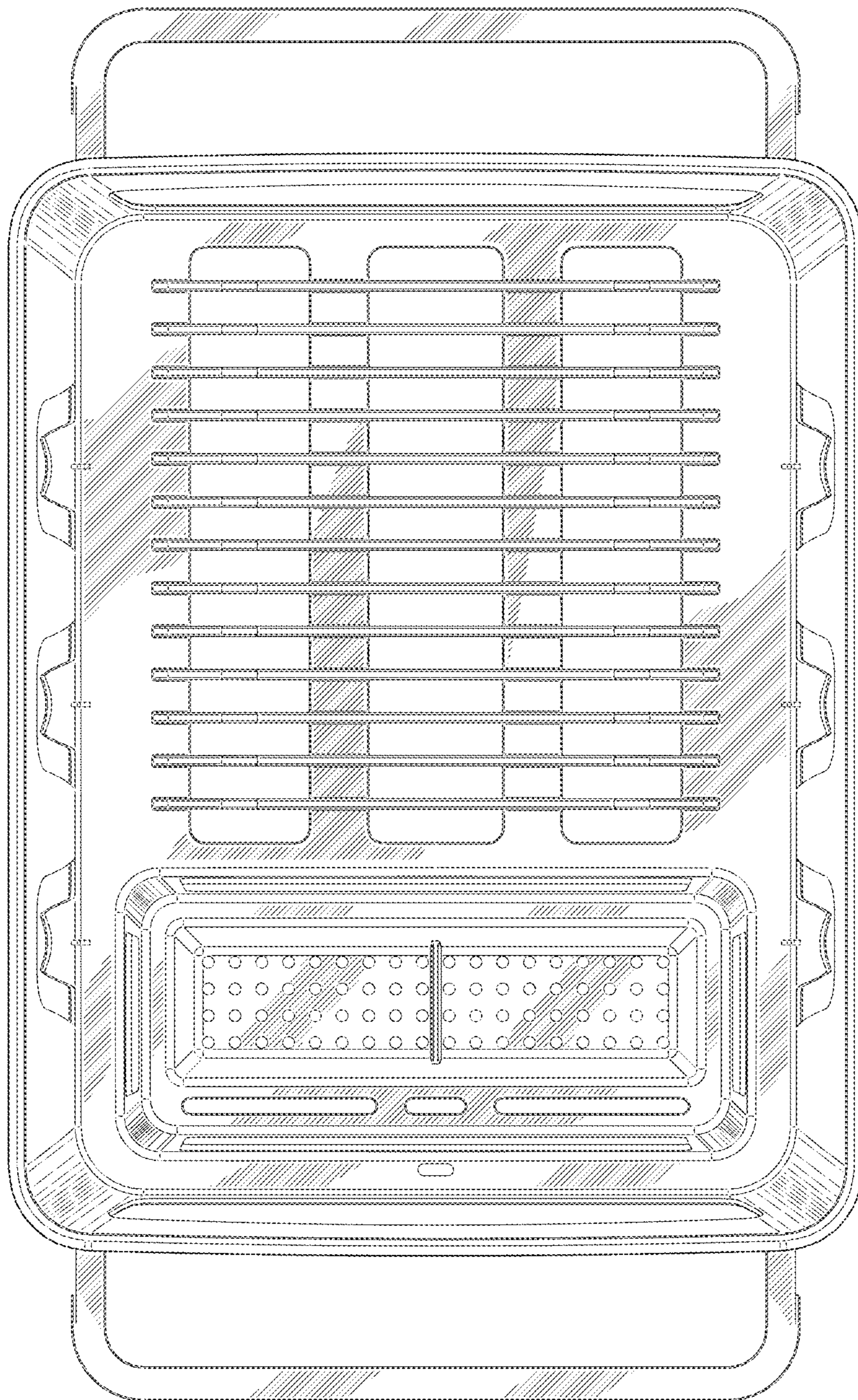

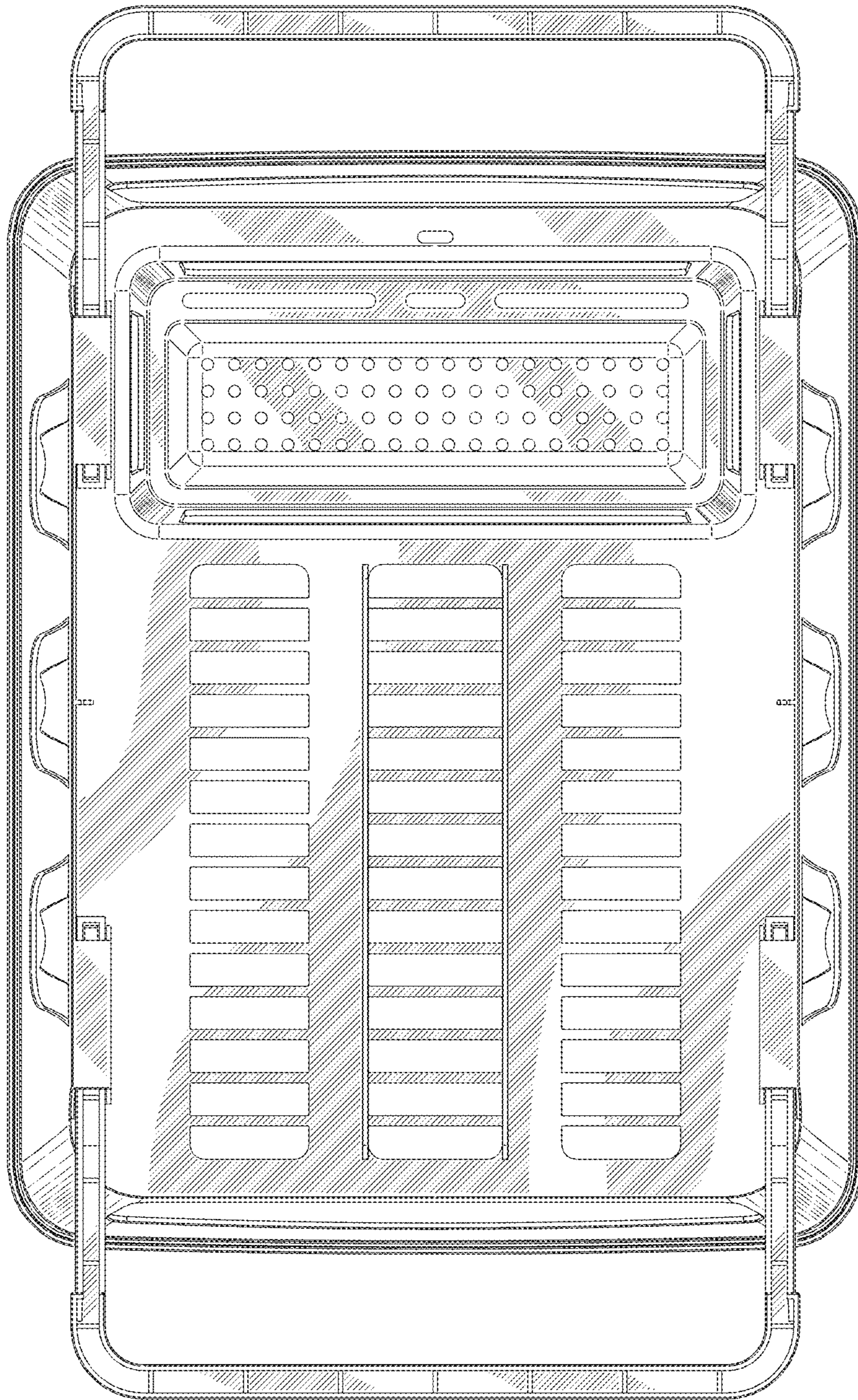
