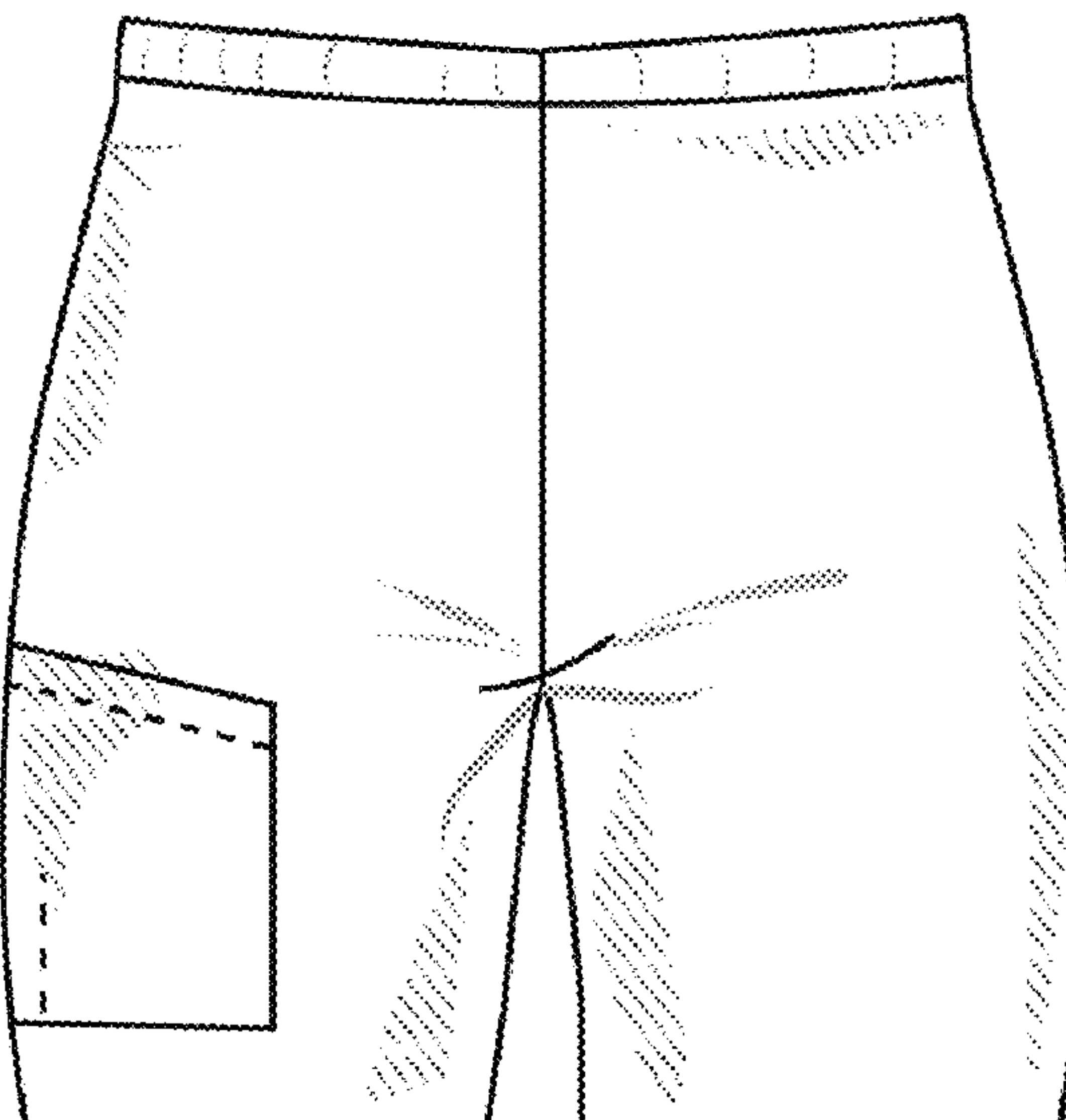
(57) **CLAIM**

The ornamental design for yoga pants with a pocket for a hand gun, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of shorts with a pocket for a hand gun;
 FIG. 2 is a rear view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a front perspective view thereof;
 FIG. 6 is a right flat side view thereof;
 FIG. 7 is a left flat side view thereof;
 FIG. 8 is a top view thereof; and
 FIG. 9 is a bottom view thereof.
 FIG. 10 is a front view of a second embodiment of shorts with a pocket for a hand gun;
 FIG. 11 is a rear view thereof;
 FIG. 12 is a right side view thereof; and
 FIG. 13 is a left side view thereof.
 FIG. 14 is a front view of a third embodiment of shorts with a pocket for a hand gun; and,
 FIG. 15 is a left side view thereof.
 In all of the FIGURES, the dashed lines shown directly on the surface of the claimed article, throughout the view, are understood to represent stitching. The broken lines showing the outline of a hand gun in the figures form no part of the claimed design.

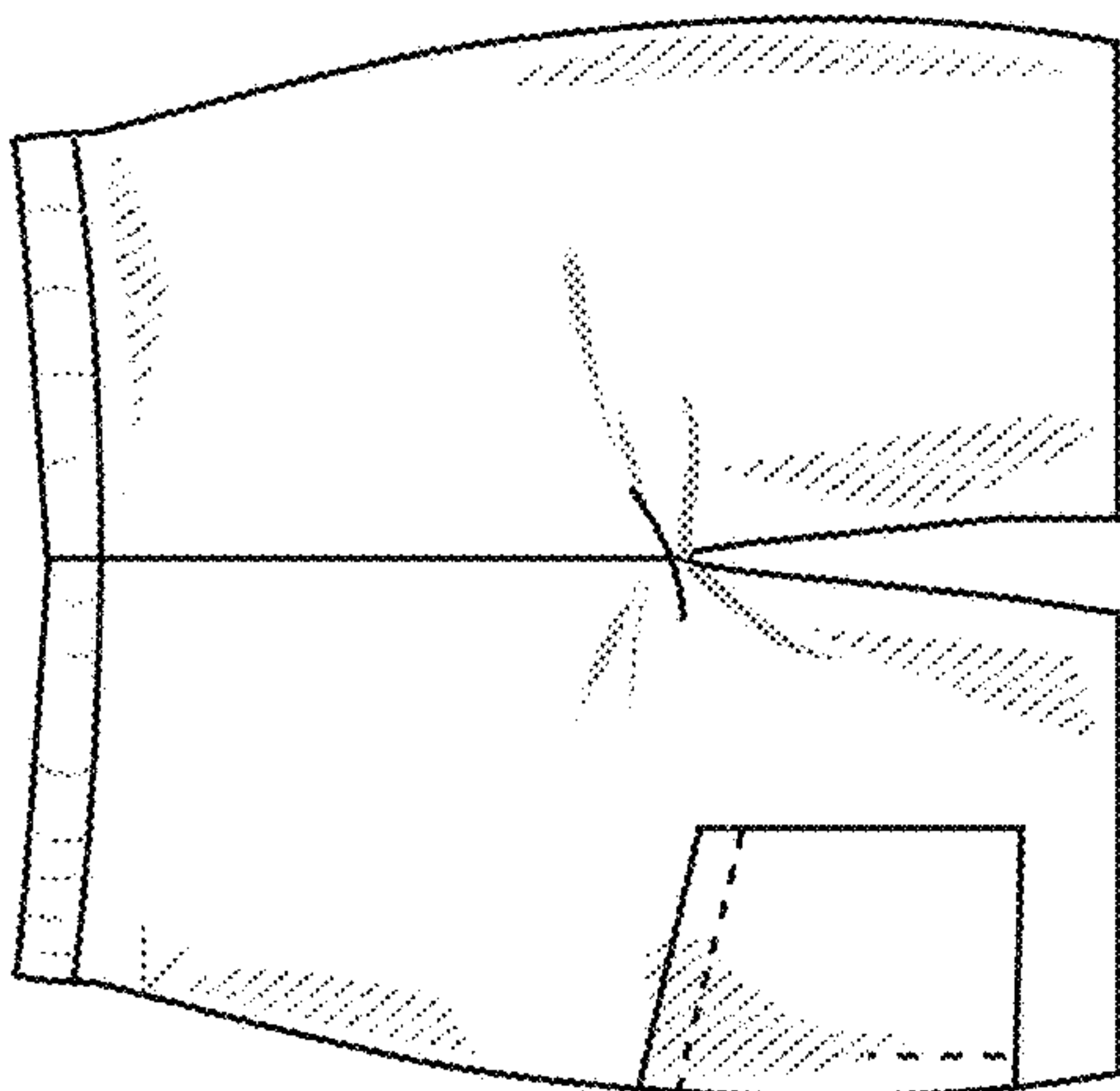

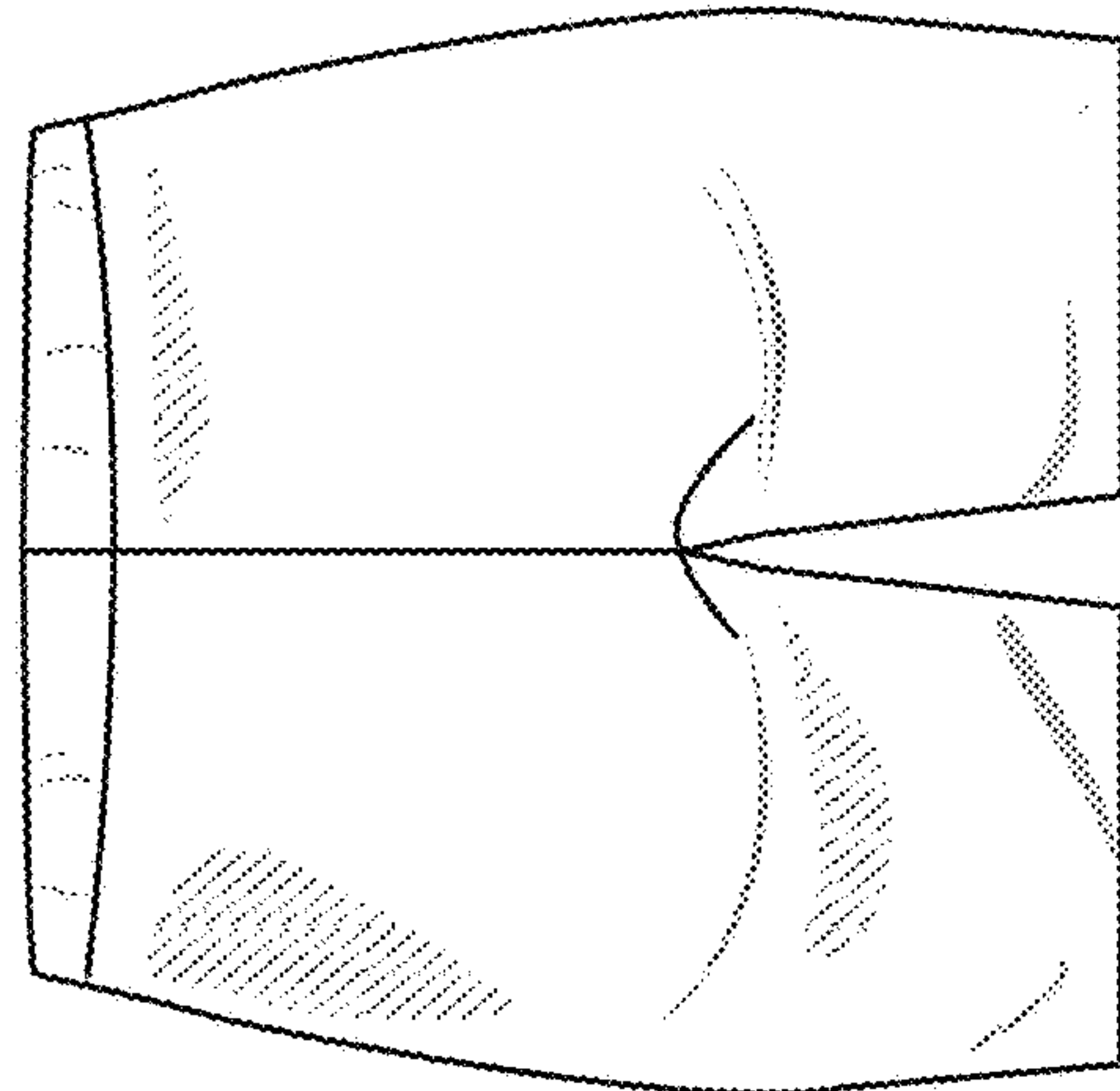

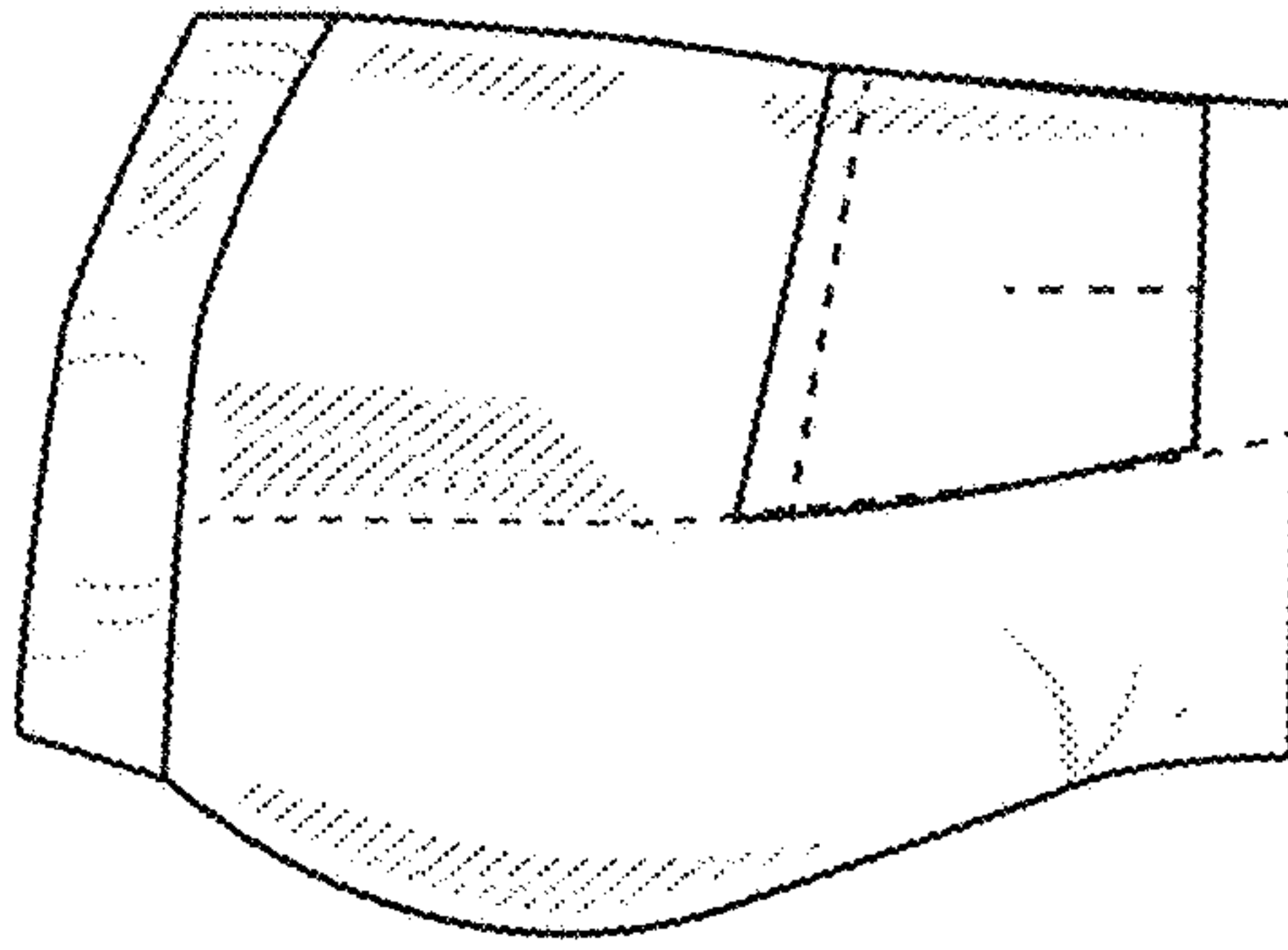

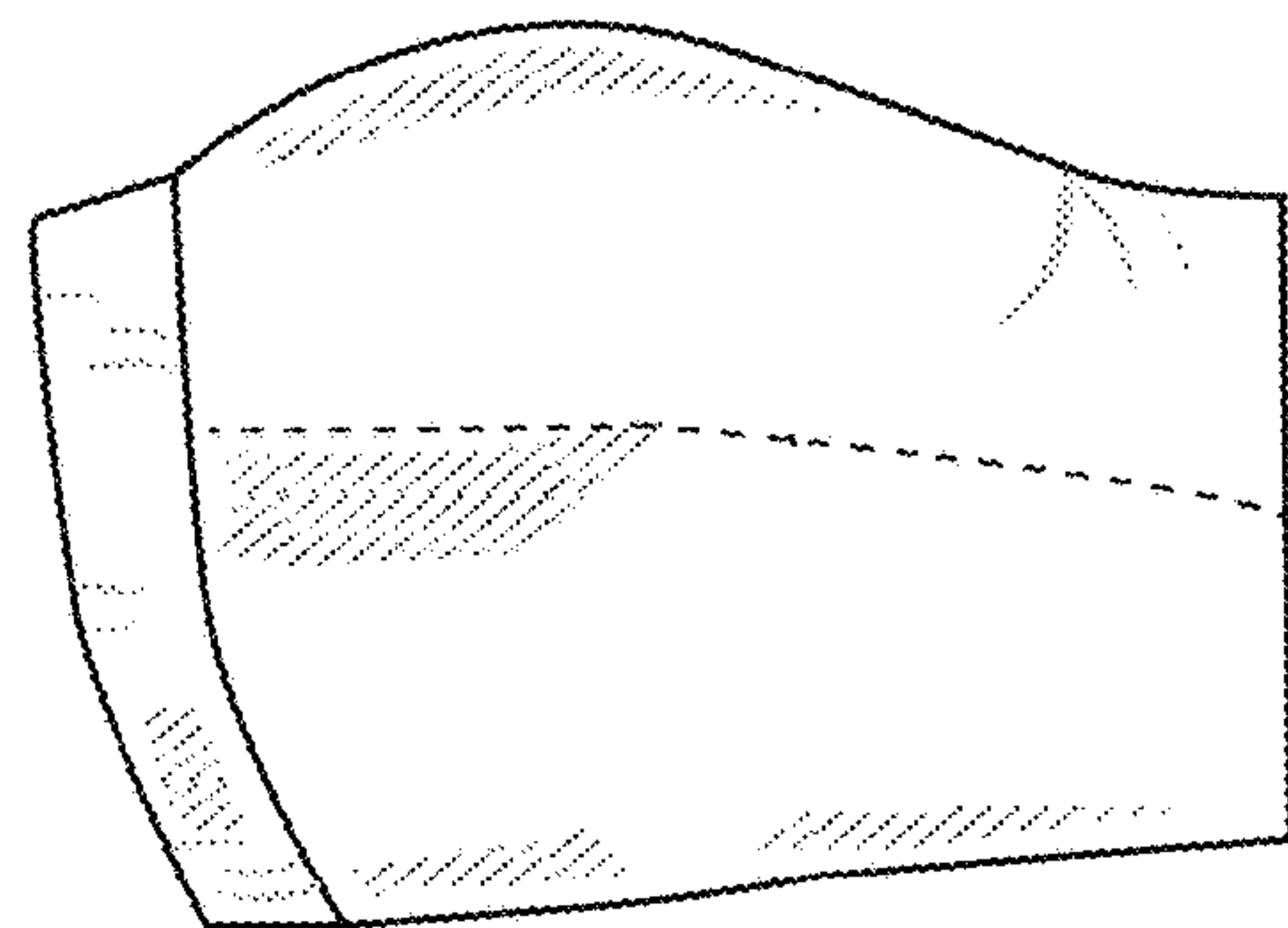

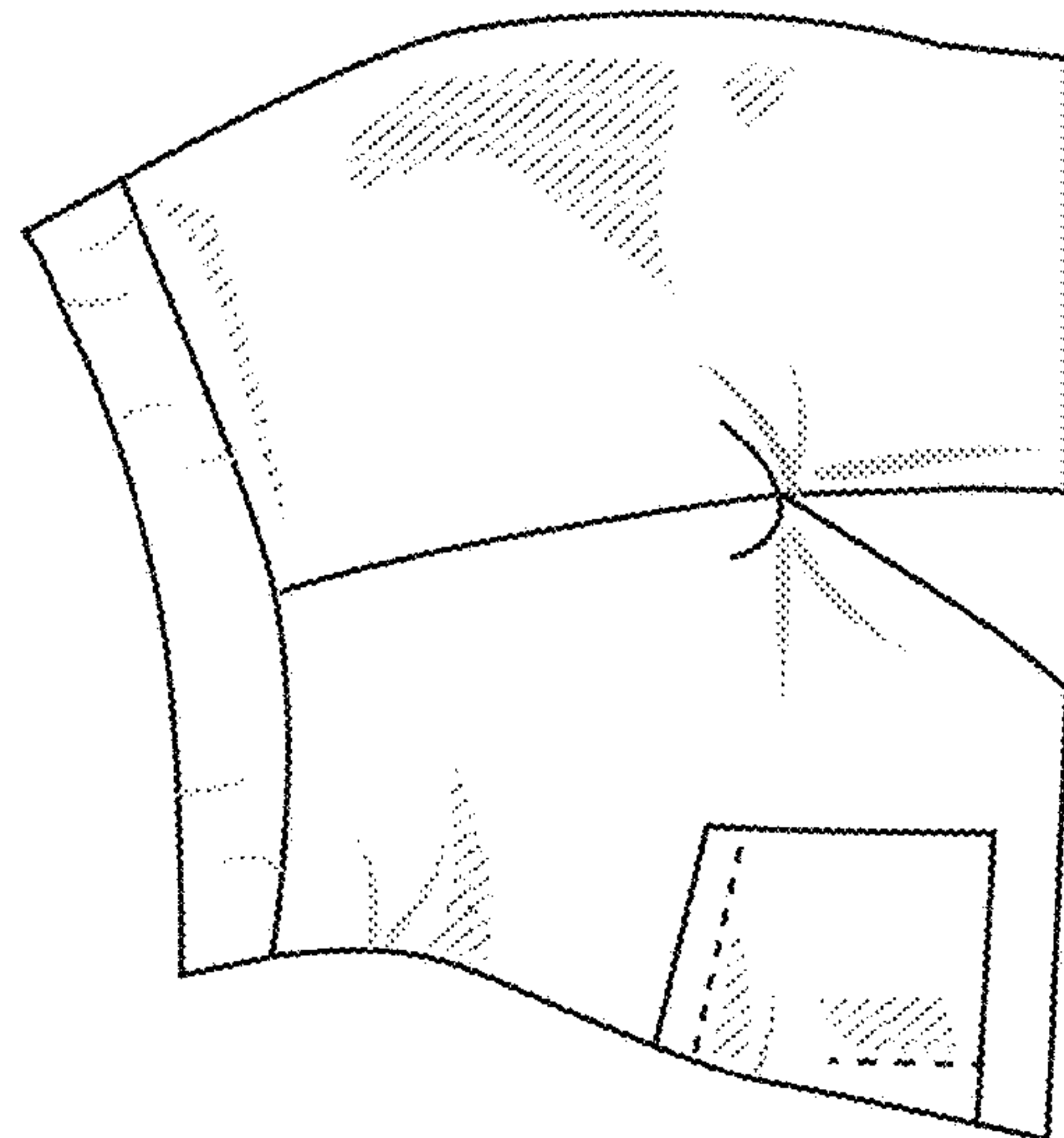

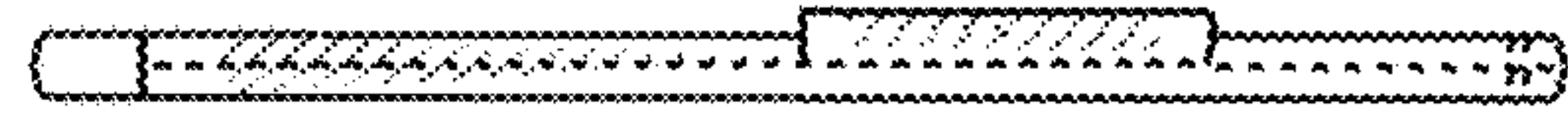

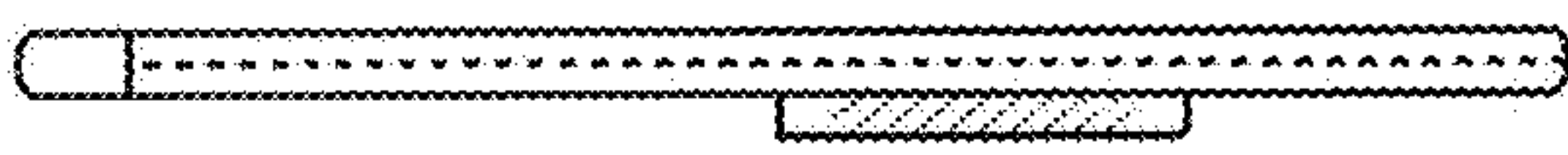

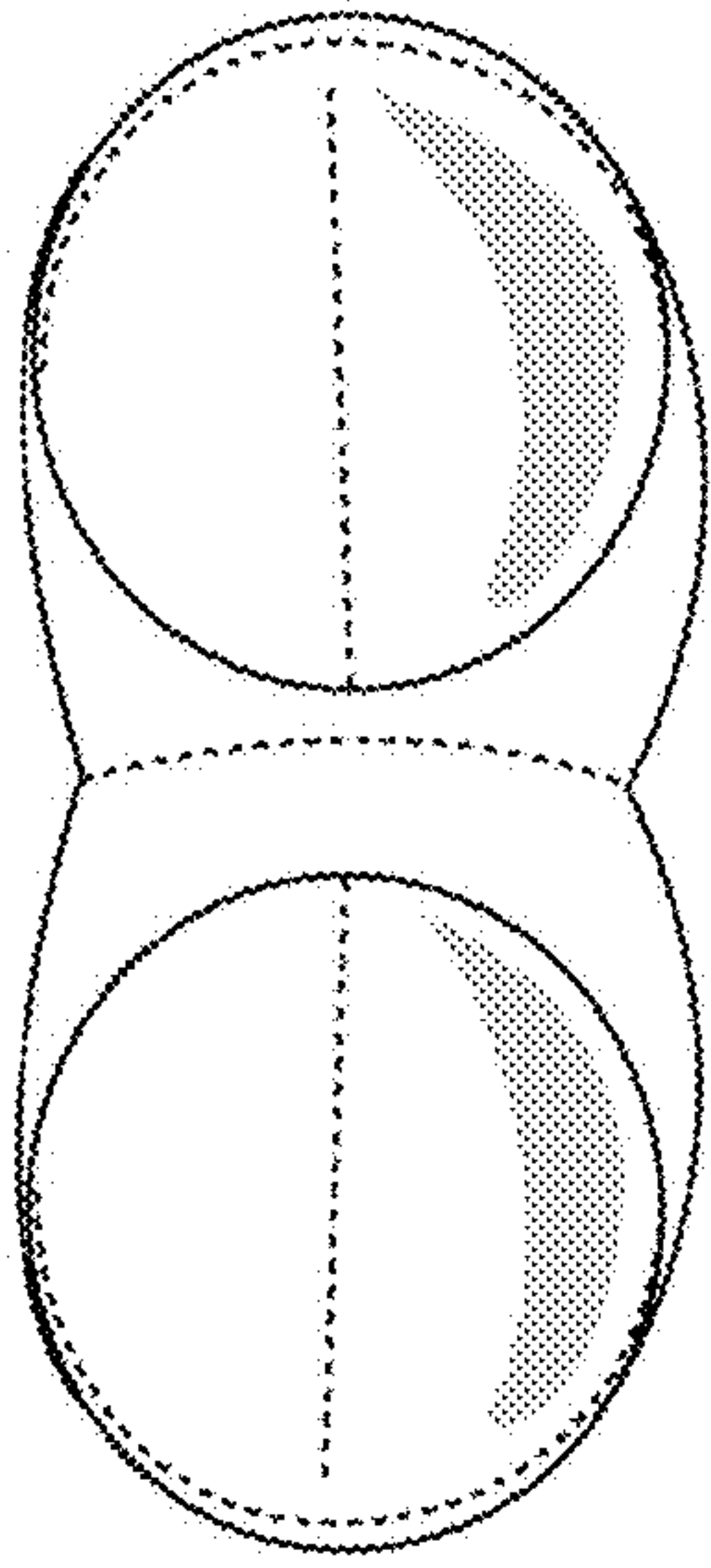

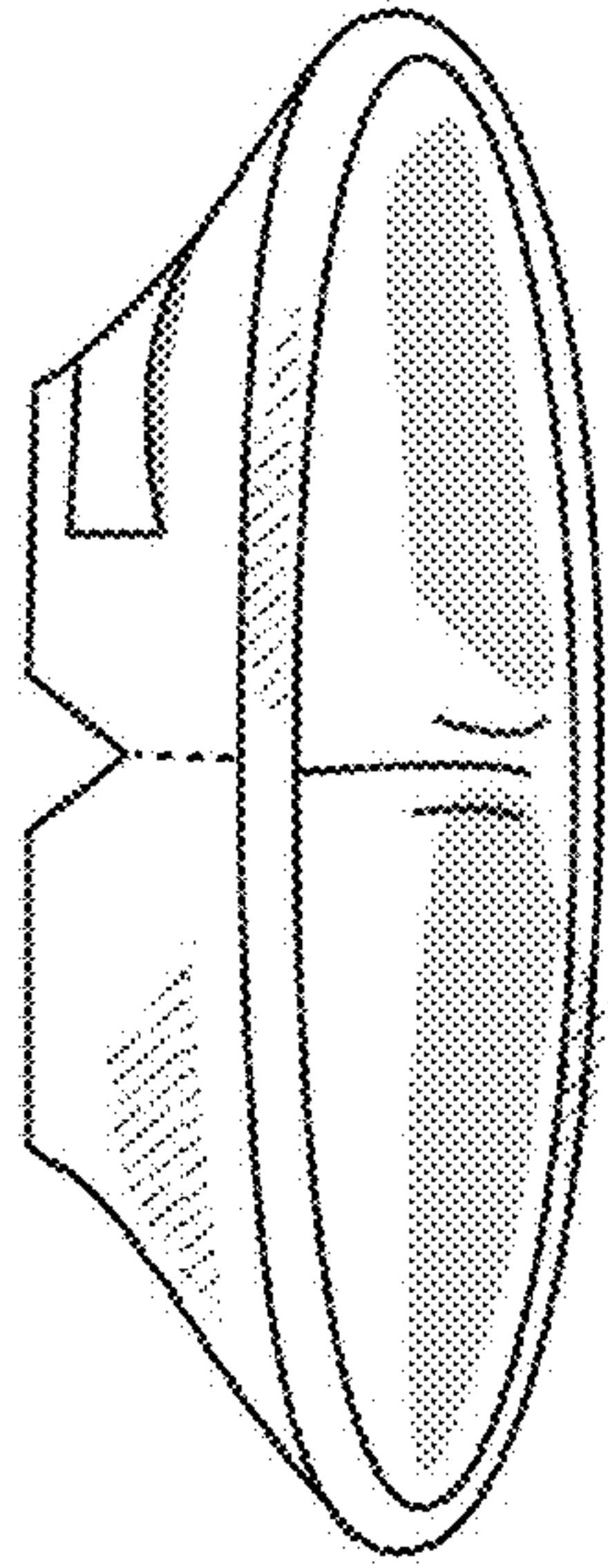

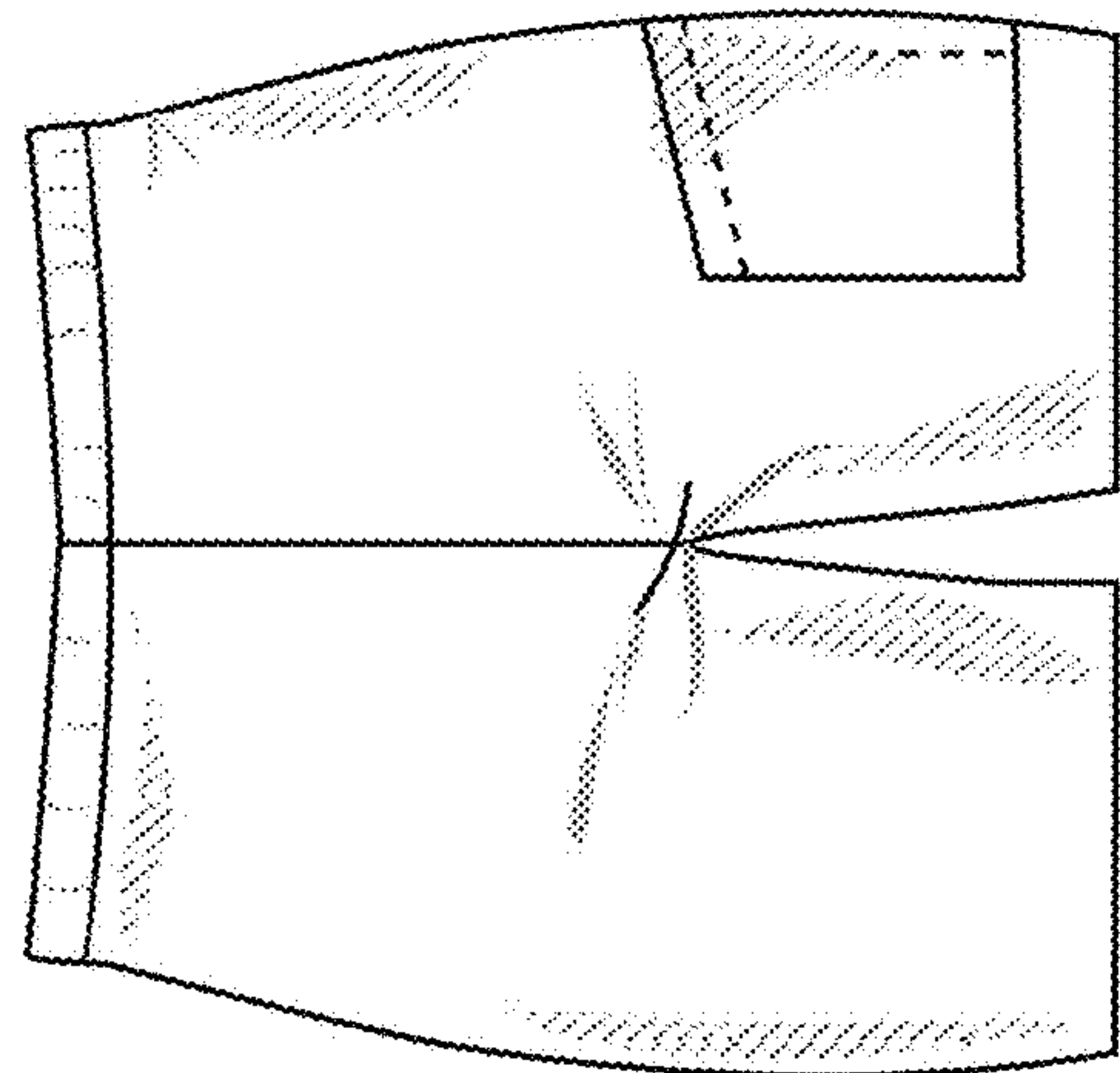

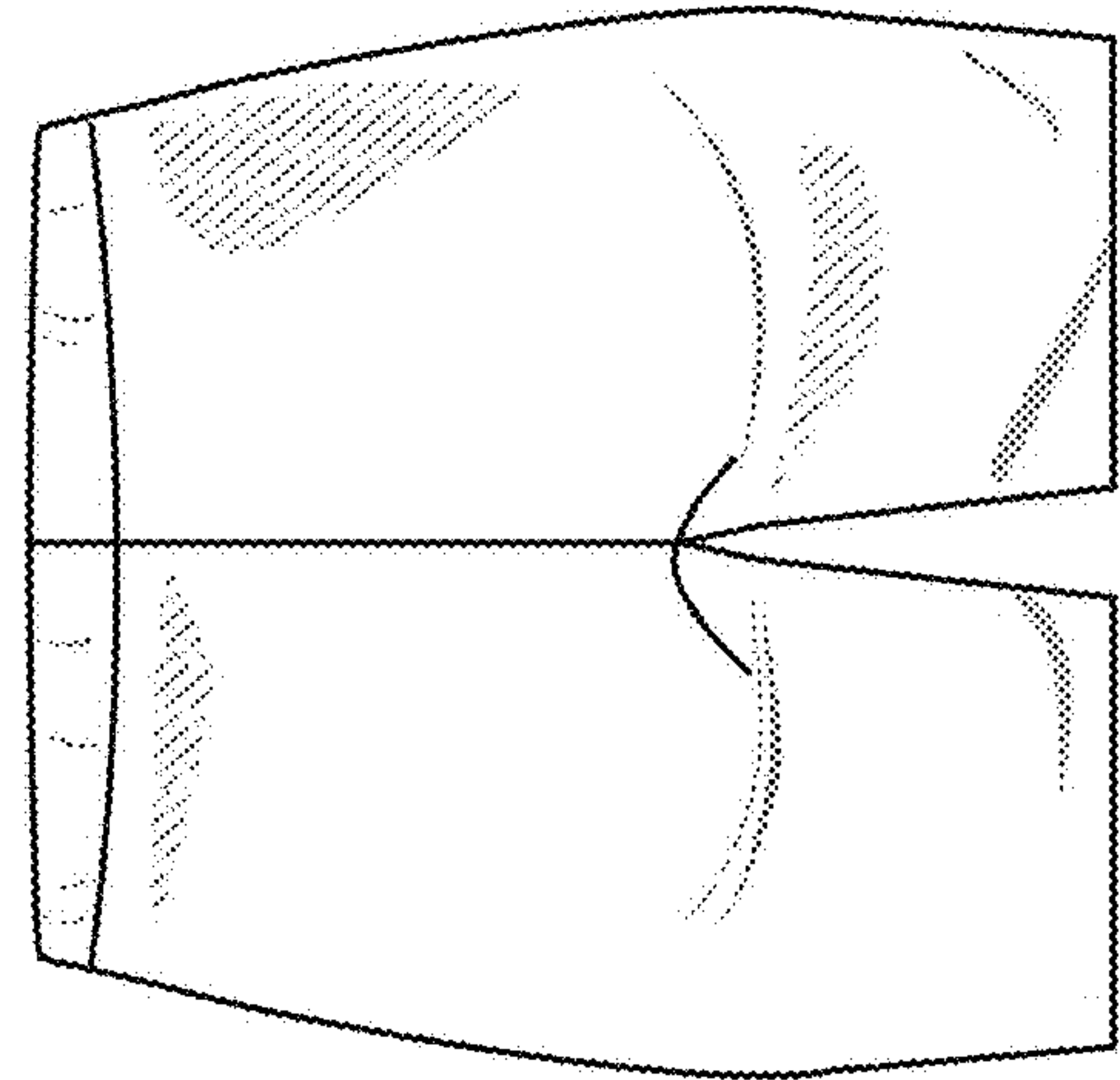

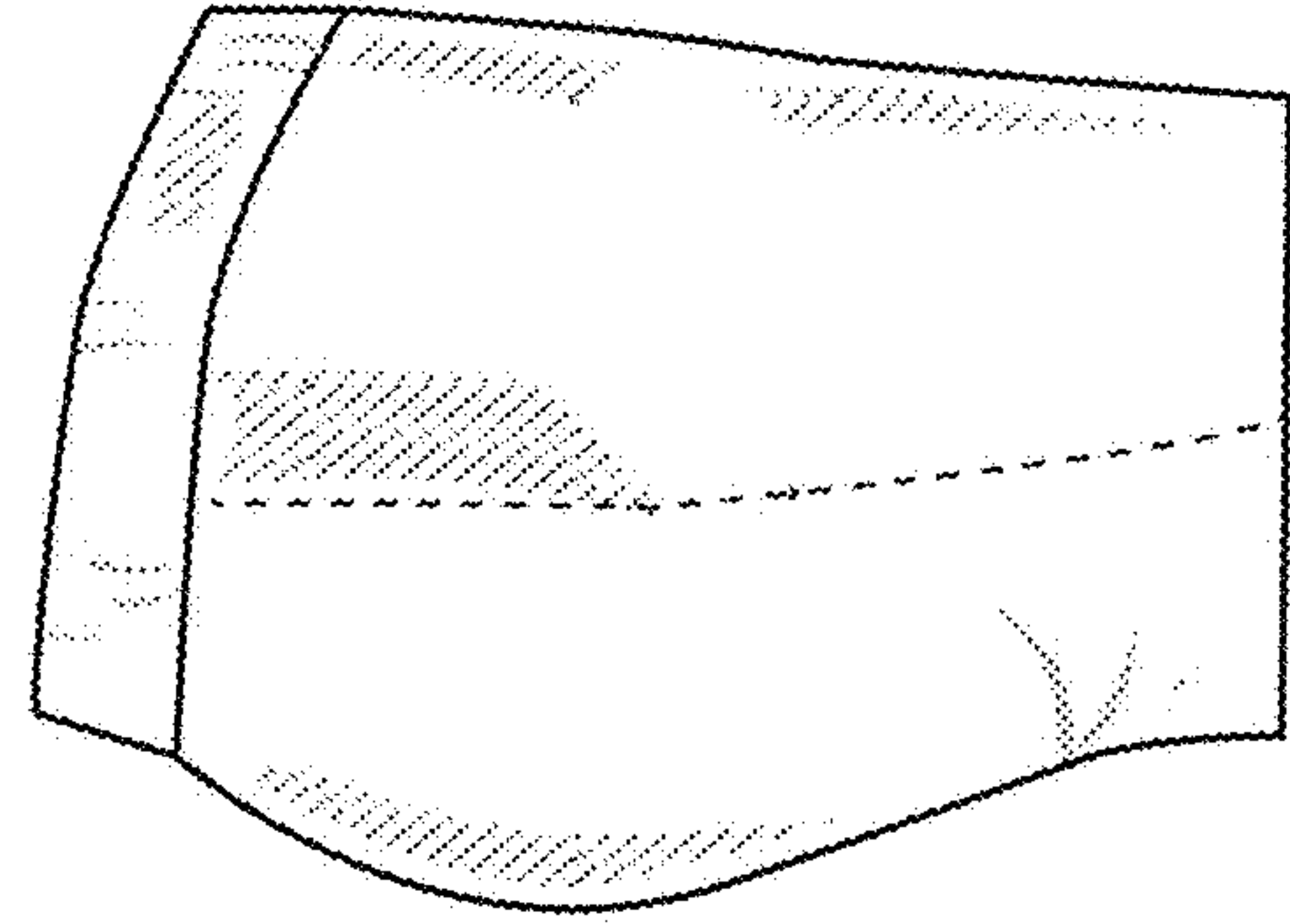

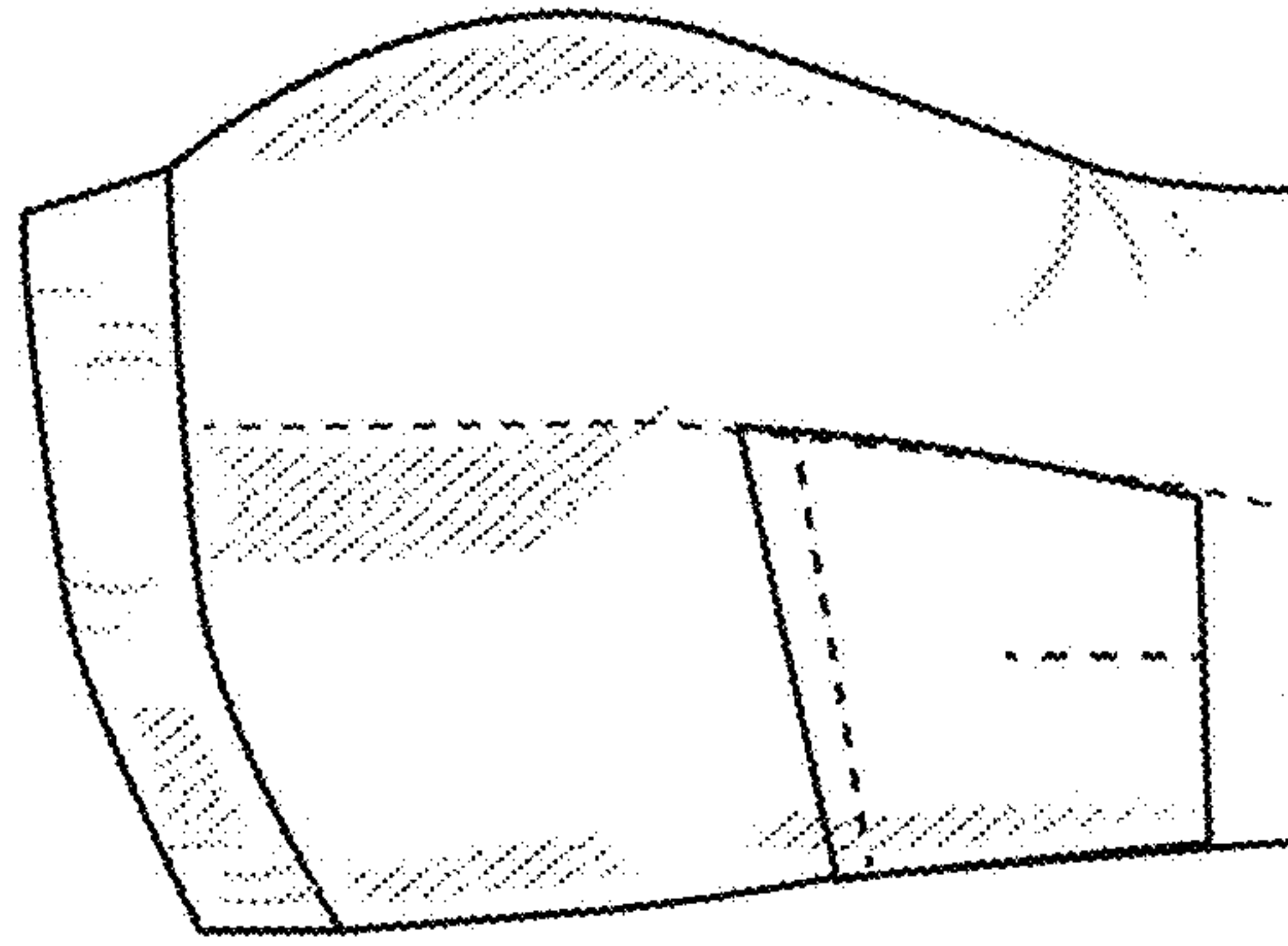

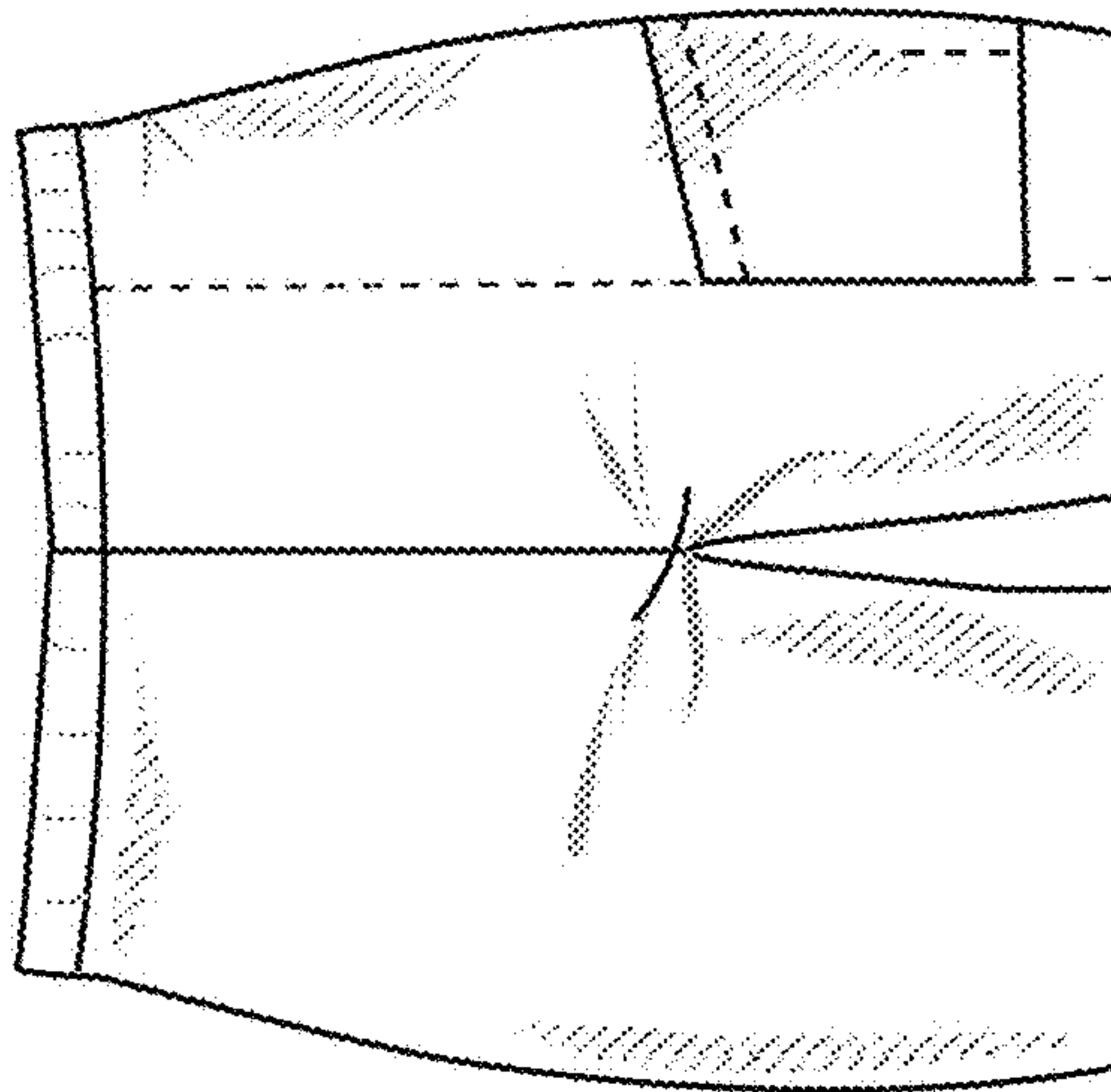
