The ornamental design for a multi-tiered V-neck maxi dress, as shown and described.

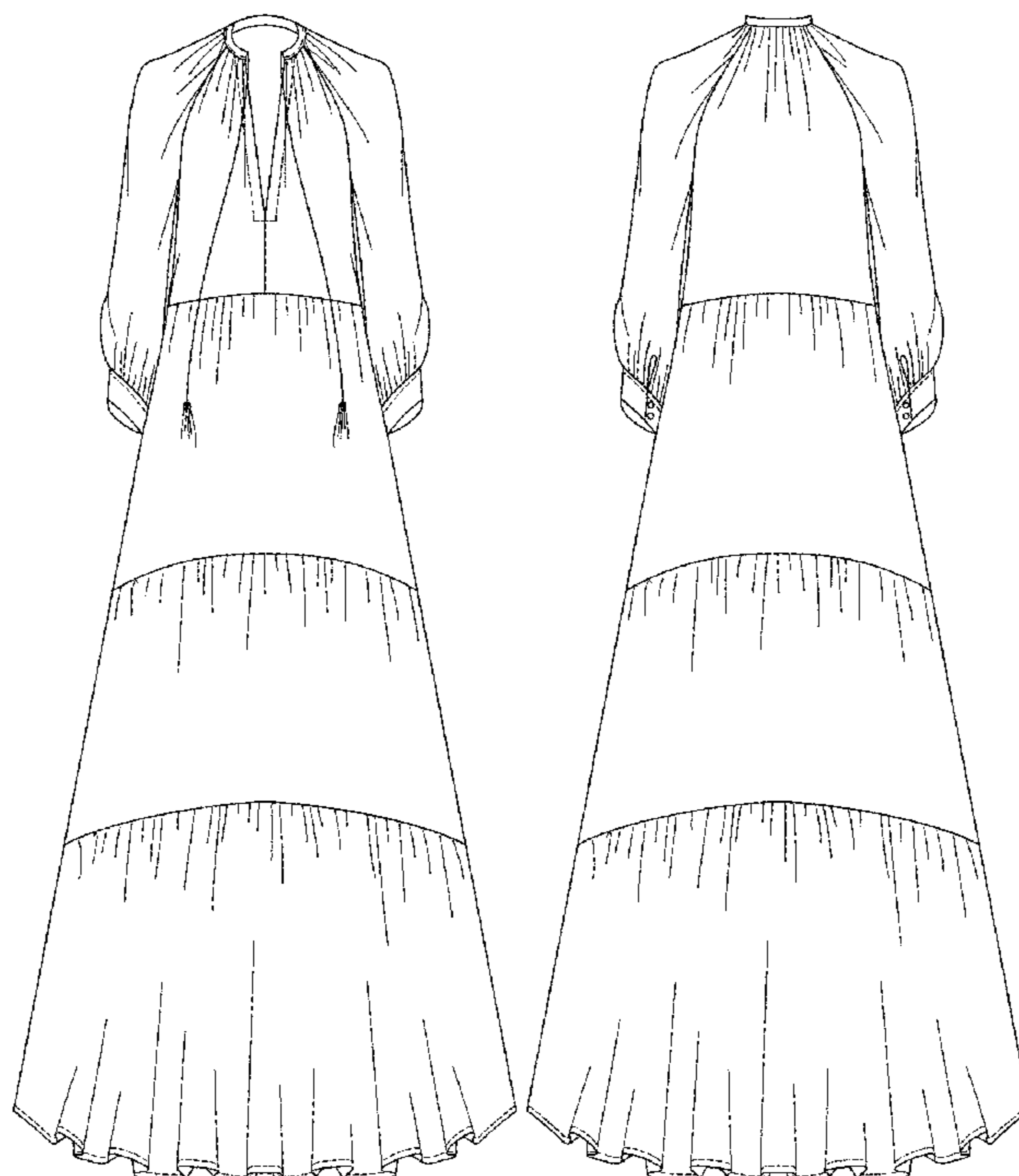
DESCRIPTION

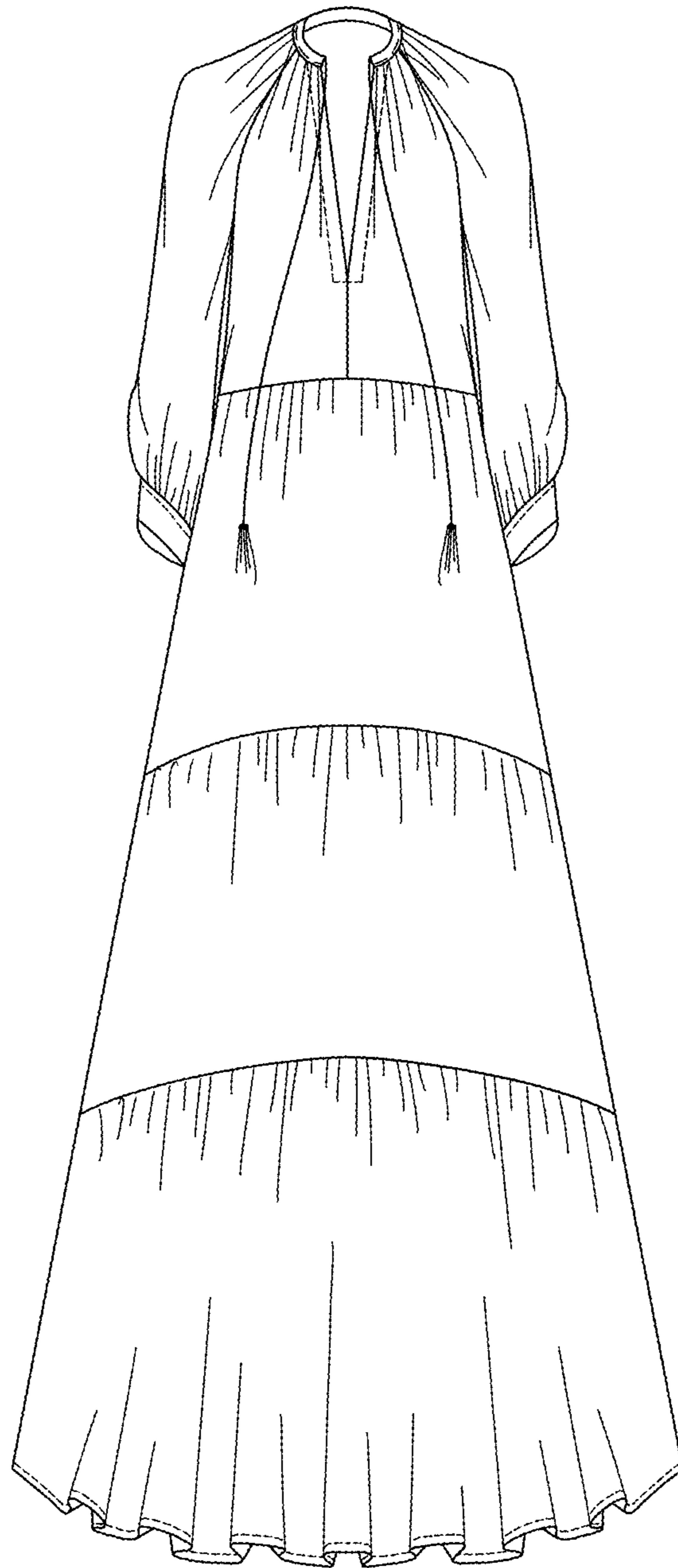

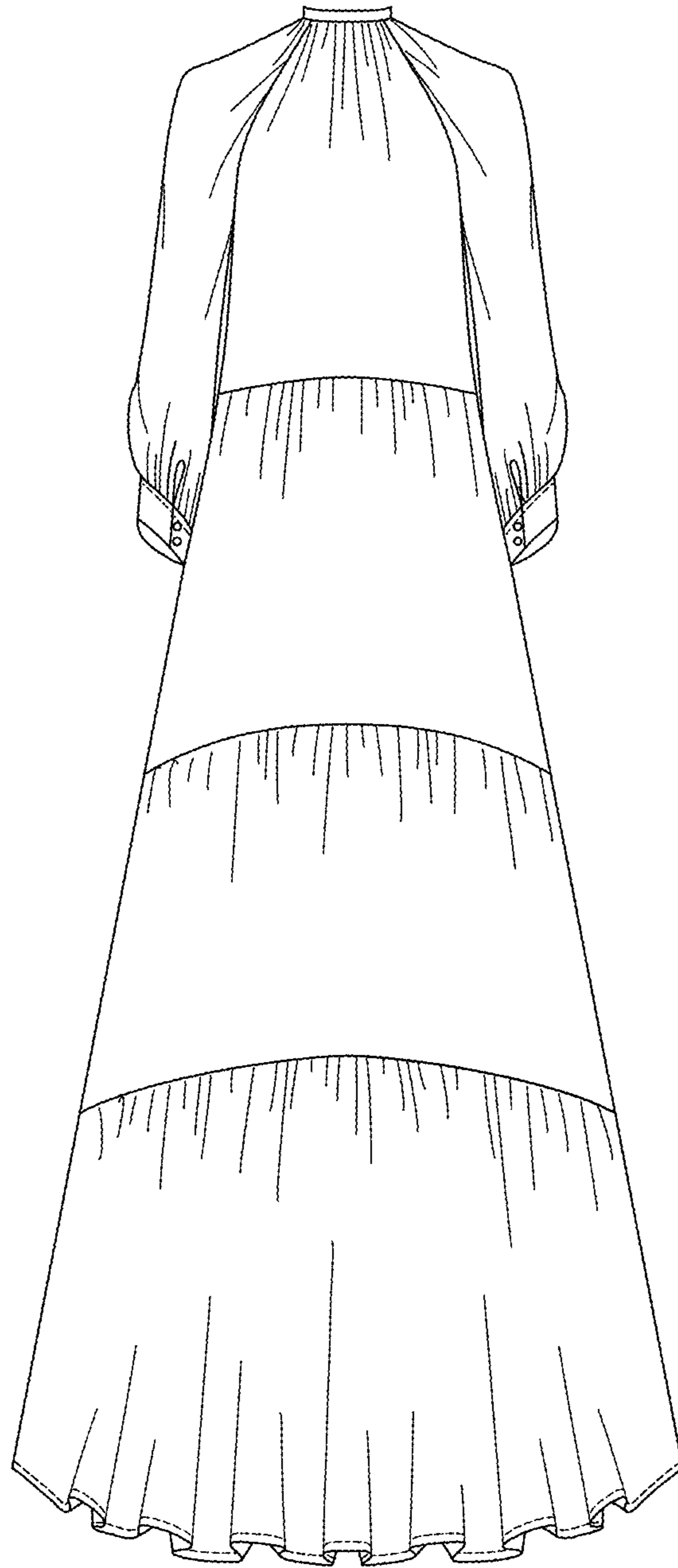
