The ornamental design of a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handbag in accordance with the present invention;
FIG. 2 is a front elevational view of the handbag of FIG. 1;
FIG. 3 is a side elevational view of a first side of the handbag of FIG. 1;
FIG. 4 is a top plan view of the handbag of FIG. 1;
FIG. 5 is a side elevational view of a second side of the handbag of FIG. 1;
FIG. 6 is a bottom plan view of the handbag of FIG. 1; and,
FIG. 7 is a rear elevational view of the handbag of FIG. 1.

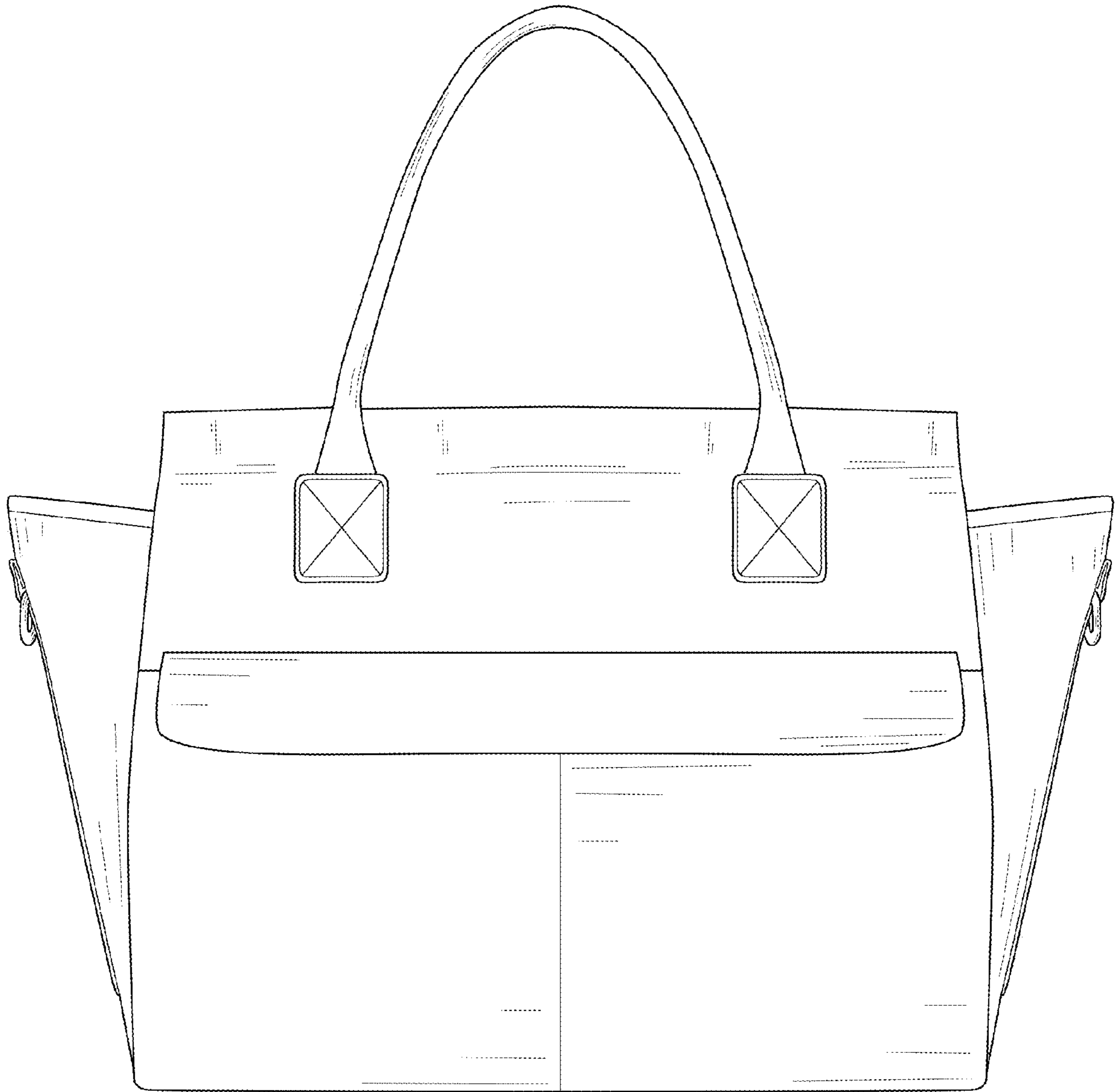

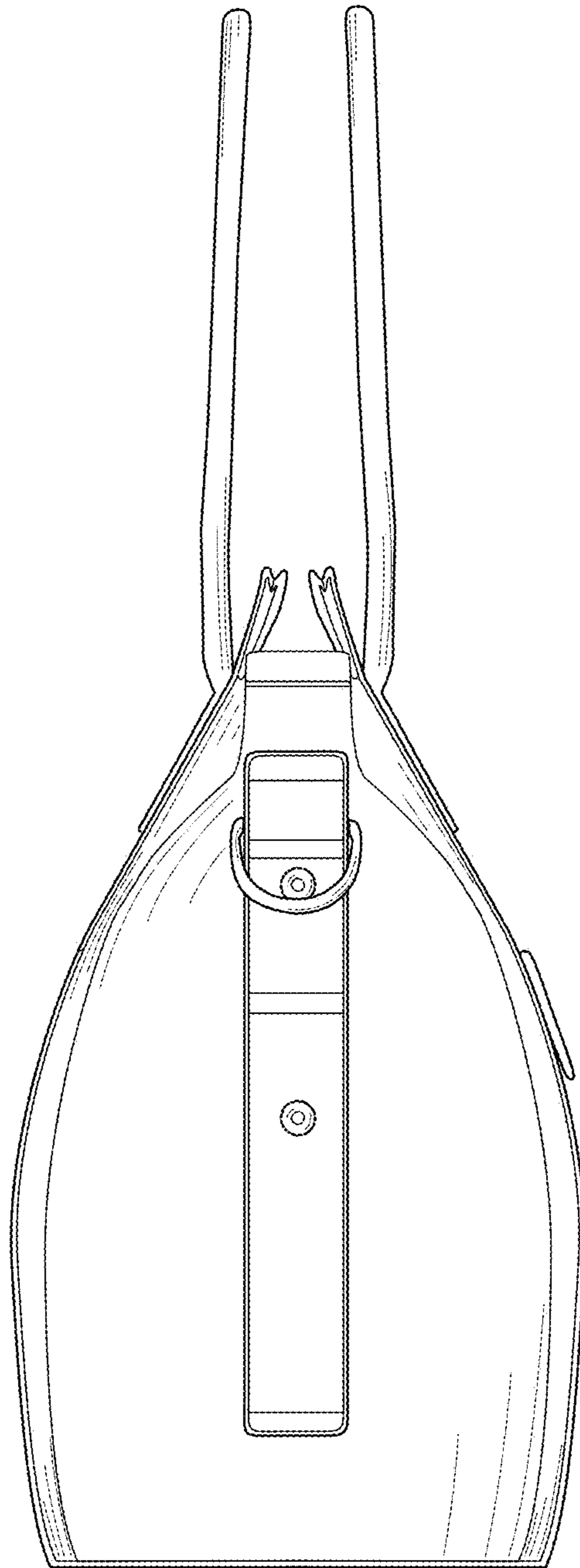

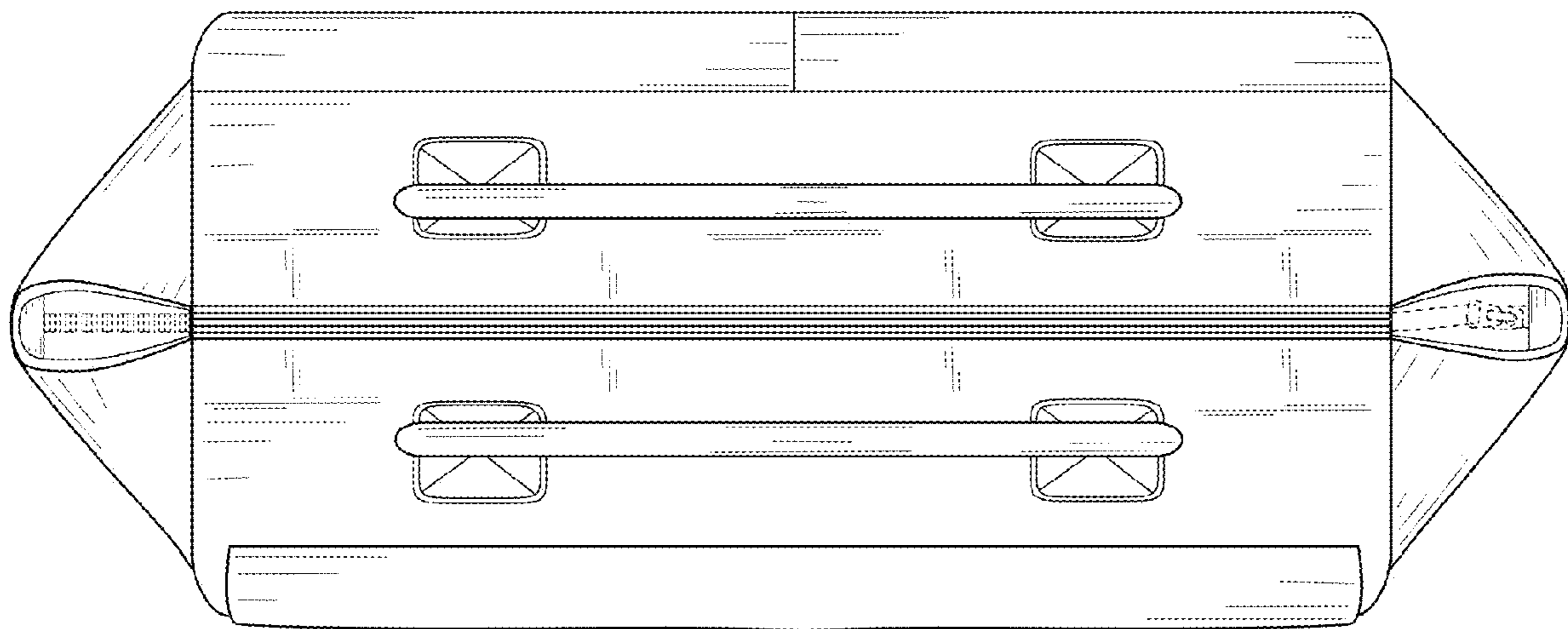

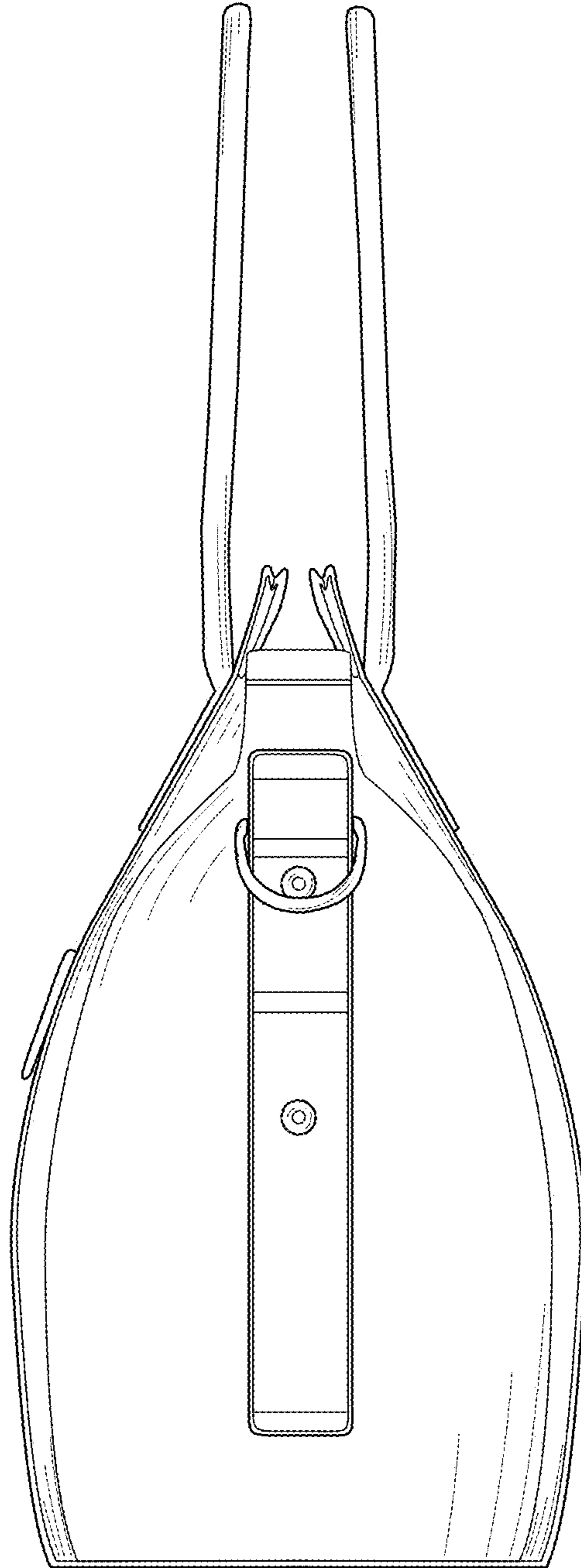

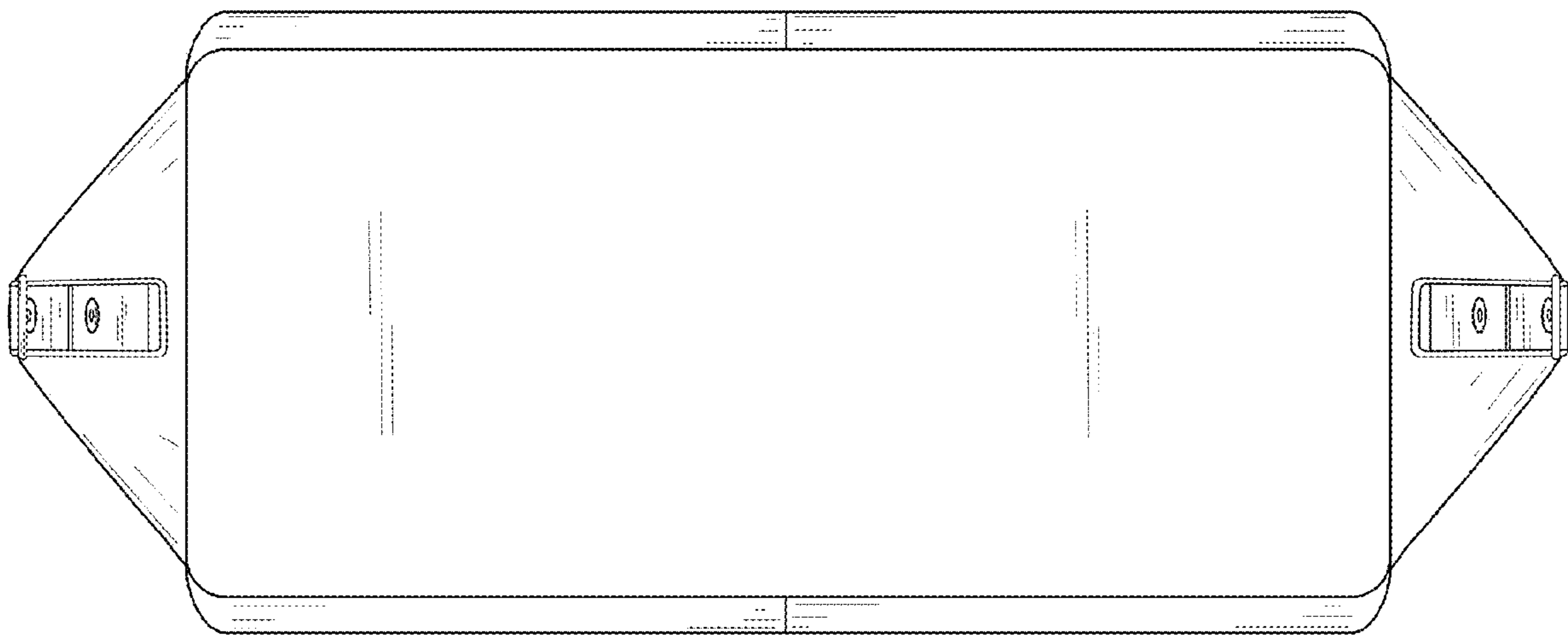

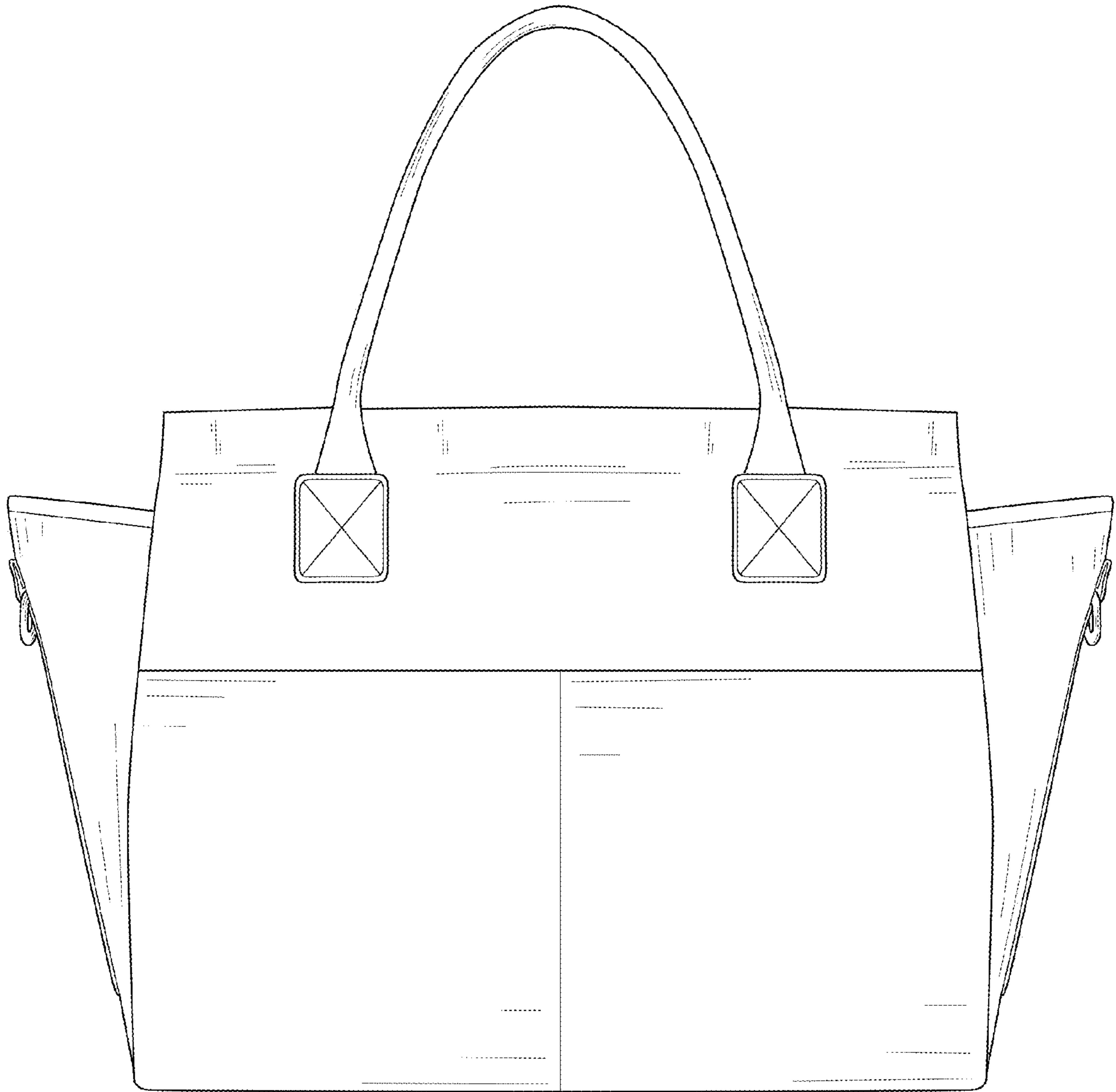
