The broken lines in the figures depict portions of the lounge chair that form no part of the claimed design.

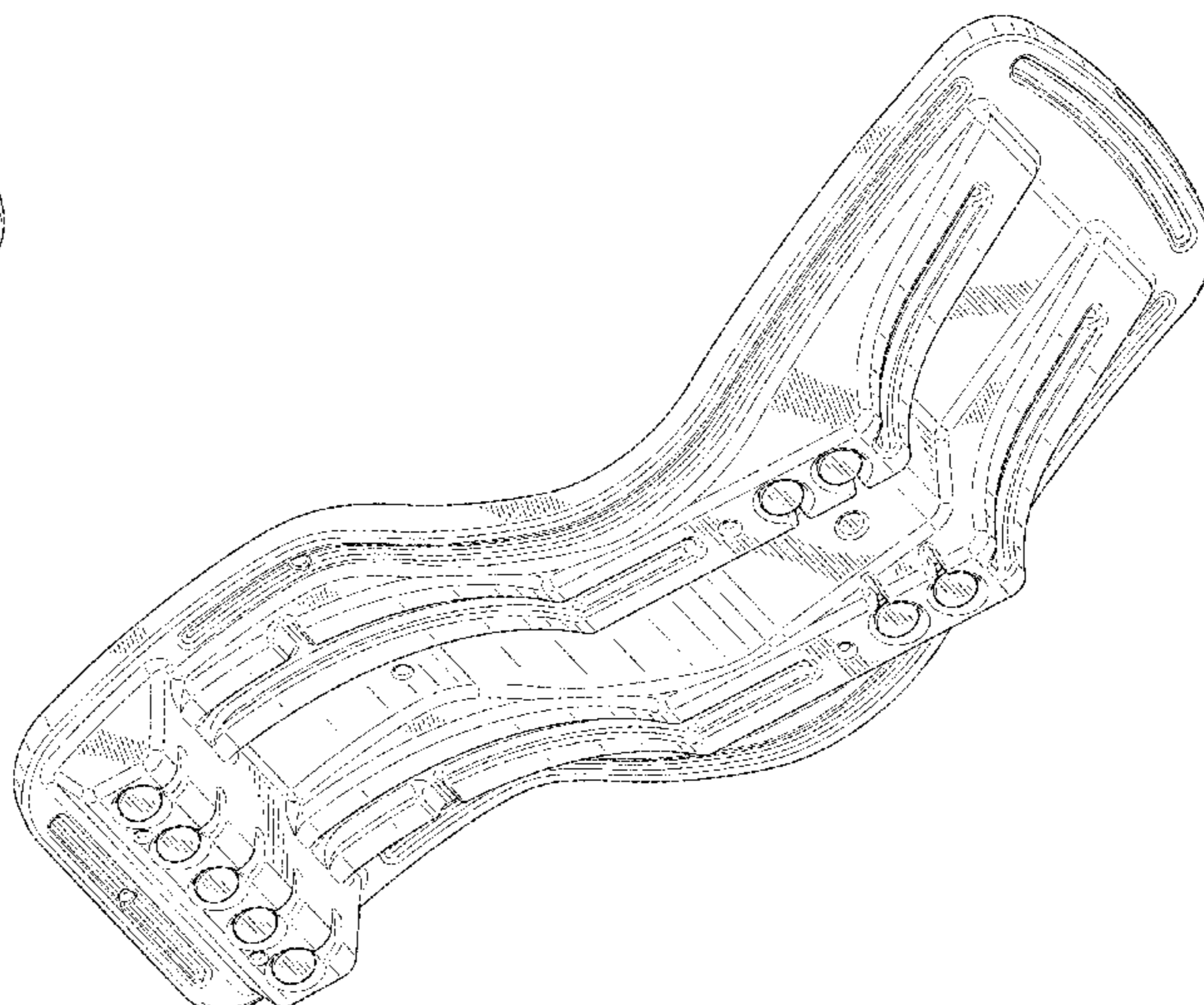
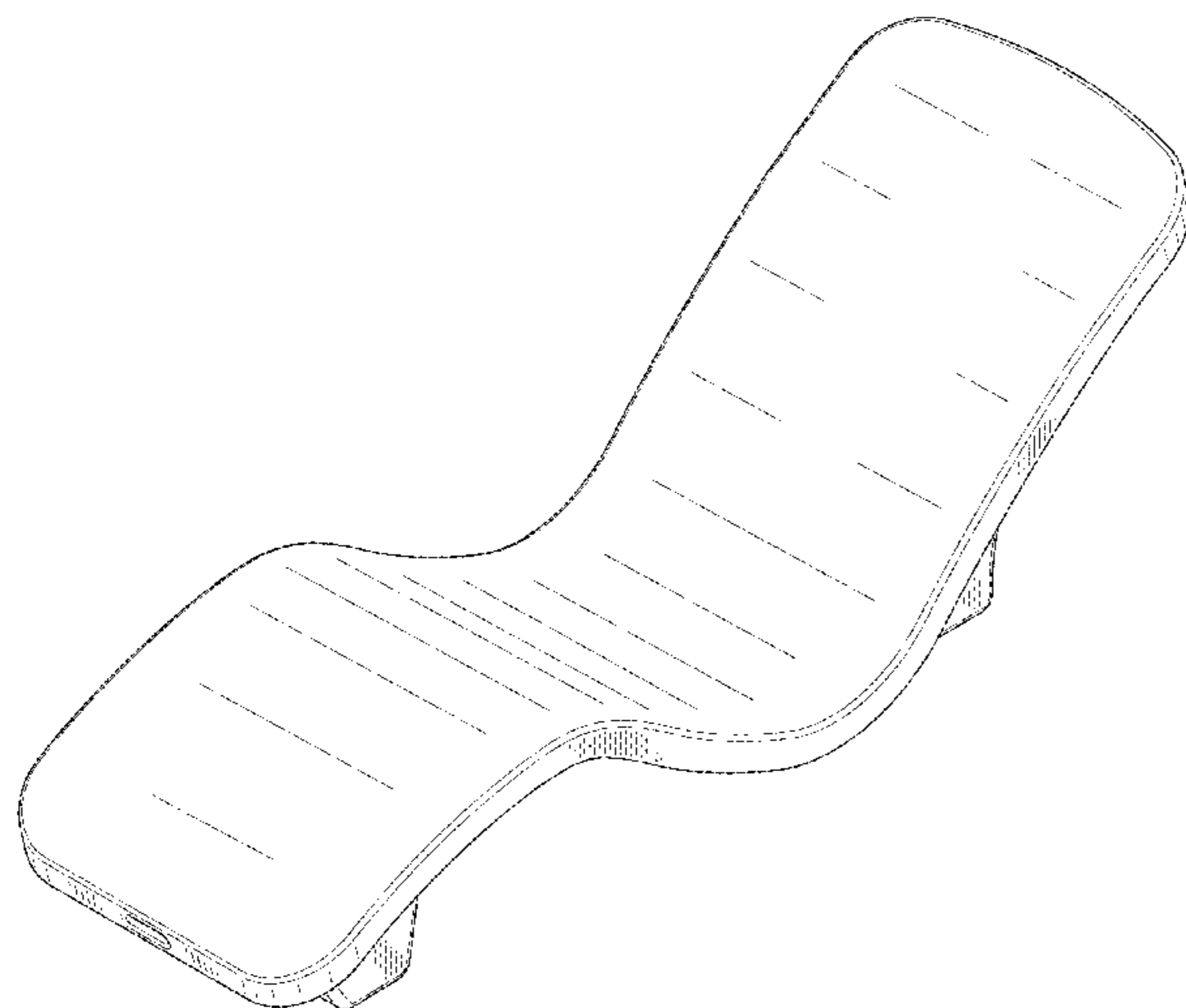

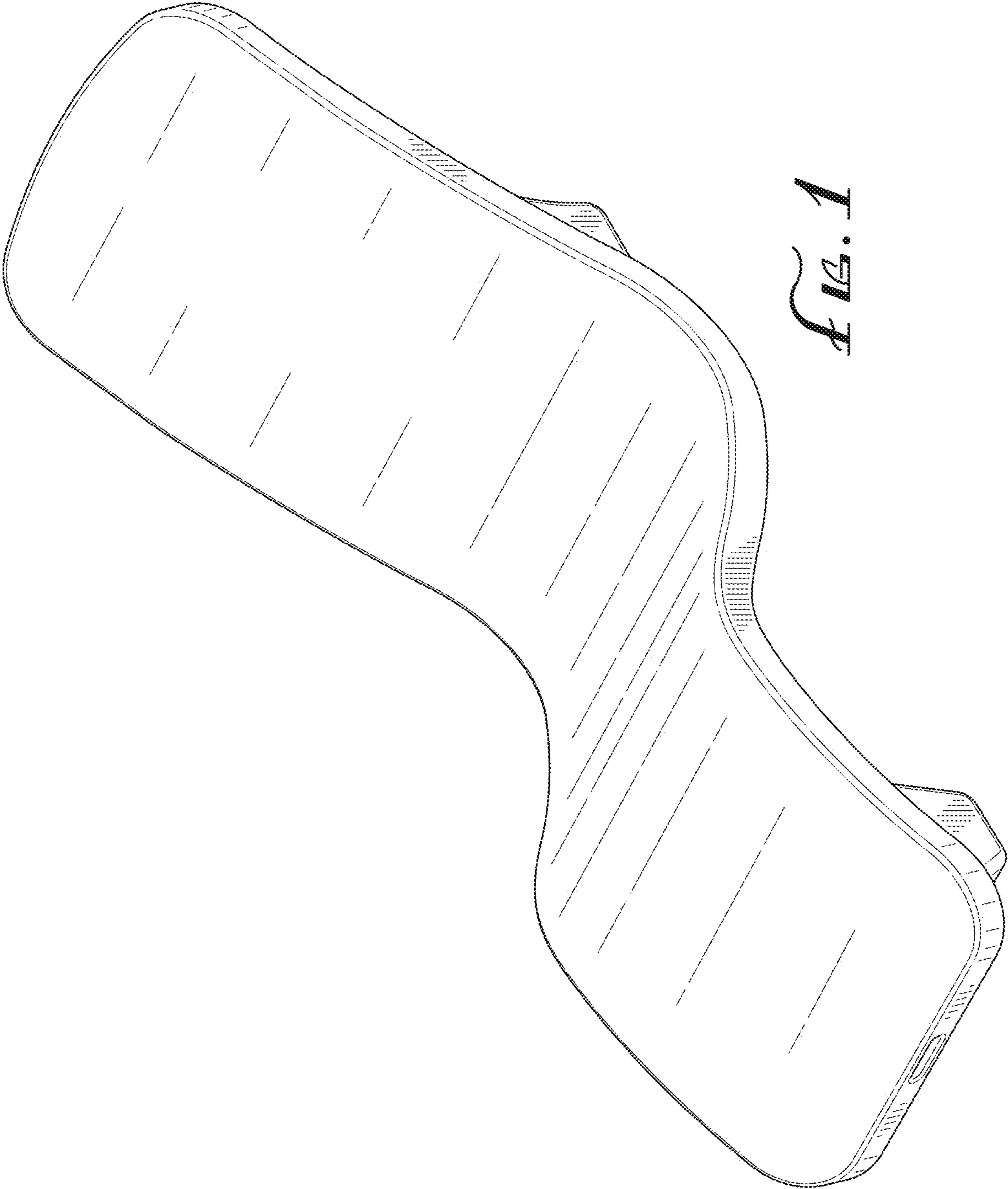

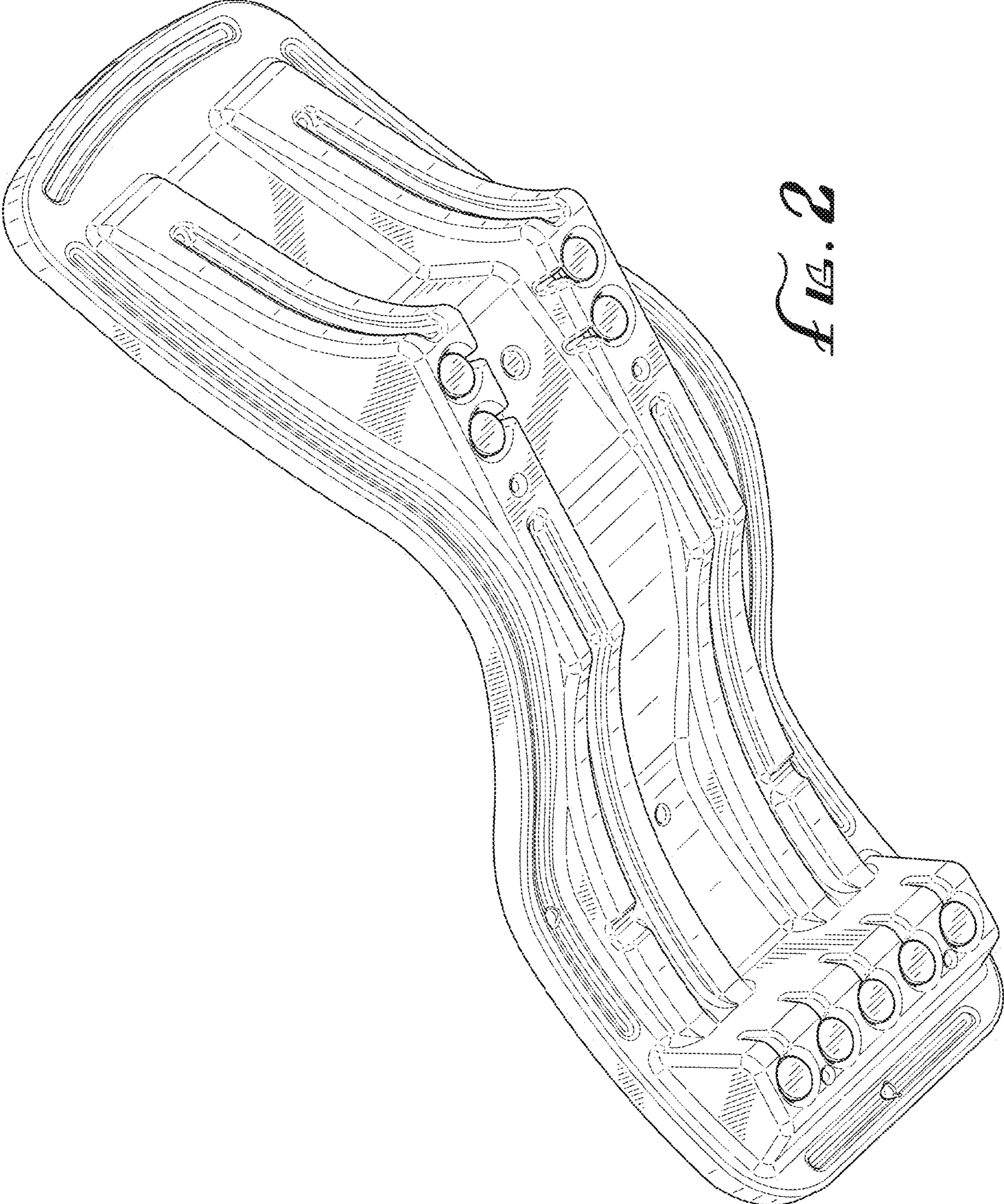

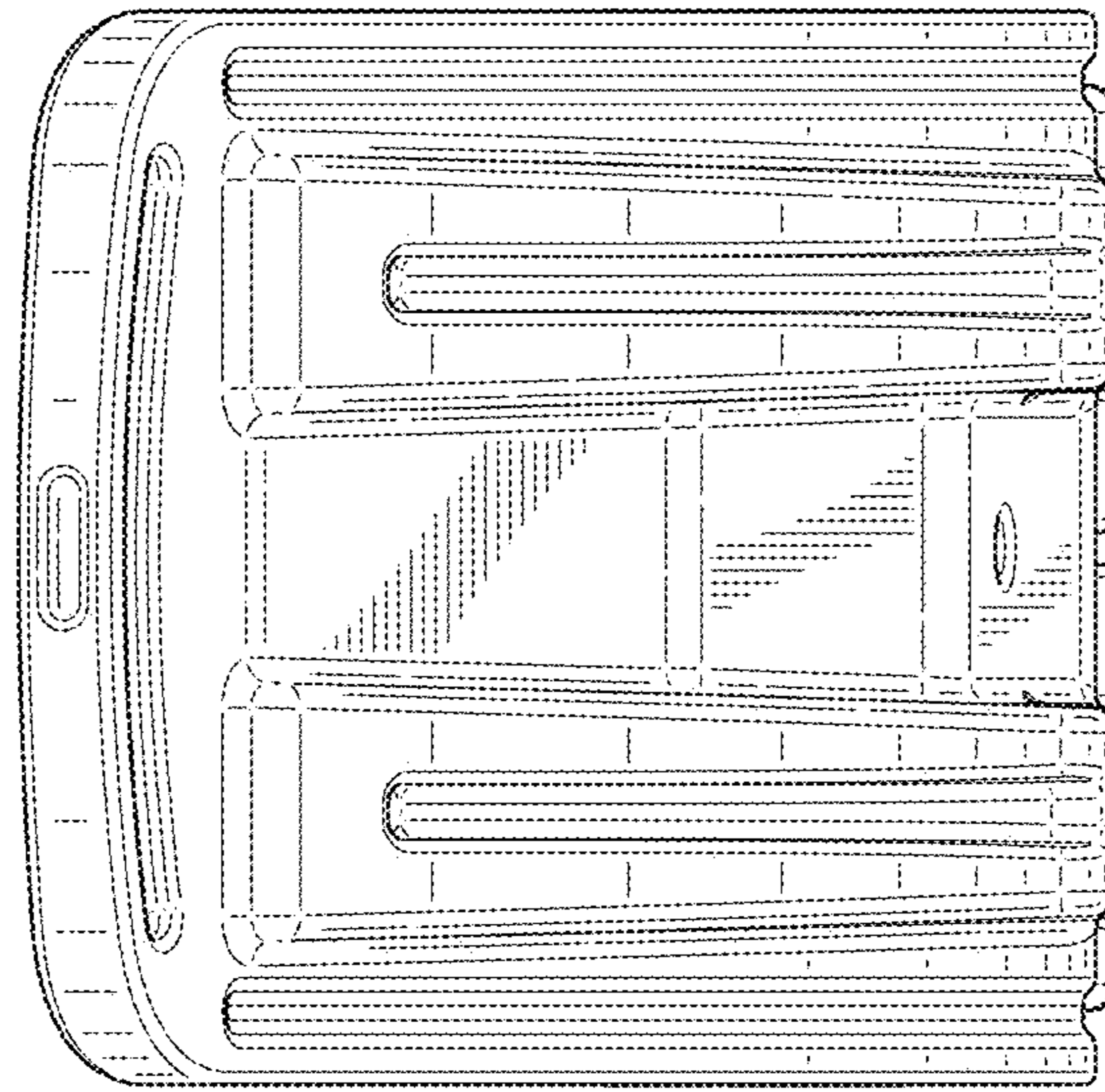

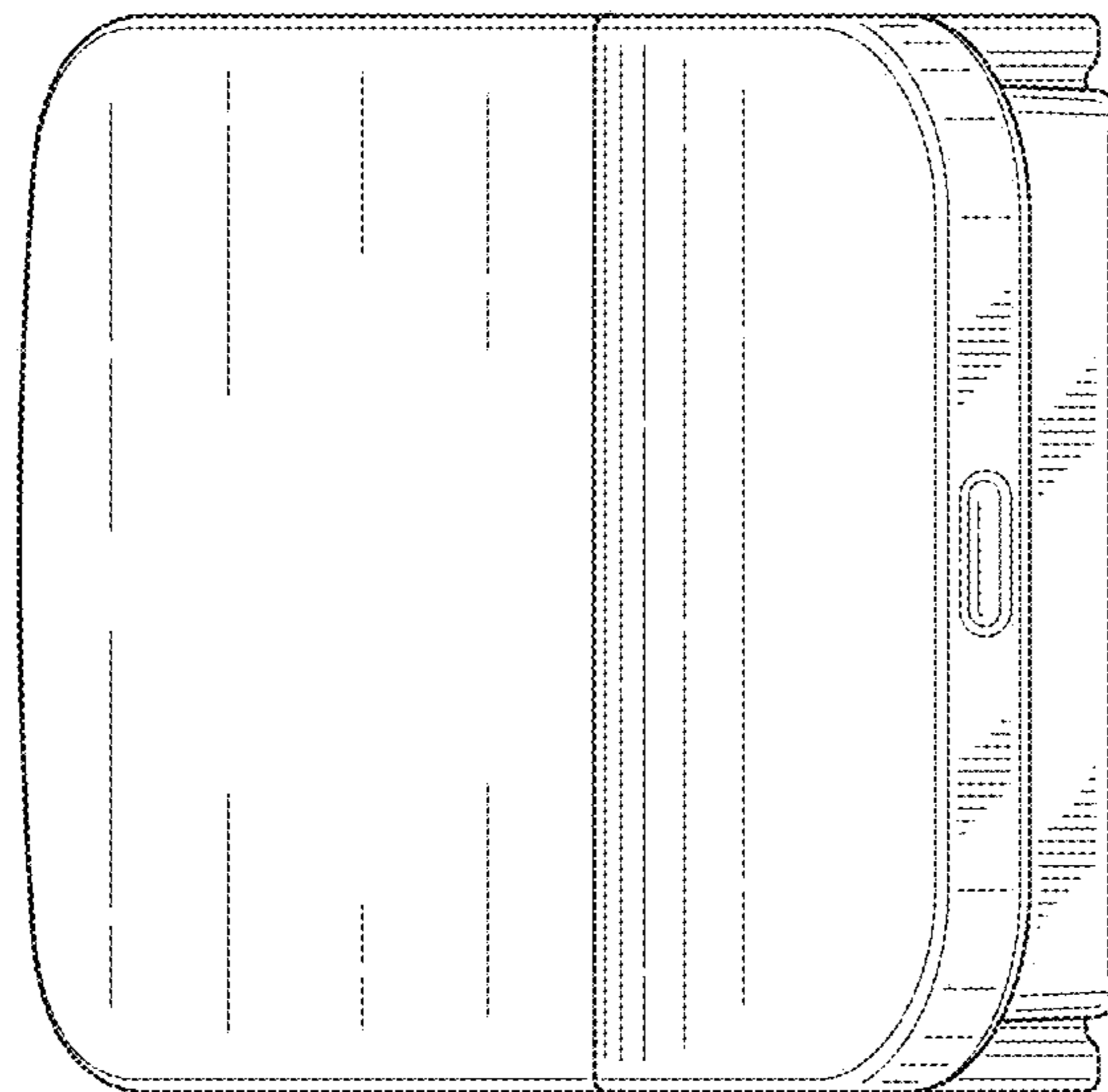

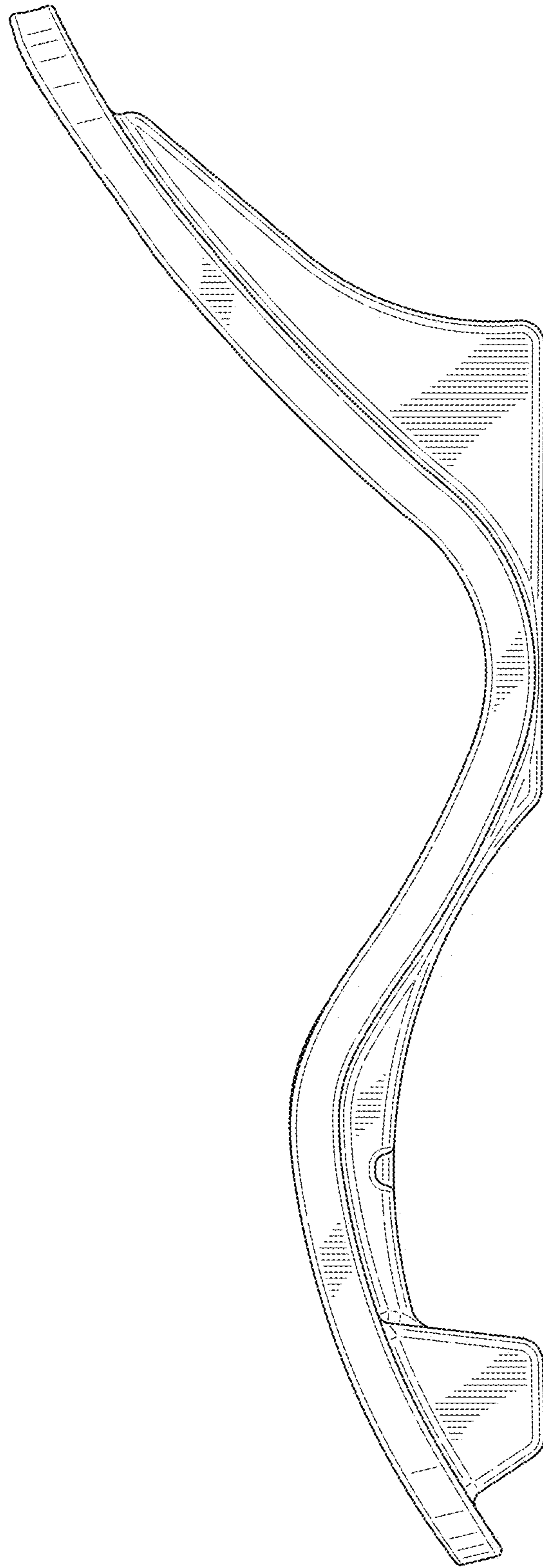

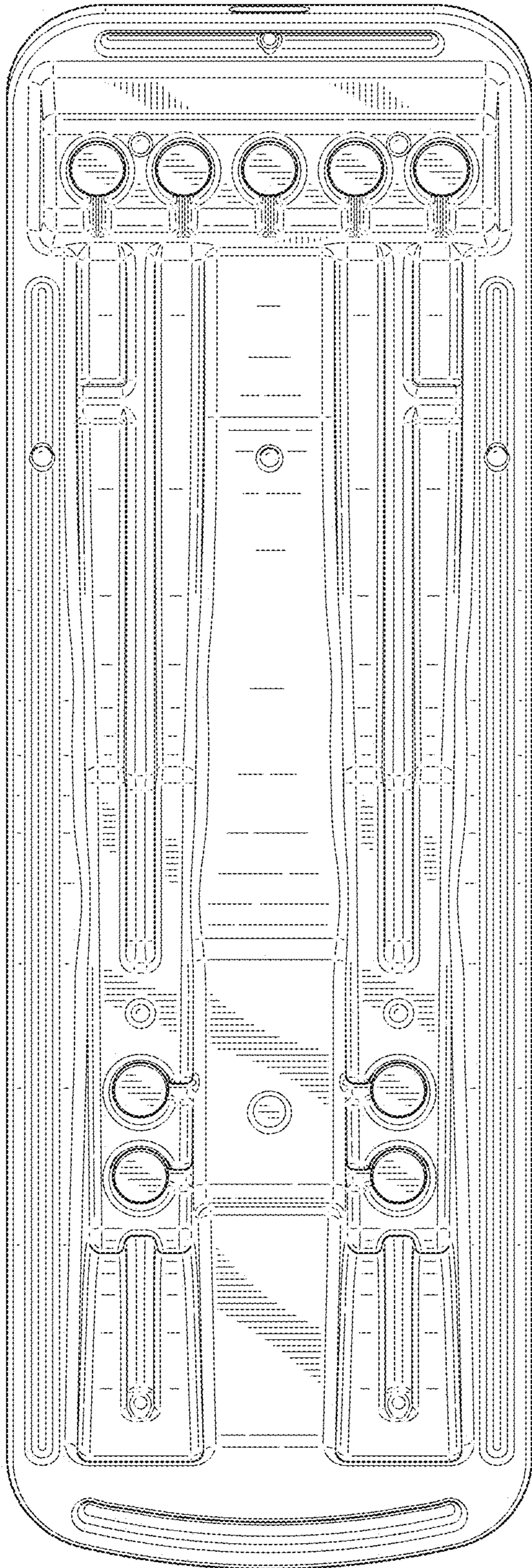

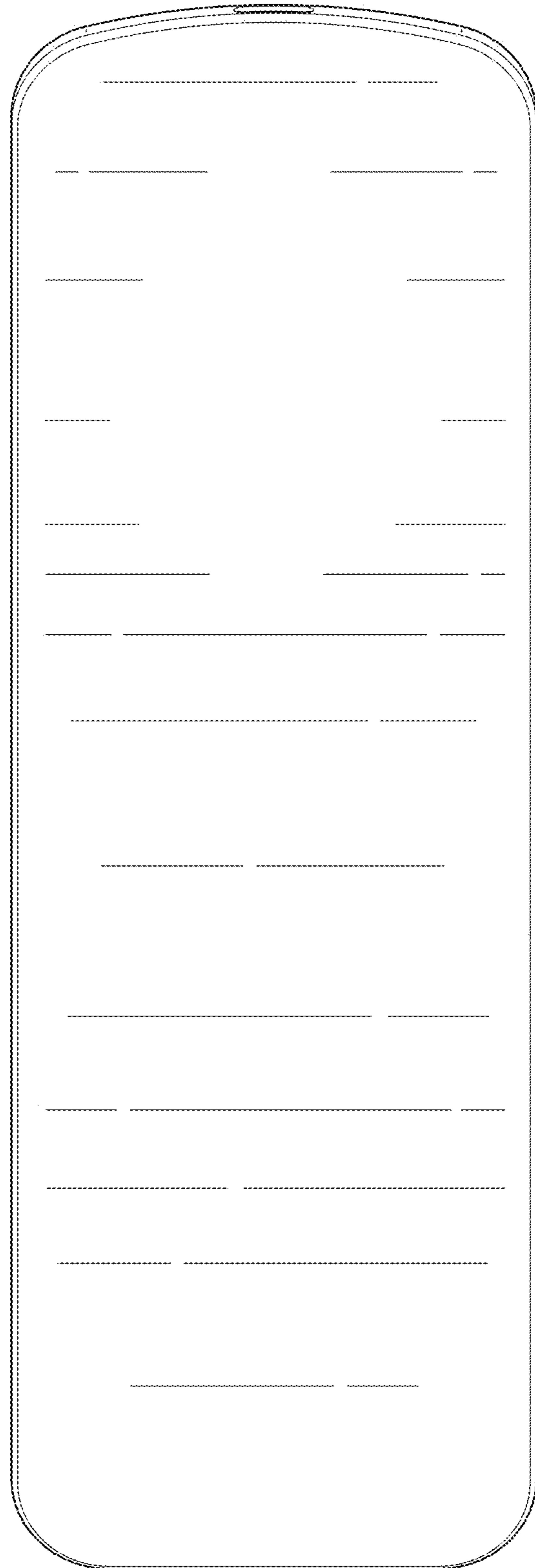

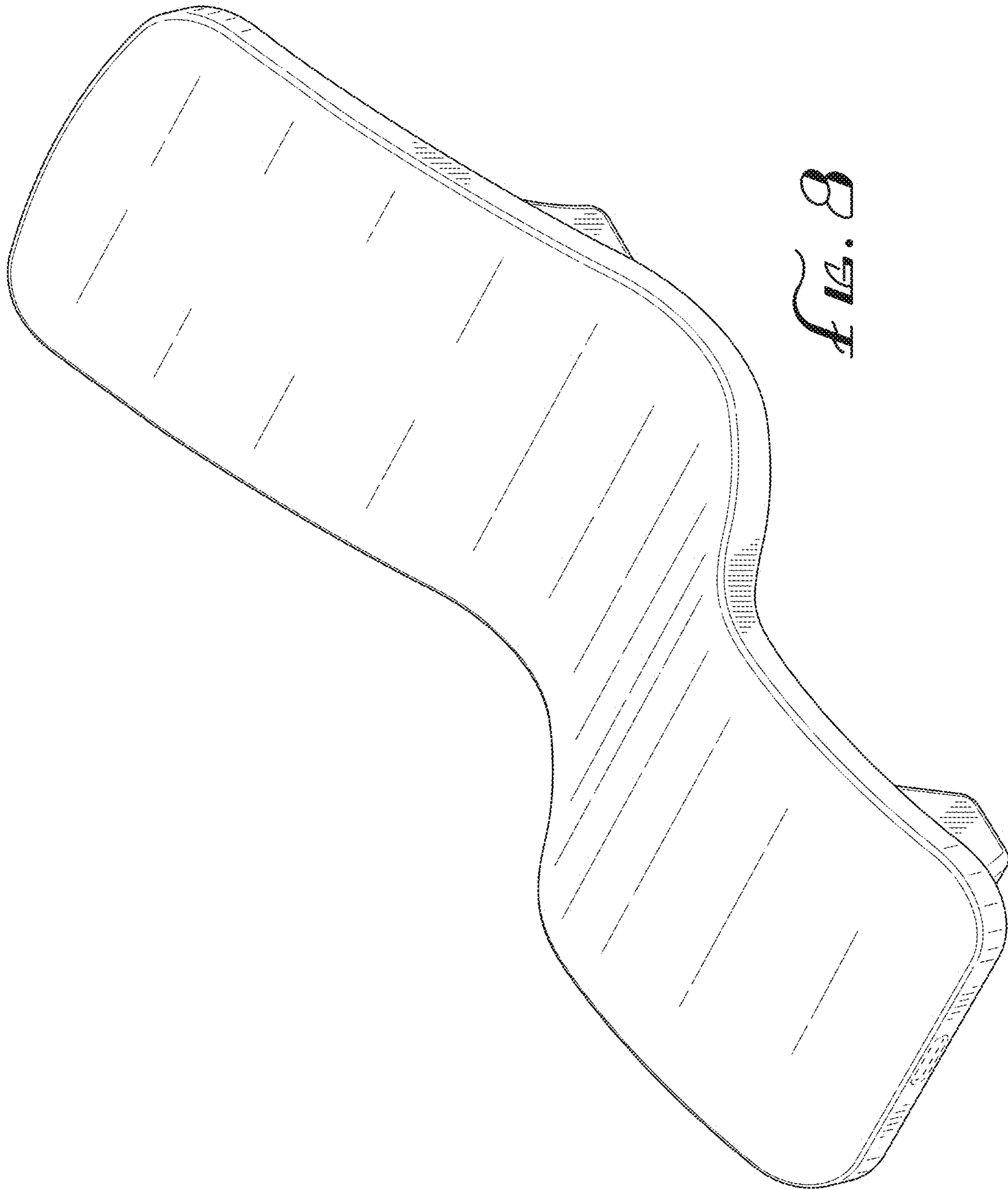

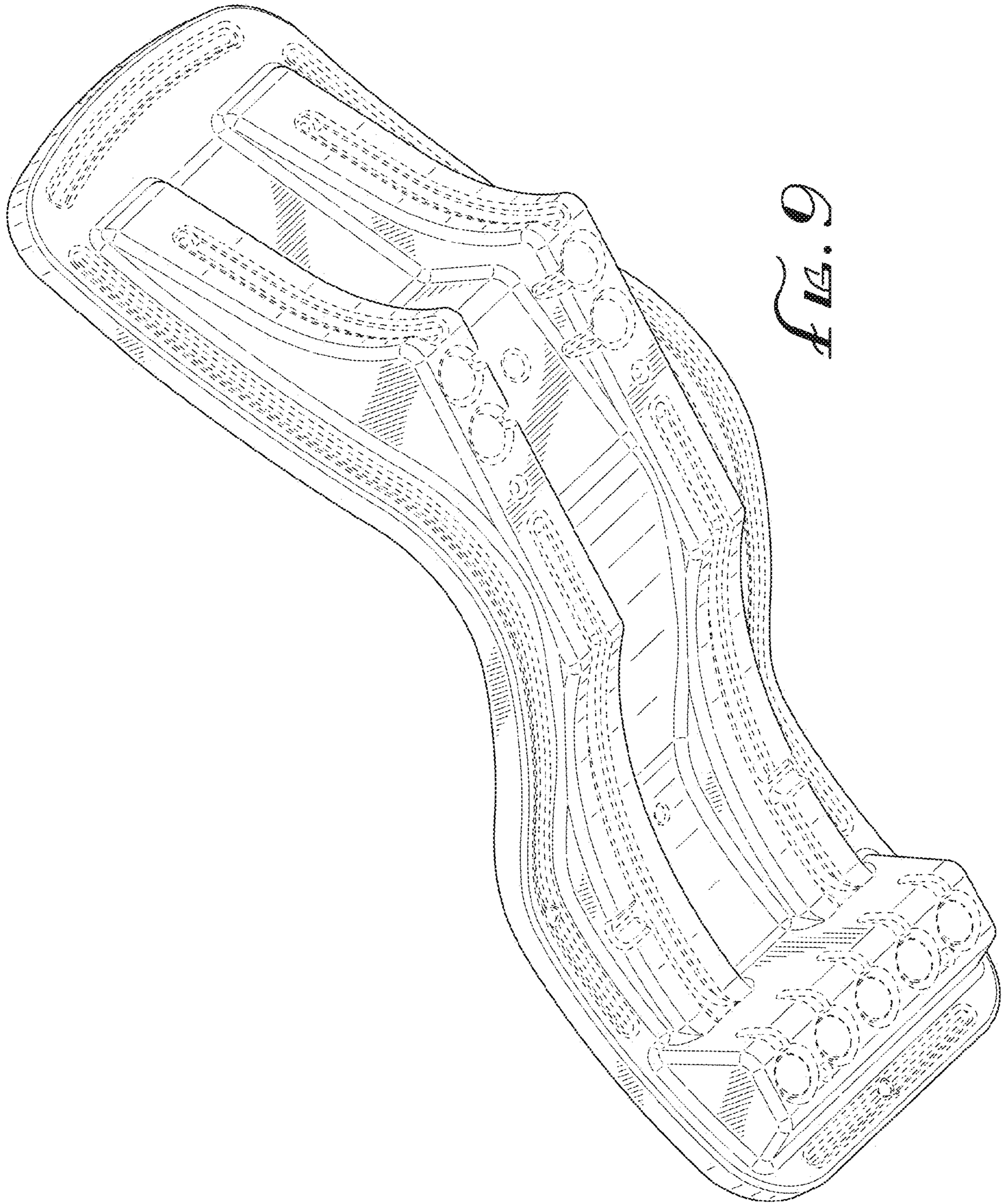

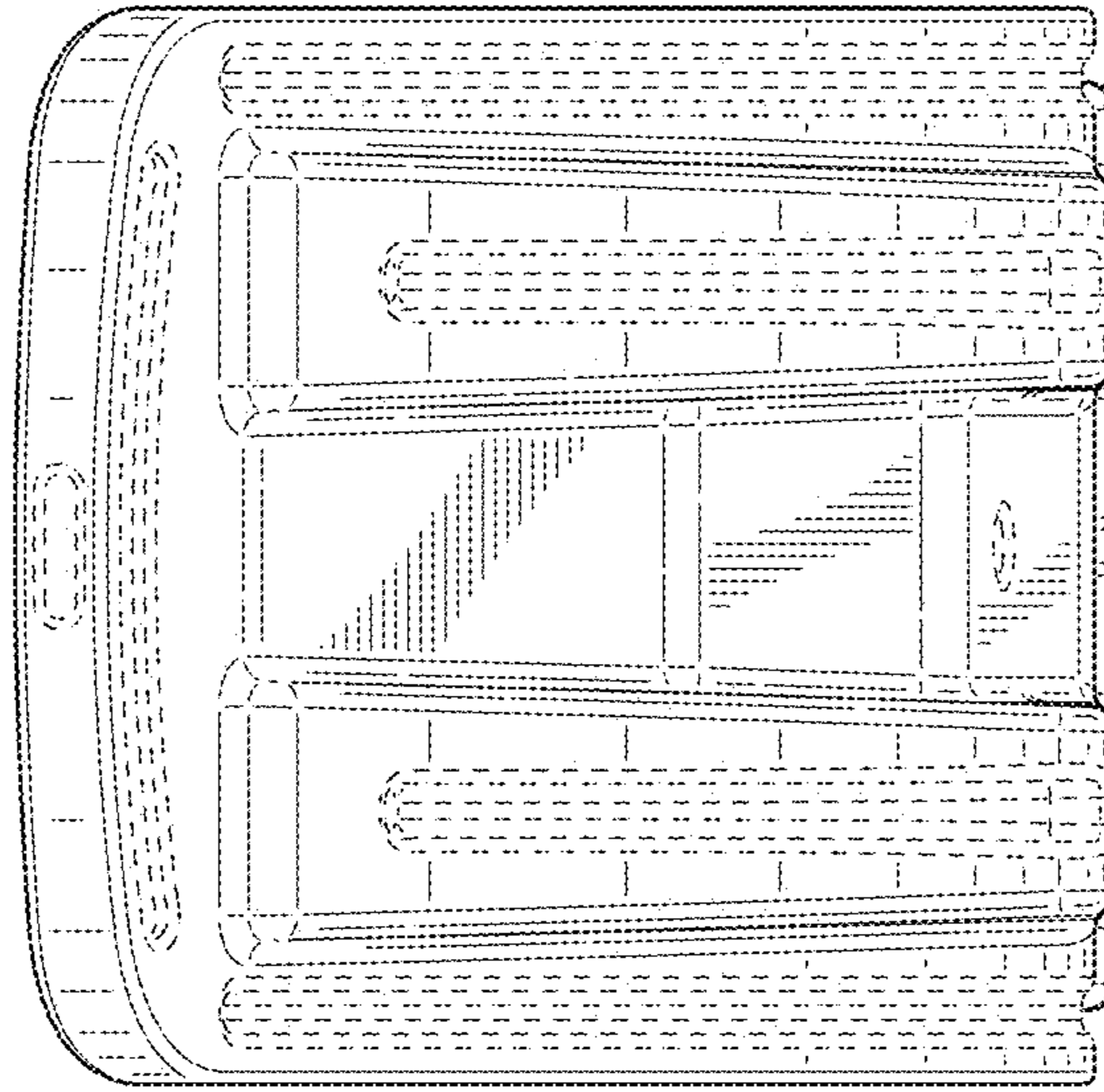

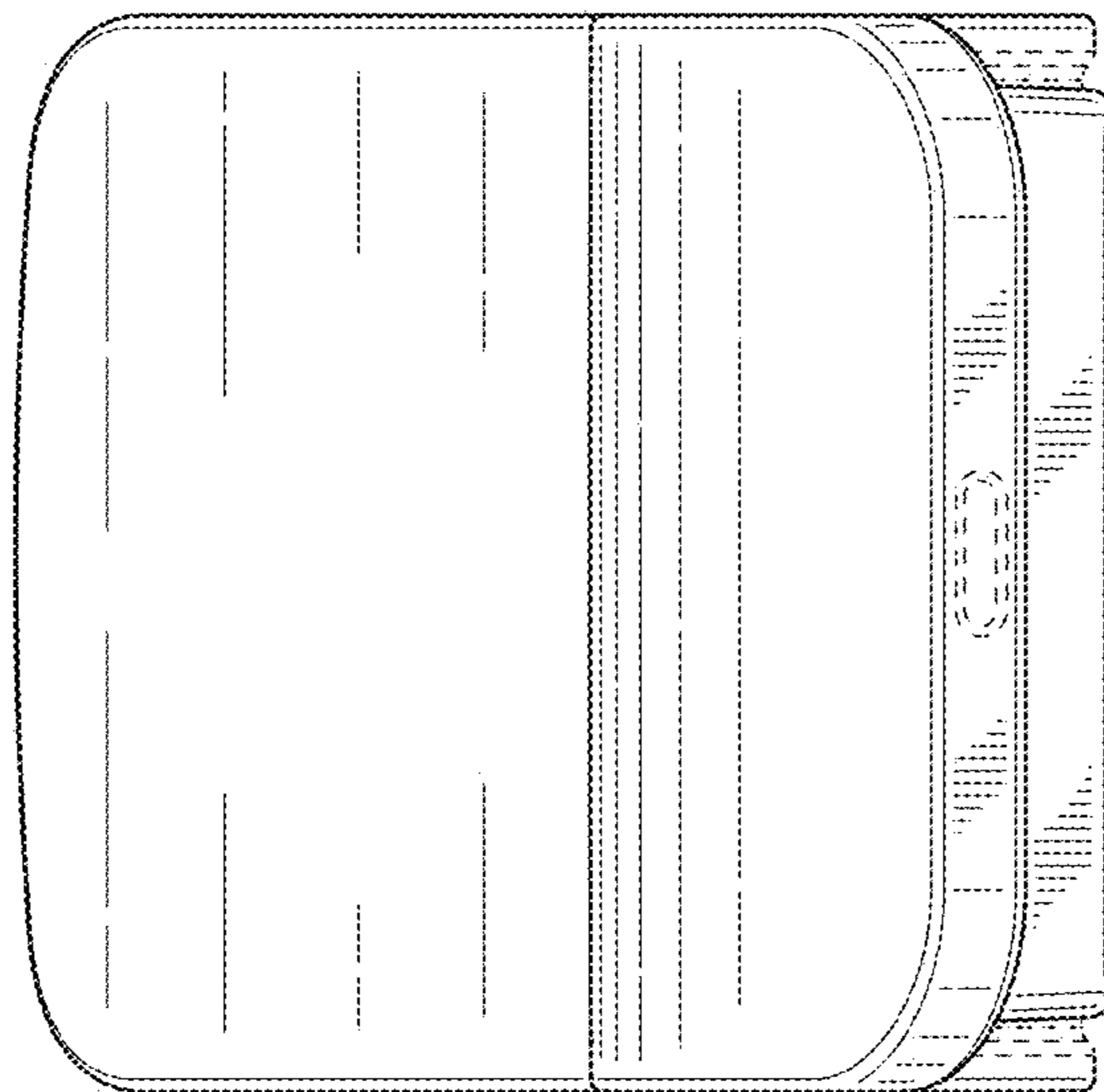

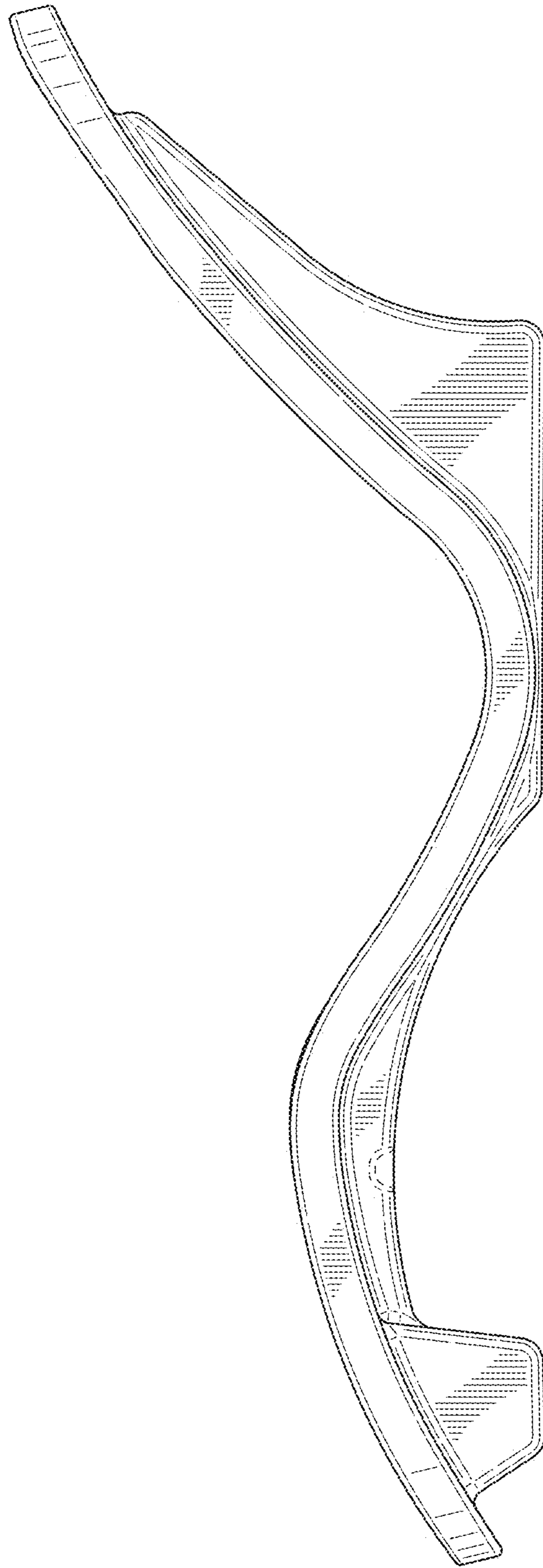

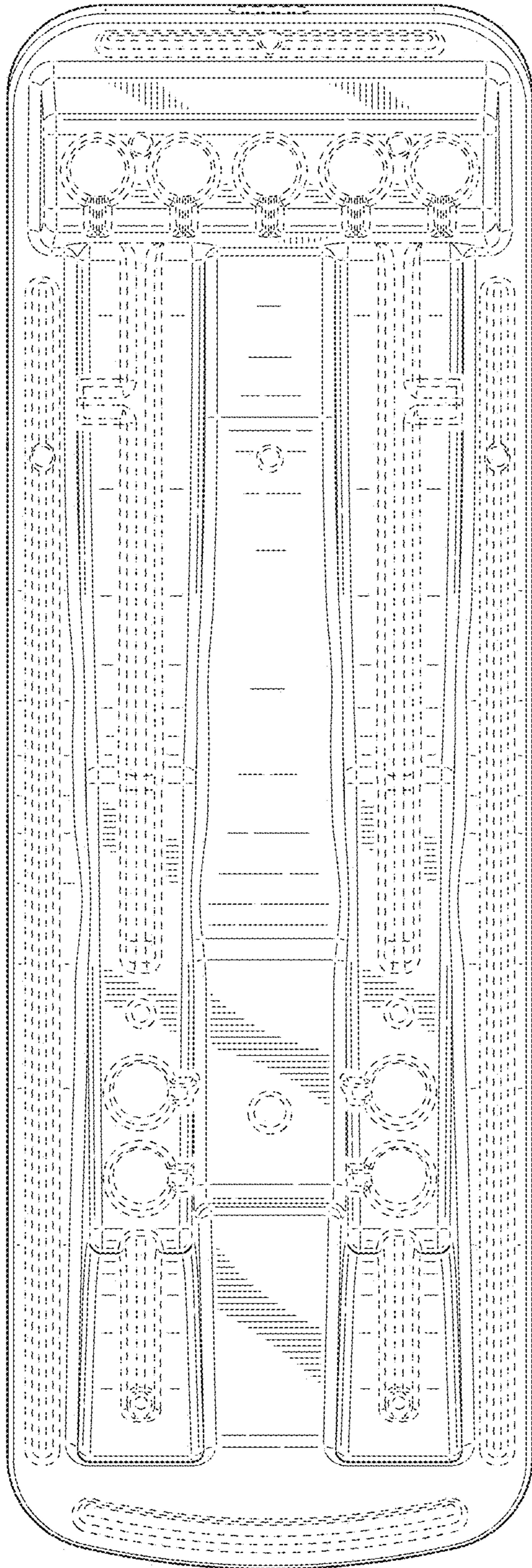

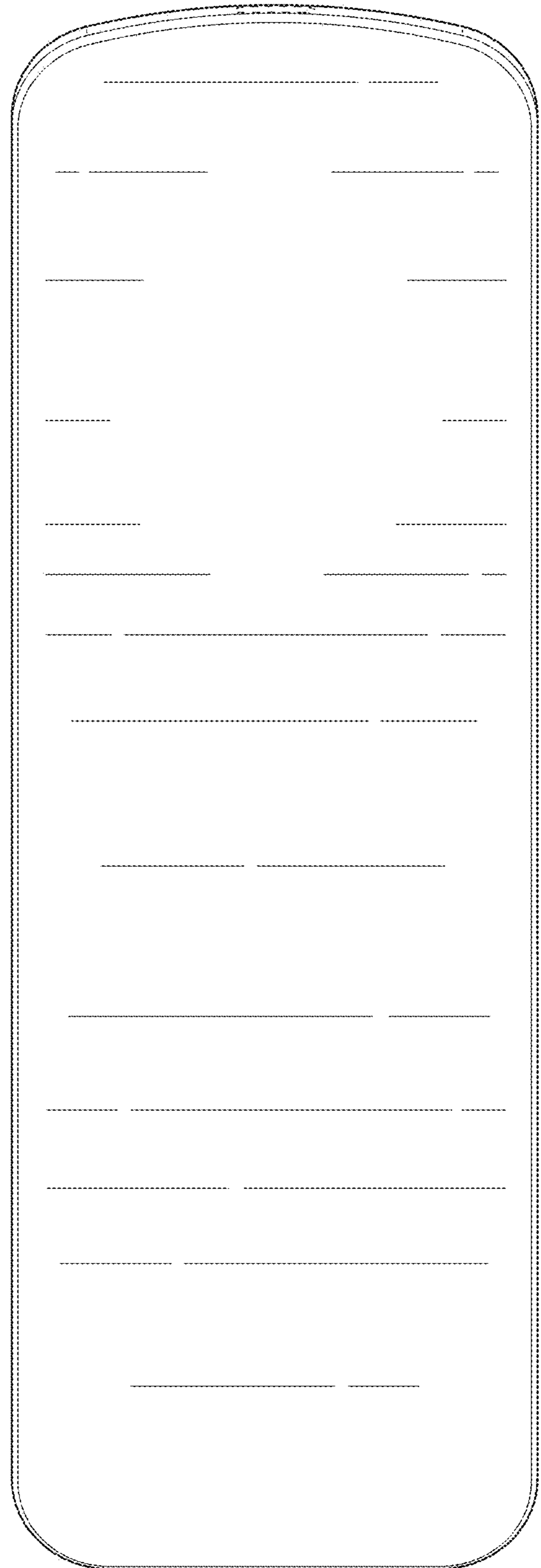
