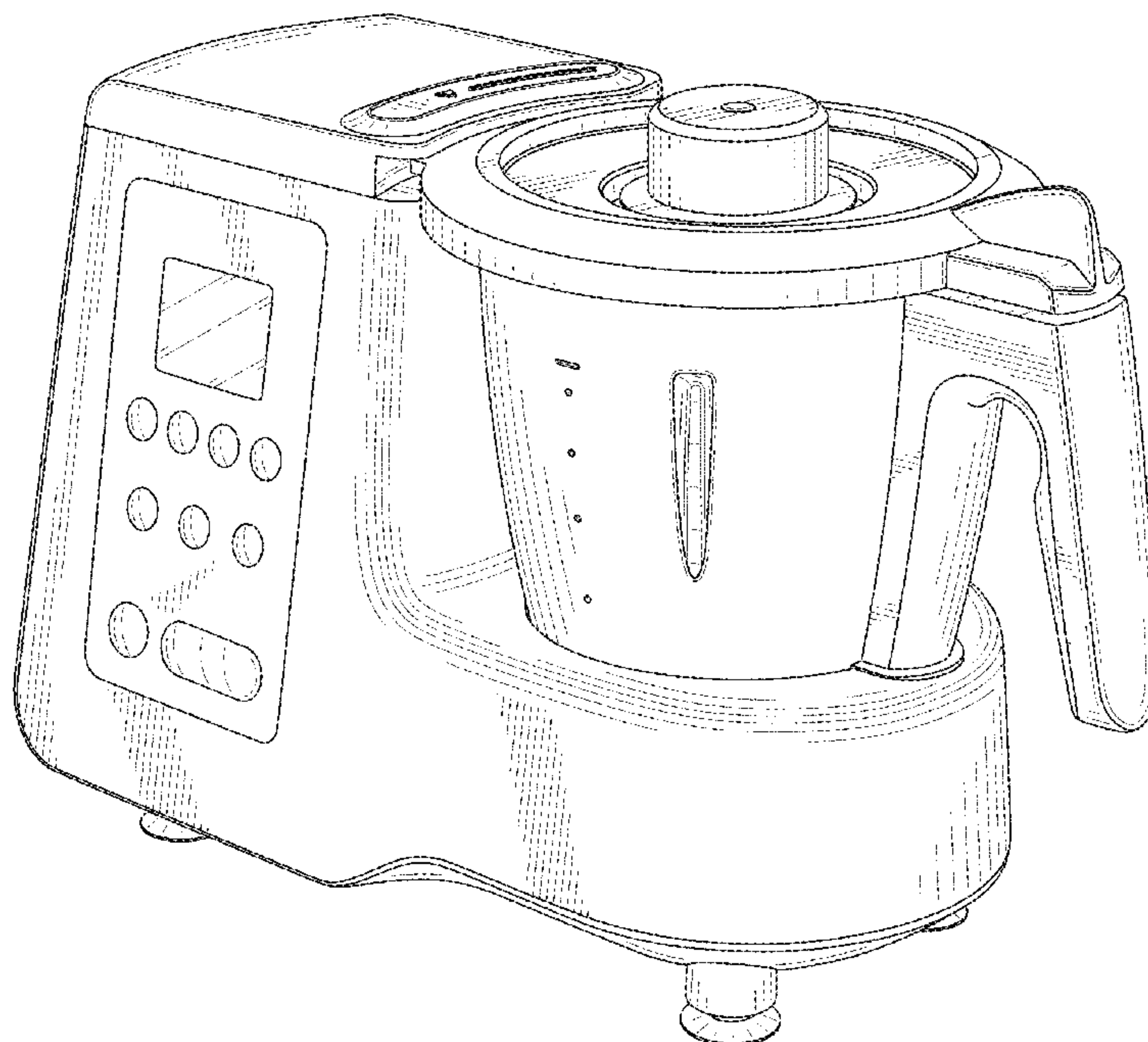
The ornamental design for a food processor, as shown and described.

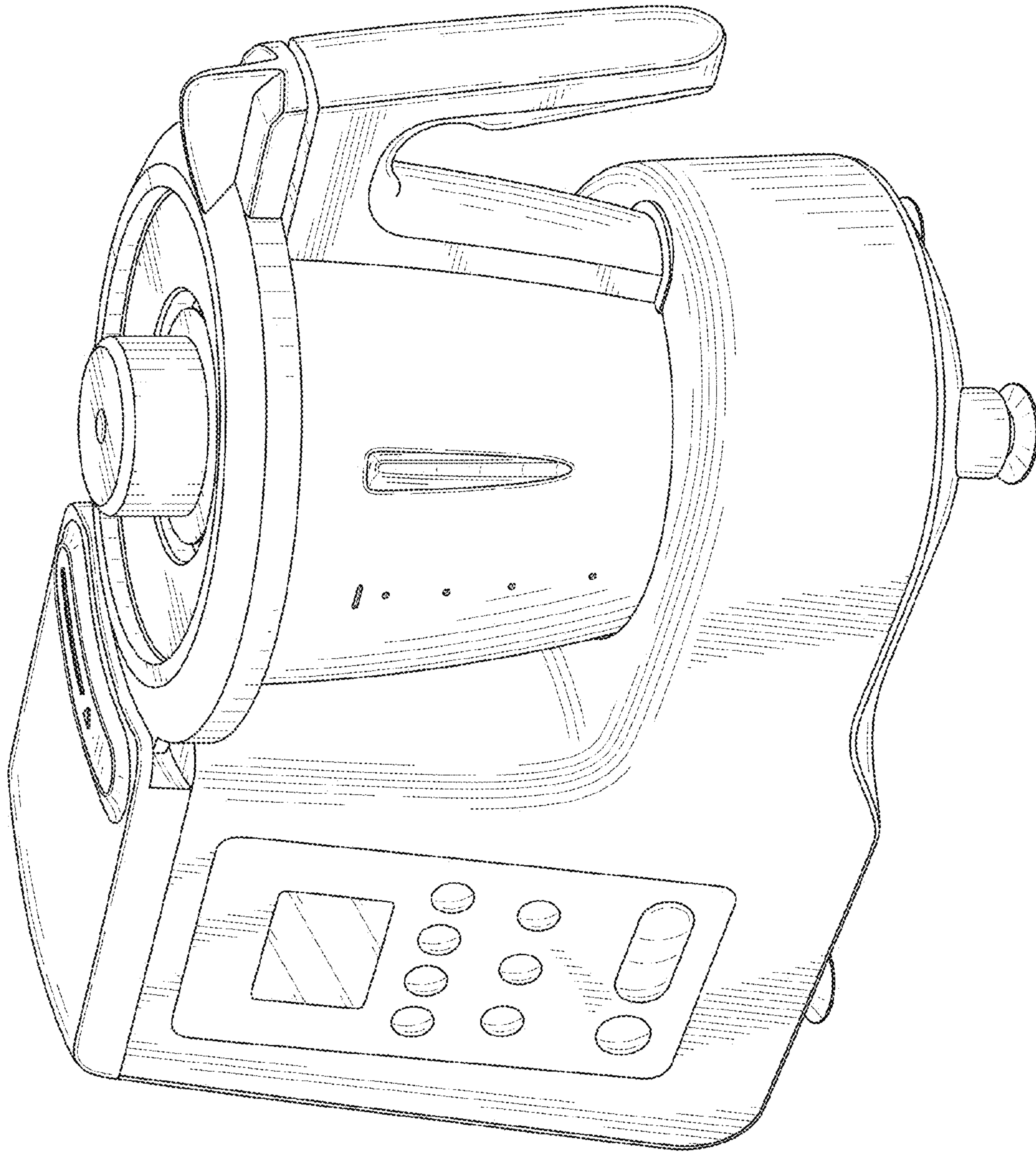

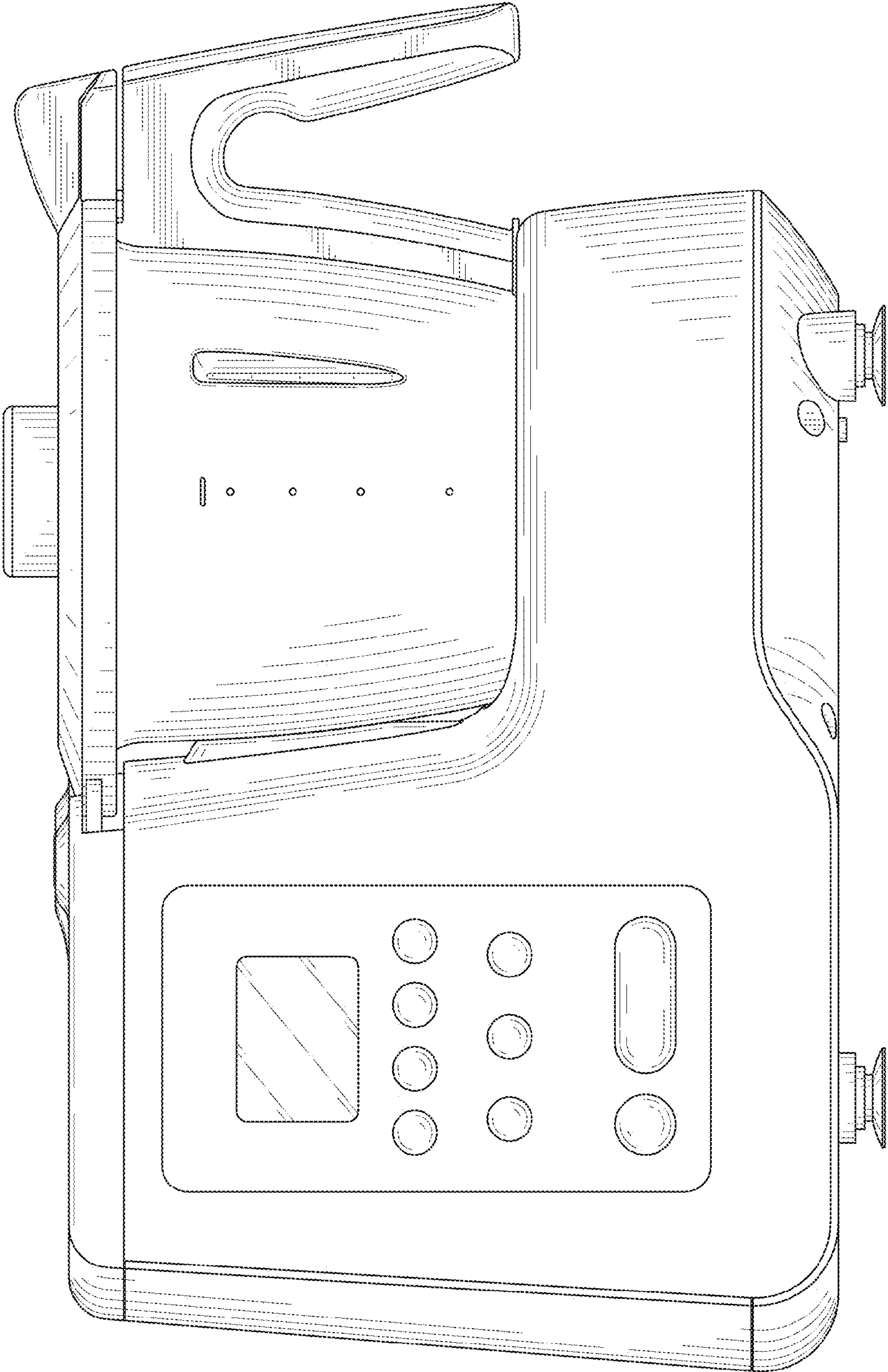

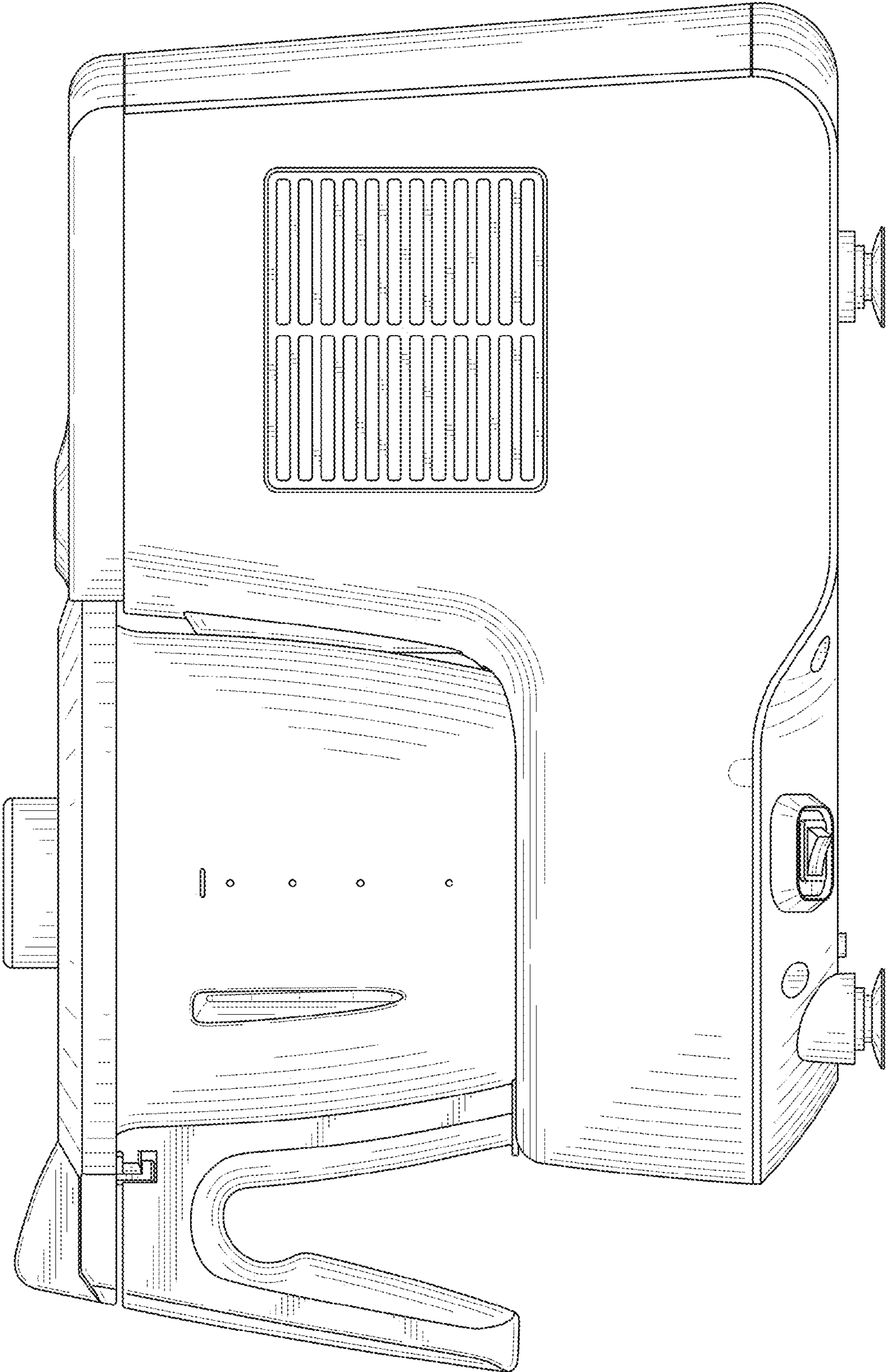

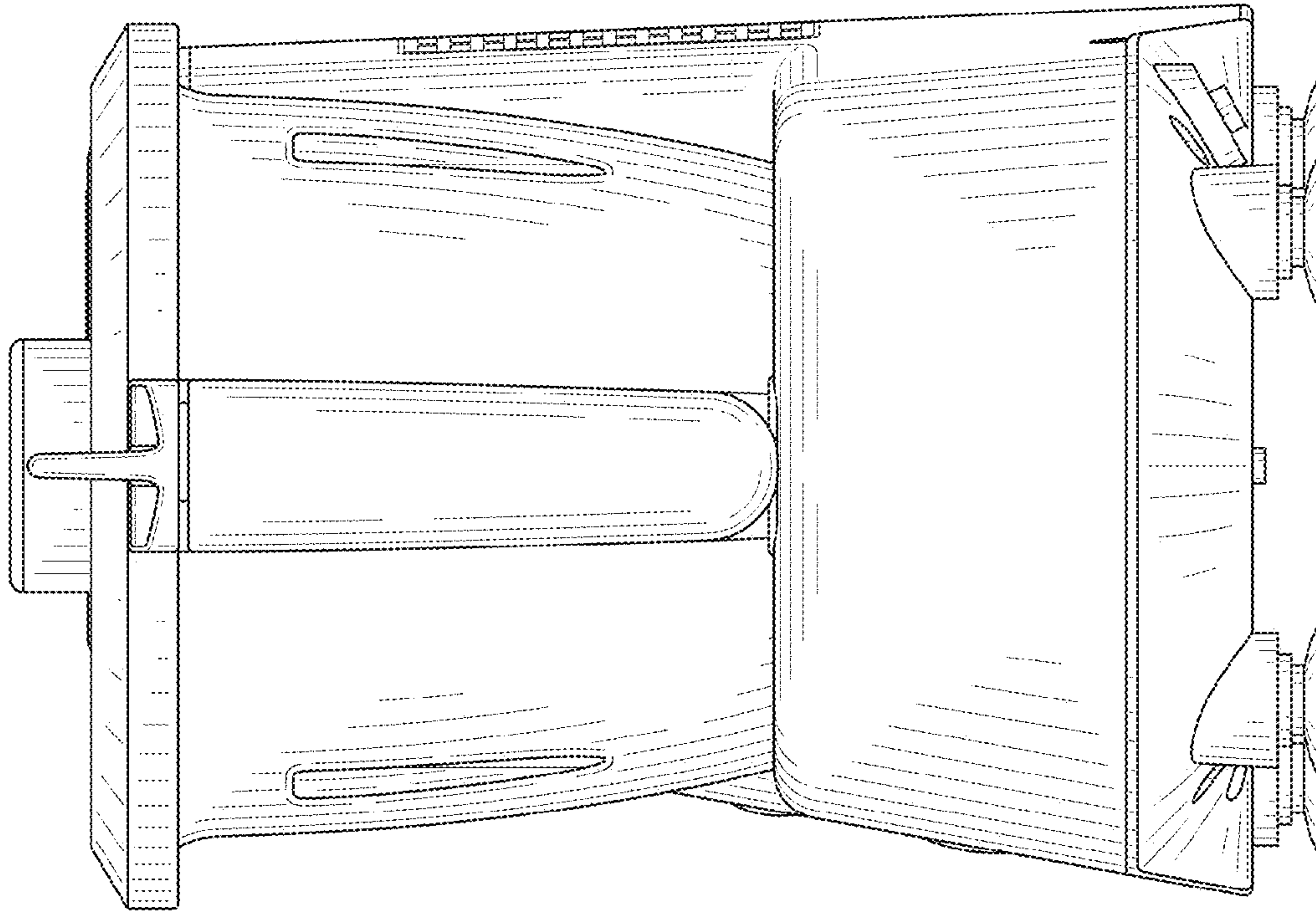

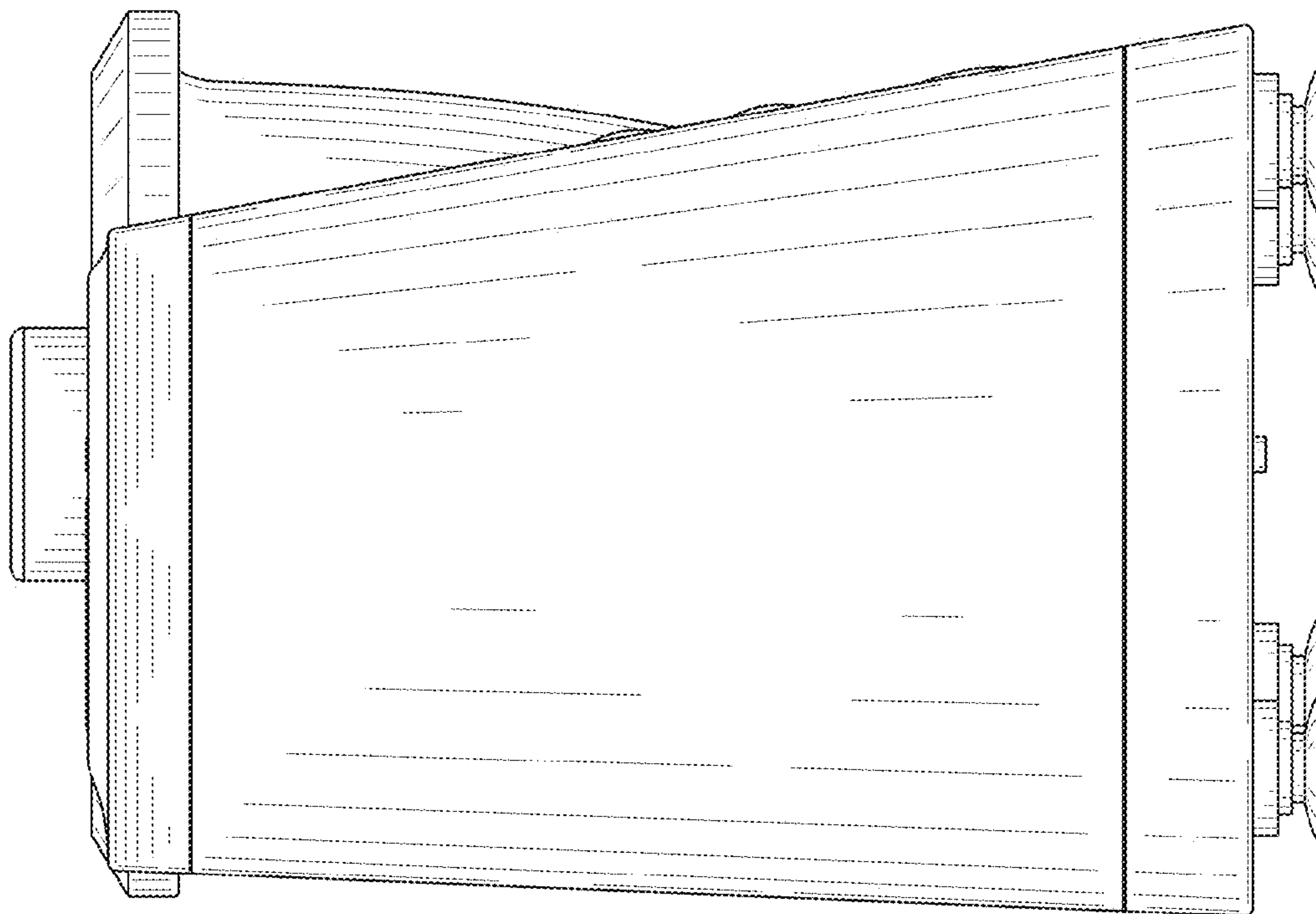

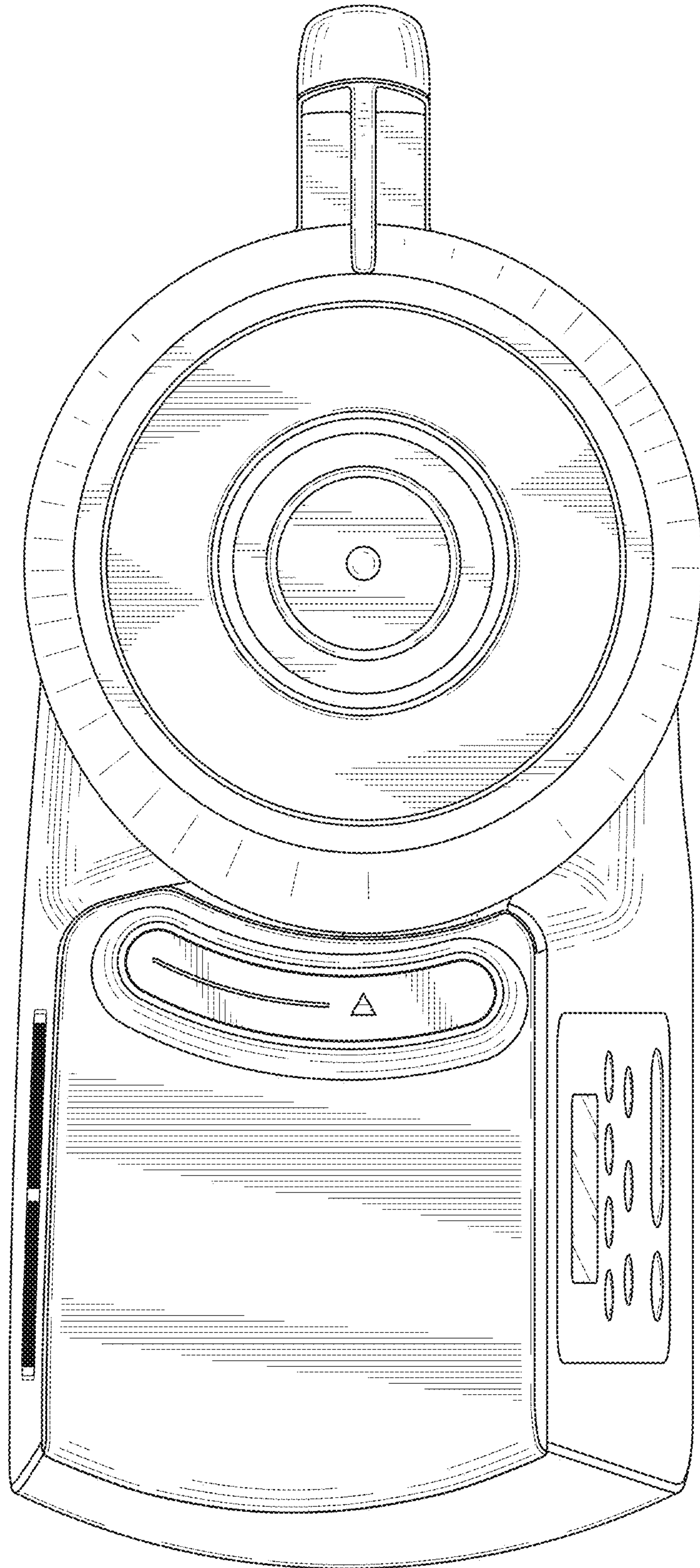

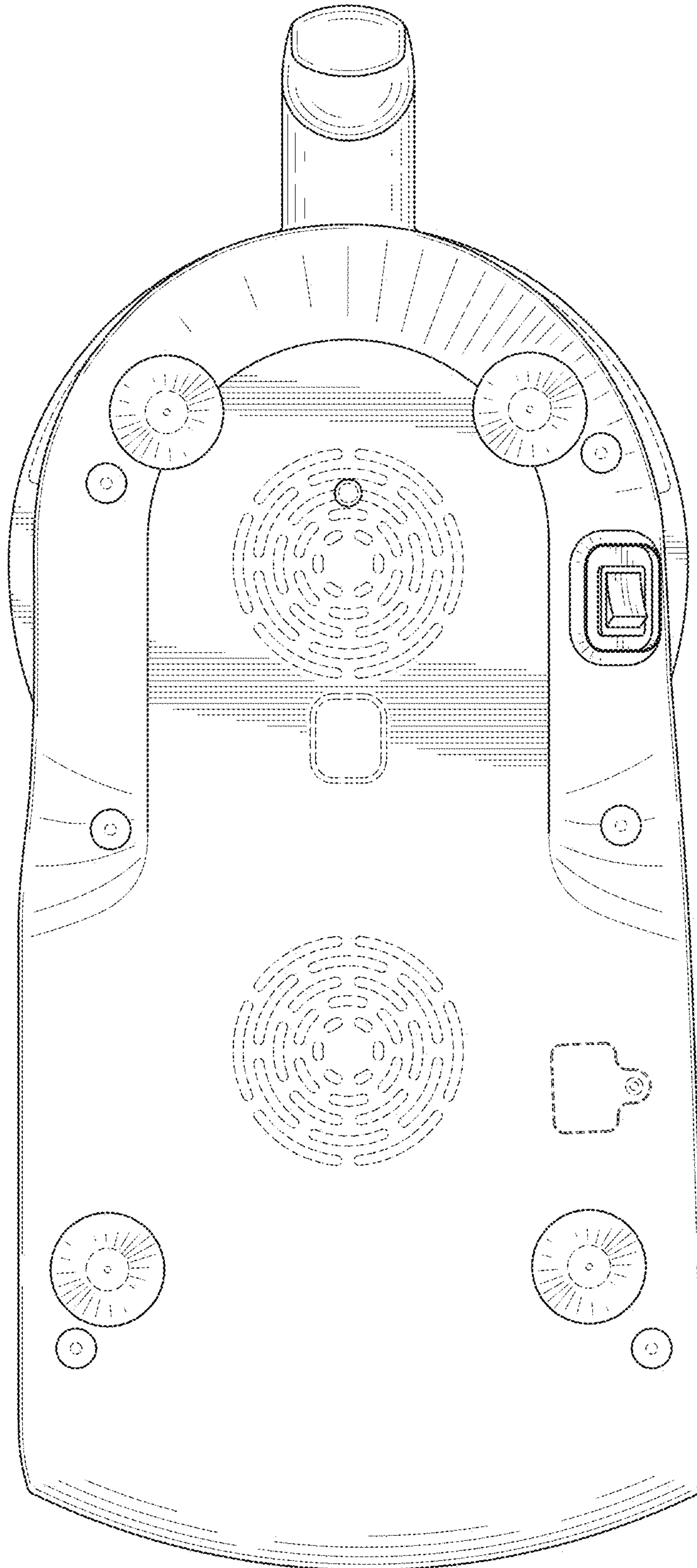
