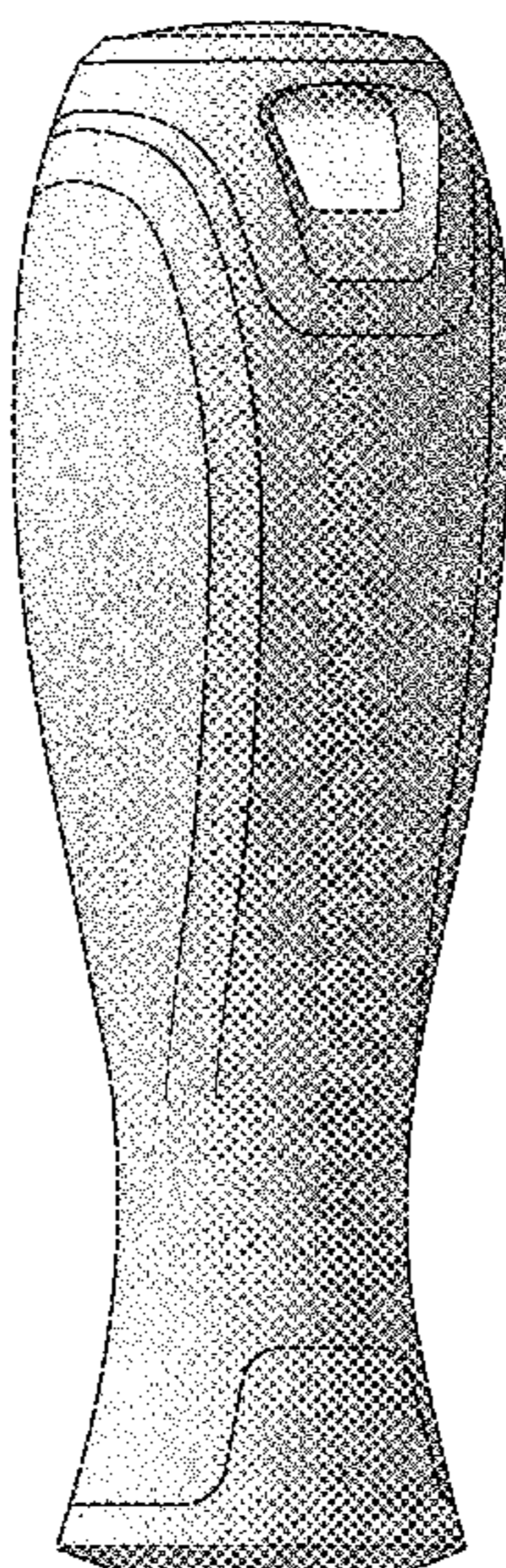
(57) **CLAIM**

The ornamental design for a tool handle for a screwdriver, as shown.

DESCRIPTION

FIG. 1 is a first side view of a first embodiment of a tool handle for a screwdriver showing the new design; FIG. 2 is a second side view, rotated 180°, thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a third side view, rotated clockwise from the top by 90° with respect to FIG. 1 thereof; FIG. 6 is a fourth side view, rotated clockwise from the top by 90° with respect to FIG. 2 thereof; FIG. 7 is a perspective view showing the first and fourth side views. FIG. 8 is a first side view of a second embodiment of a tool handle for a screwdriver showing the new design; FIG. 9 is a second side view, rotated 180°, thereof; FIG. 10 is a bottom view thereof; FIG. 11 is a top plan view thereof; FIG. 12 is a third side view, rotated clockwise from the top by 90° with respect to FIG. 8 thereof; FIG. 13 is a fourth side view, rotated clockwise from the top by 90° with respect to FIG. 9 thereof; and, FIG. 14 is a perspective view showing the first and fourth side views.

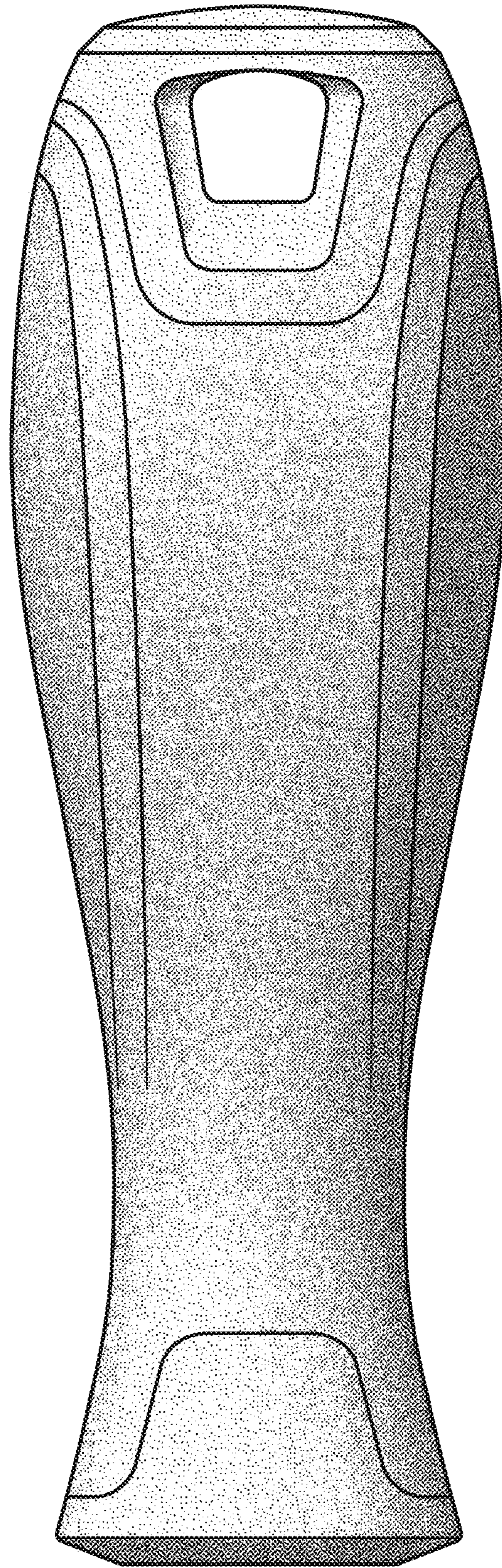

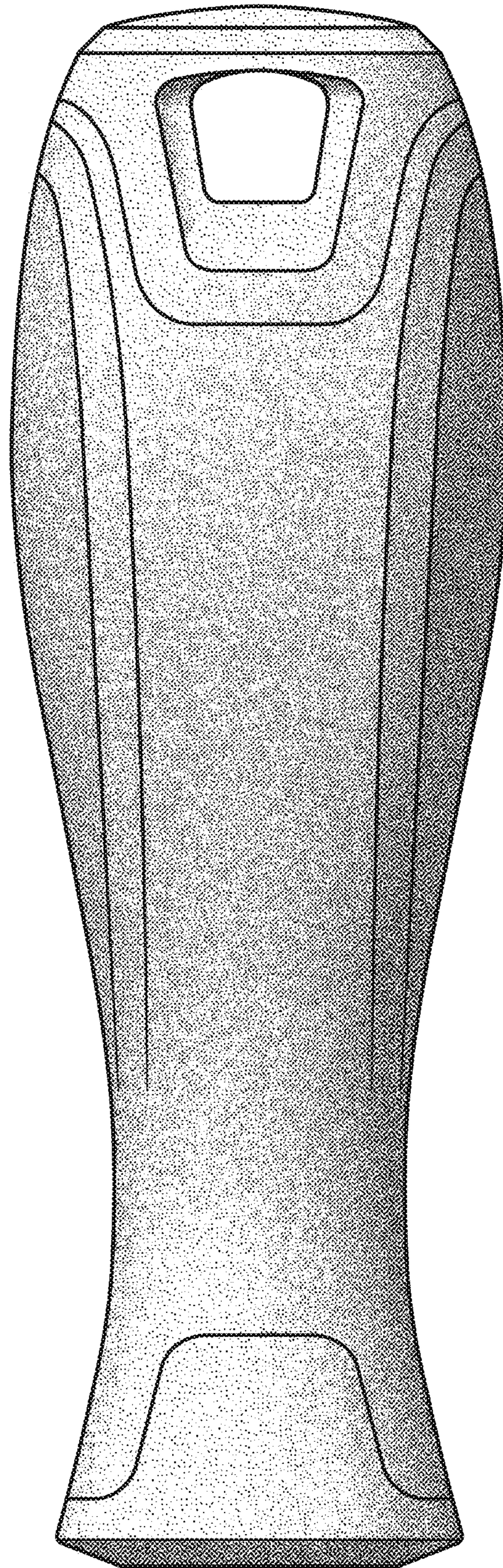

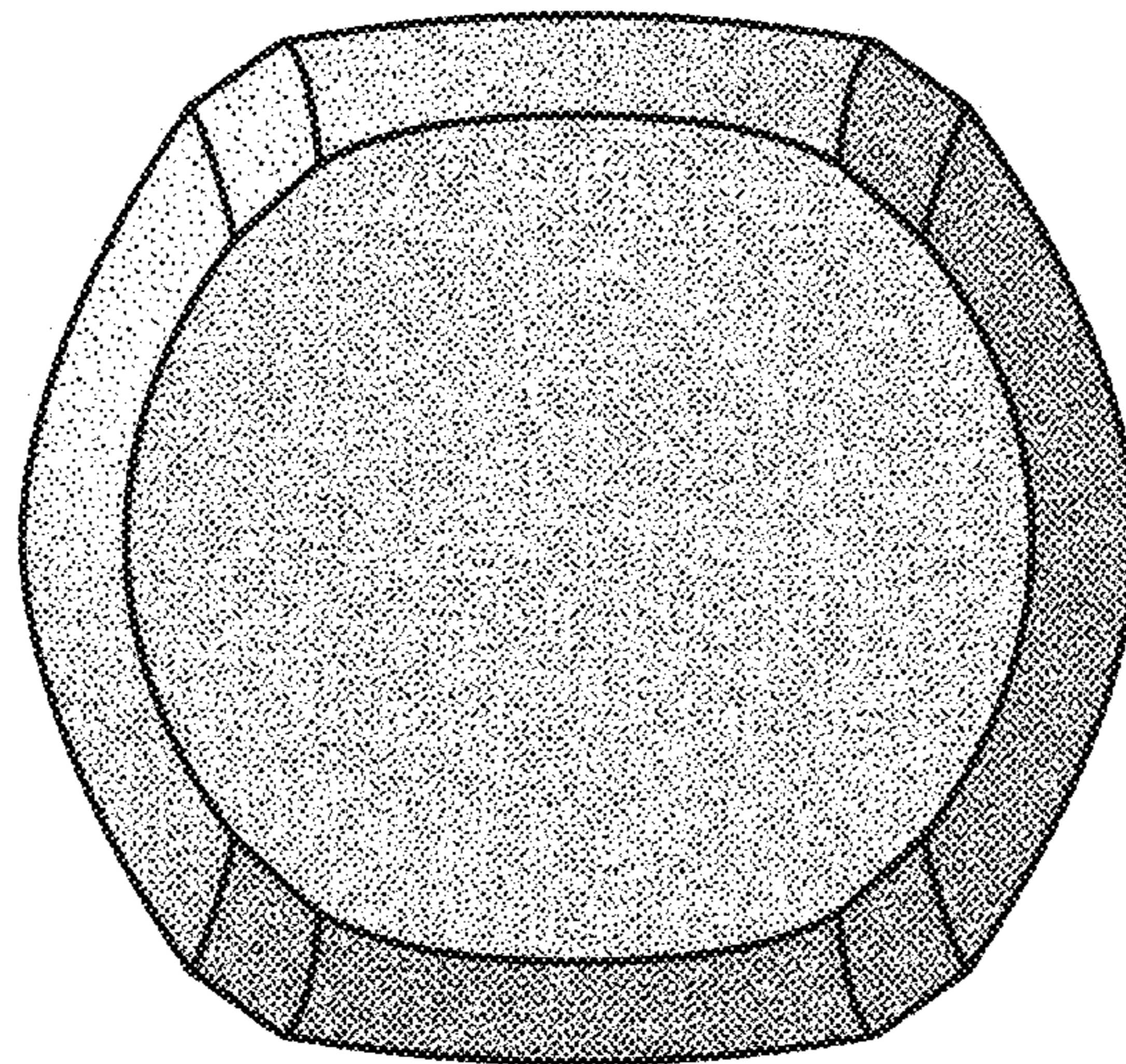

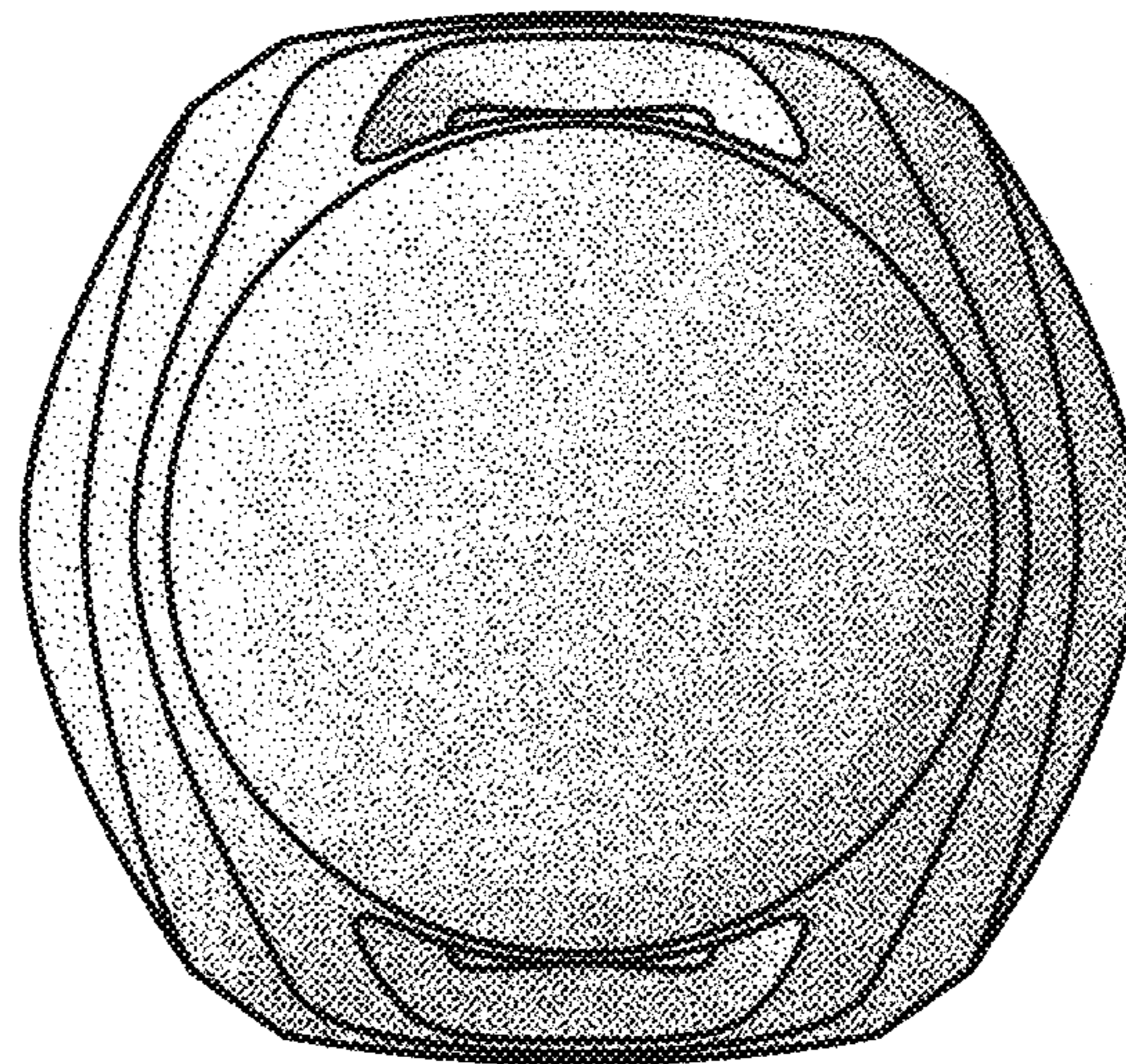

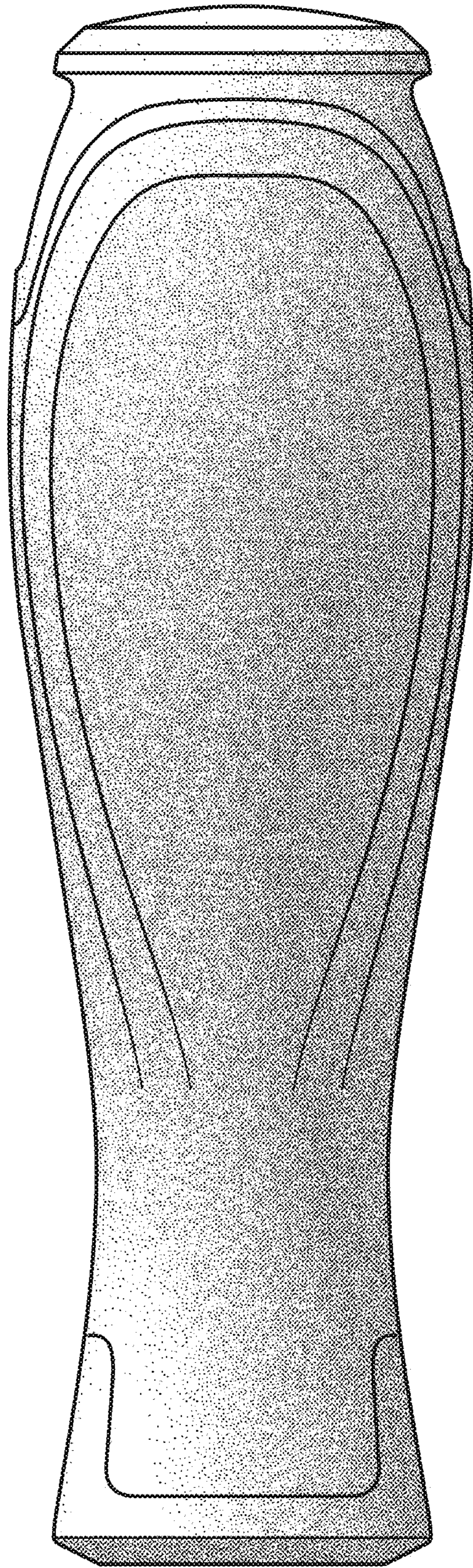

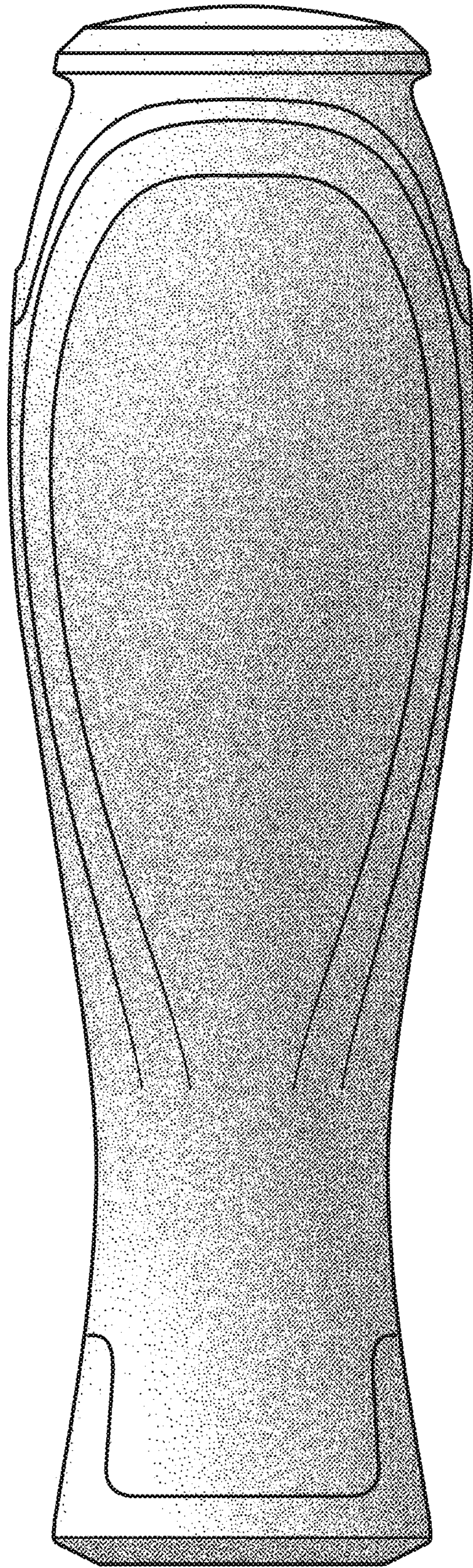

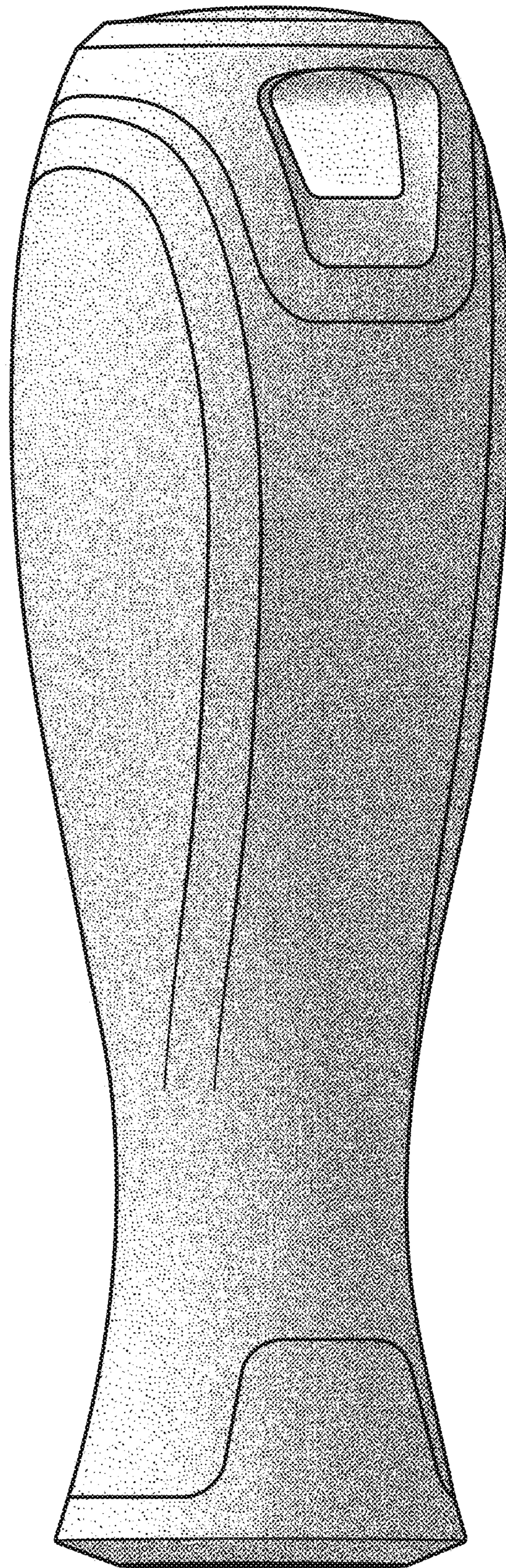

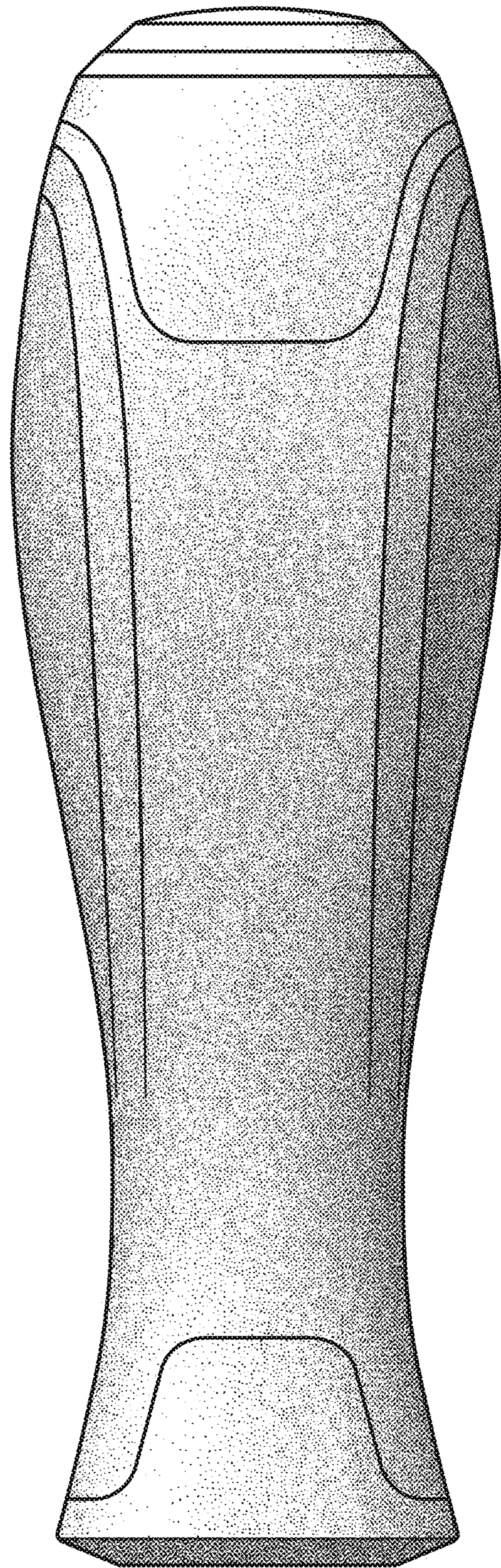

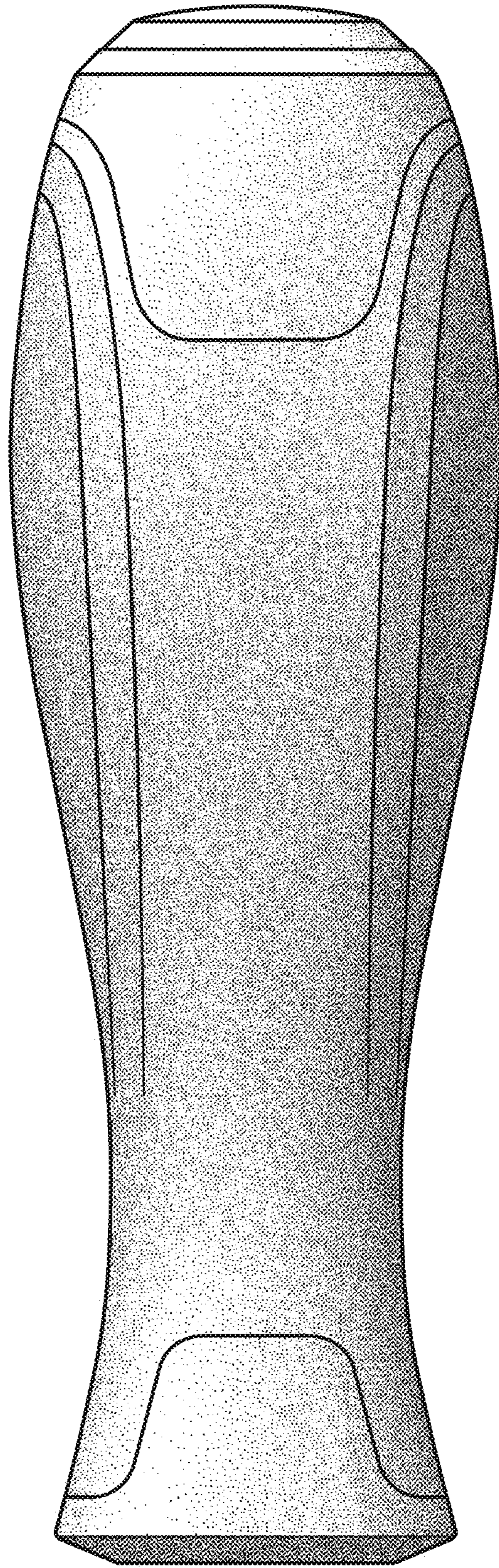

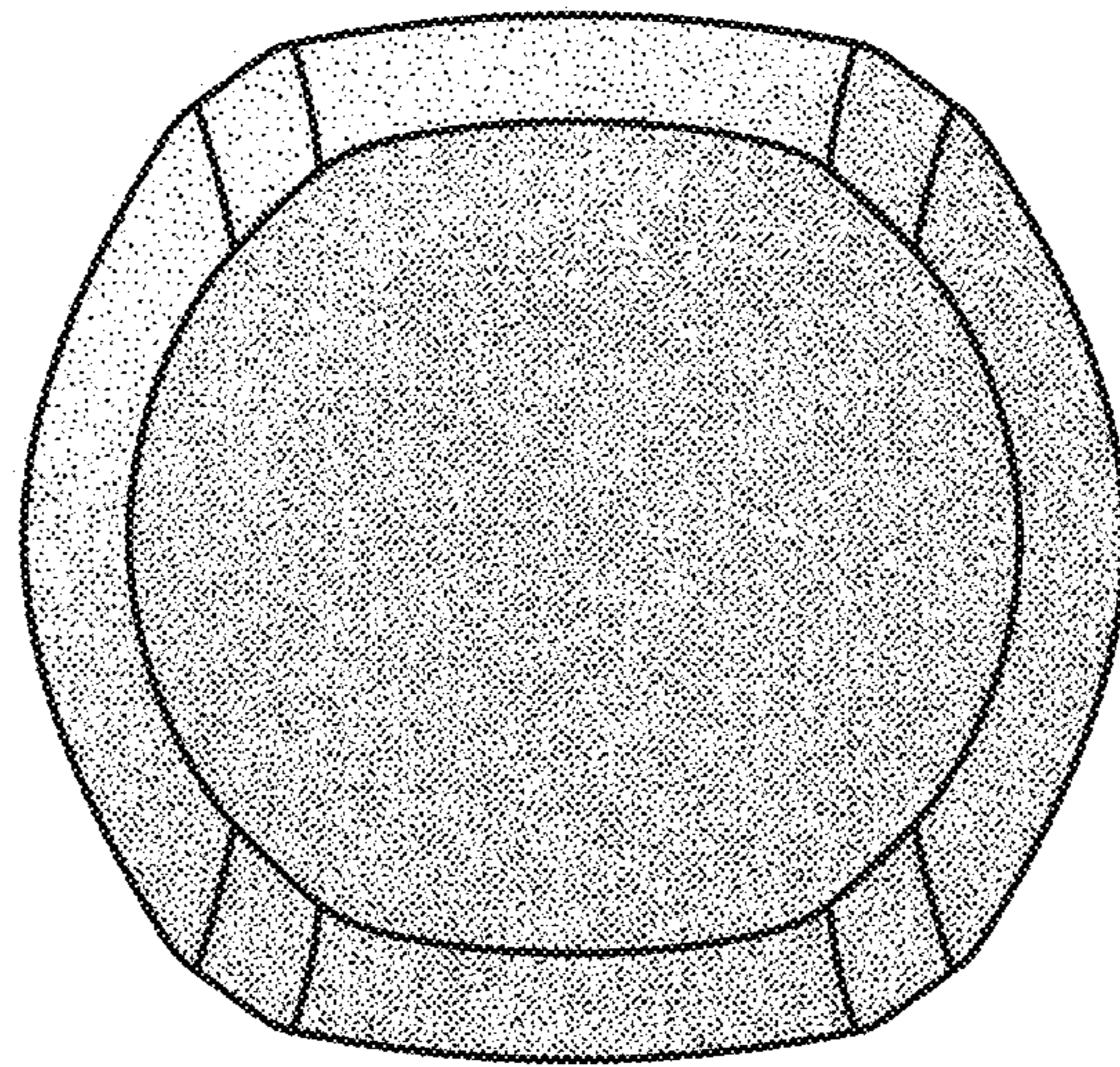

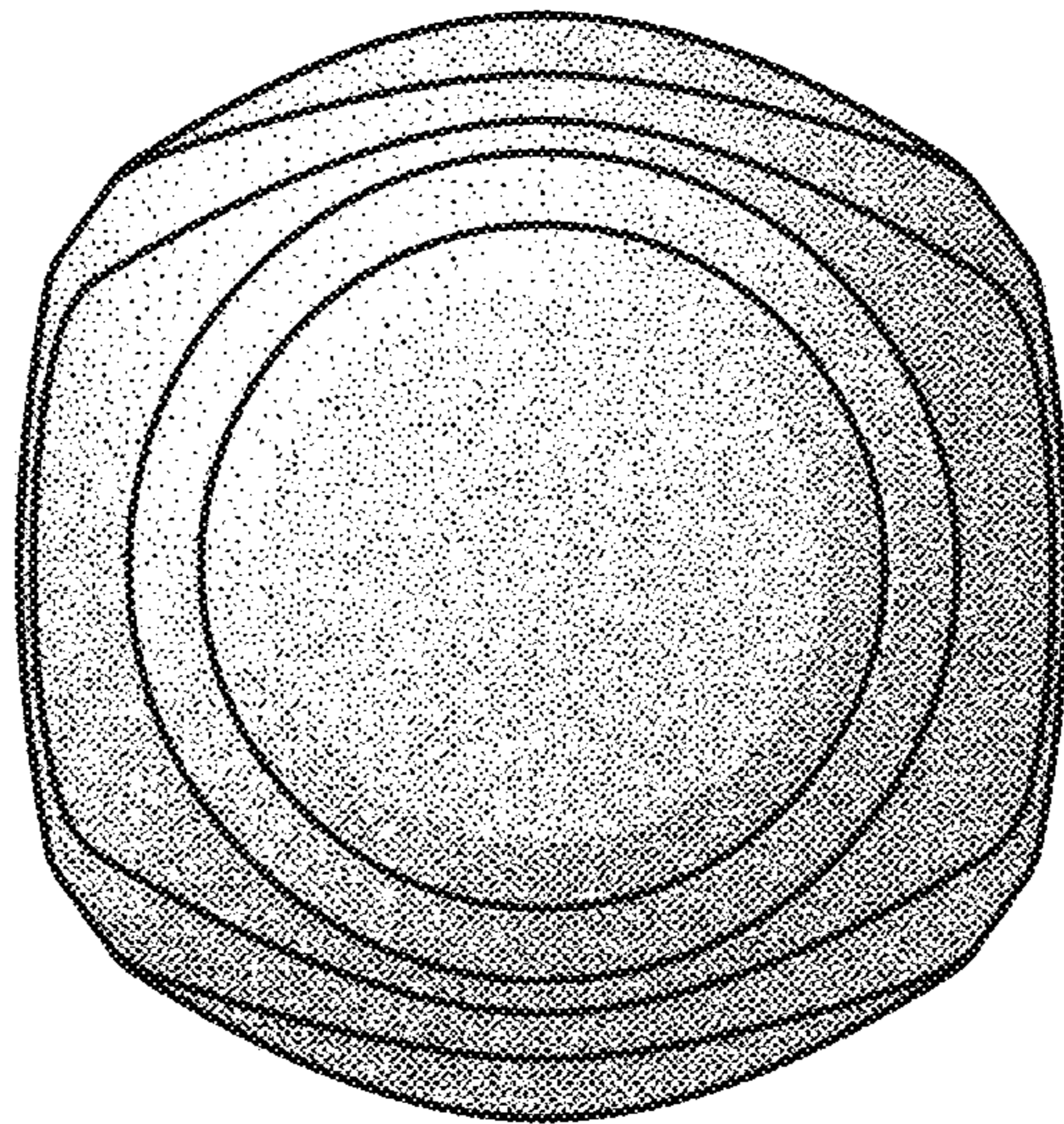

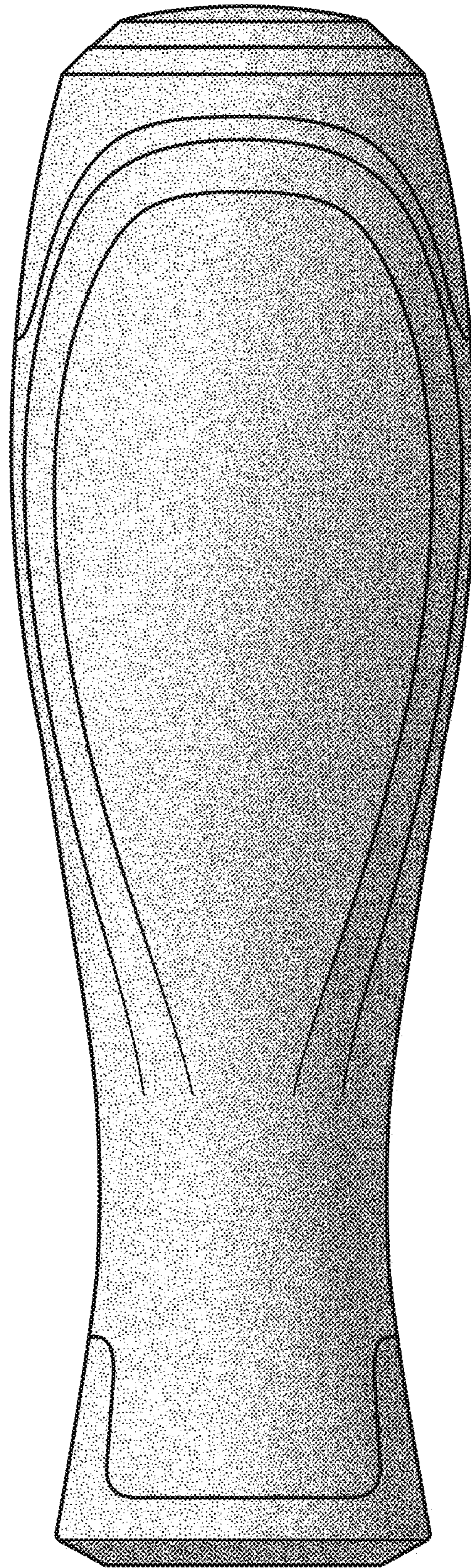

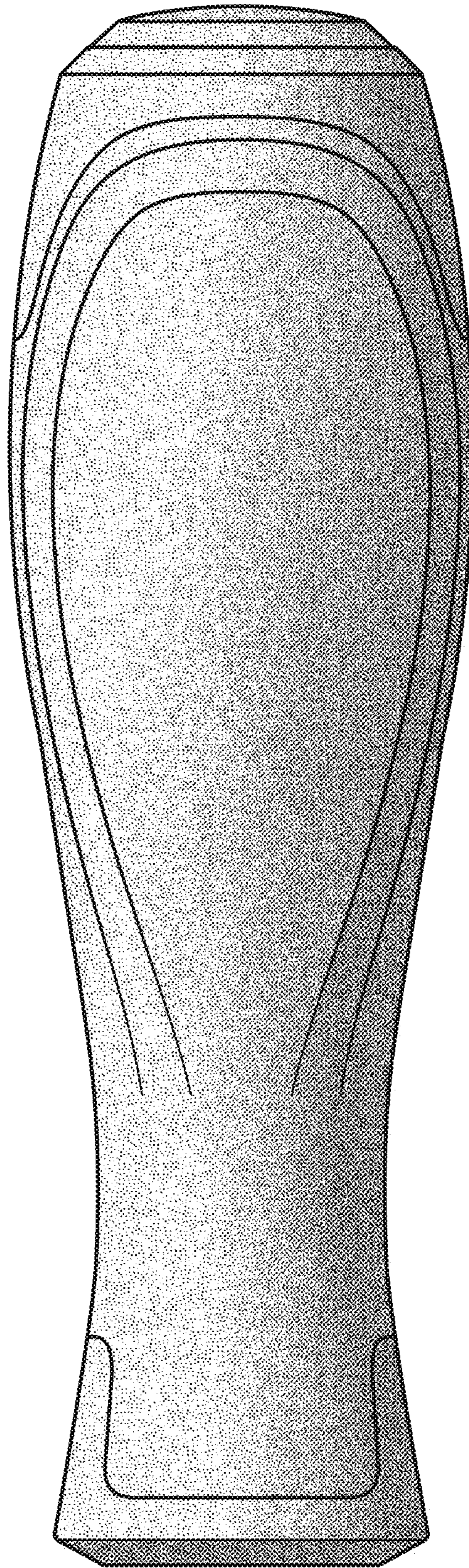

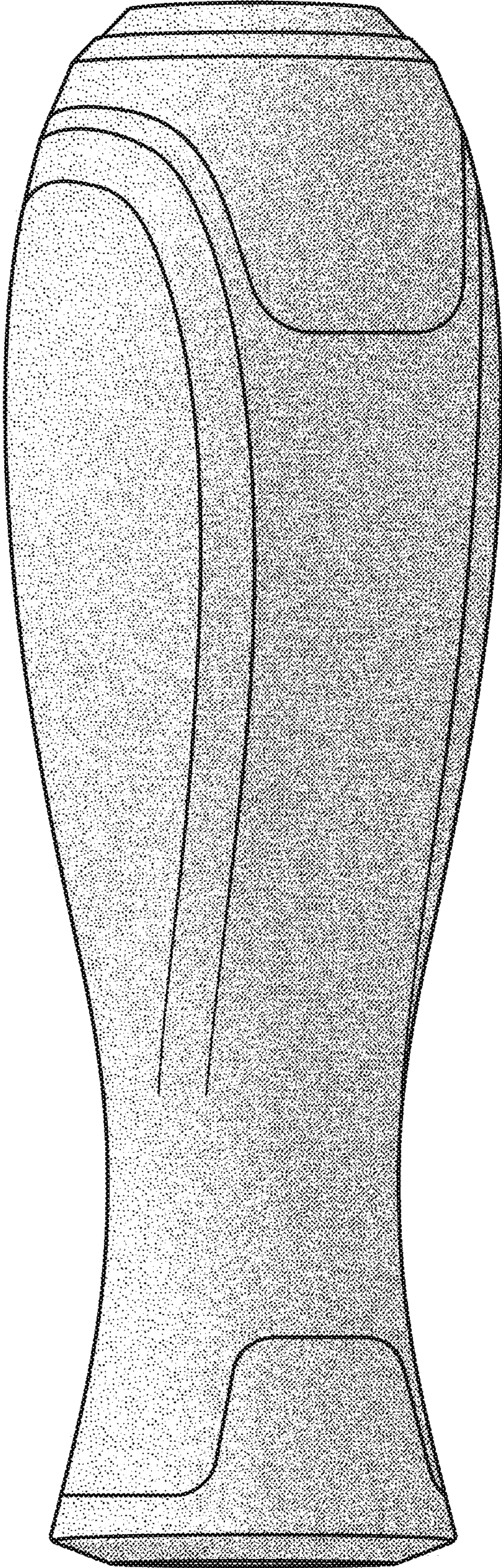
